(57) **CLAIM**

The ornamental design for a star shaped floral card holder, as shown and described.

DESCRIPTION

FIG. 1 is front view of a star shaped floral card holder according to the present invention;

FIG. 2 is a left side view of the star shaped floral card holder according to the present invention;

FIG. 3 is a right side view of the star shaped floral card holder according to the present invention;

FIG. 4 is a top view of the star shaped floral card holder according to the present invention;

FIG. 5 is a bottom view of the star shaped floral card holder according to the present invention; and,

FIG. 6 is a fragmentary side view of the star shaped floral card holder according to the present invention, illustrated in an alternate, expanded position.

The stem portion of the star shaped floral card holder is shown broken away to show indeterminate length; the broken lines in the drawings represent environmental structure only and form no part of the claimed design.

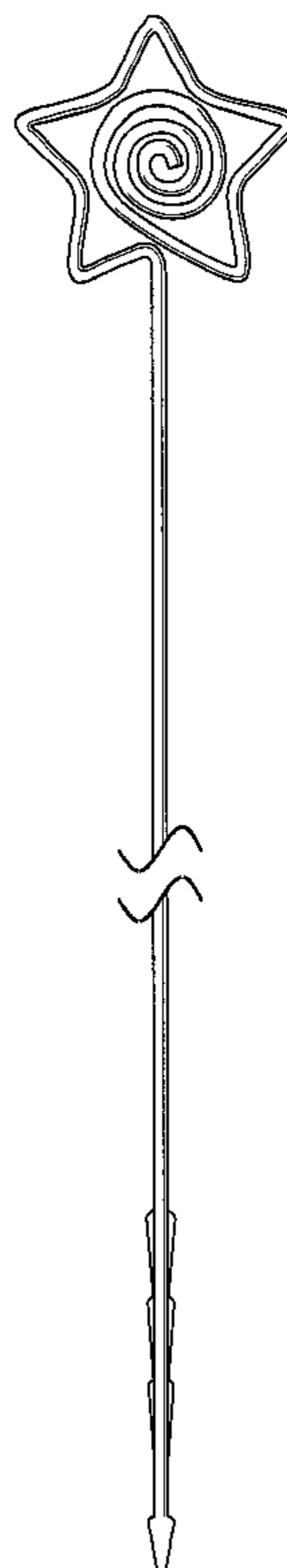

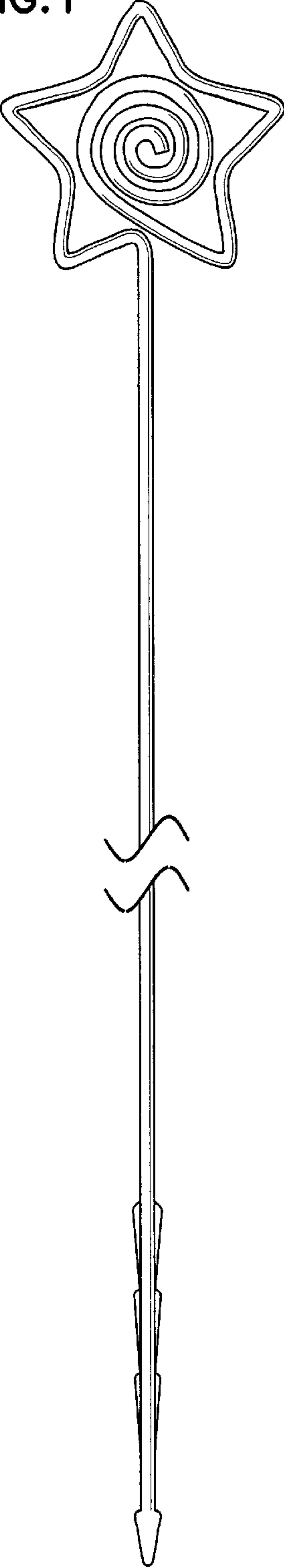

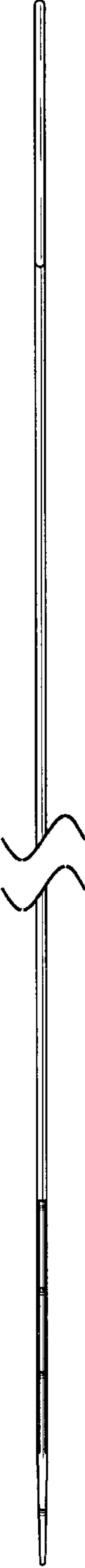

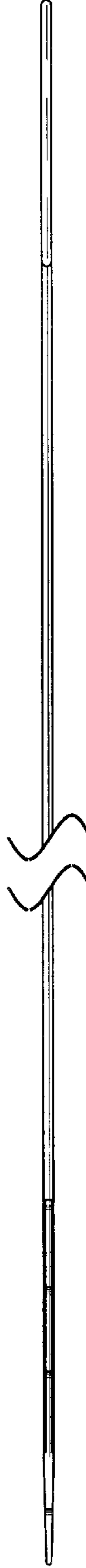

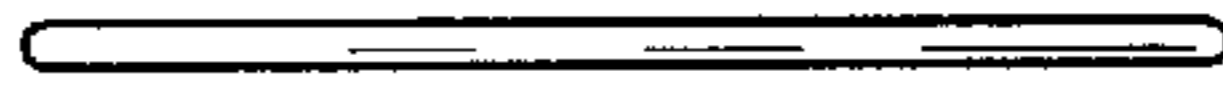
