FIG. 3 is a side elevational view thereof.

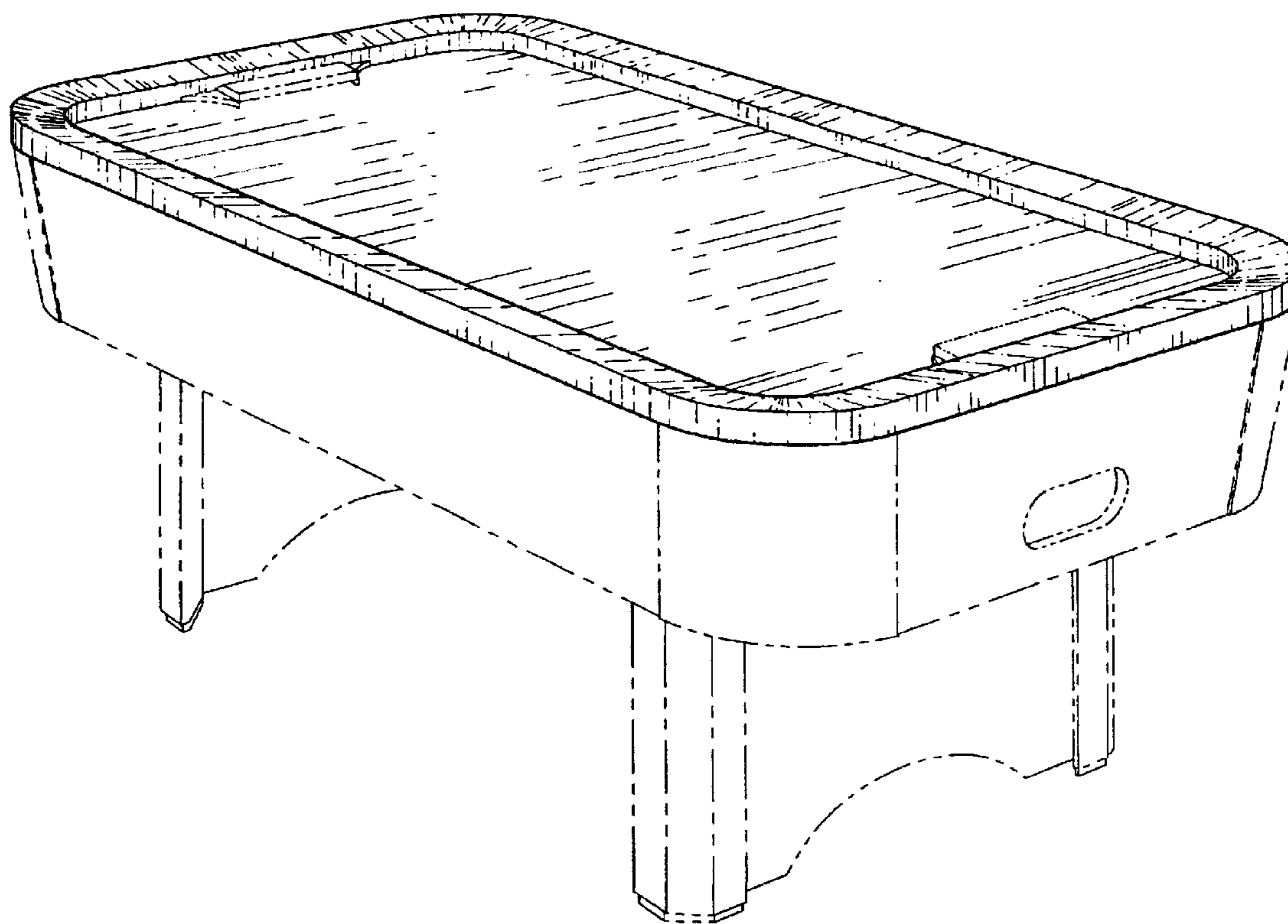
FIG. 4 is an end-on view thereof.

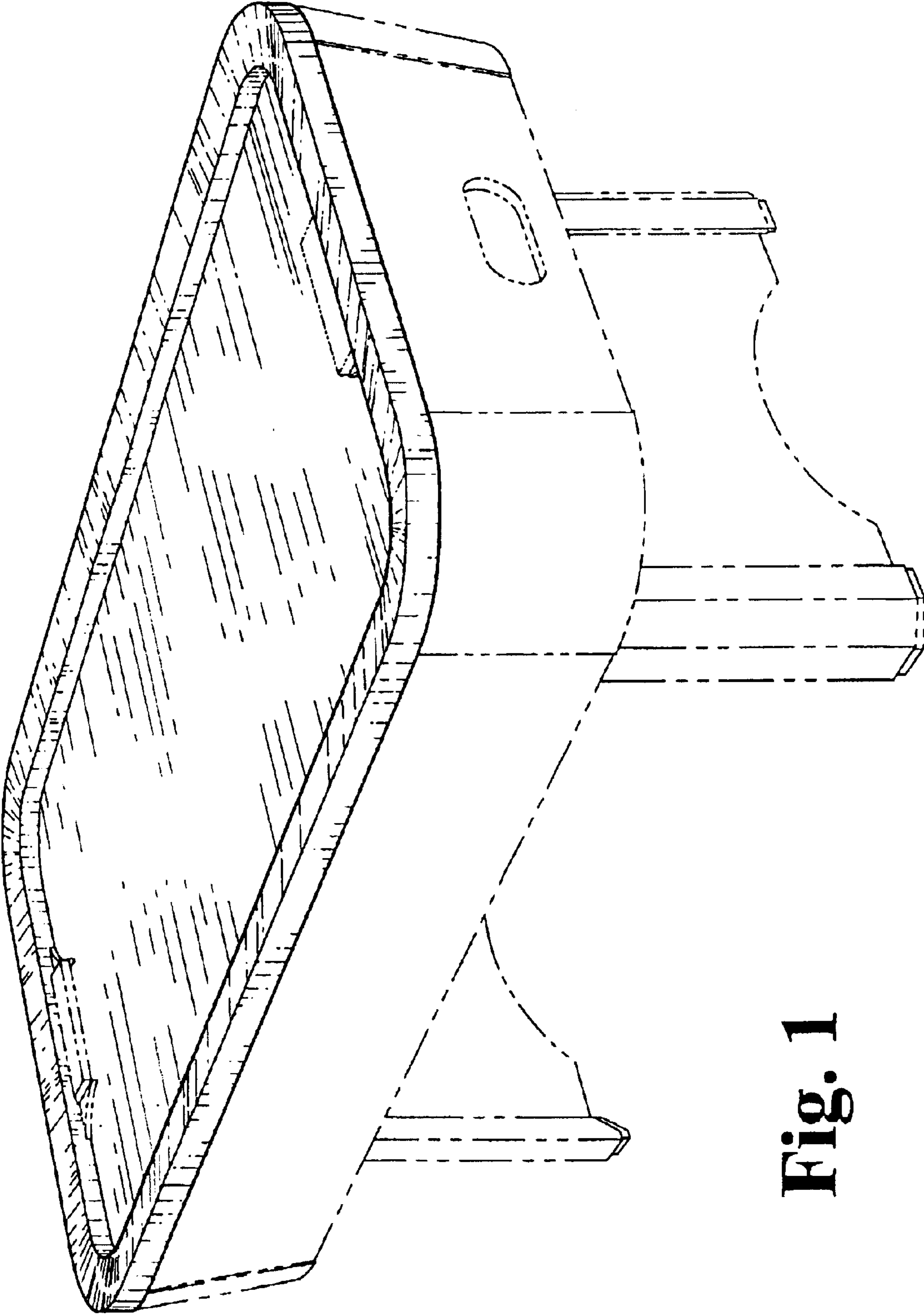

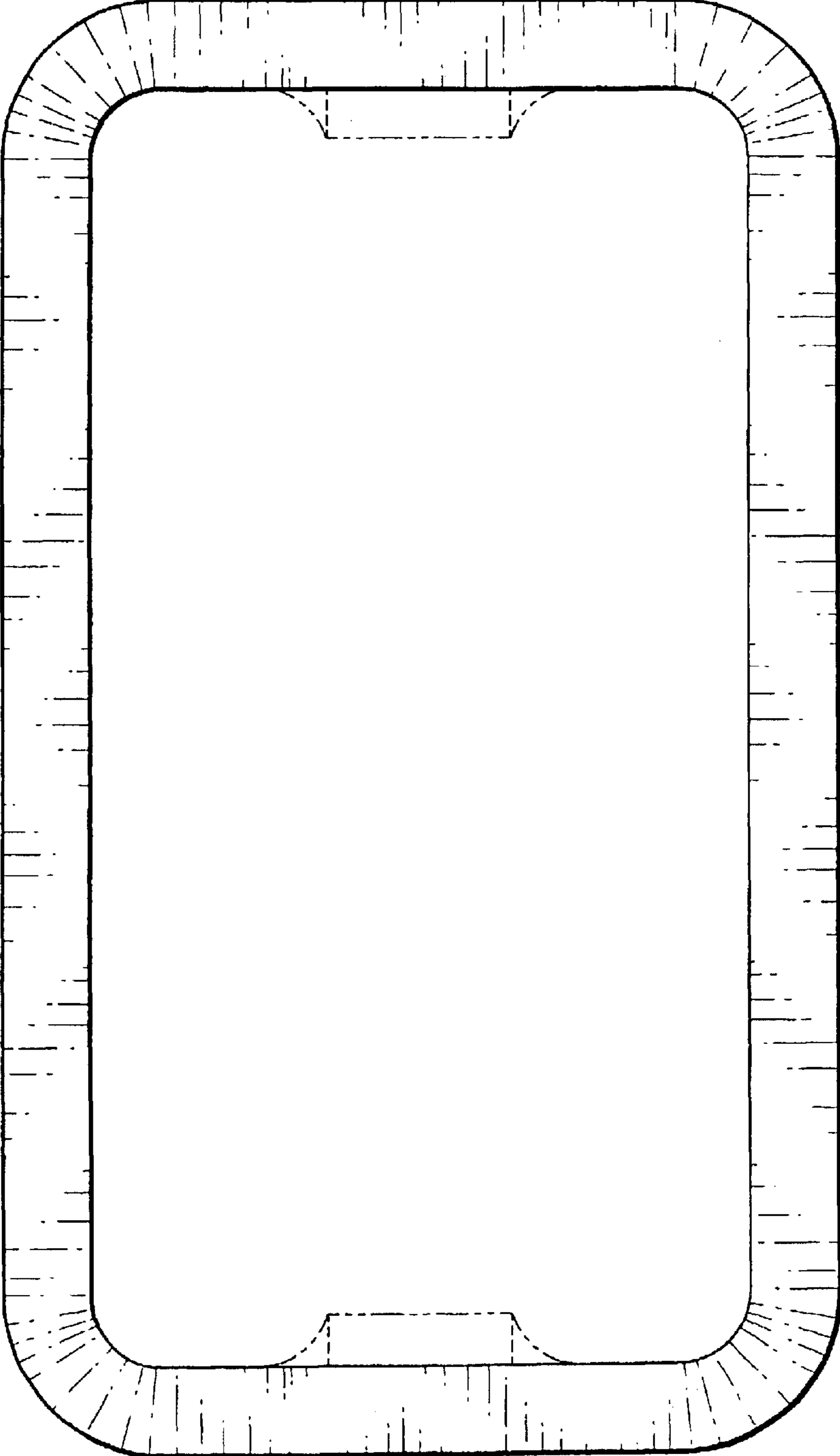

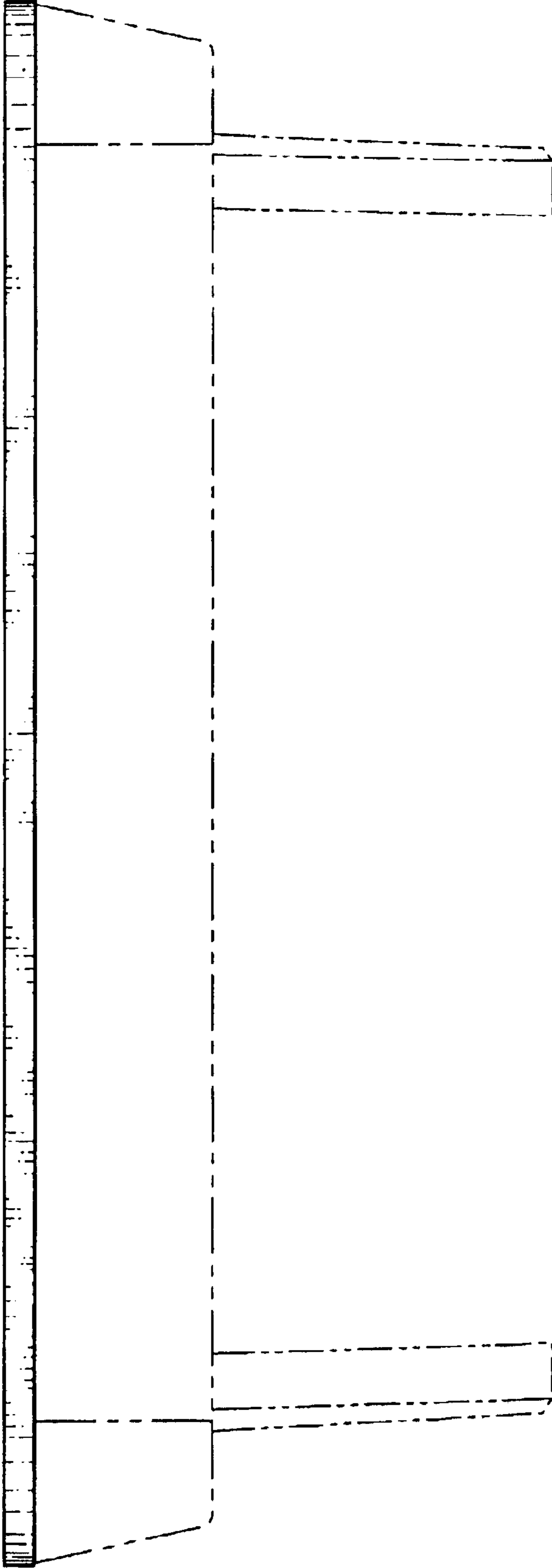

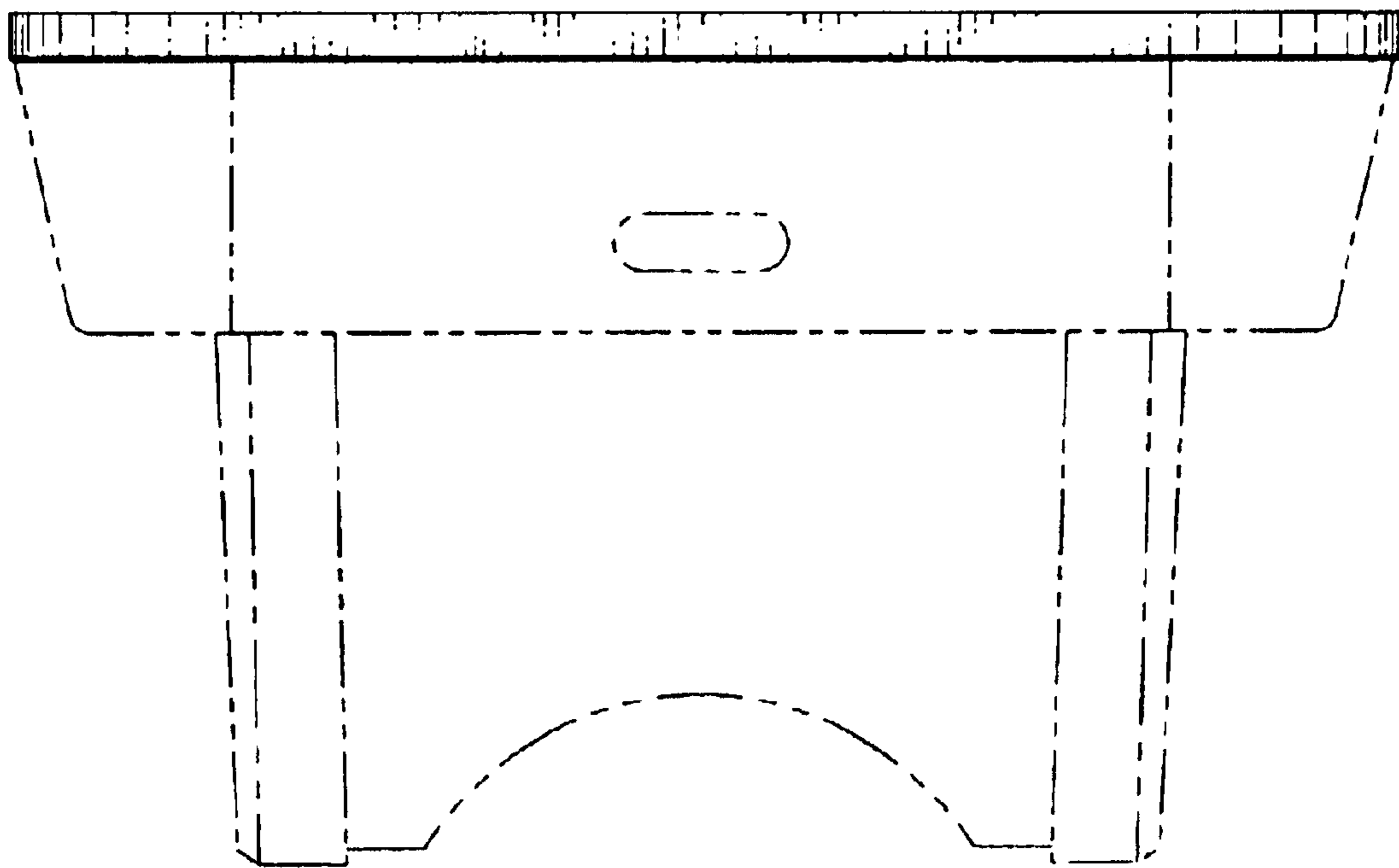

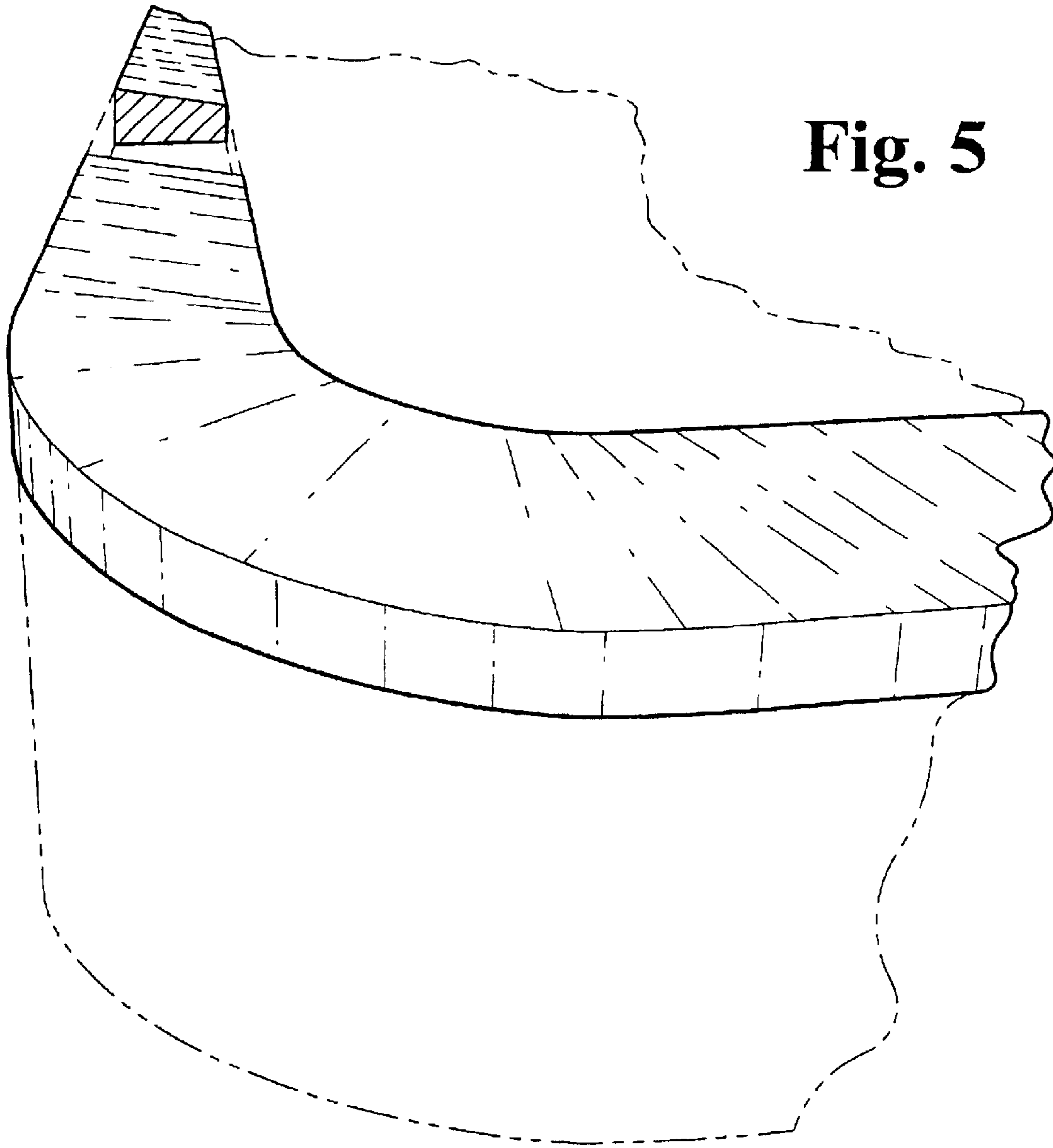

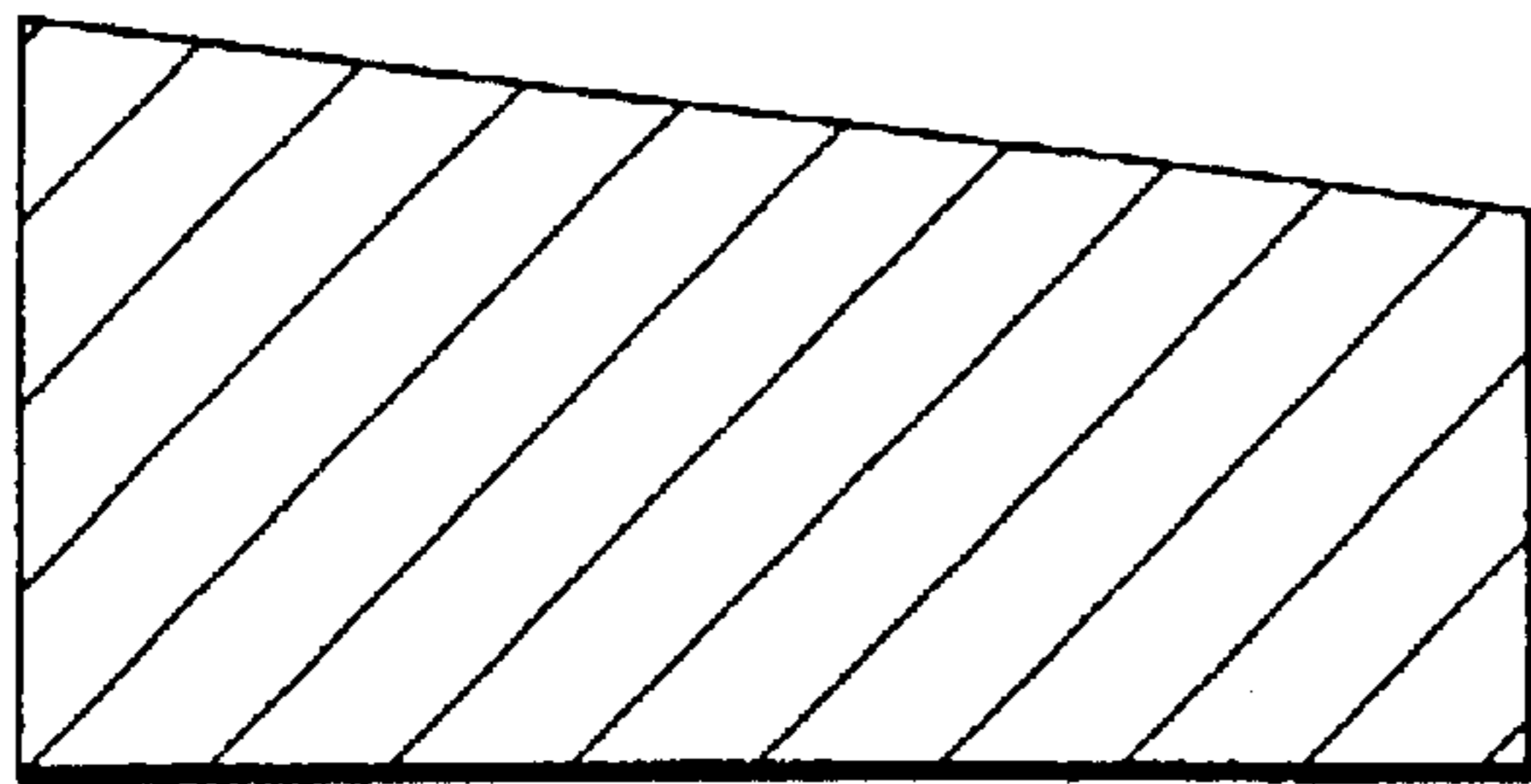
