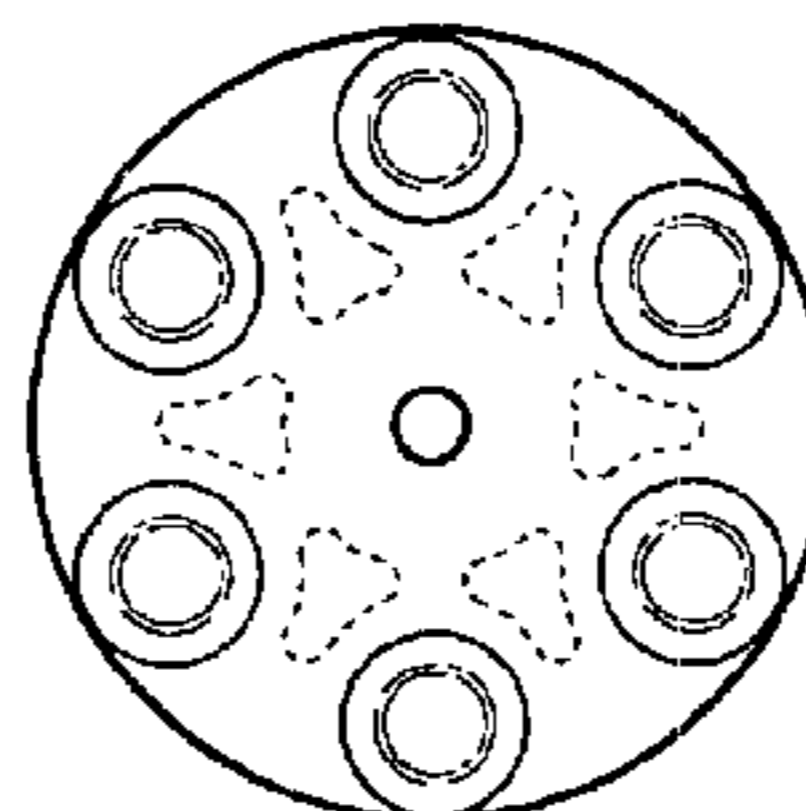
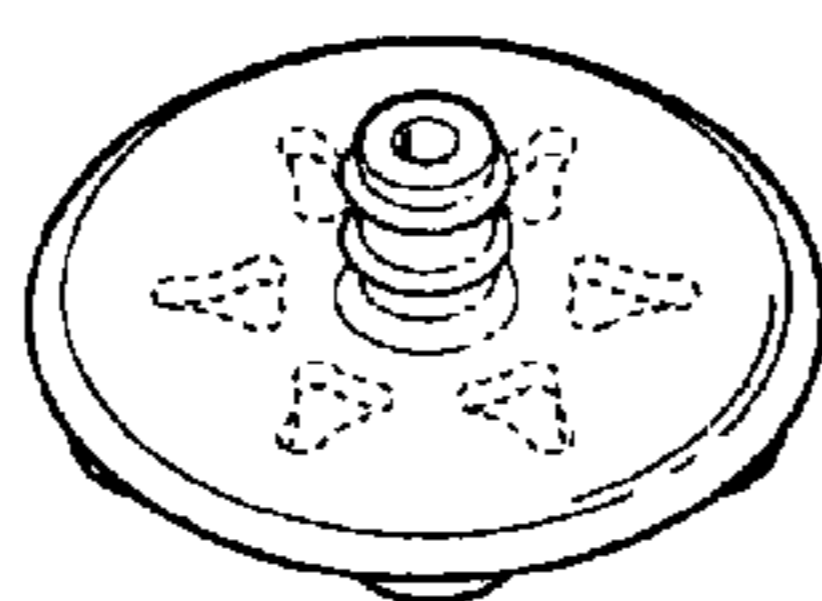
(57) **CLAIM**

The ornamental design for a bolster, as shown and described.

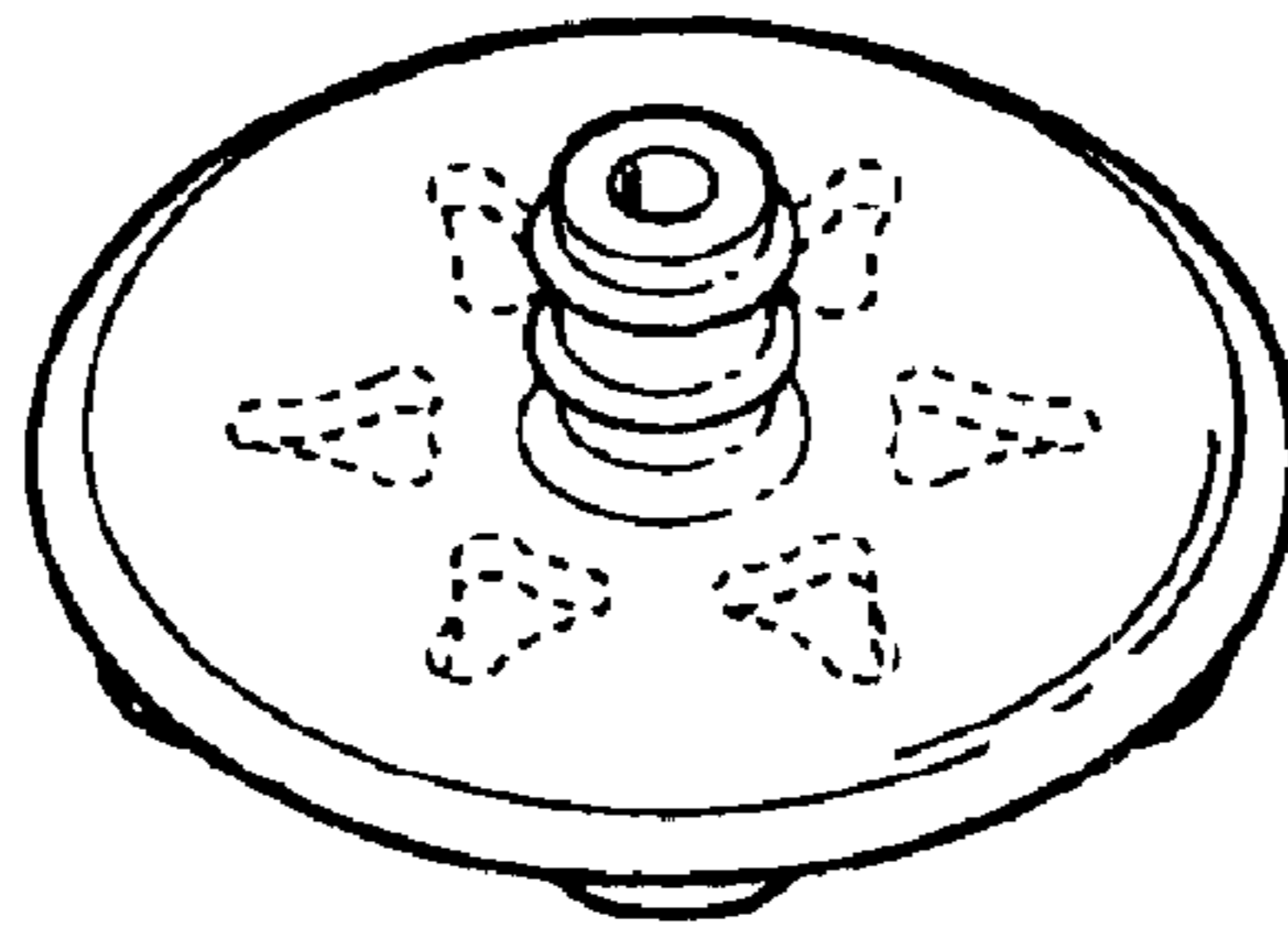
**DESCRIPTION**

FIG. 1 is an perspective view of a bolster;  
FIG. 2 is a top view;  
FIG. 3 is a side view showing one alignment of the feet of the bolster;  
FIG. 4 is an alternate side view showing an alternate alignment of the feet of the bolster; and,  
FIG. 5 is a bottom view.  
The broken line showing in FIGS. 1, 2 and 5 is for illustrative purposes only and forms no part of the claimed design.

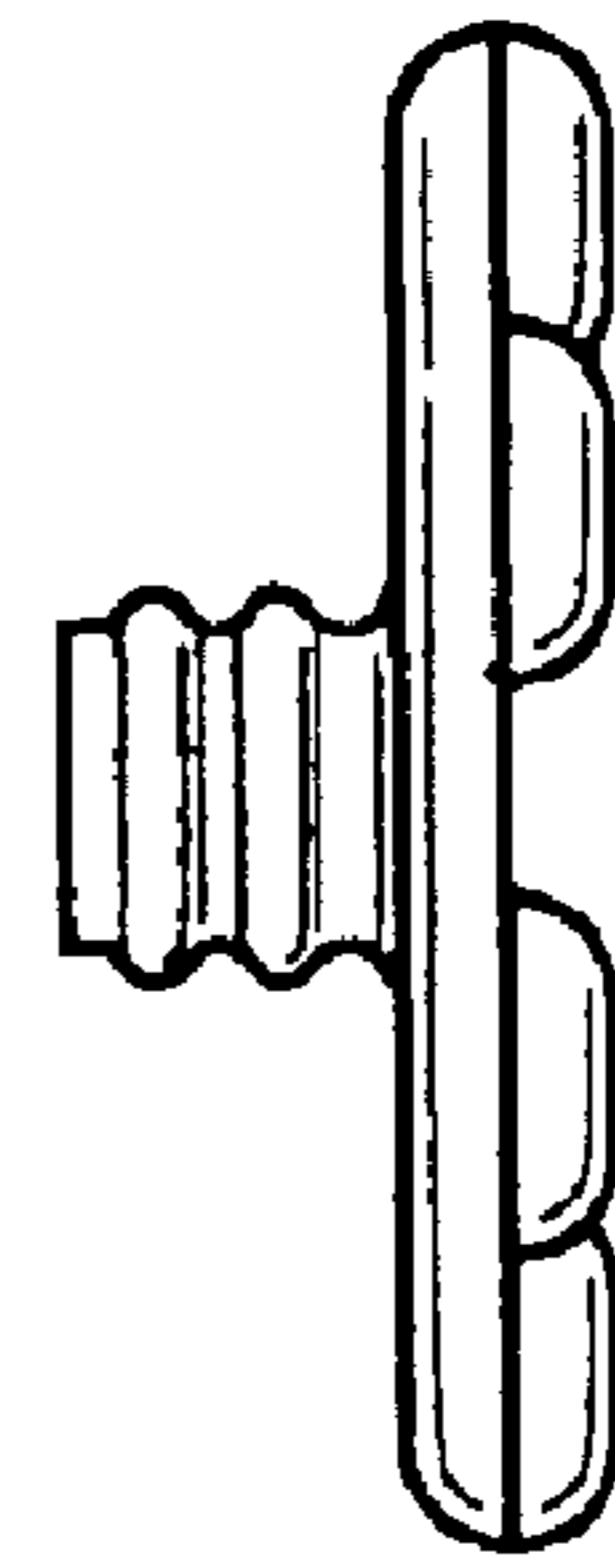
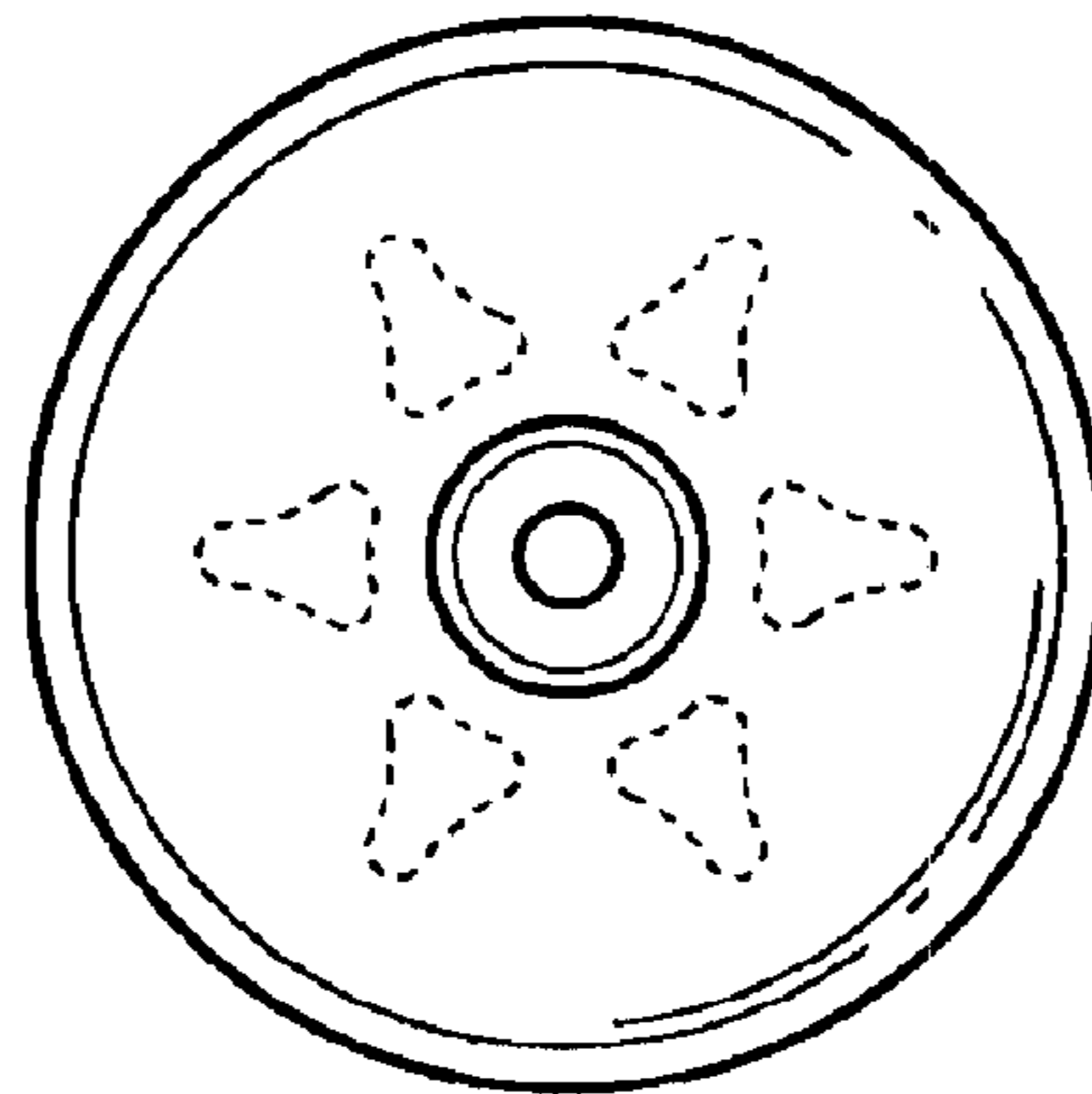

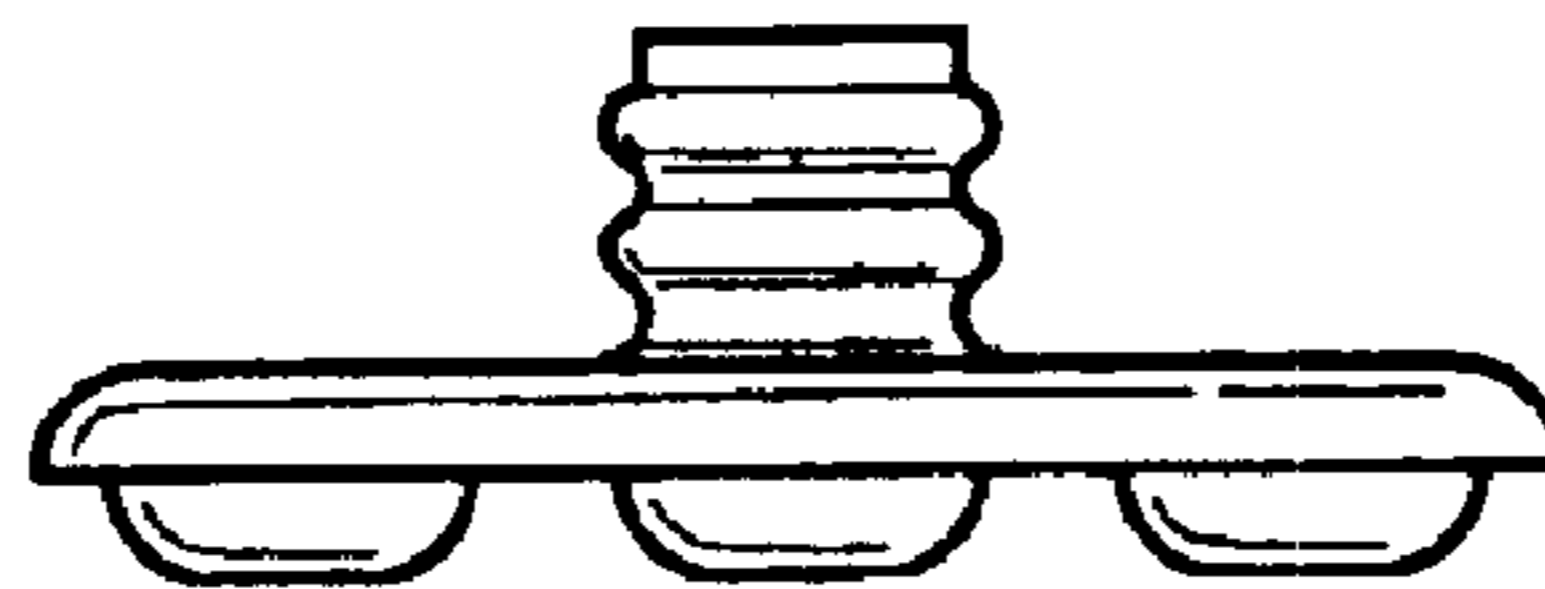
