We claim the ornamental design for combined folding chair and flag pole support, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the of the combined folding chair and flag pole support showing the new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a top plan view of the invention and FIG. 1; and, FIG. 7 is a bottom view of the invention and FIG. 1.

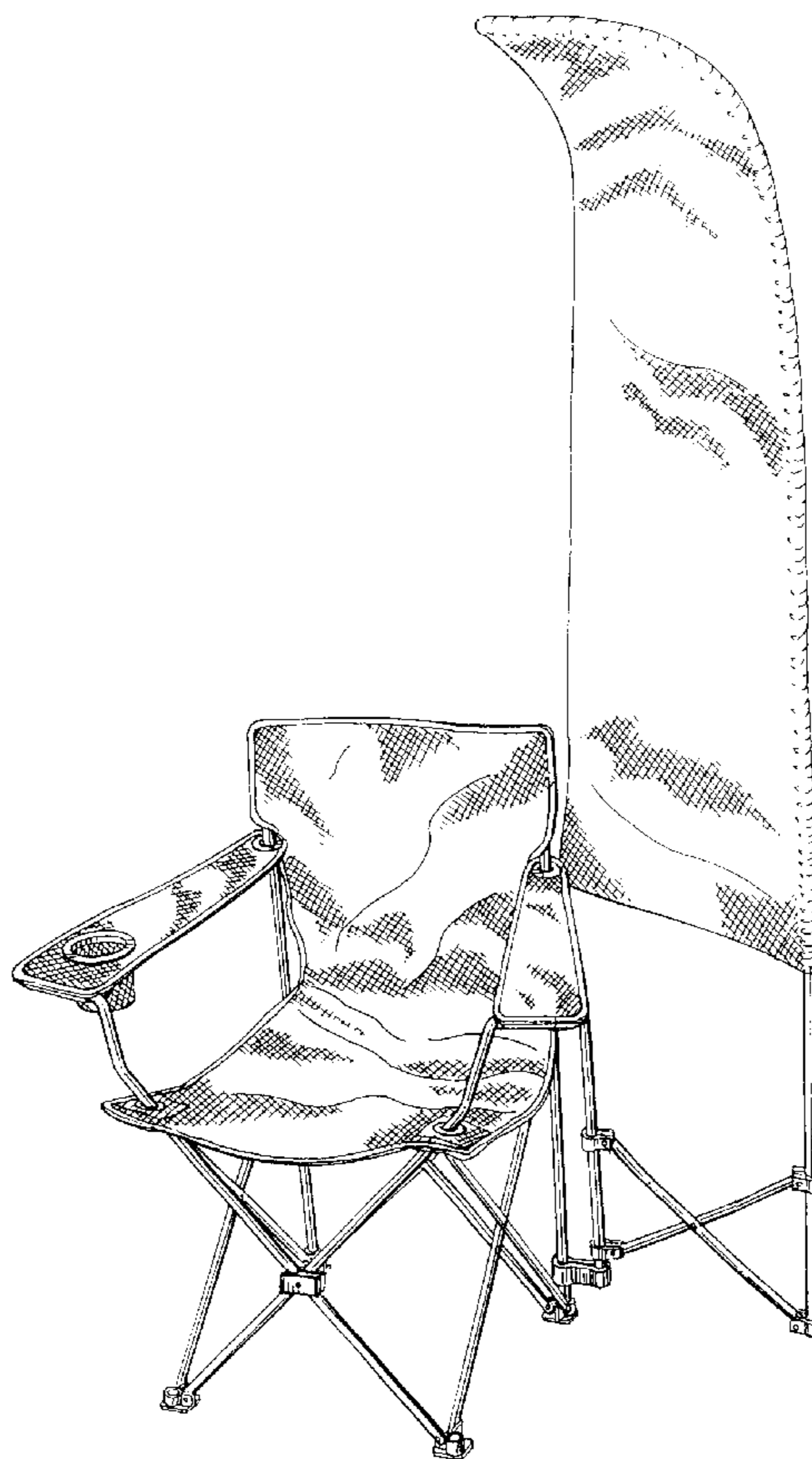

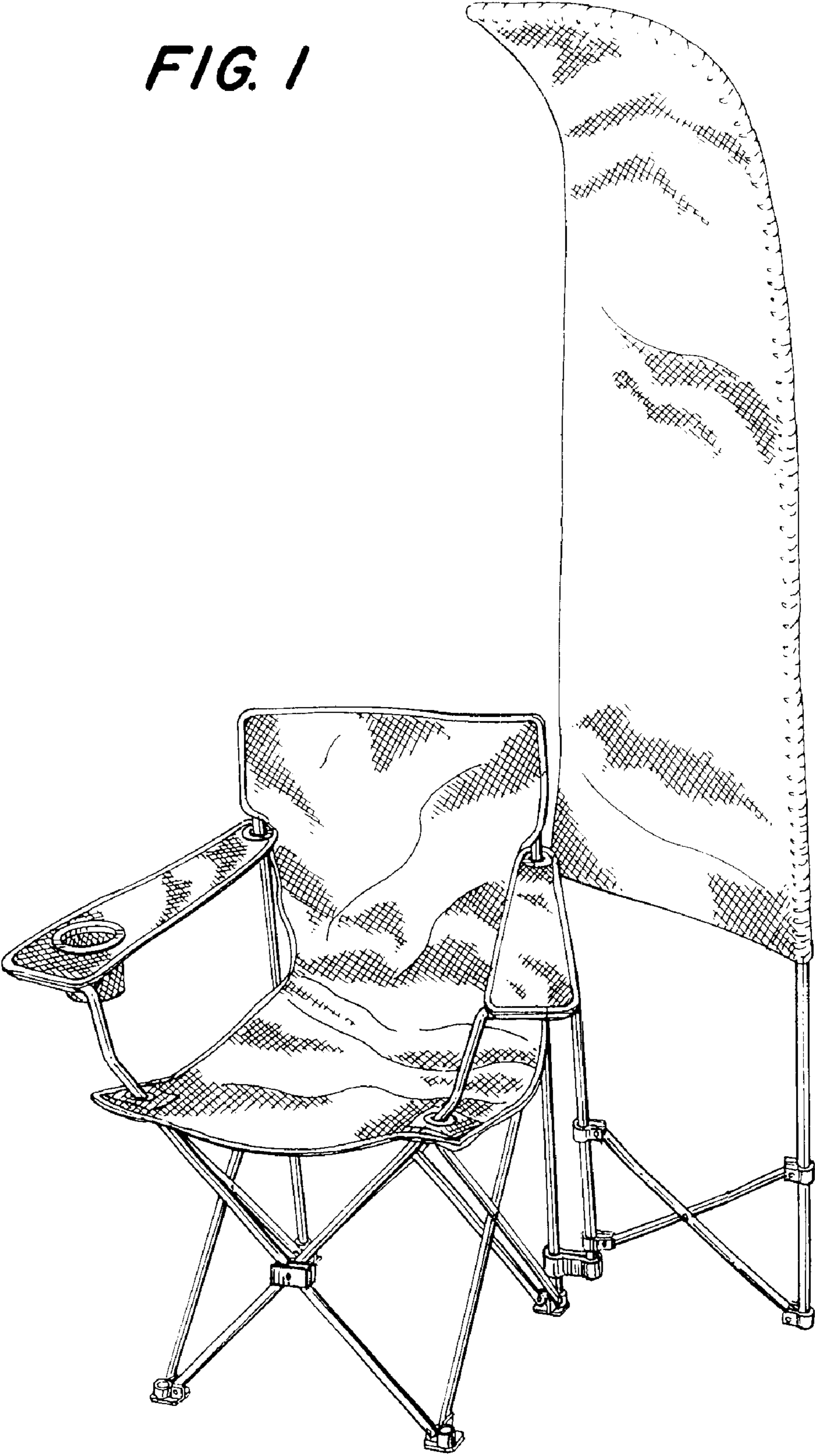

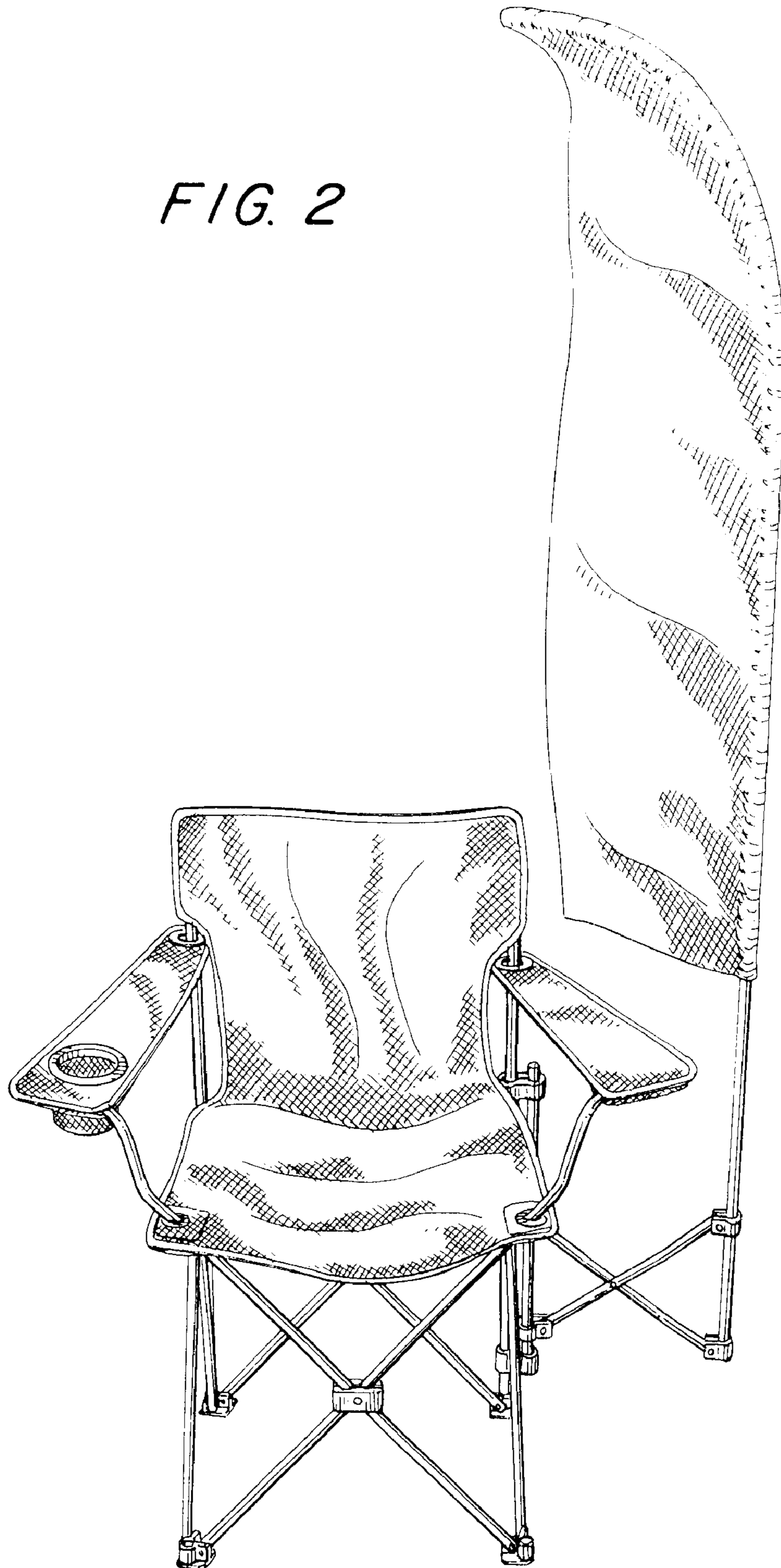

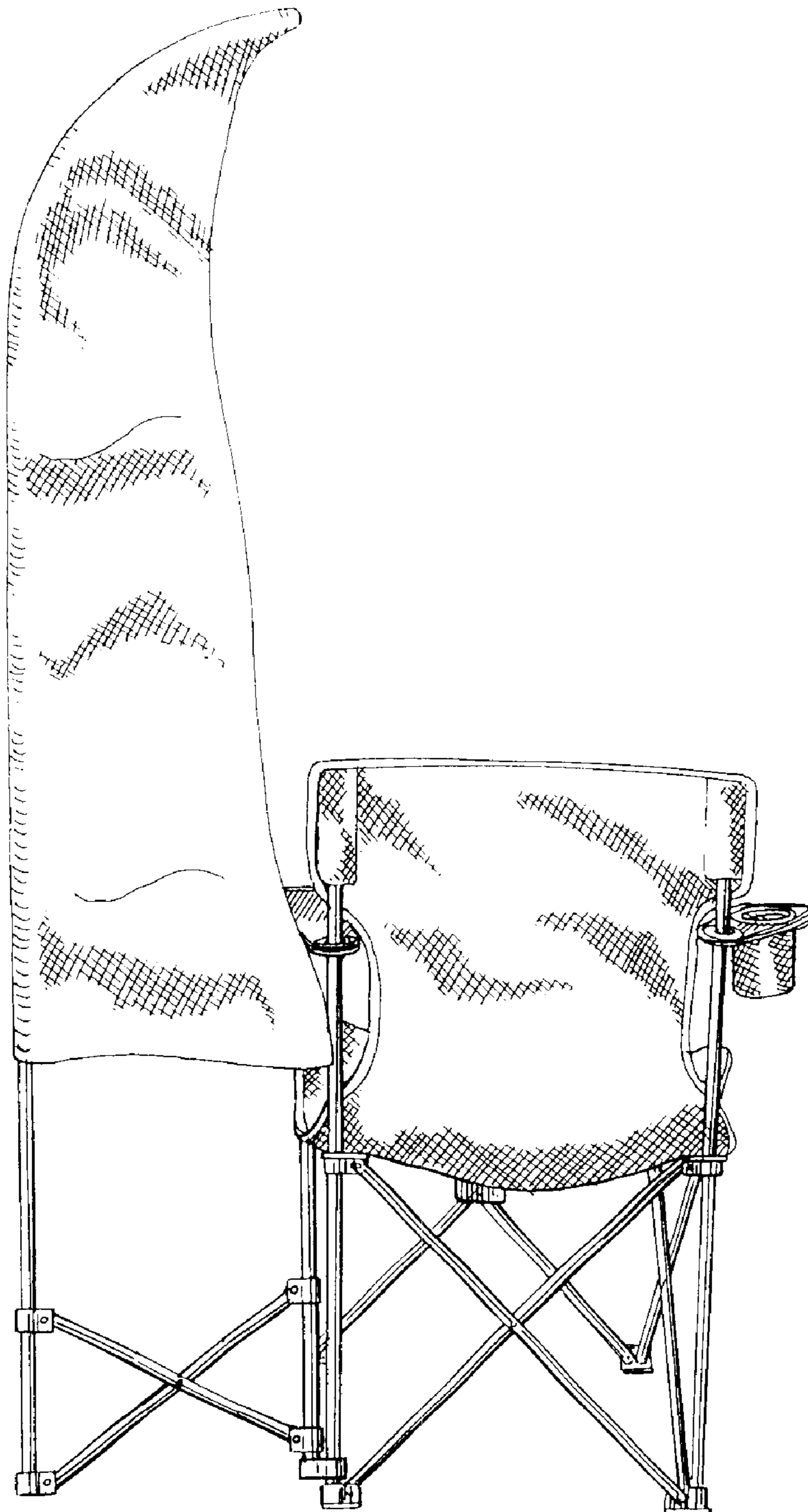
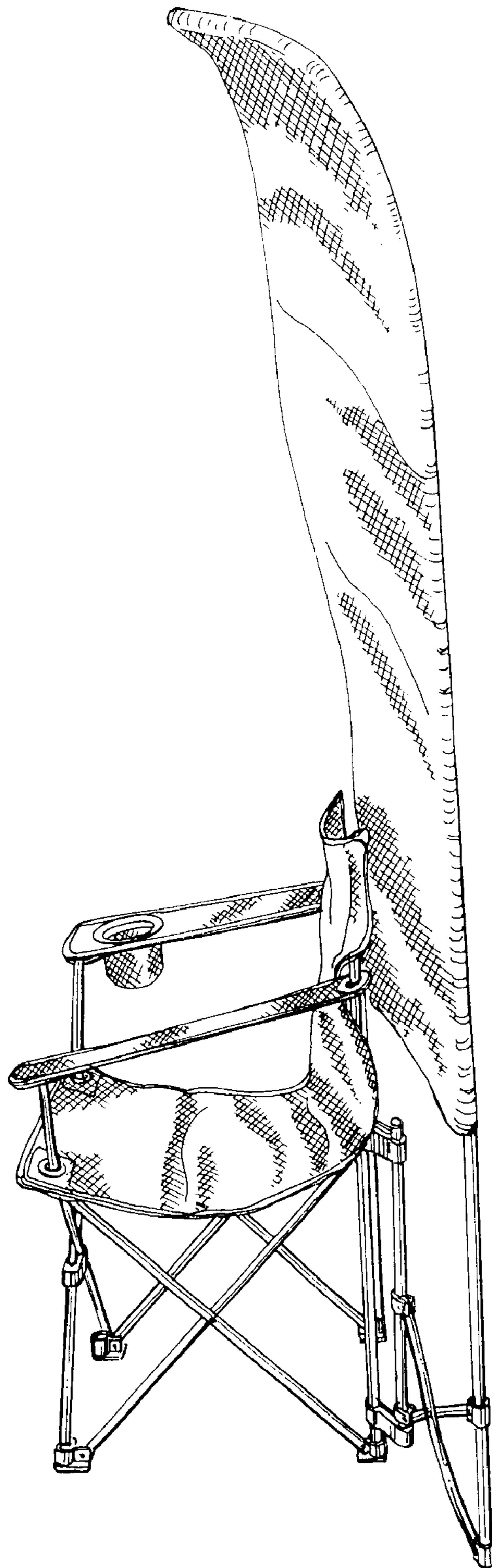

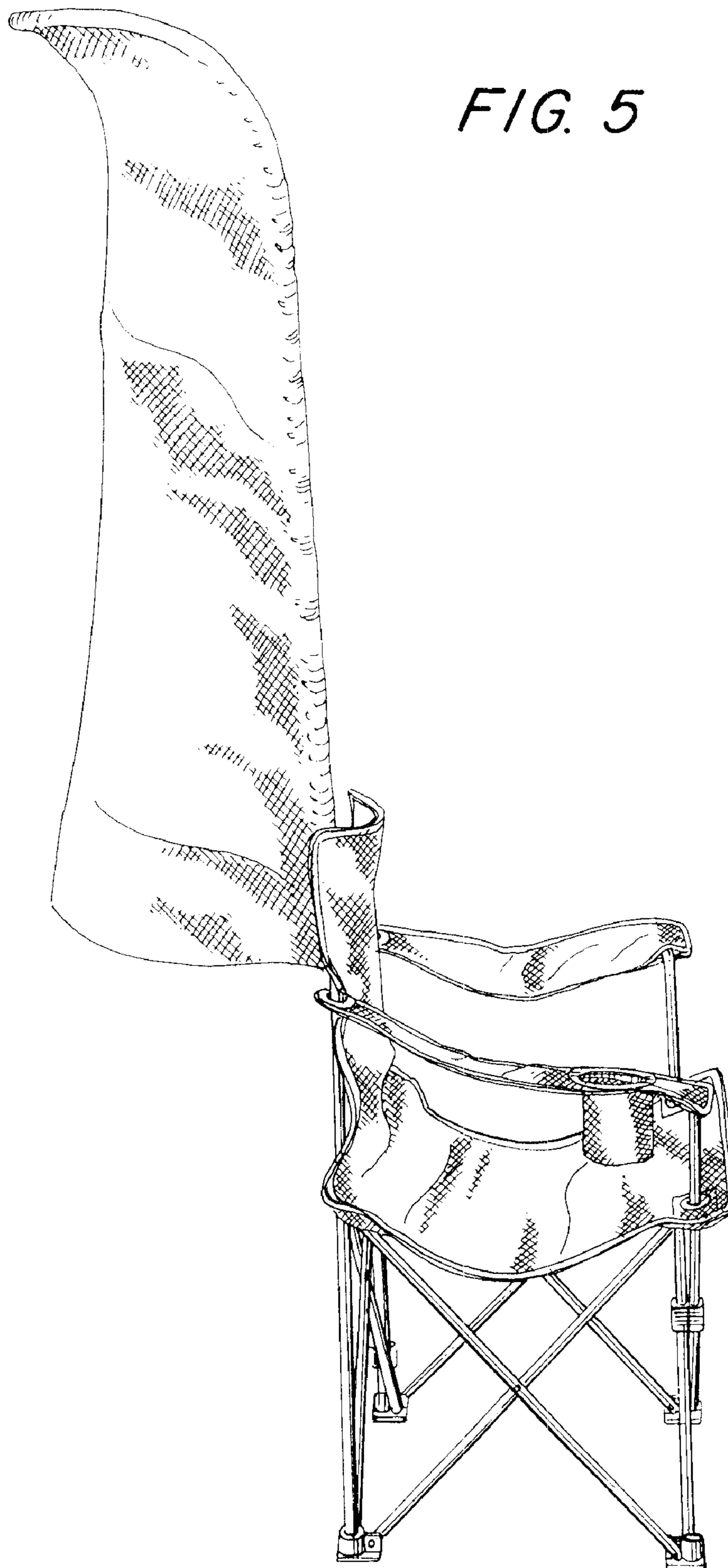

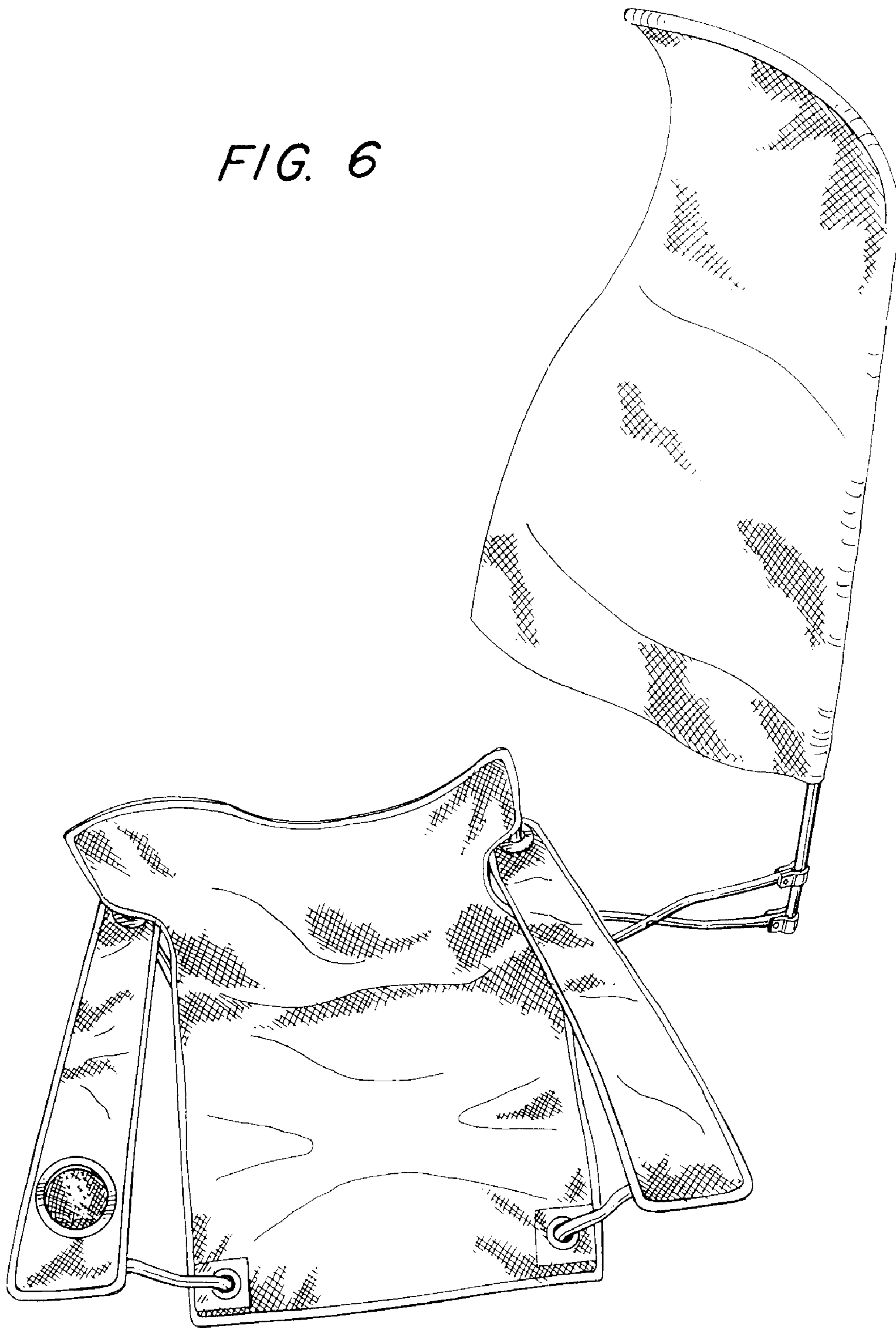
