FIG. 4 is a front view thereof;

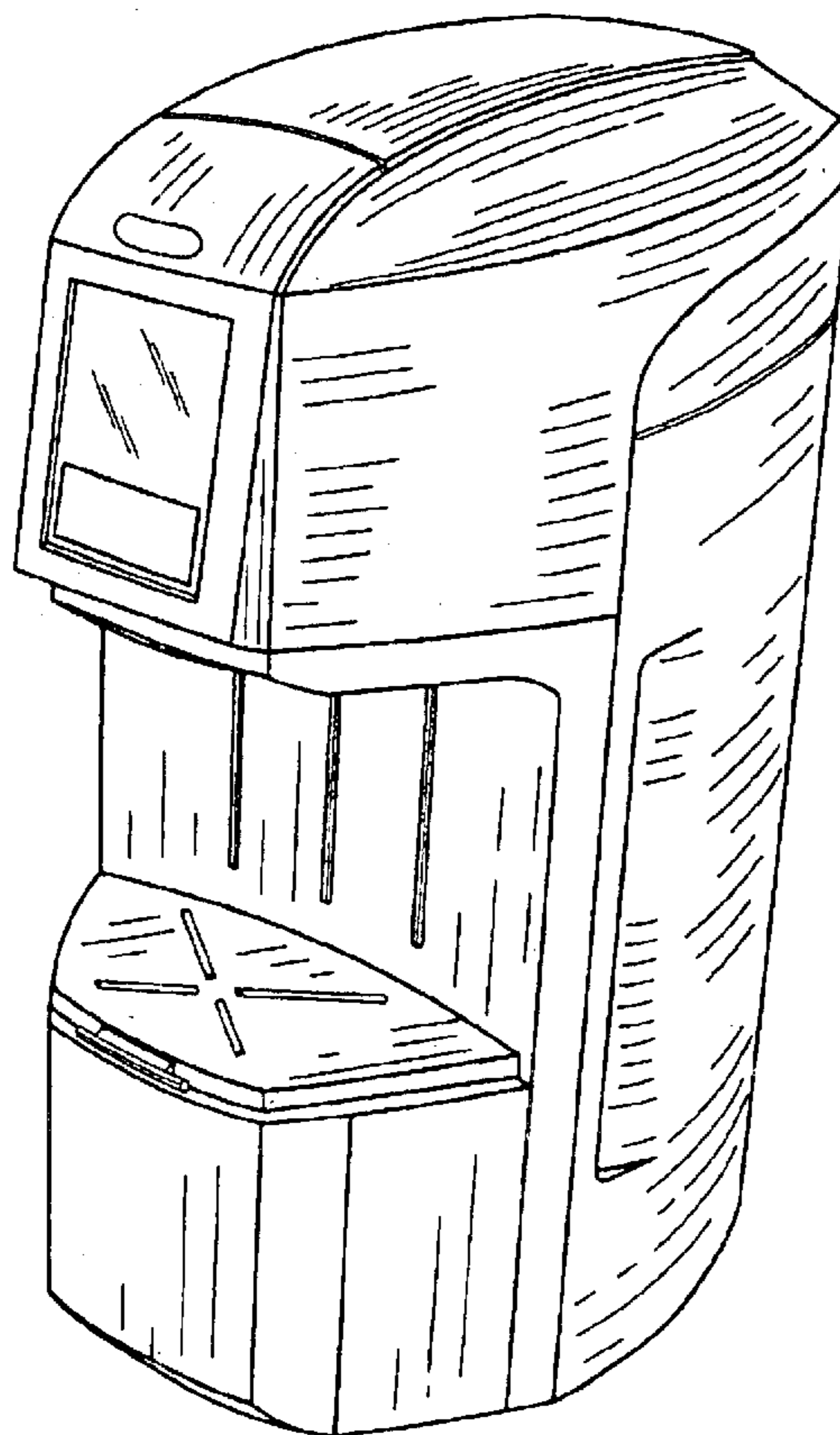
FIG. 5 is a right side view thereof, the left side being a mirror

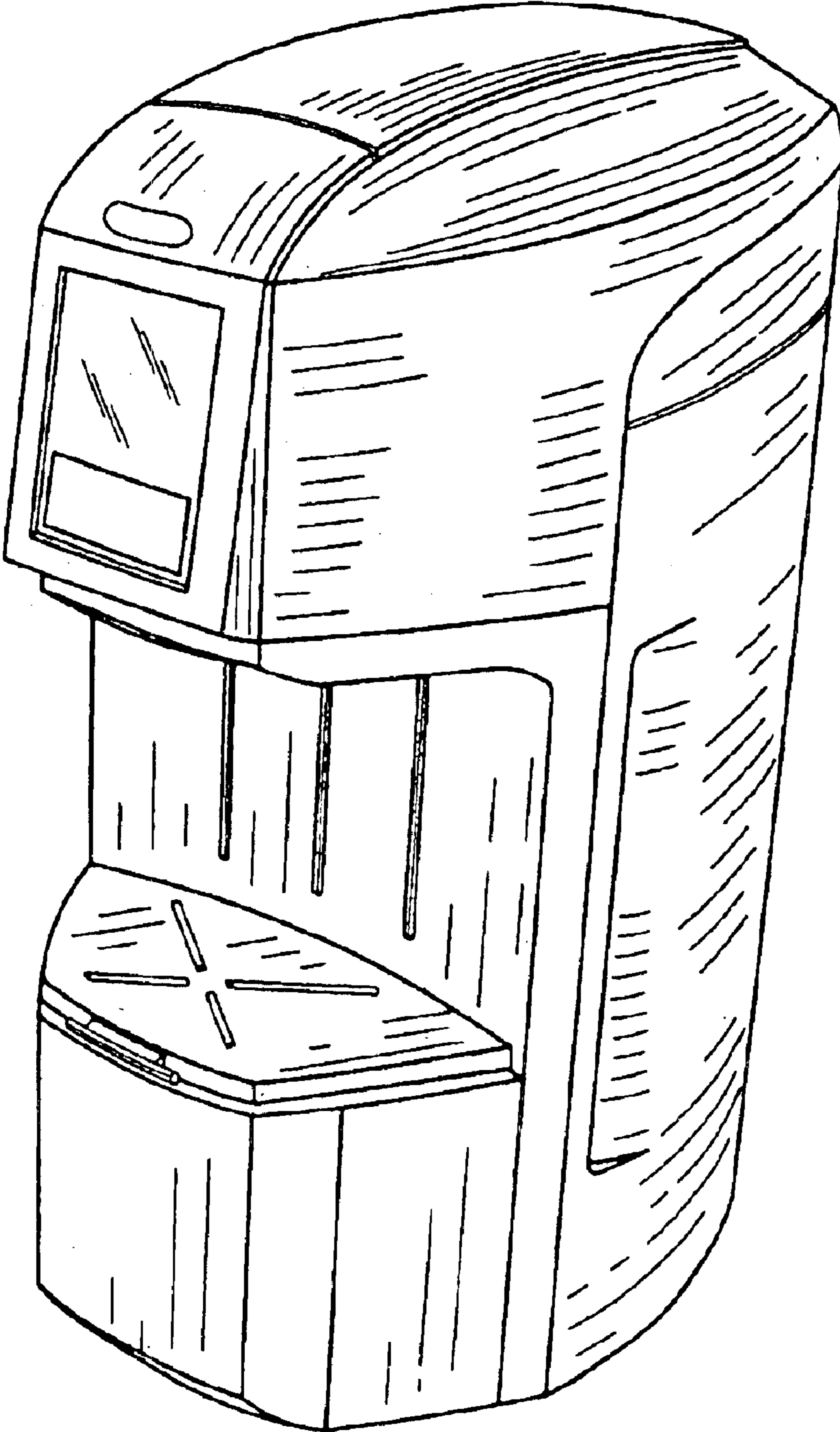

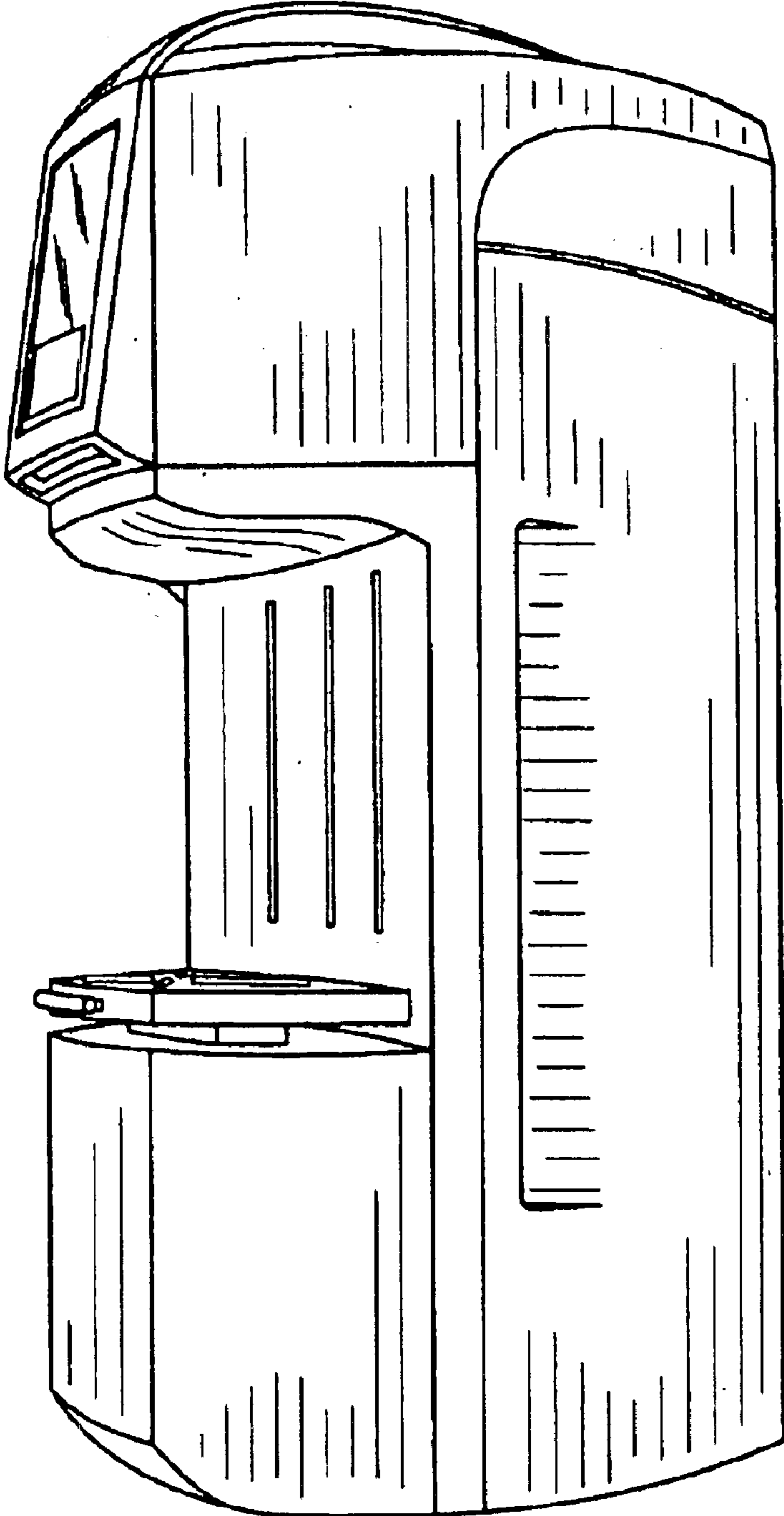

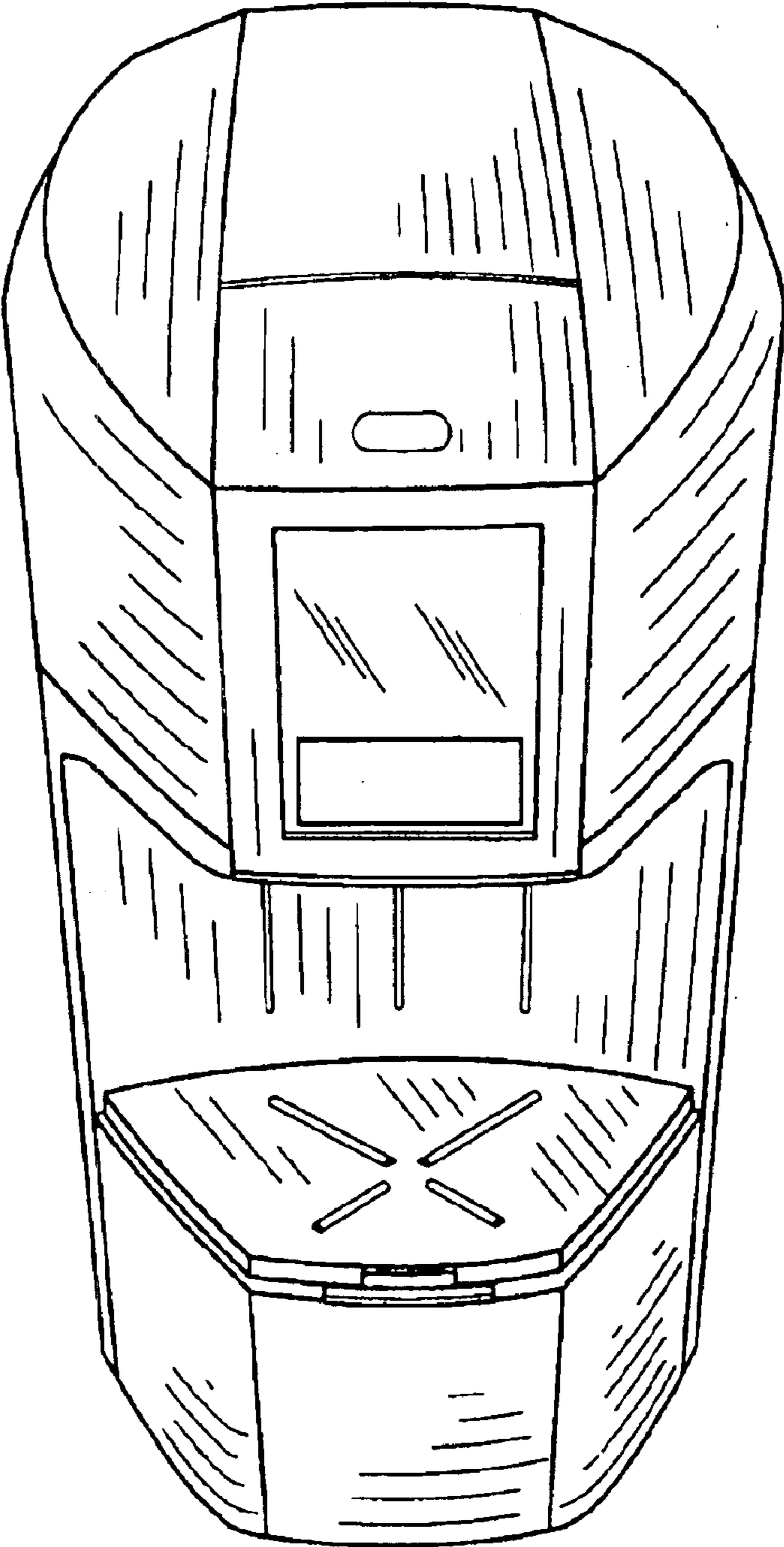

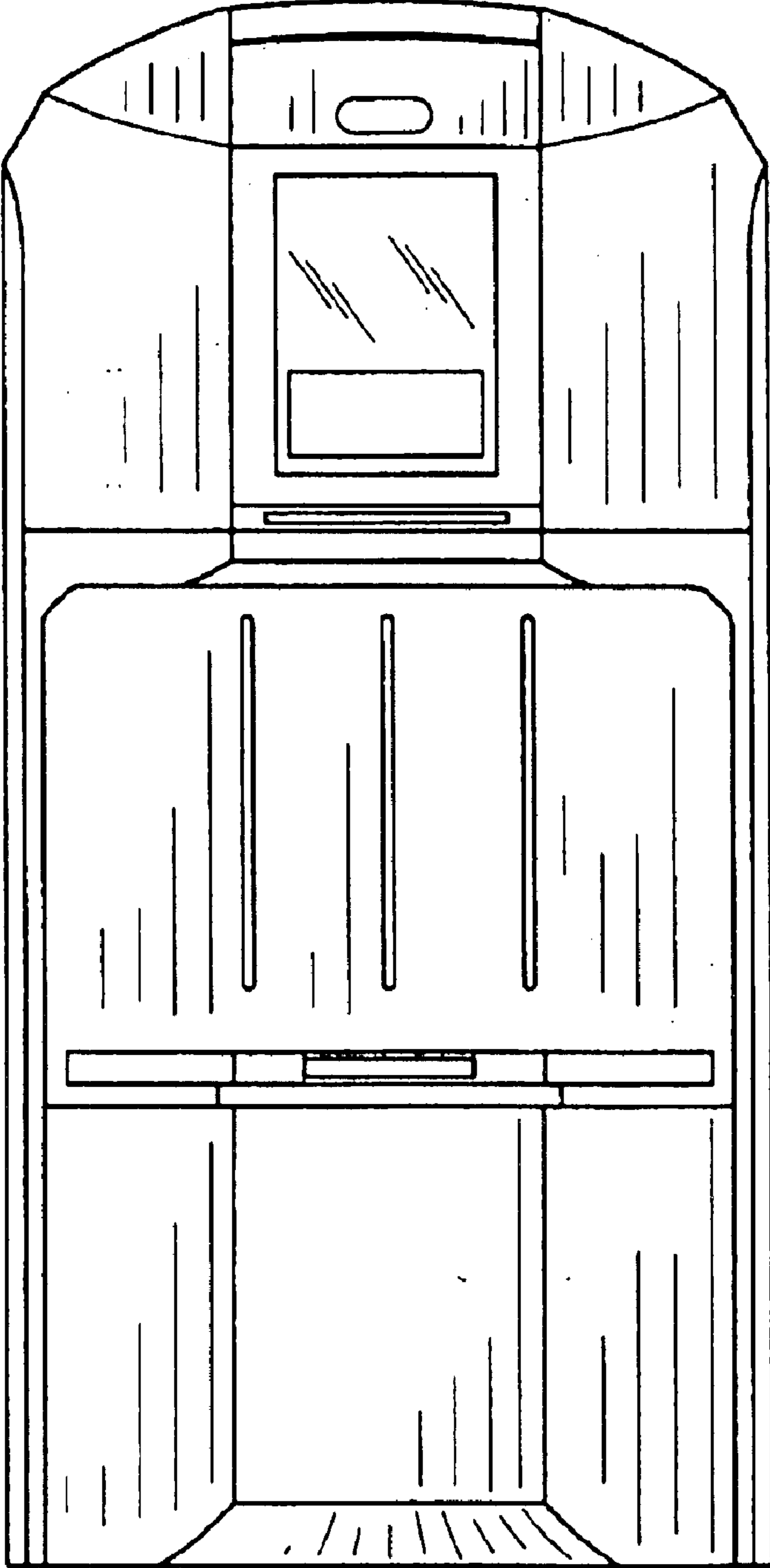

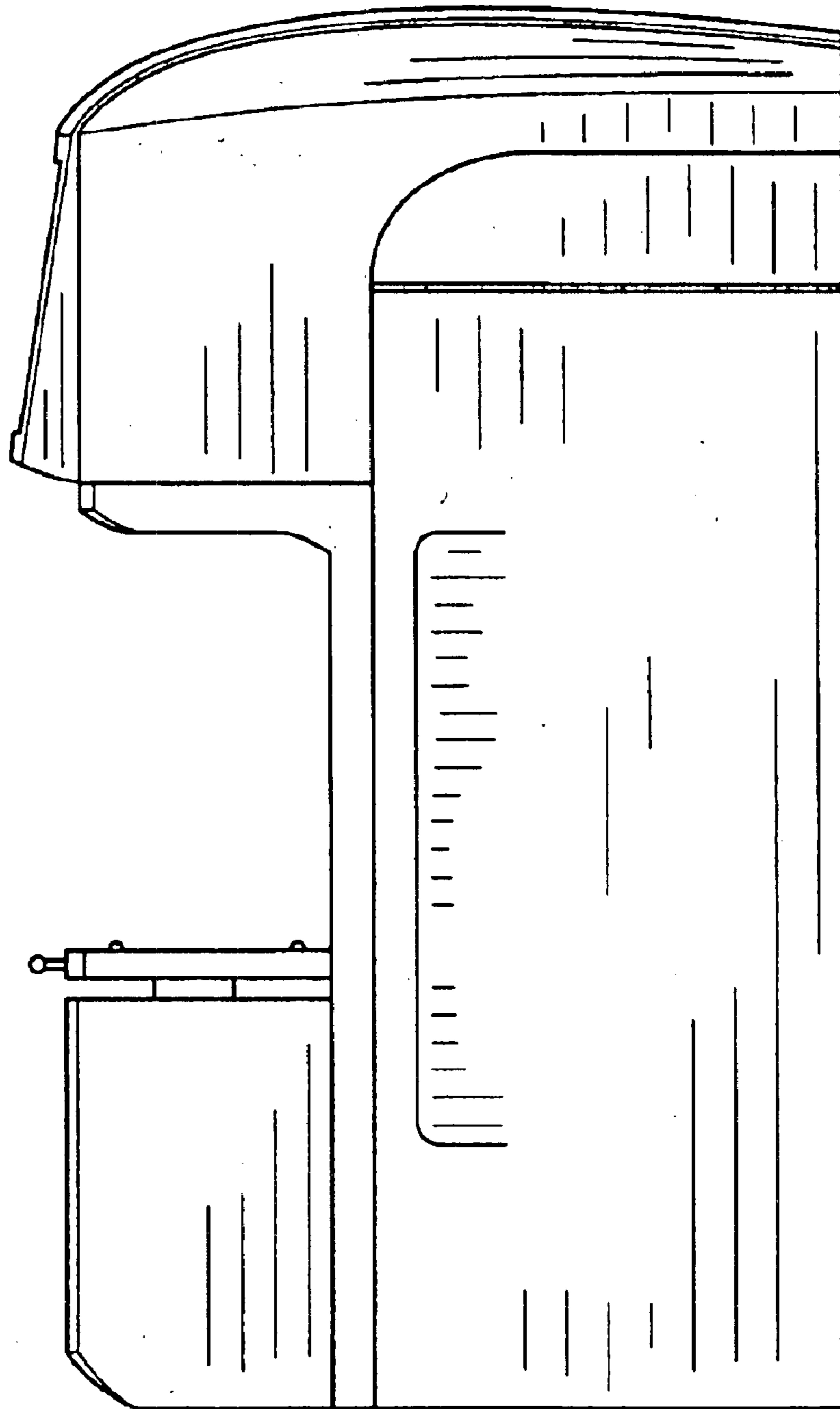

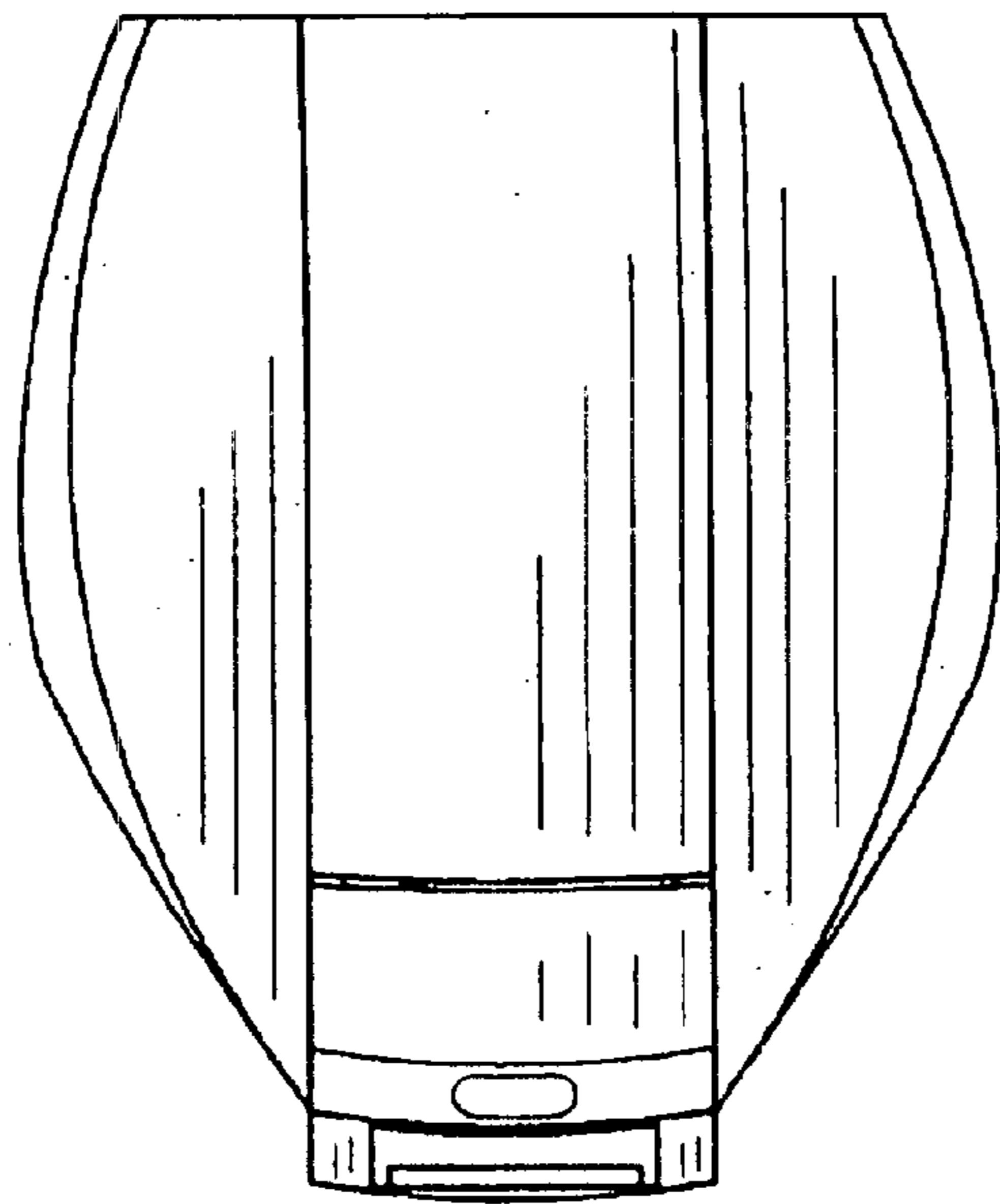

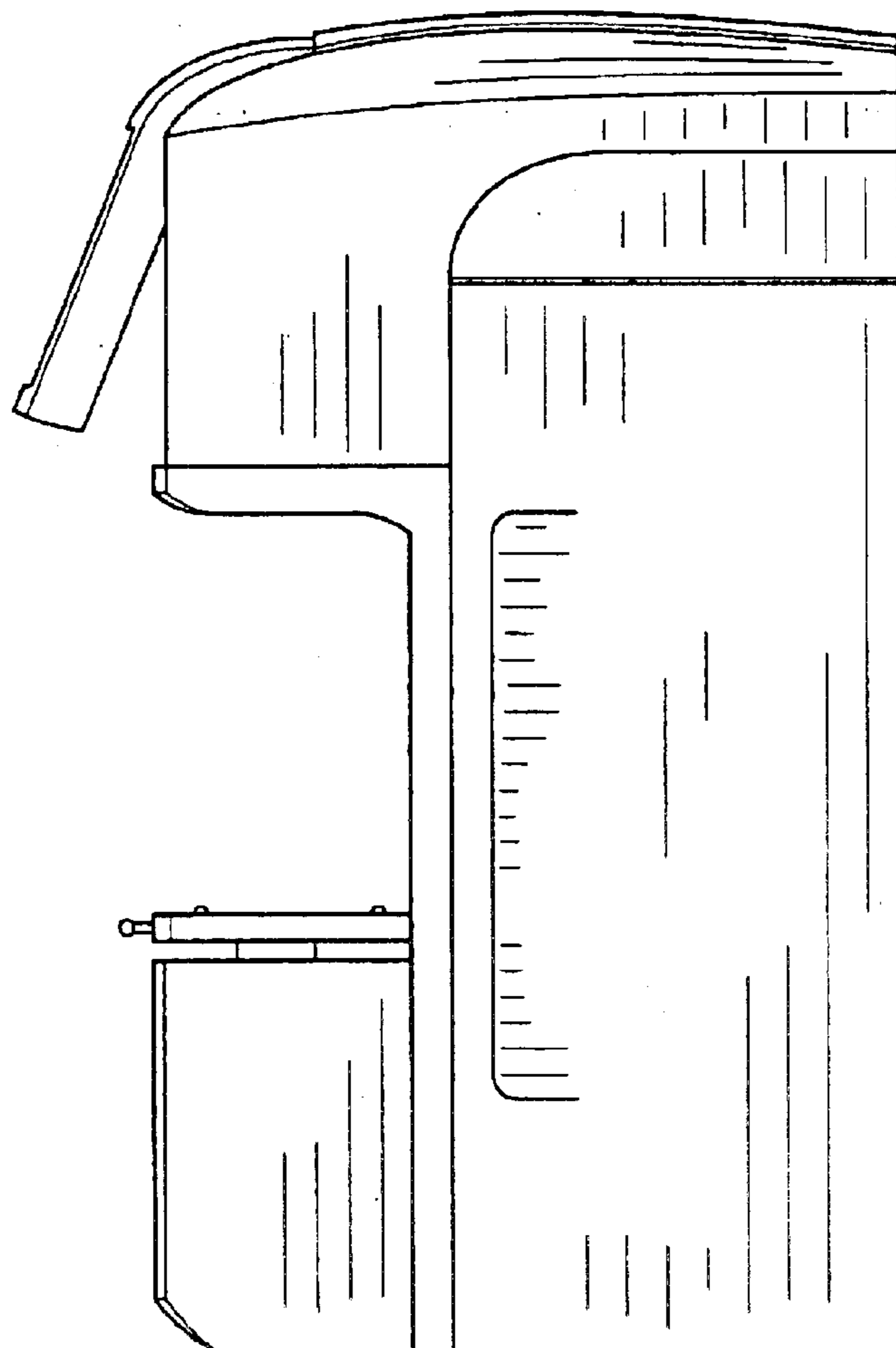
