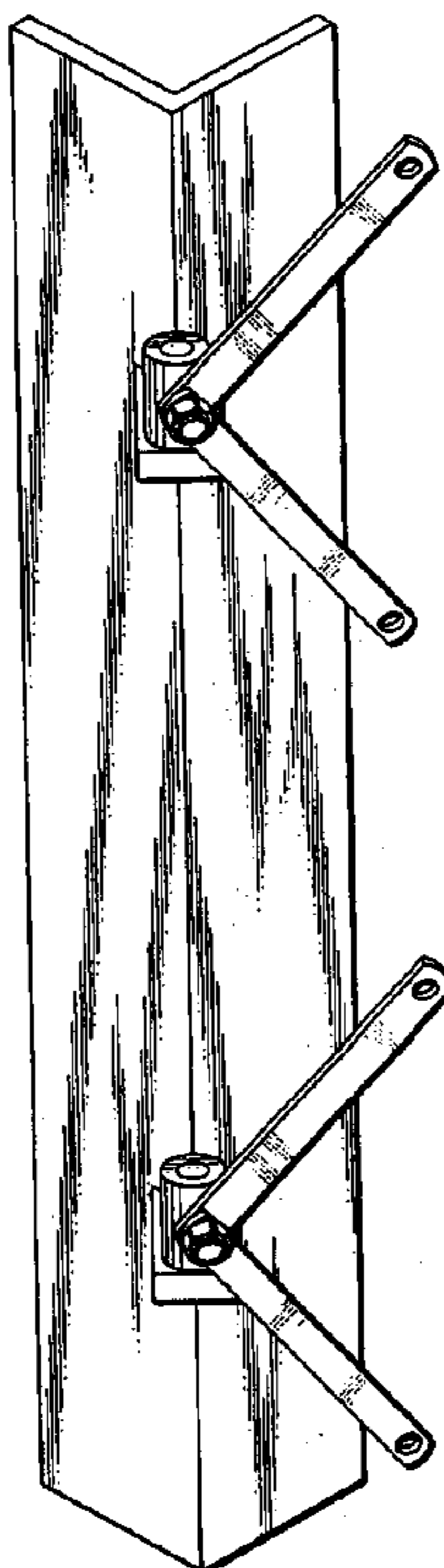
(57) **CLAIM**

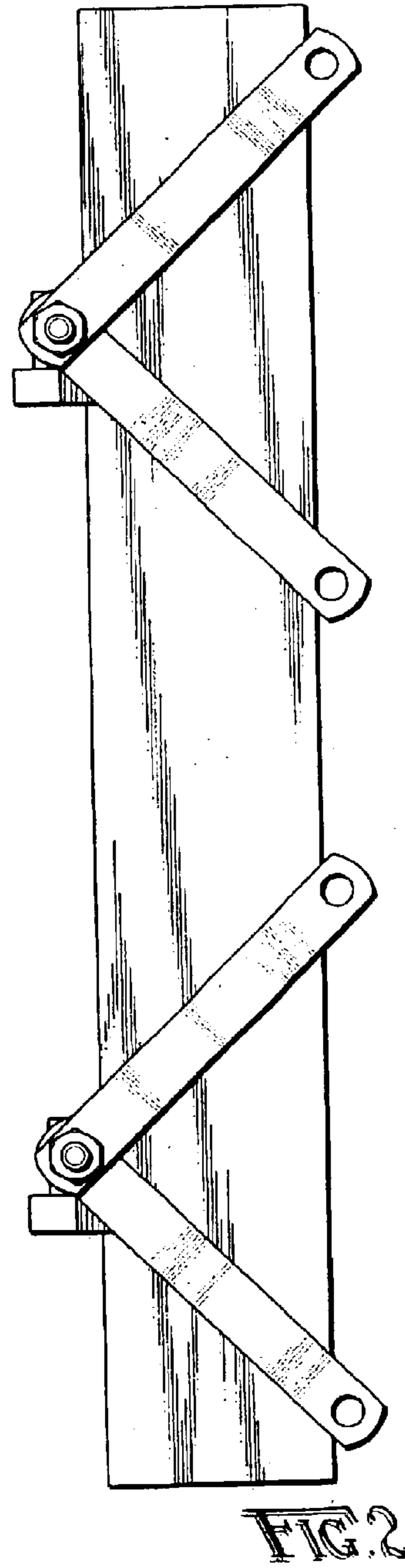
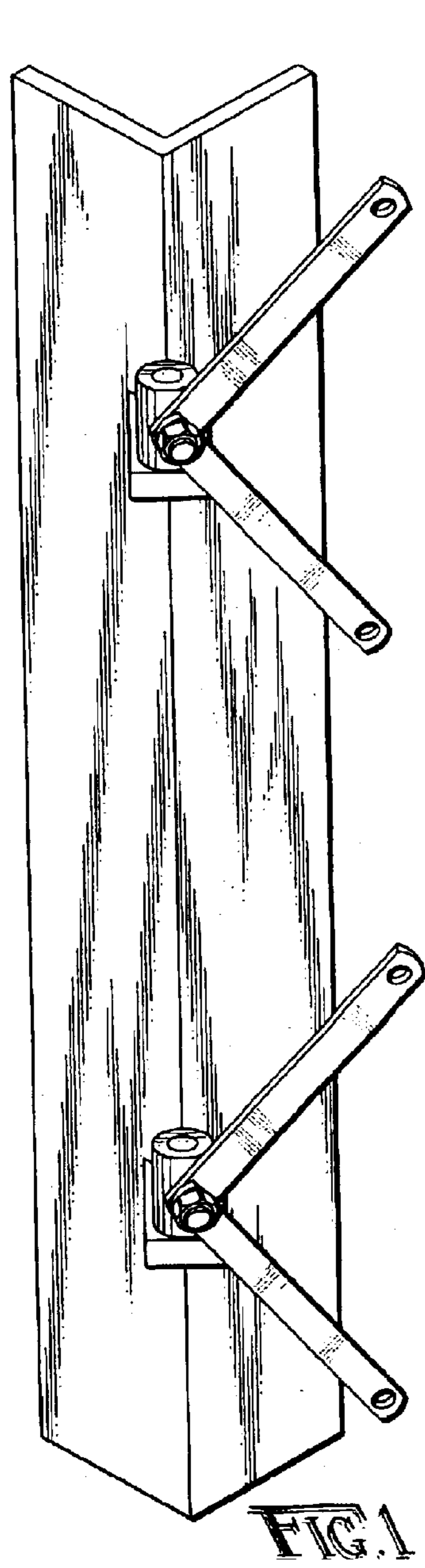
We claim the ornamental design for an 180-degree double hinge with pivoting gate-attaching arms, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an 180-degree double hinge with pivoting gate-attaching arms showing our new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a side elevational view thereof; FIG. 4 is an elevational view of the opposing side thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; and, FIG. 8 is a reduced perspective view showing the 180-degree double hinge with pivoting gate-attaching arms in use with the arms in a closed position in solid lines; the broken lines depict environmental structure for illustrative purposes only and form no part of the claimed design.

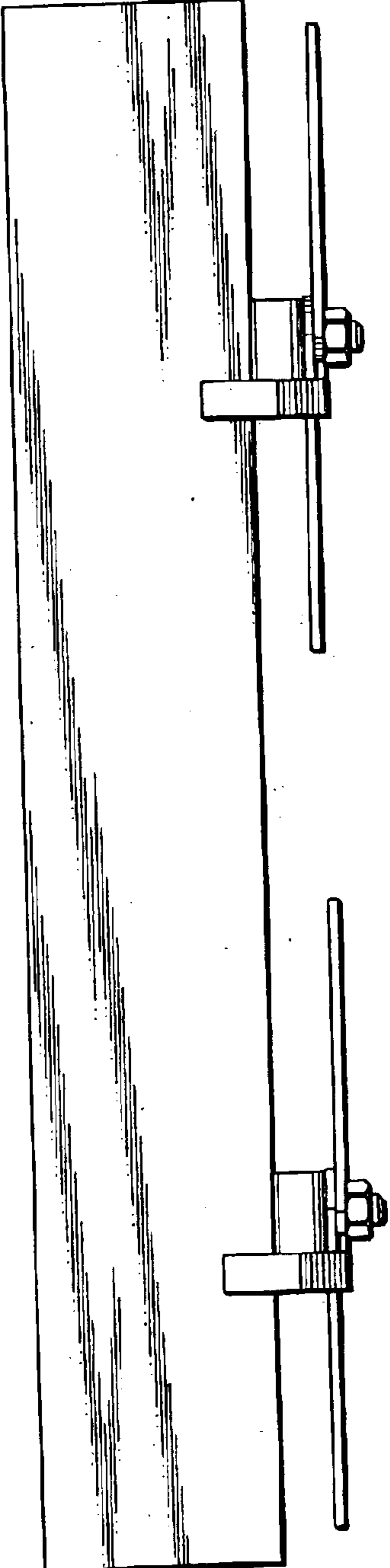

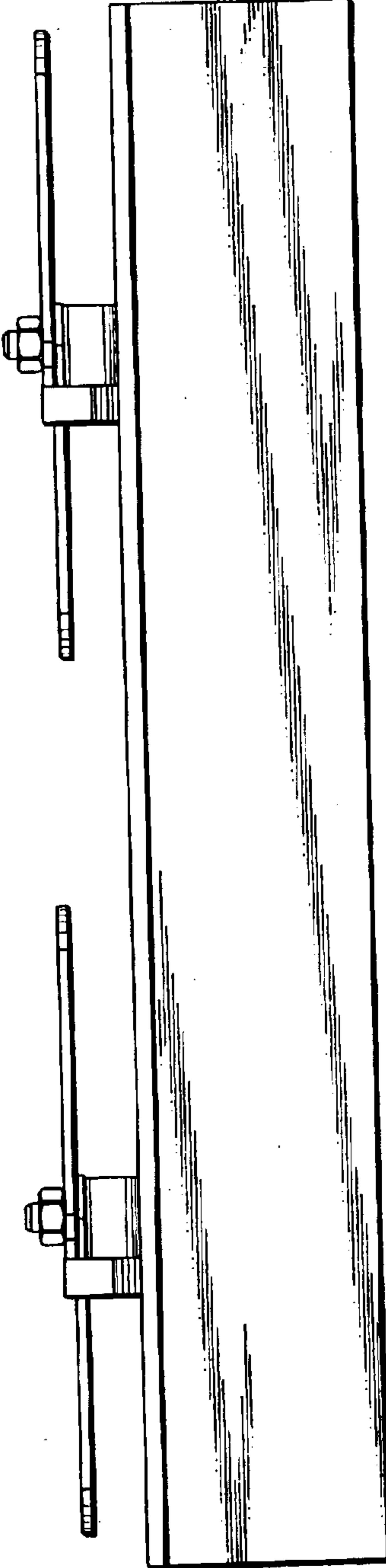

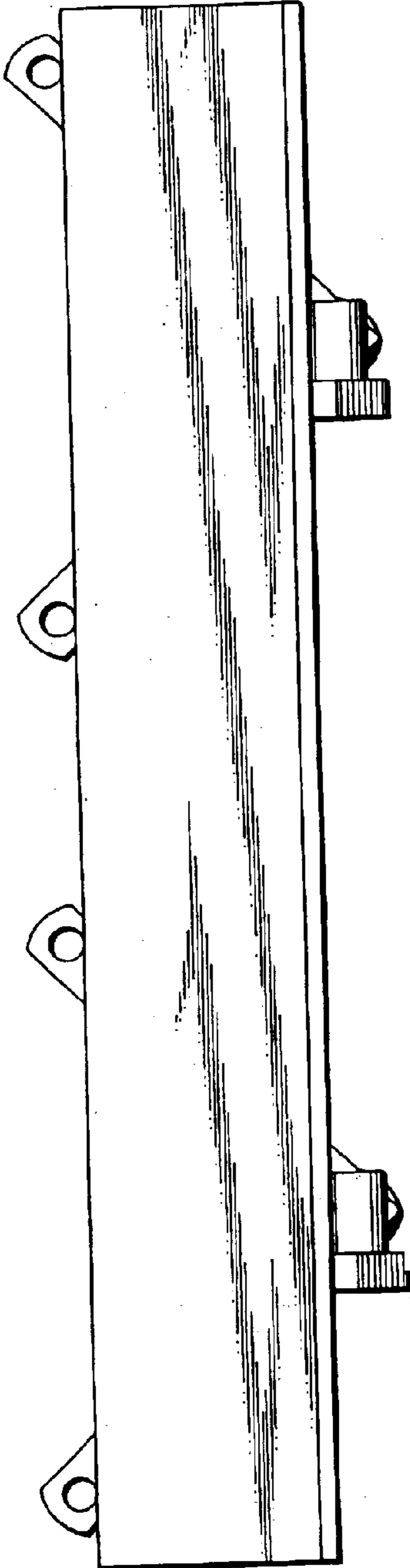

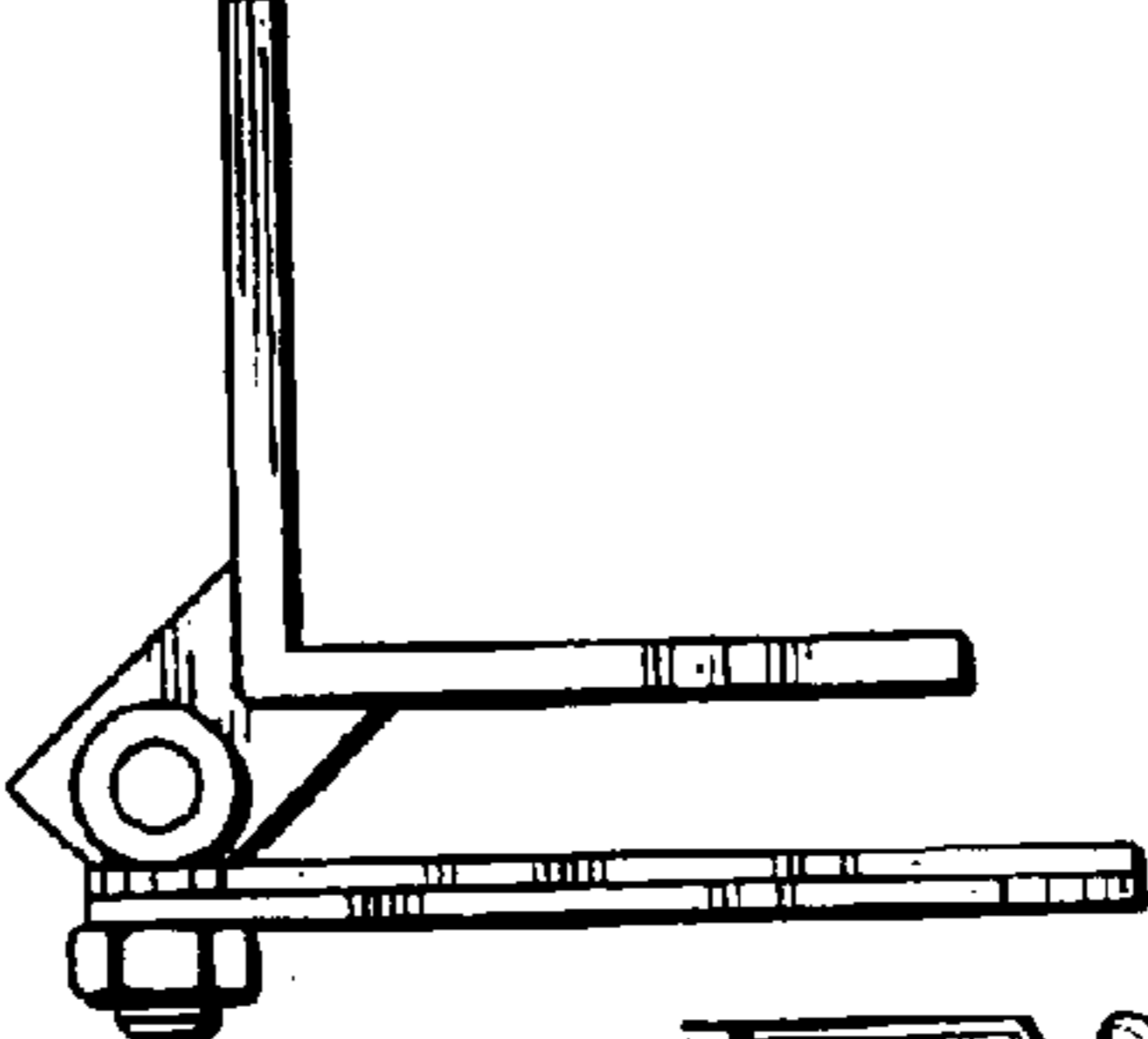

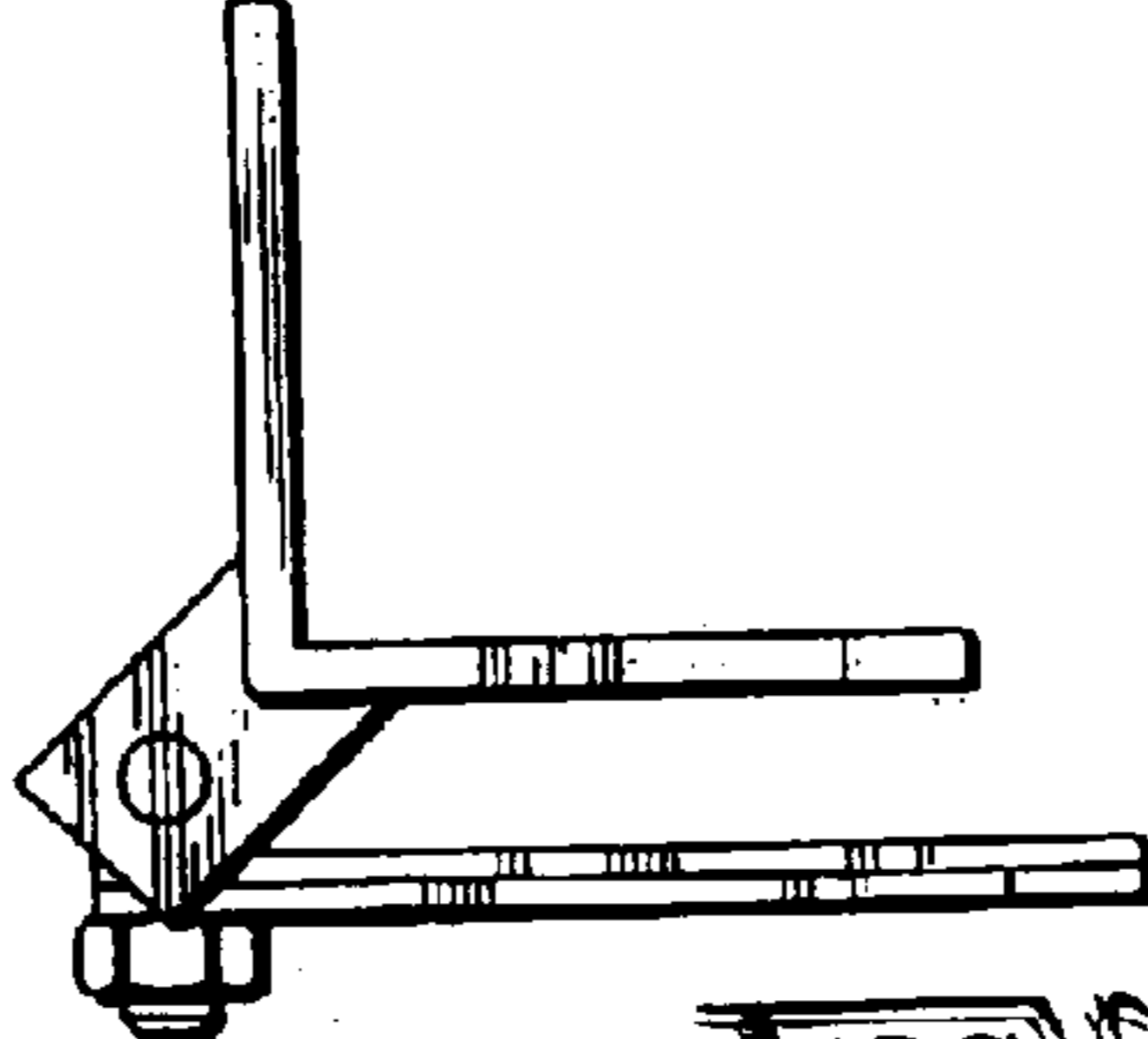

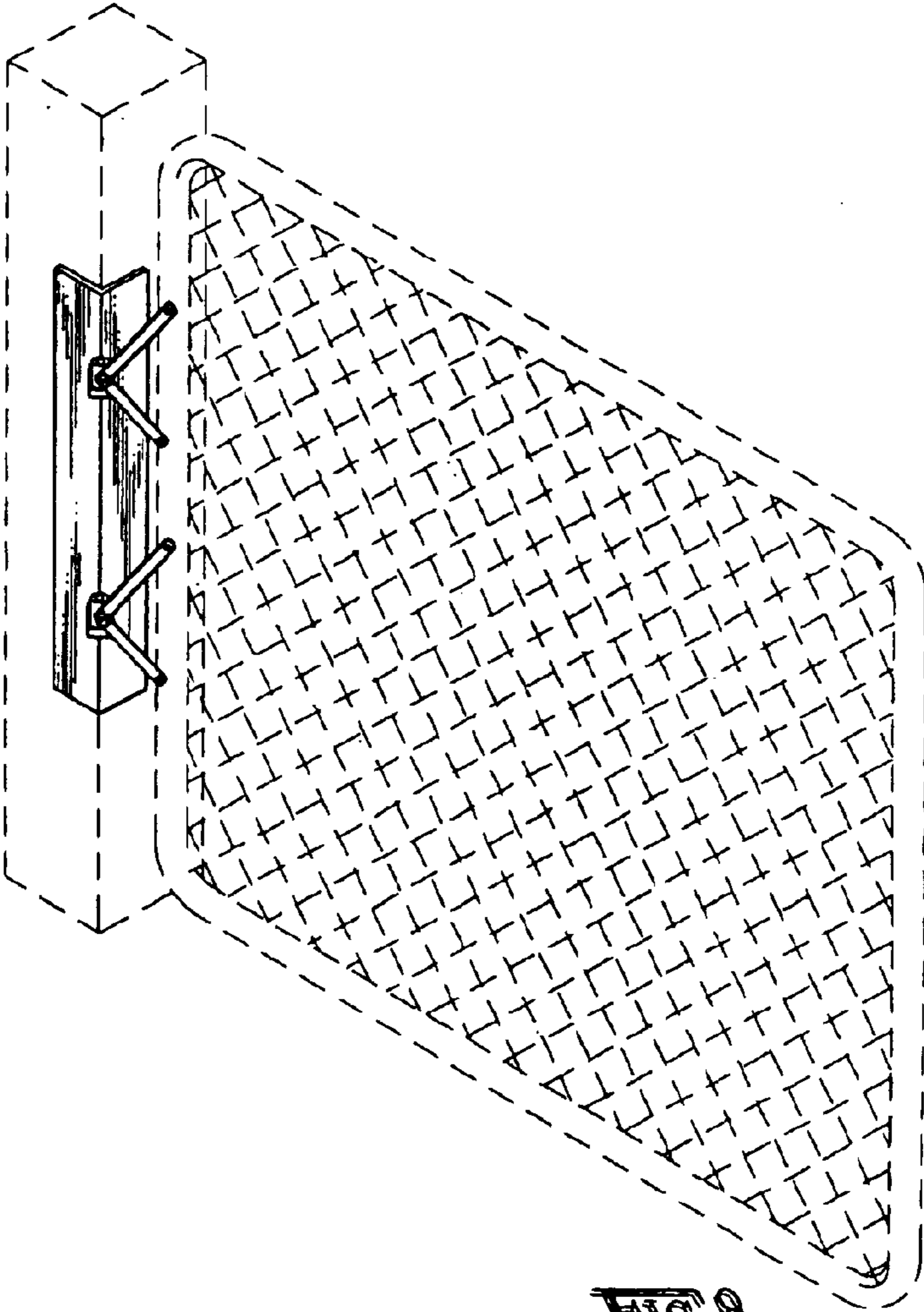
