(57) **CLAIM**

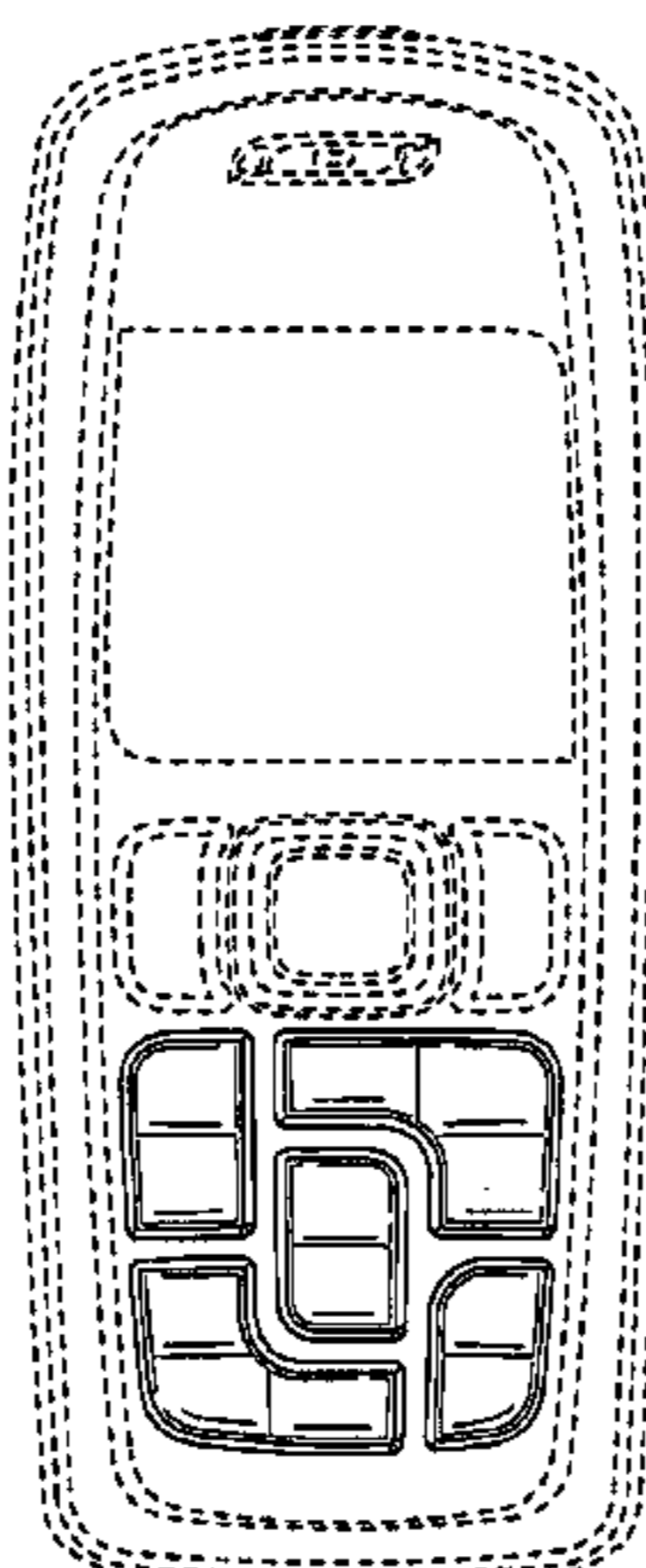
The ornamental design for a key button arrangement for a handset, as shown and described.

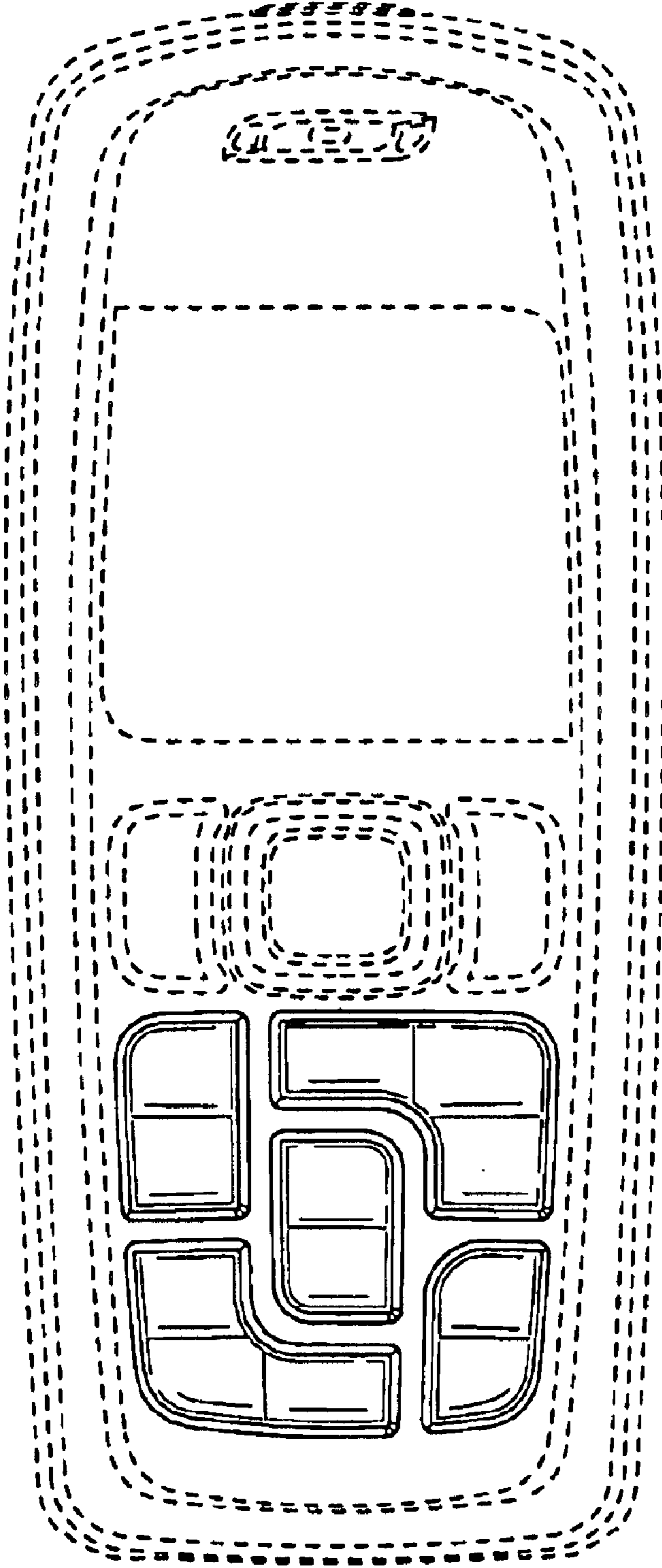

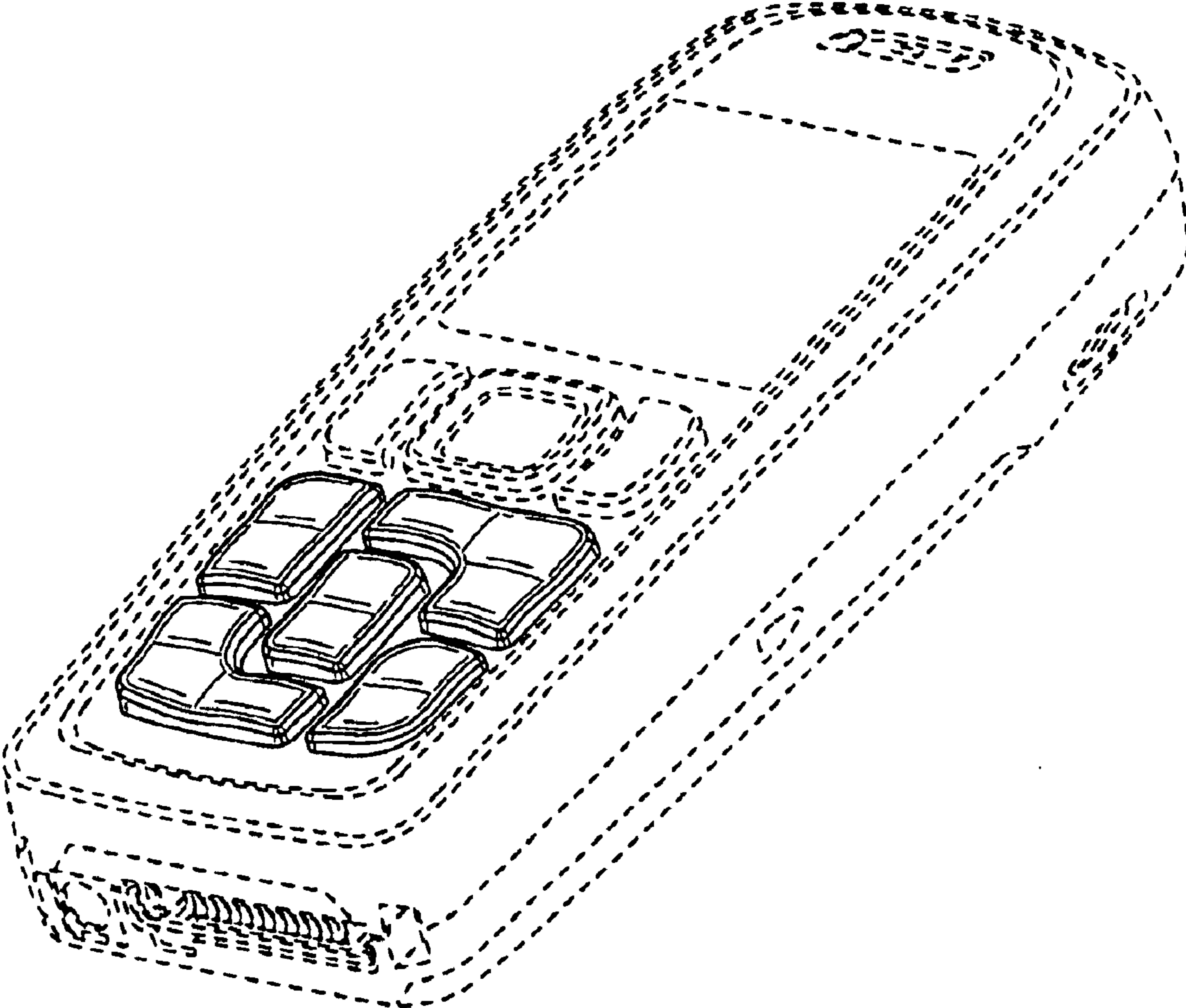
