DESCRIPTION

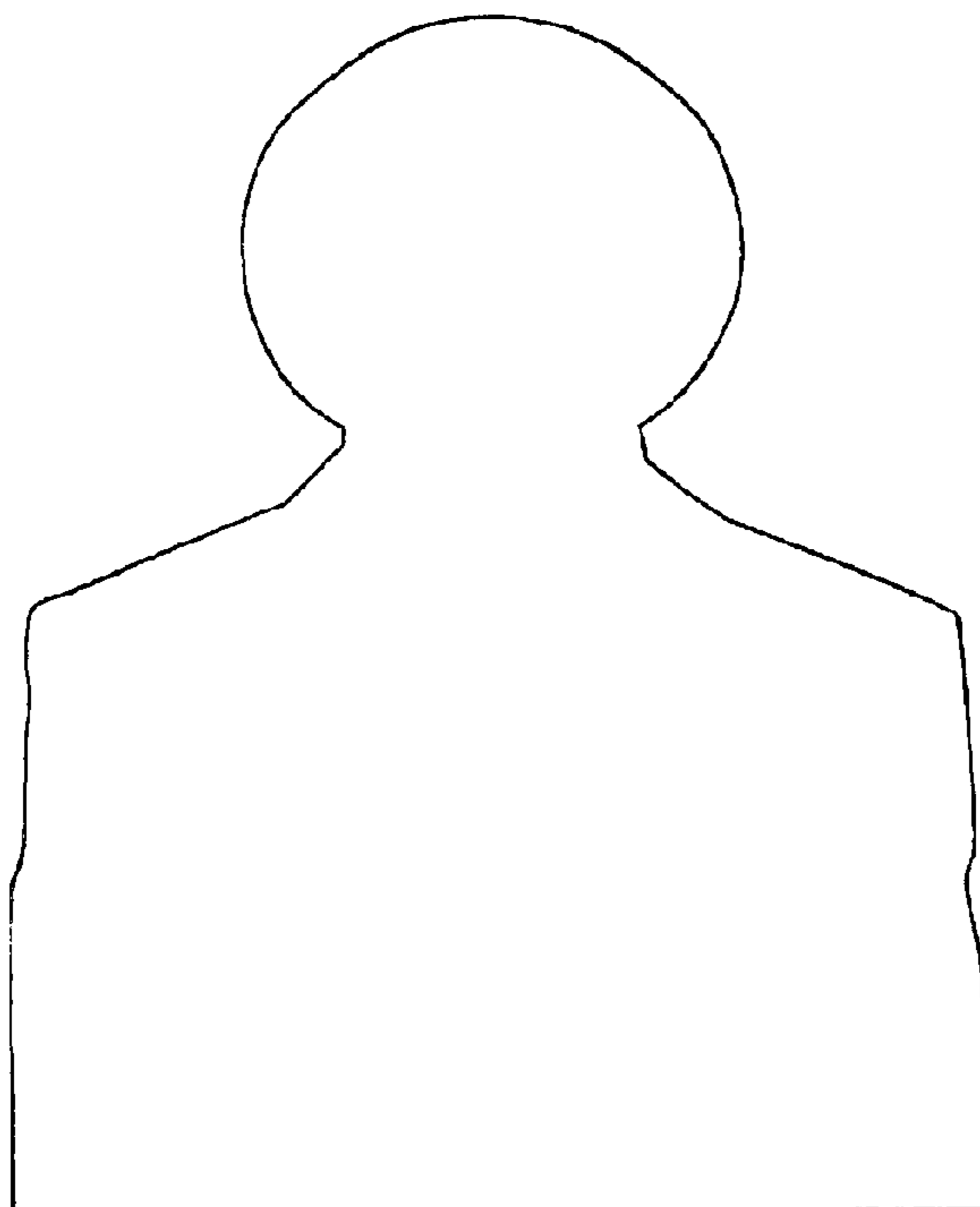
FIG. 1 is a front elevational view of a first embodiment of a greeting card showing my new design;

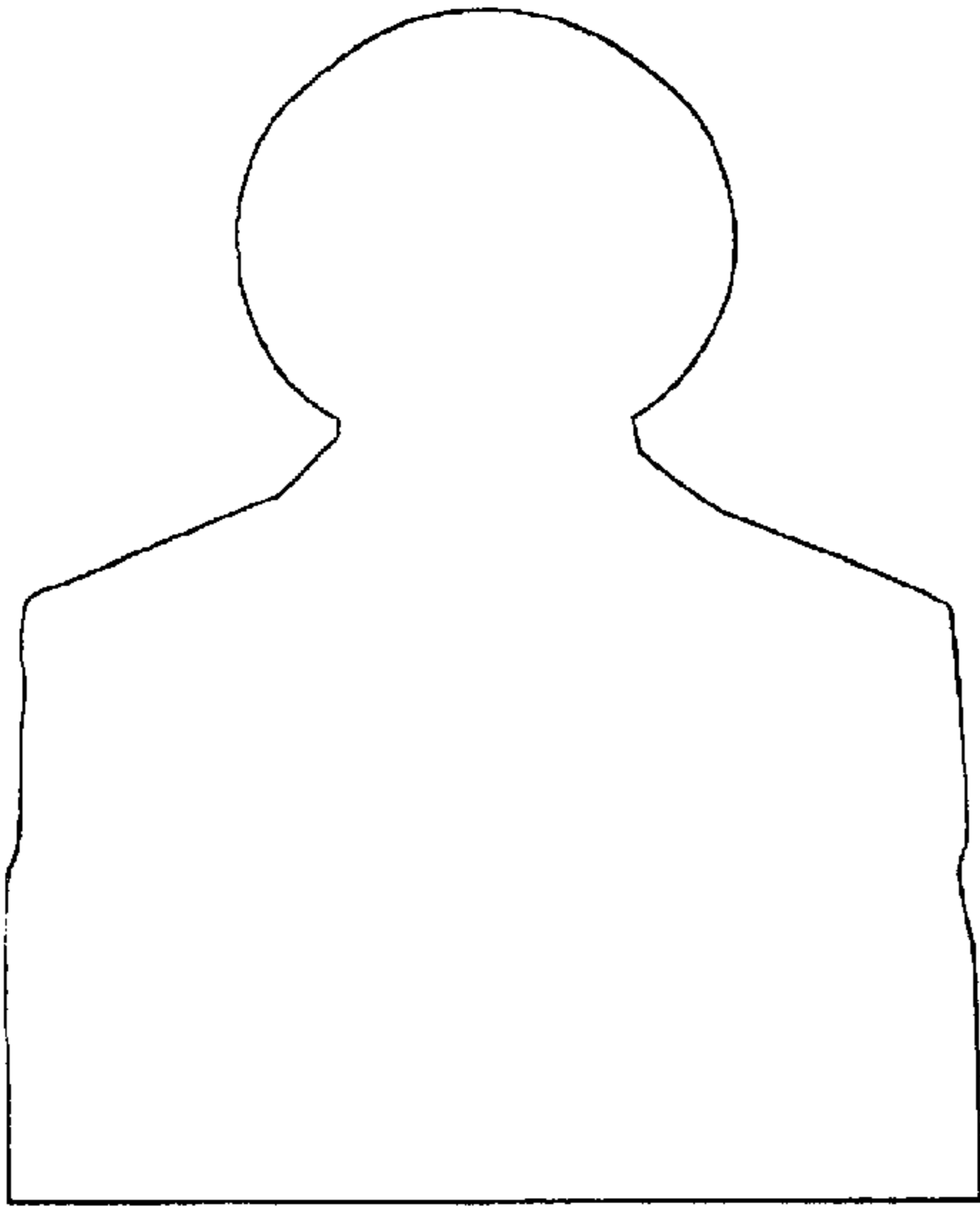

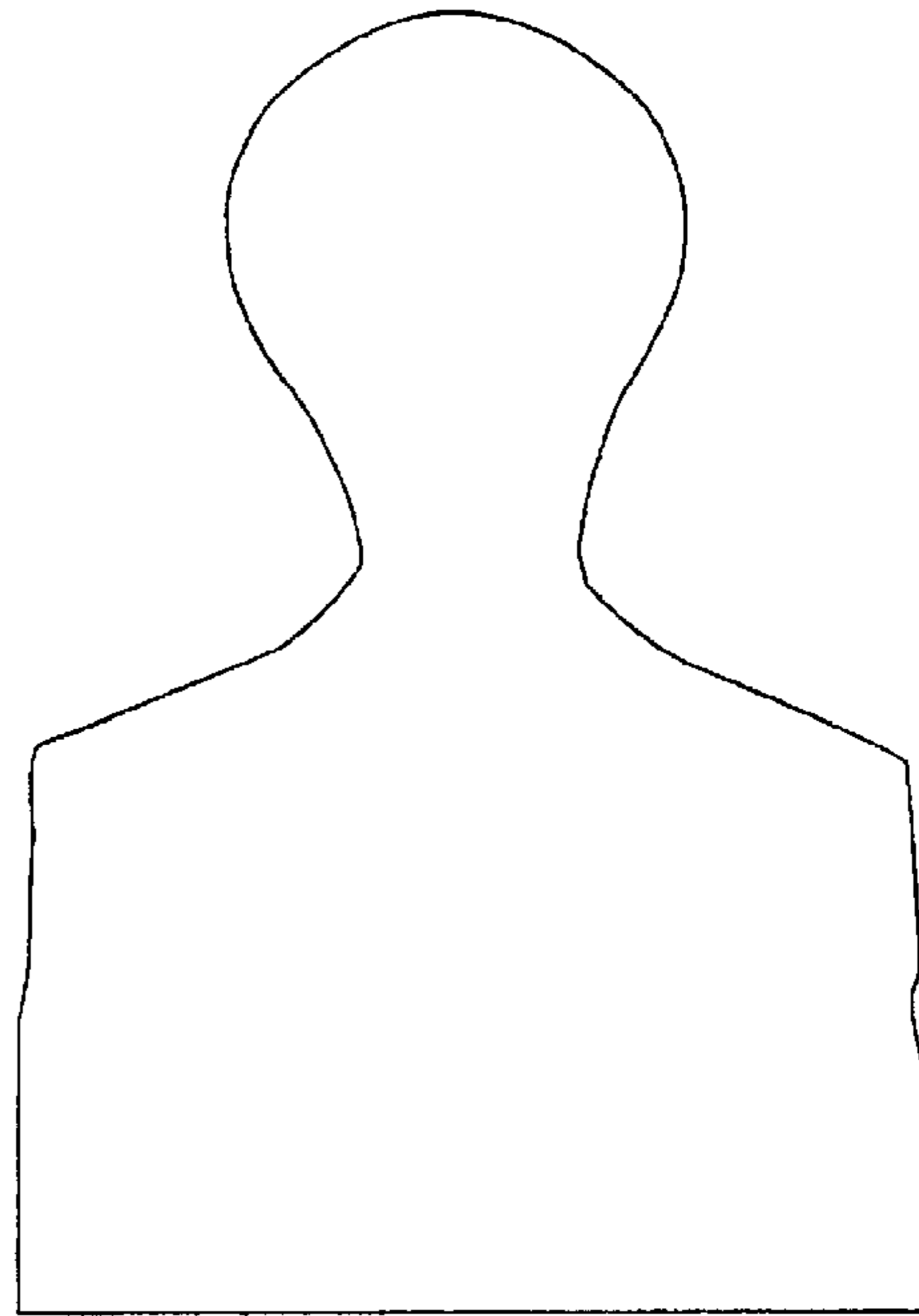

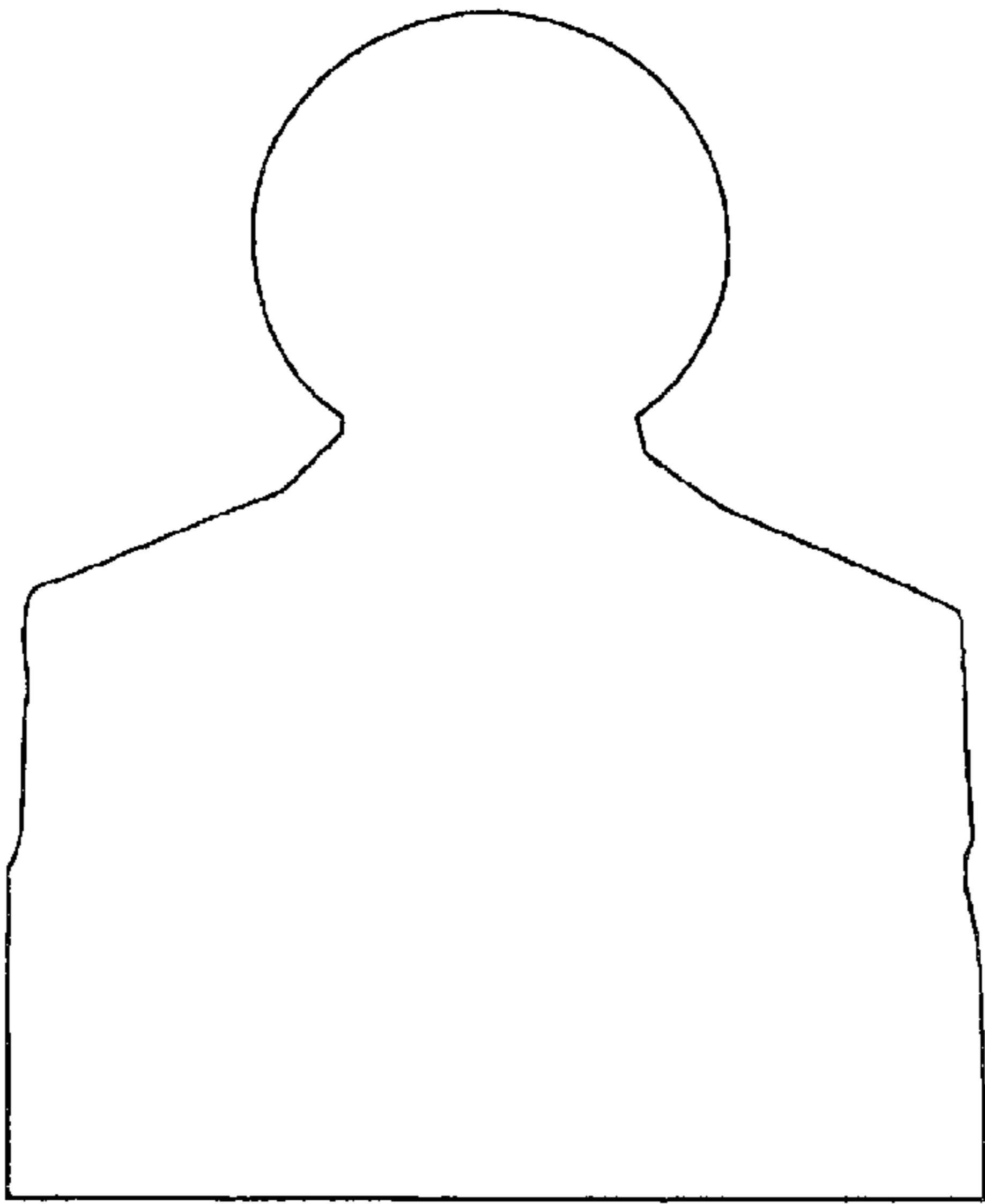

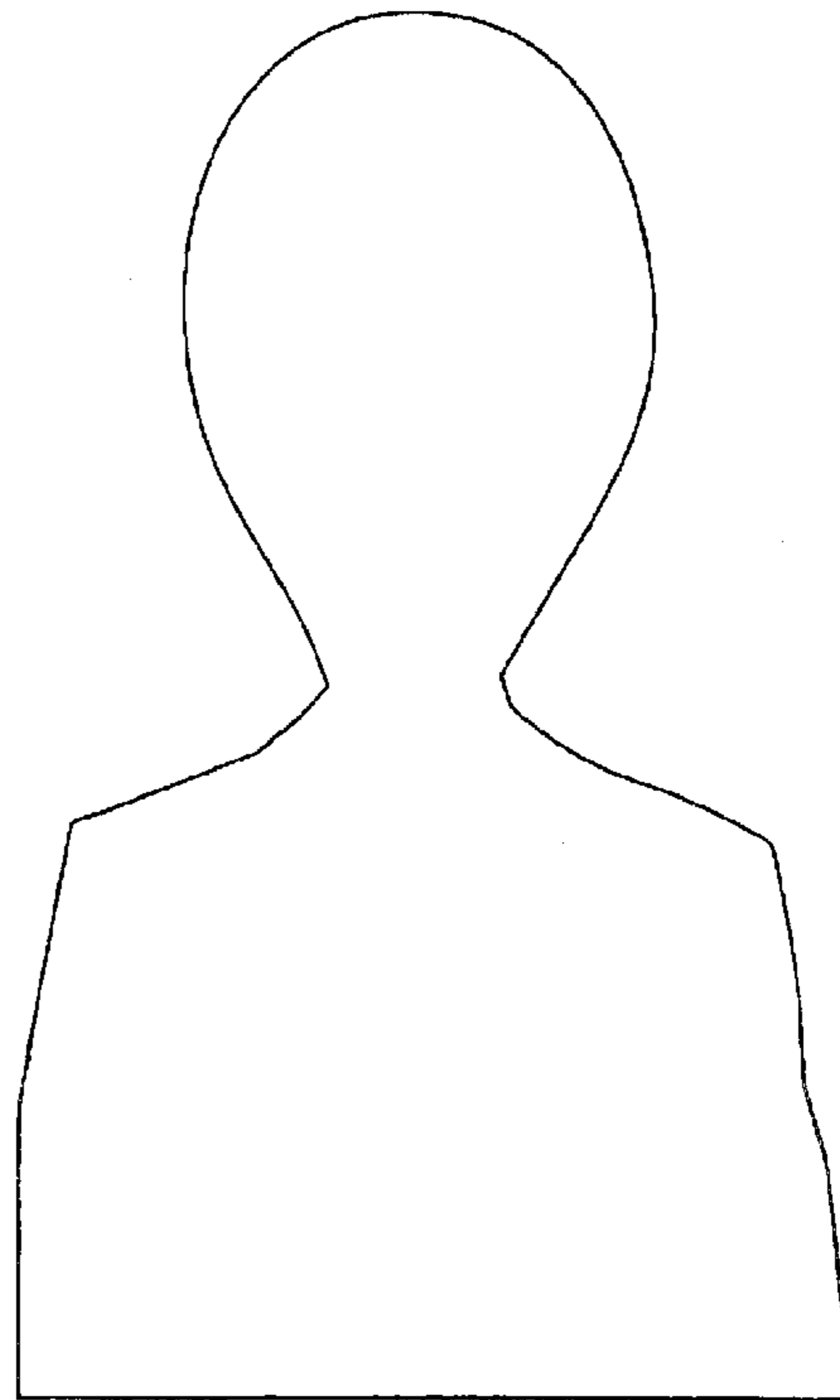

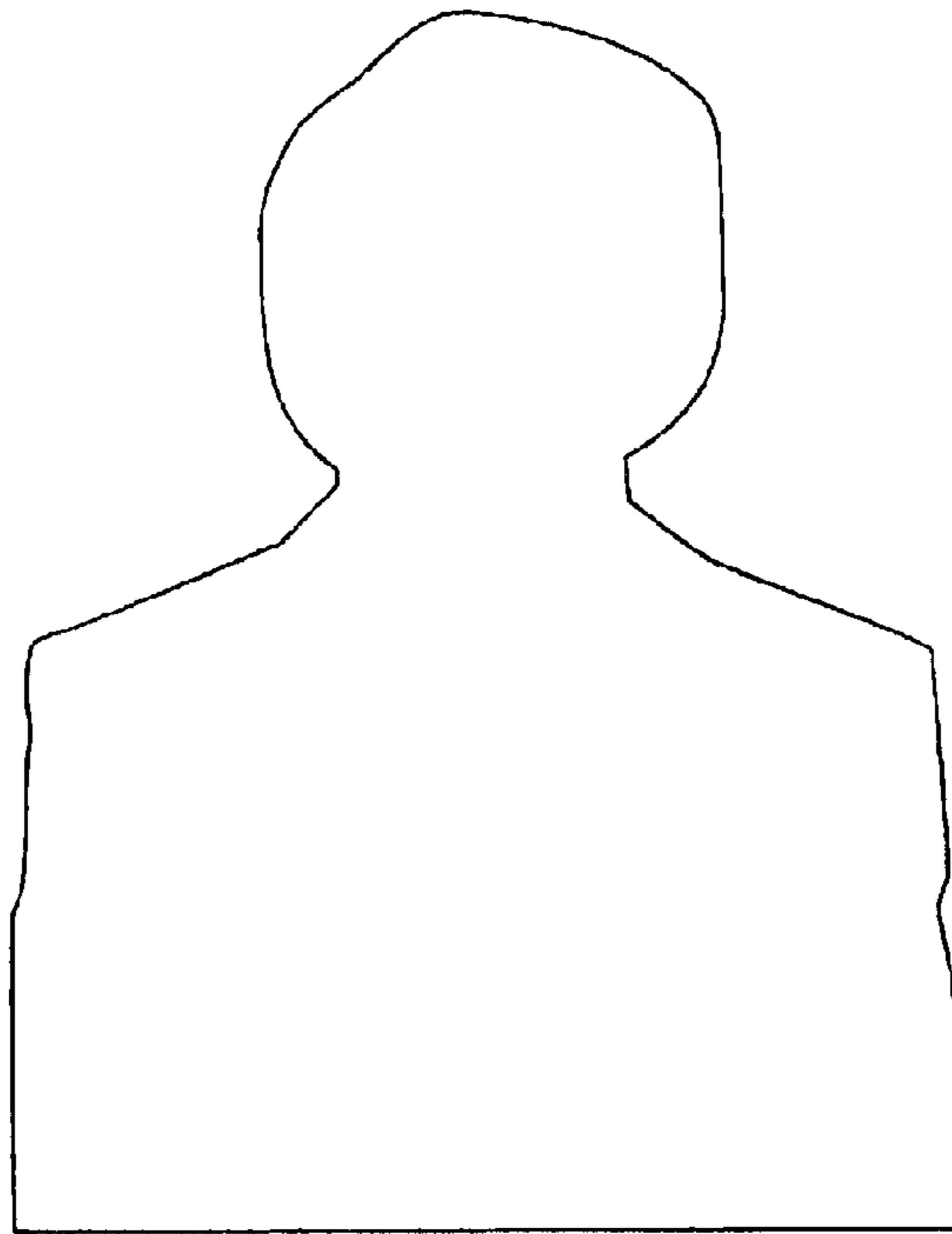

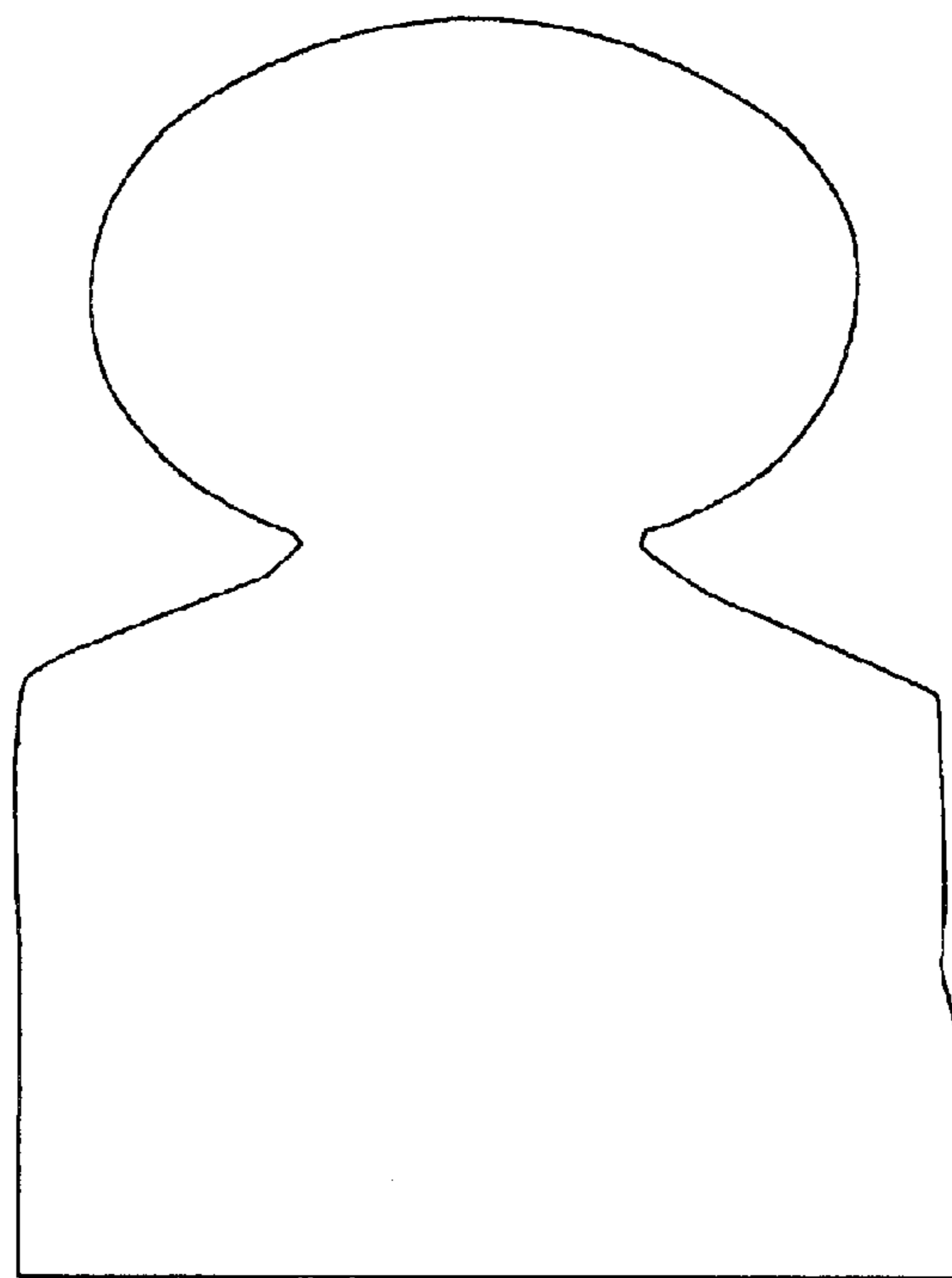
