The ornamental design for a digital pen, as shown and described.

**DESCRIPTION**

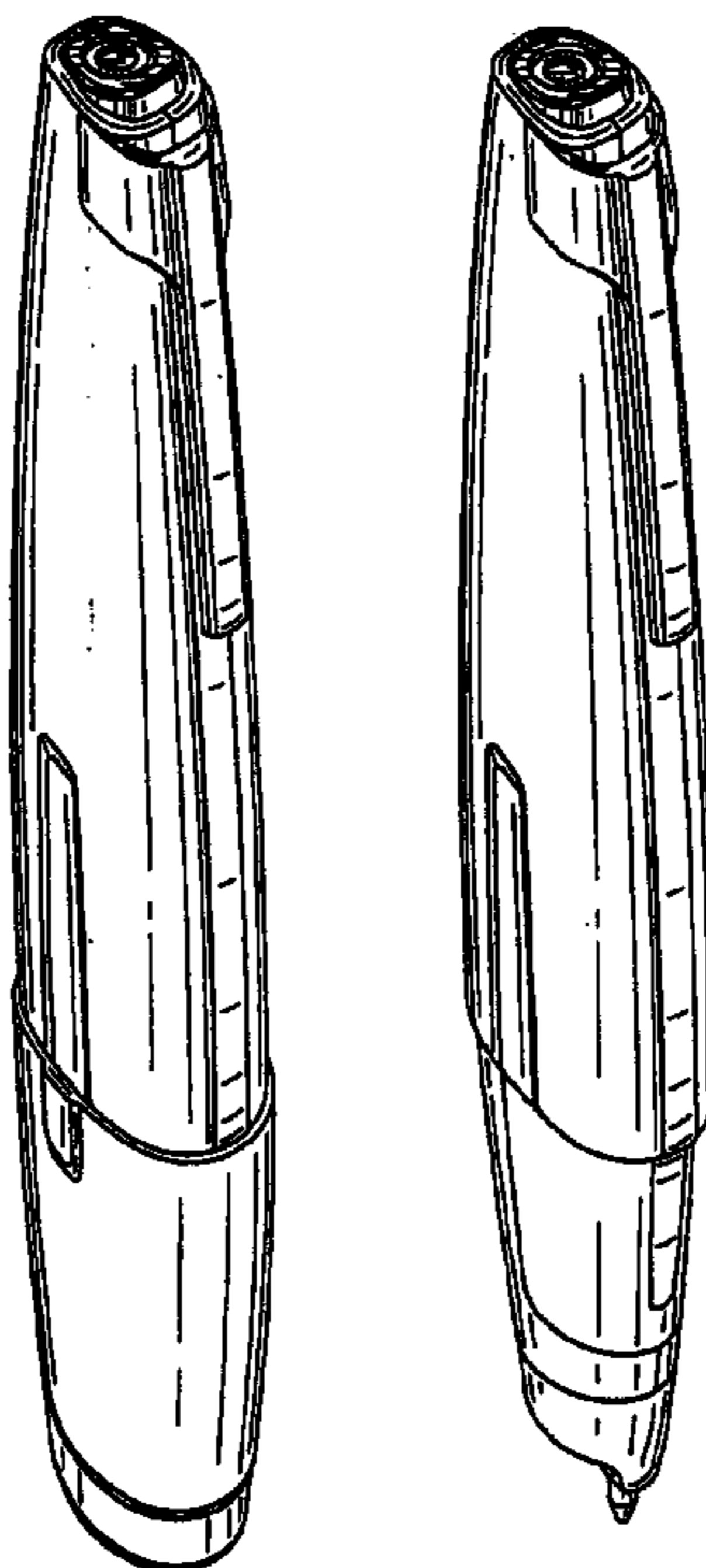

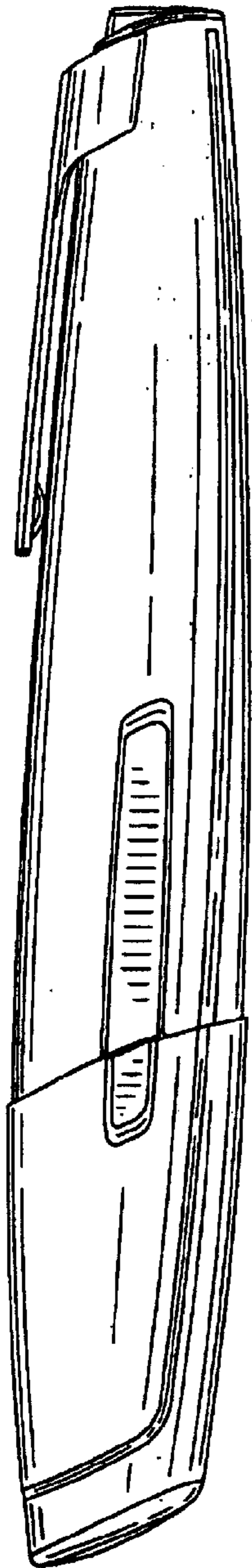
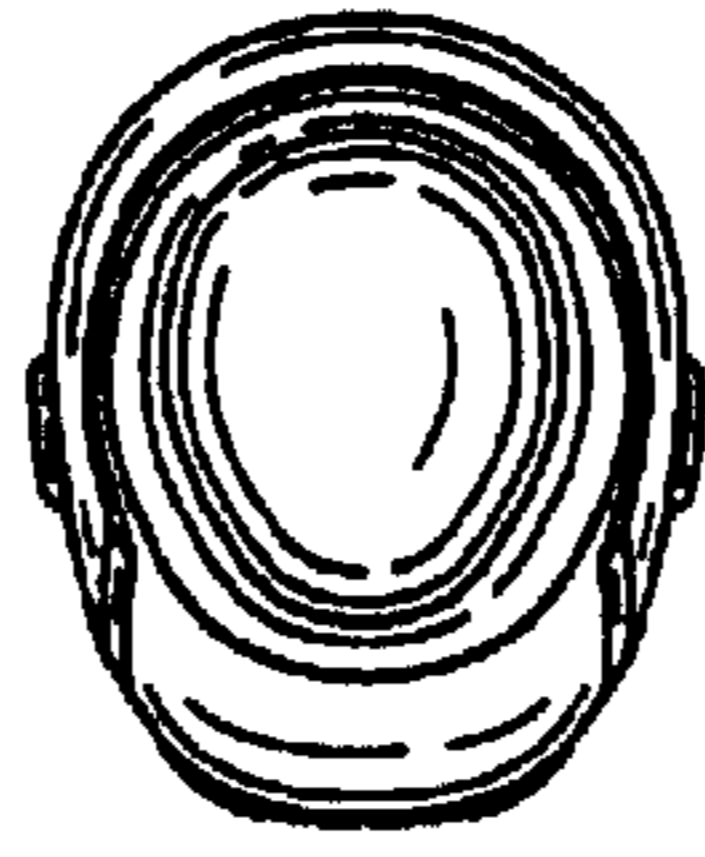

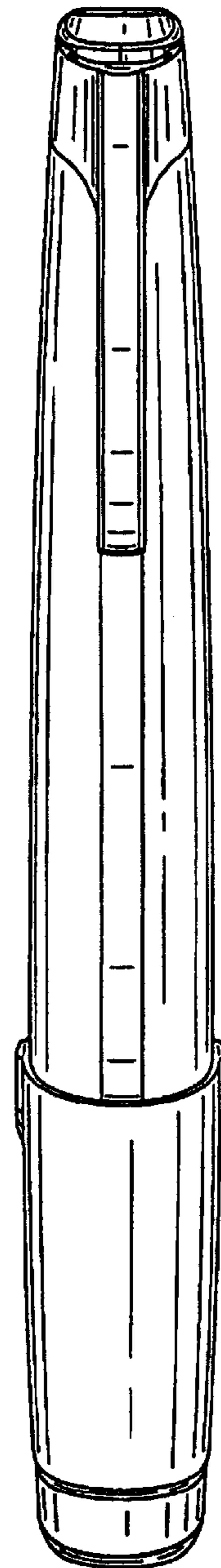

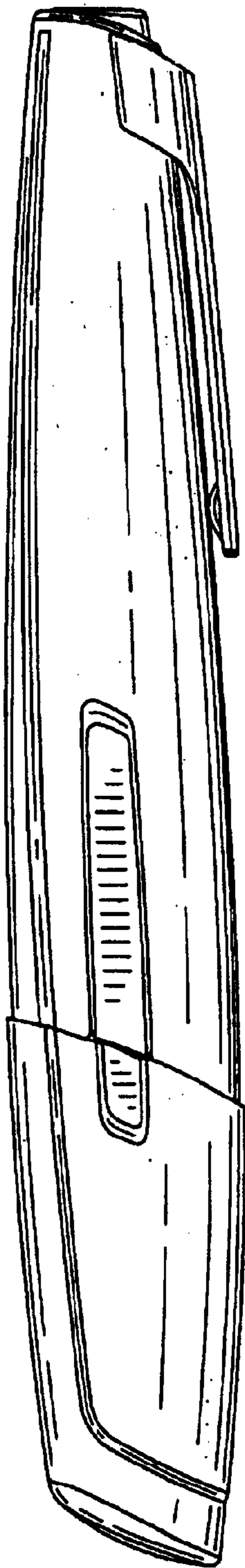

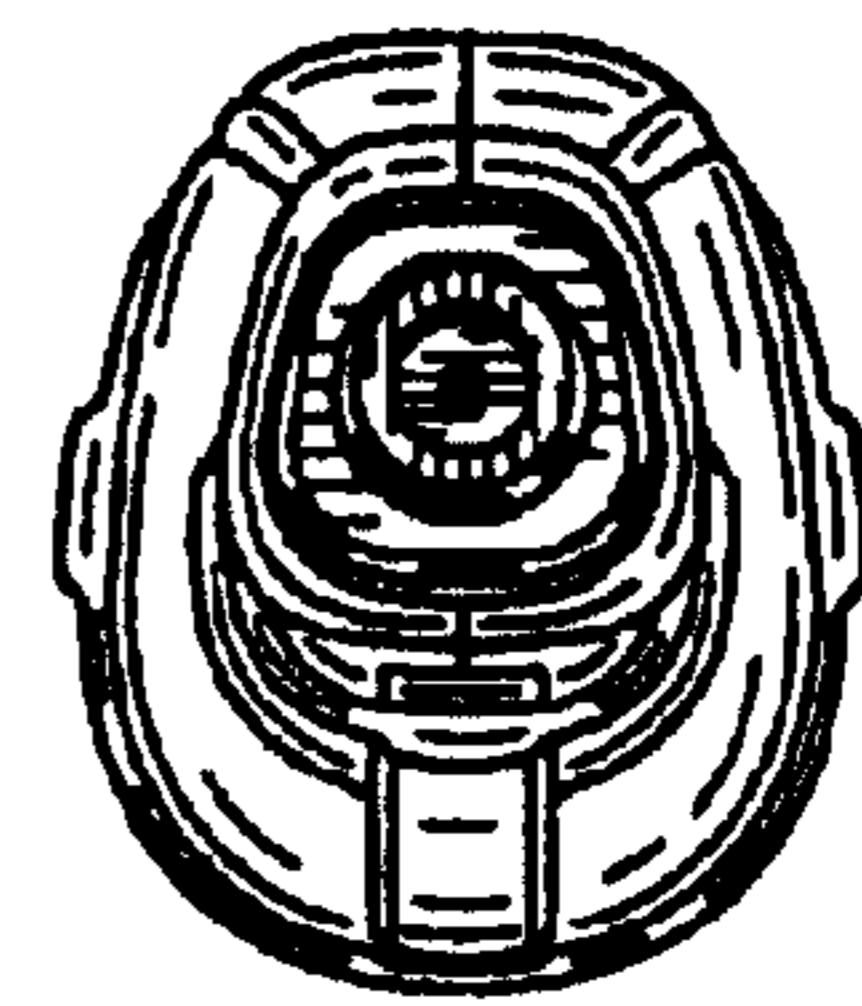

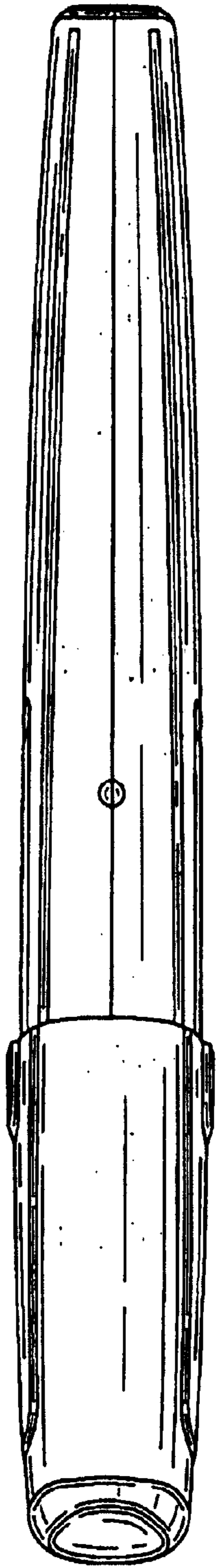

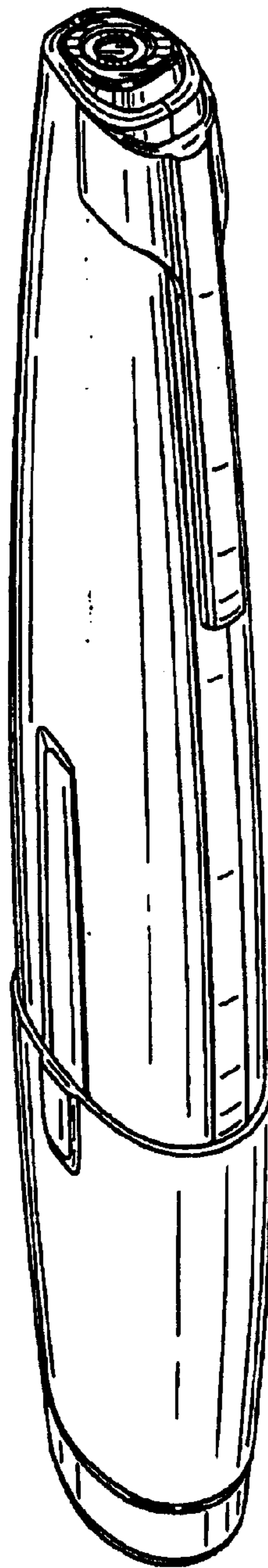

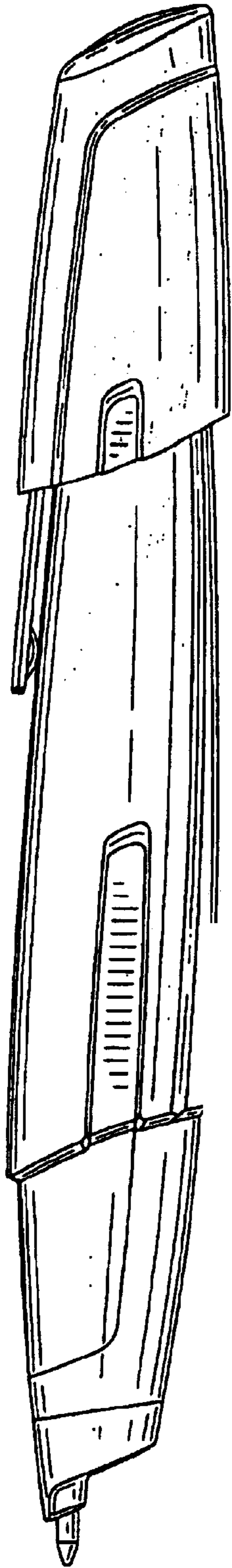

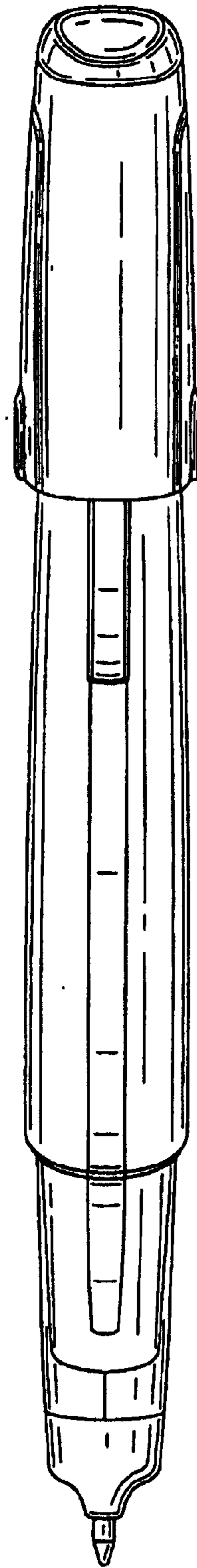

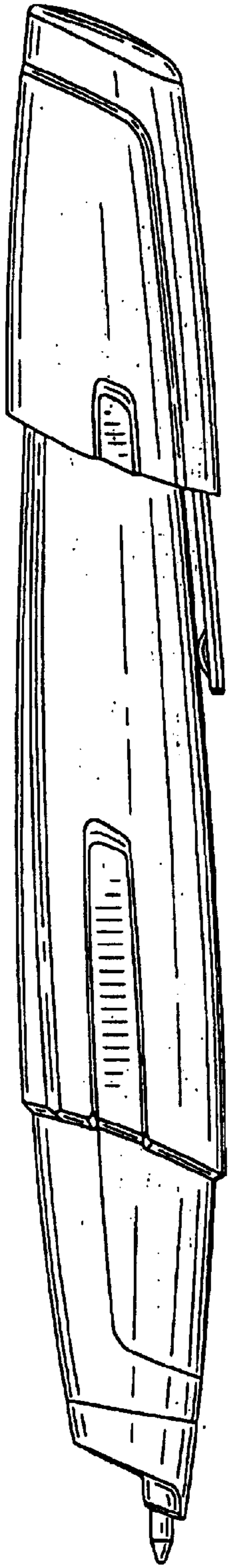

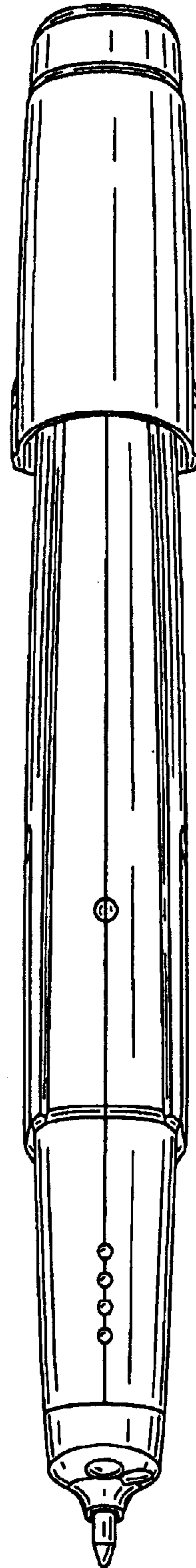

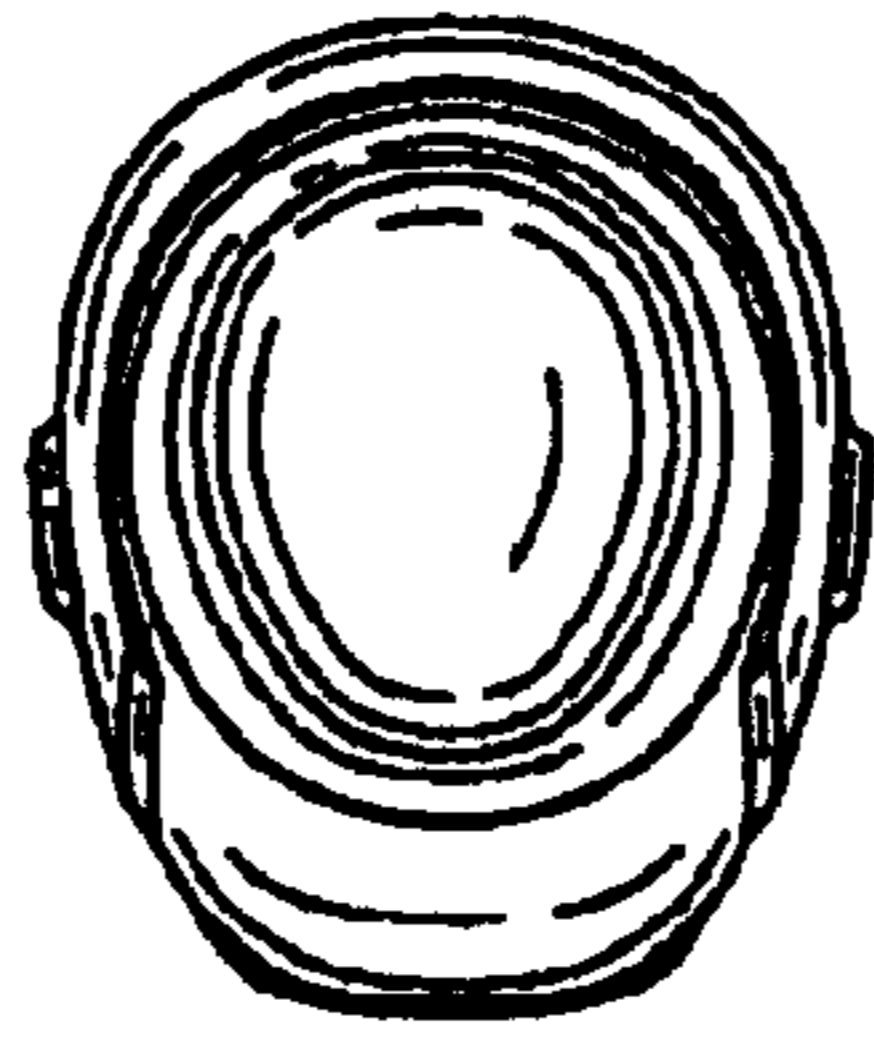

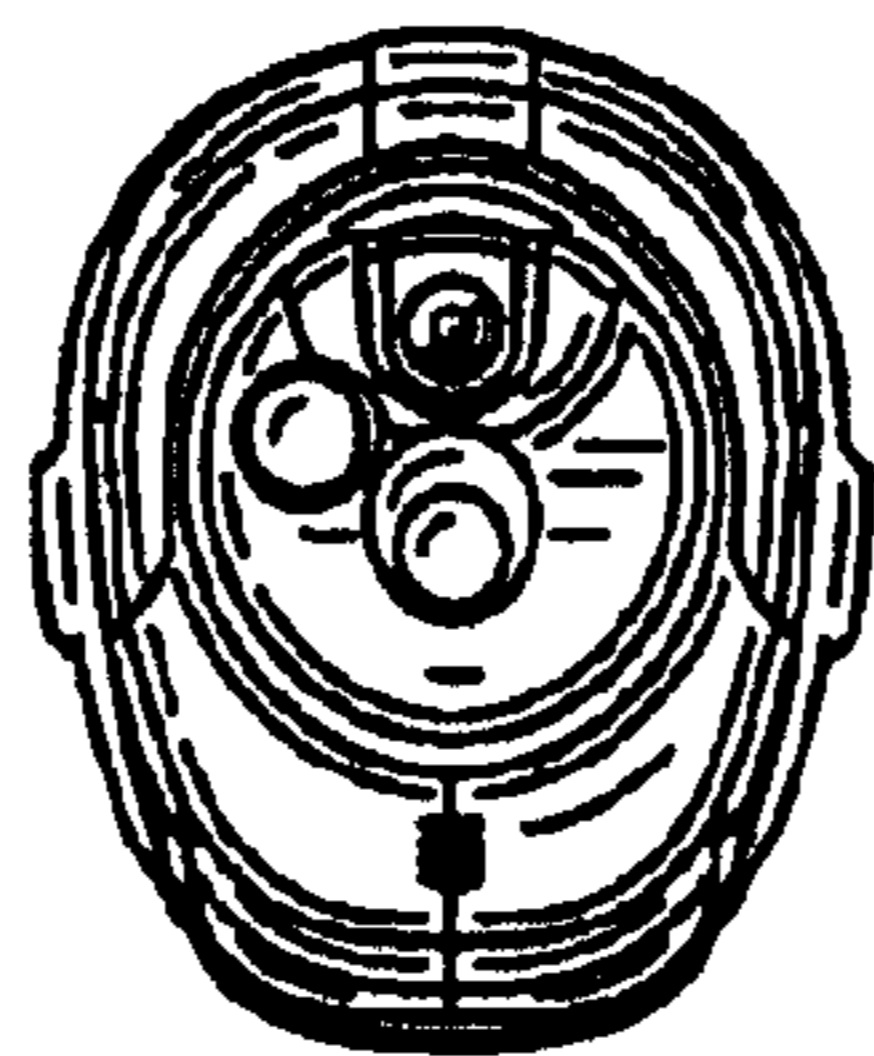

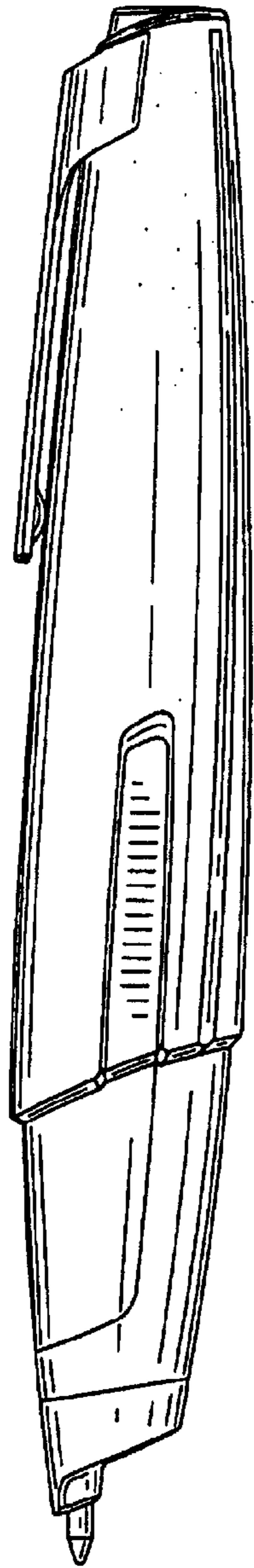
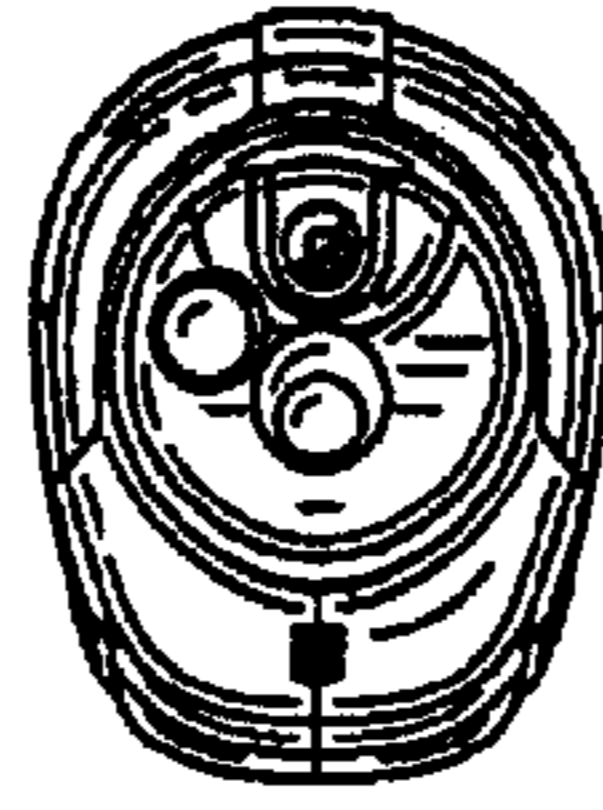

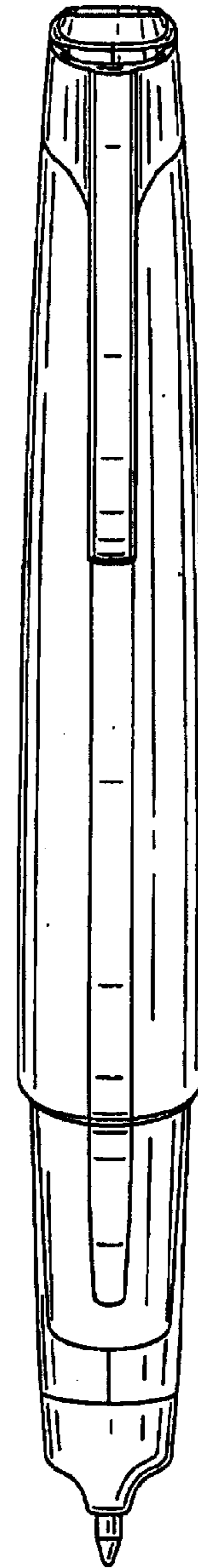

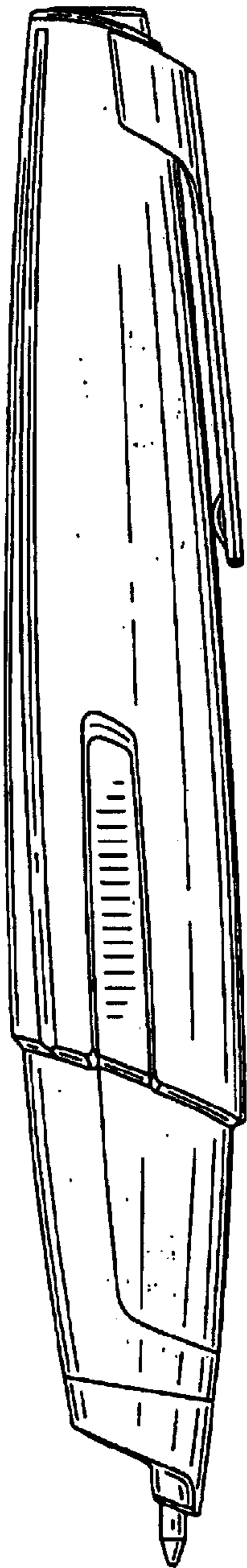

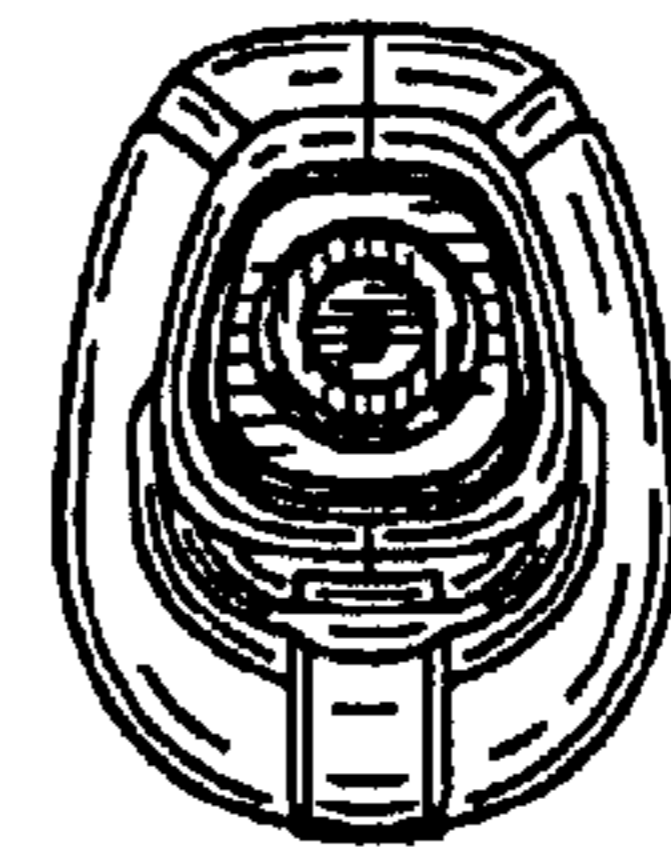

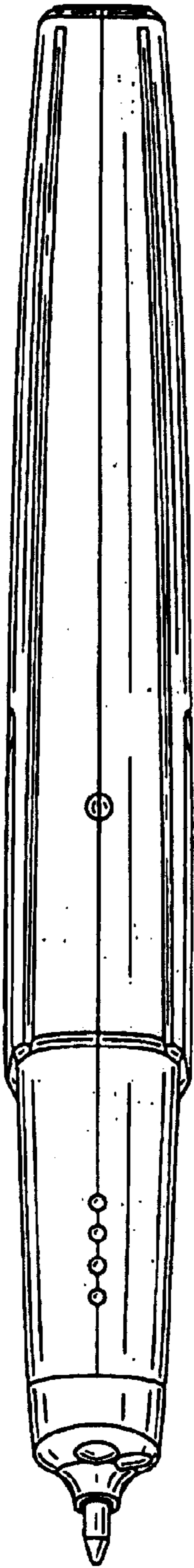

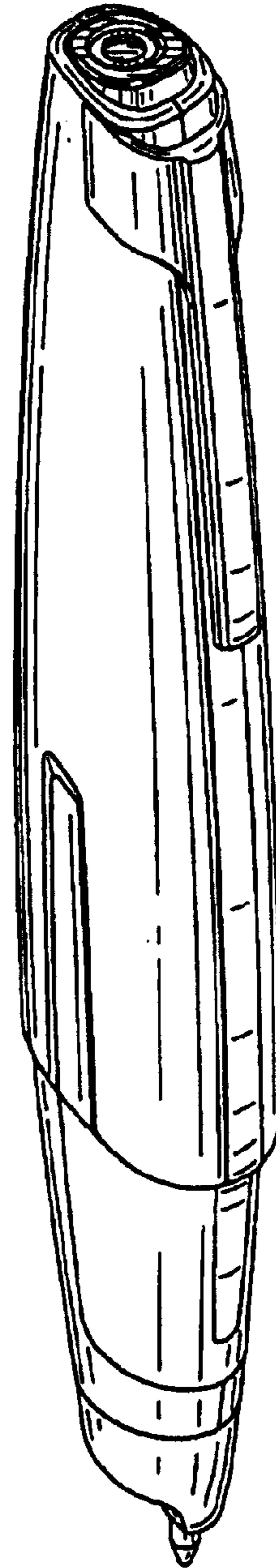

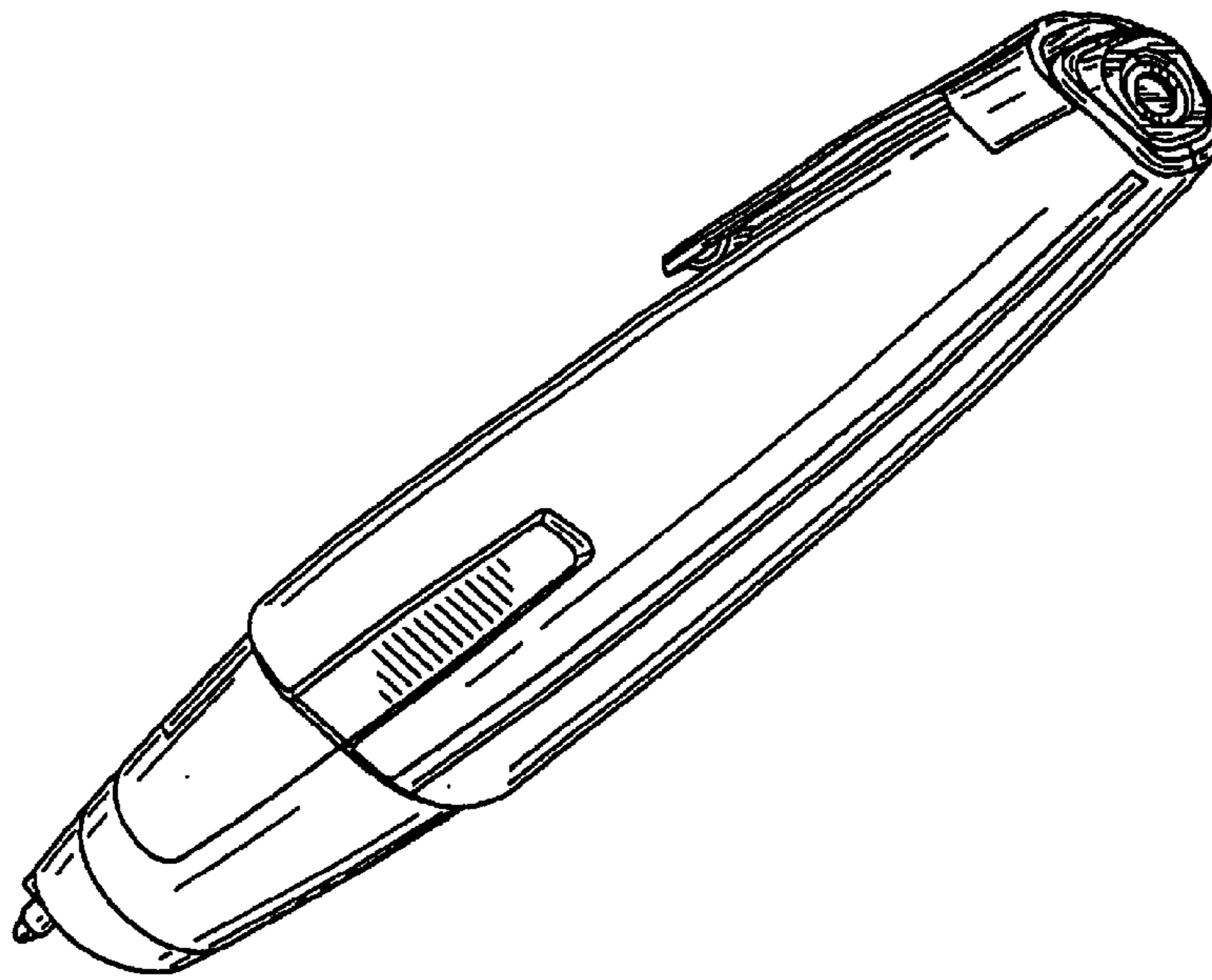

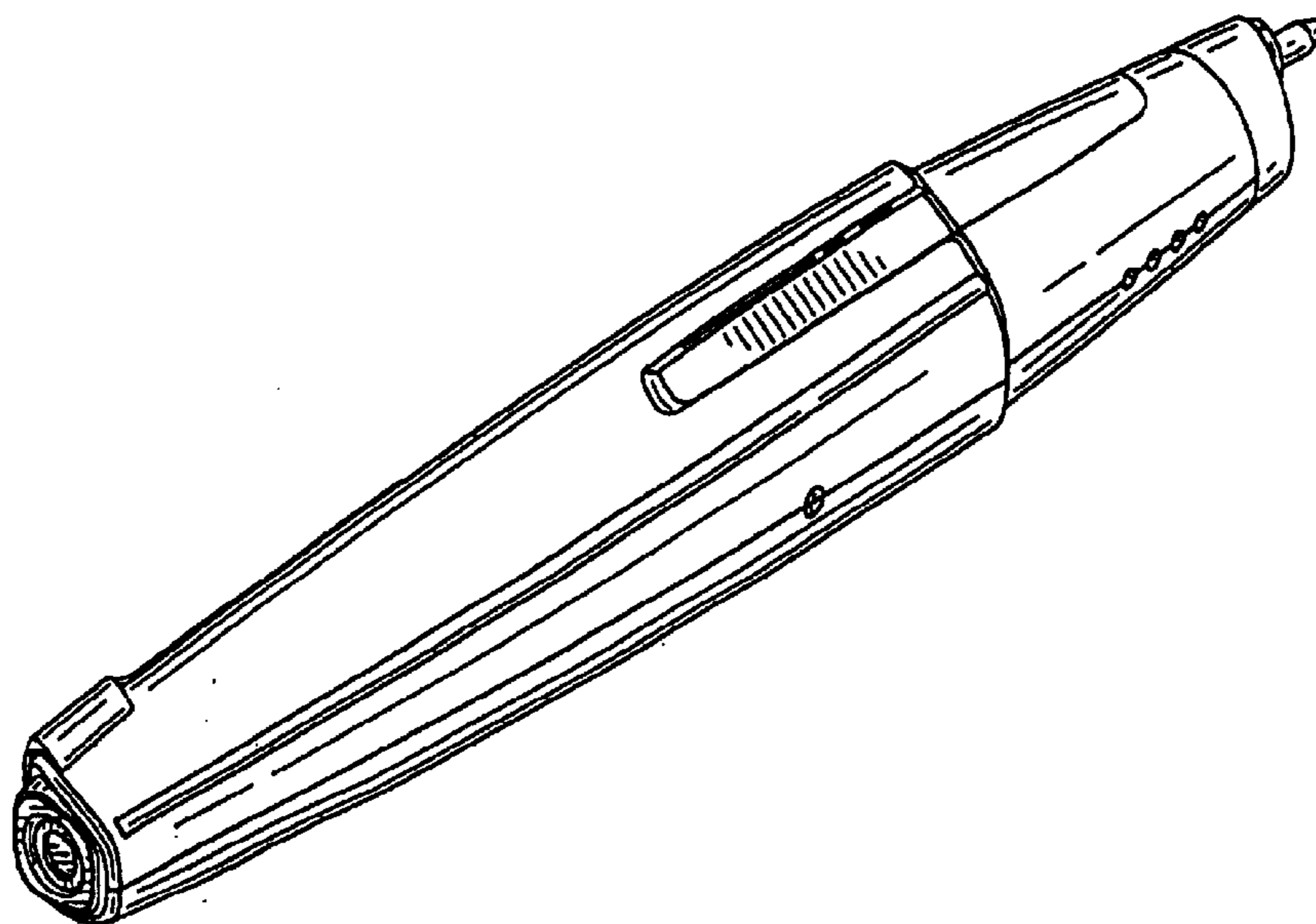
