(57) **CLAIM**

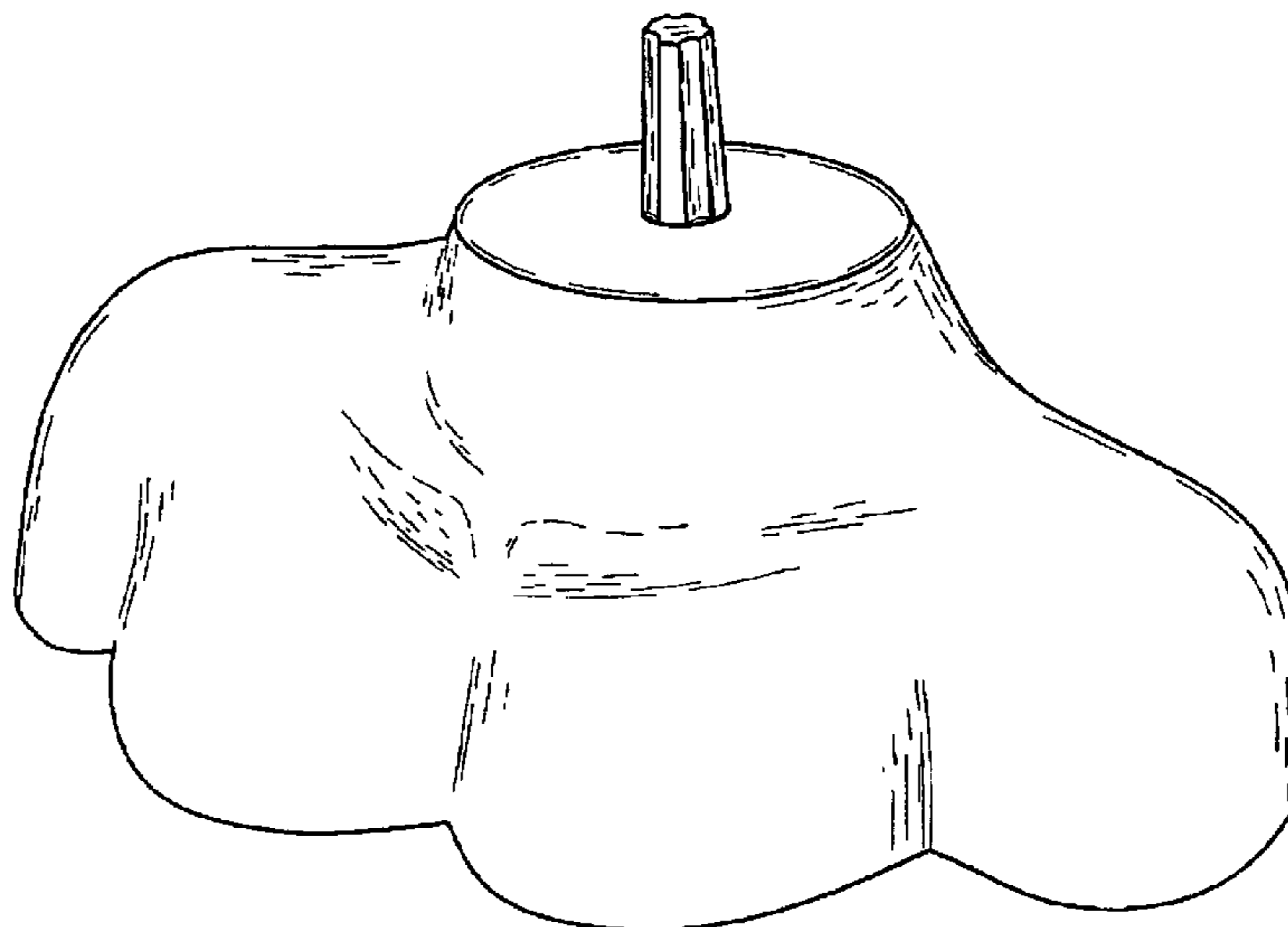
The ornamental design for a shoulder model for hairdressing and make-up teaching, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the shoulder model for hairdressing and make-up teaching of the present invention; FIG. 2 is a front elevation view of the shoulder model for hairdressing and make-up teaching of the present invention; FIG. 3 is a rear elevation view of the shoulder model for hairdressing and make-up teaching of the present invention; FIG. 4 is a right elevation view of the shoulder model for hairdressing and make-up teaching of the present invention; FIG. 5 is a left elevation view of the shoulder model for hairdressing and make-up teaching of the present invention; FIG. 6 is a bottom plan view of the shoulder model for hairdressing and make-up teaching of the present invention; and,

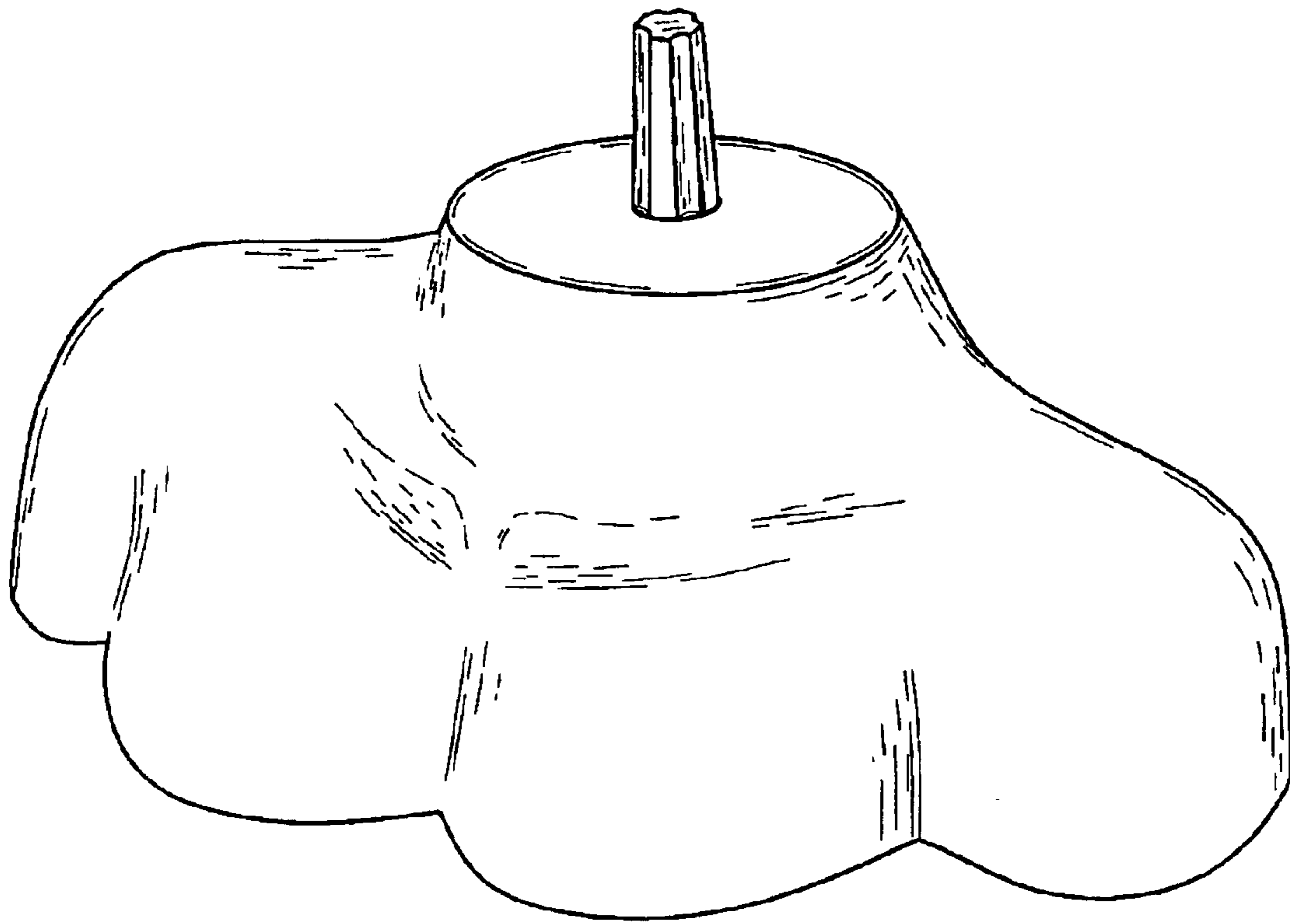

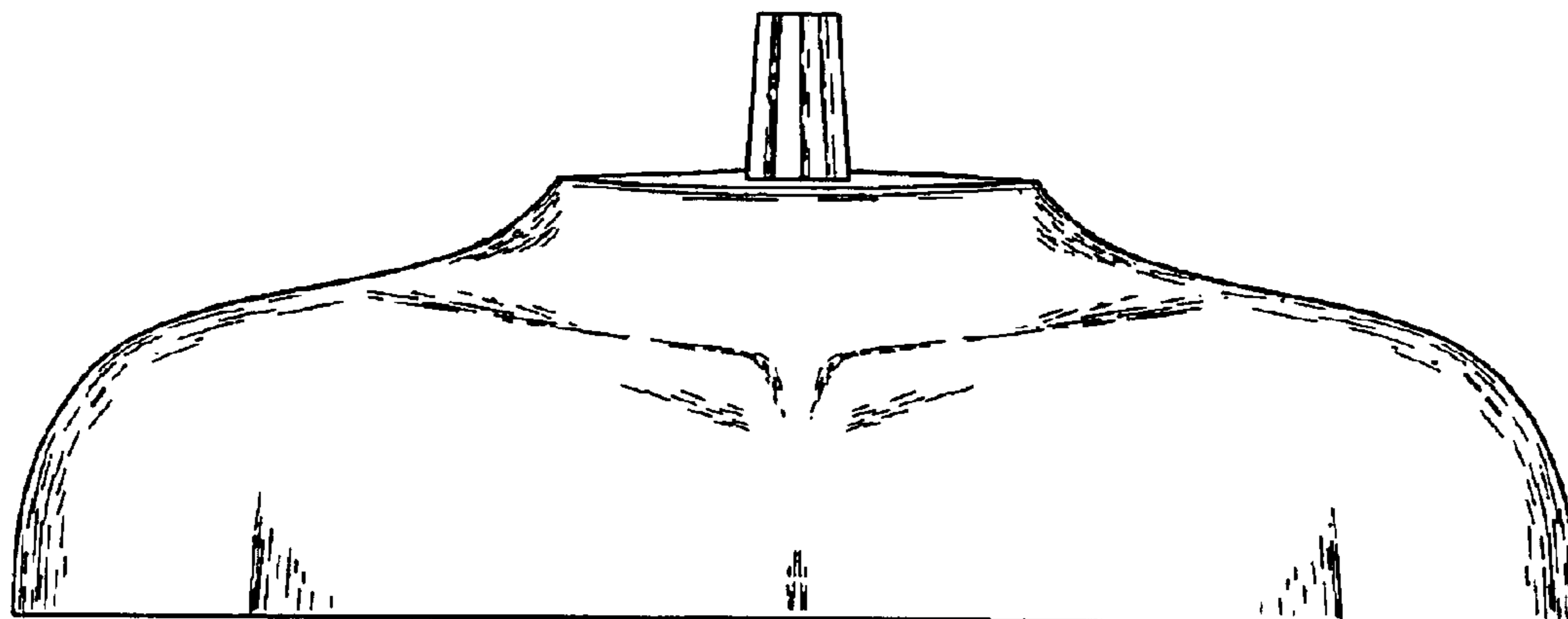

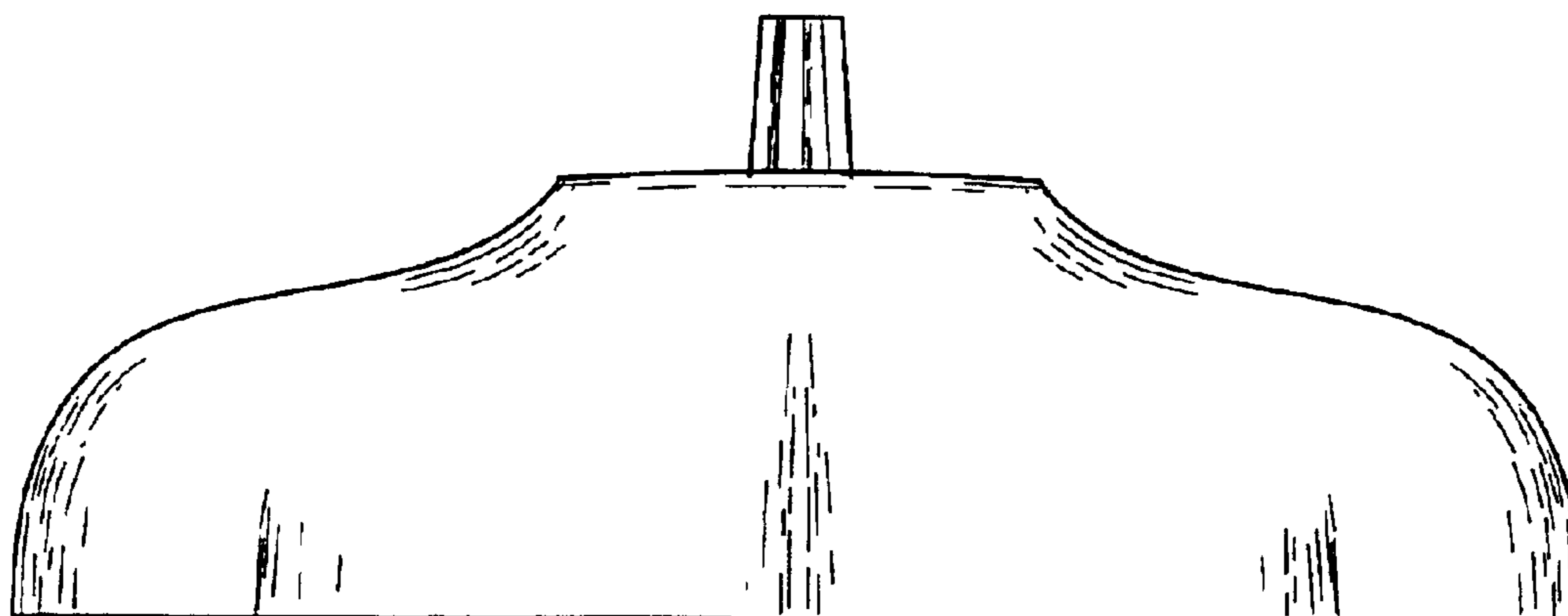

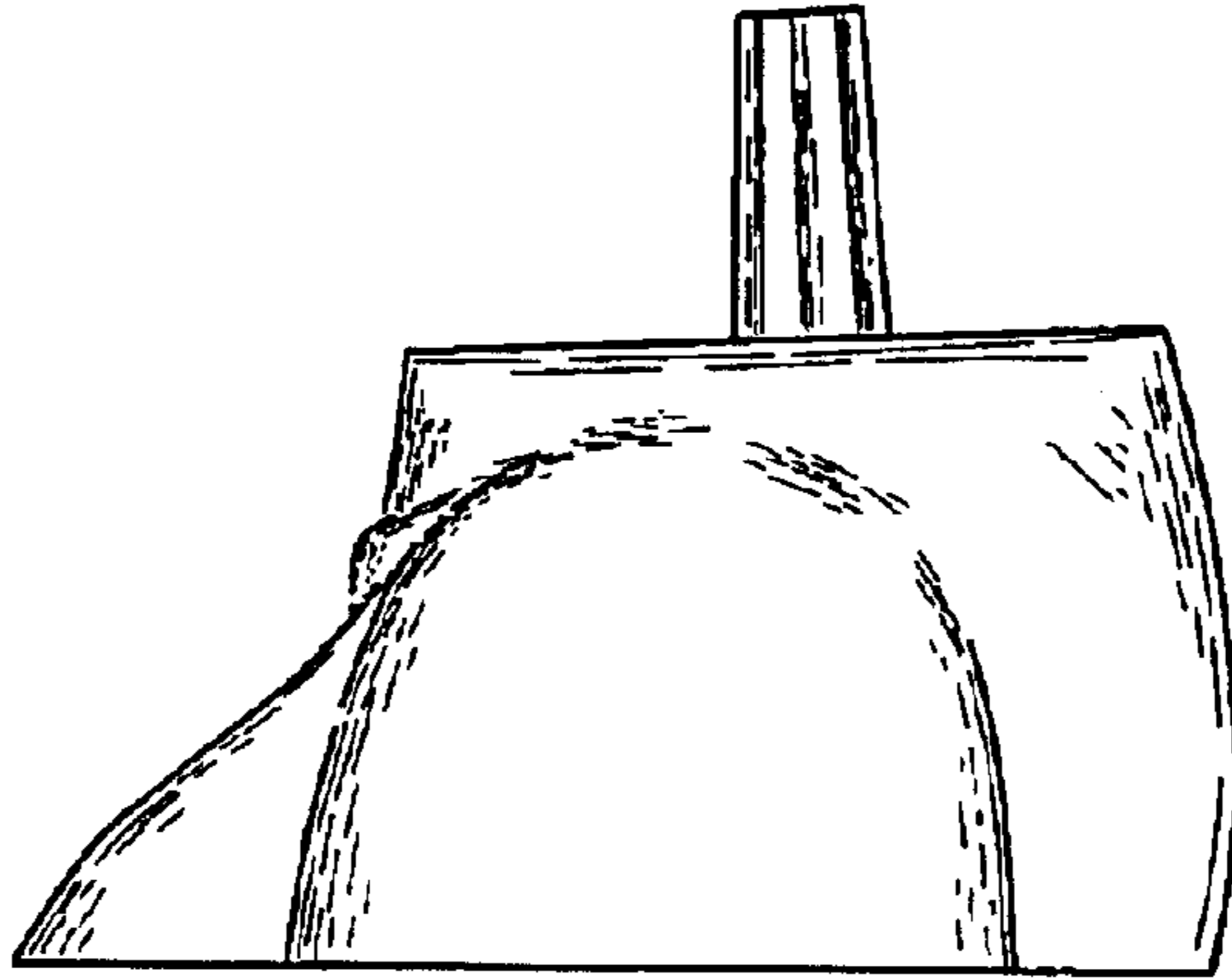

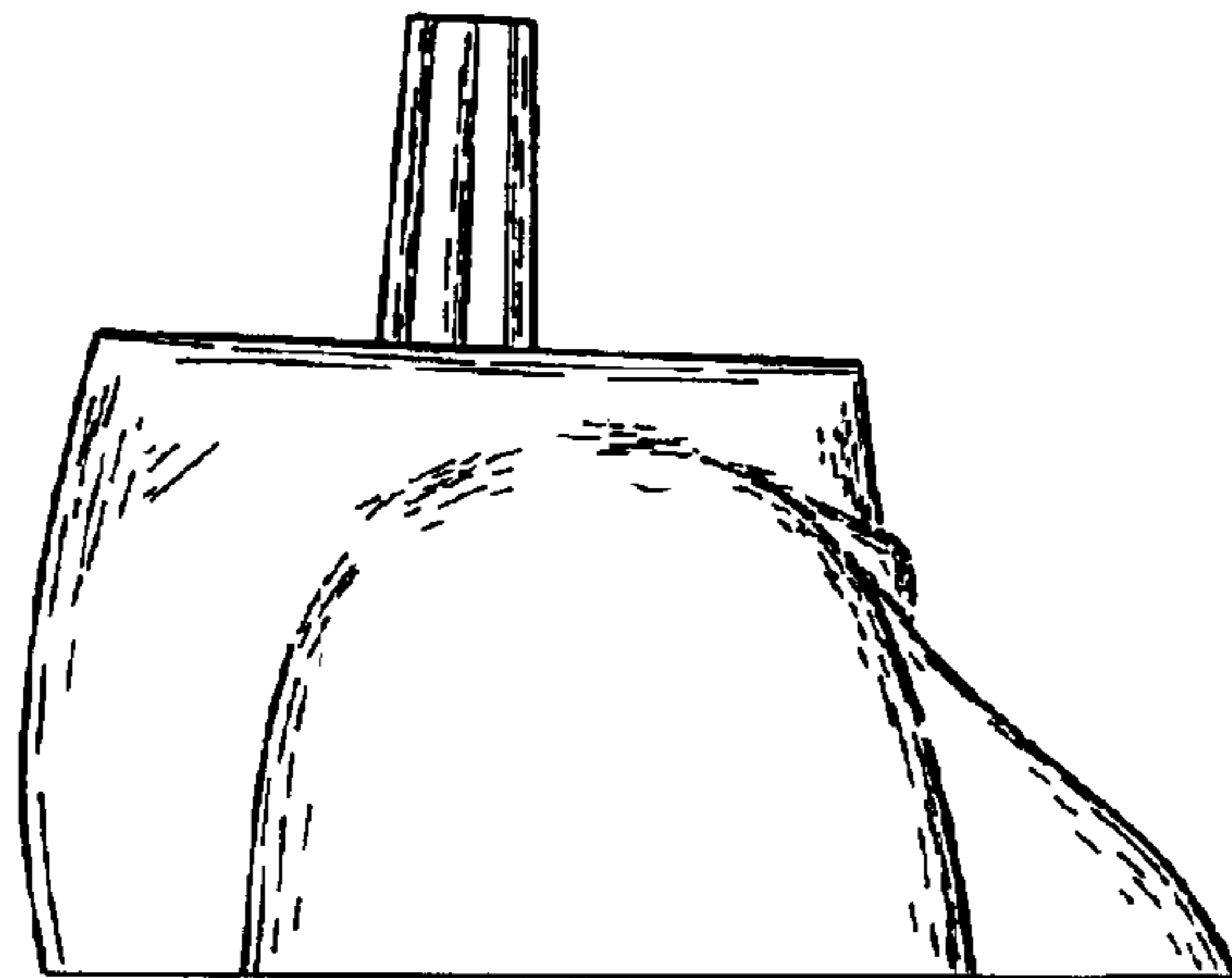

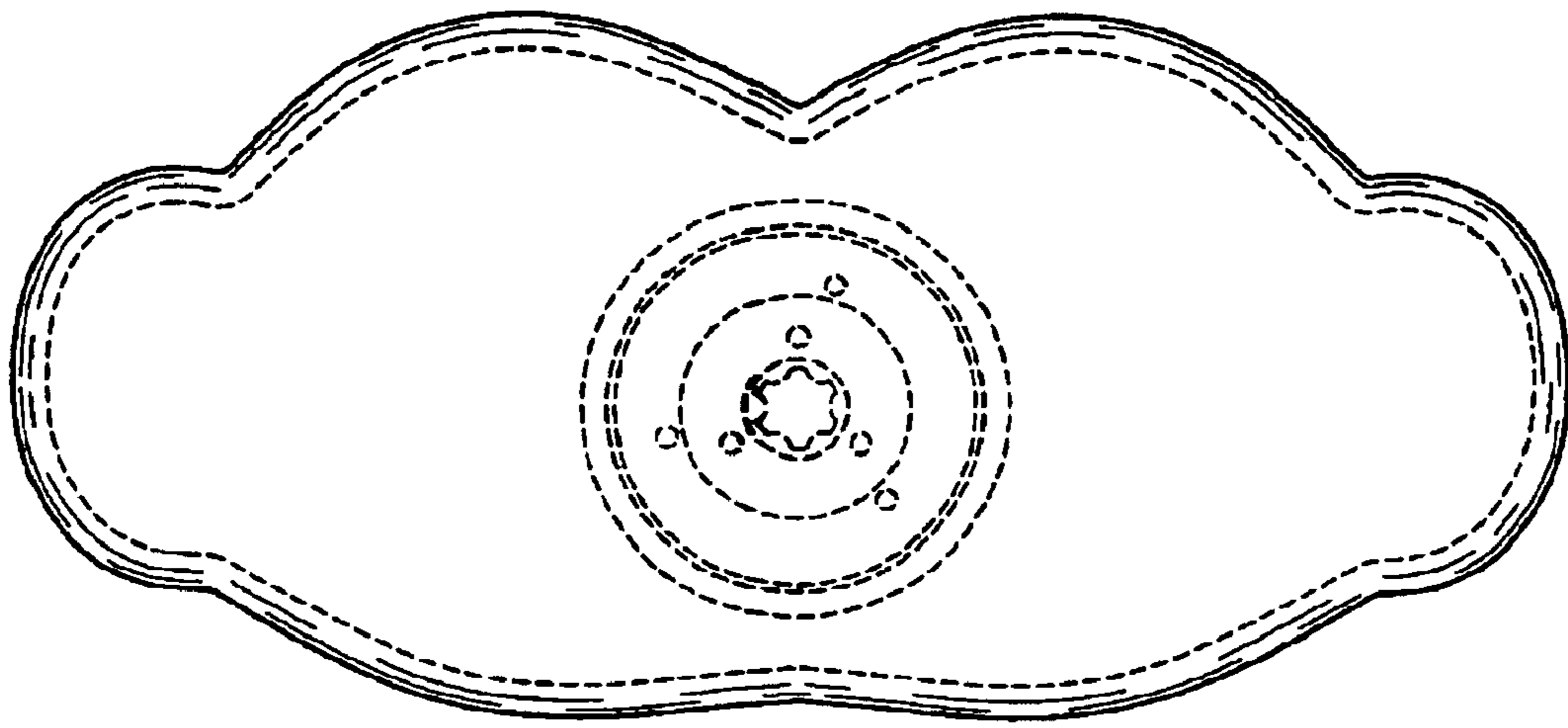

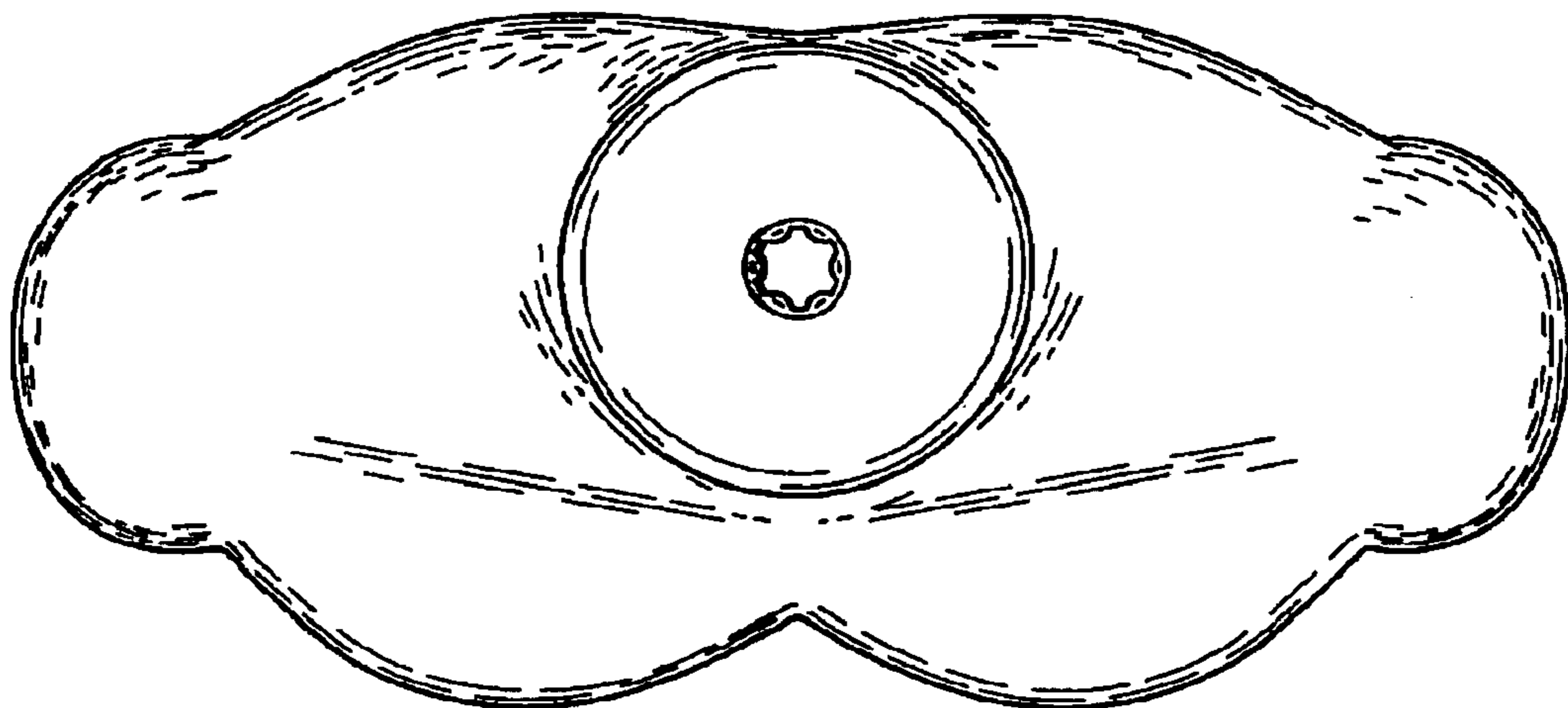
