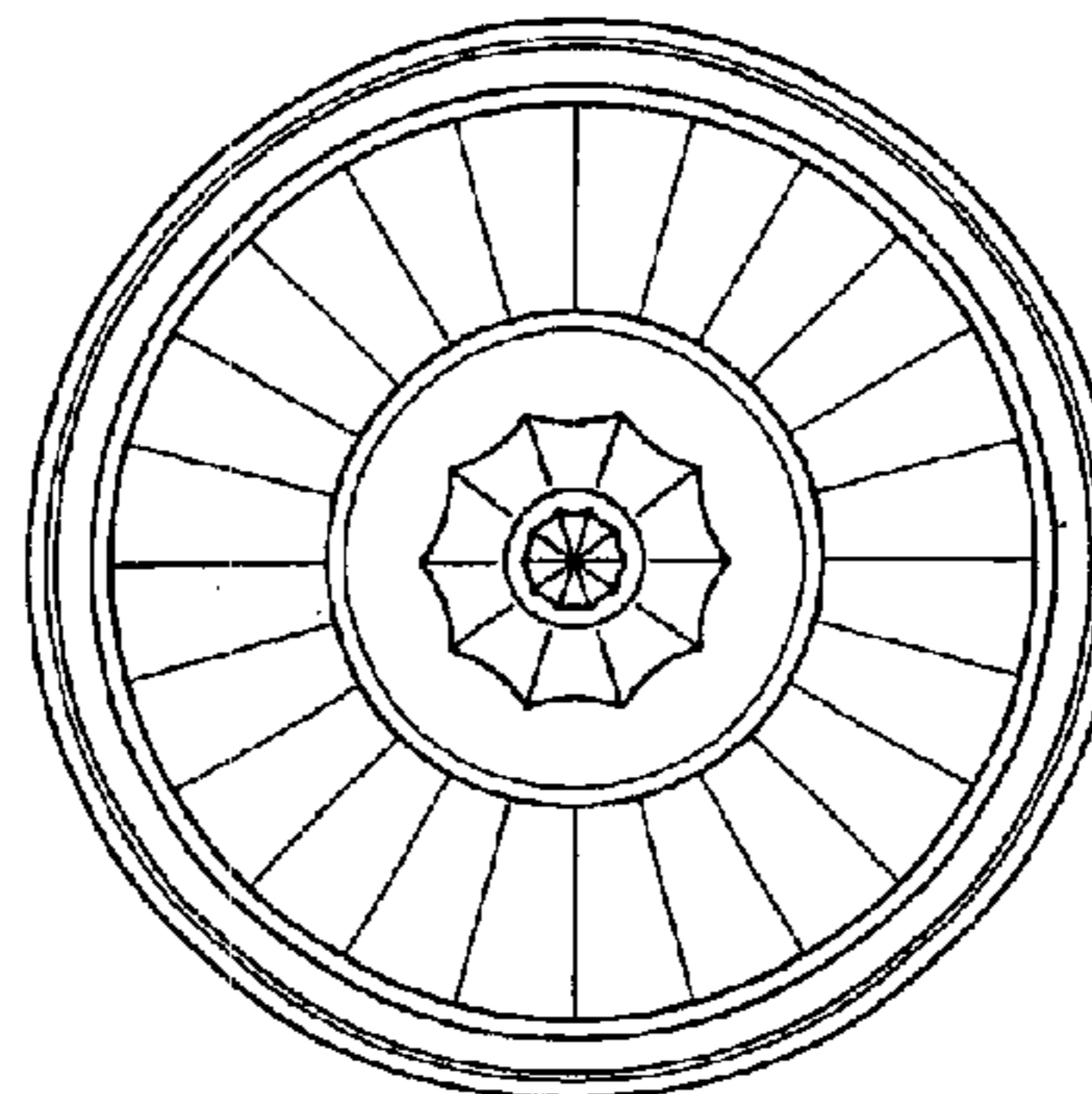
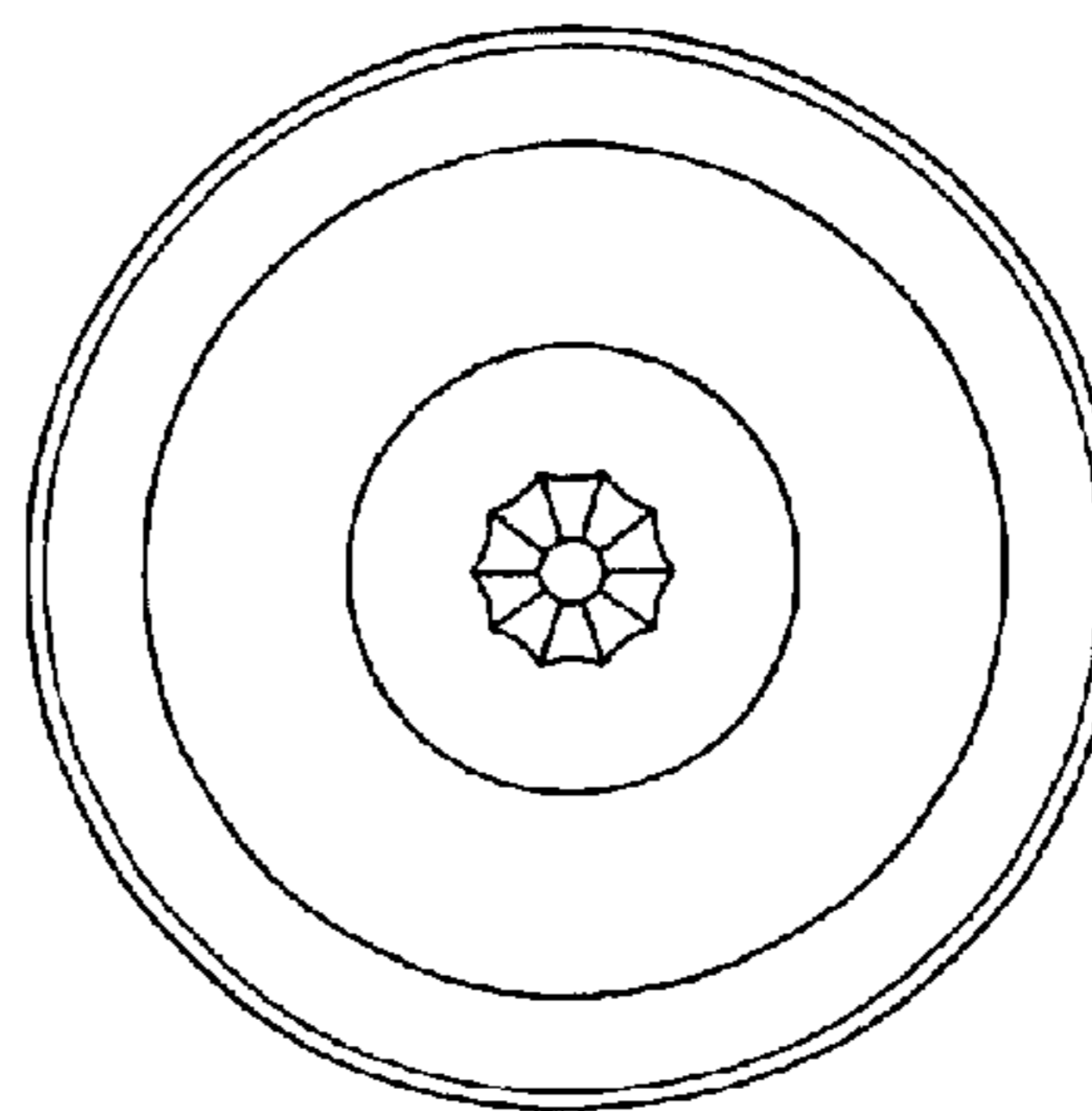
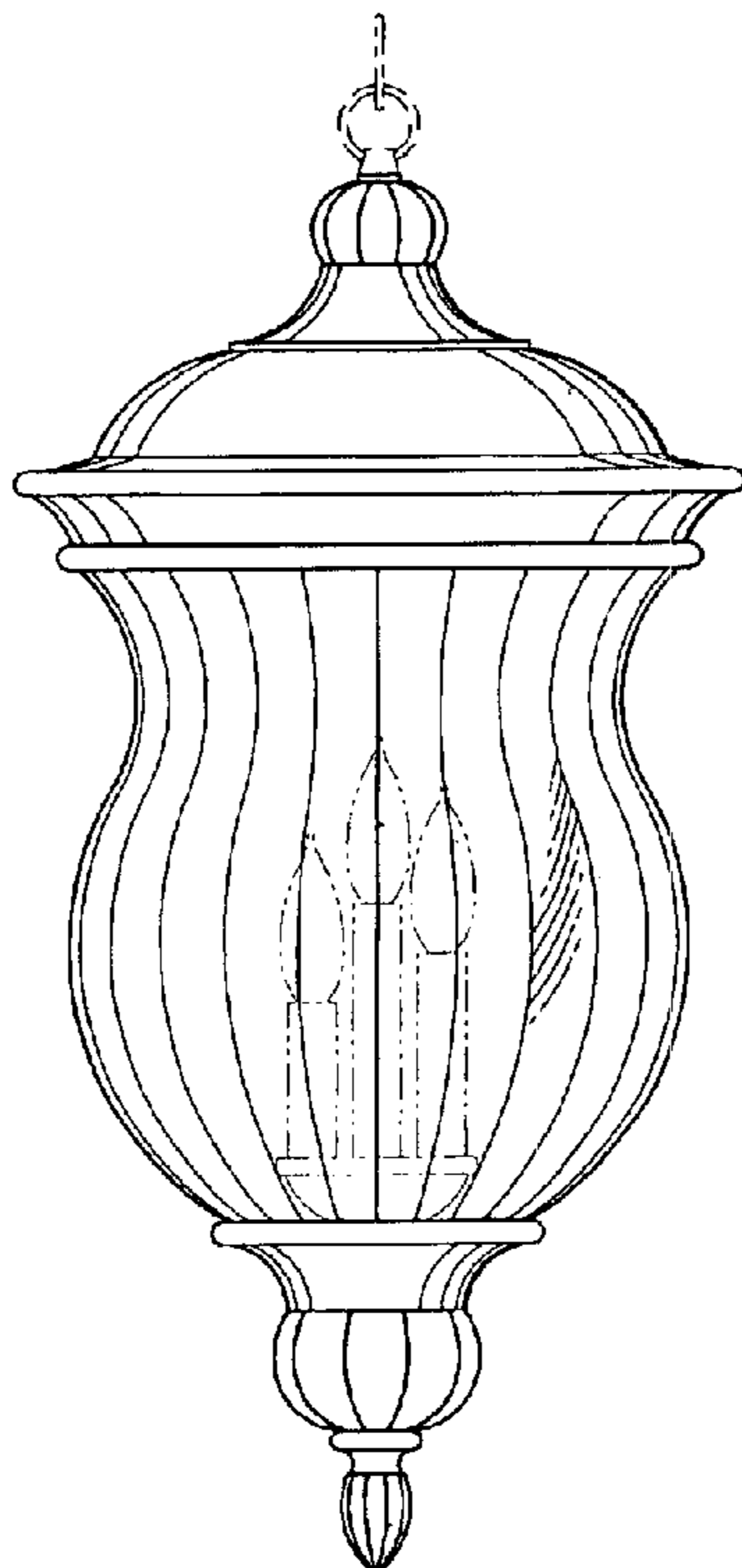

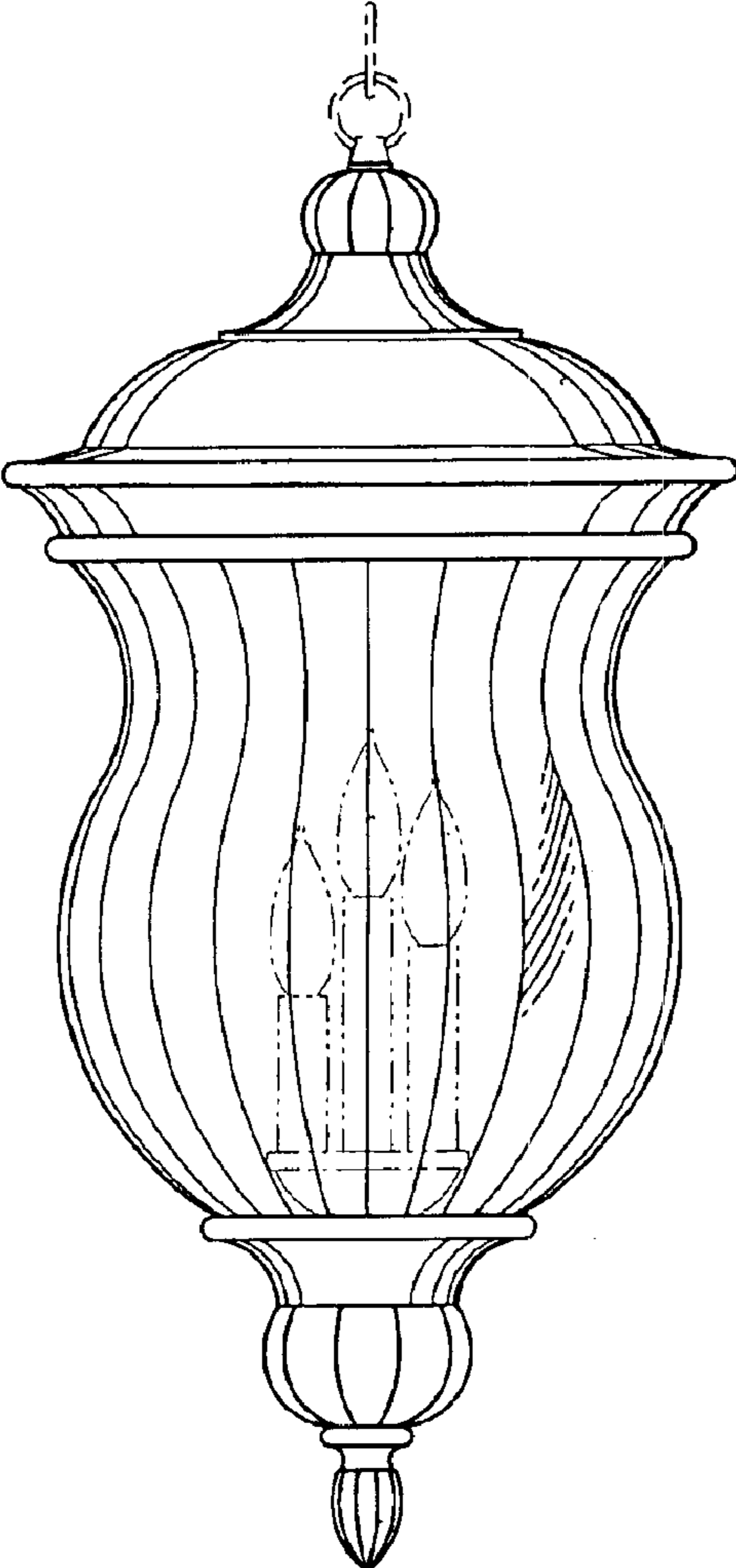
The ornamental design for the lantern, as shown and described.

**DESCRIPTION**

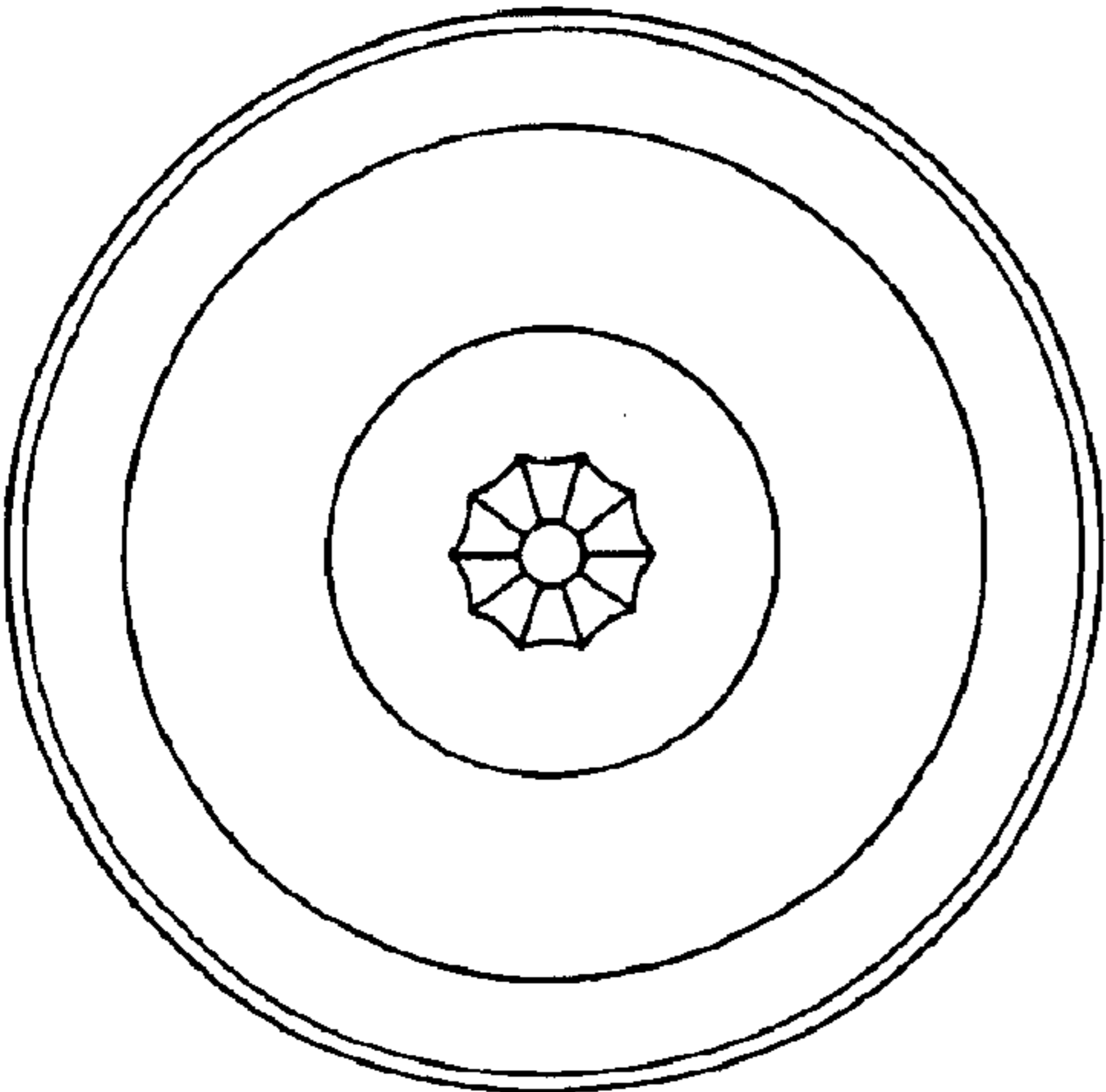
FIG. 1 is a front view of the lantern showing my new design, the right side view, the left side view, and the rear view being the same;

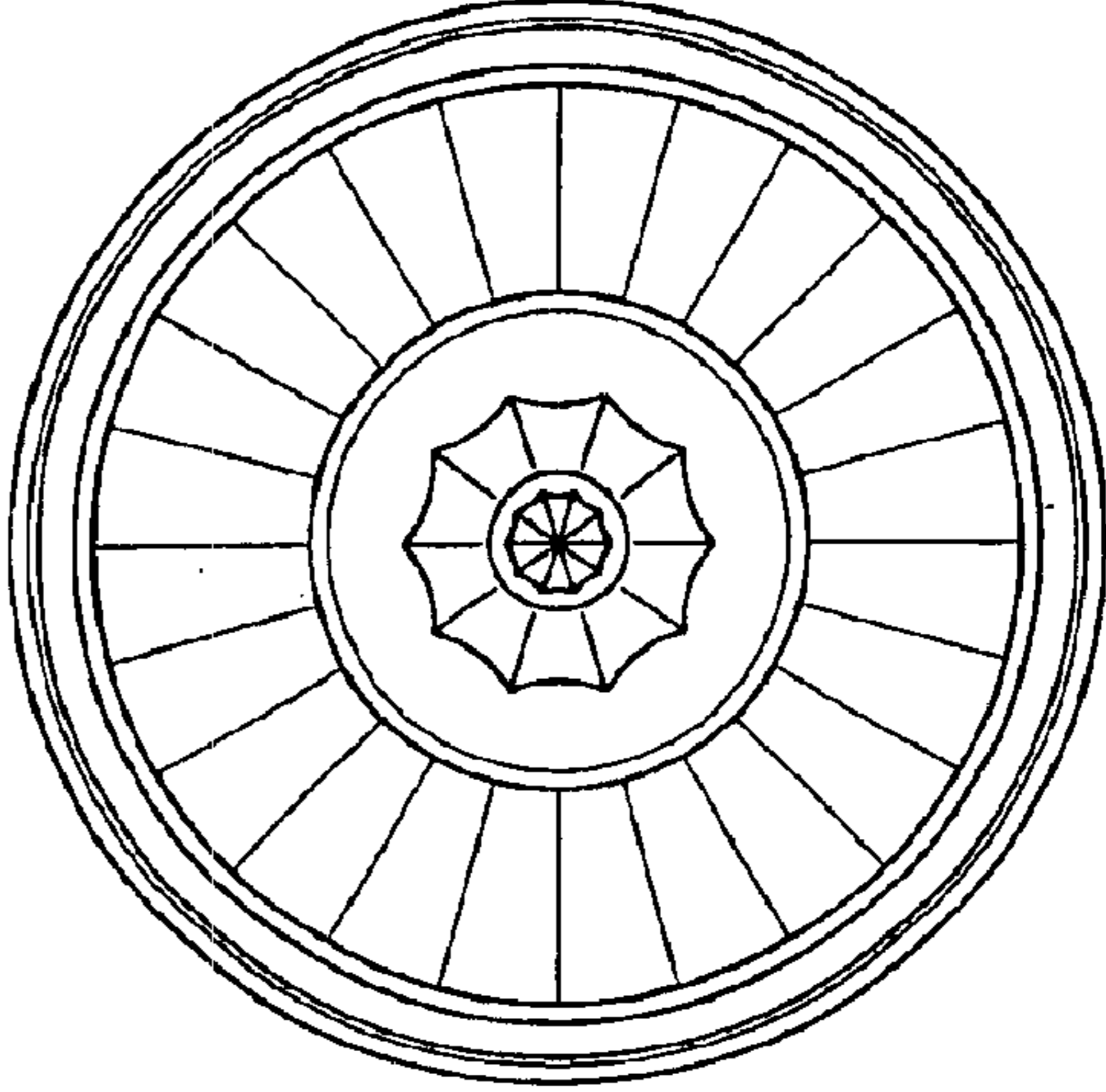
