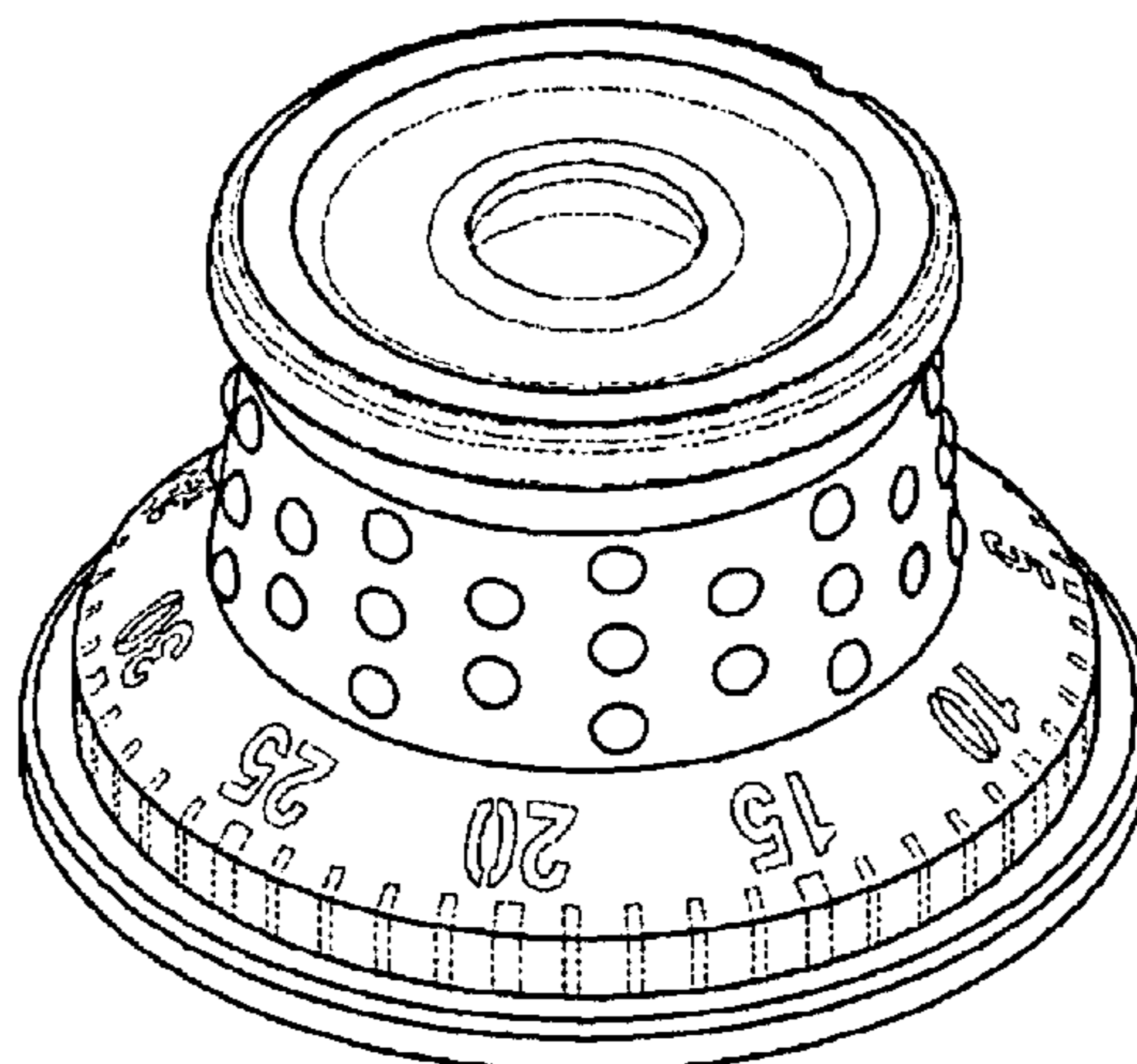
The ornamental design for a lock dial, as shown and described.

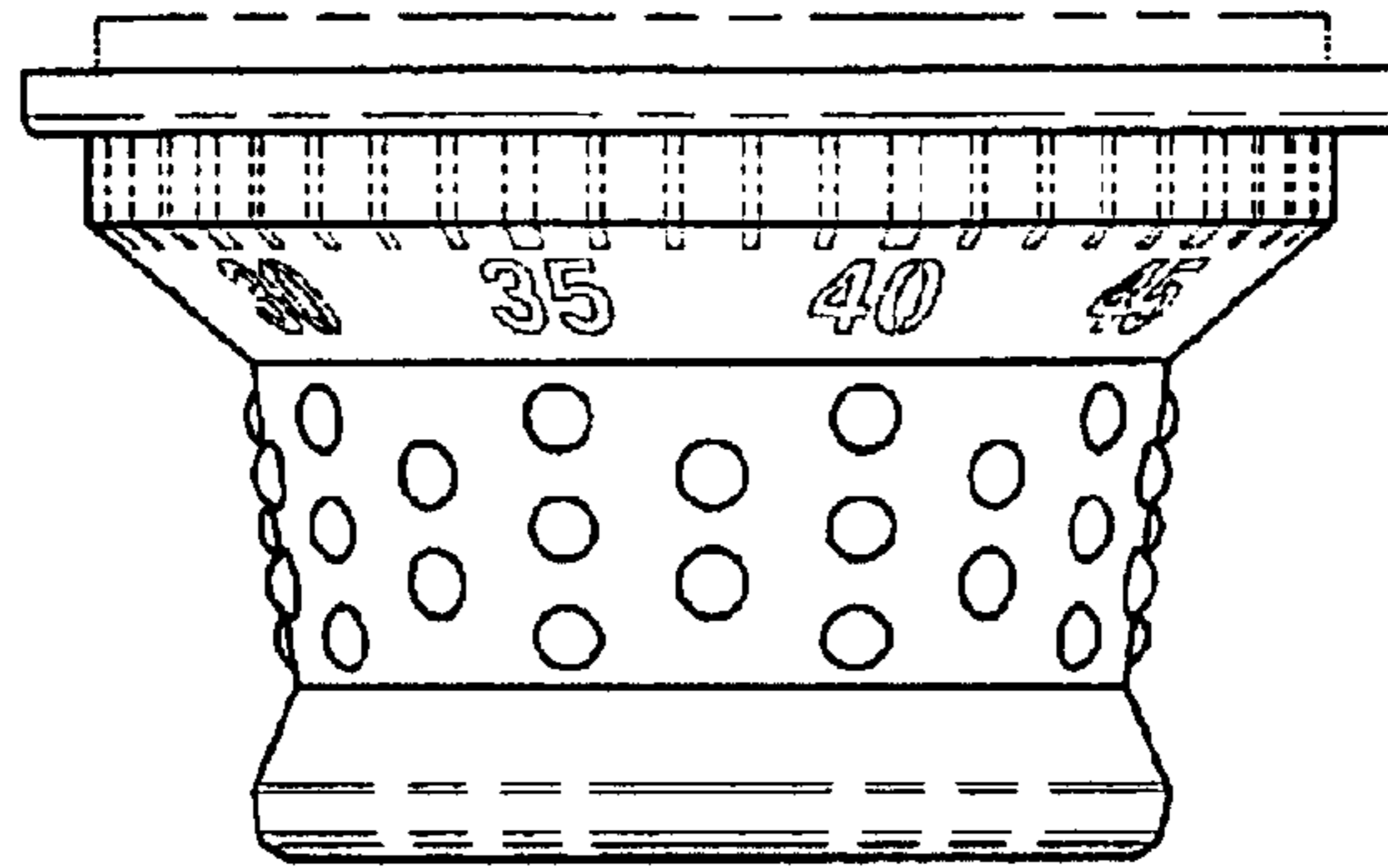

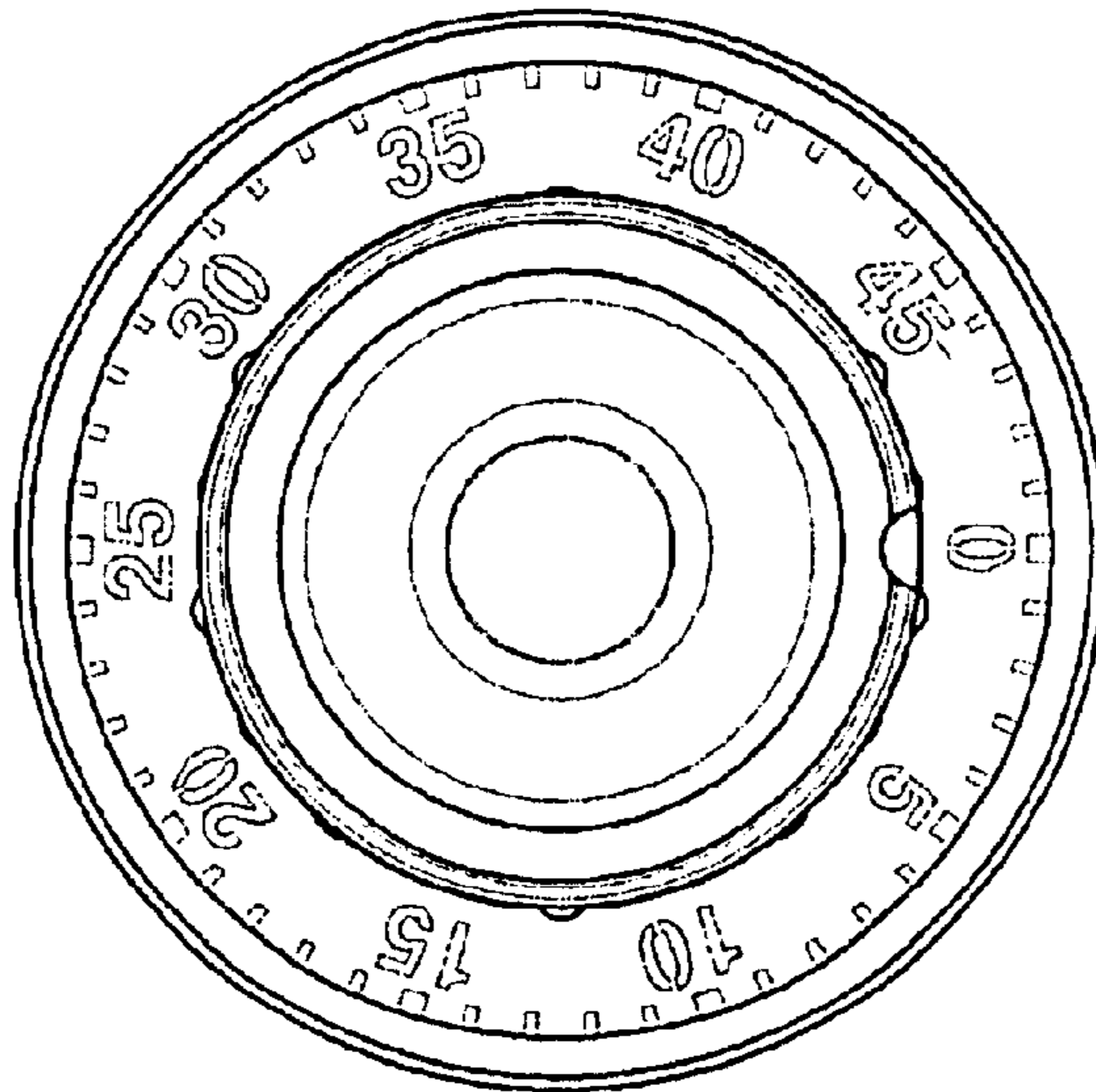

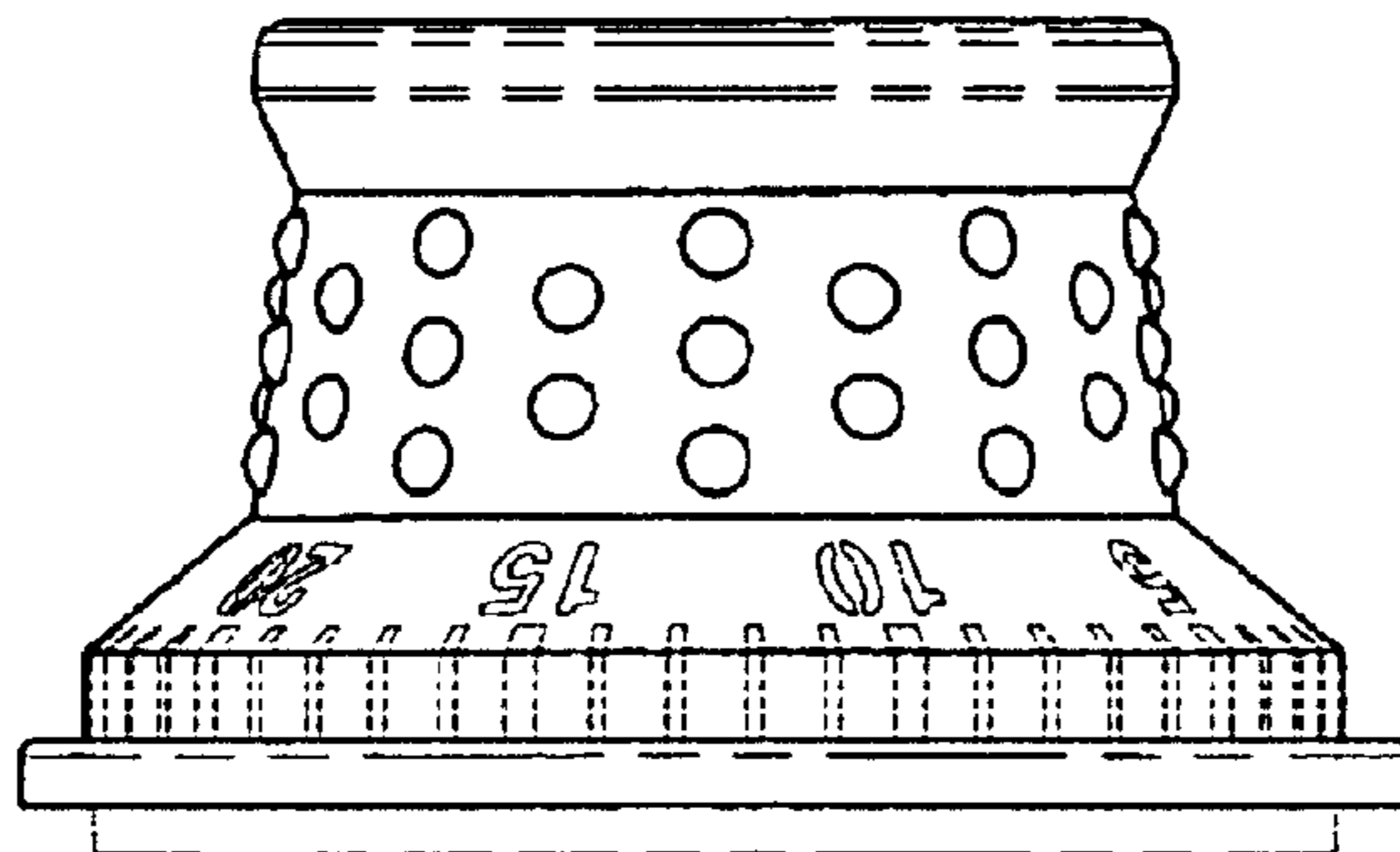

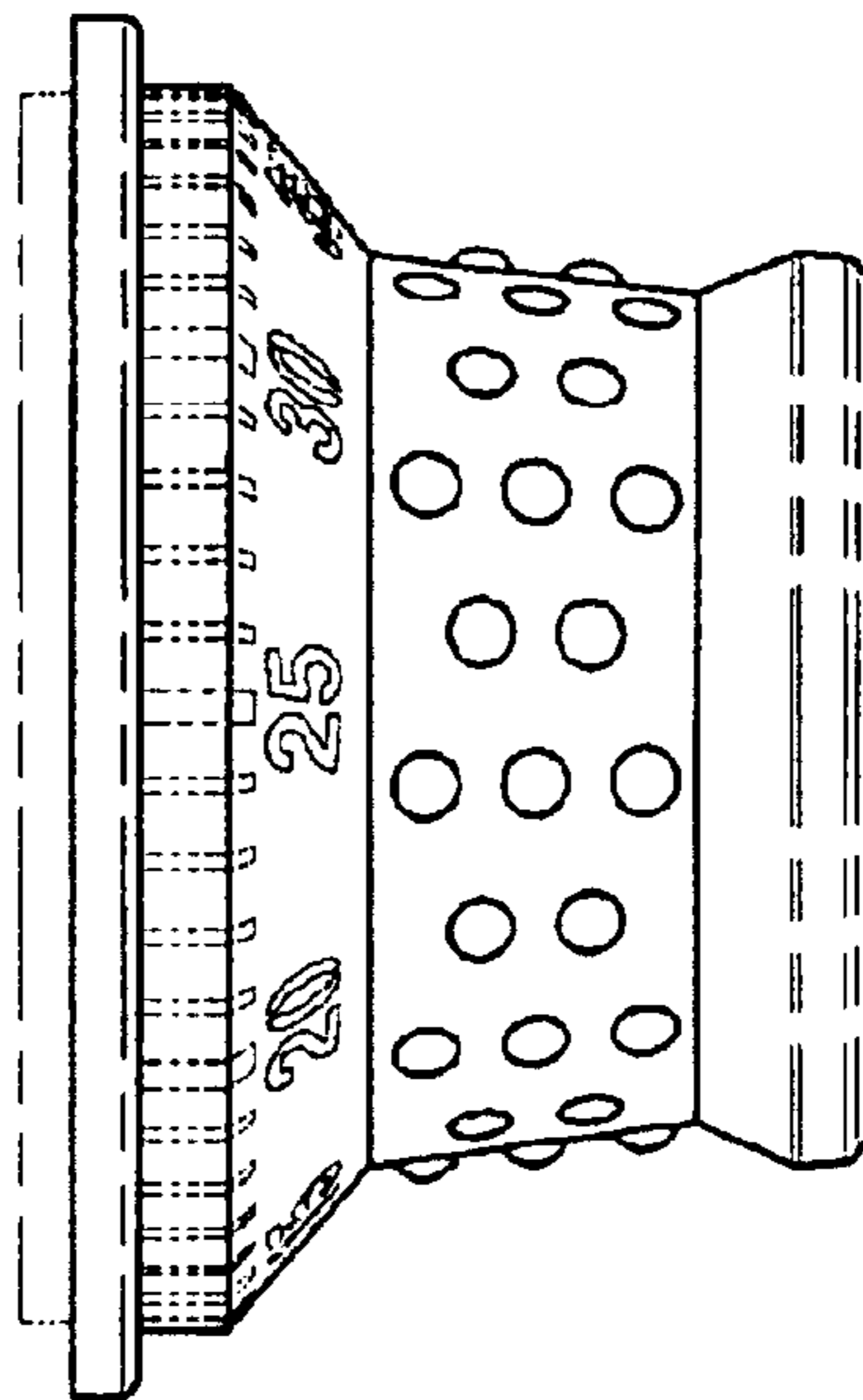

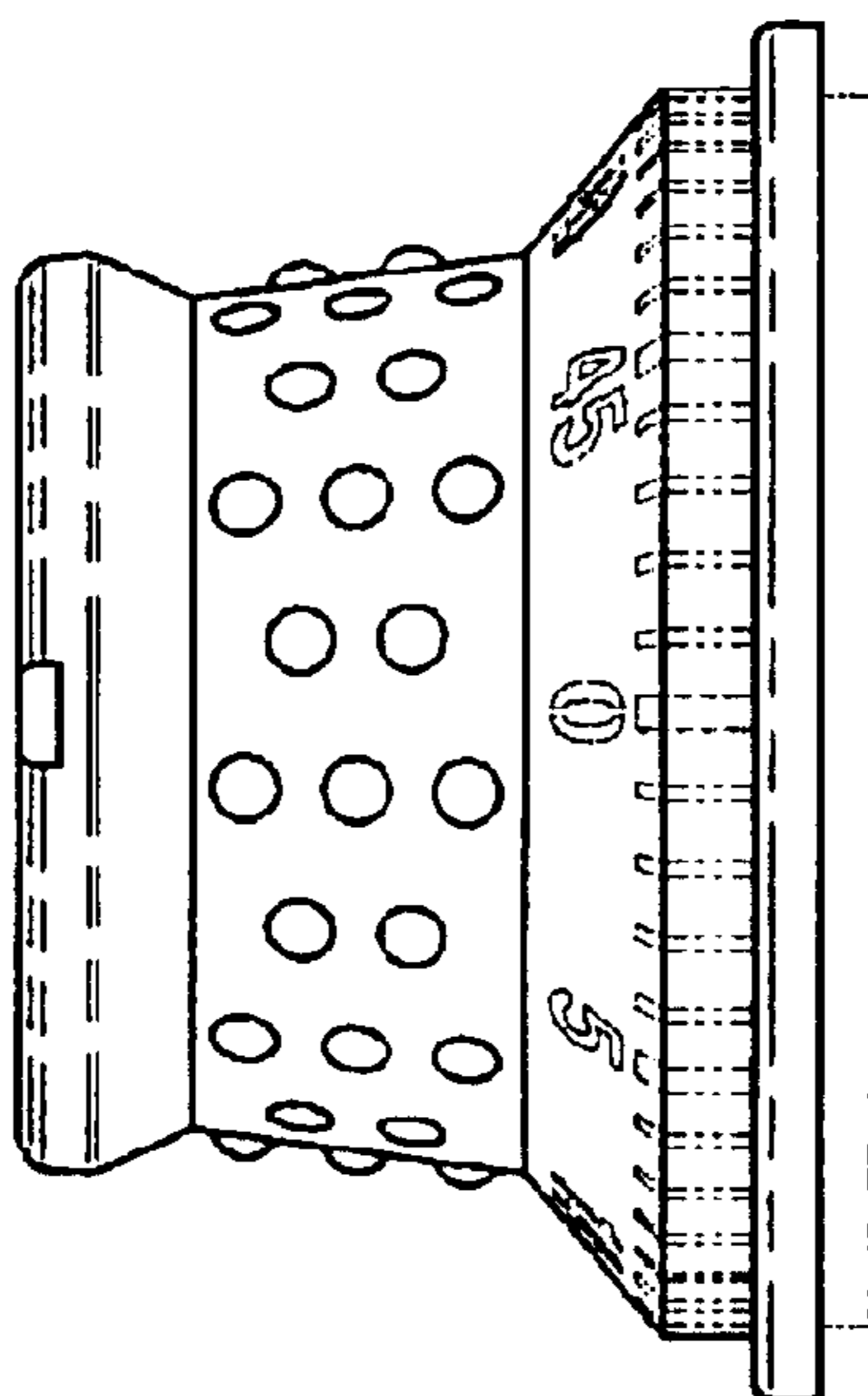

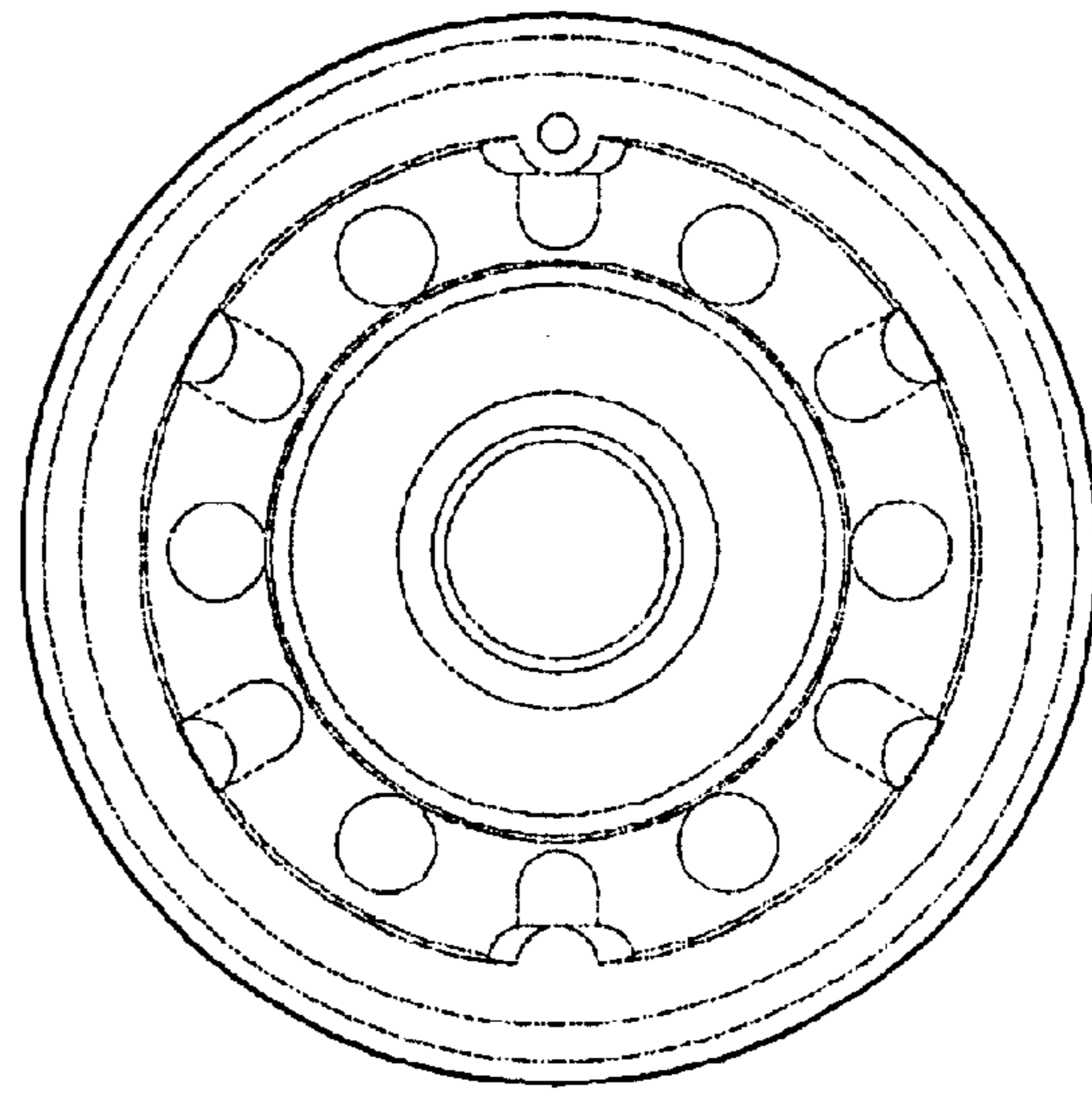

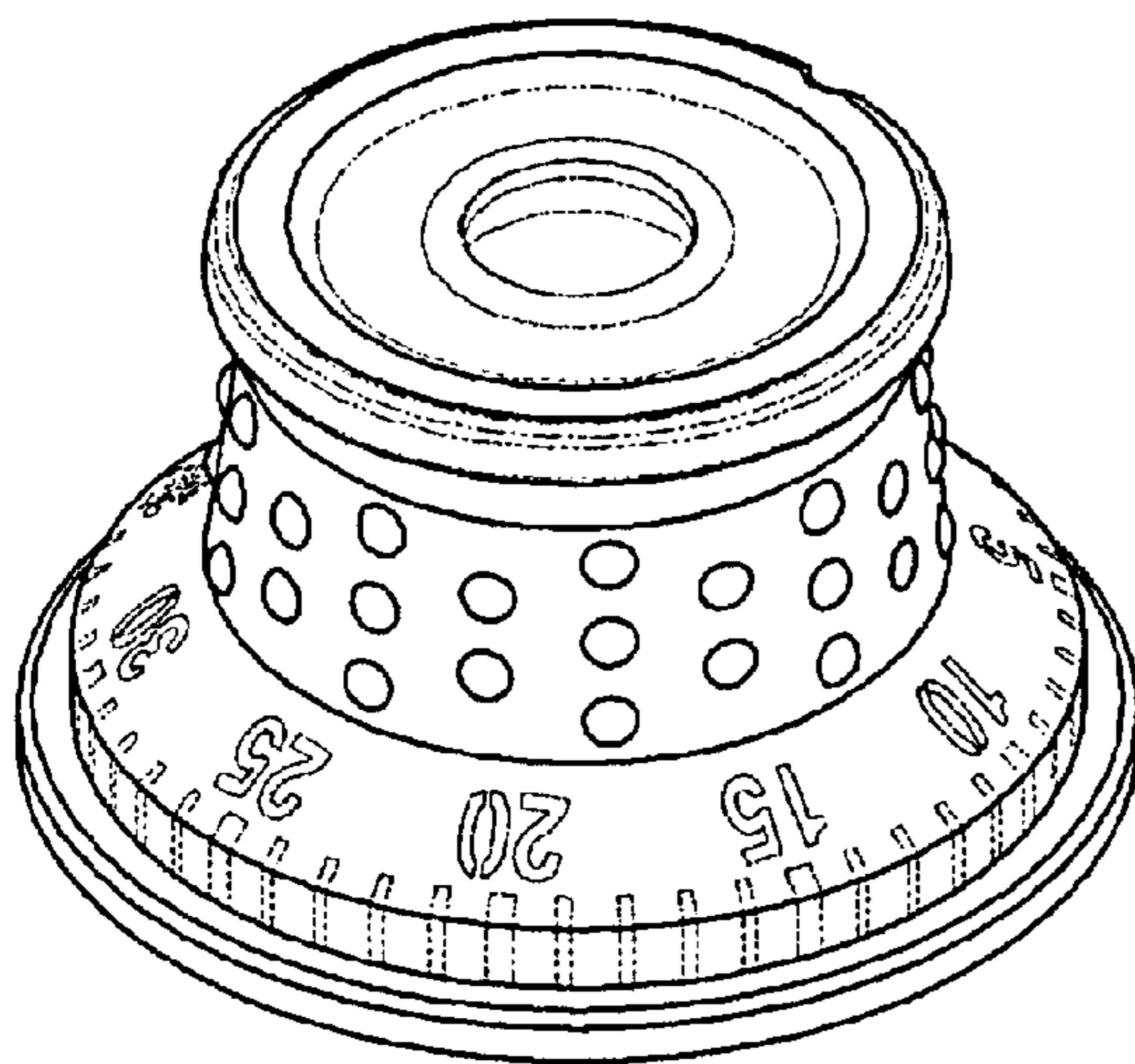

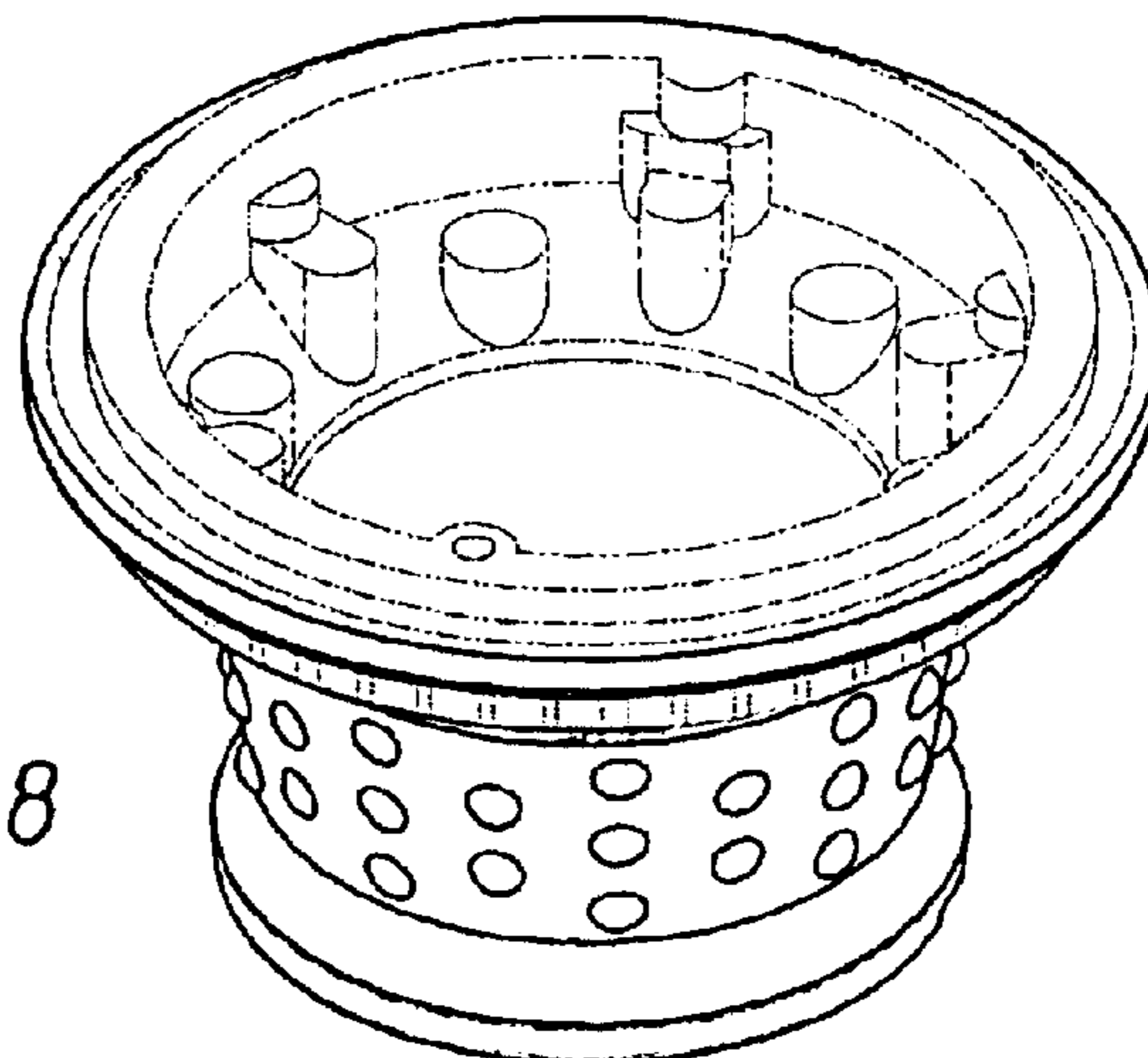

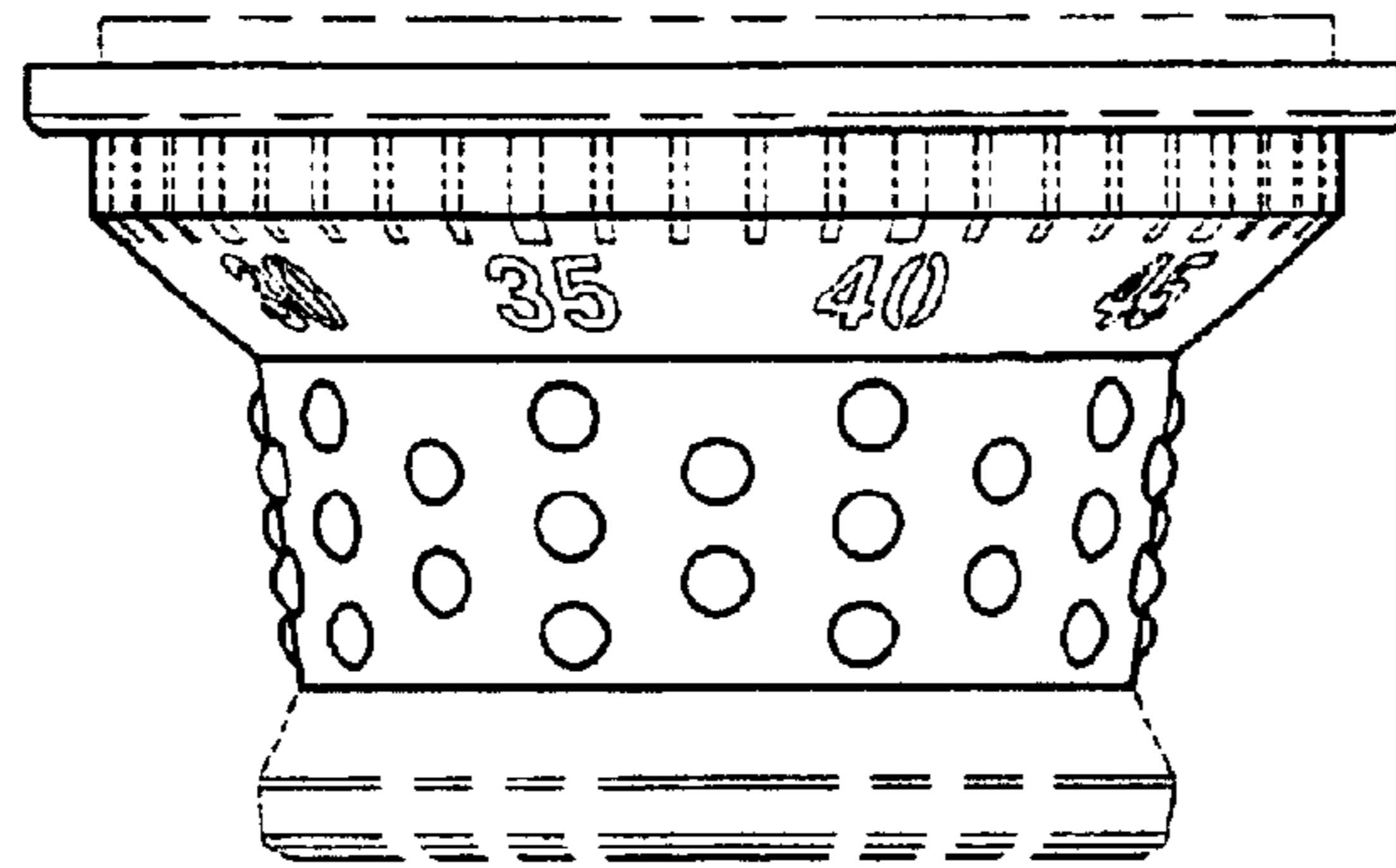

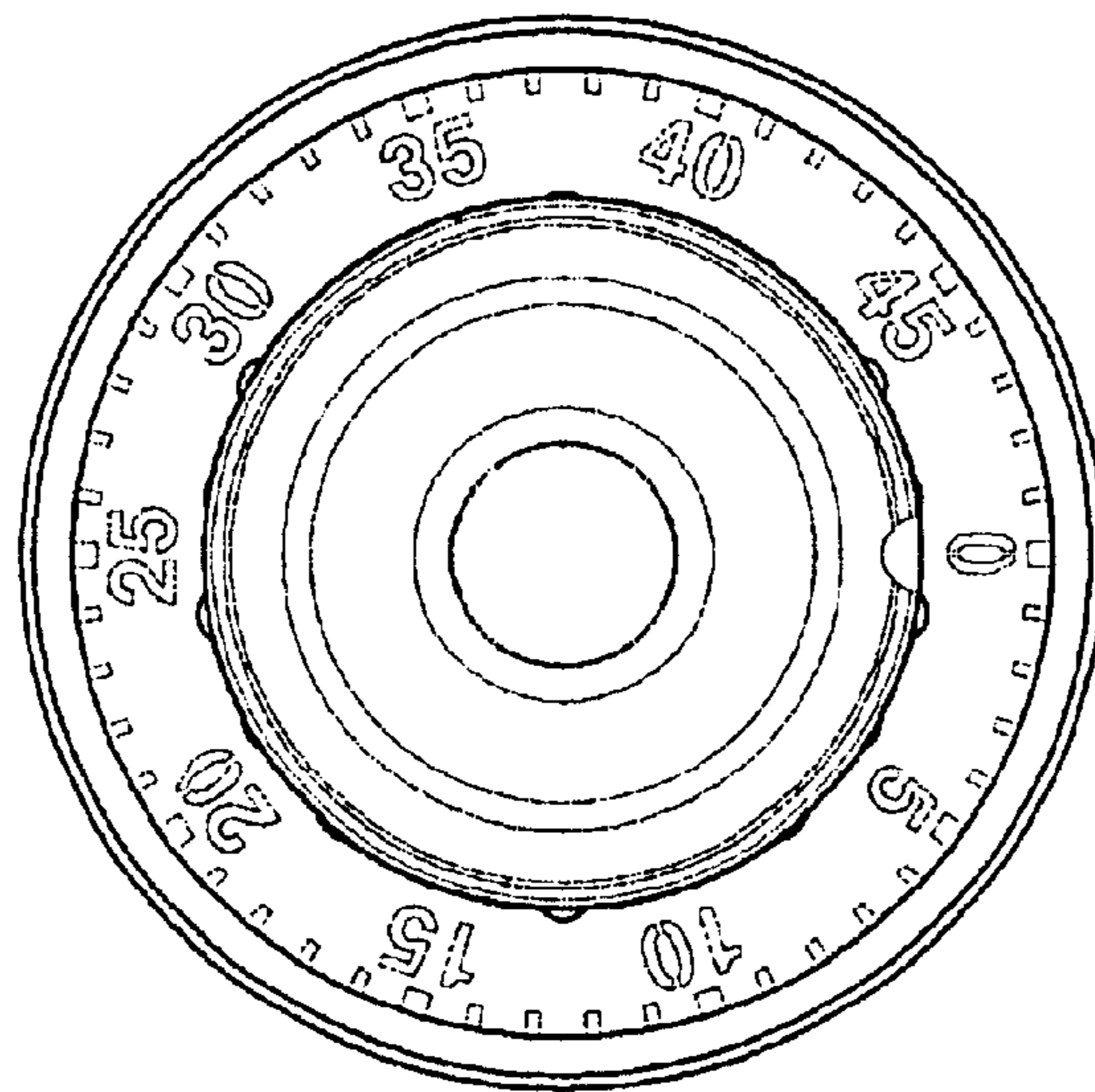

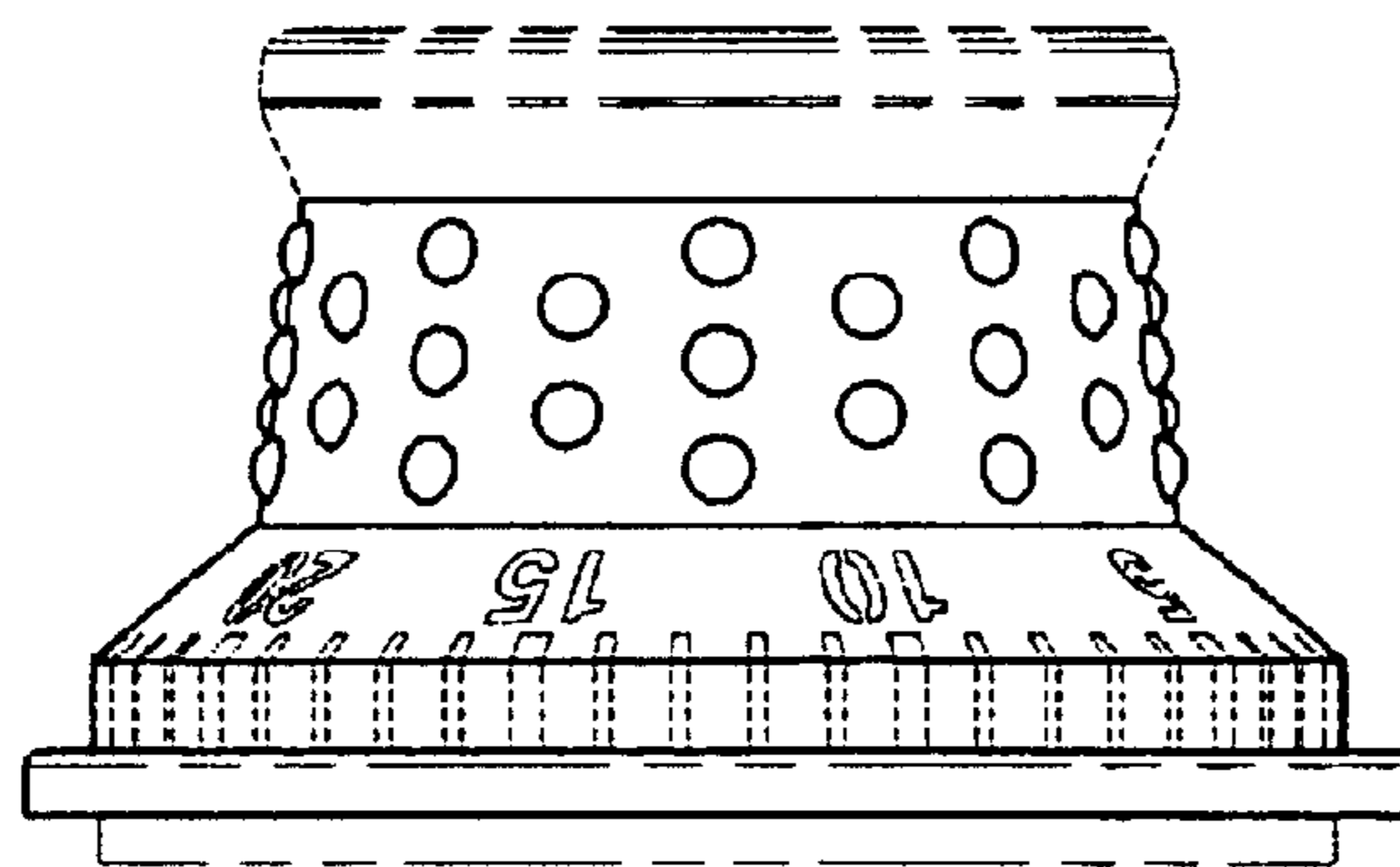

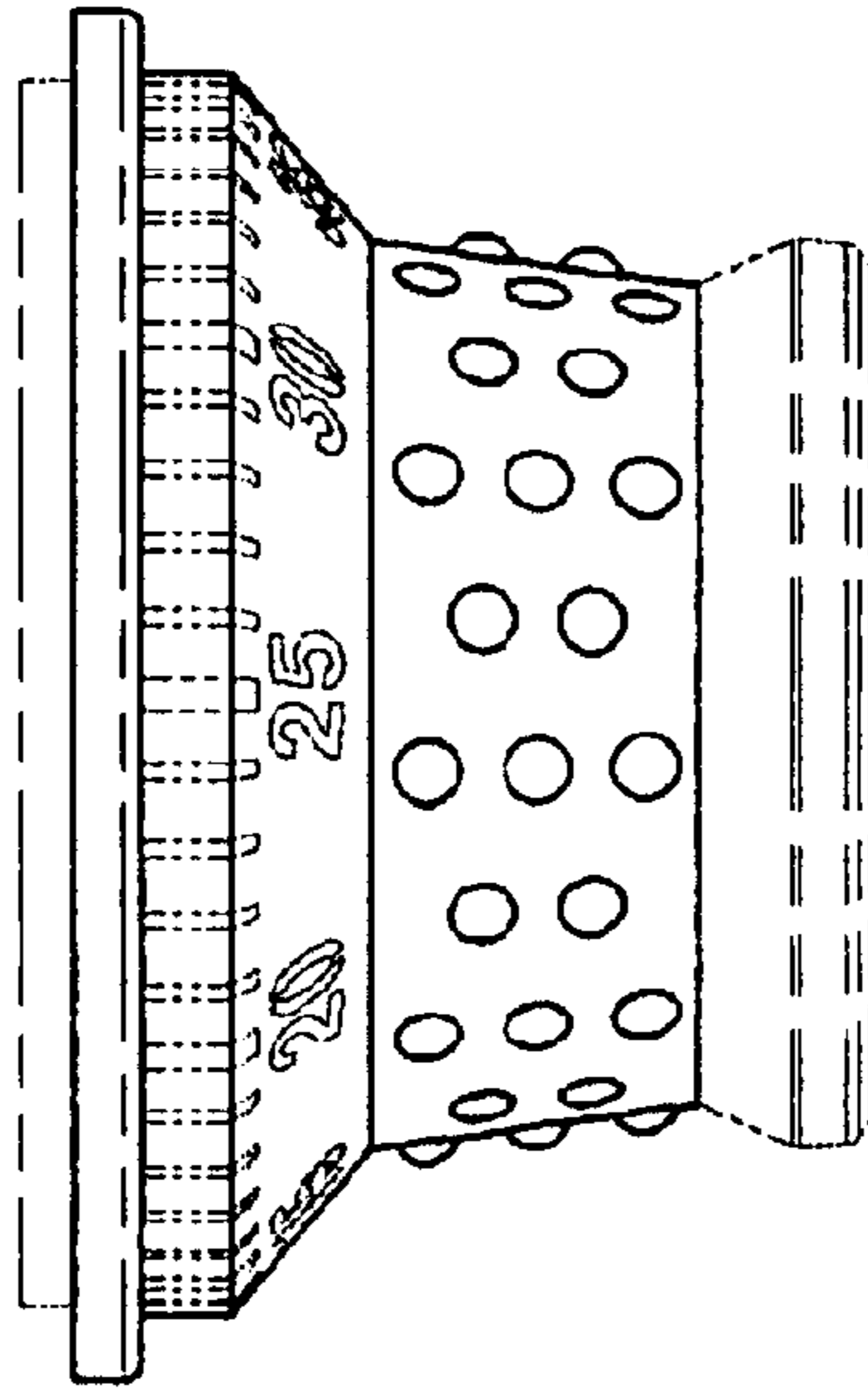

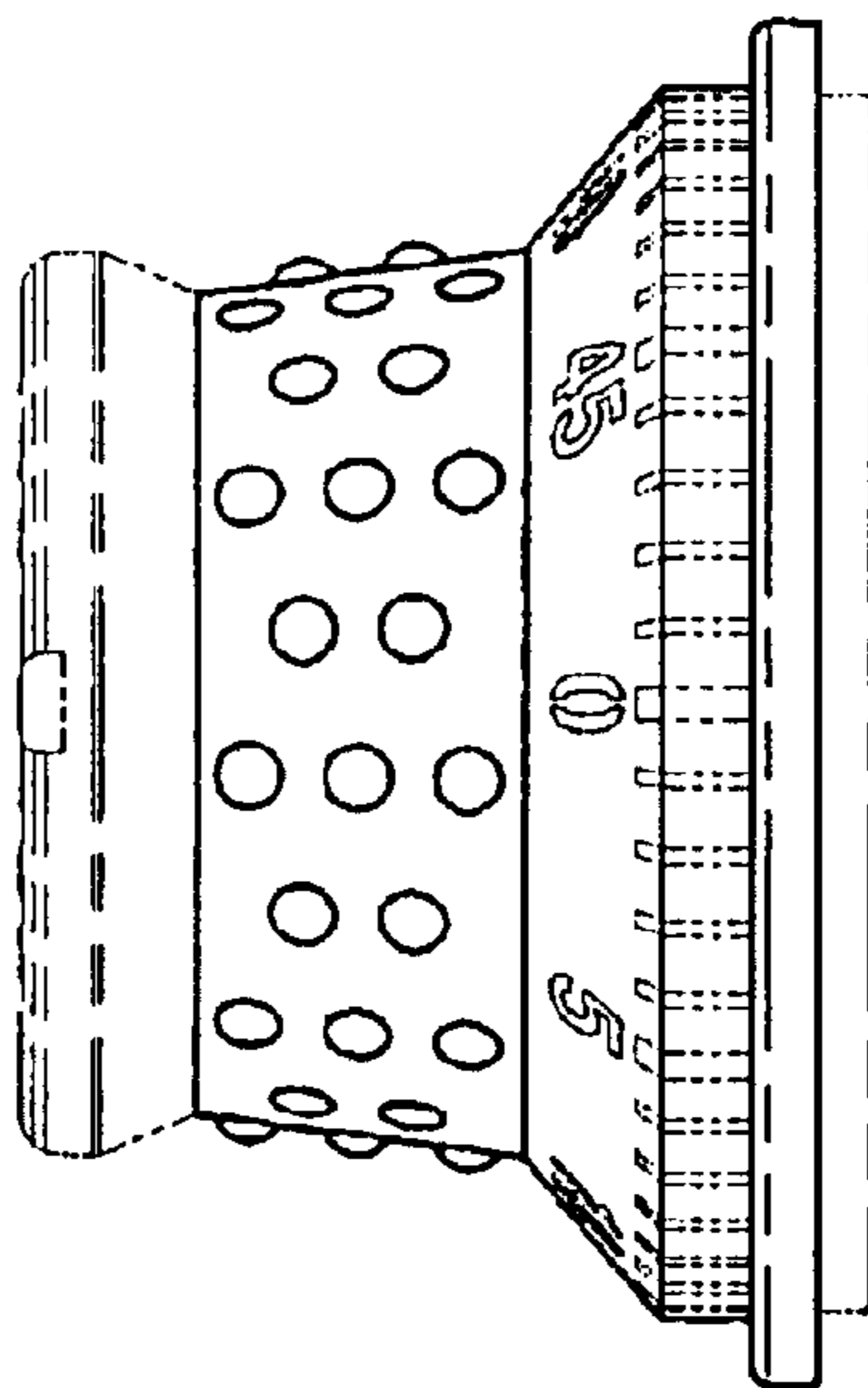

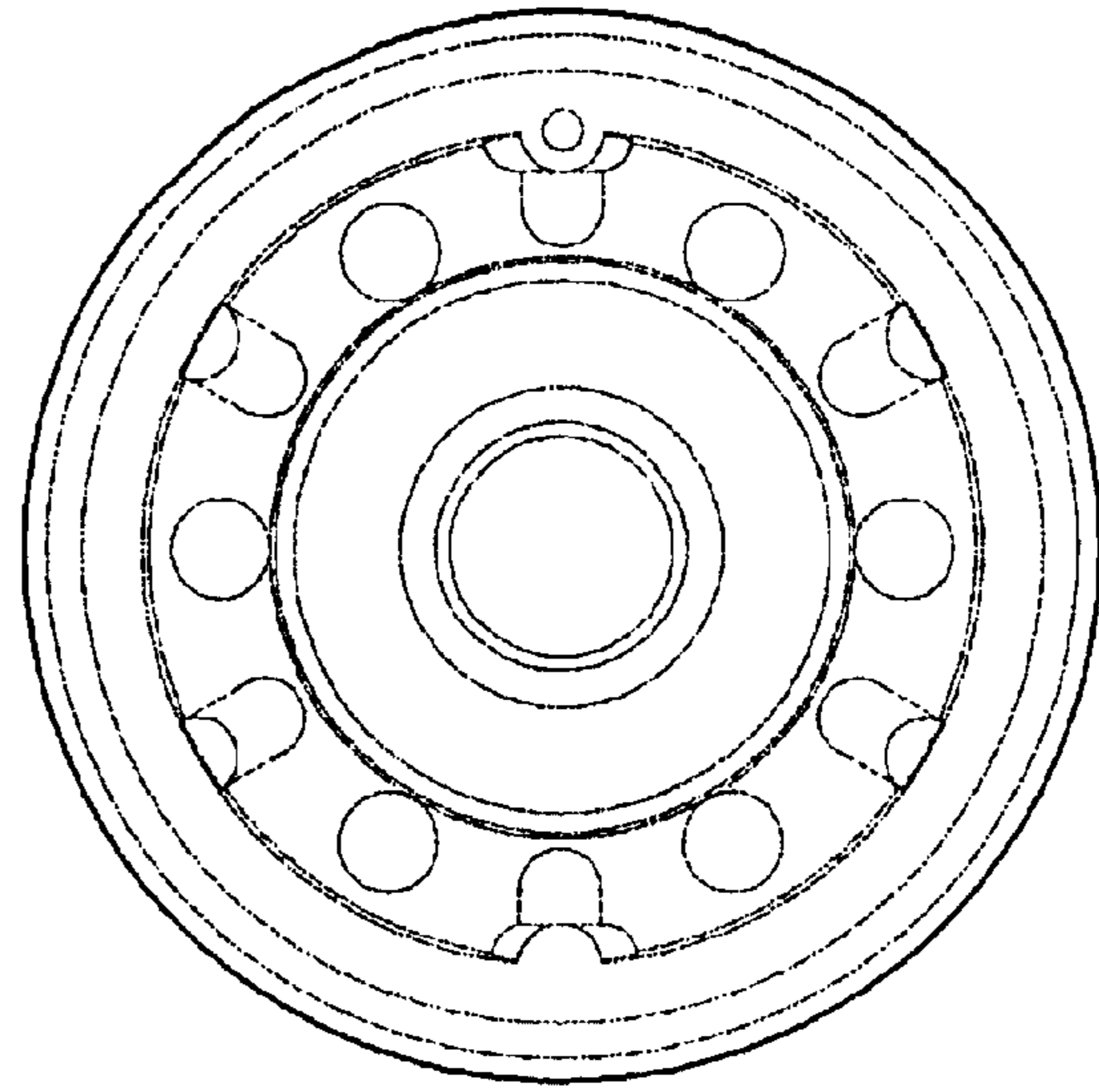

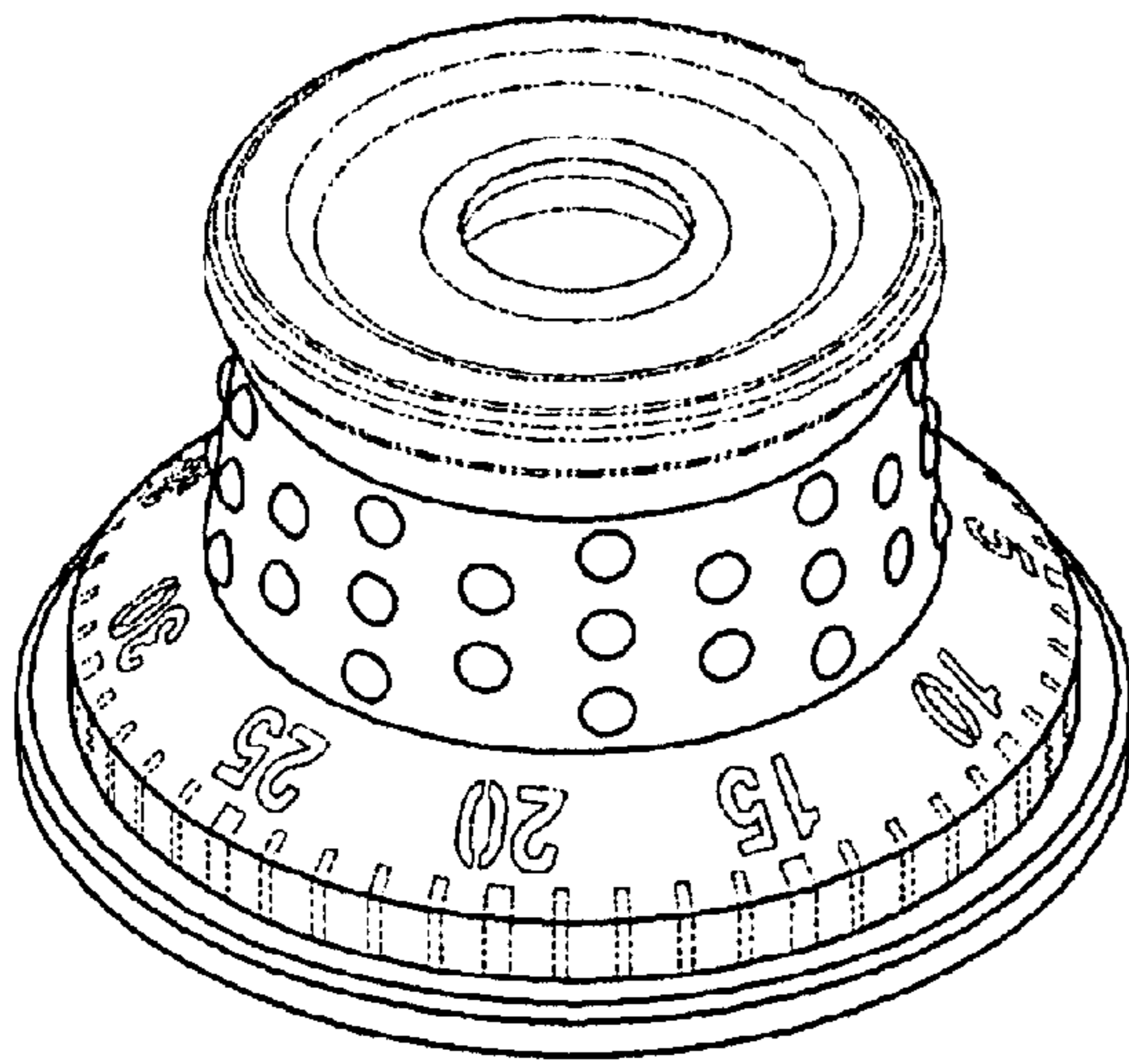

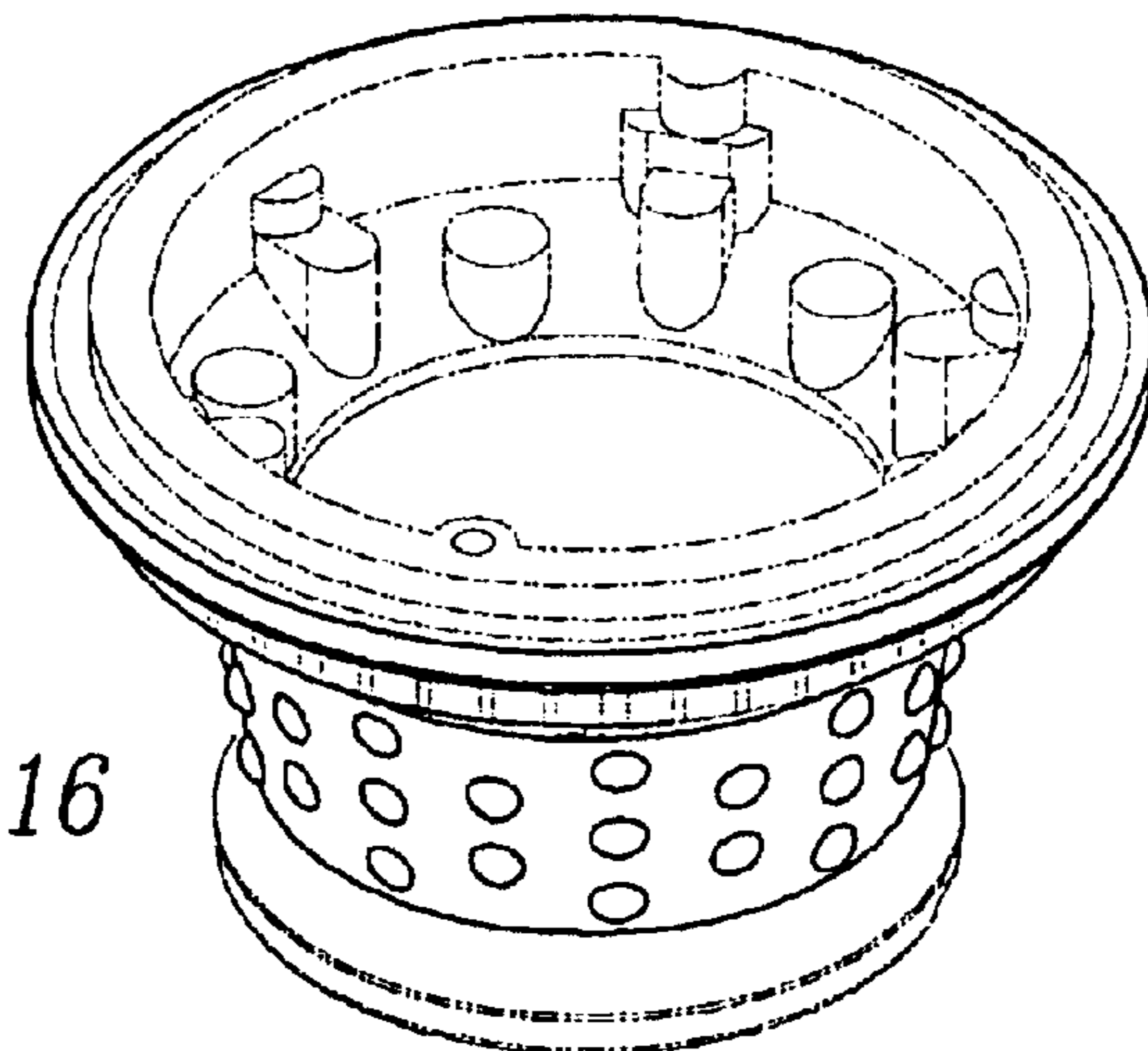

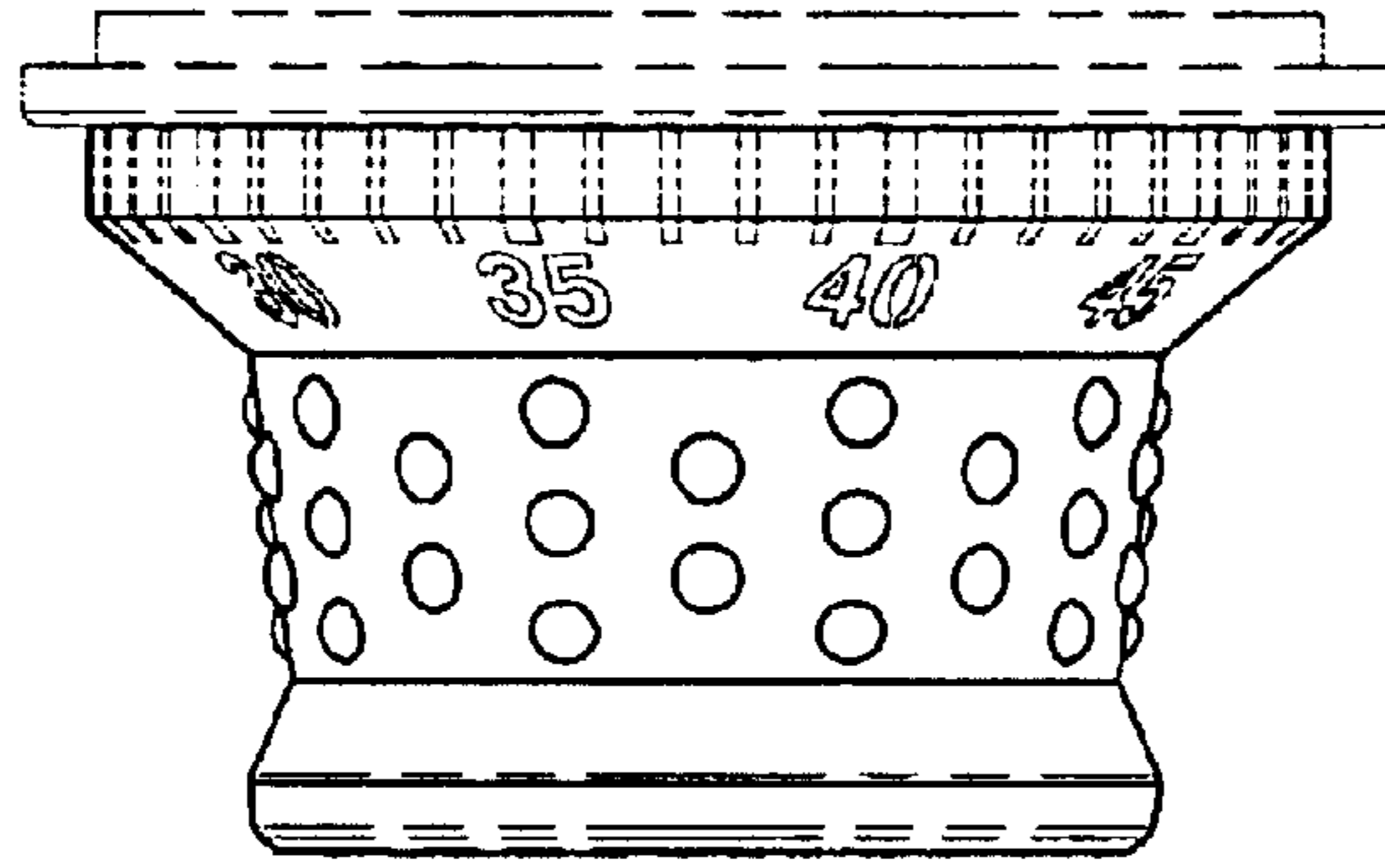

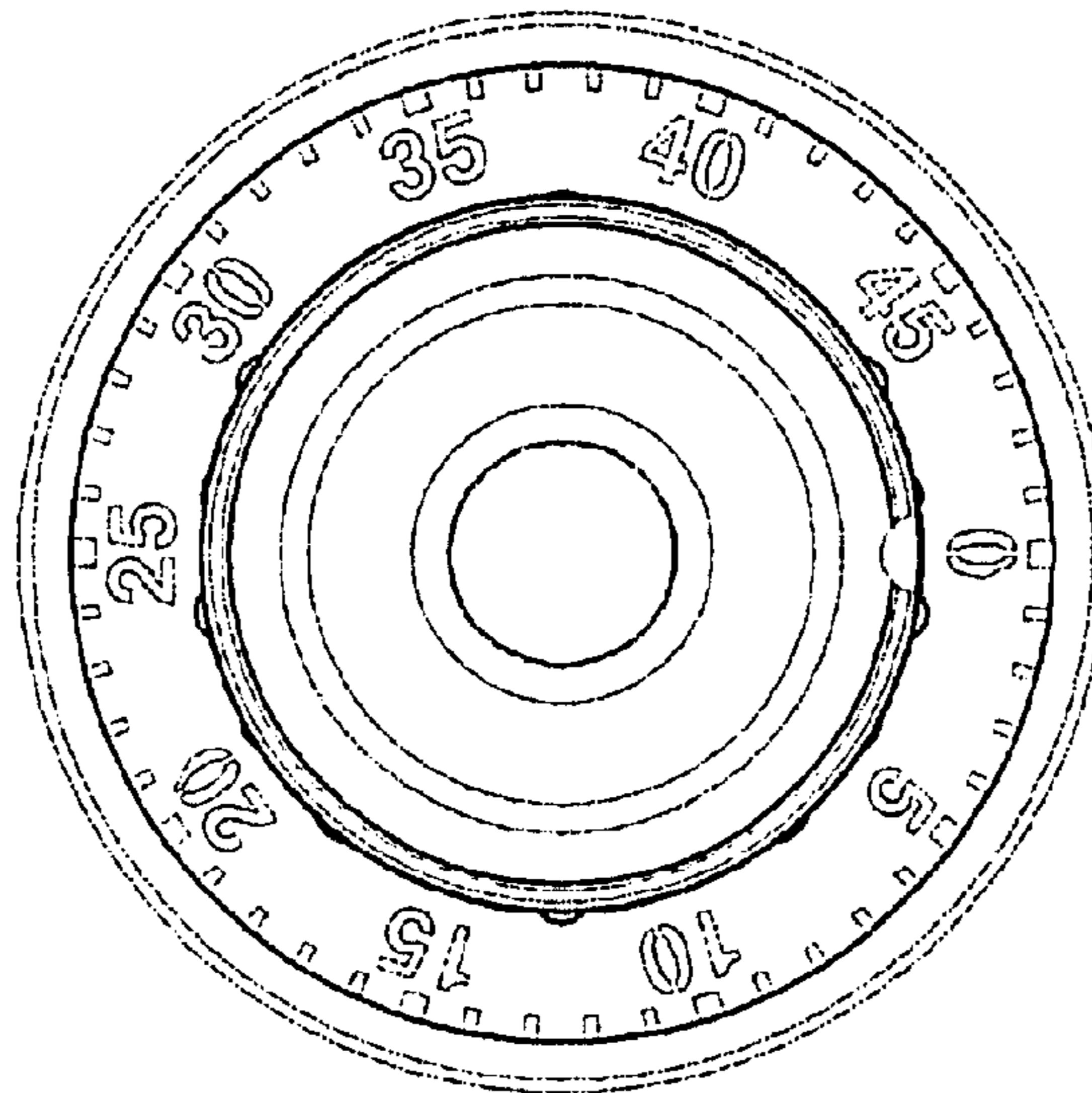

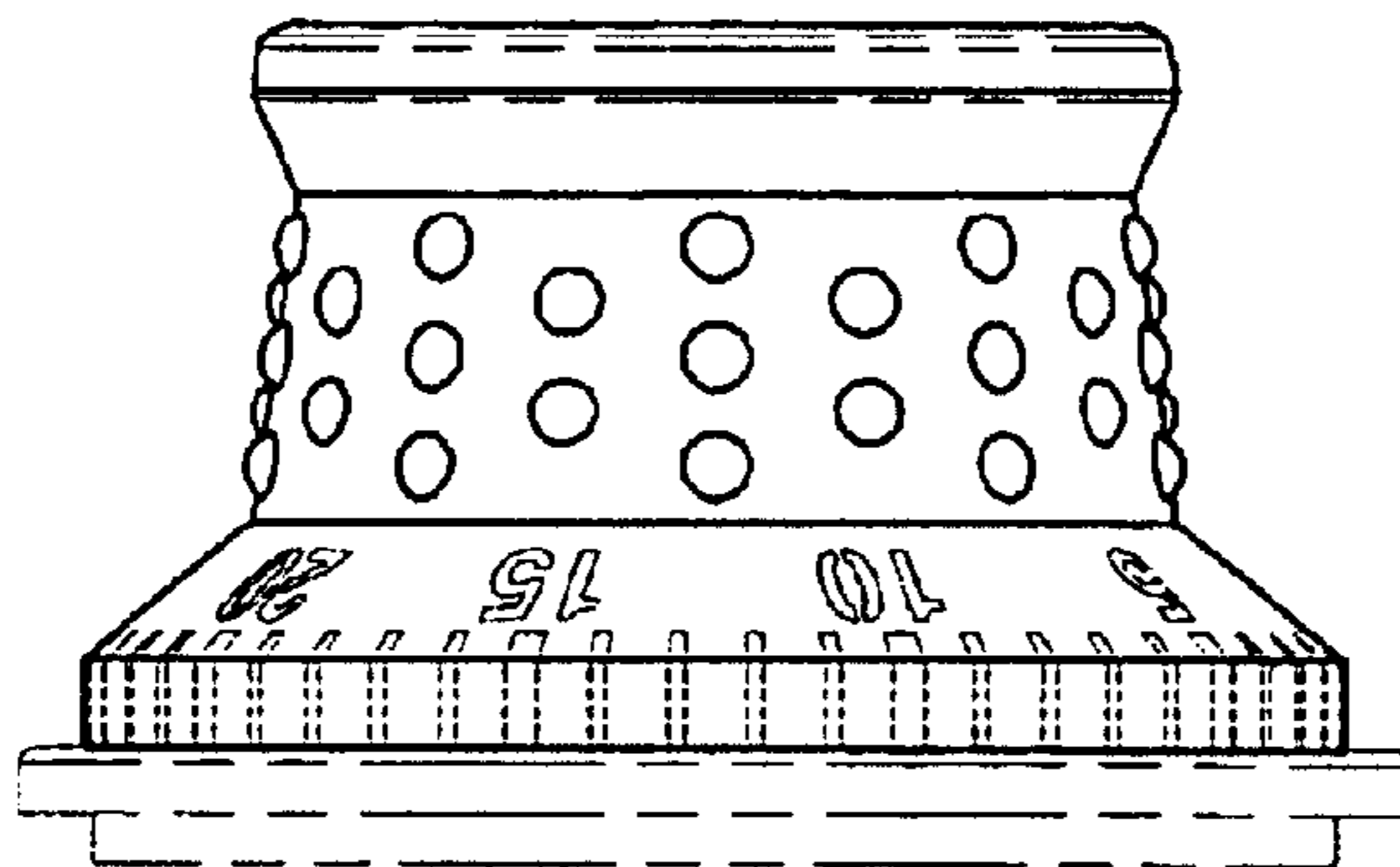

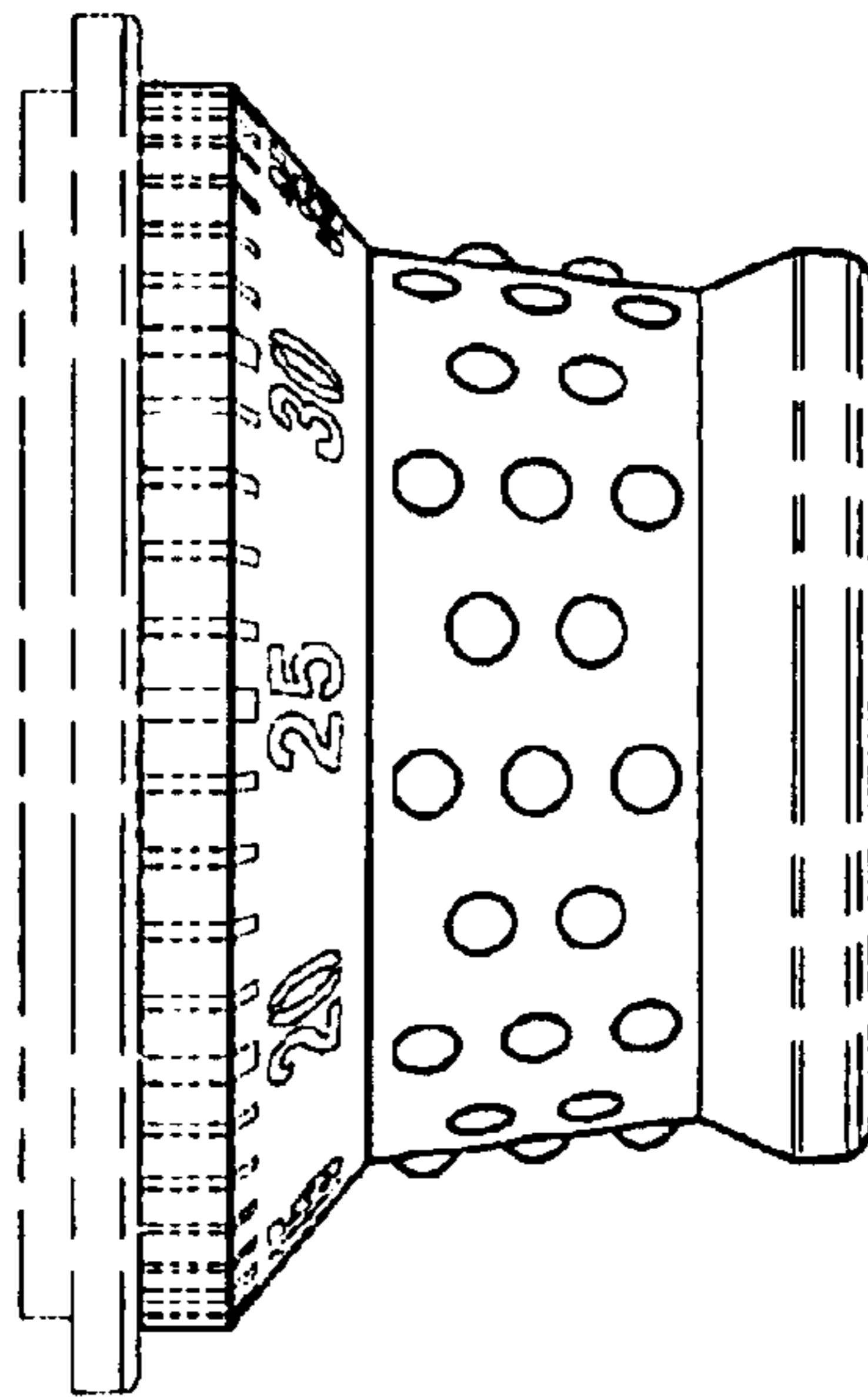

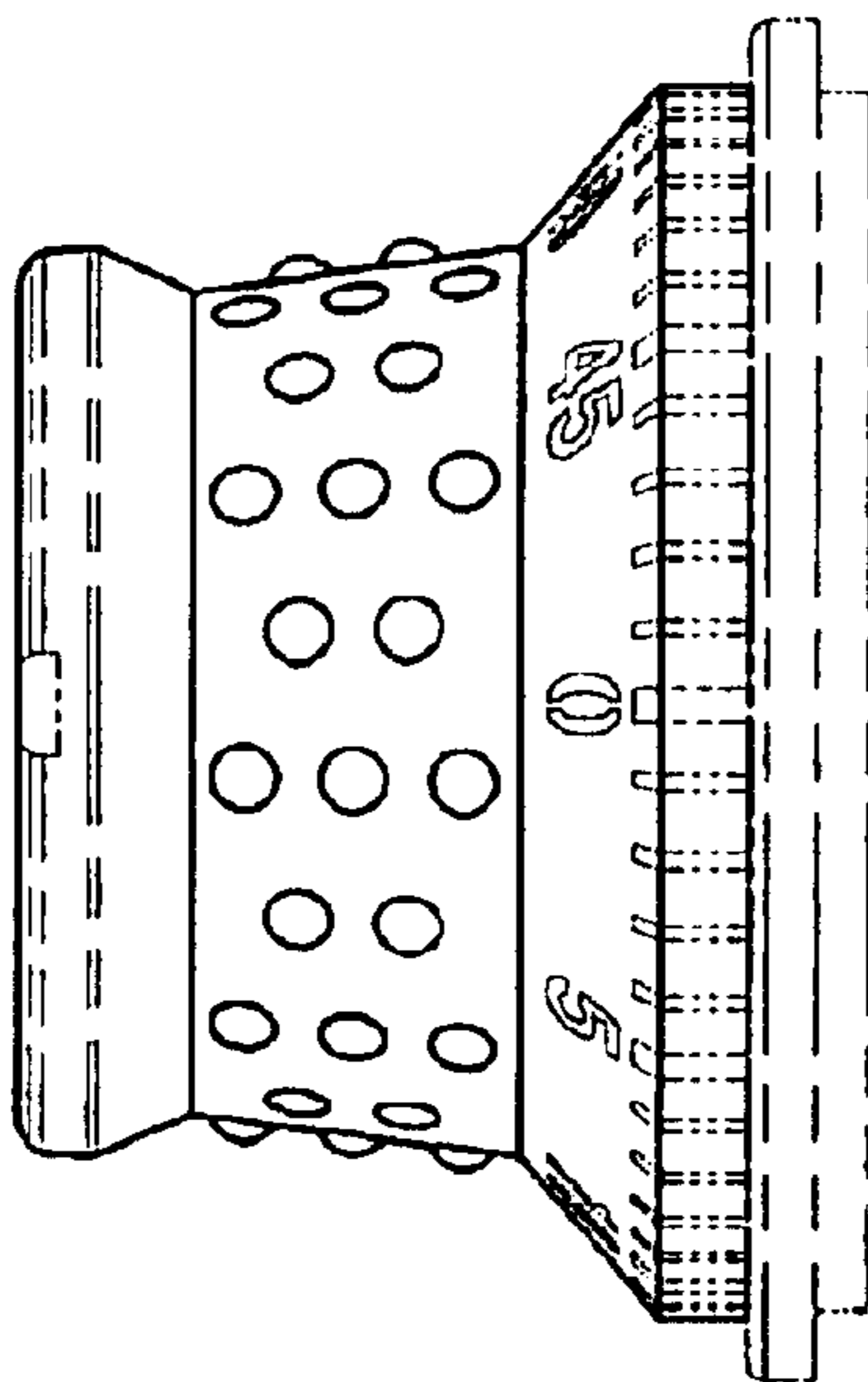

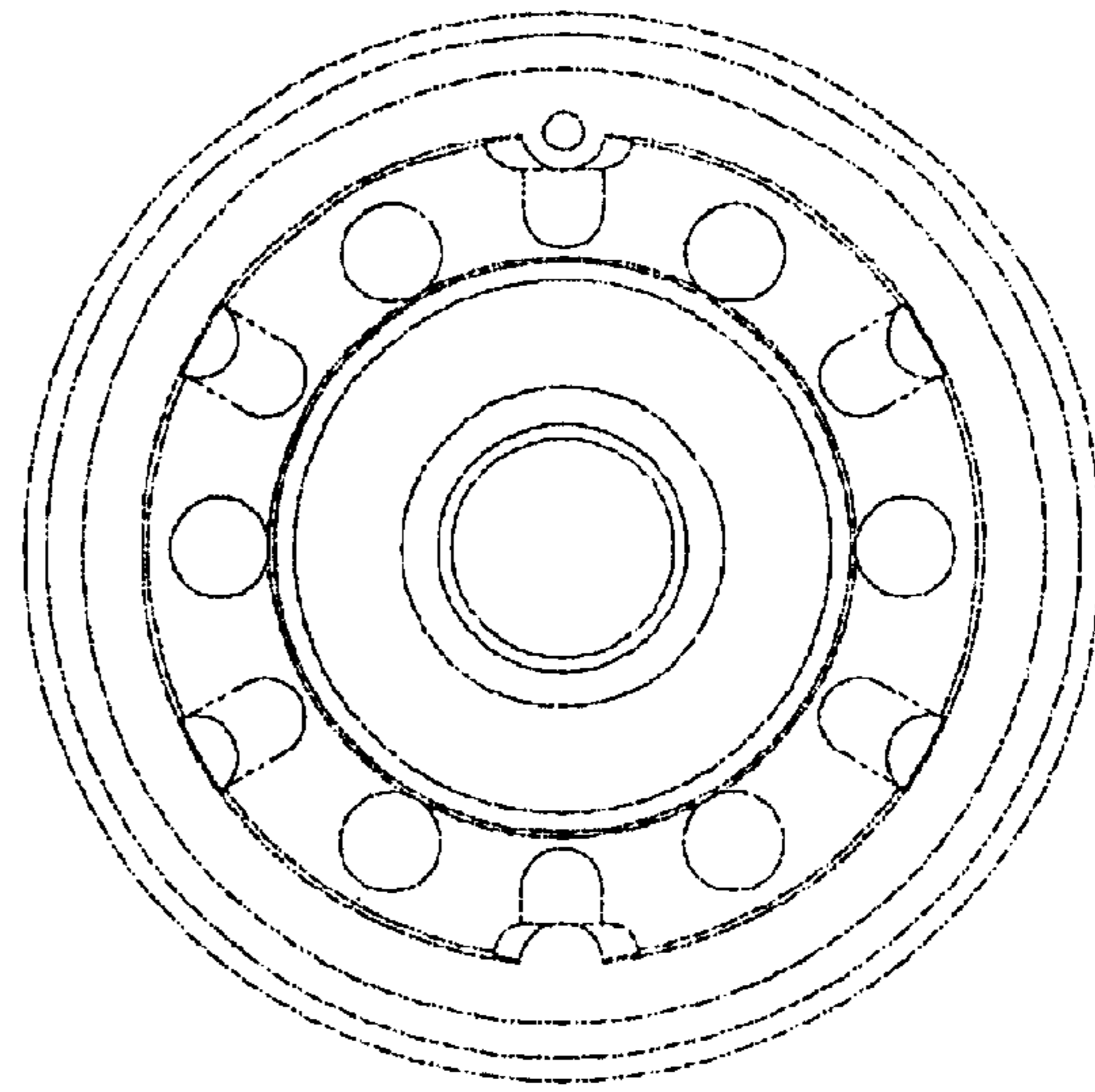

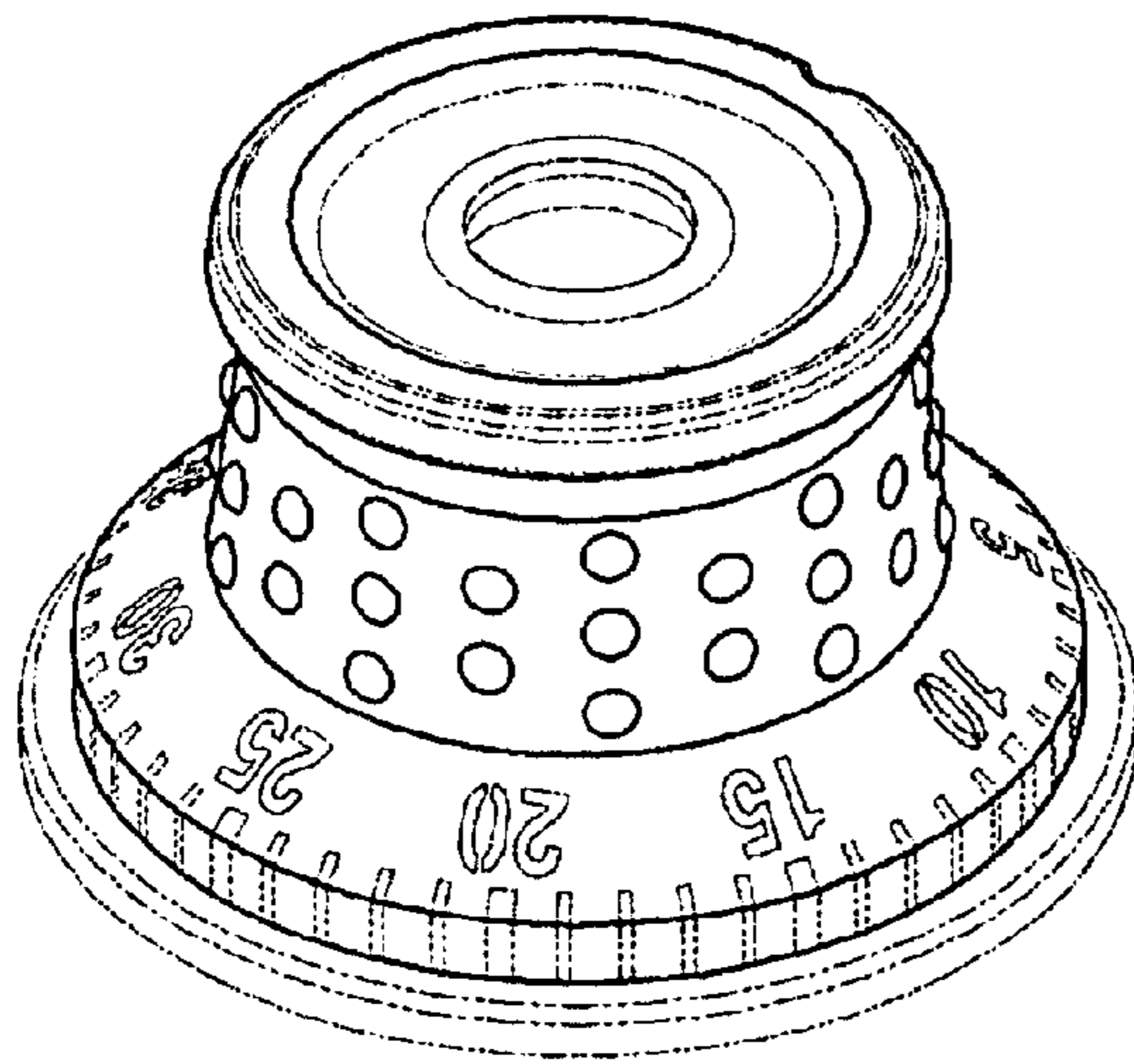

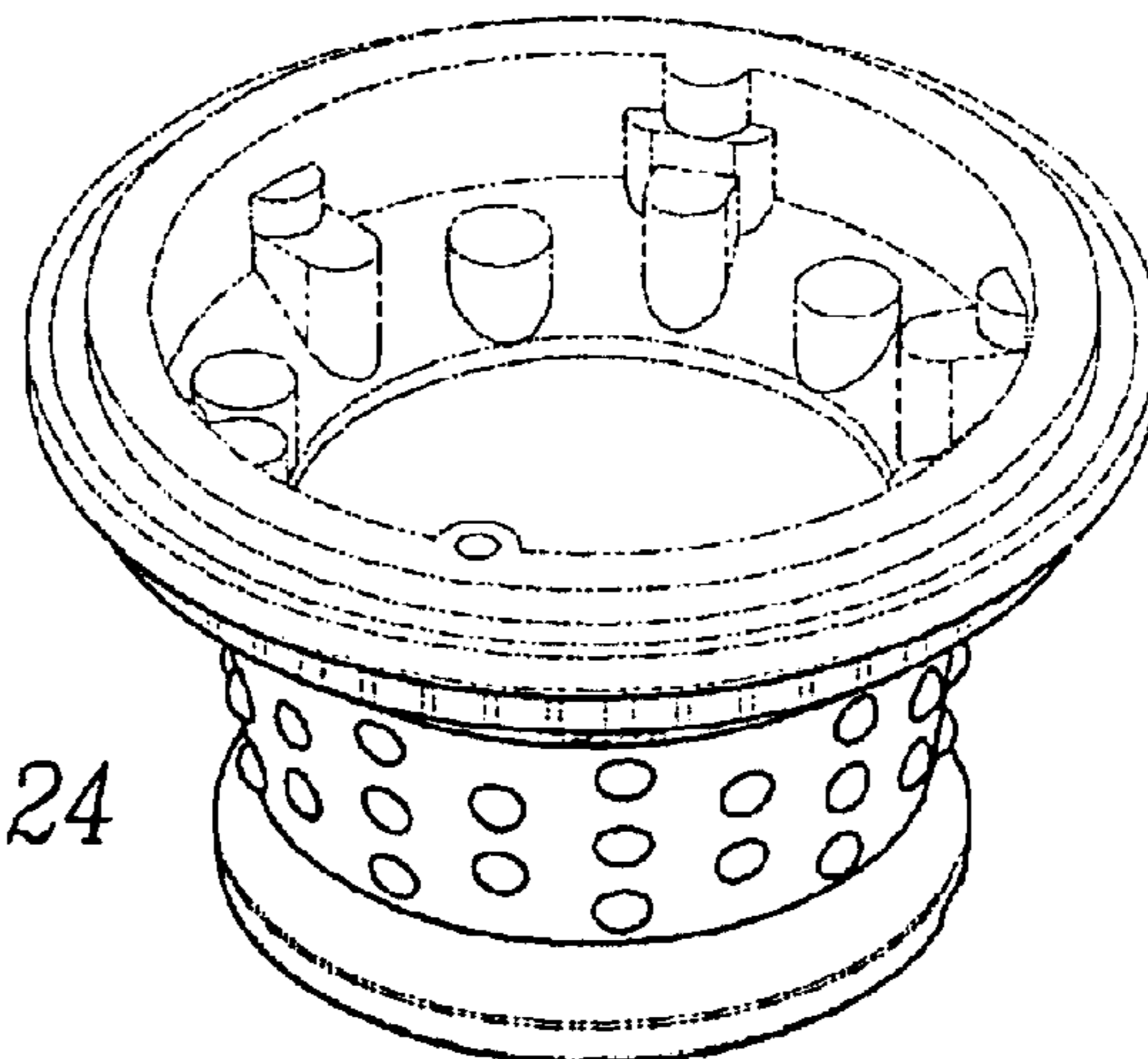

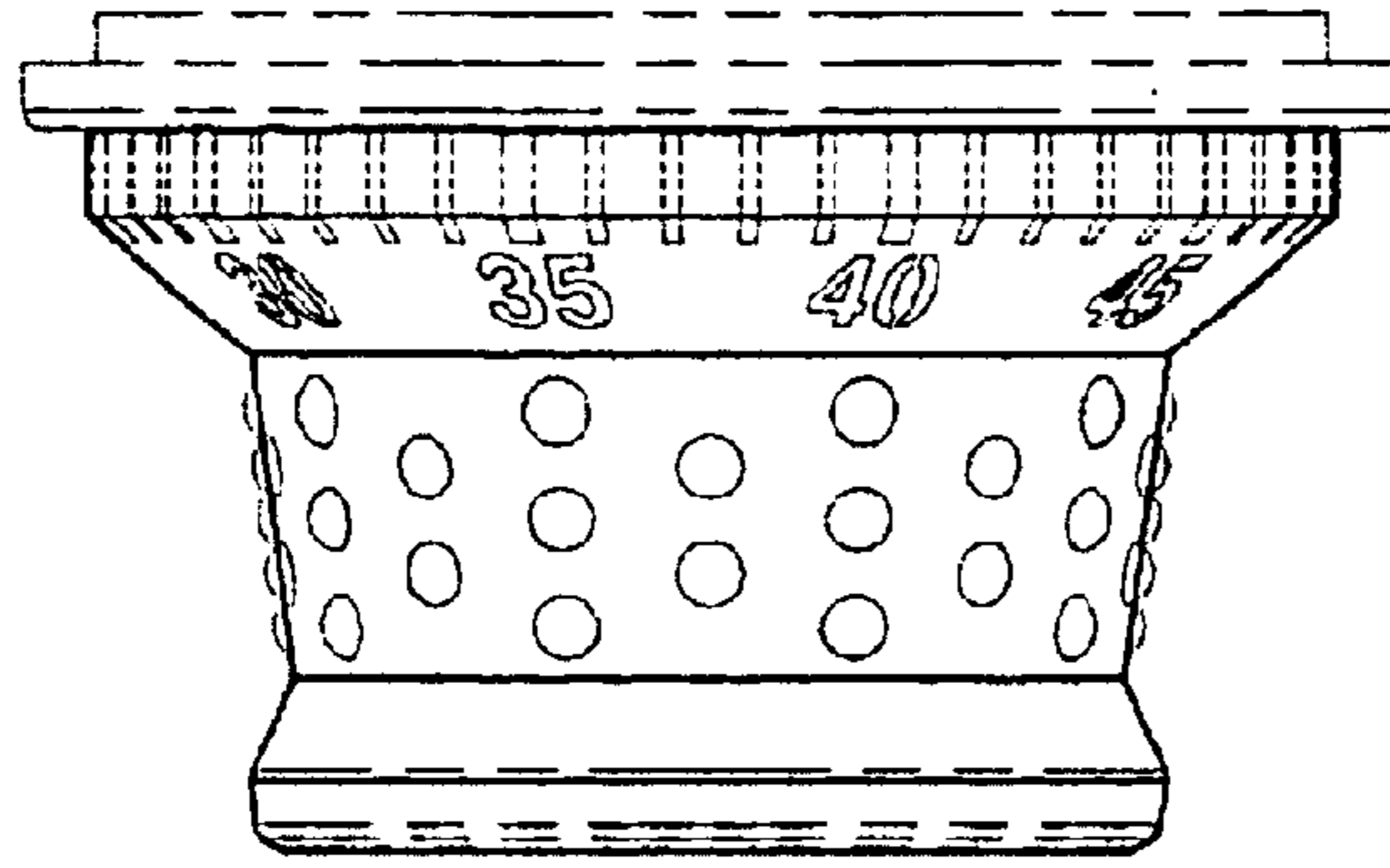

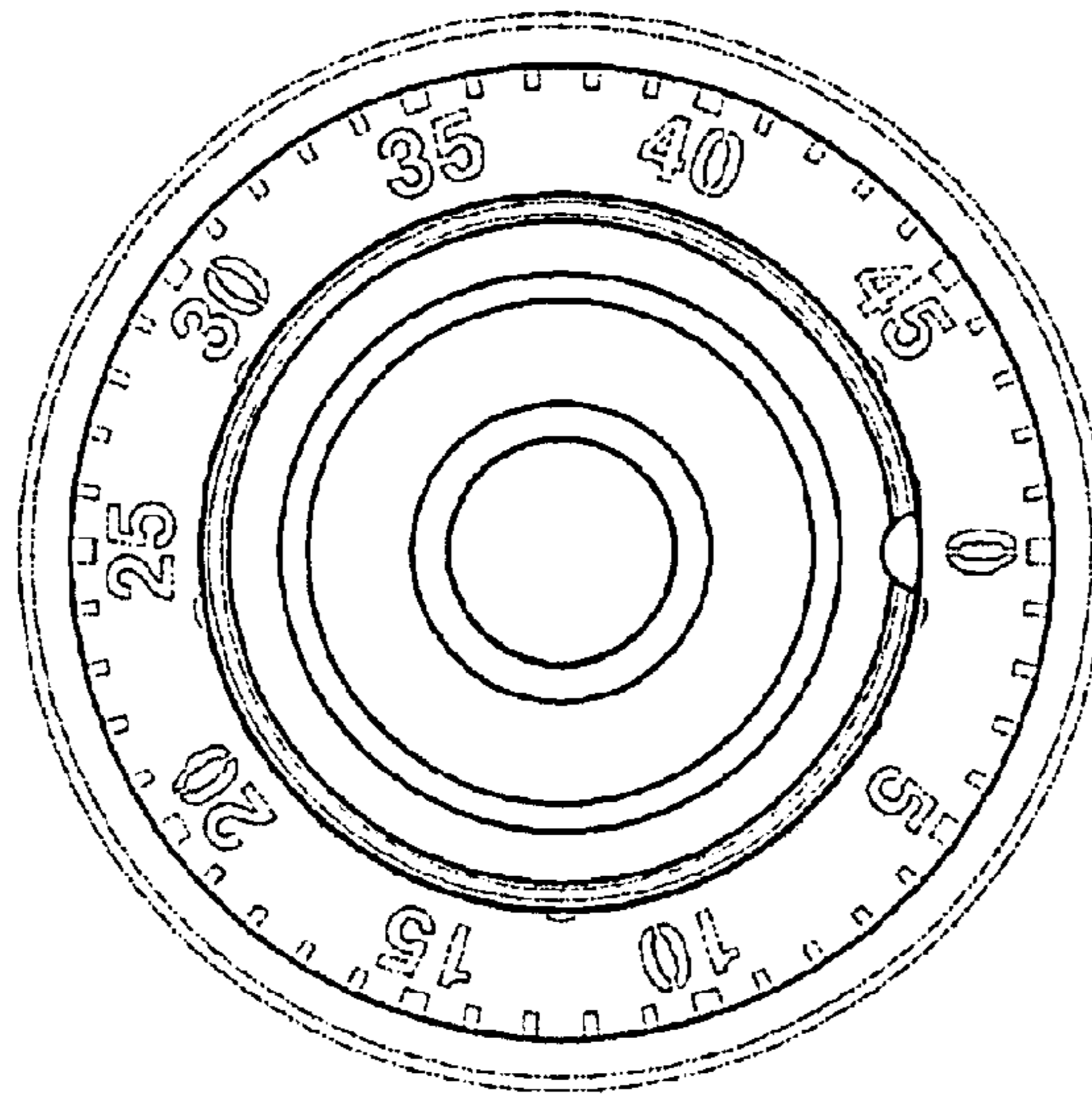

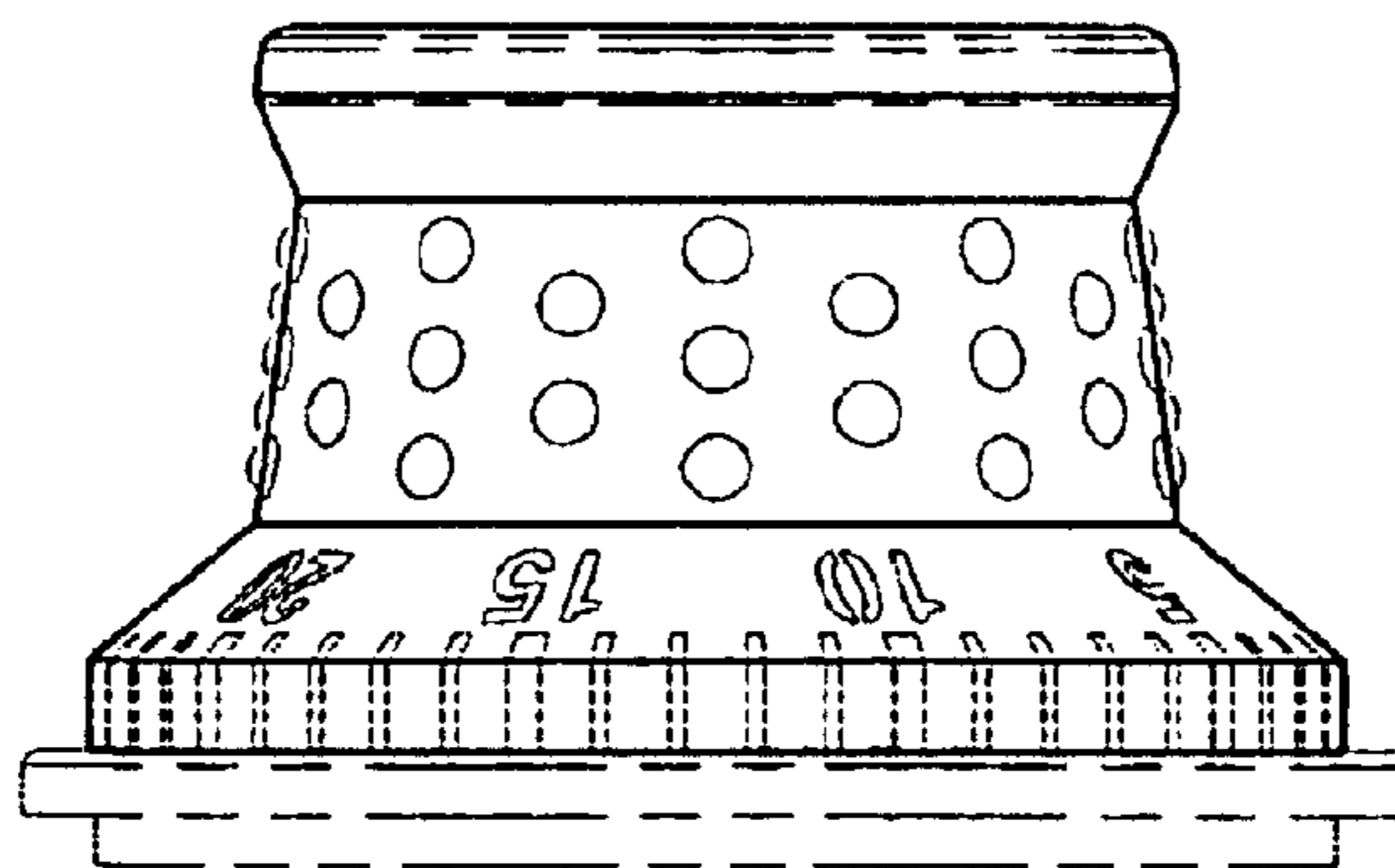

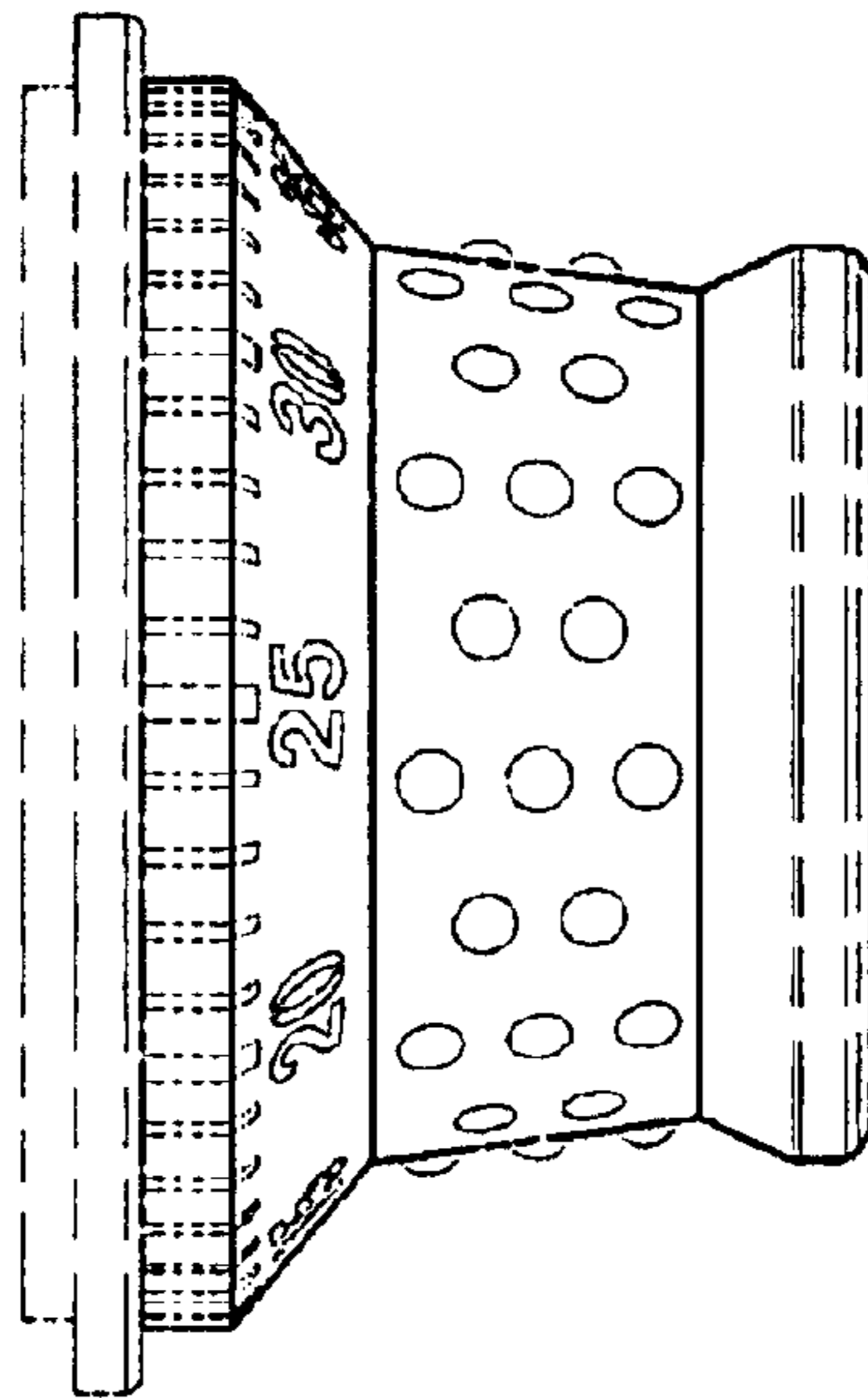

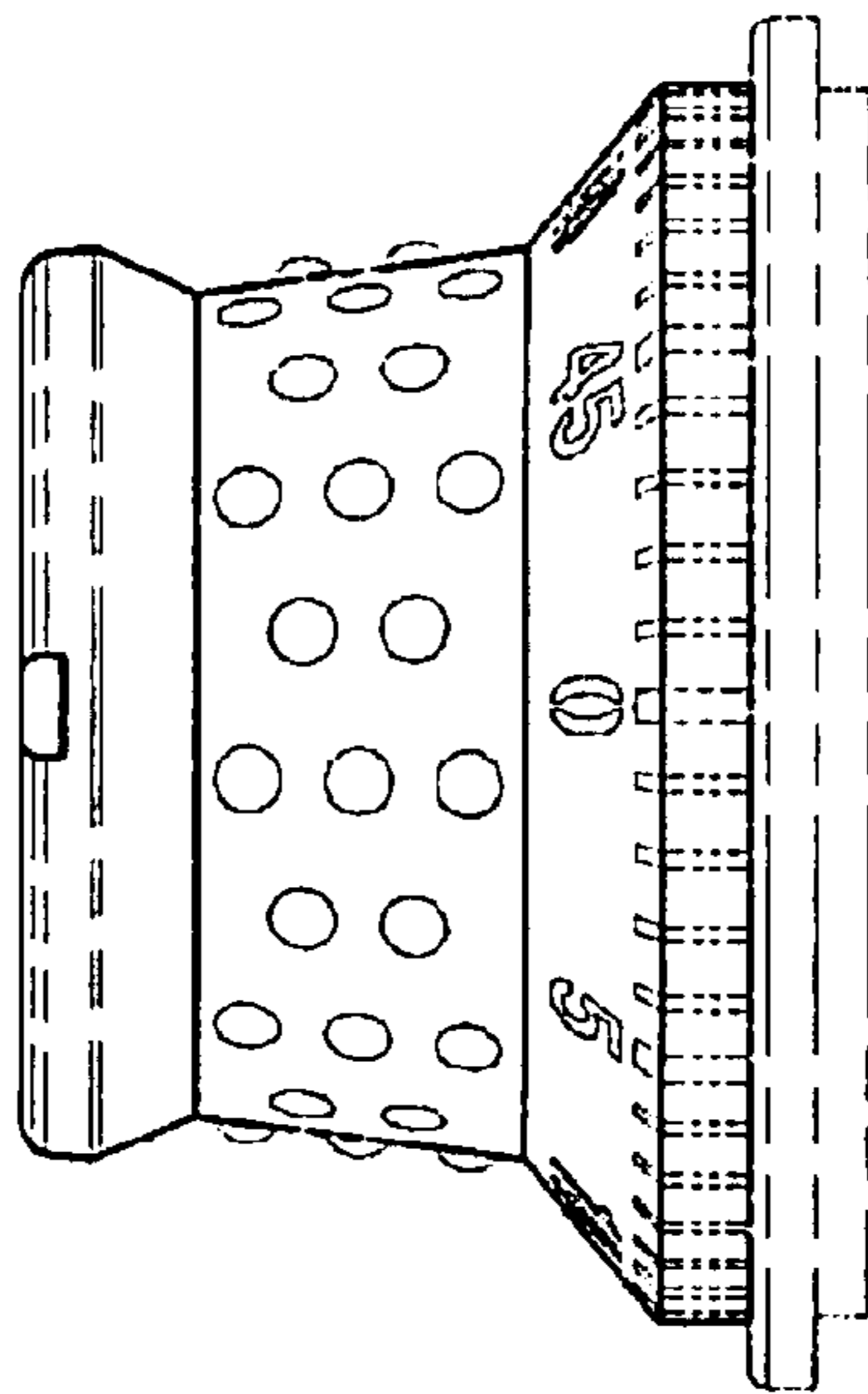

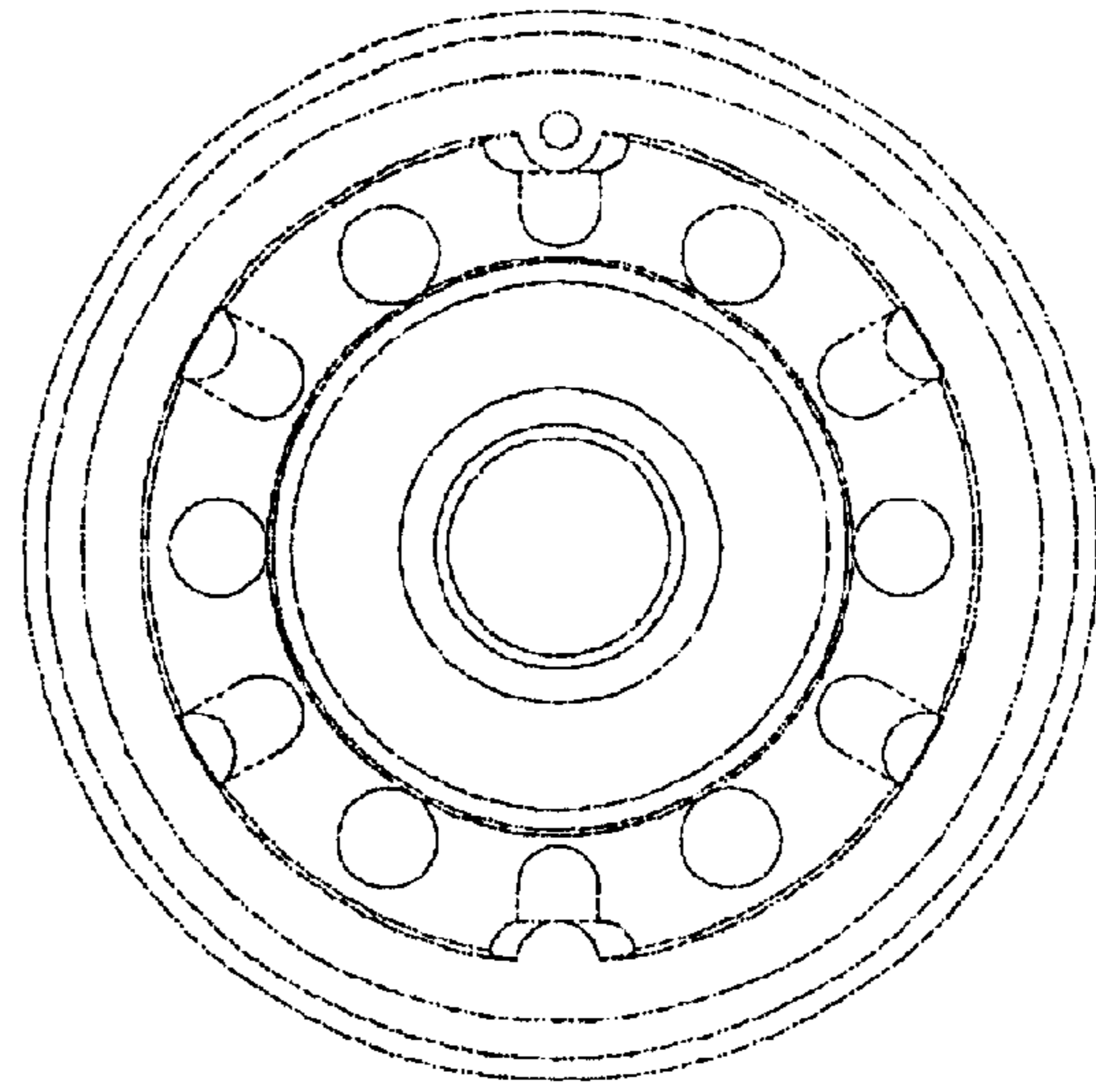

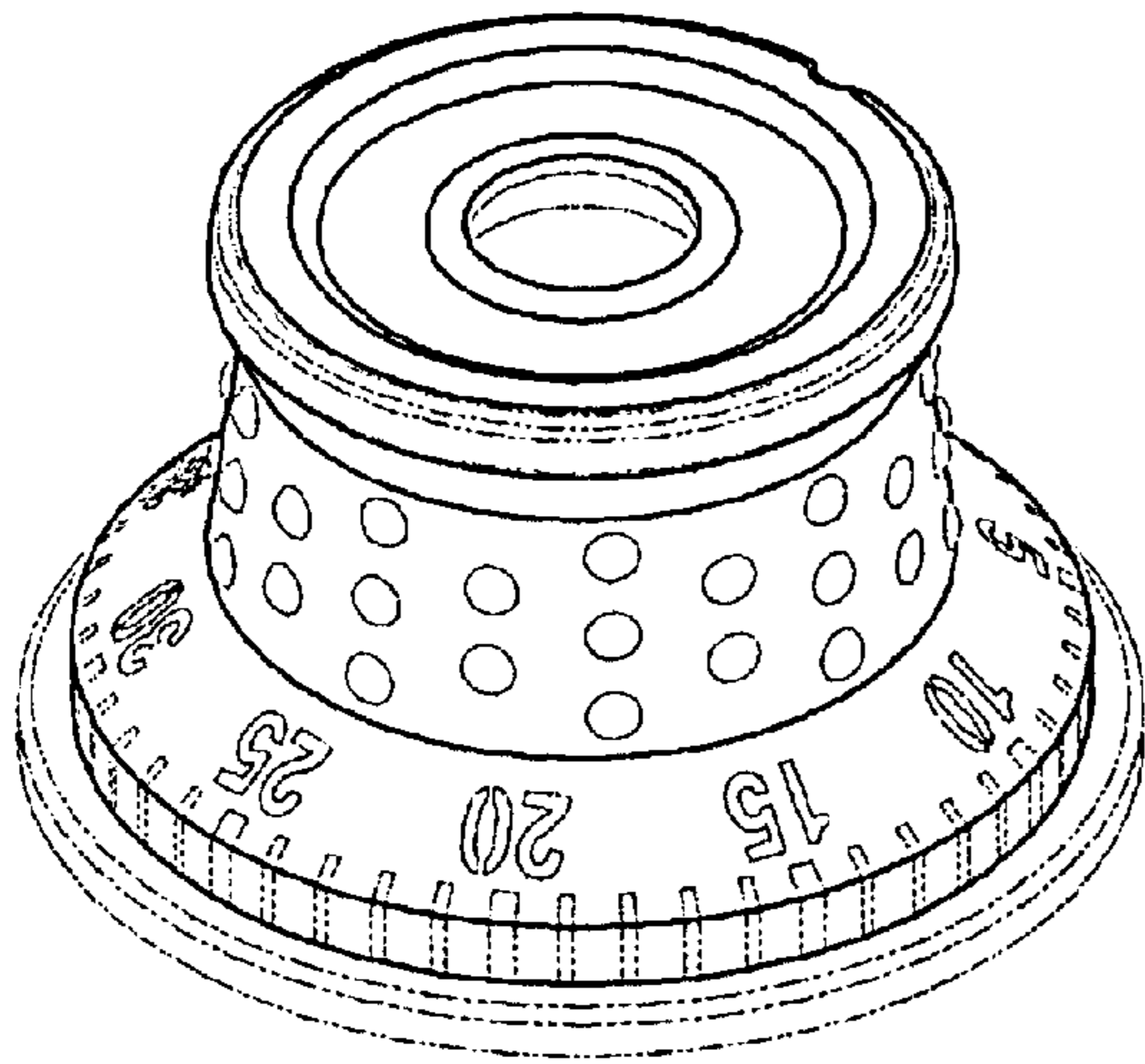

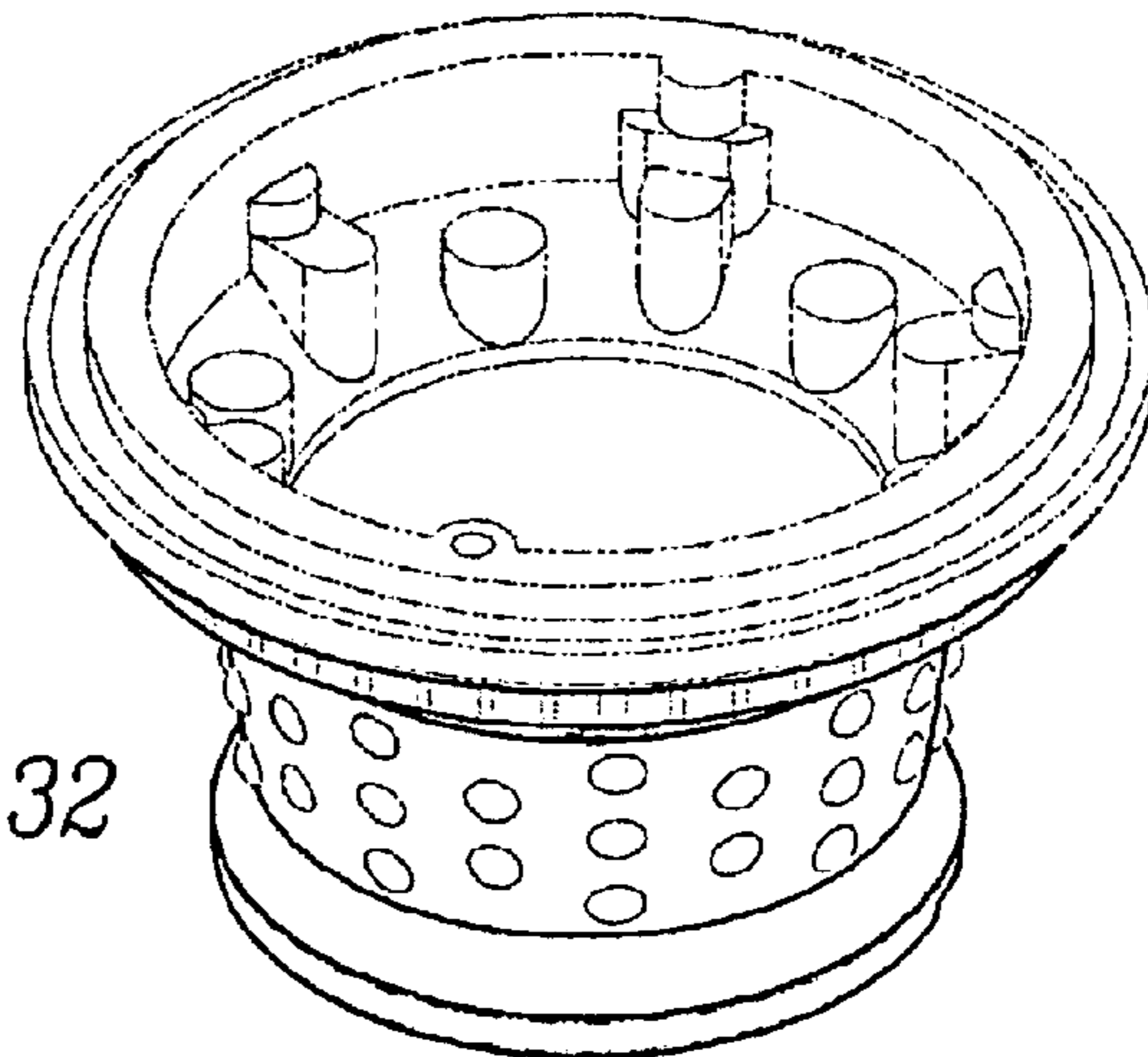
