(57) **CLAIM**

The ornamental design for a circular shaped kinetic sculpture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing my new design for a circular shaped kinetic sculpture;

FIG. 2 is a front elevational view thereof, the rear view being identical thereto;

FIG. 3 is a right side elevational view thereof, the left side view being identical thereto;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a perspective view of an alternate embodiment of my design;

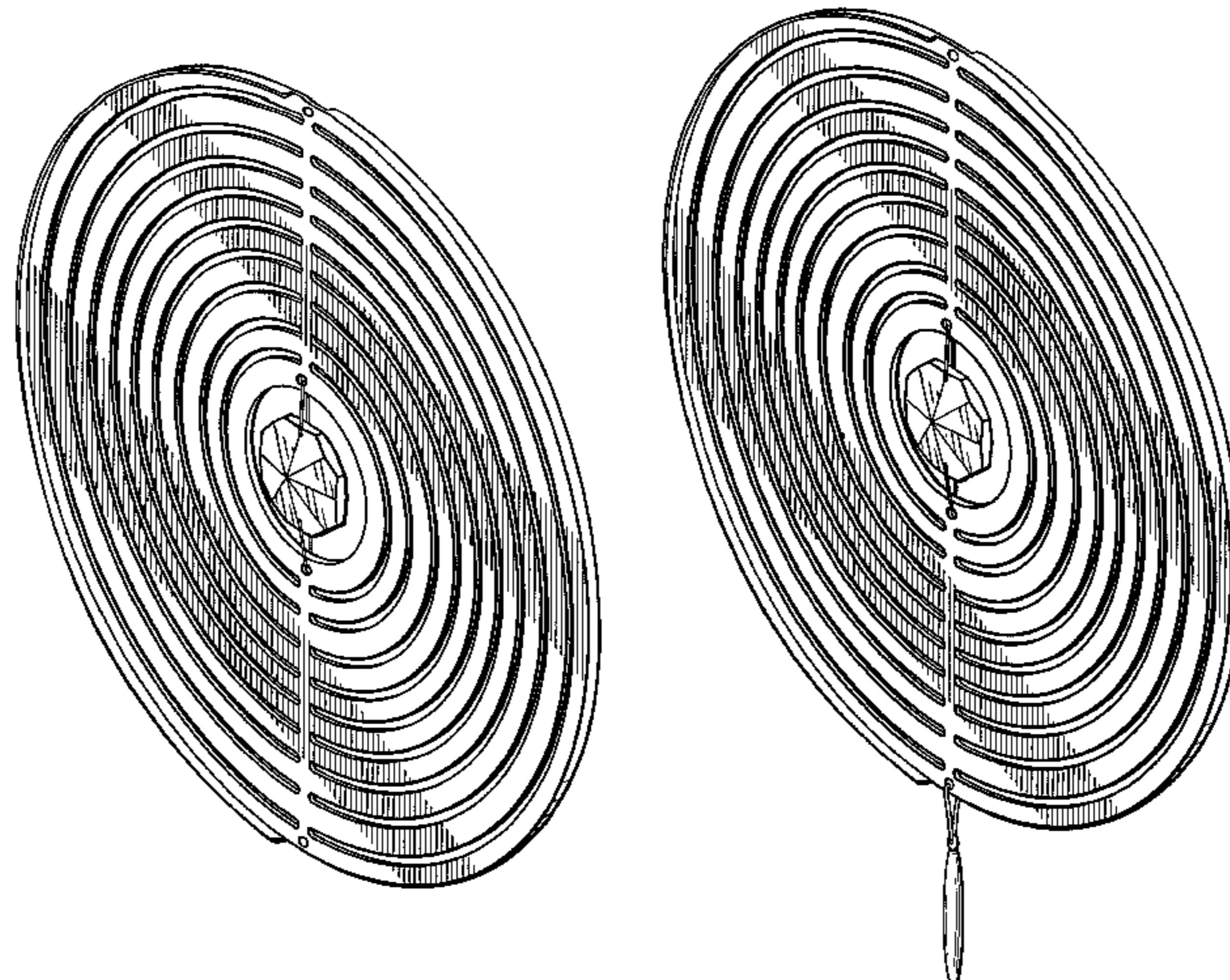
FIG. 7 is a front elevational view thereof, the rear view being identical thereto;

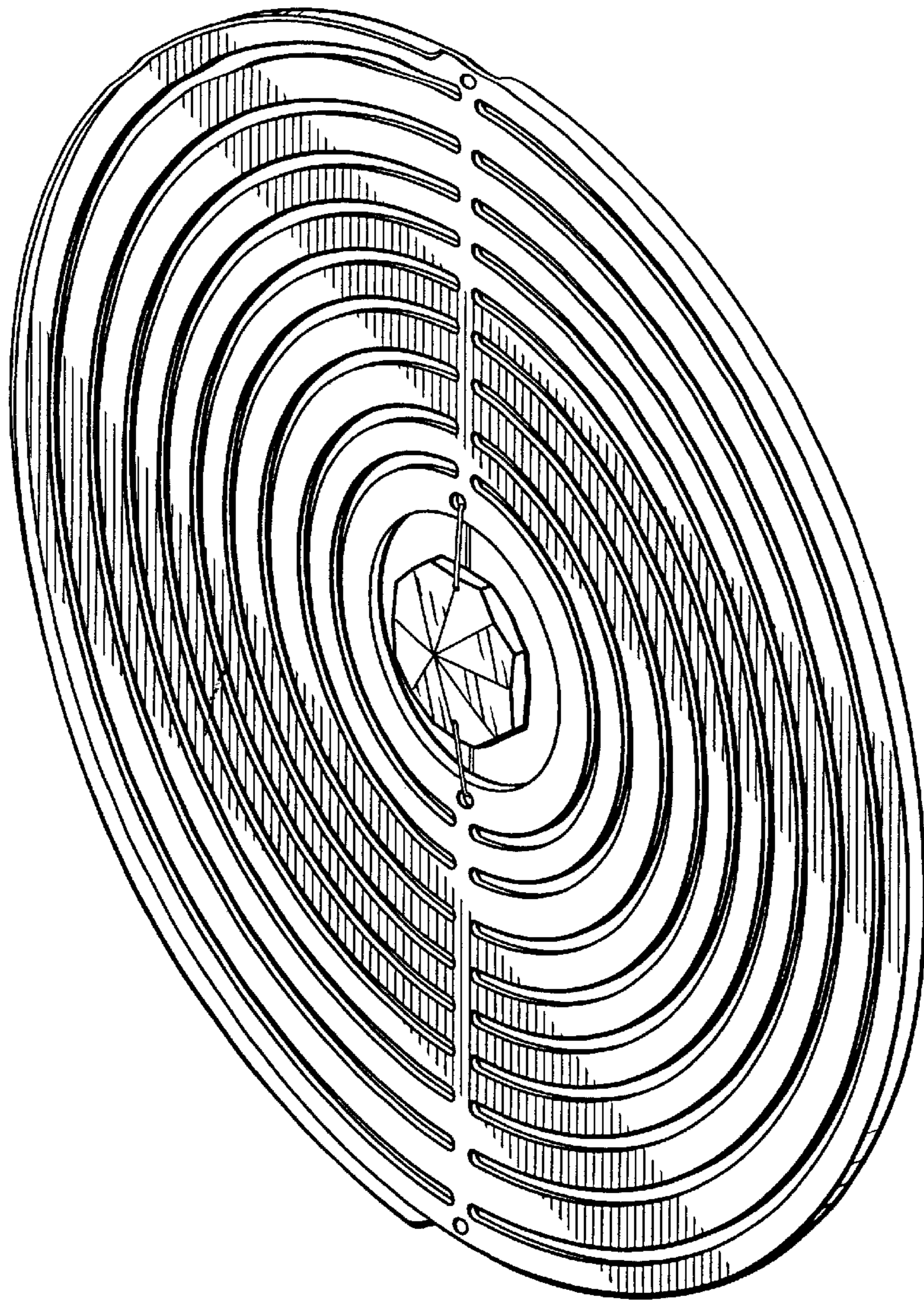

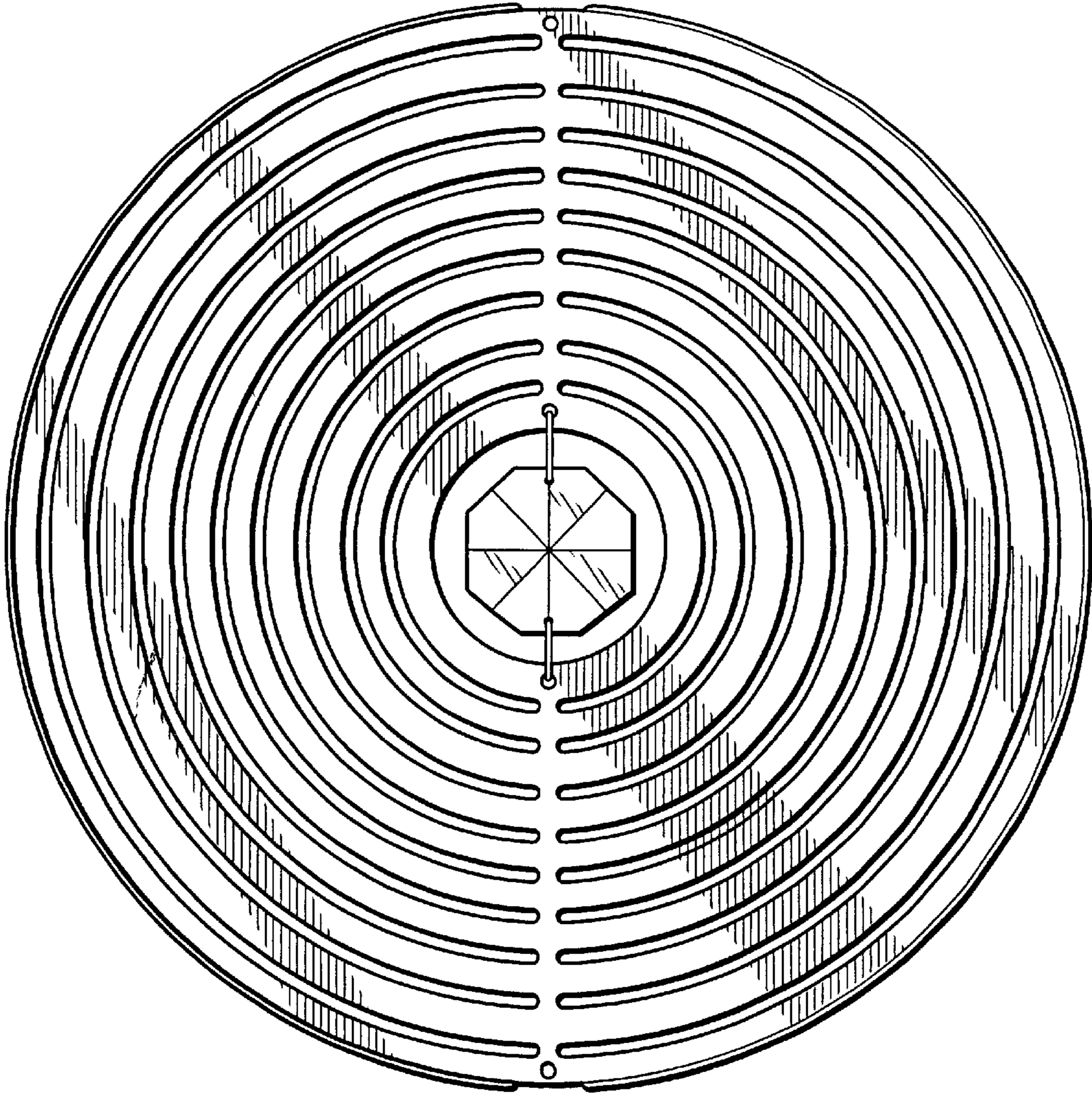

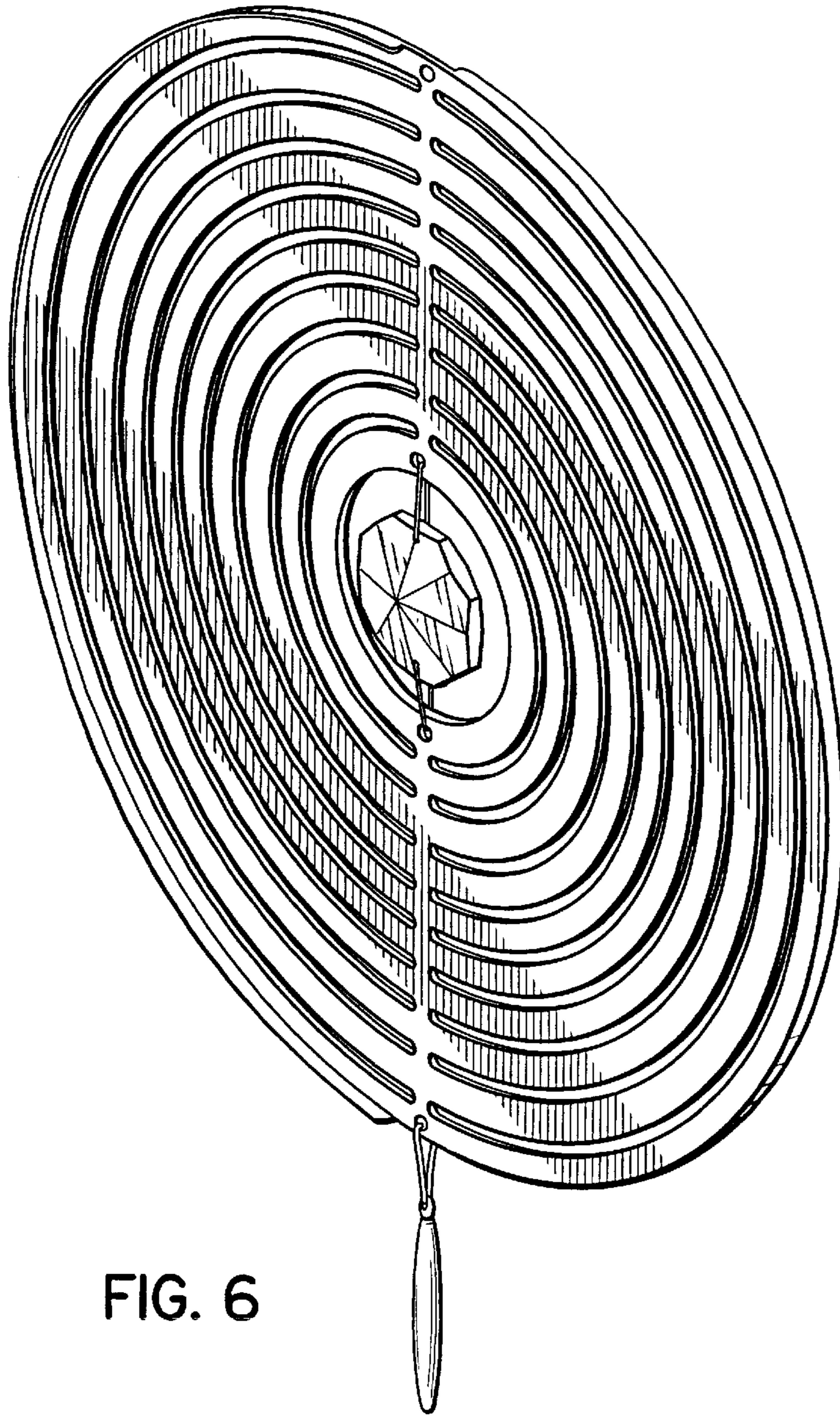
