novel design.

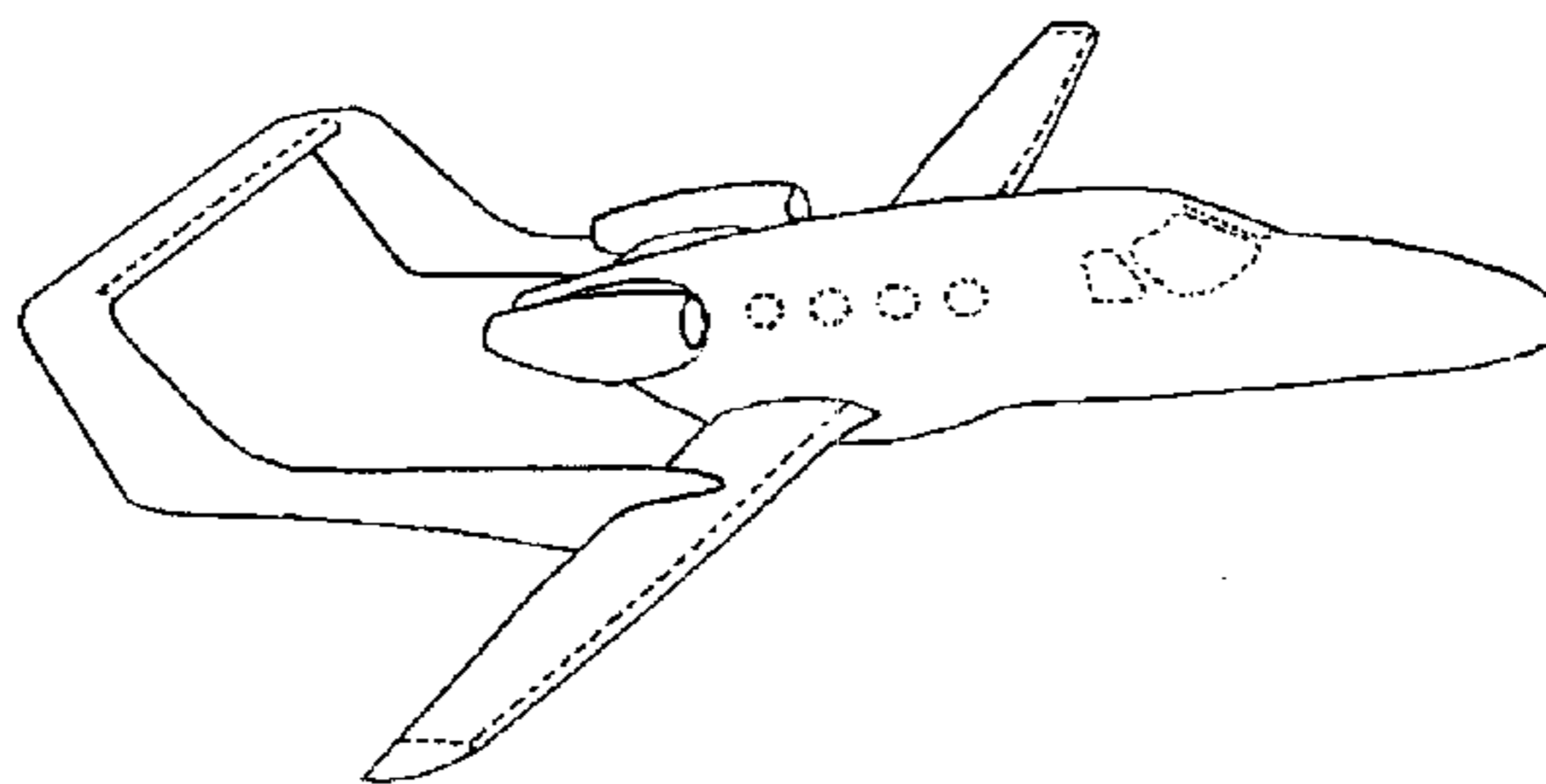
FIG. 3 is a side perspective of an aircraft according to a

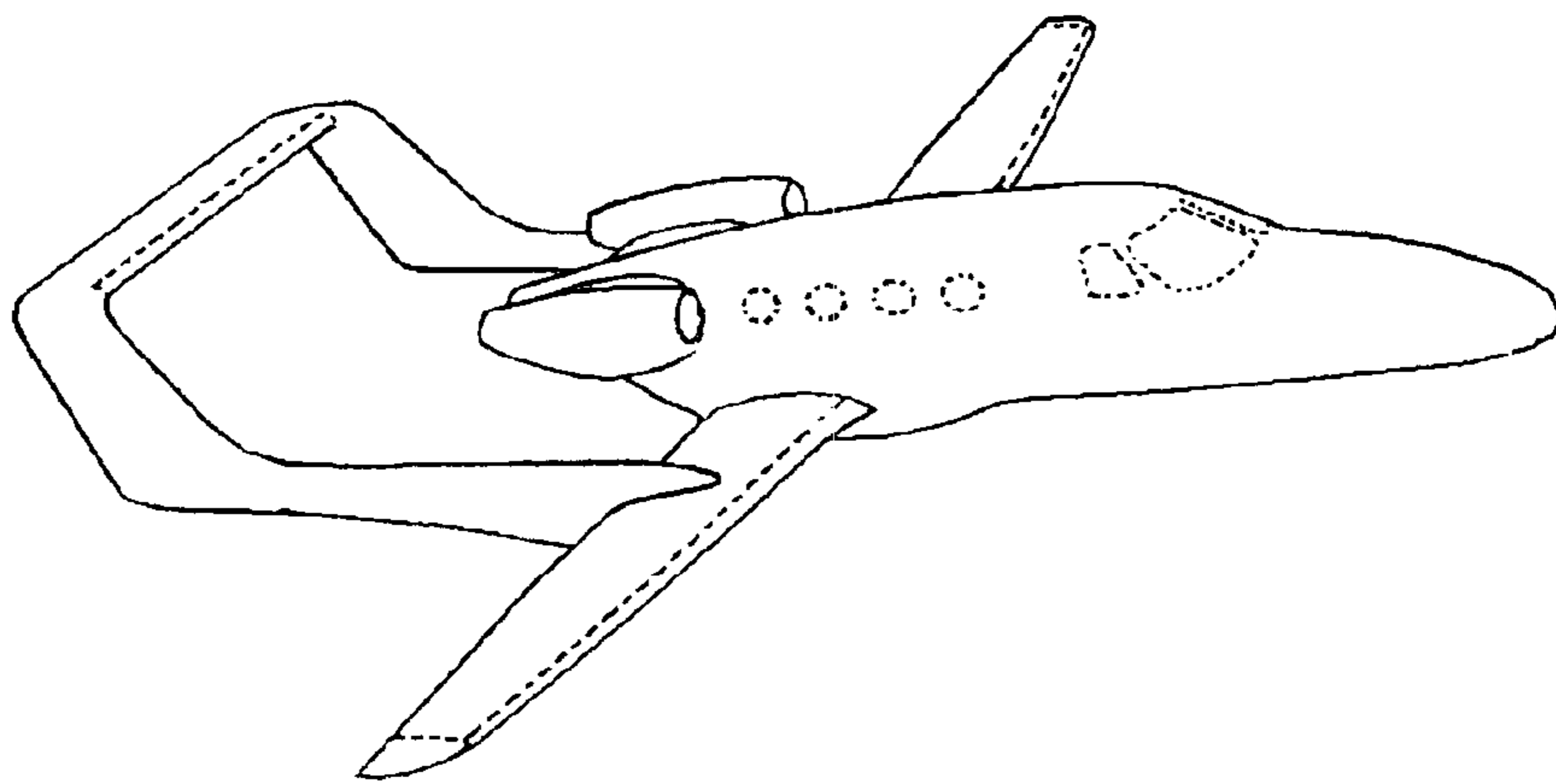

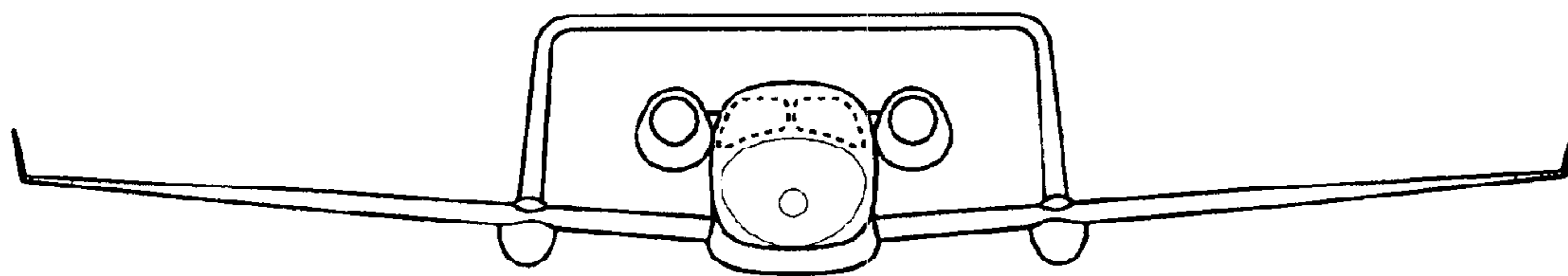

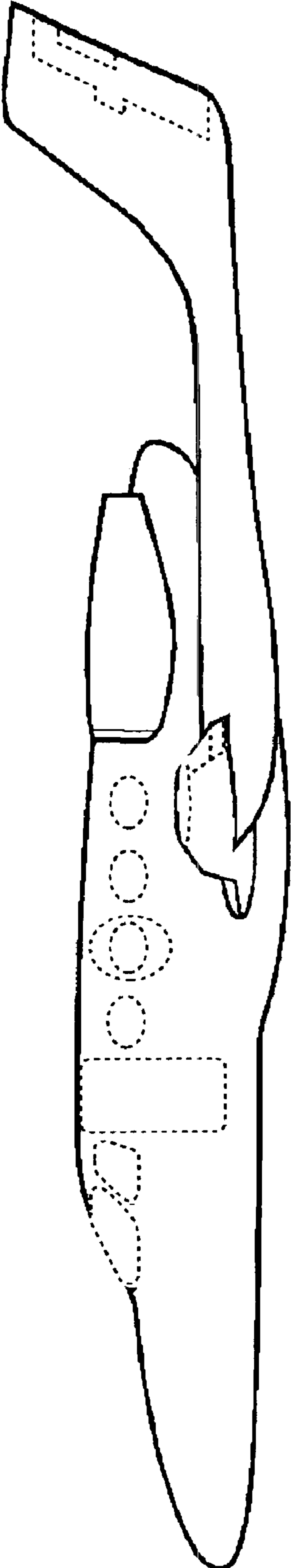

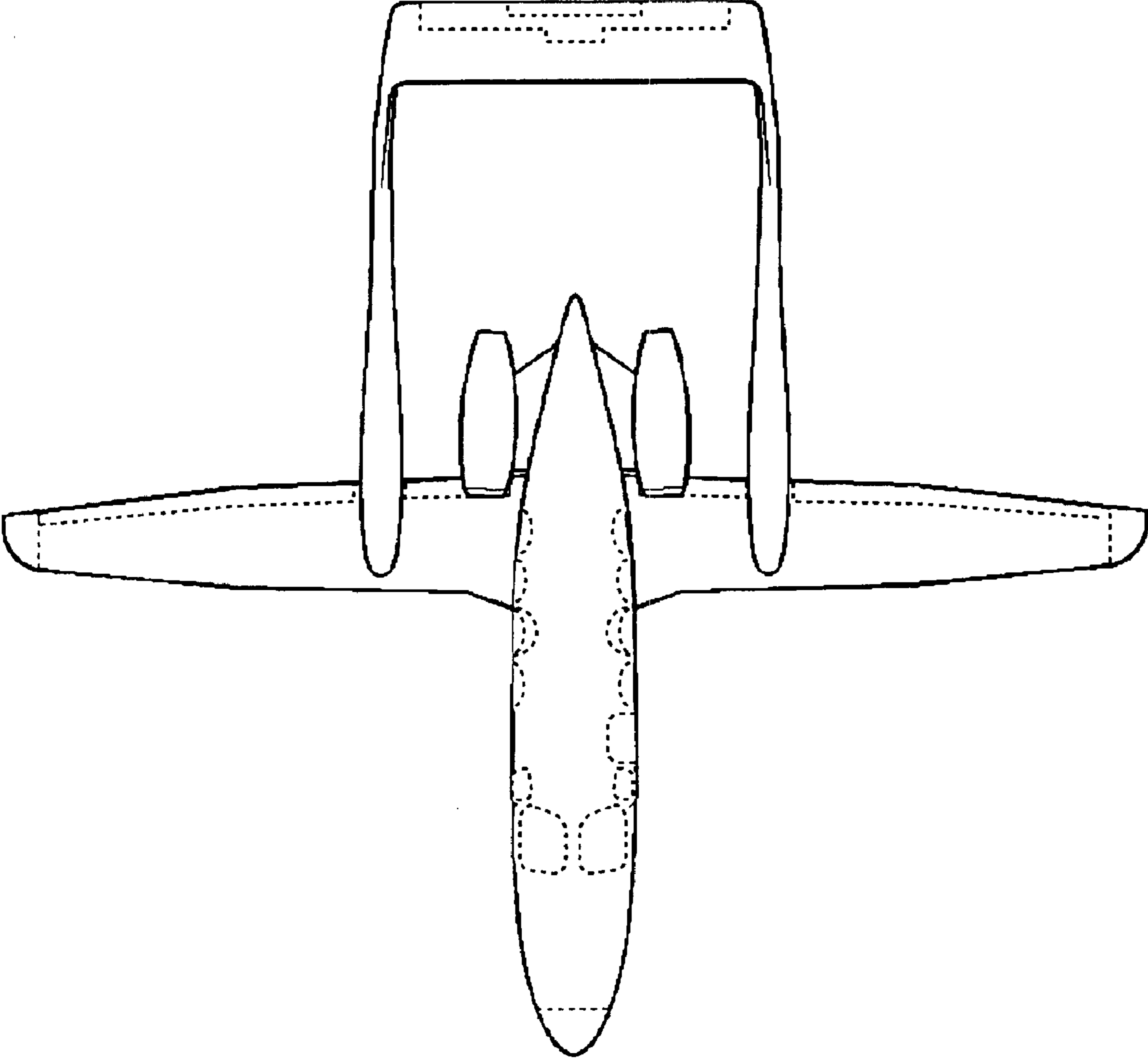

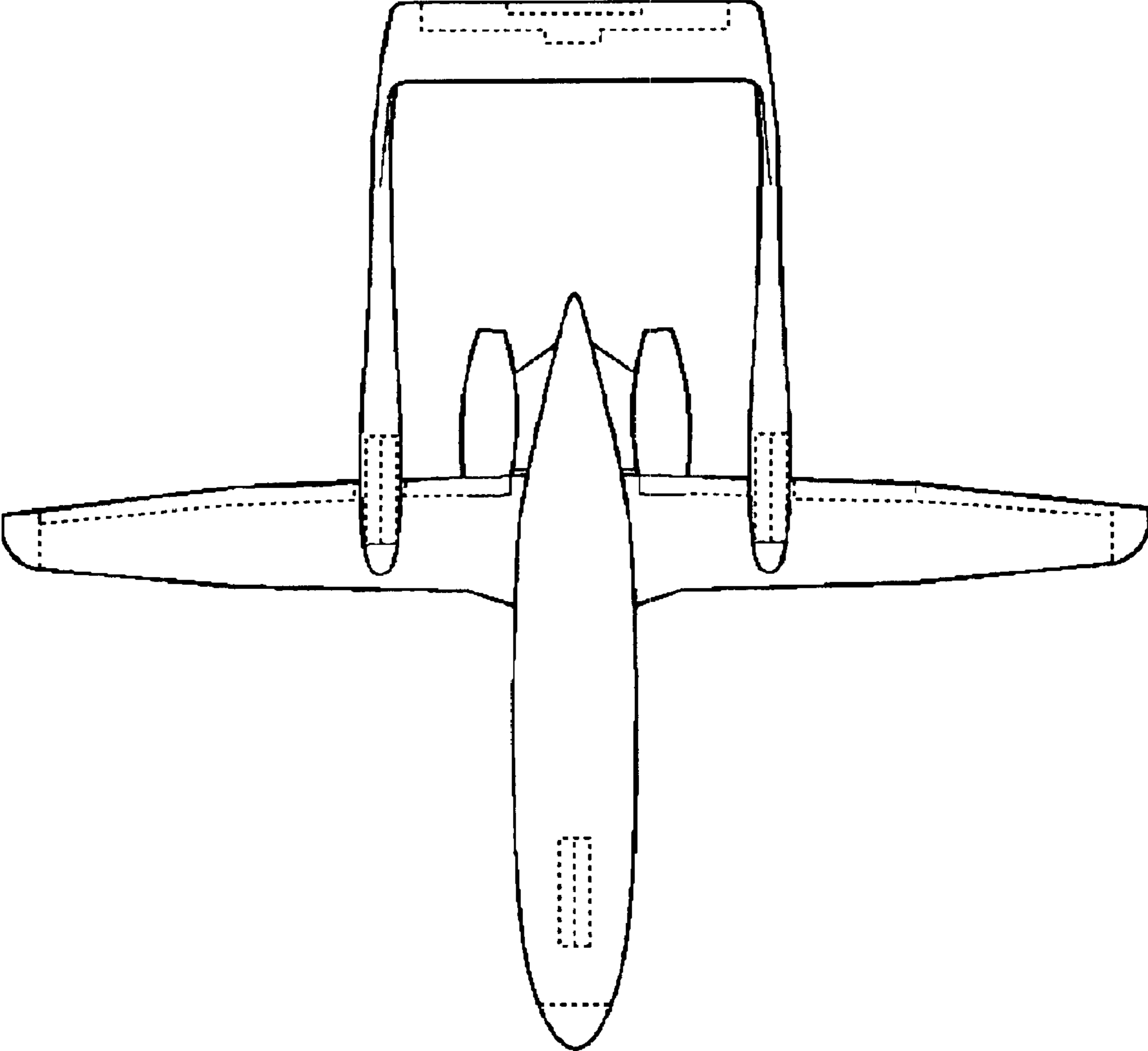
