(57) **CLAIM**

The ornamental design for a medium floor console with adjustable drink holder, as shown and described.

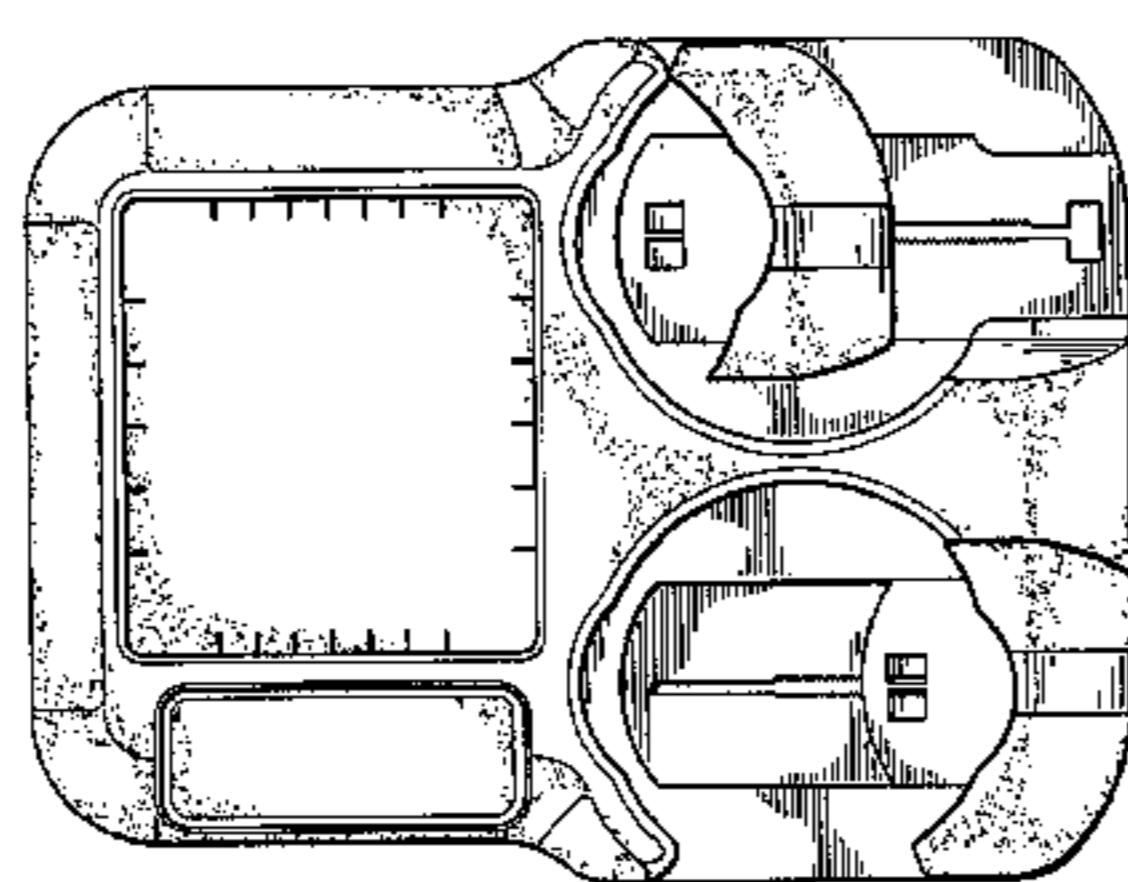

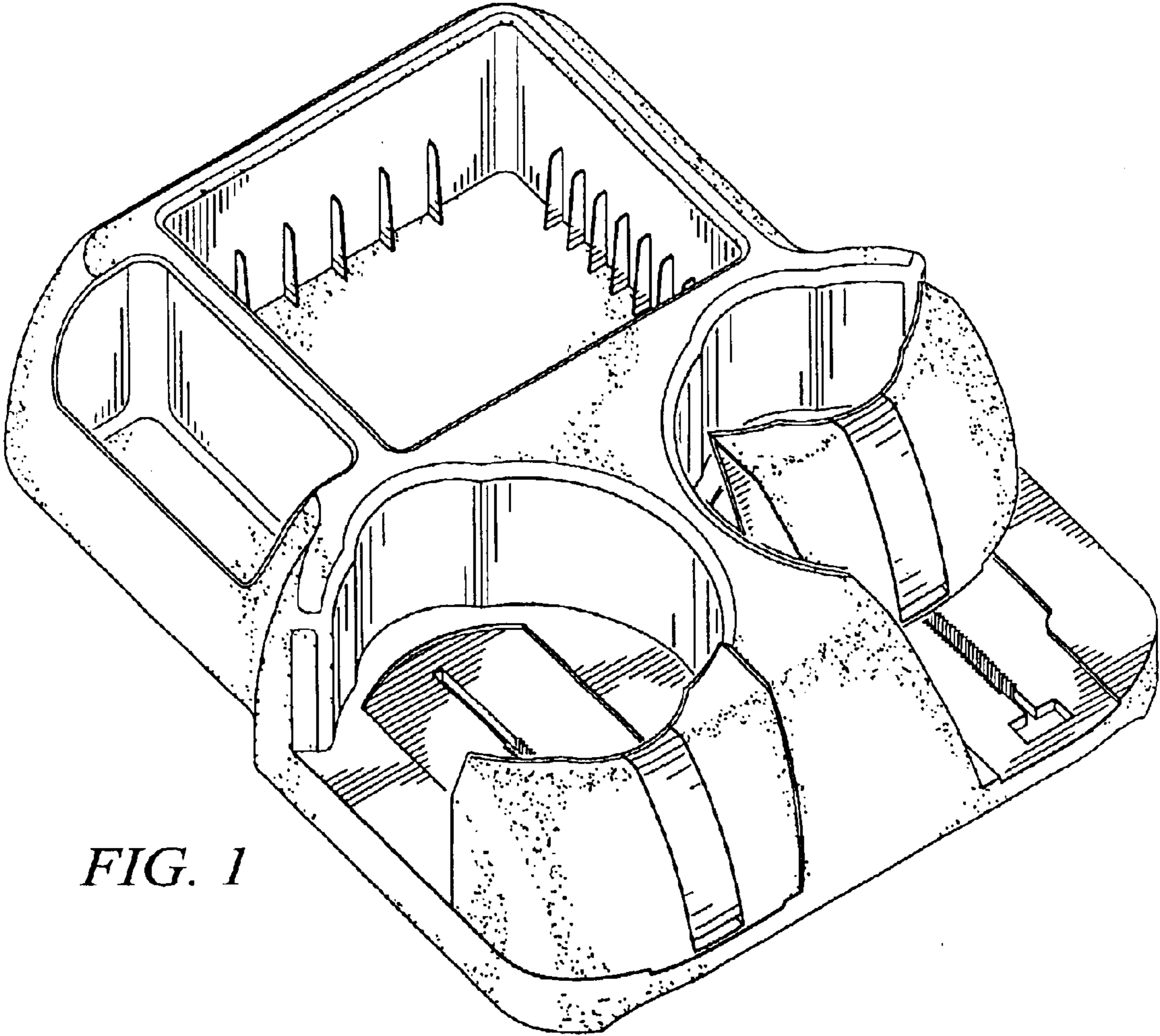

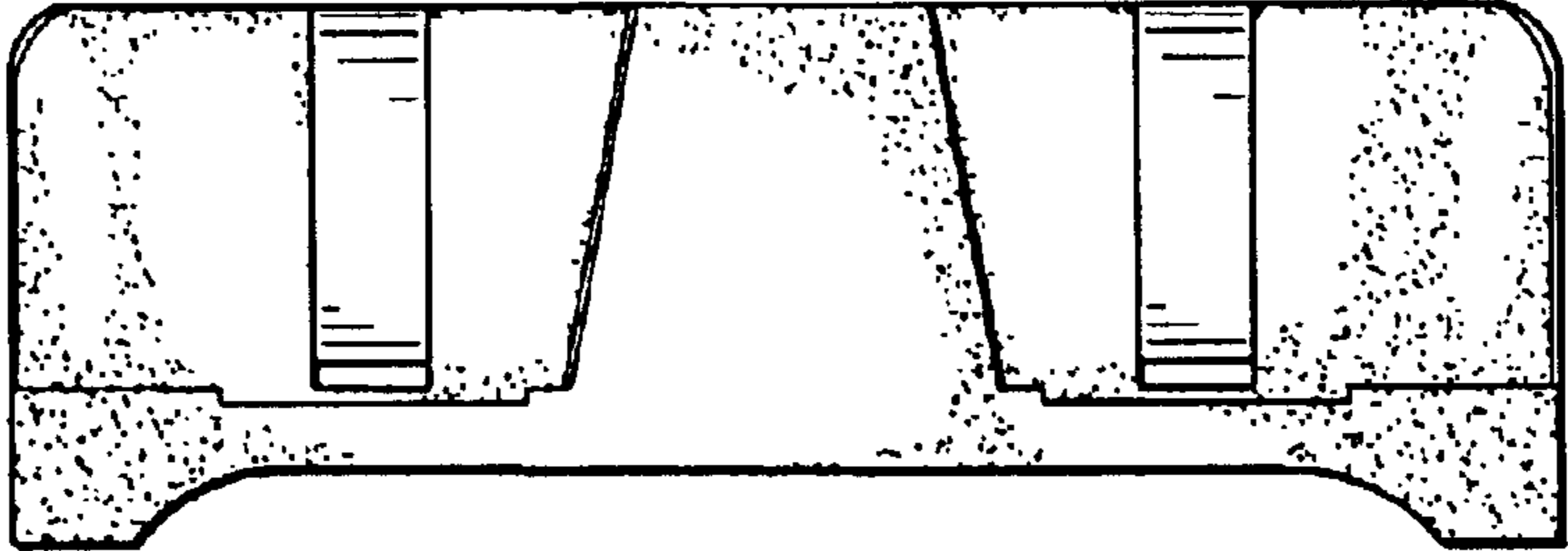

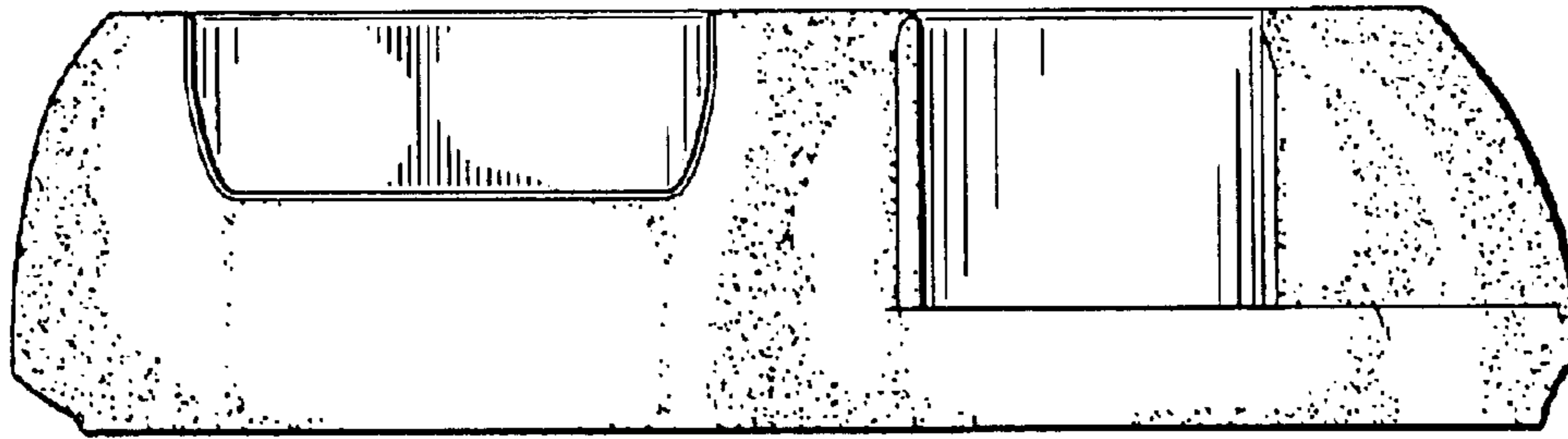

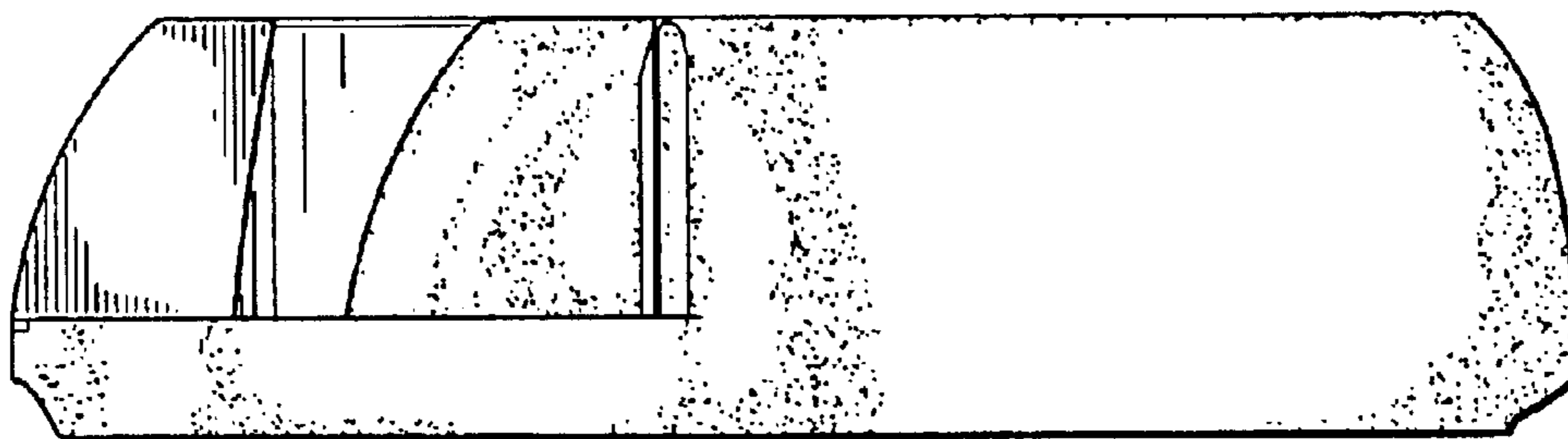

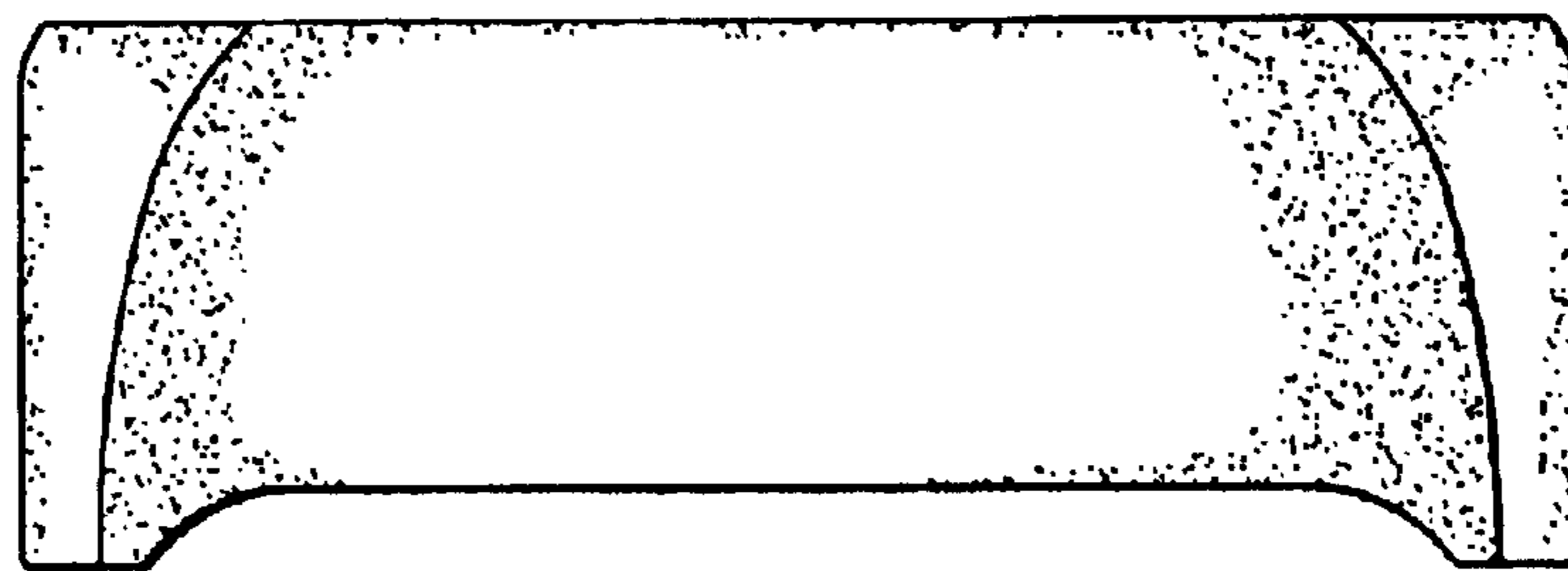

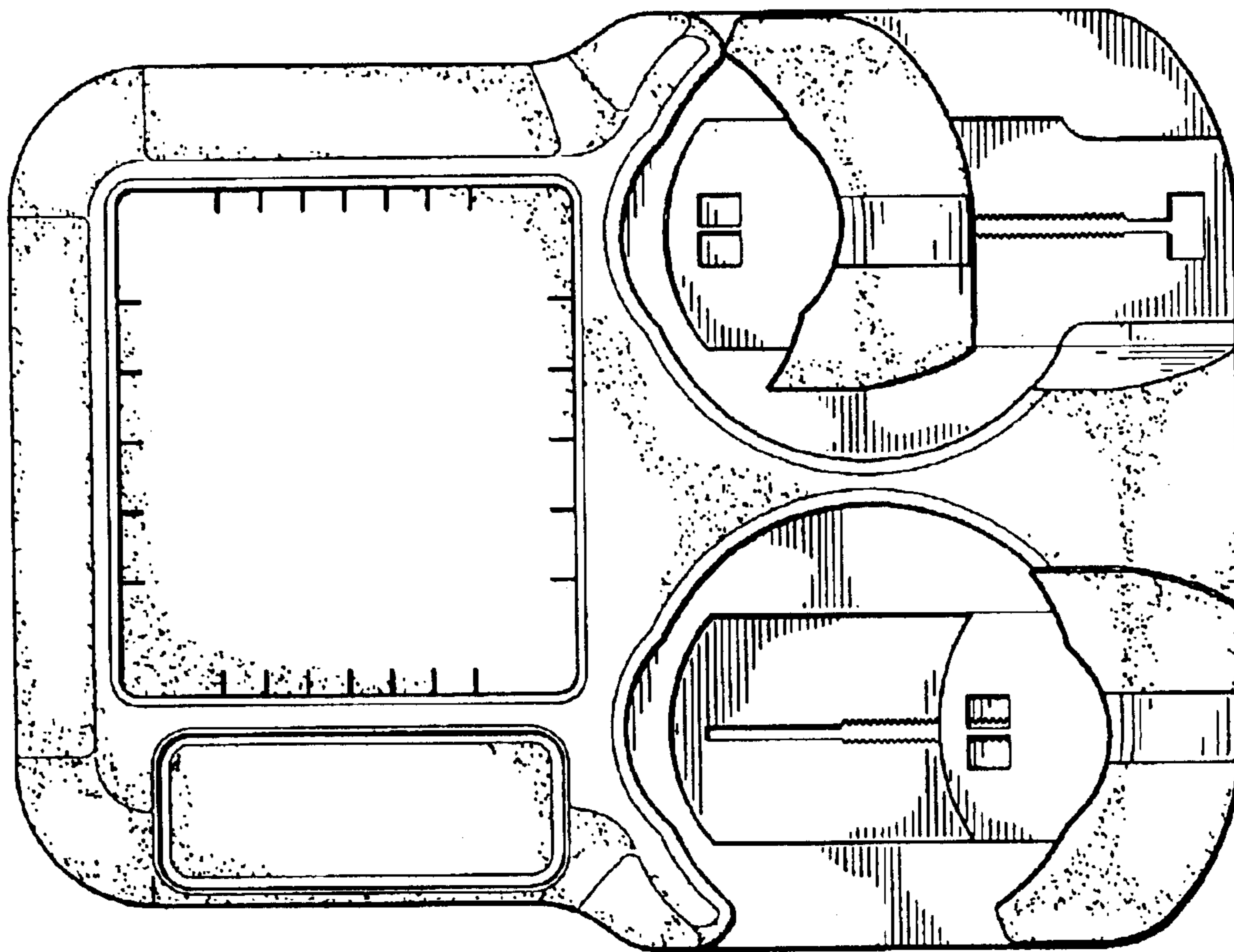
