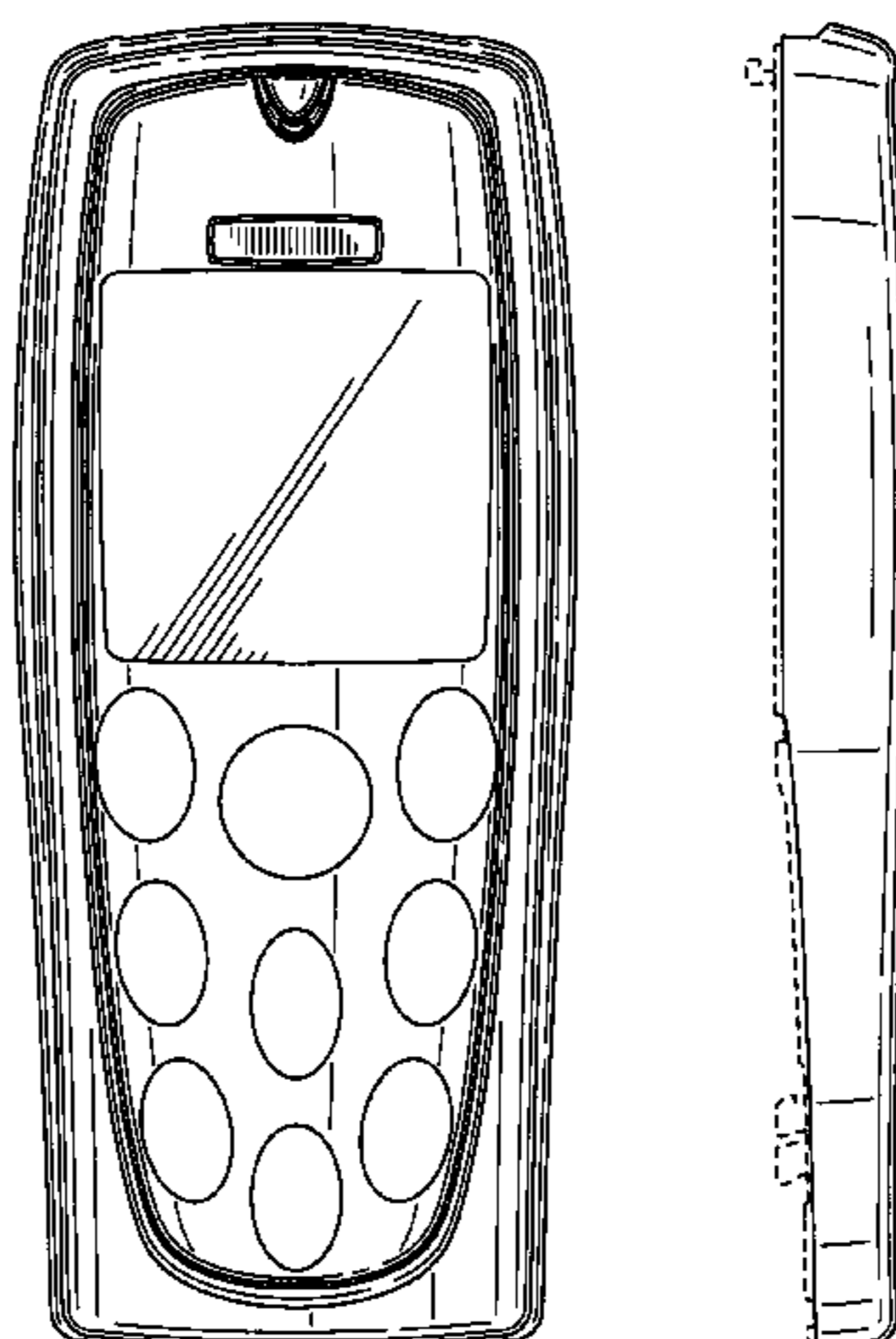
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a bottom plan view of a front cover for a handset showing my new design;  
 FIG. 2 is a right side view thereof;

 FIG. 4 is a left side view thereof;

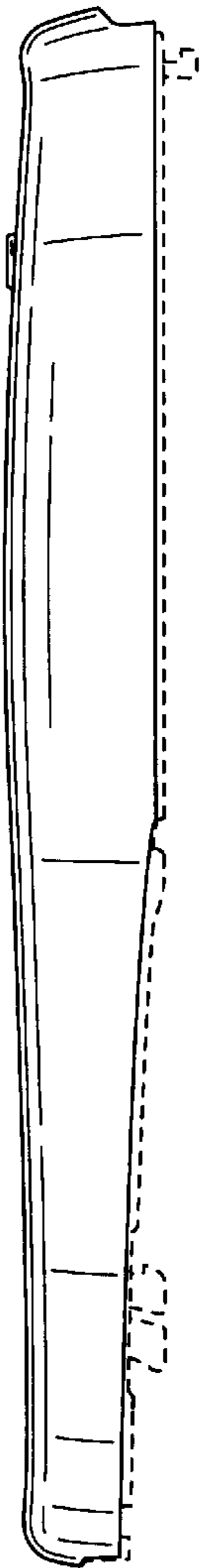
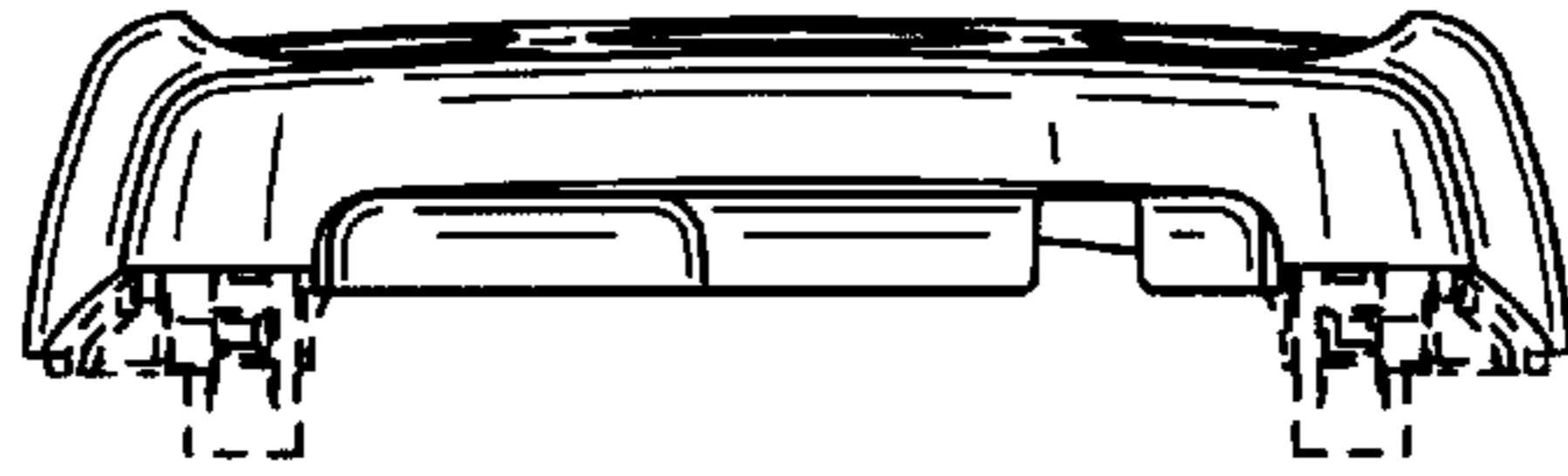

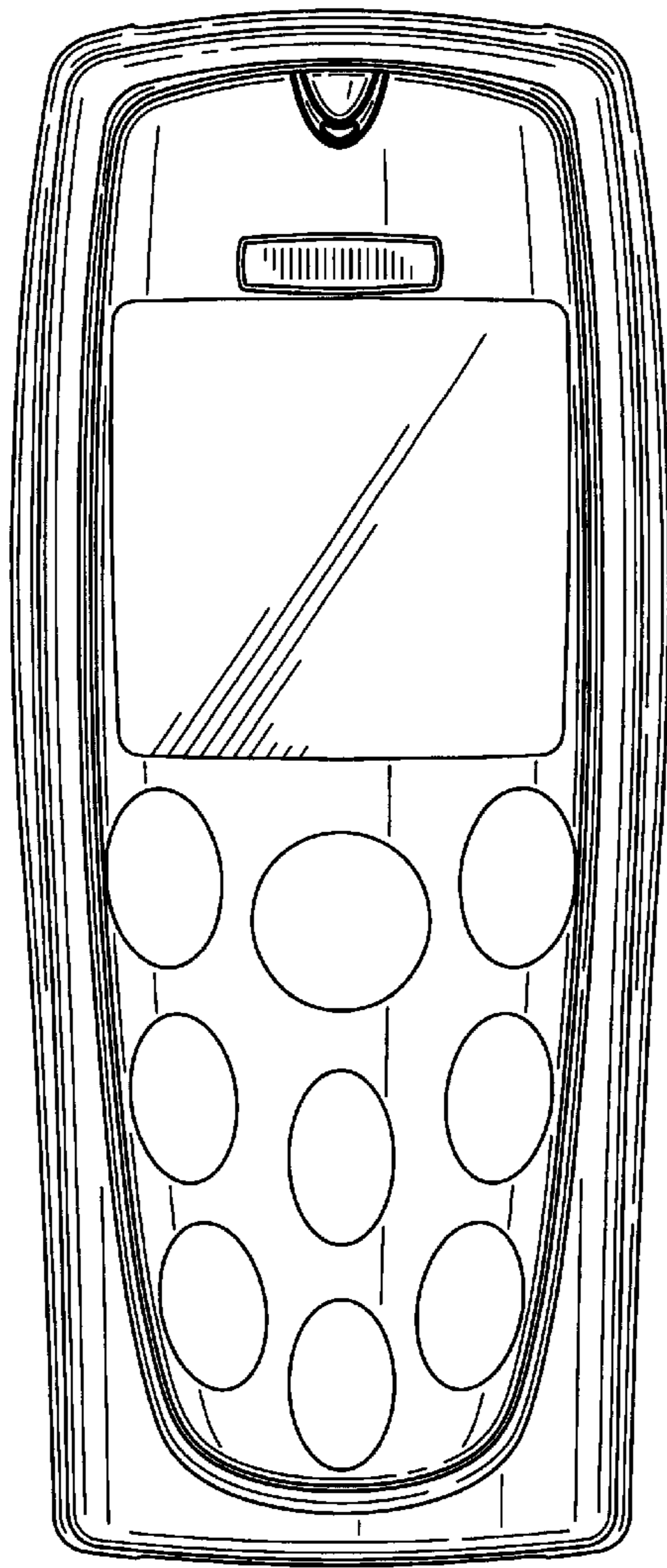

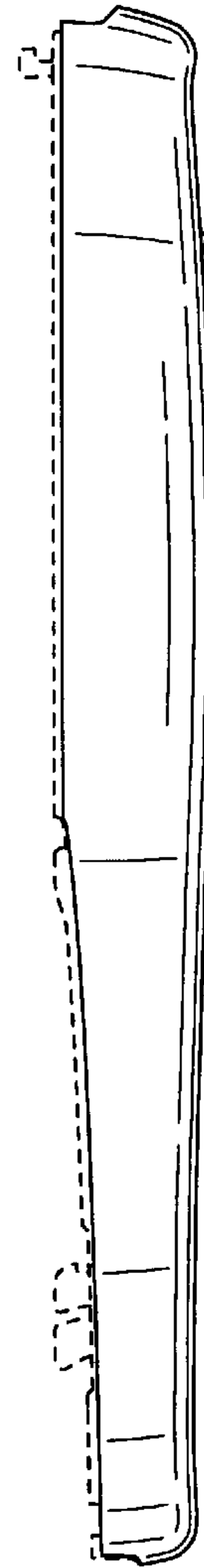
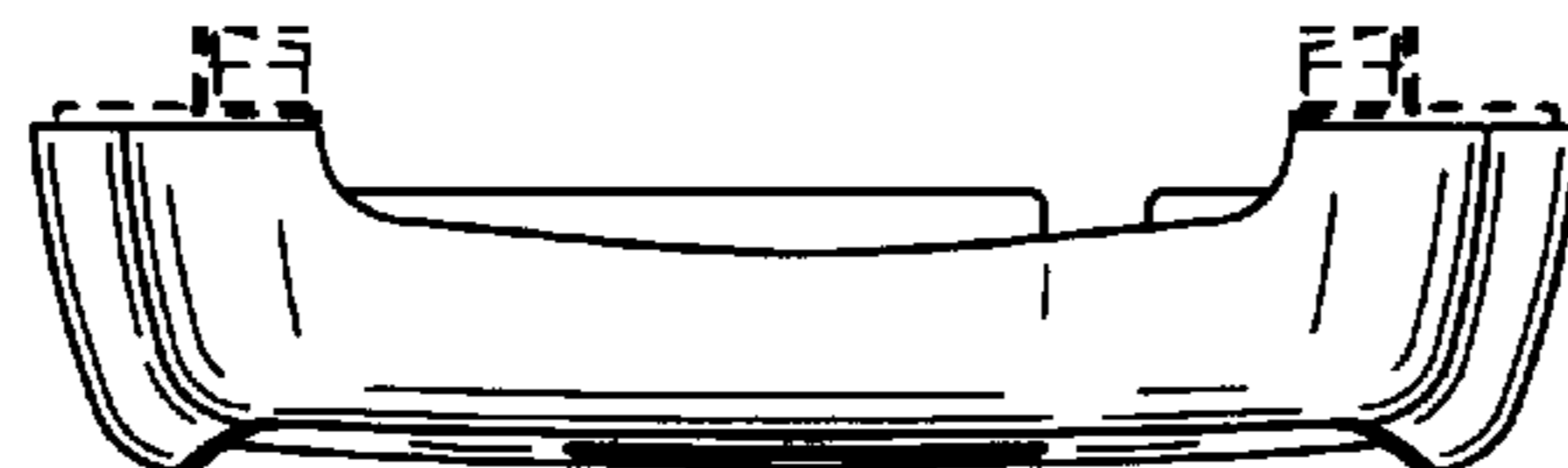

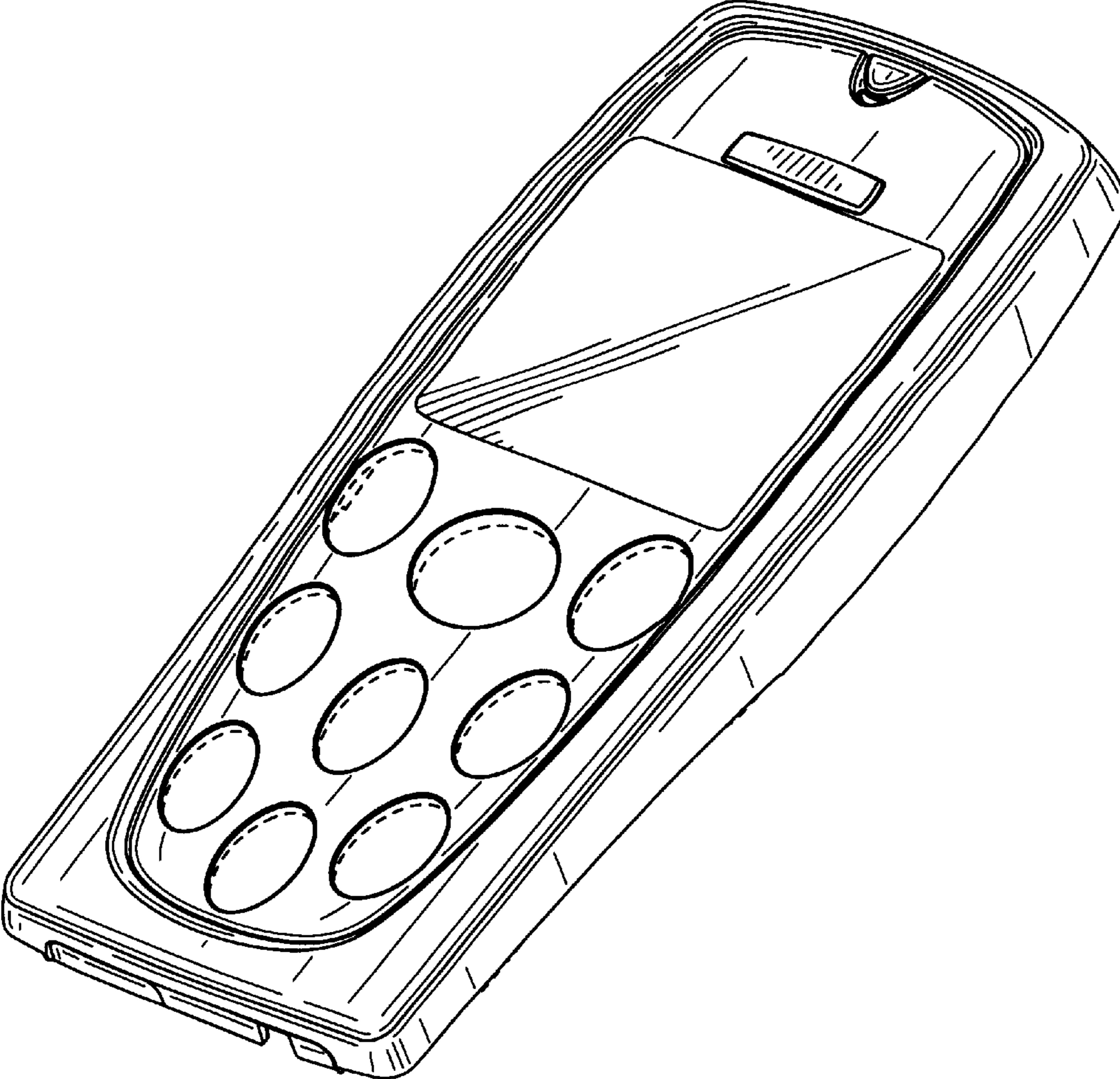
