The ornamental design for a laser printer, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation of a laser printer according to the present invention;

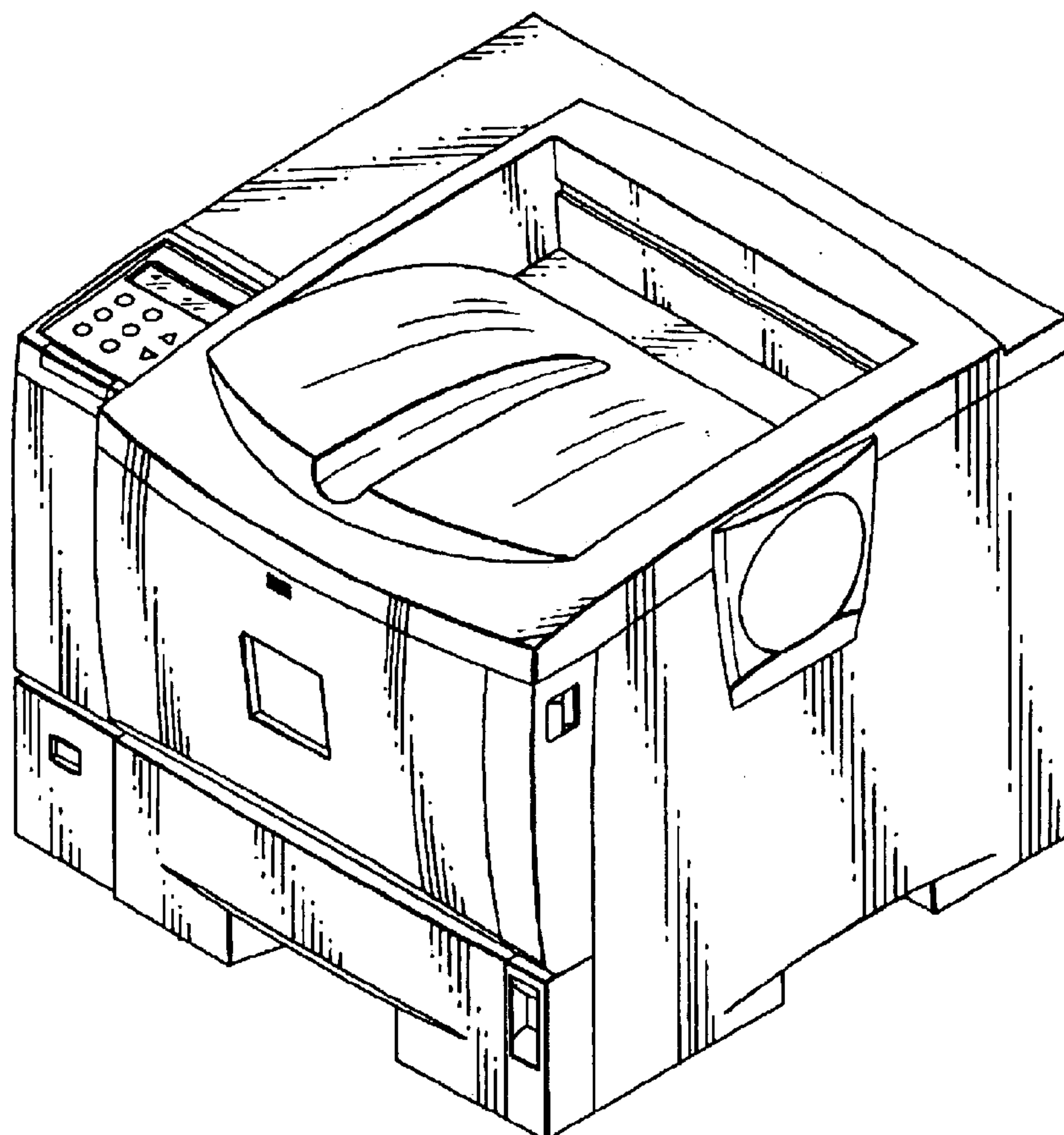

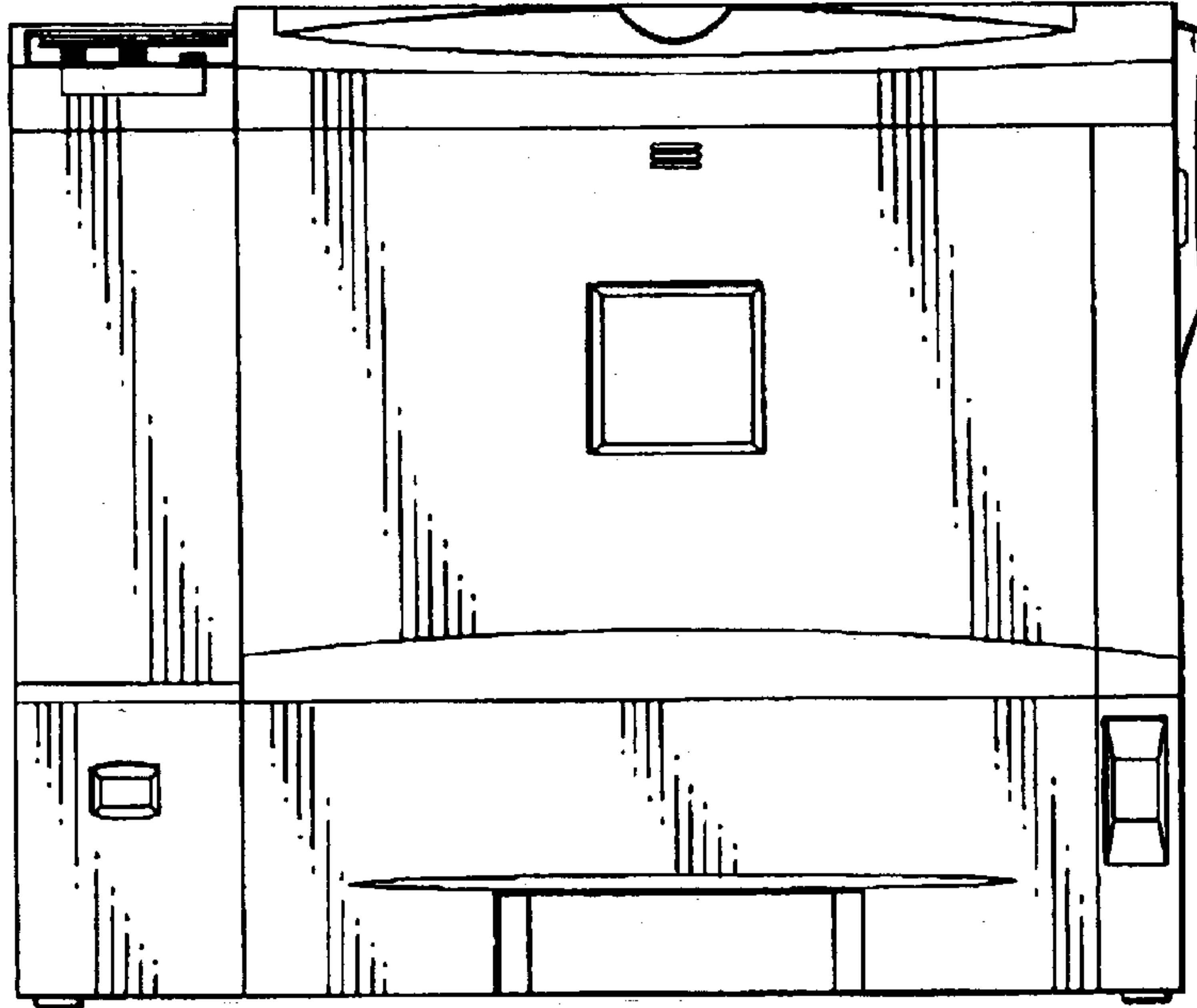

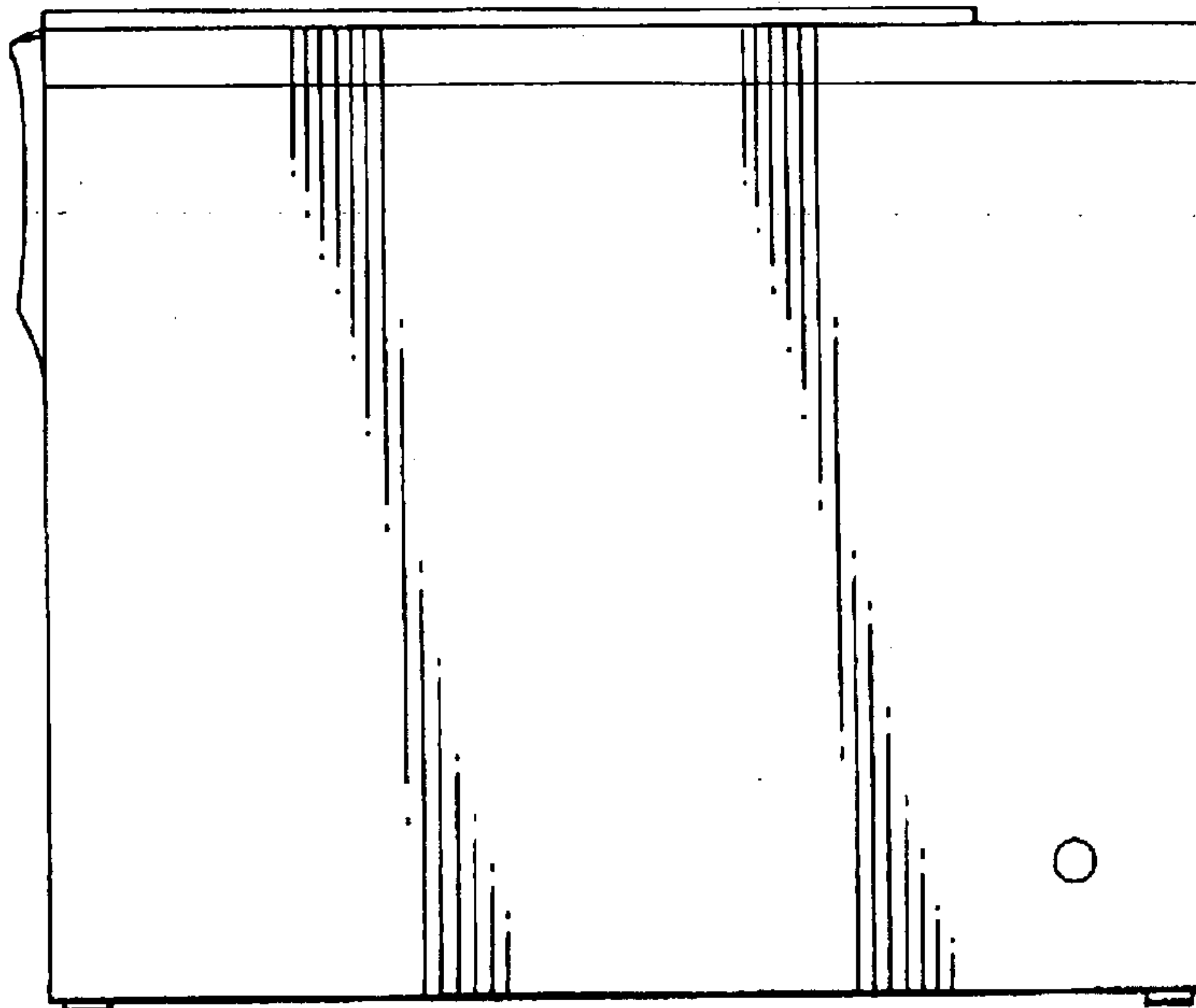

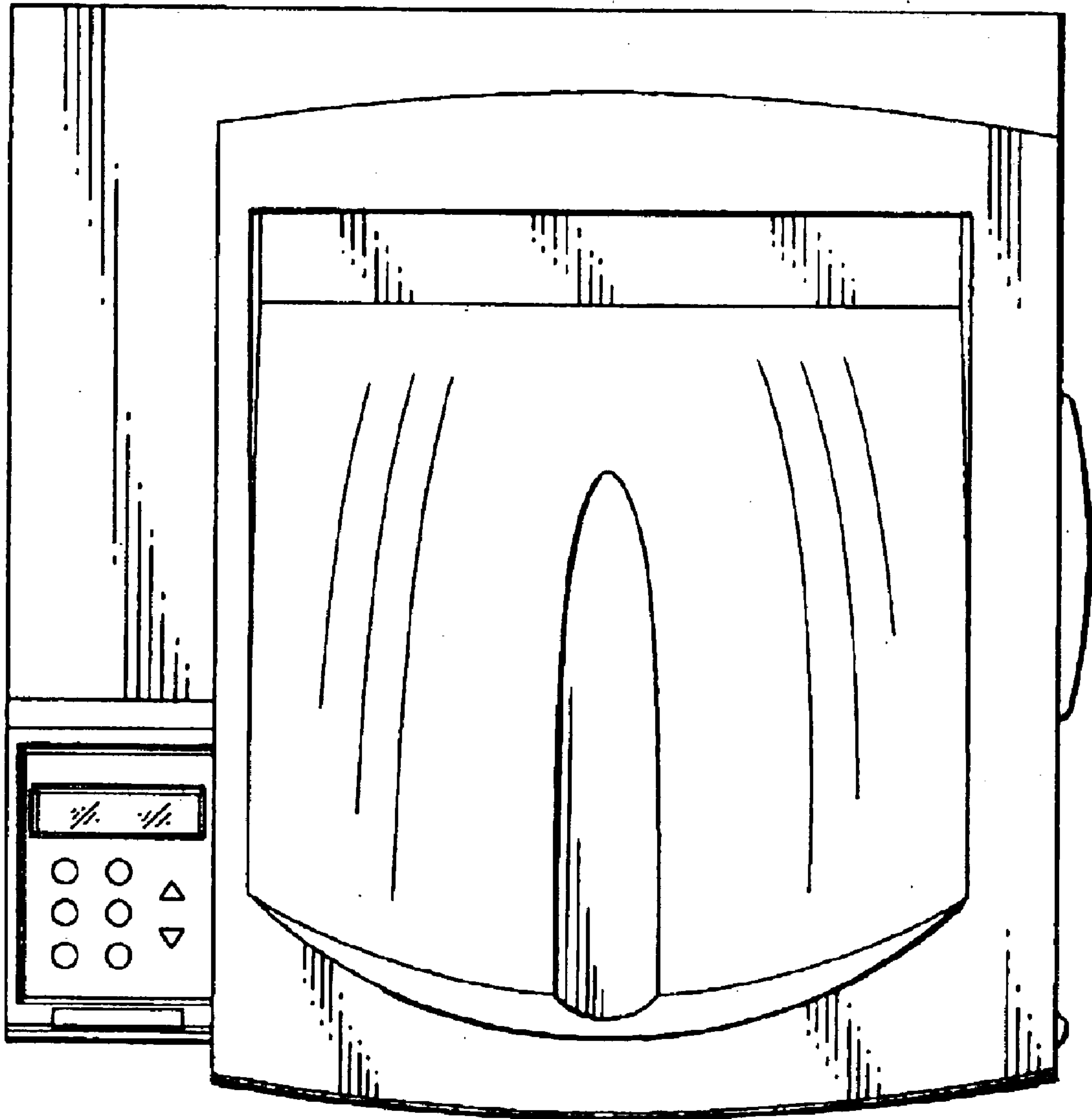

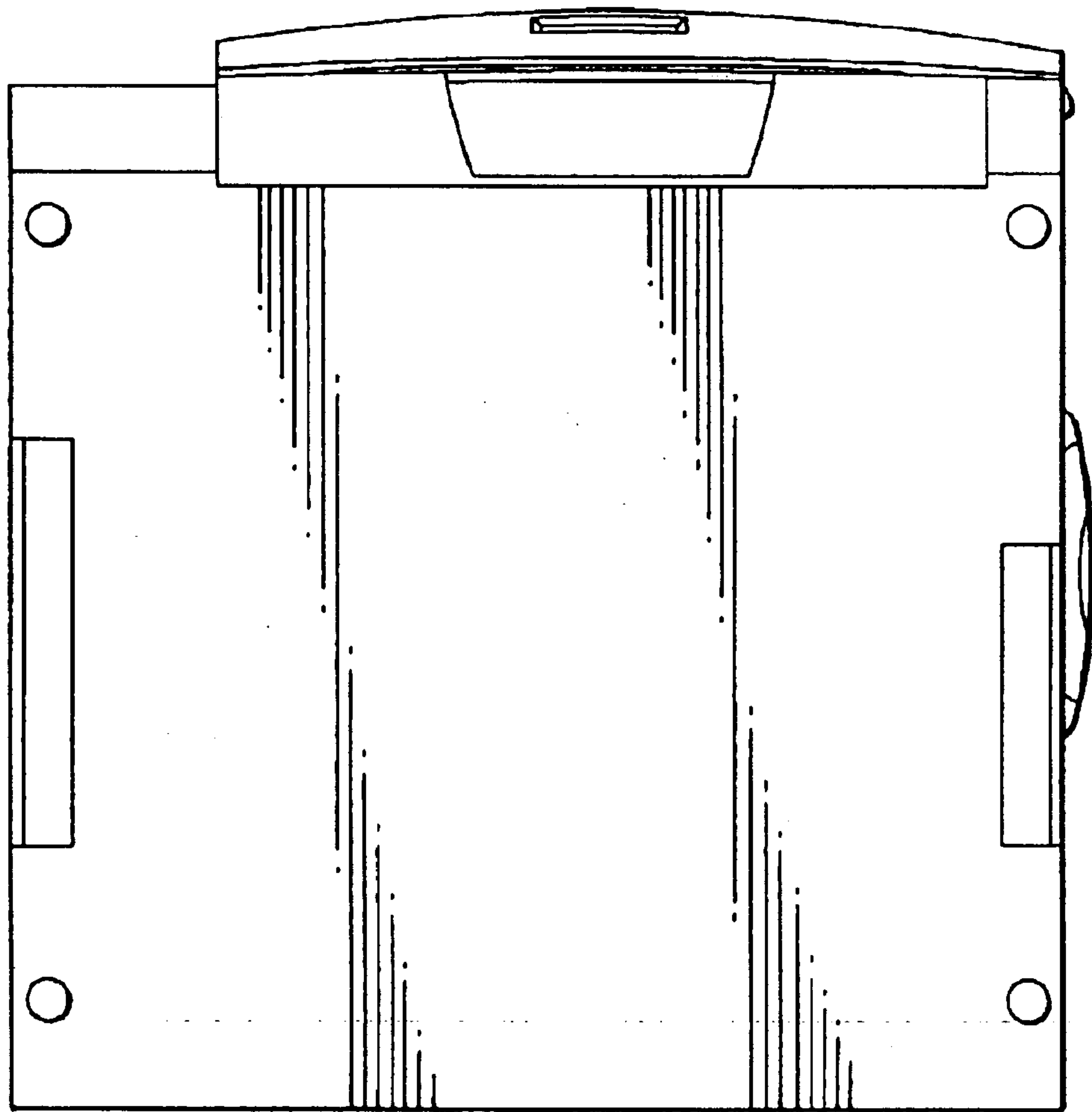

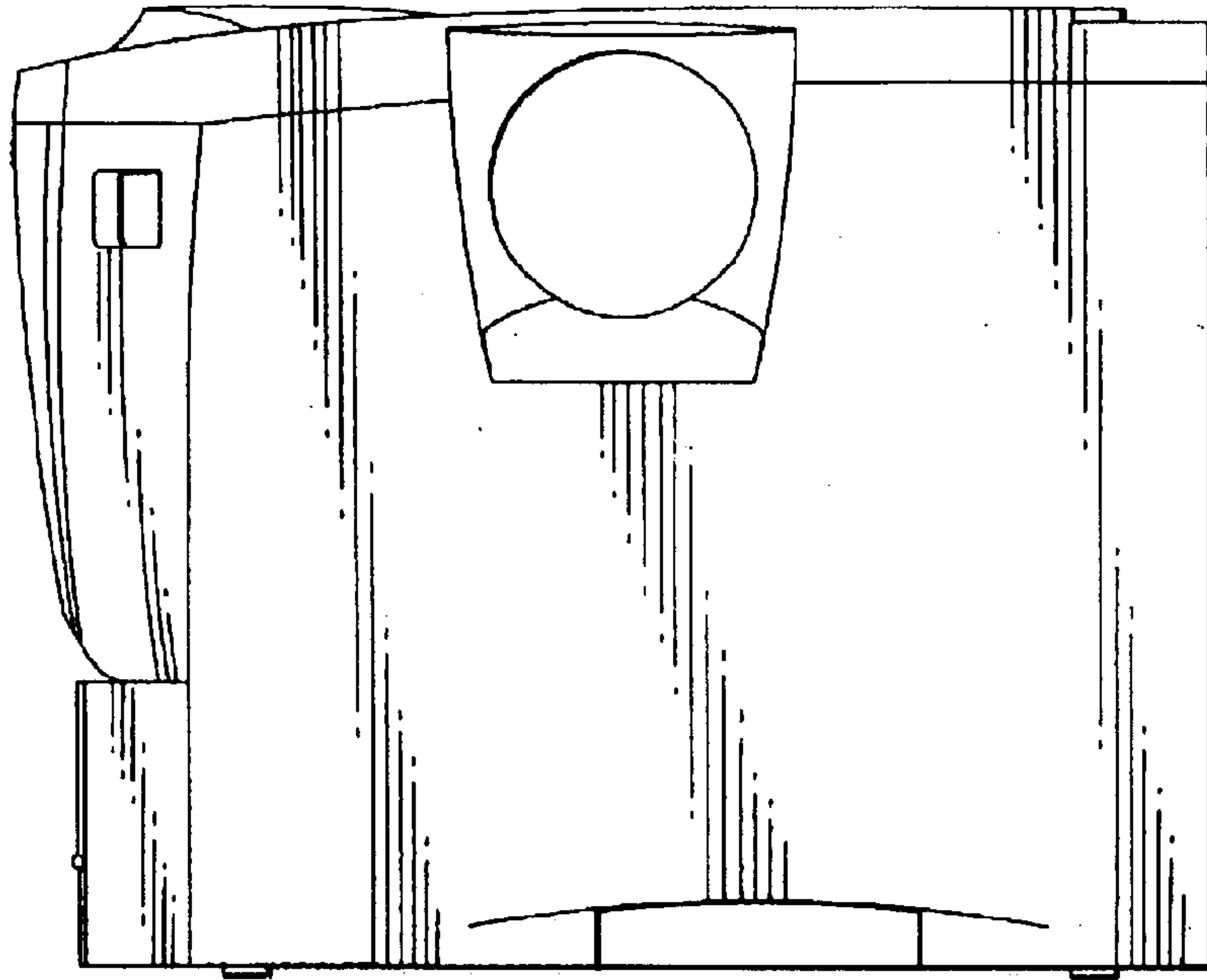

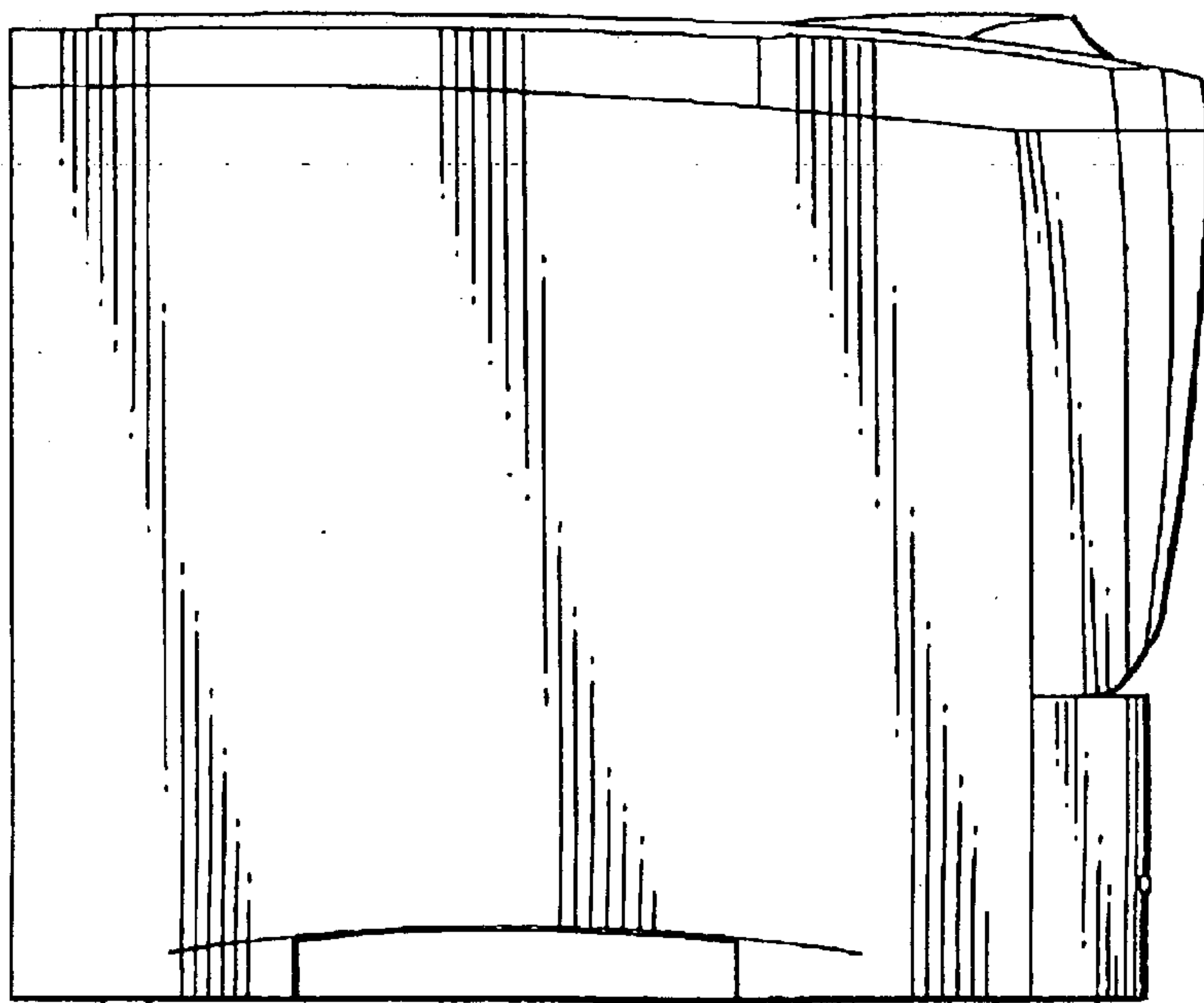
