(57) **CLAIM**

The ornamental design for a combined duo highlighters and holder therefor, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a combined duo highlighters and holder therefor showing my new design, with the highlighters in a fully inserted position;

FIG. 2 is a front elevational view of FIG. 1;

FIG. 3 is a bottom plan view of FIG. 1;

FIG. 4 is a left side elevational view of FIG. 1, the right side being identical thereto;

FIG. 5 is a top right perspective view of FIG. 1;

FIG. 6 is a top right perspective view with one of the highlighters in a partially raised position;

FIG. 7 is a top right perspective view of the holder with both highlighters removed for ease of illustration;

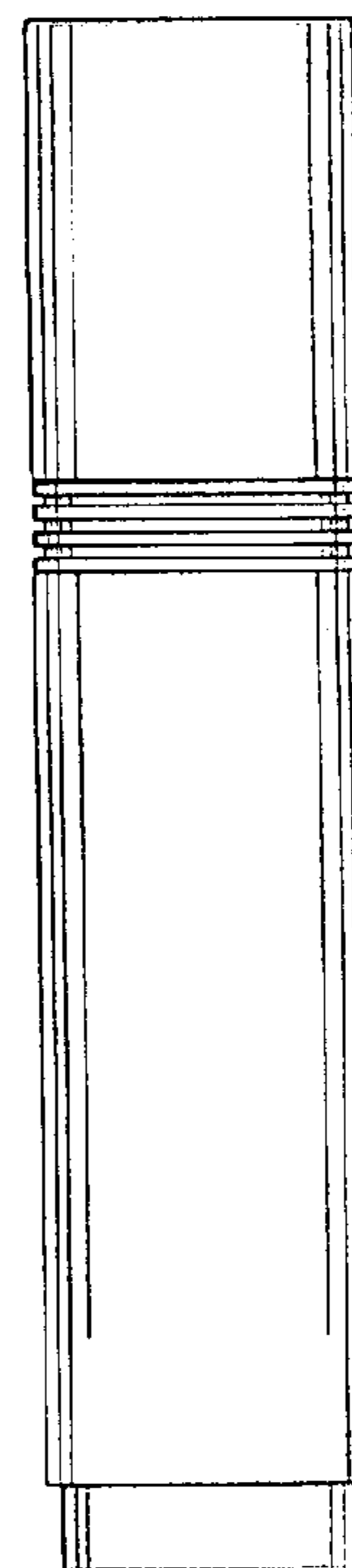
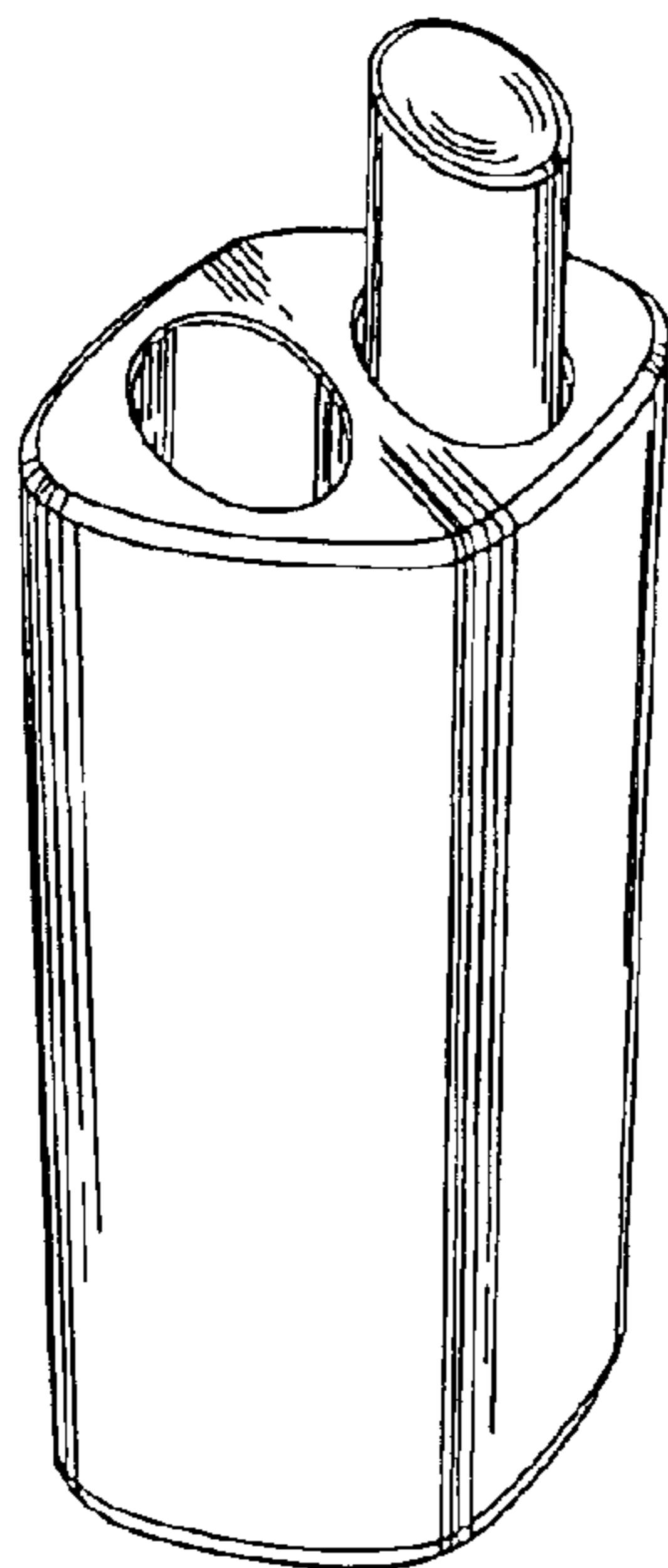
FIG. 8 is a top plan view of one of the highlighters shown separately for ease of illustration;

FIG. 9 is a front elevational view of FIG. 8, the rear view being identical thereto;

FIG. 10 is a left side elevational view of FIG. 8, the right side being identical thereto; and,

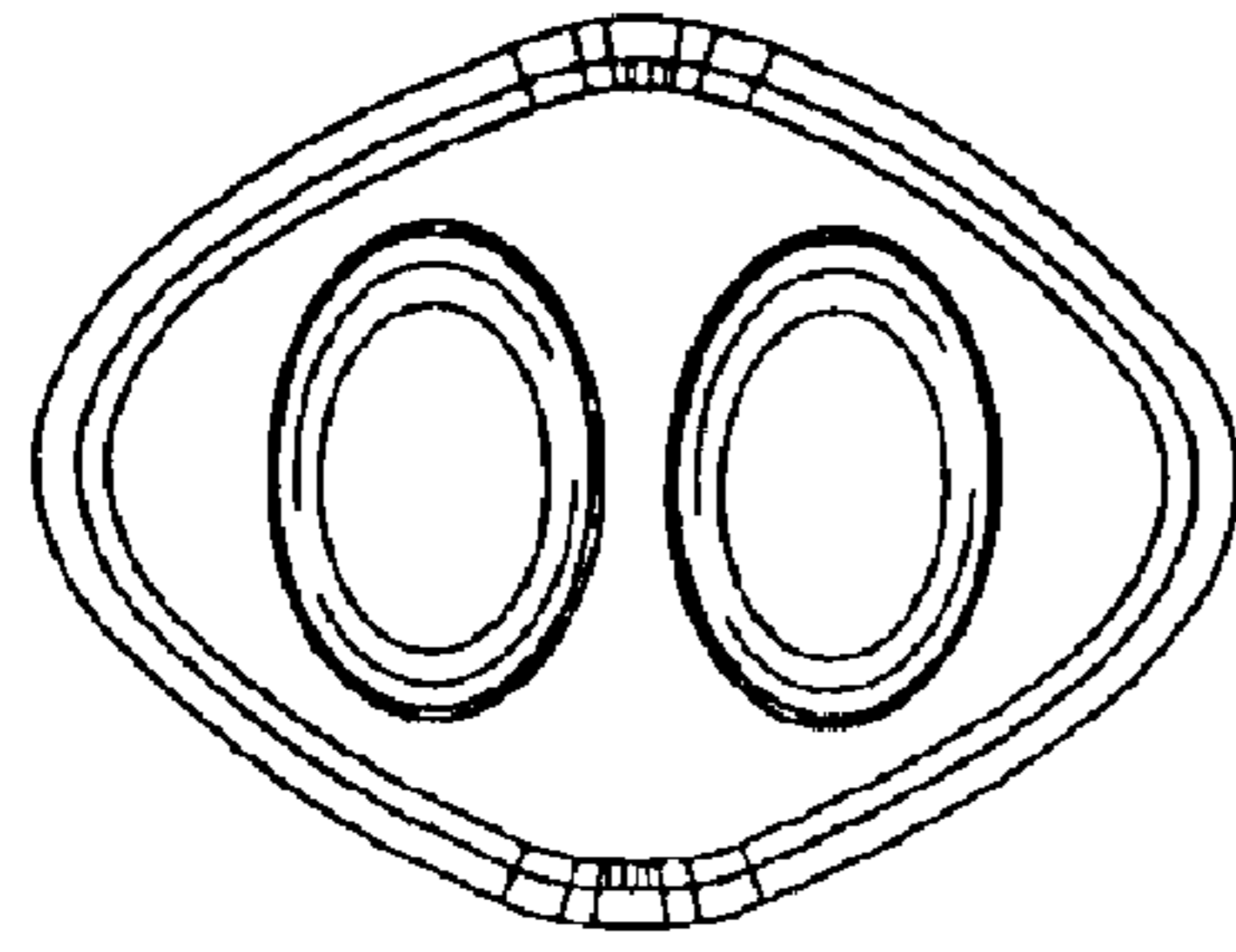

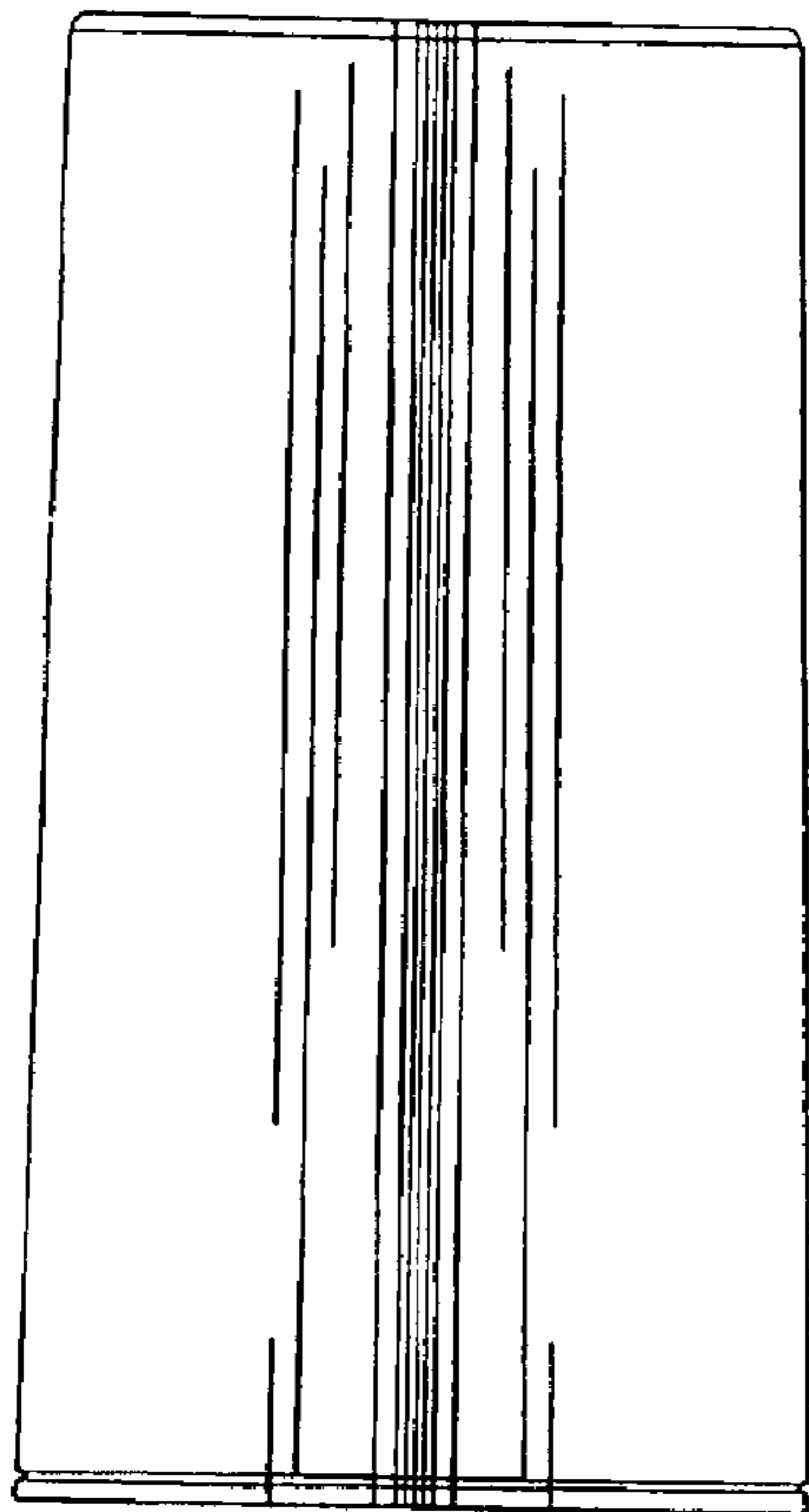

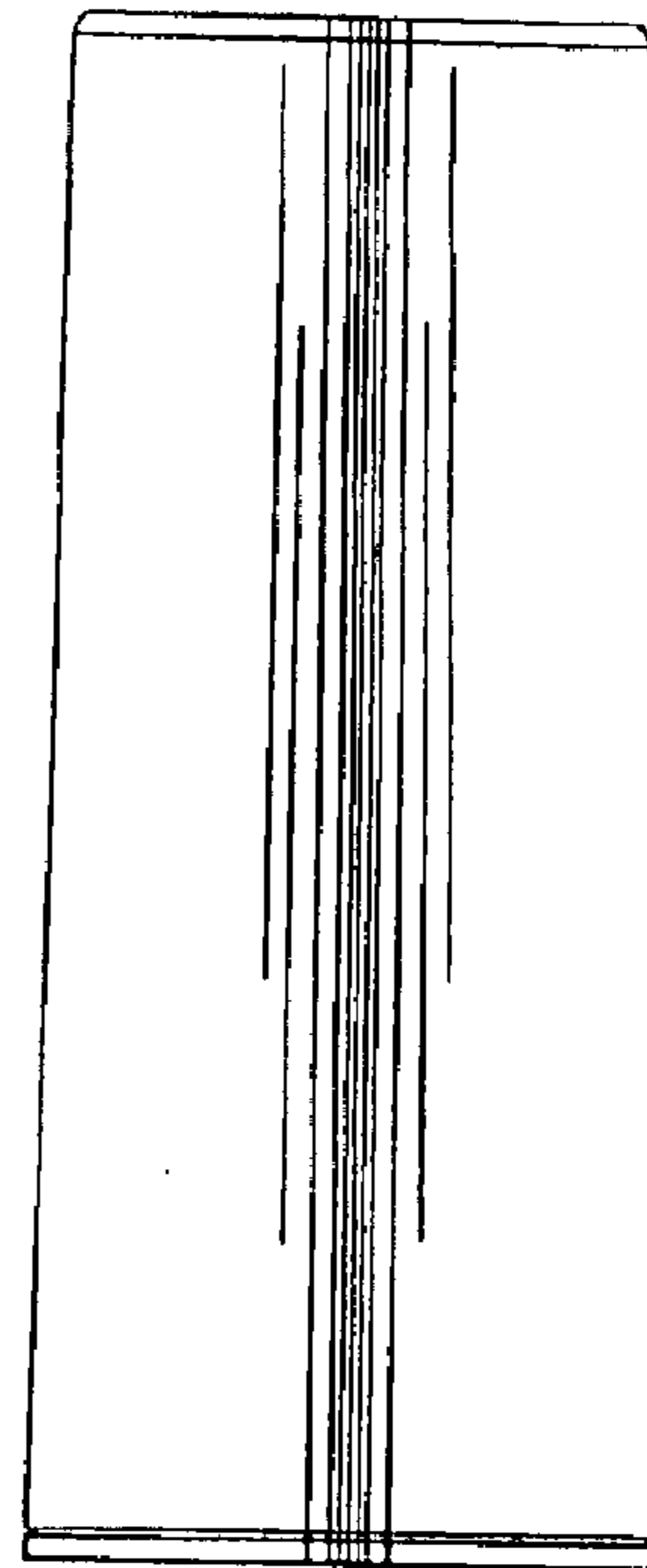

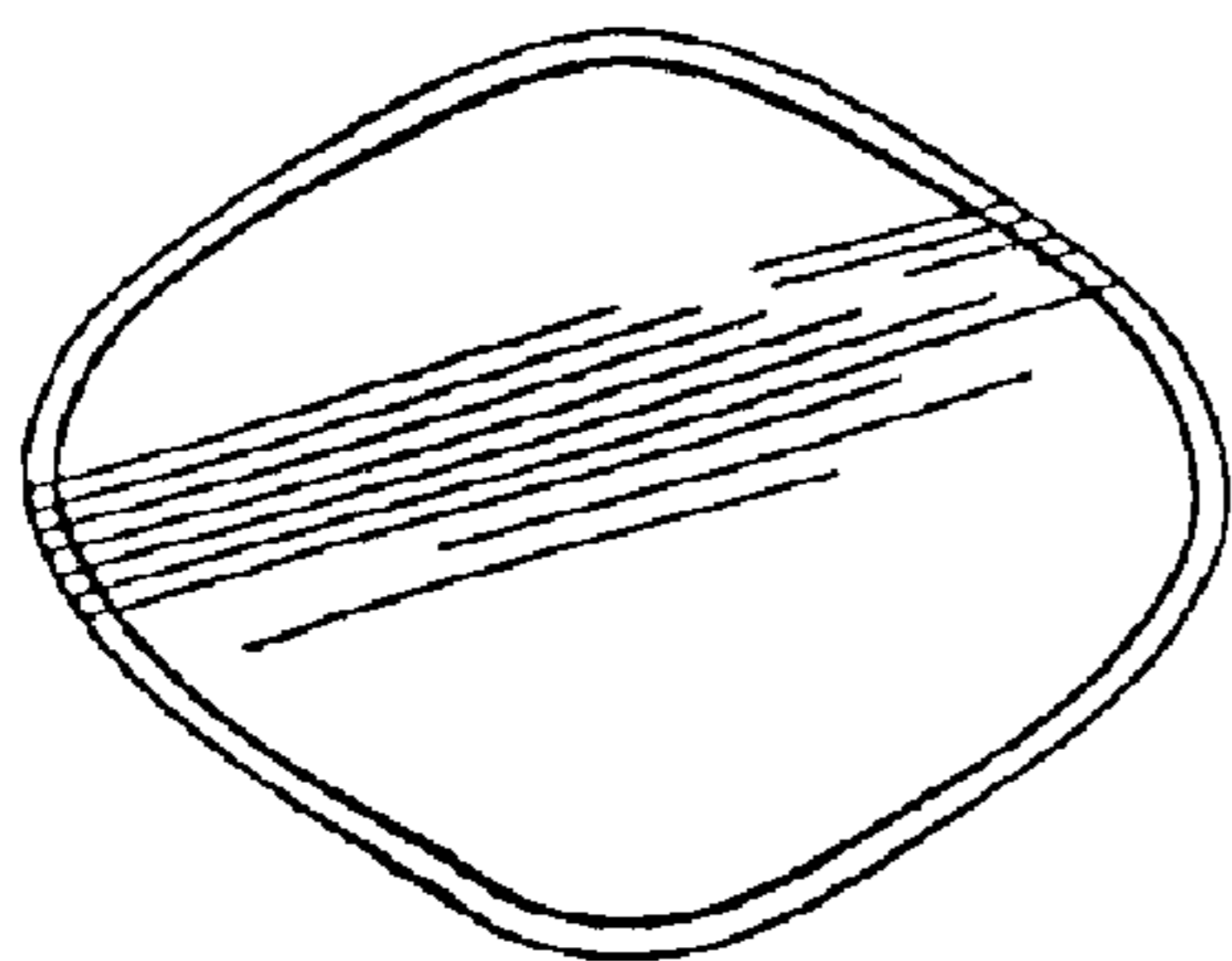

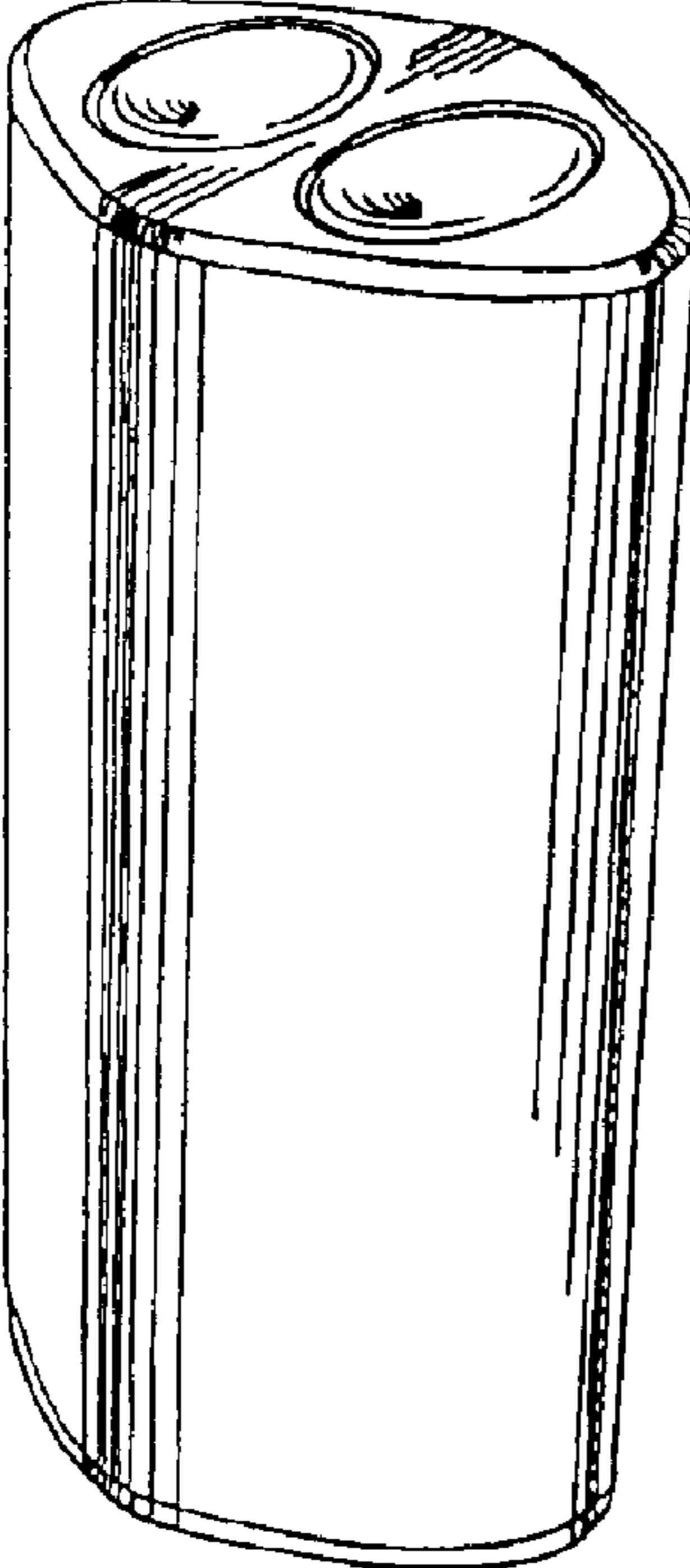

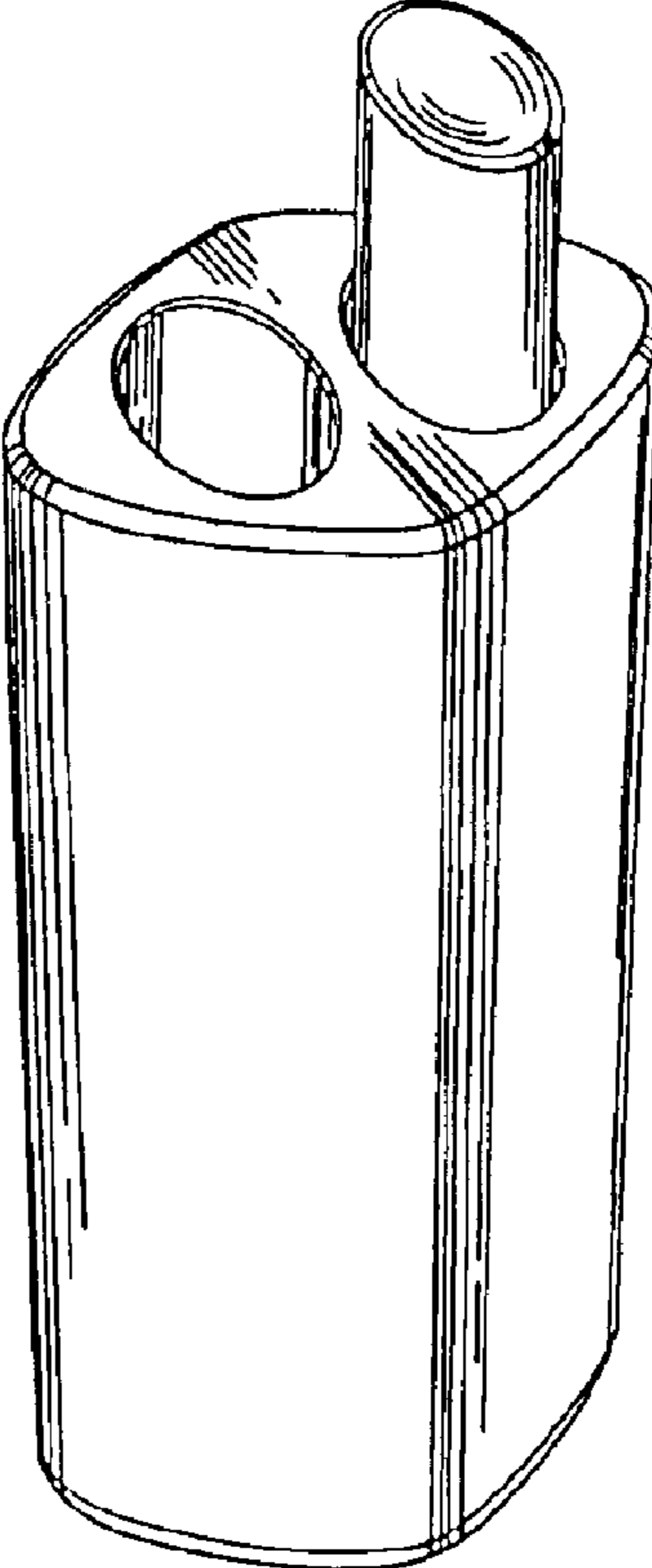

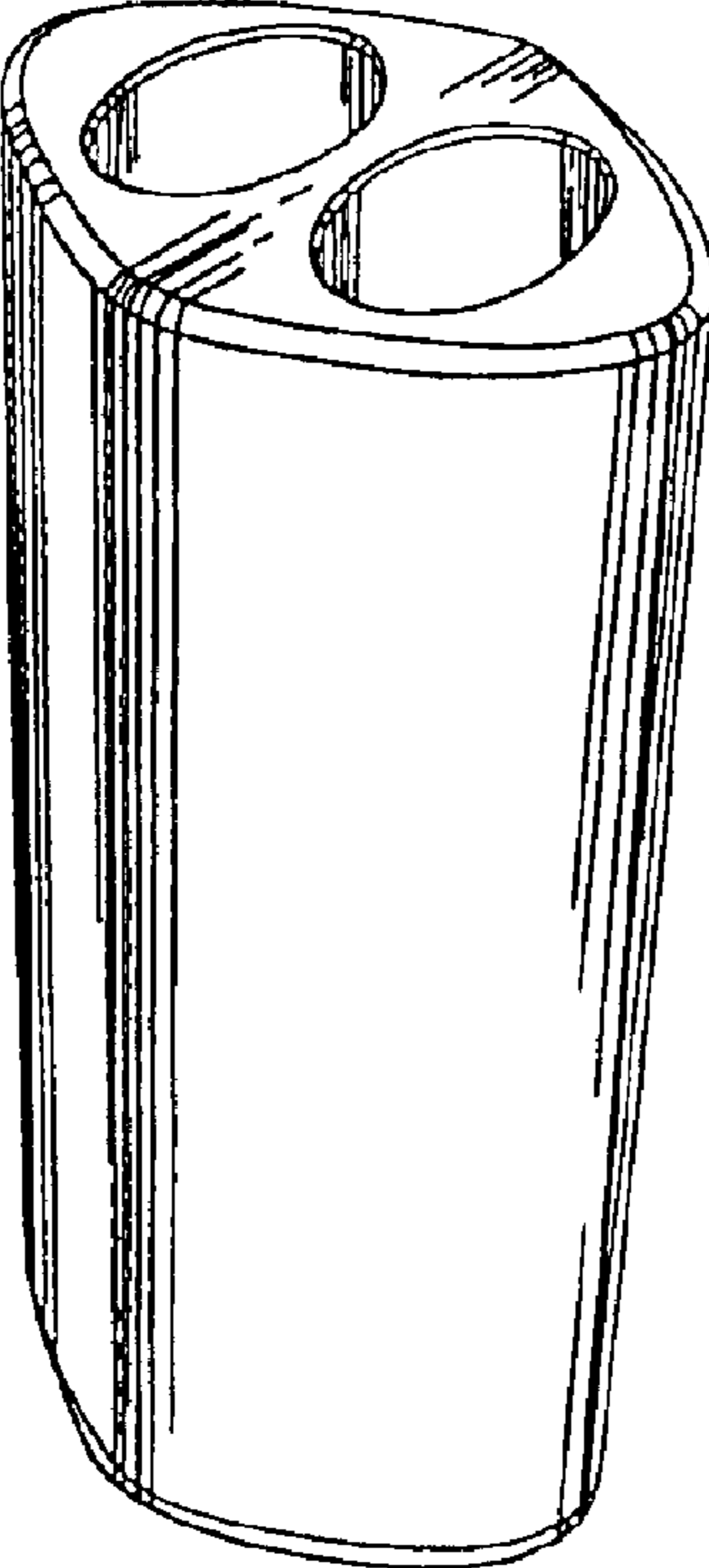

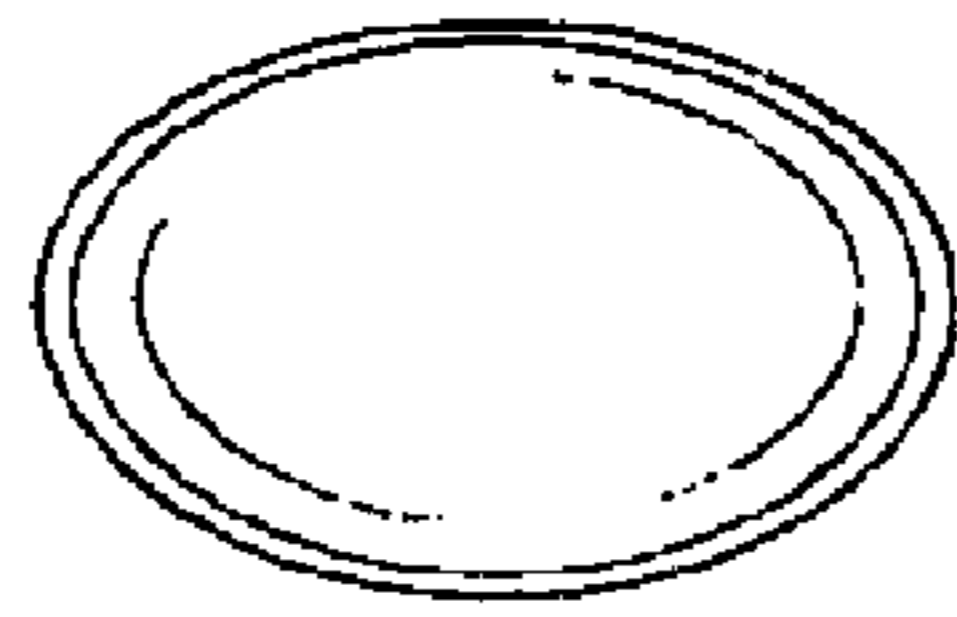

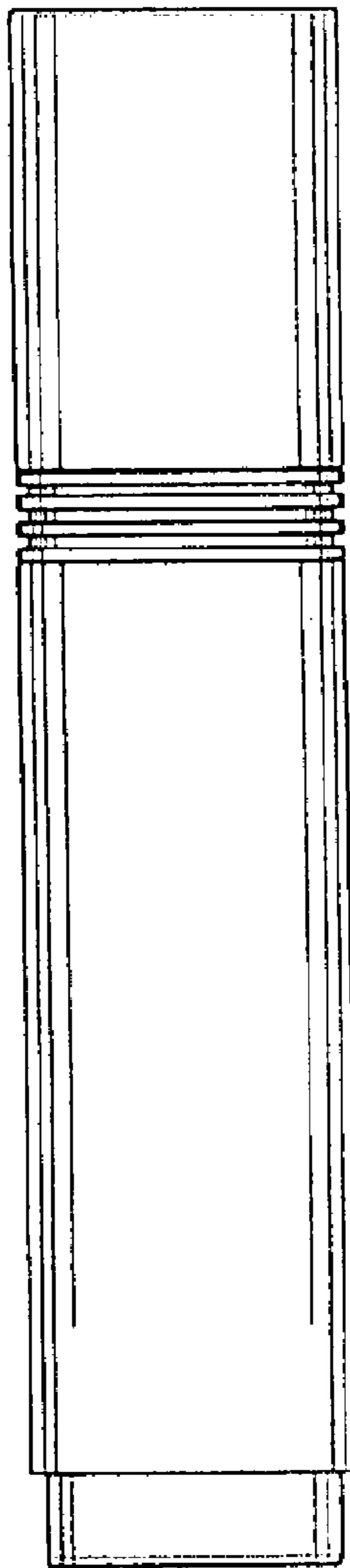

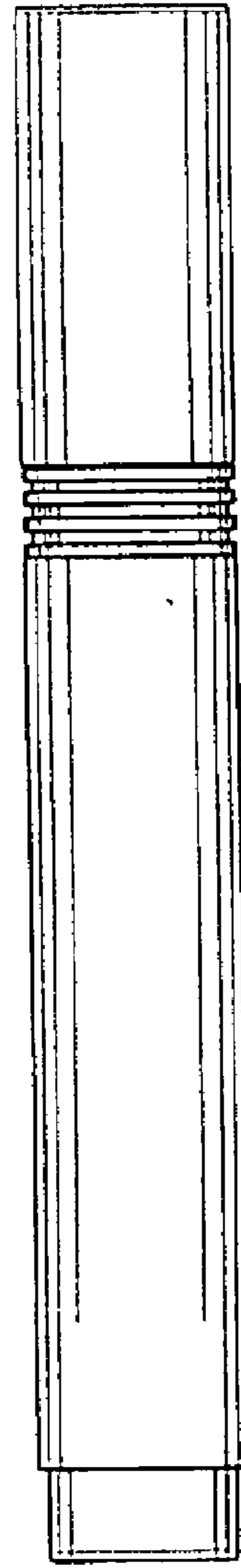

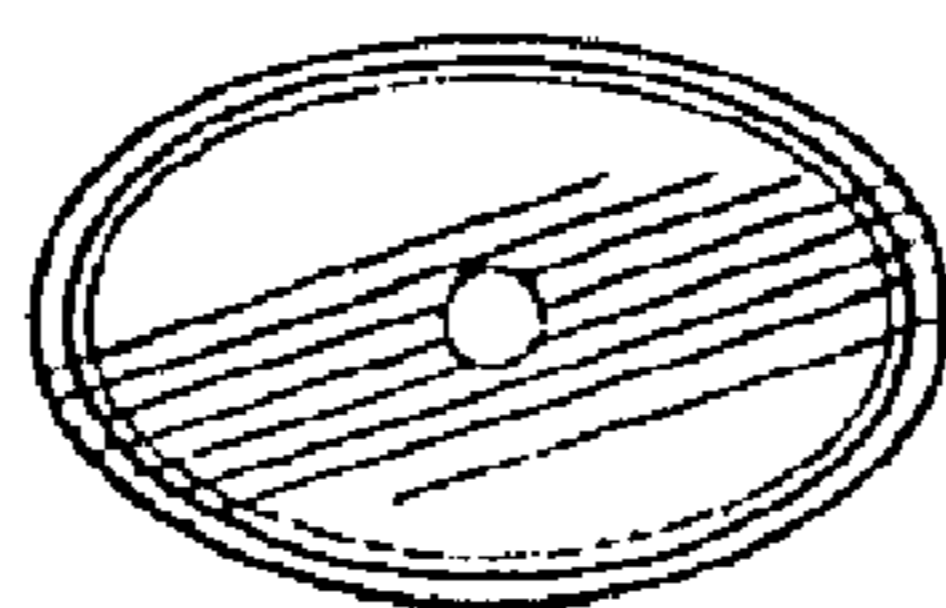
