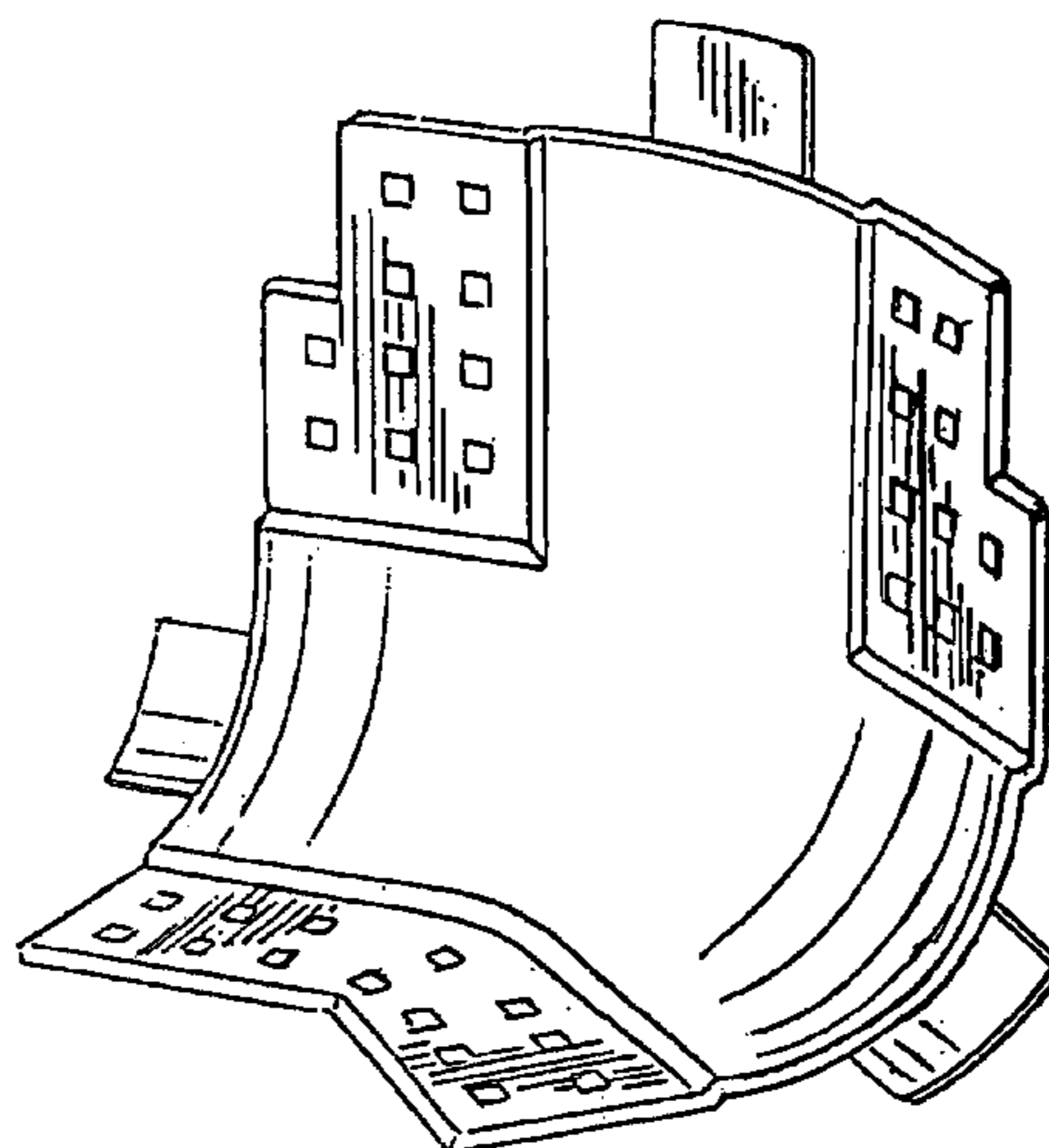
(57) **CLAIM**

The ornamental design for a “three way; 2-90° outside, 1-135° inside, bullnose corner”, as shown and described.

DESCRIPTION

FIG. 1 is a front side, and end perspective view of a three way; 2-90 outside, 1-135 inside bullnose corner showing our new design, the opposite end is identical; FIG. 2 is a rear elevational view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a top, front, and side perspective view showing a second embodiment of our new design; and, FIG. 5 is top plan view showing a third embodiment of our new design.

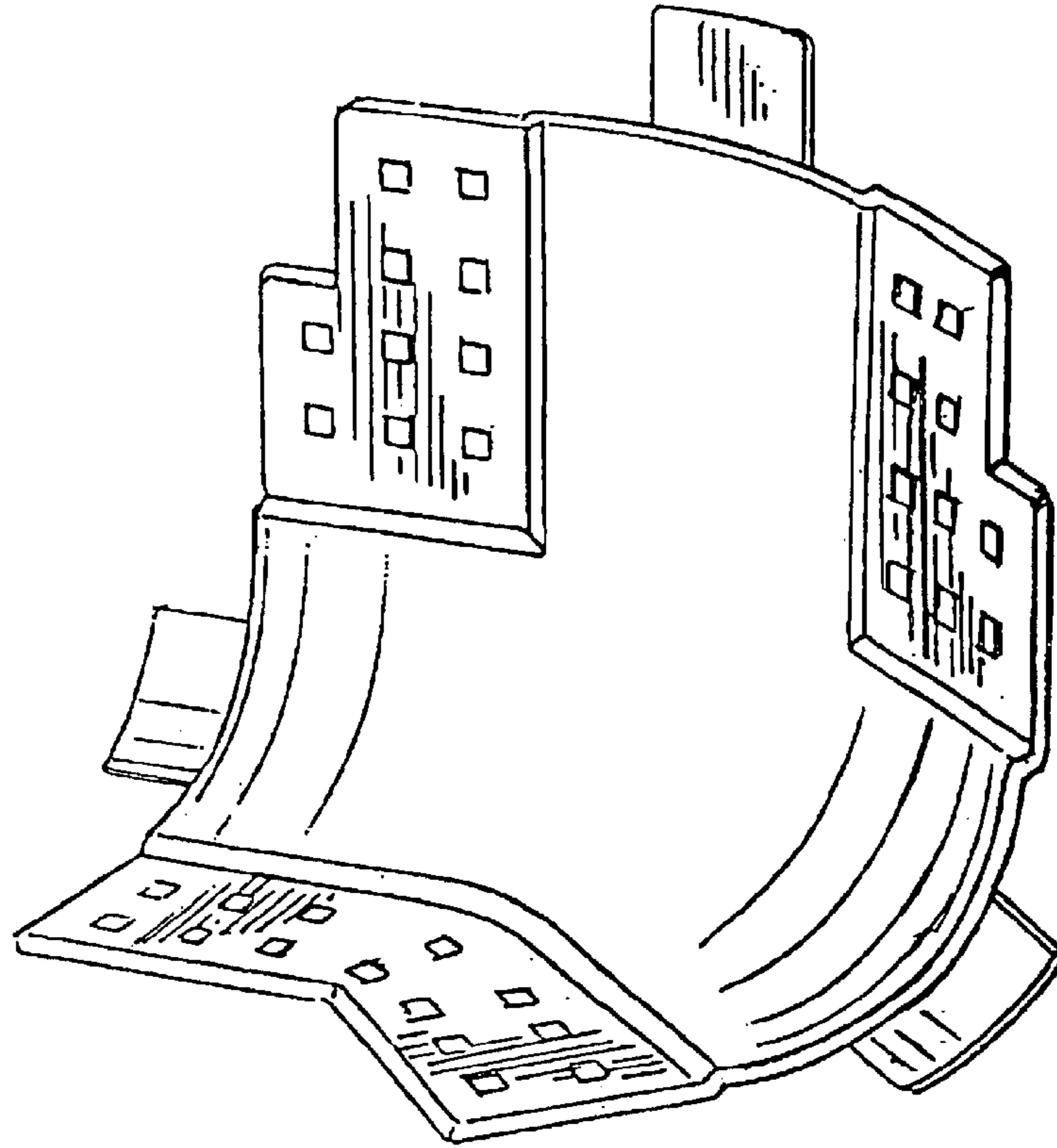

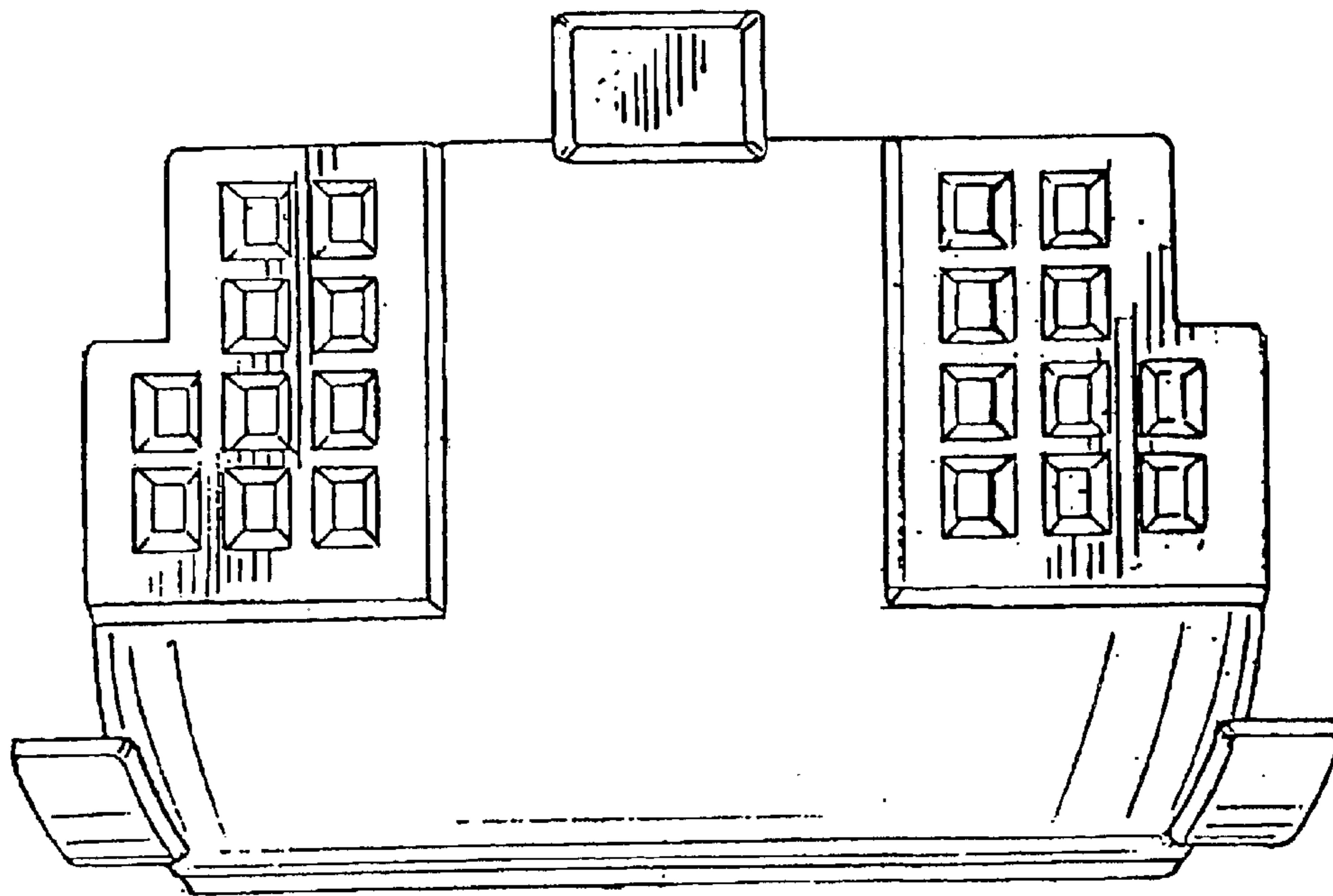

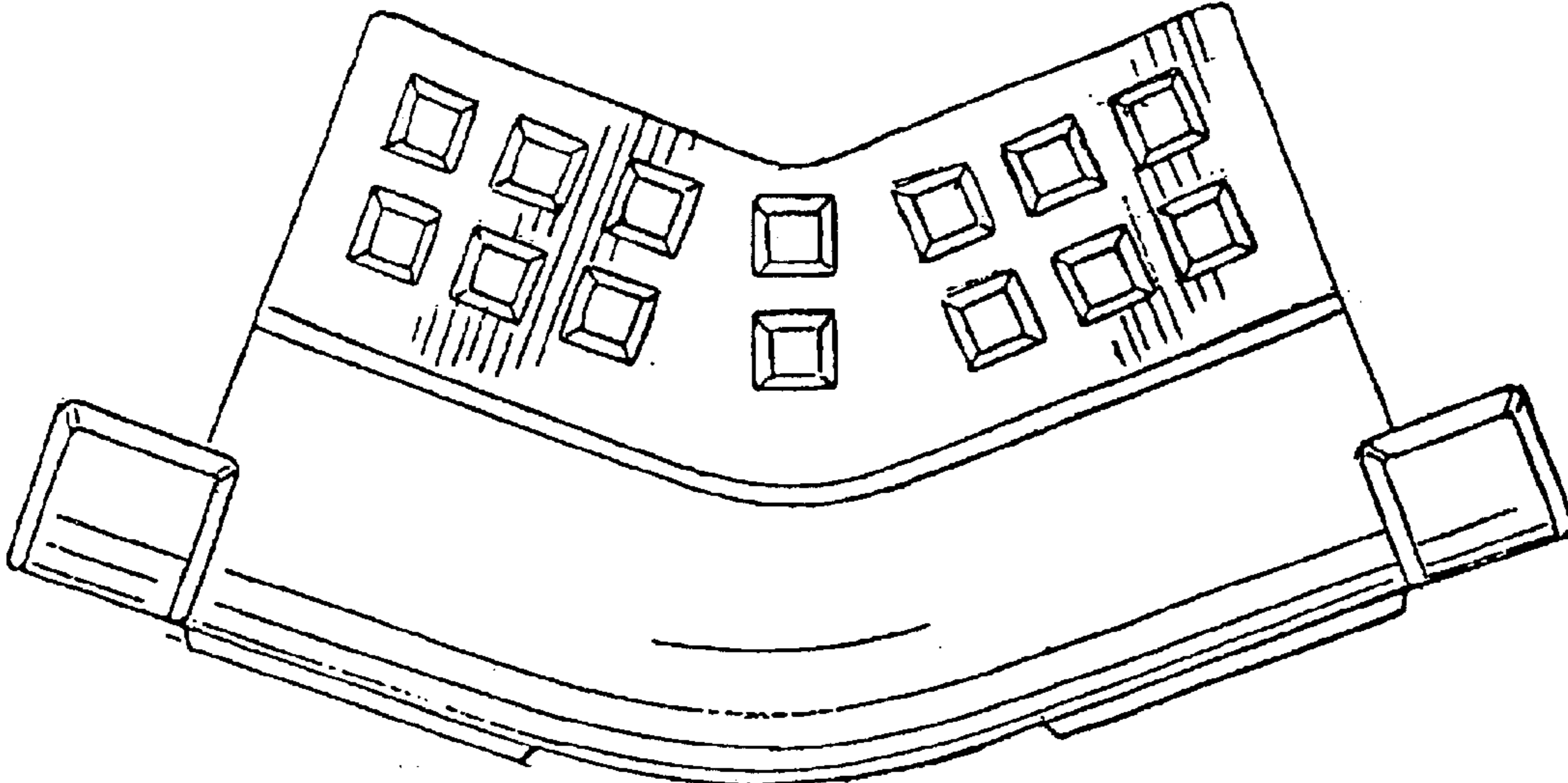

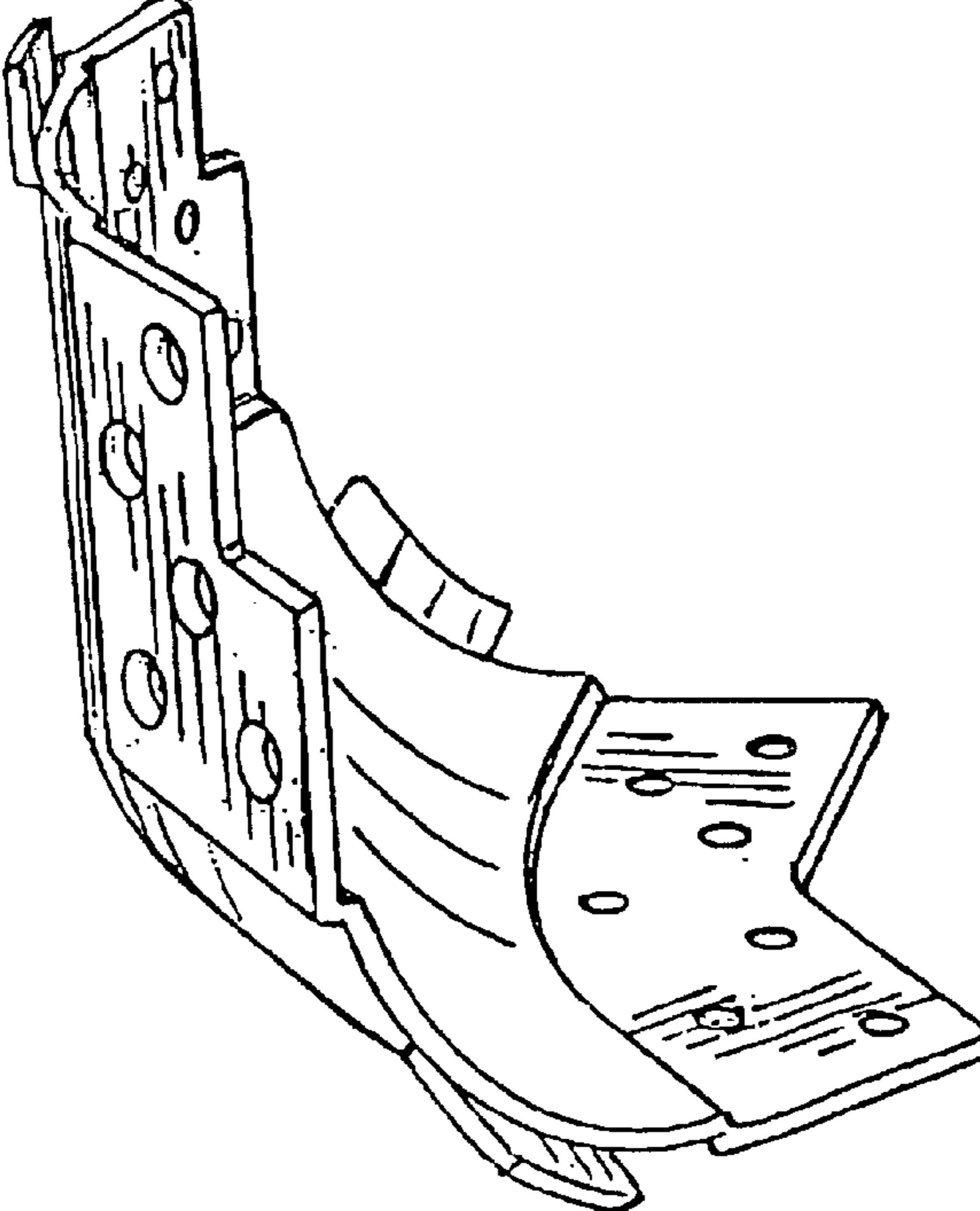

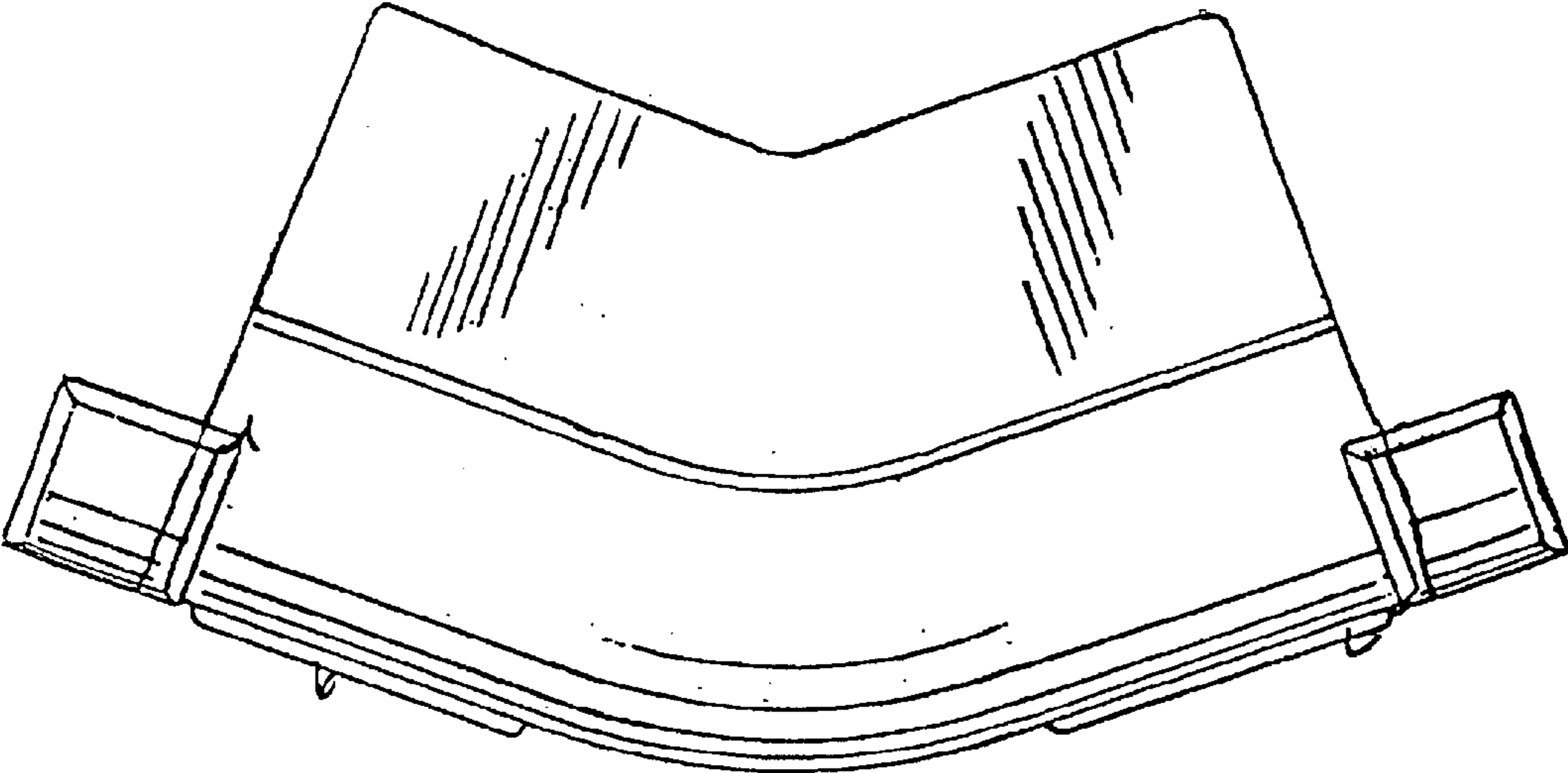
