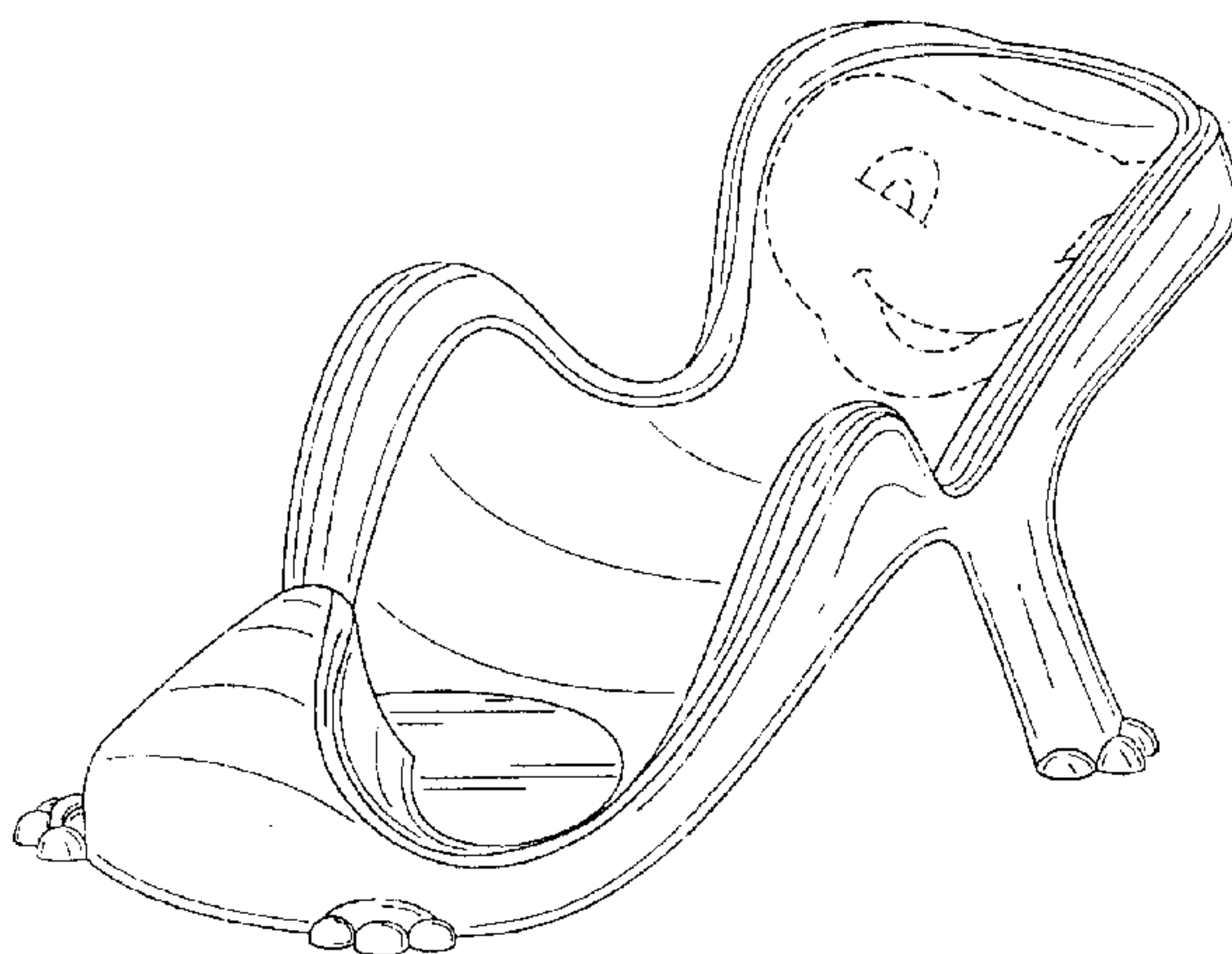
(57) **CLAIM**

I claim the ornamental design for a baby seat, as shown and described.

DESCRIPTION

FIG. 1 is a front view, showing a baby seat of my new design;
 FIG. 2 is a rear view thereof;
 FIG. 3 is a right side view thereof;
 FIG. 4 is a top view thereof;
 FIG. 5 is a bottom view thereof;
 FIG. 6 is a front top perspective view thereof;
 FIG. 7 is a front bottom perspective view thereof;
 FIG. 8 is a top right side perspective view thereof; and,
 FIG. 9 is a top left side perspective view thereof.

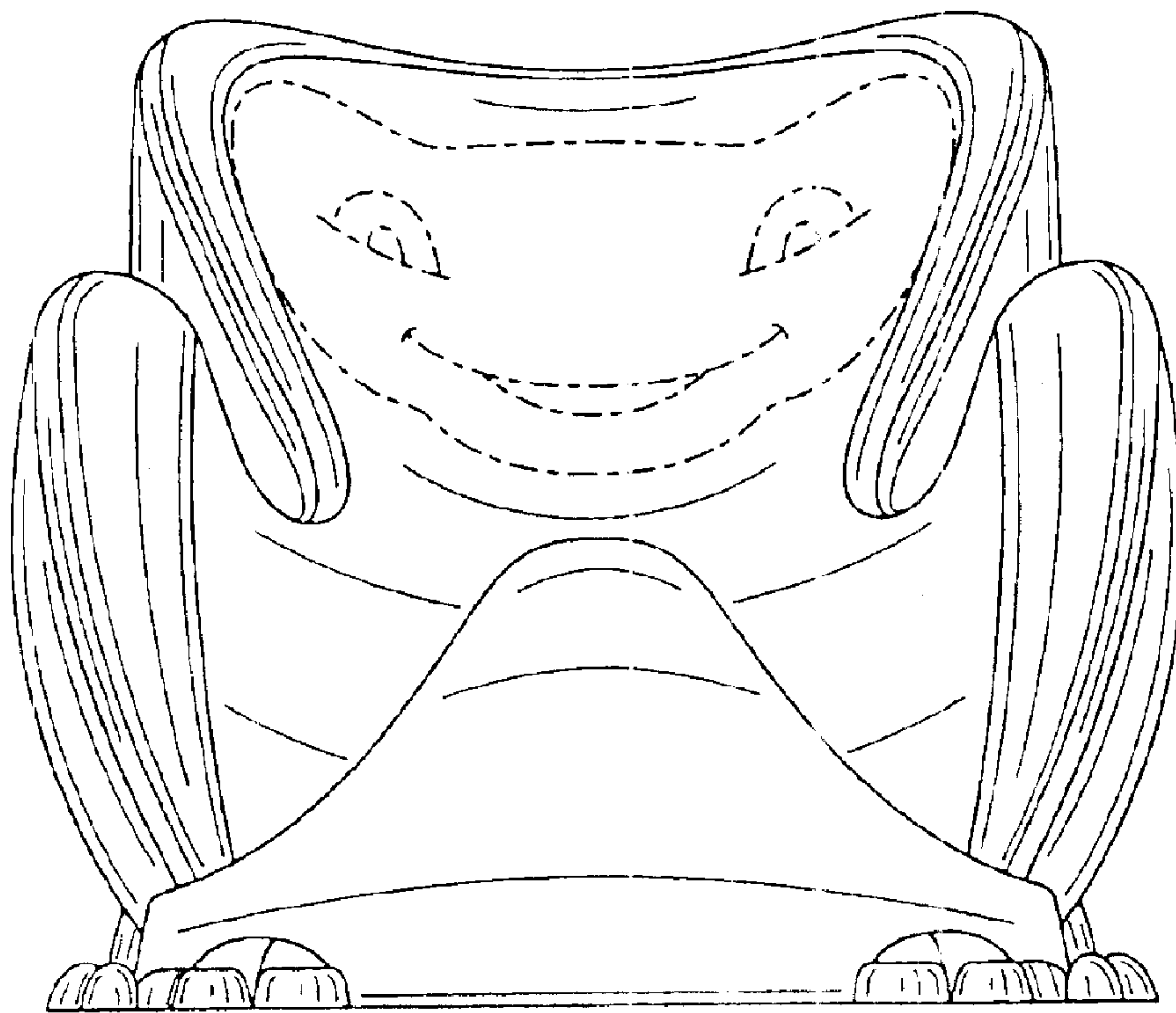

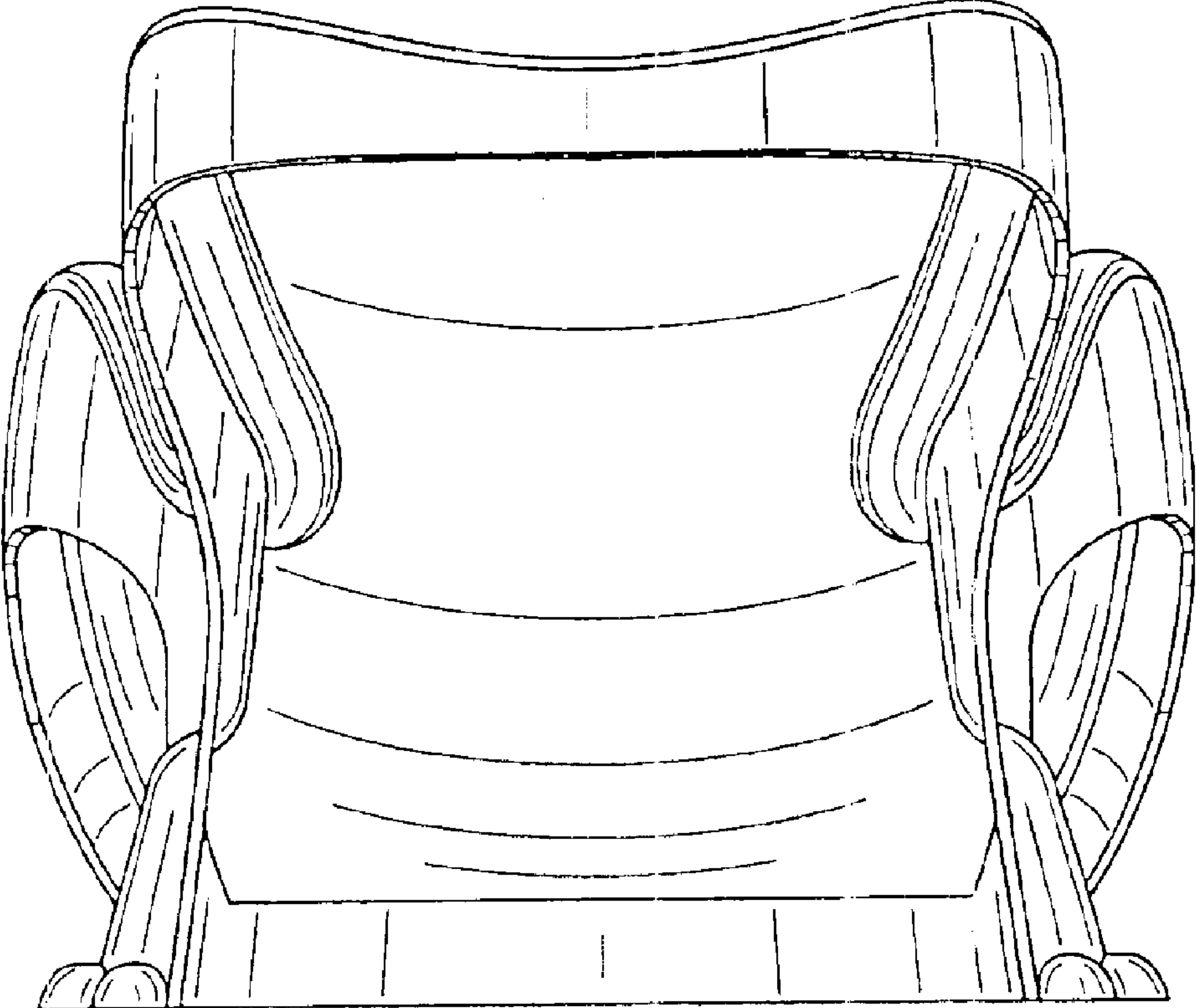

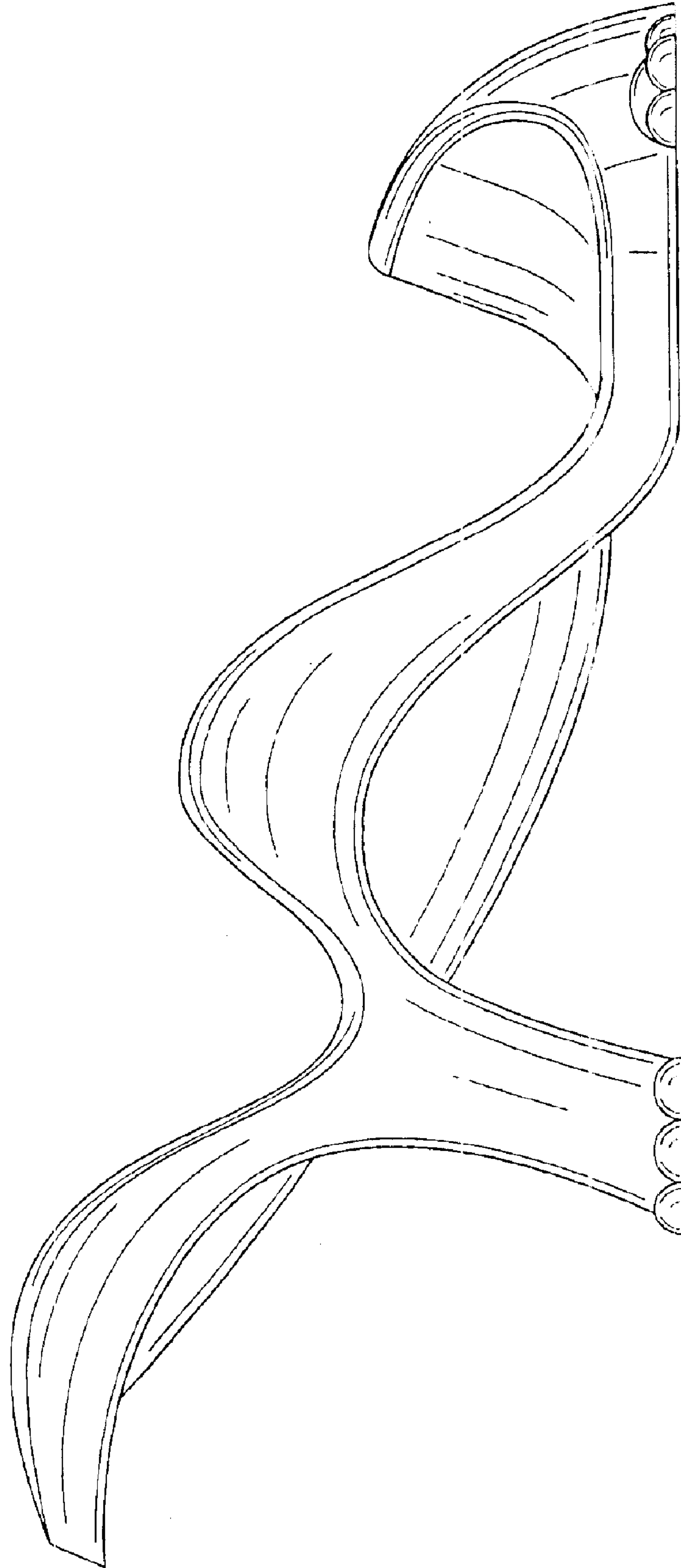

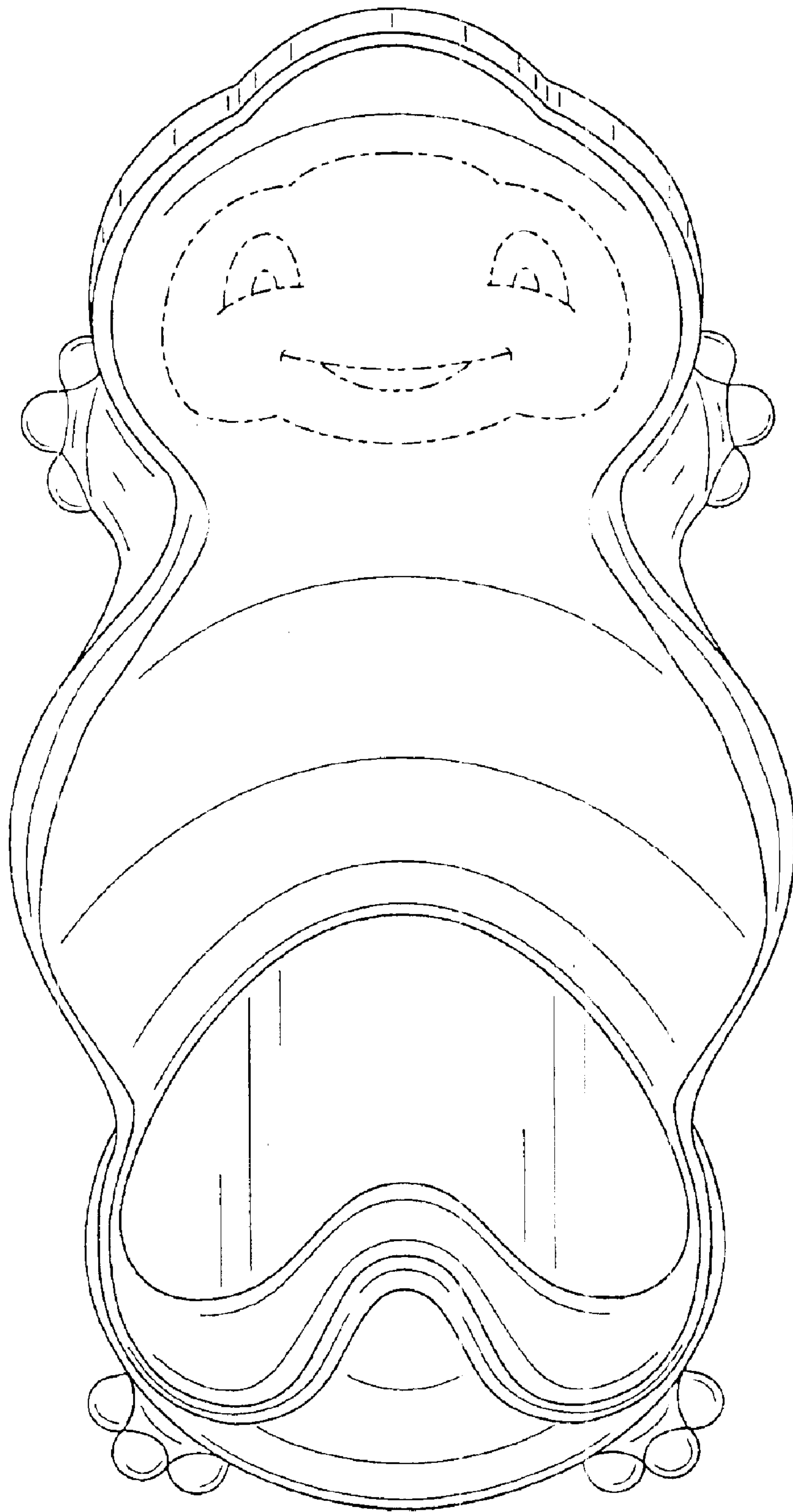

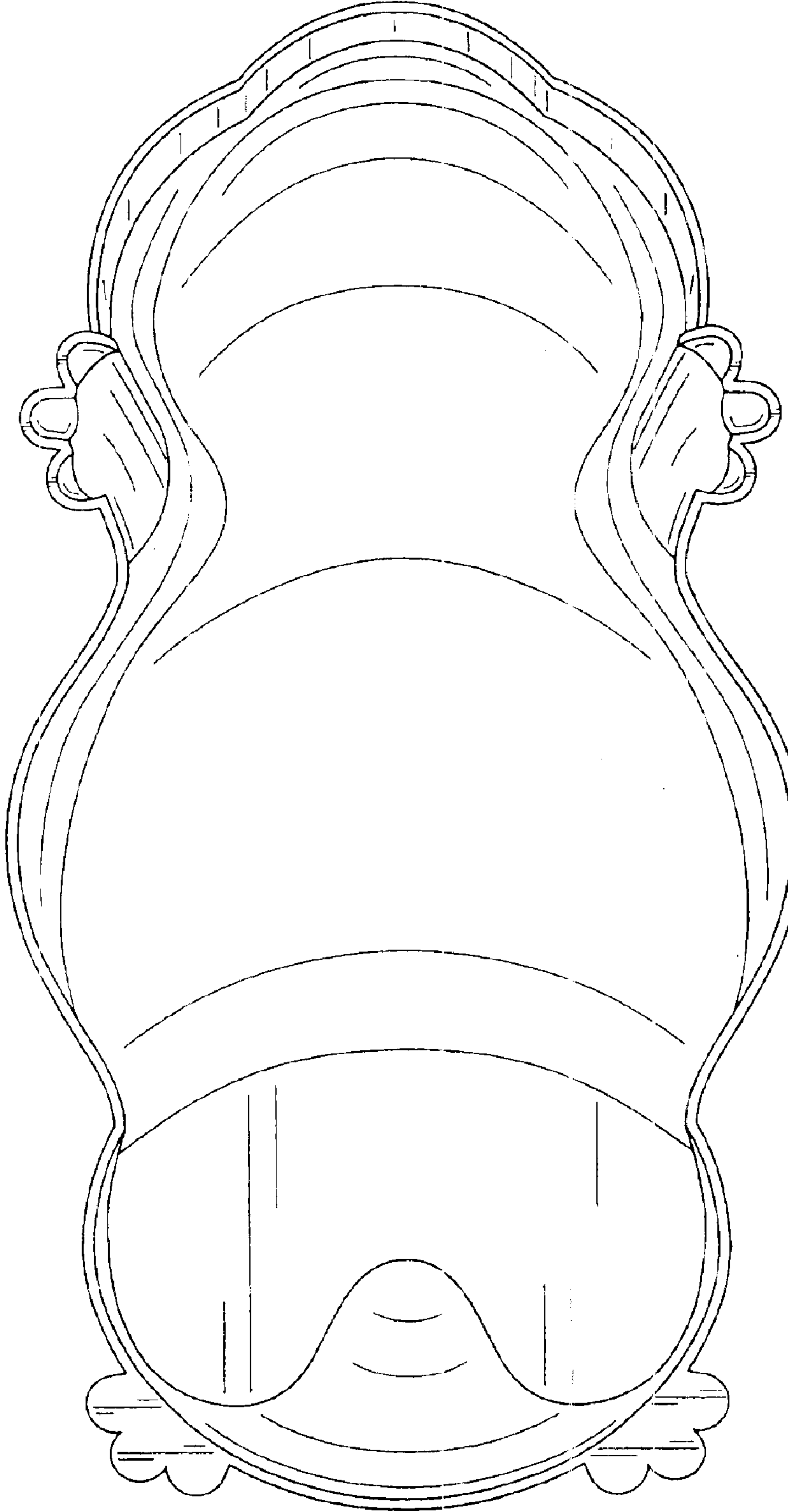

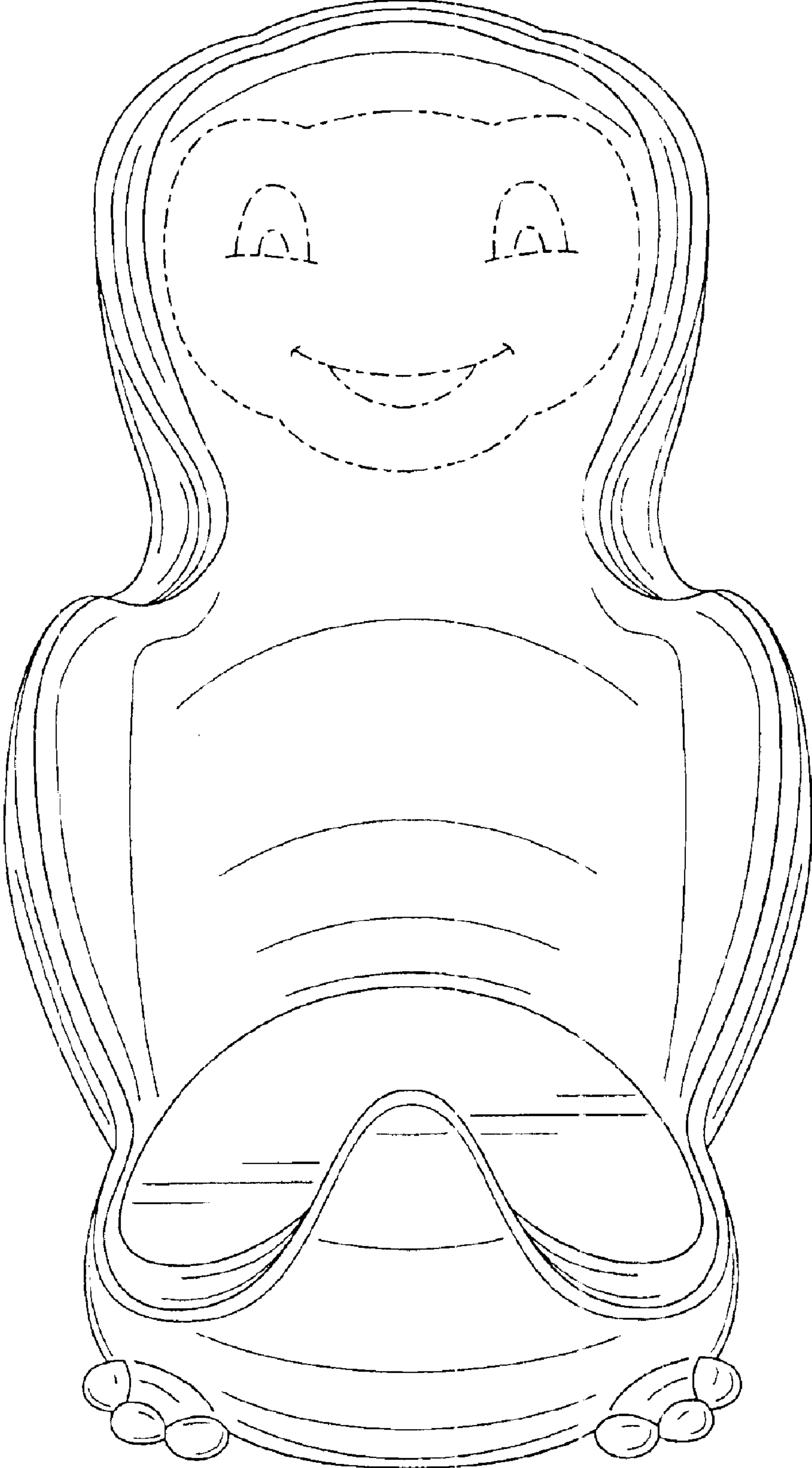

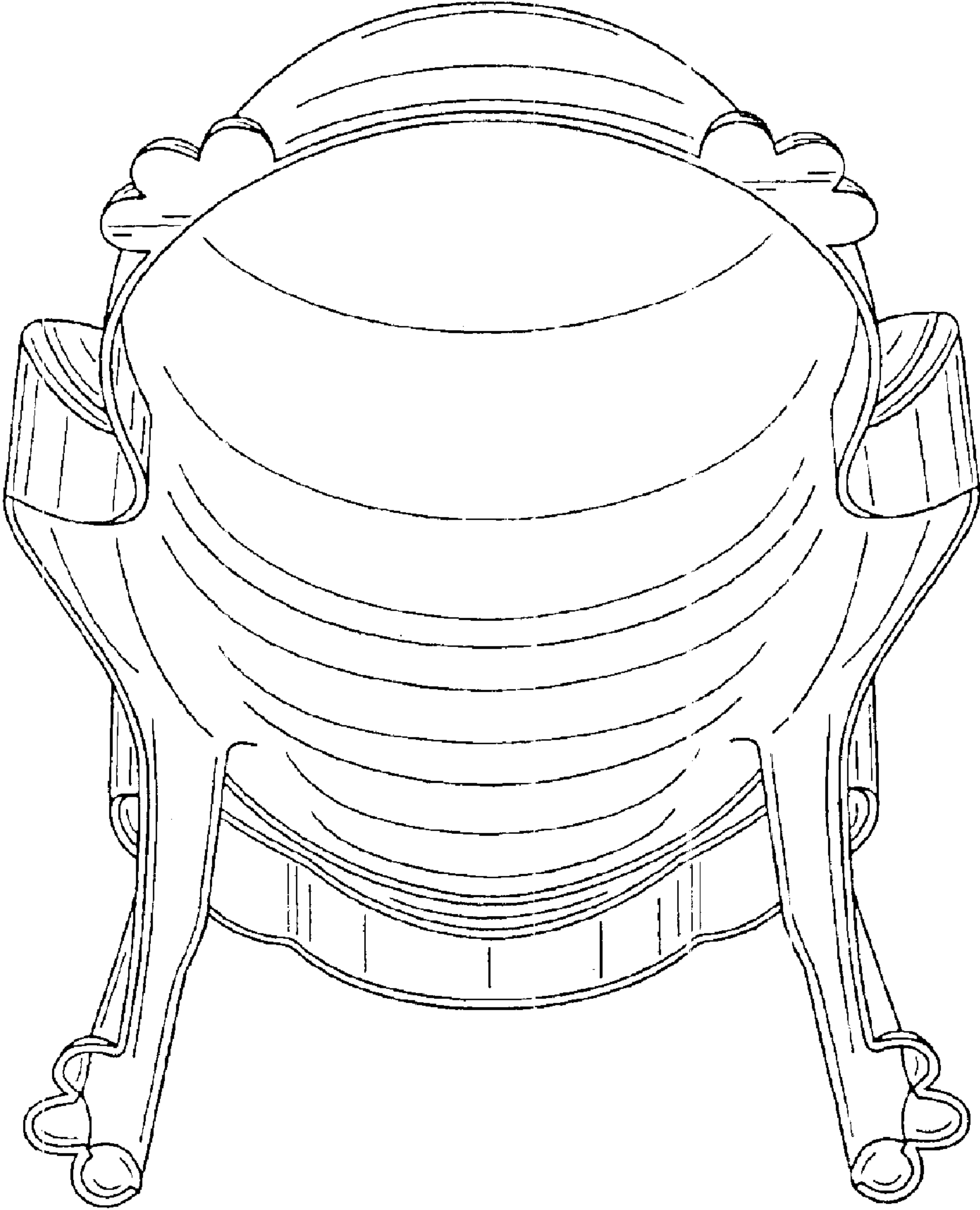

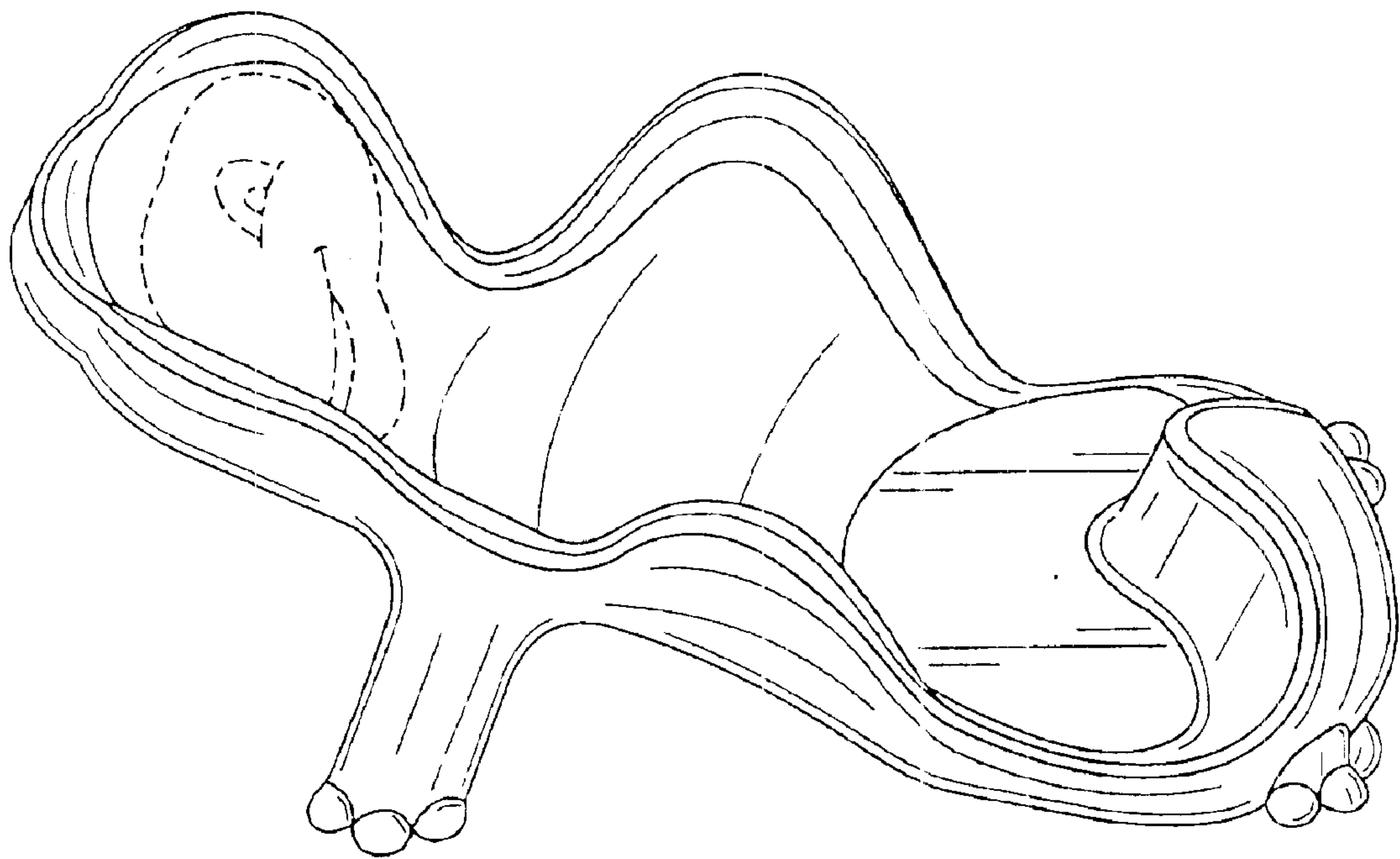

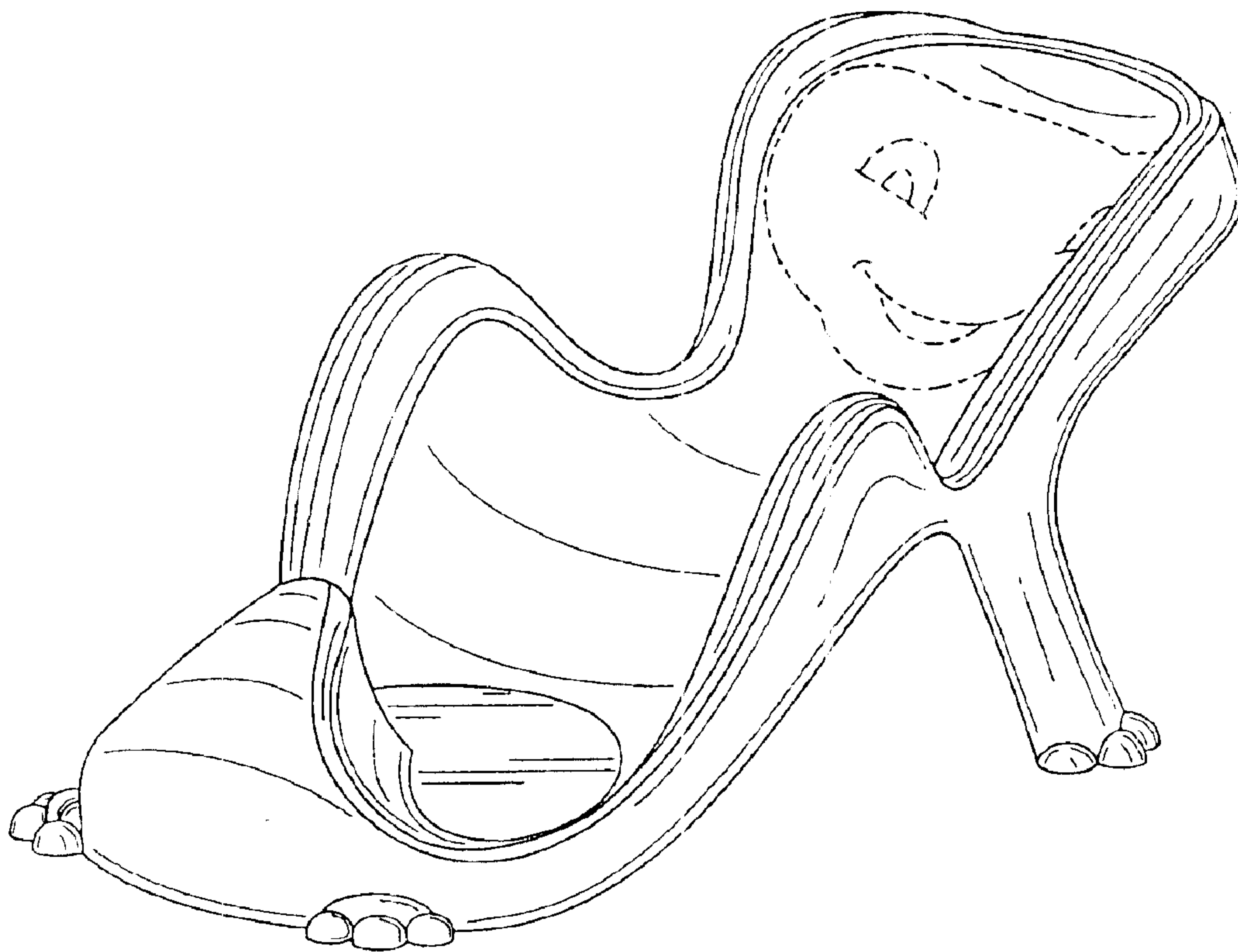
