described.

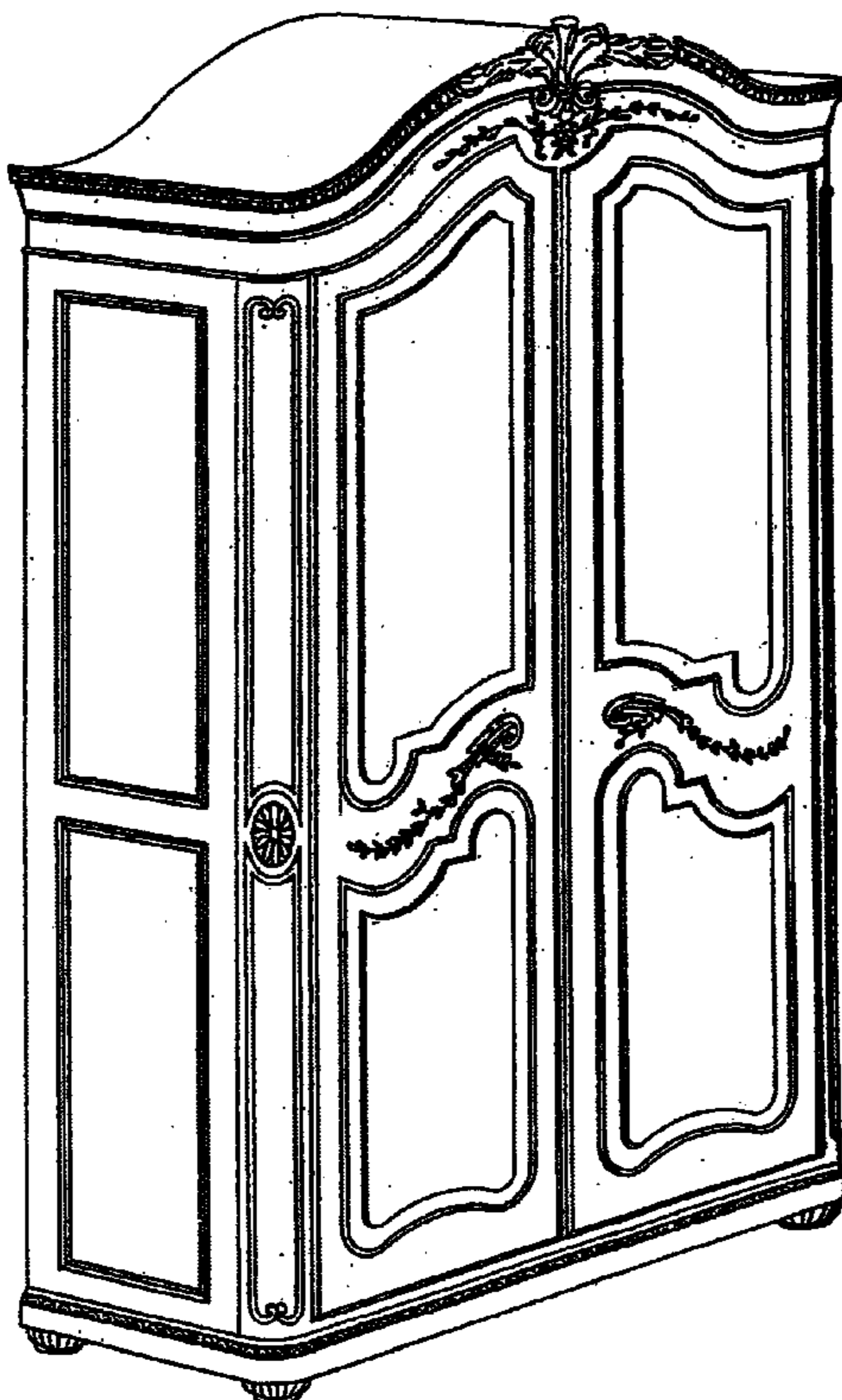
DESCRIPTION

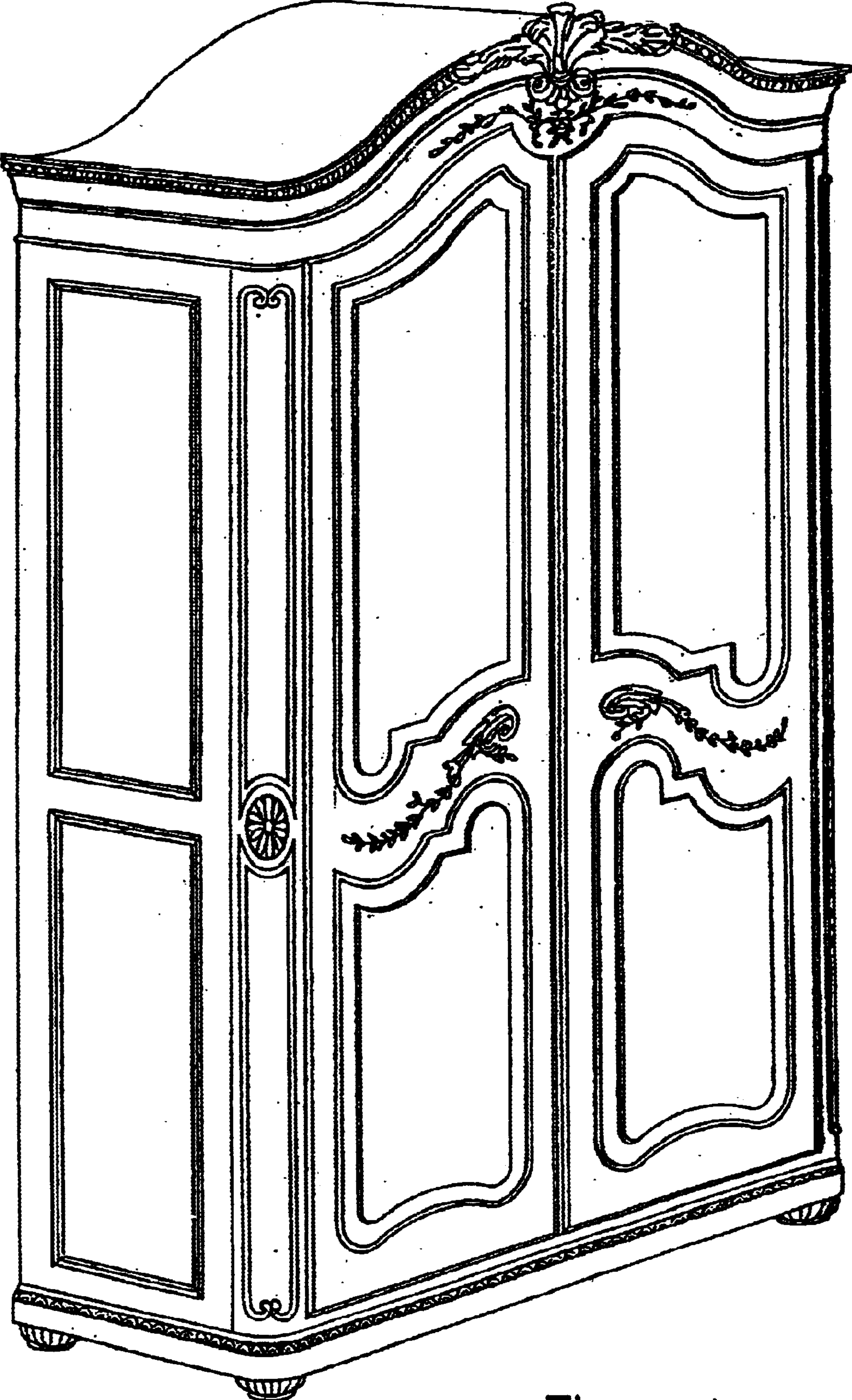

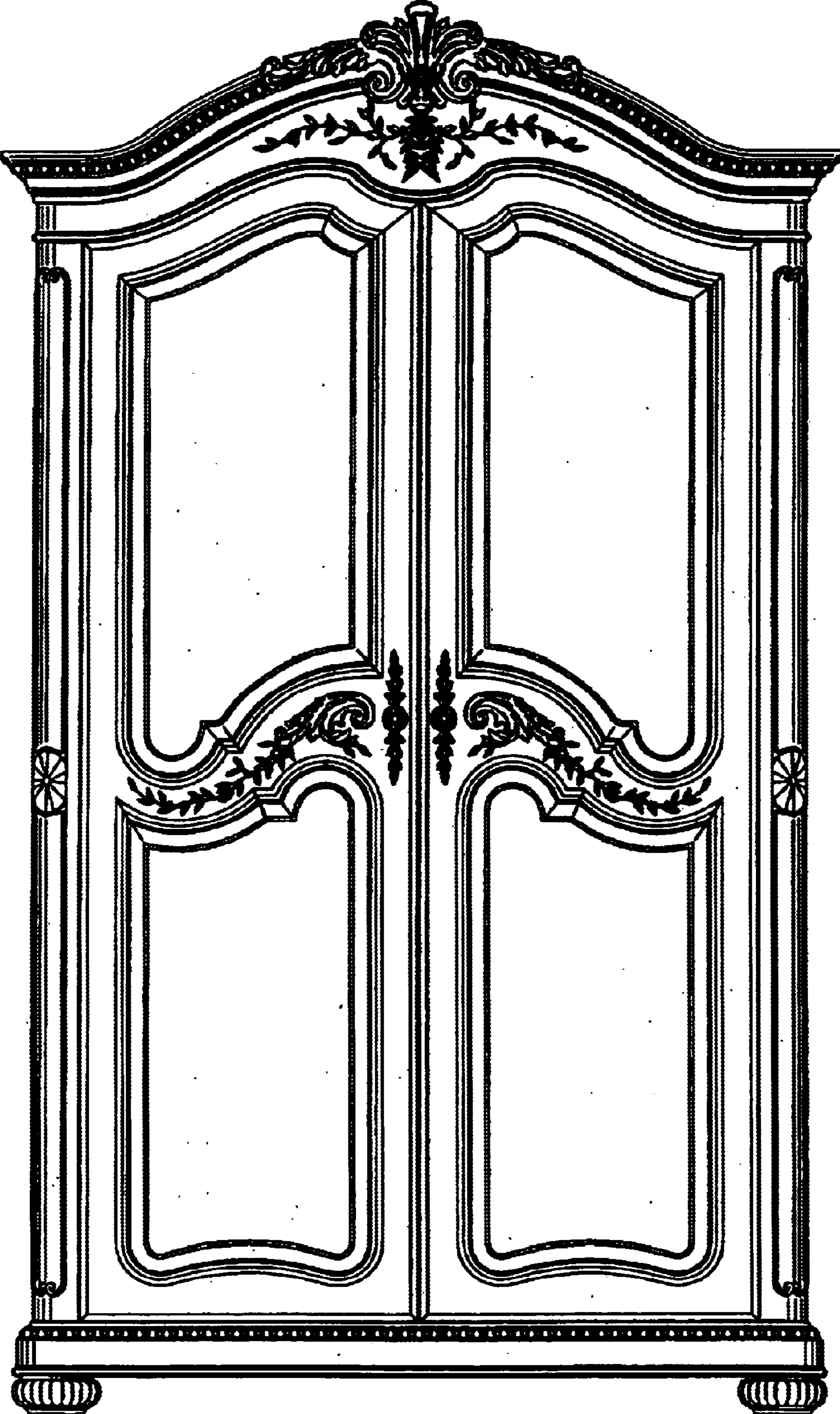

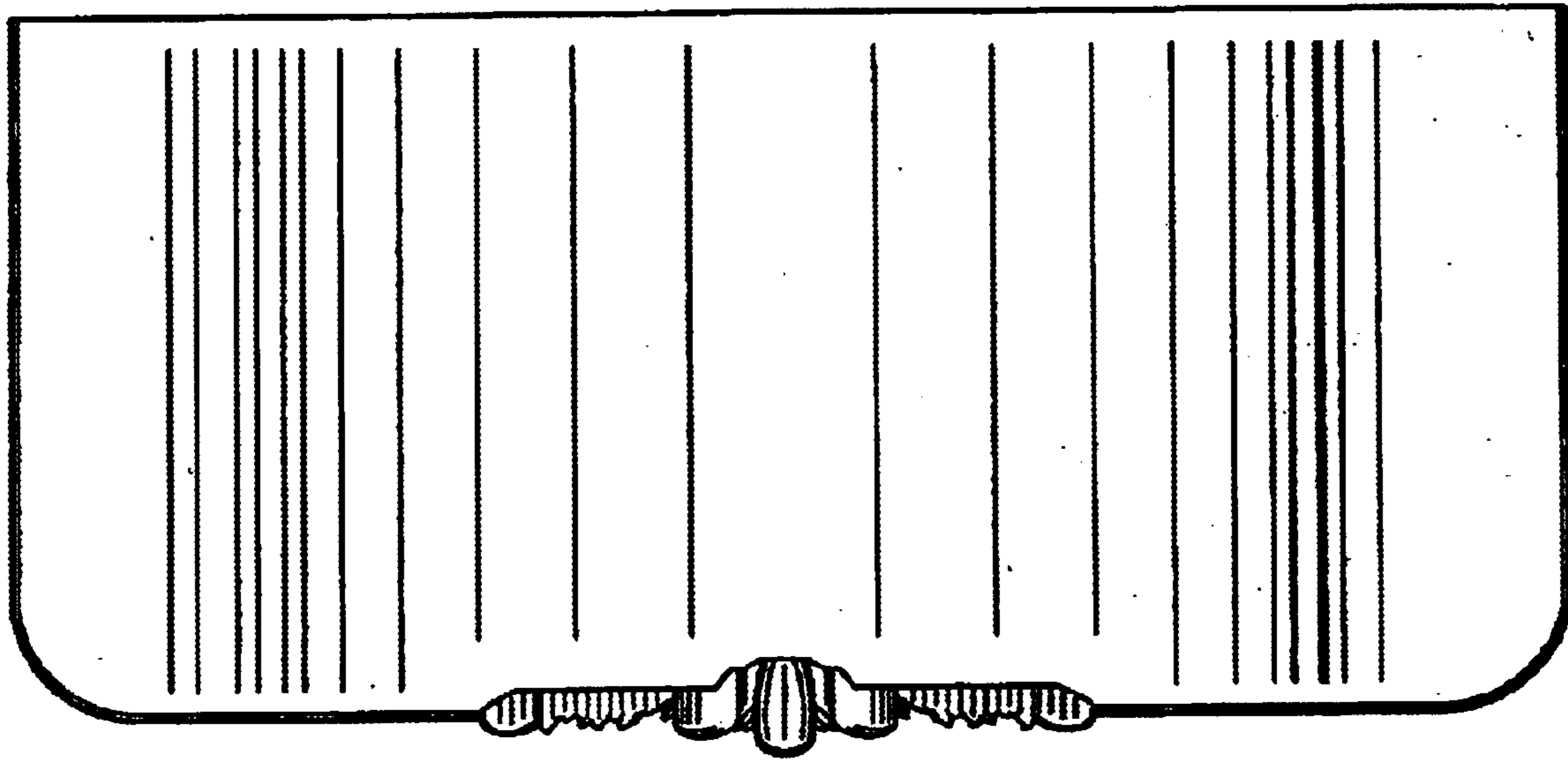

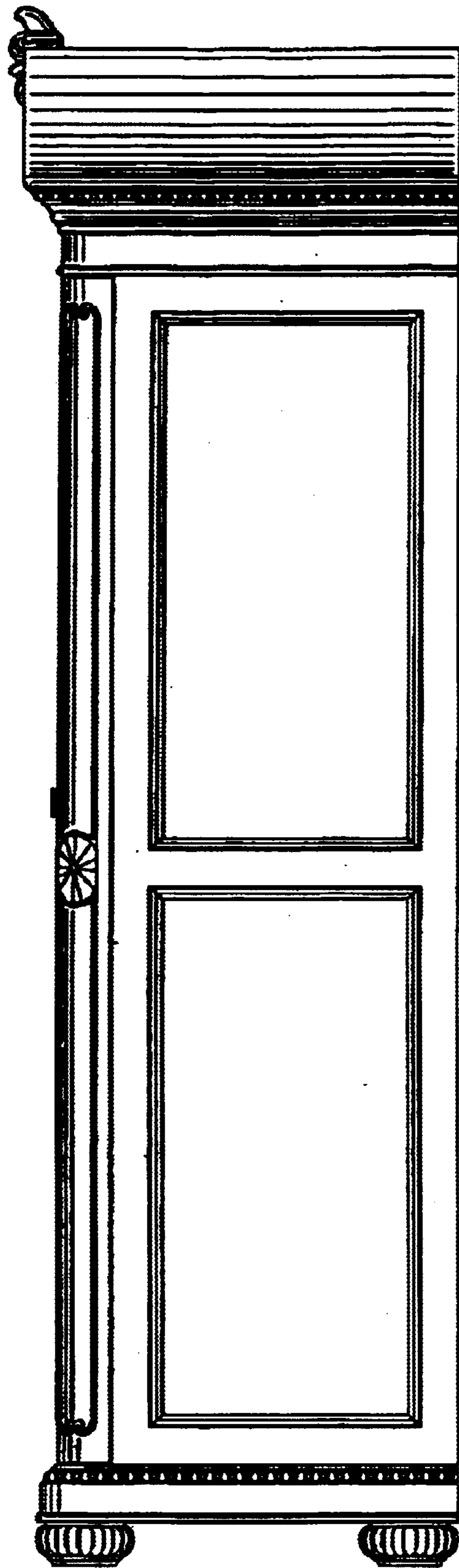
