The ornamental design for an accessory post, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of an accessory post of the new design;  
FIG. 2 is a front elevational view of the accessory post of FIG. 1;  
FIG. 3 is a left side elevational view of the accessory post of FIG. 1;  
FIG. 4 is a bottom plan view of the accessory post of FIG. 1;  
FIG. 5 is a right side elevational view of the accessory post of FIG. 1; and,  
FIG. 6 is a rear elevational view of the accessory post of FIG. 1.

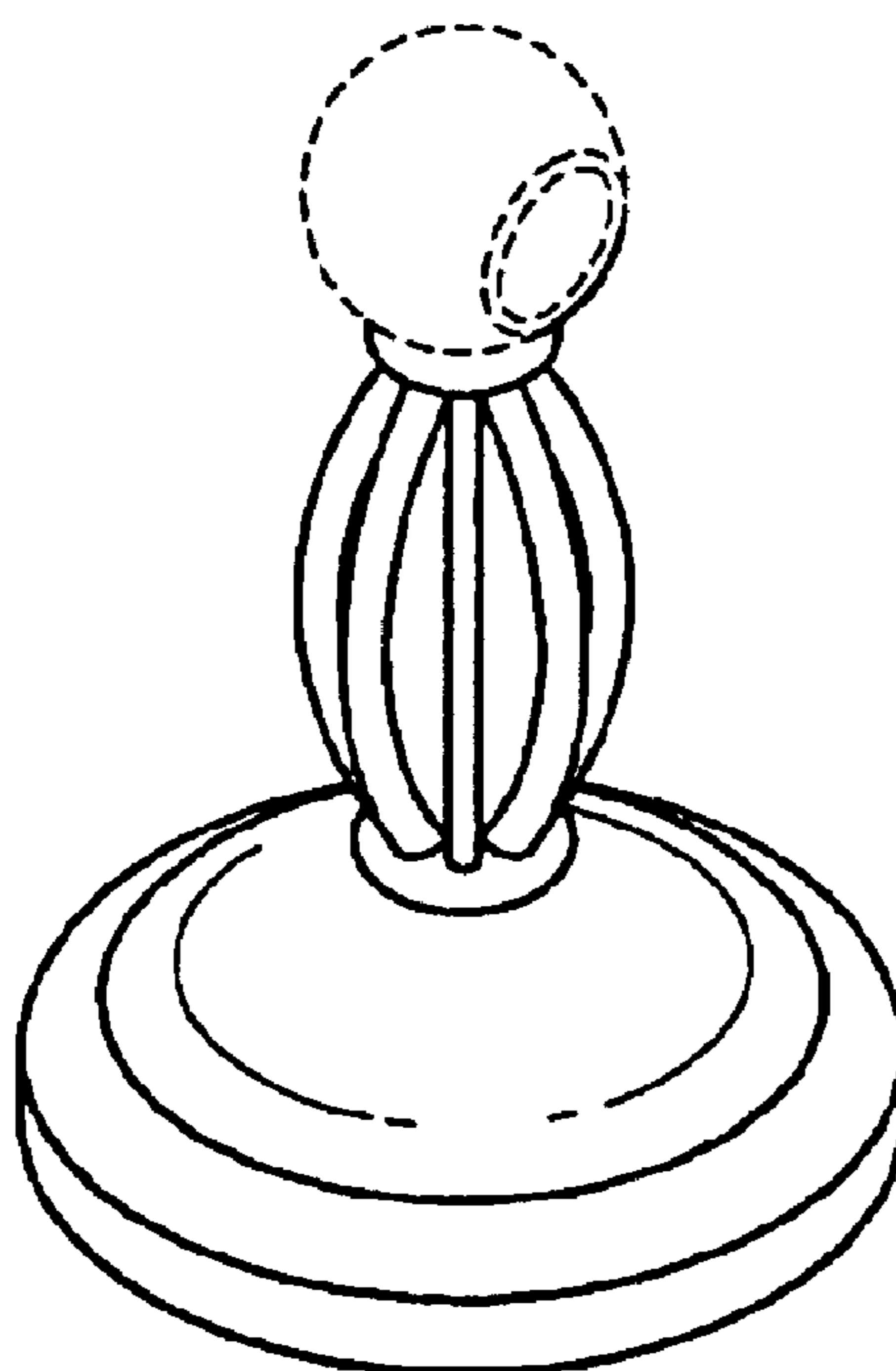

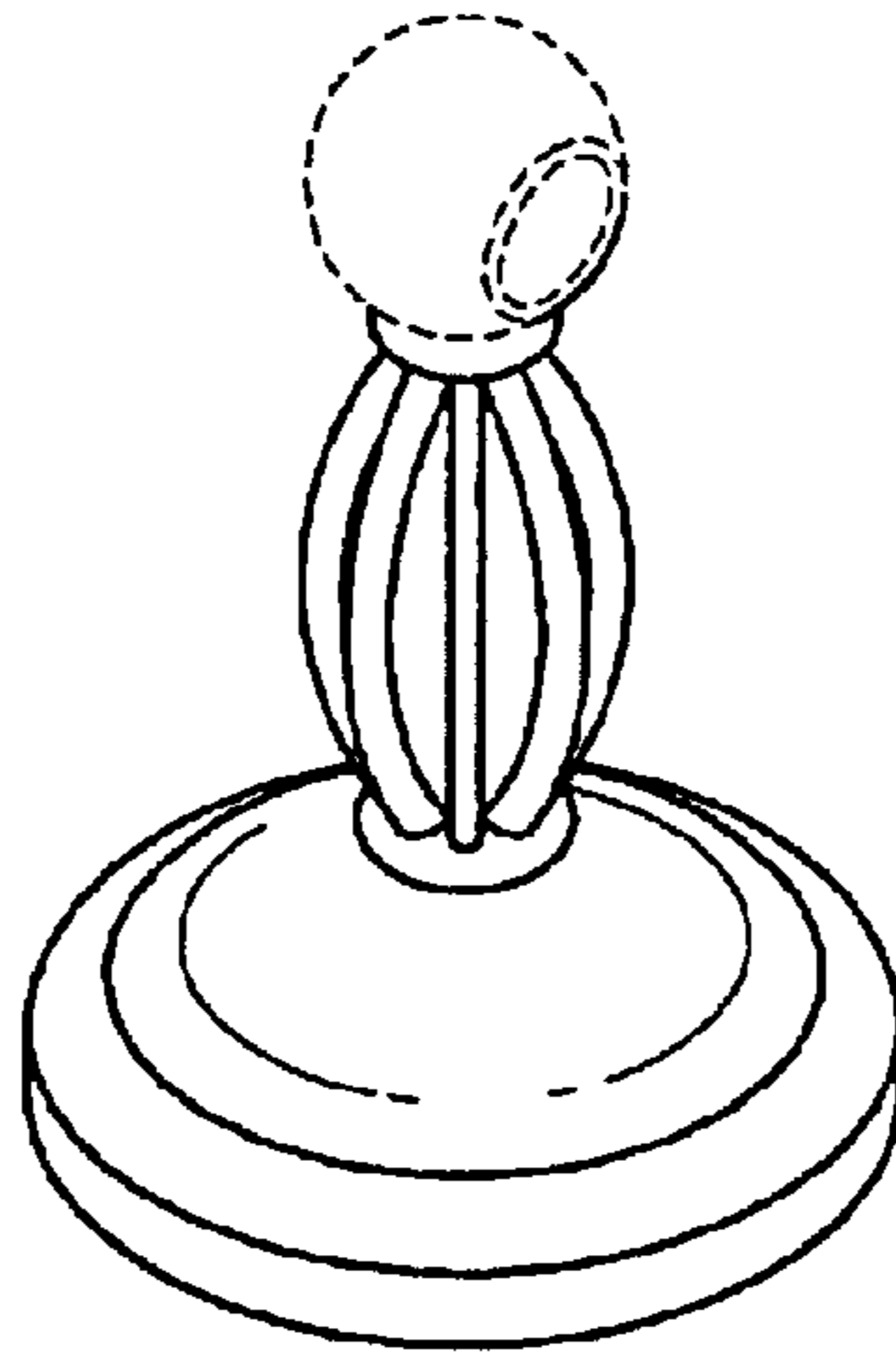

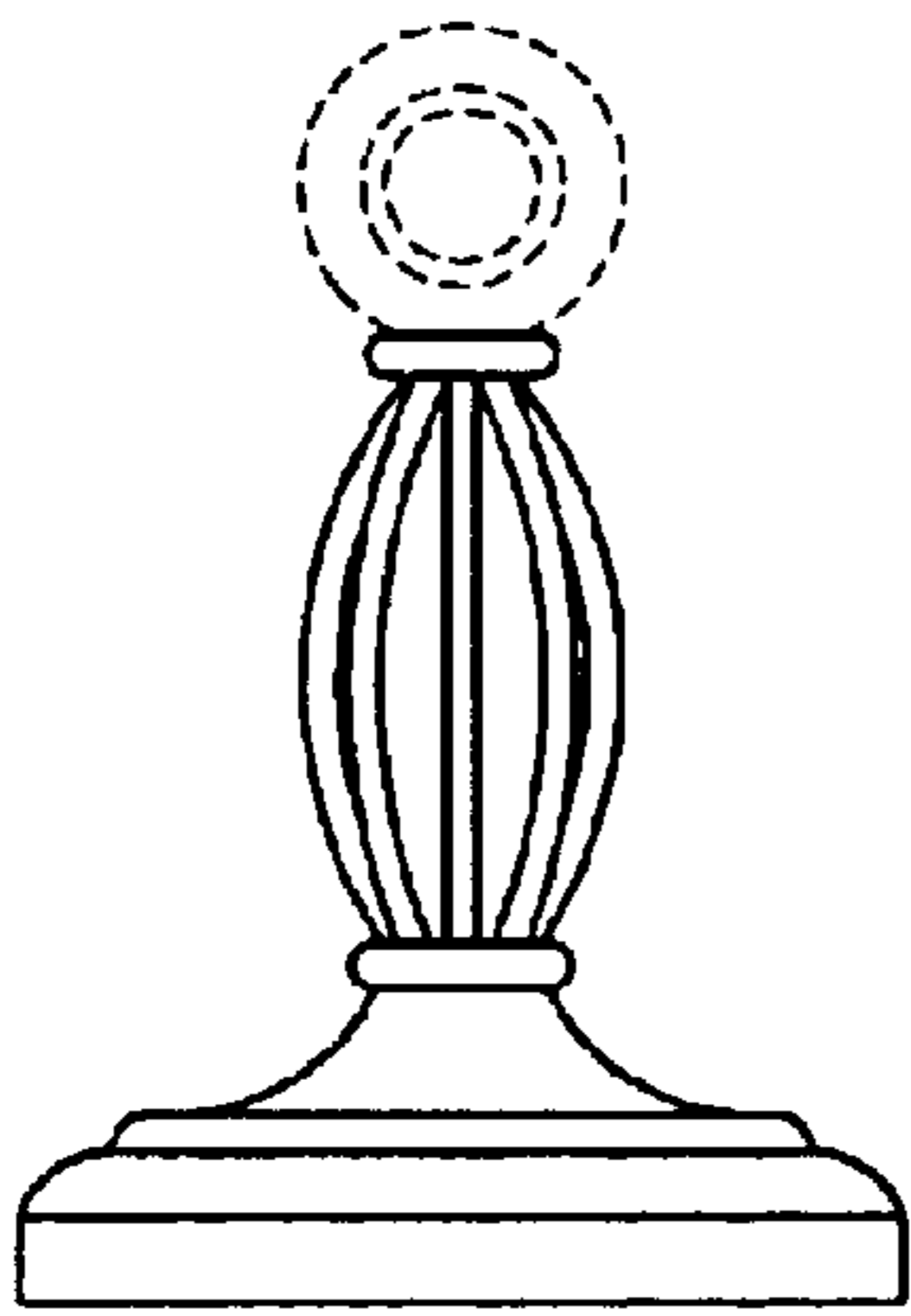
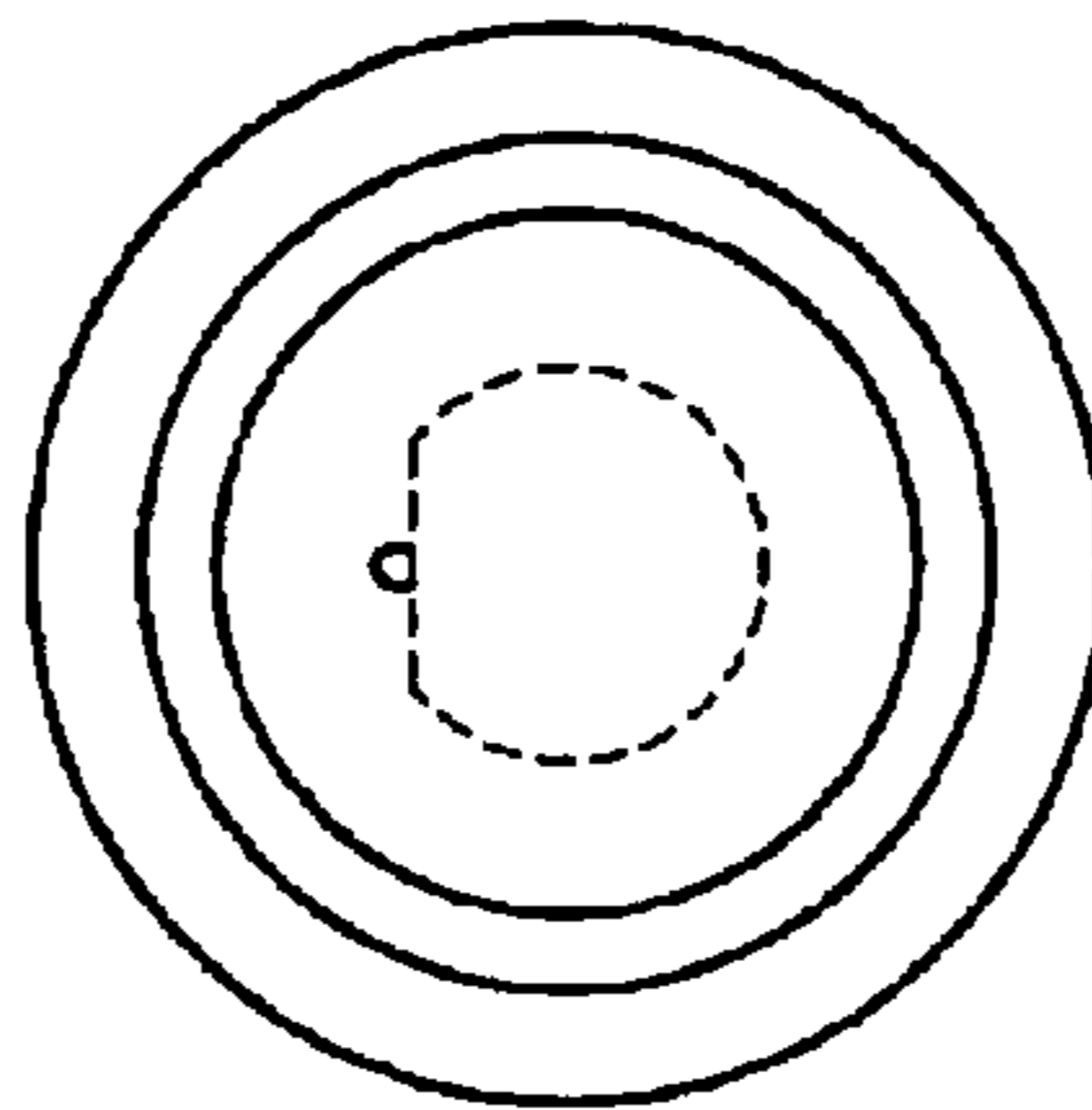

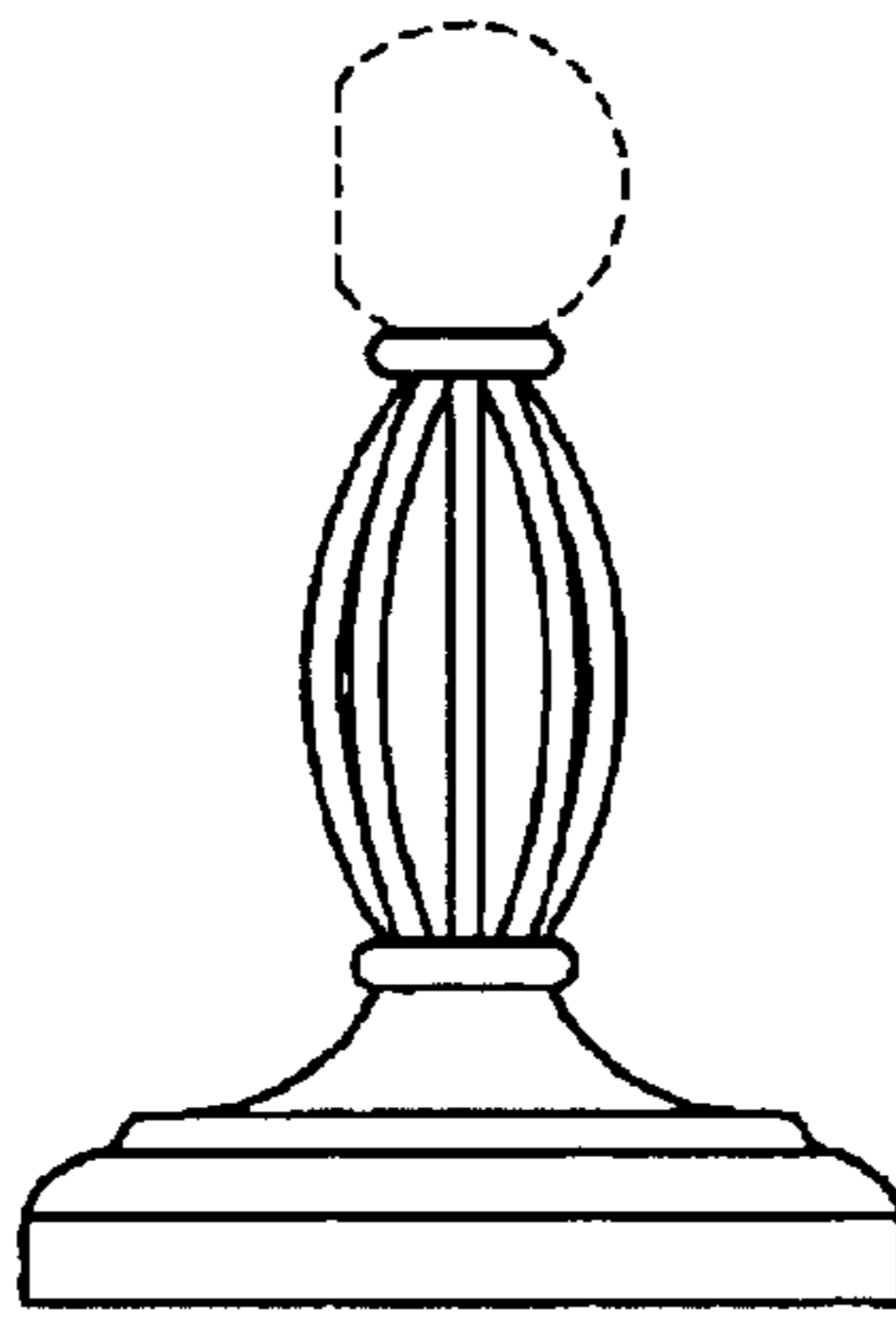

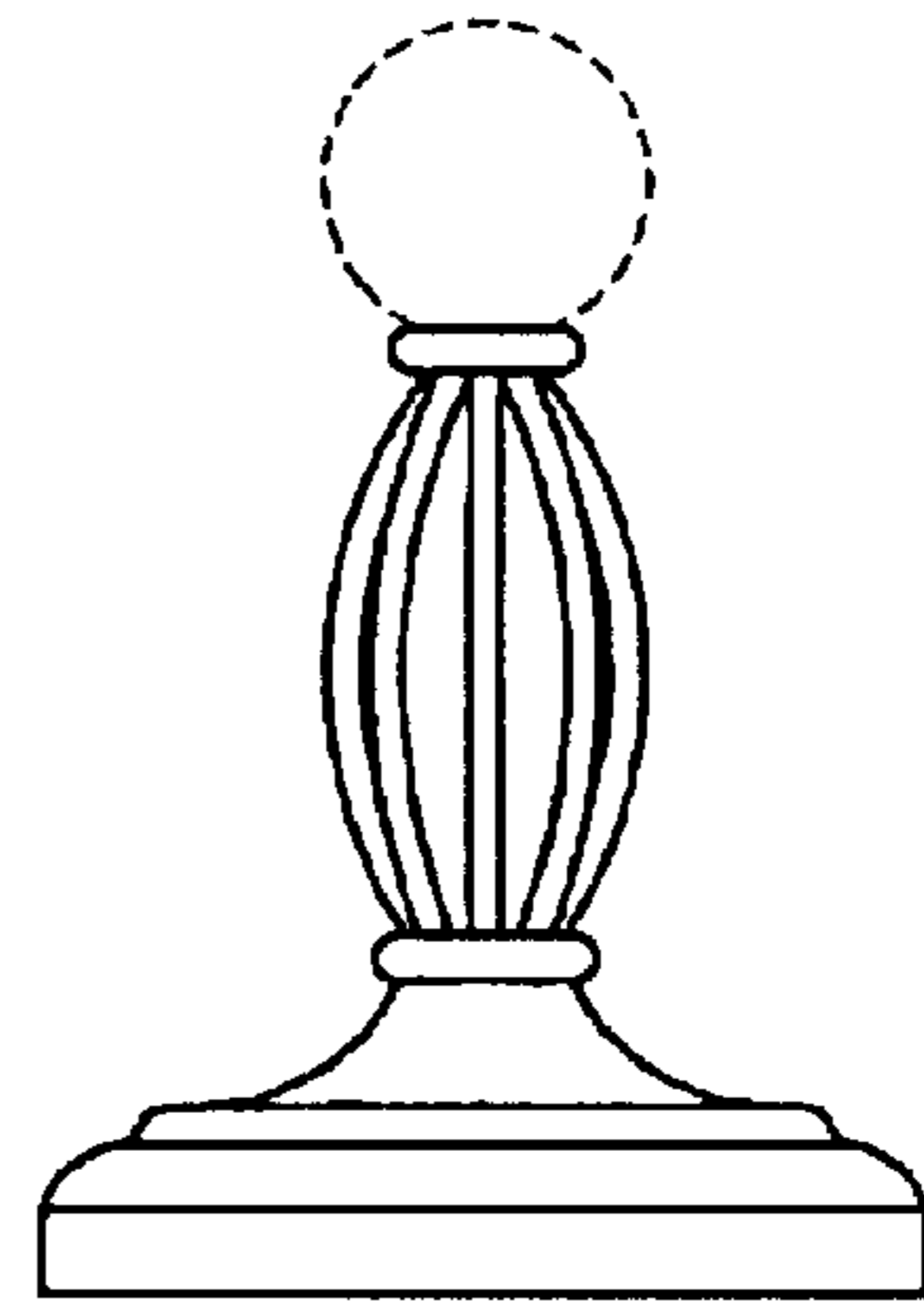
