**DESCRIPTION**

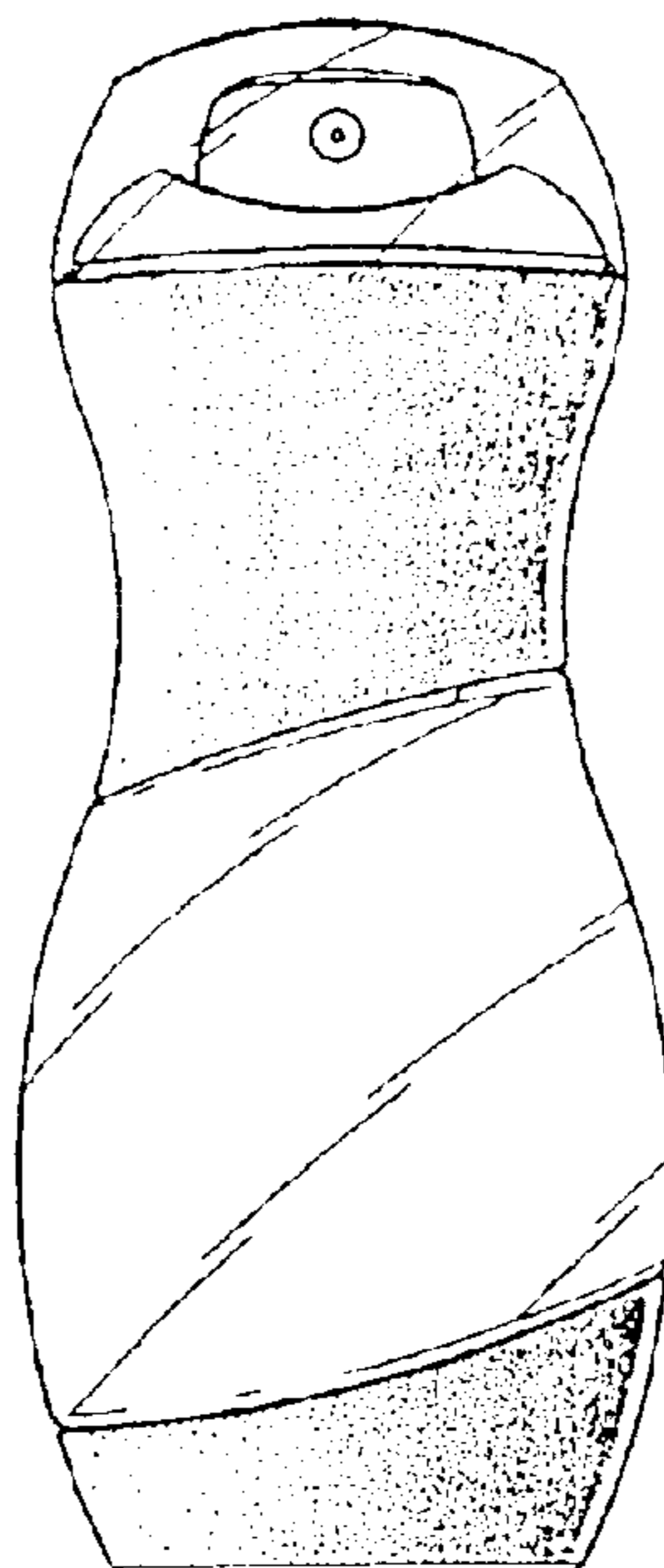
FIG. 1 is a front elevational view of a container embodying our new design;

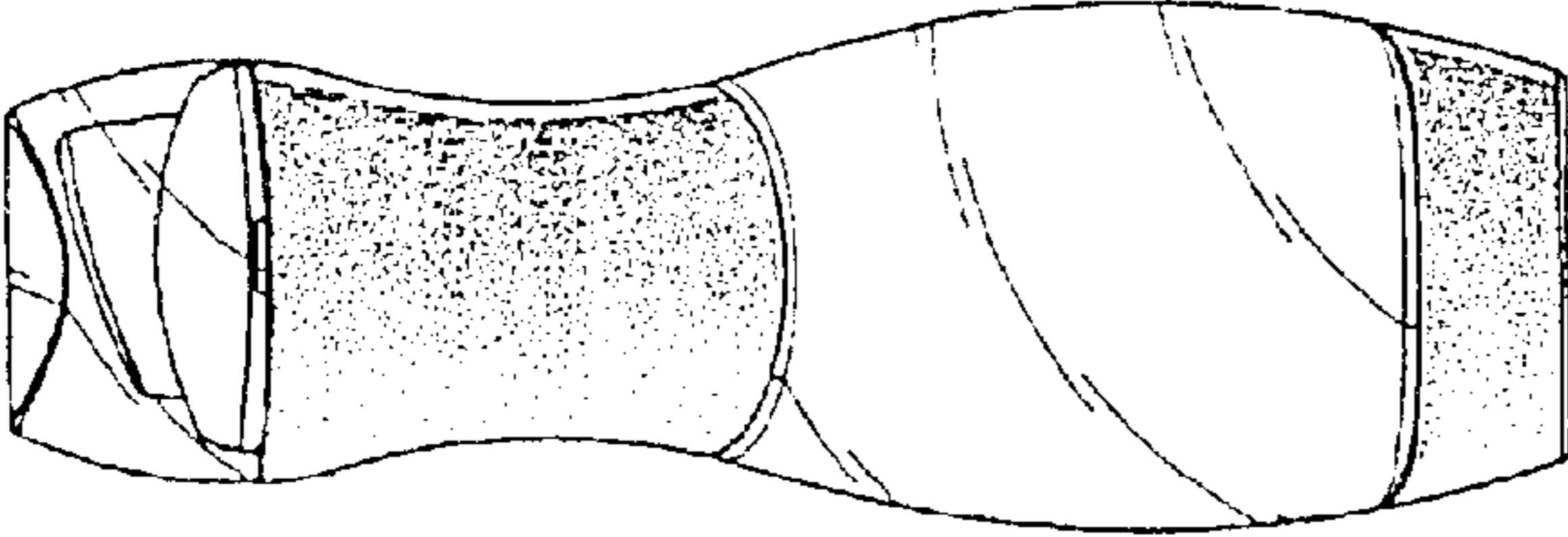

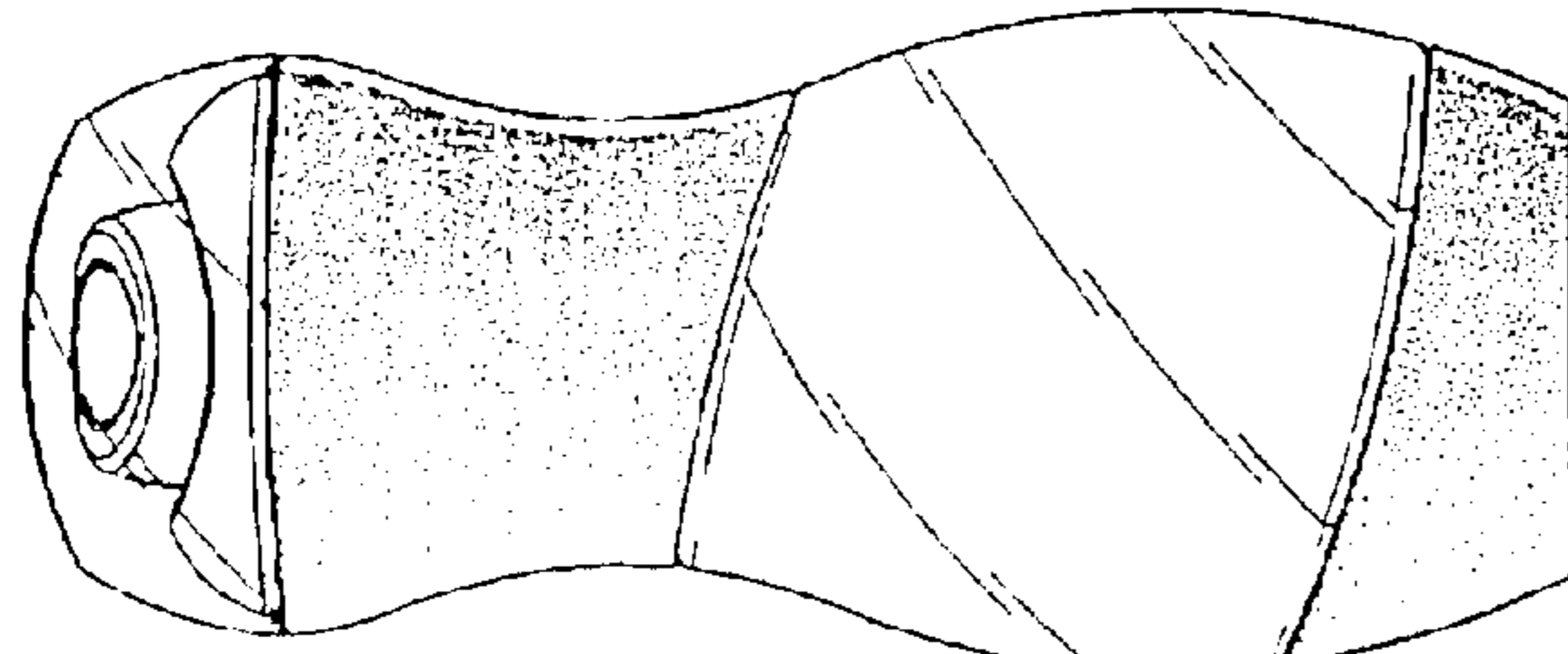

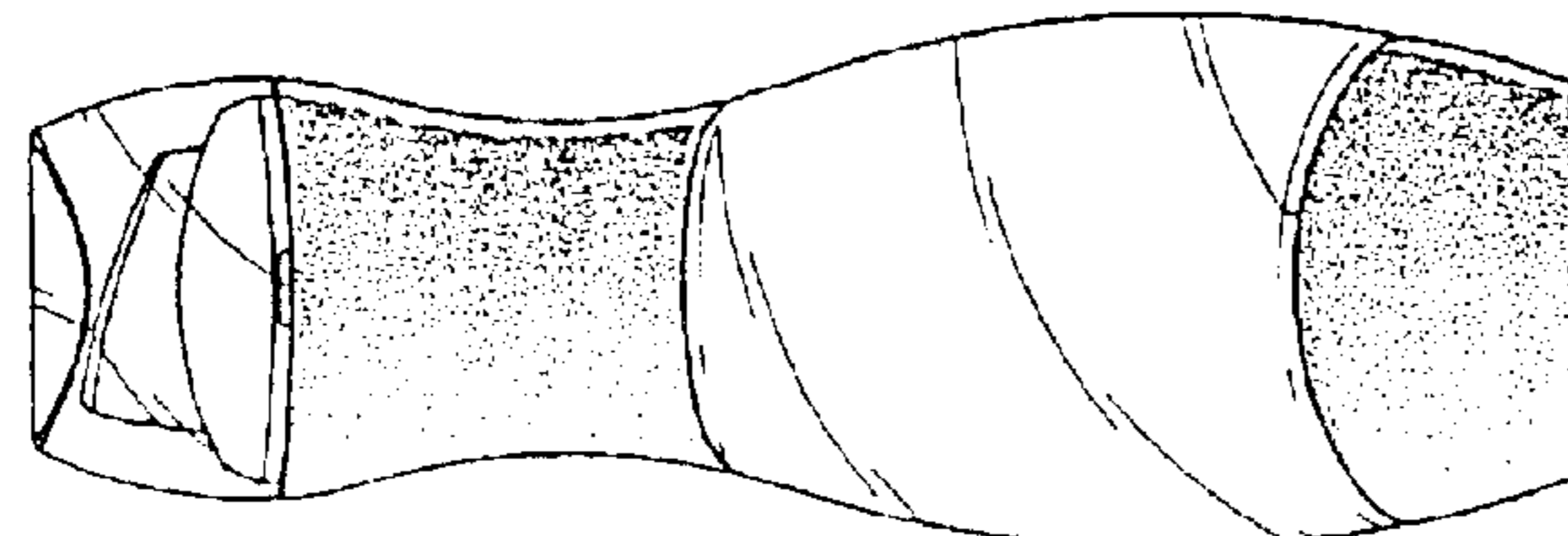

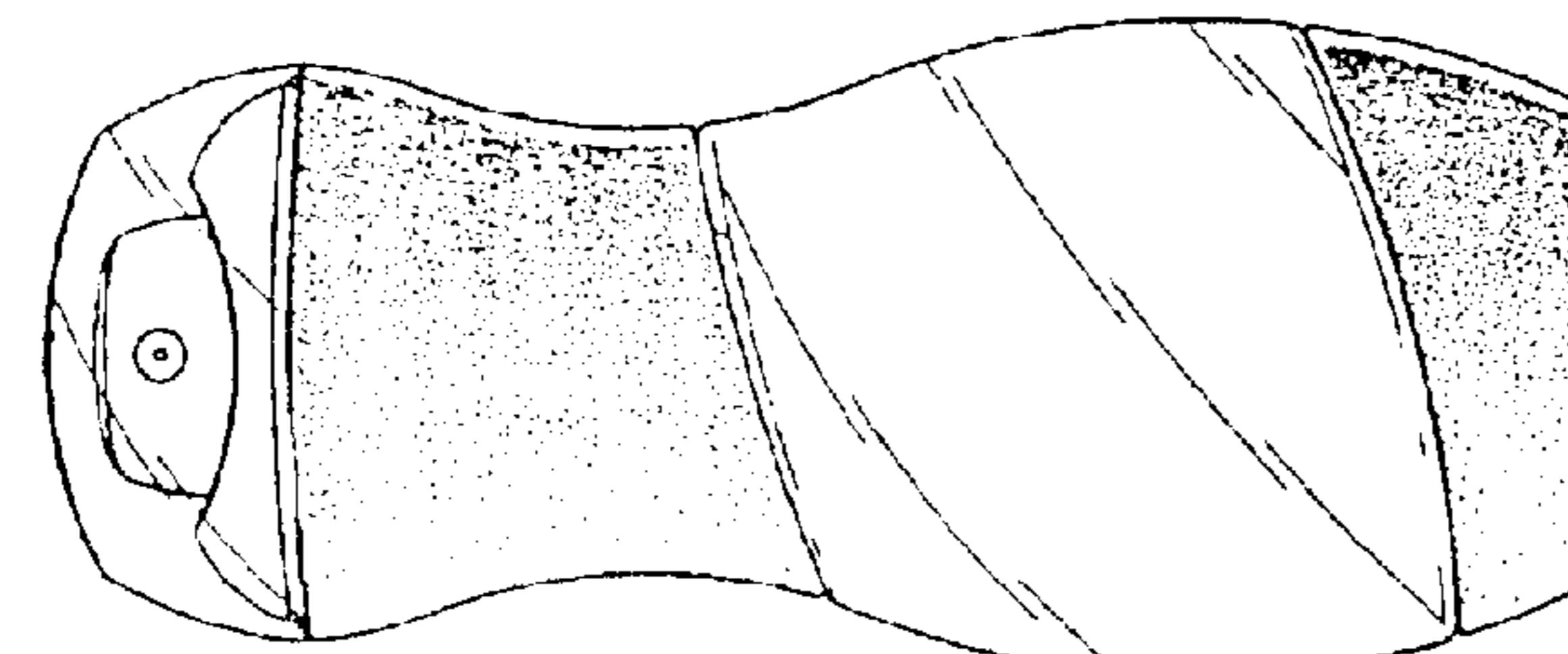

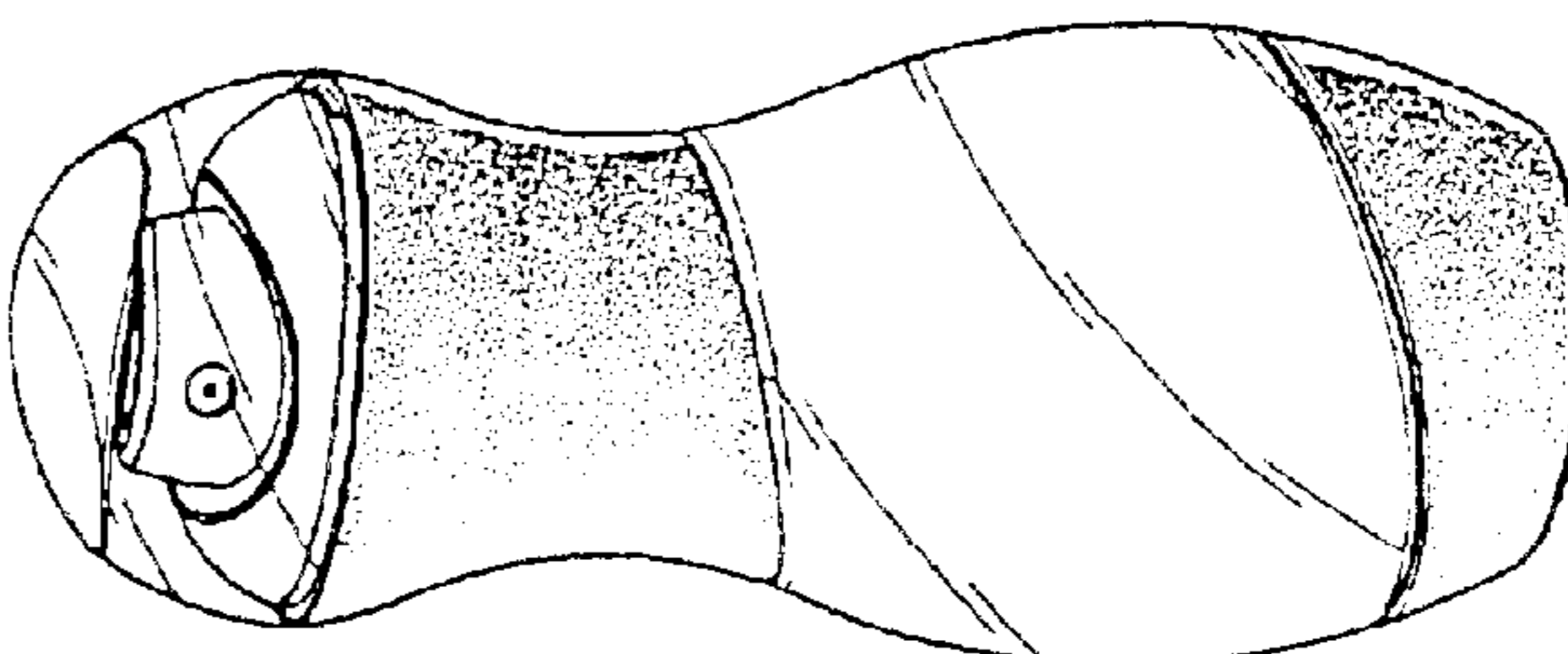

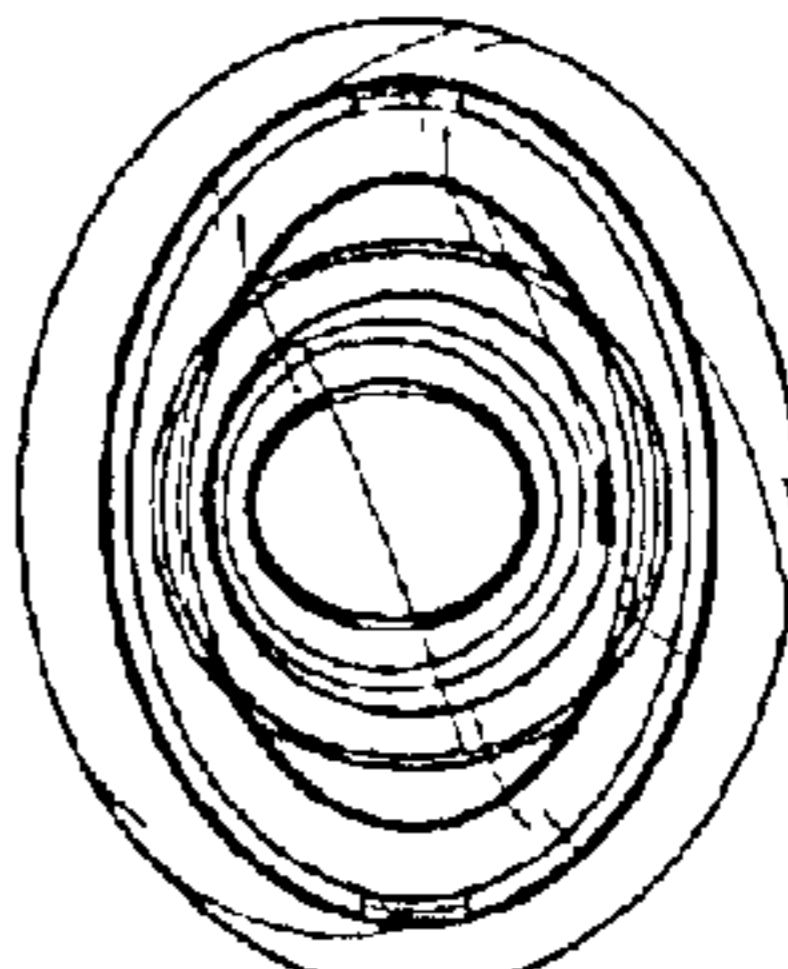
