The ornamental design for a cord end cover, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a cord end cover showing my new design;

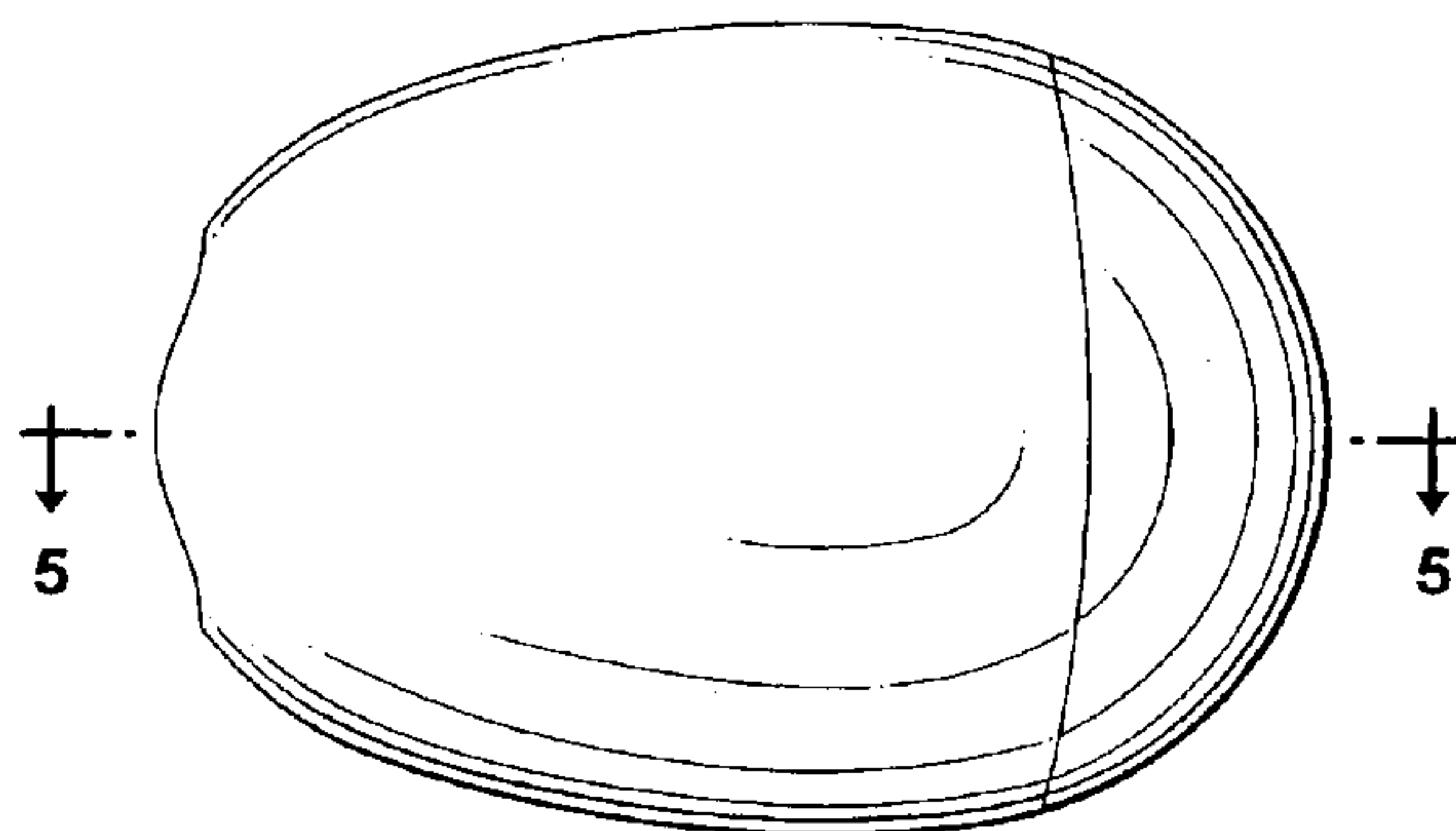


FIG. 2 is a top plan view thereof;

FIG. 19 is a left-side elevation view thereof;

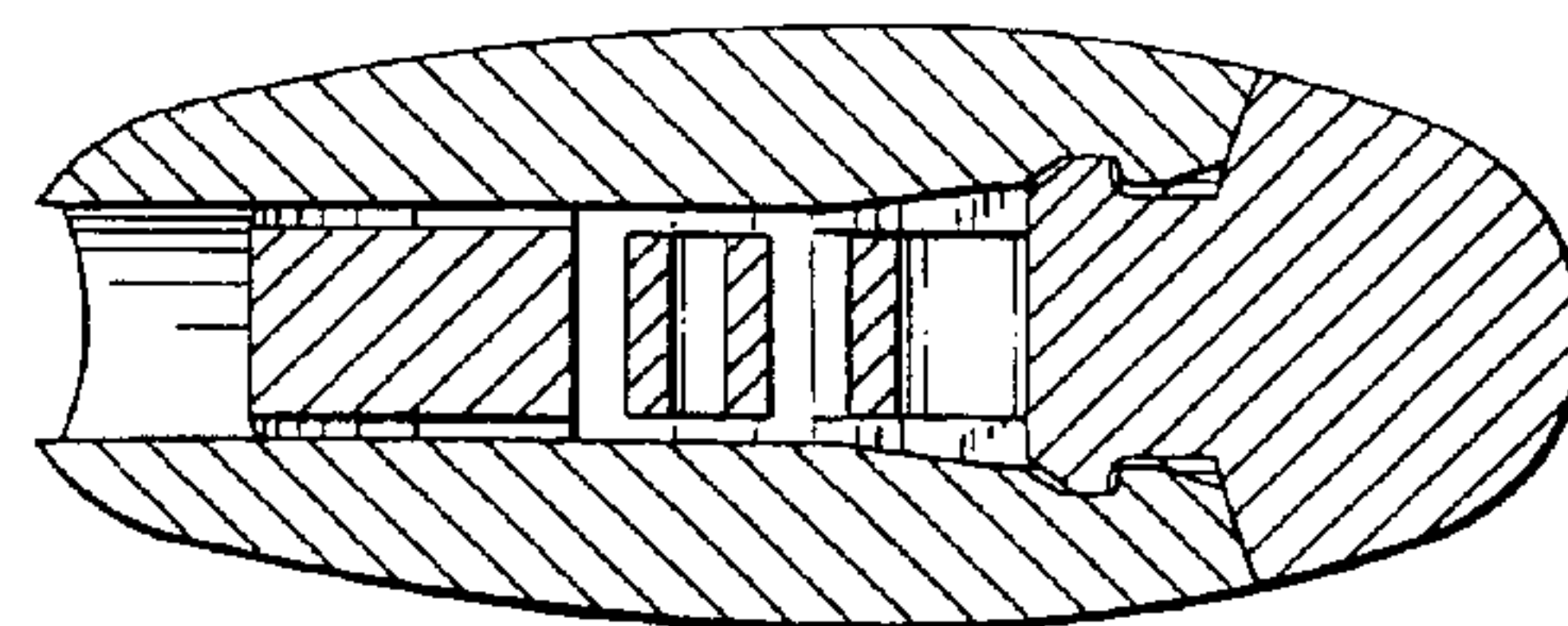
FIG. 20 is a cross-sectional view thereof, taken along line 20—20 in FIG. 16;

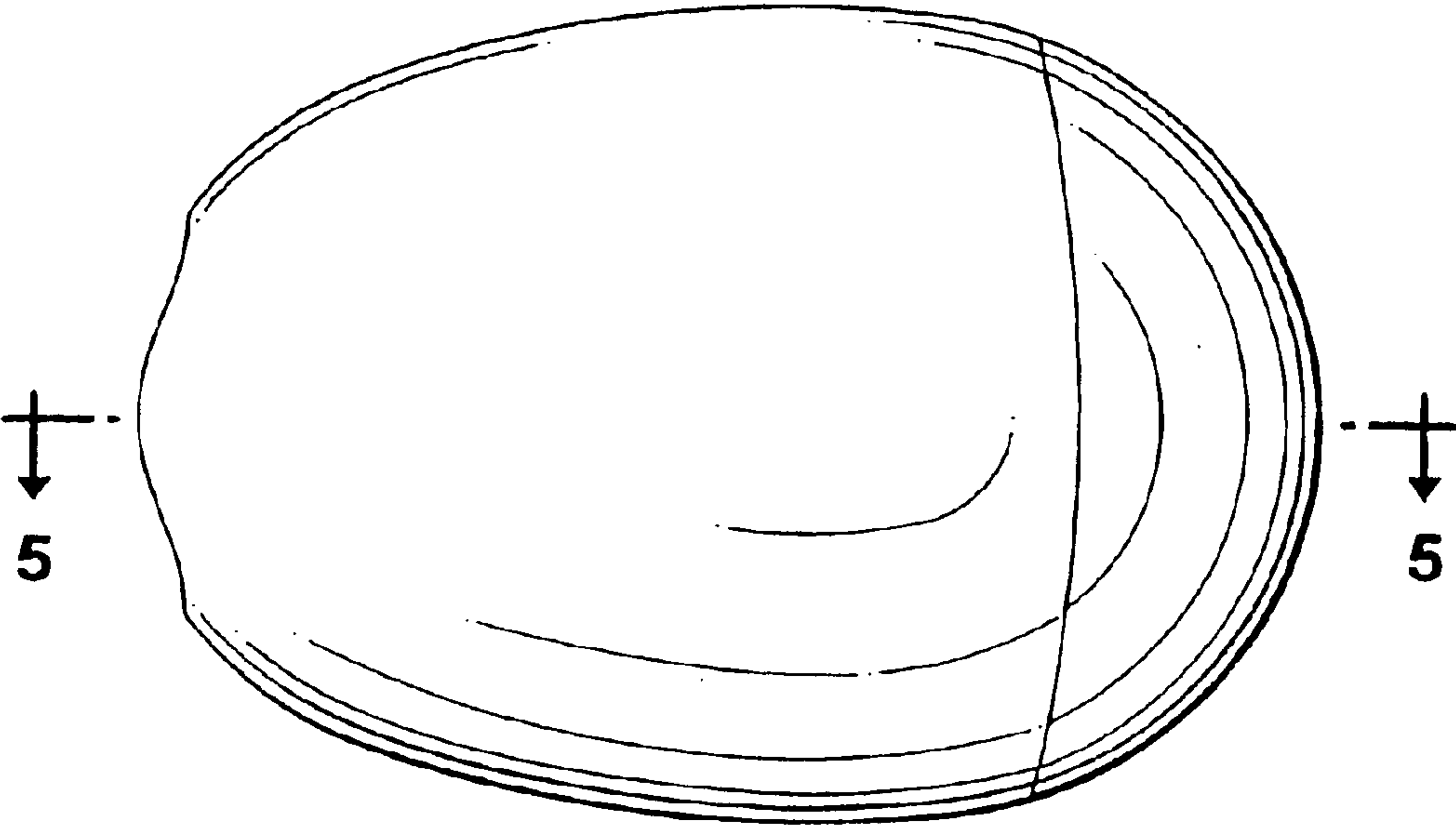

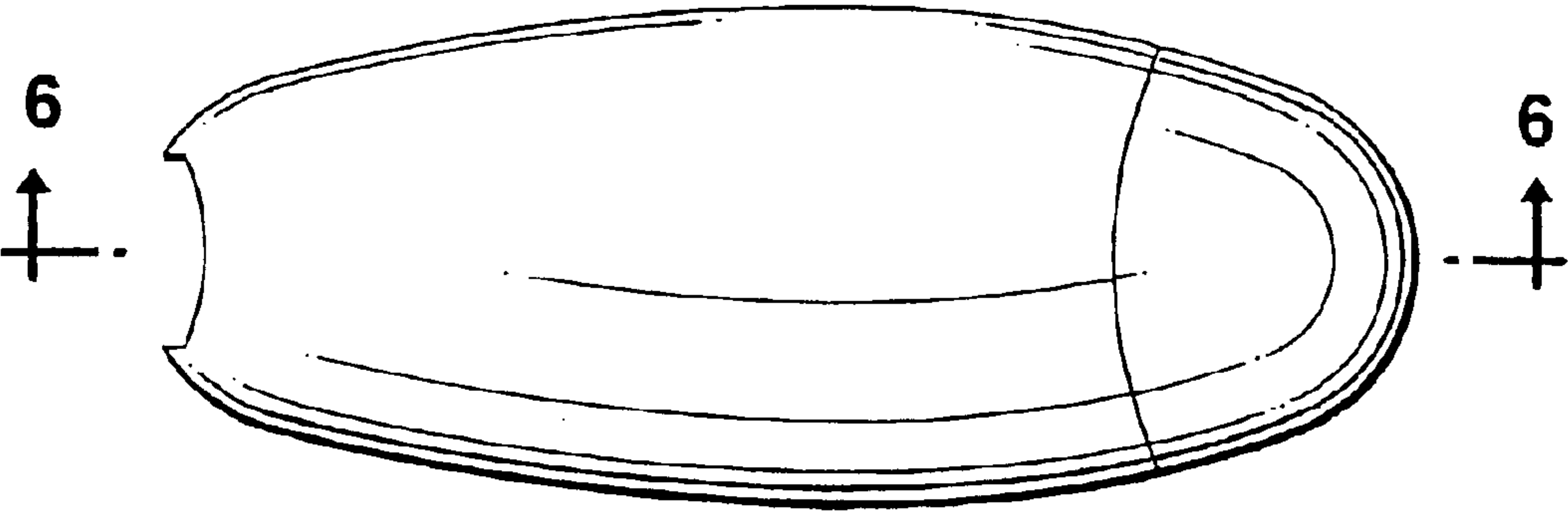

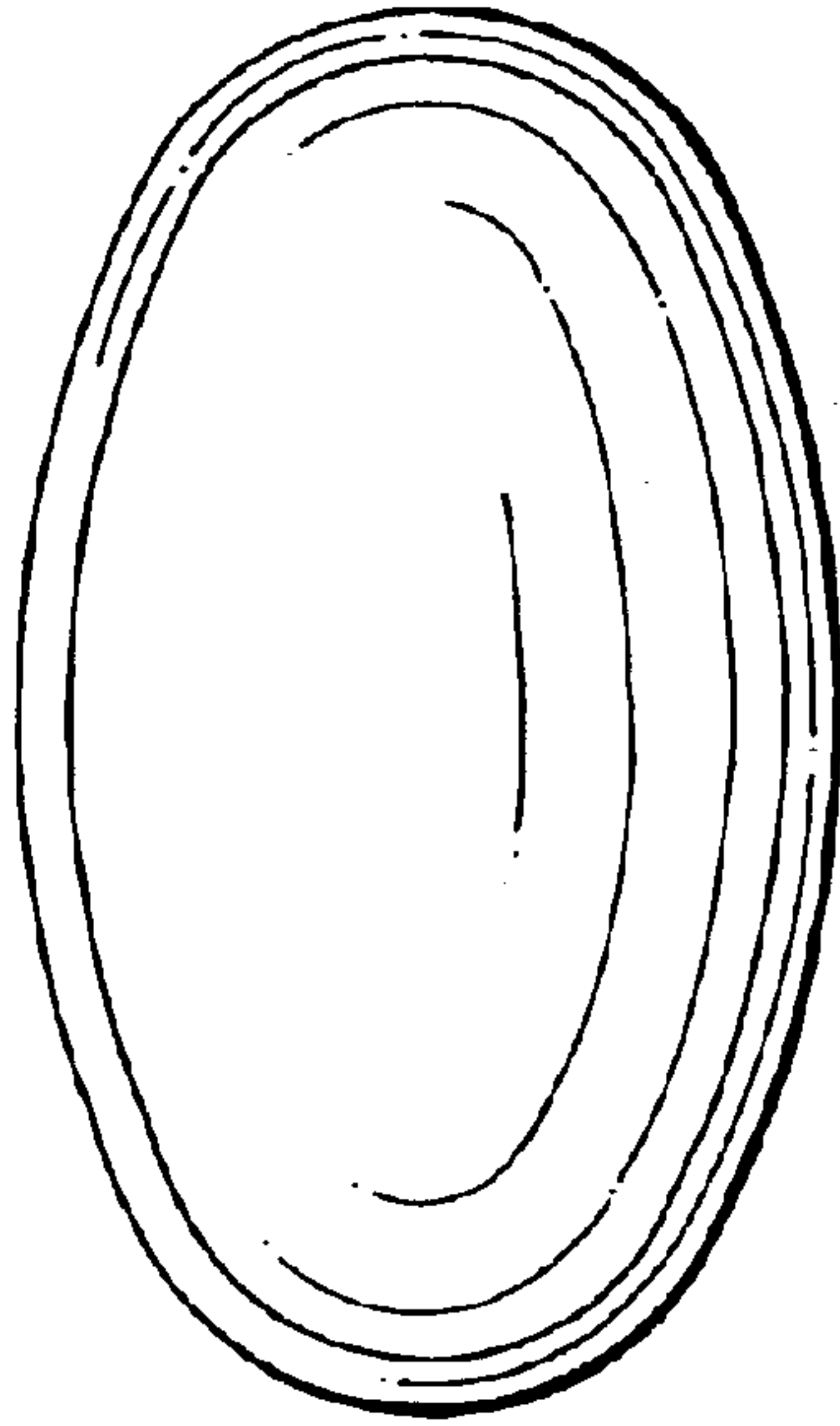

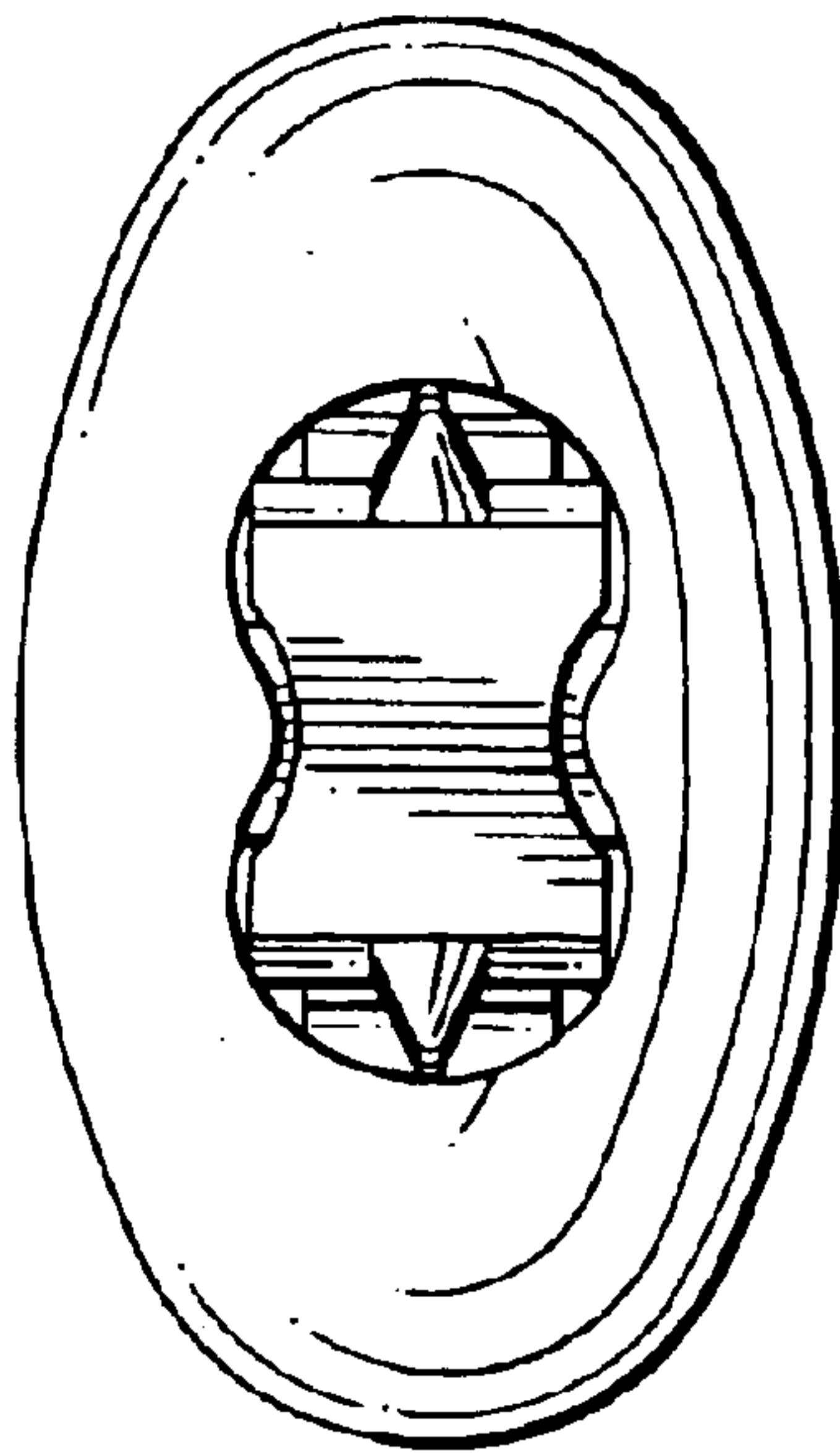

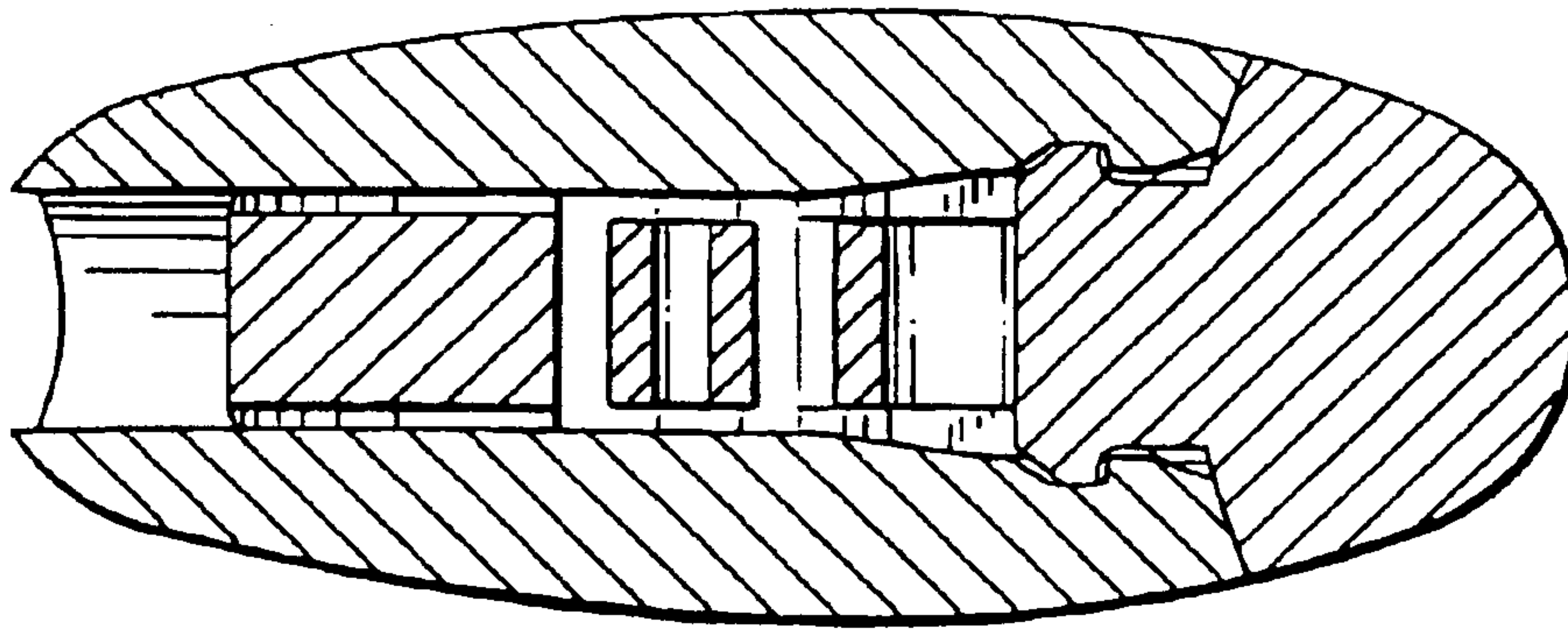

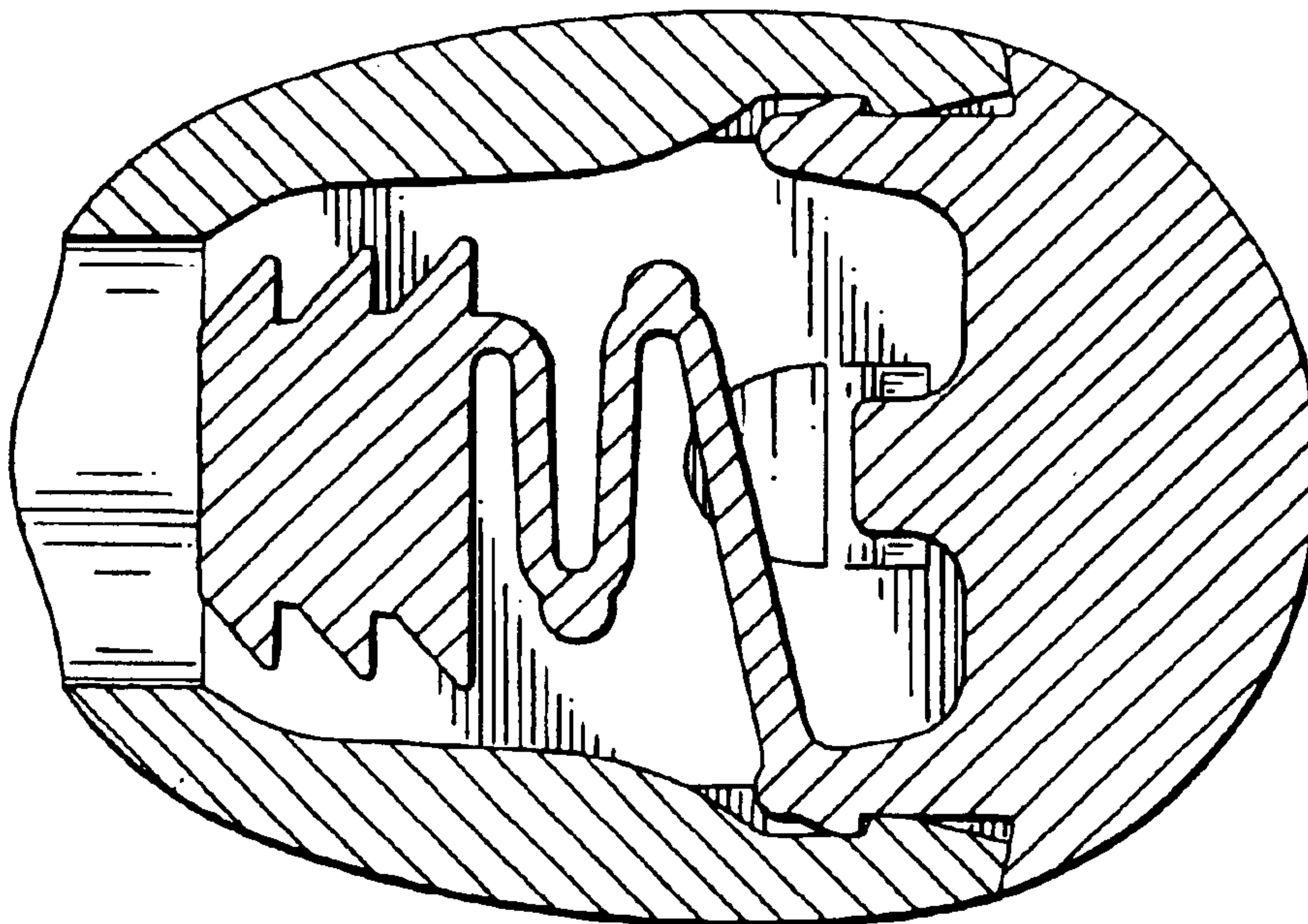

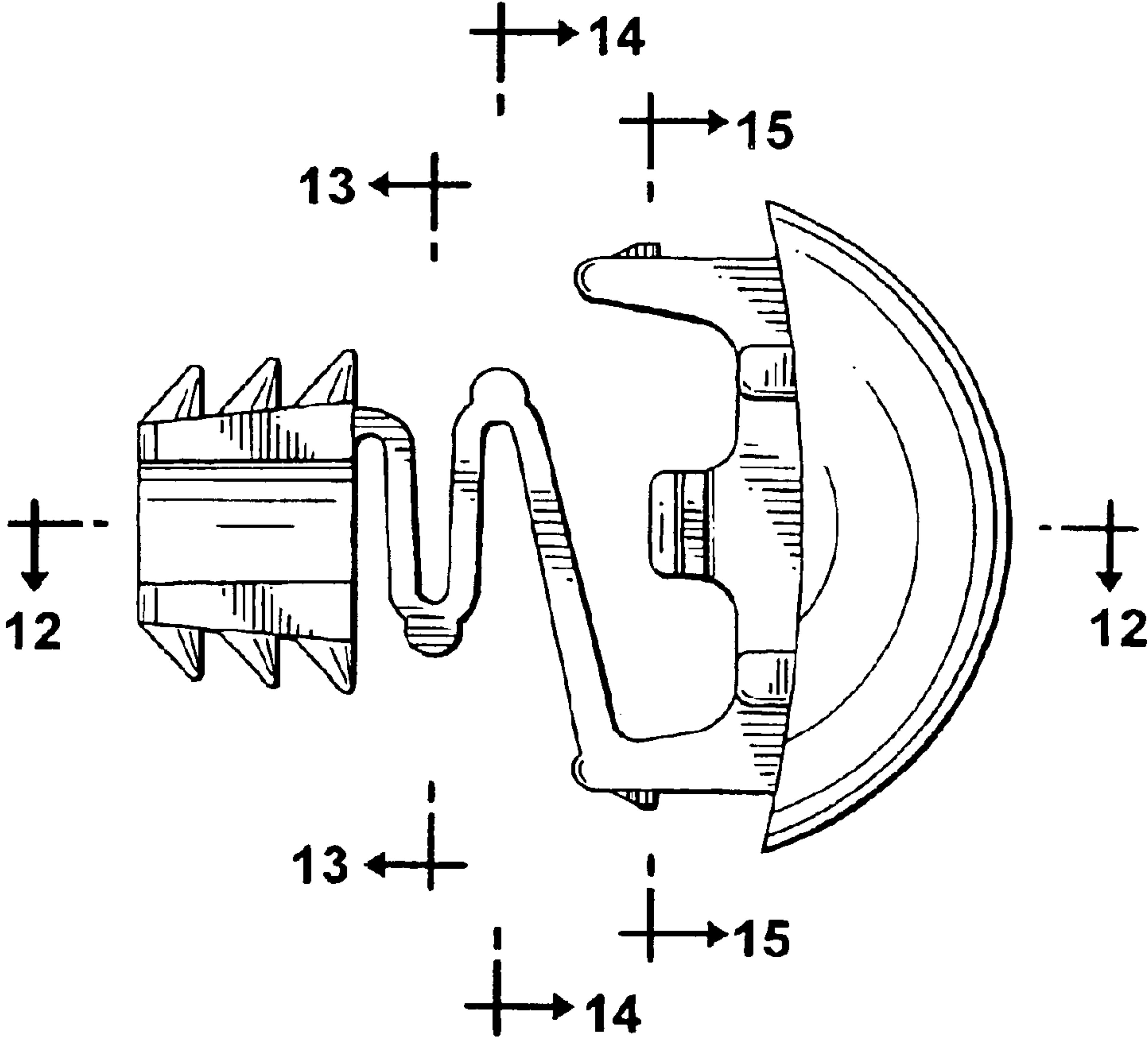

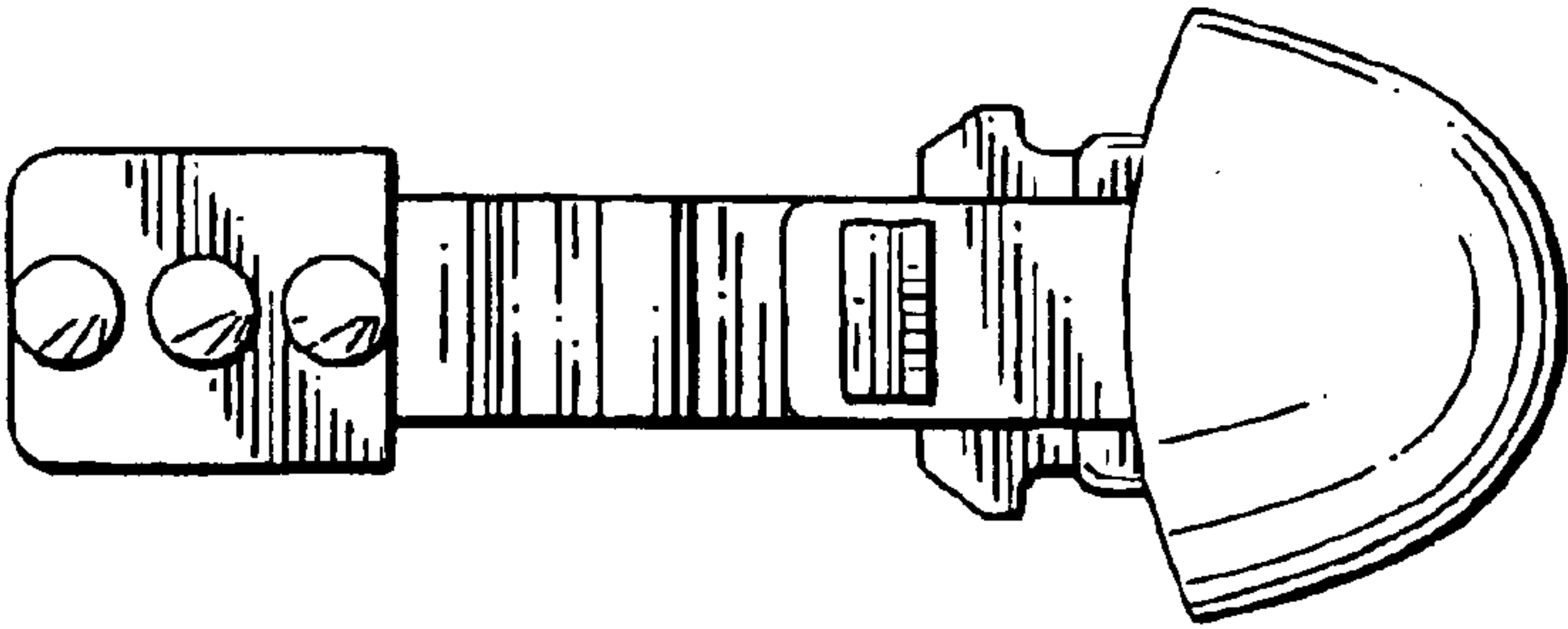

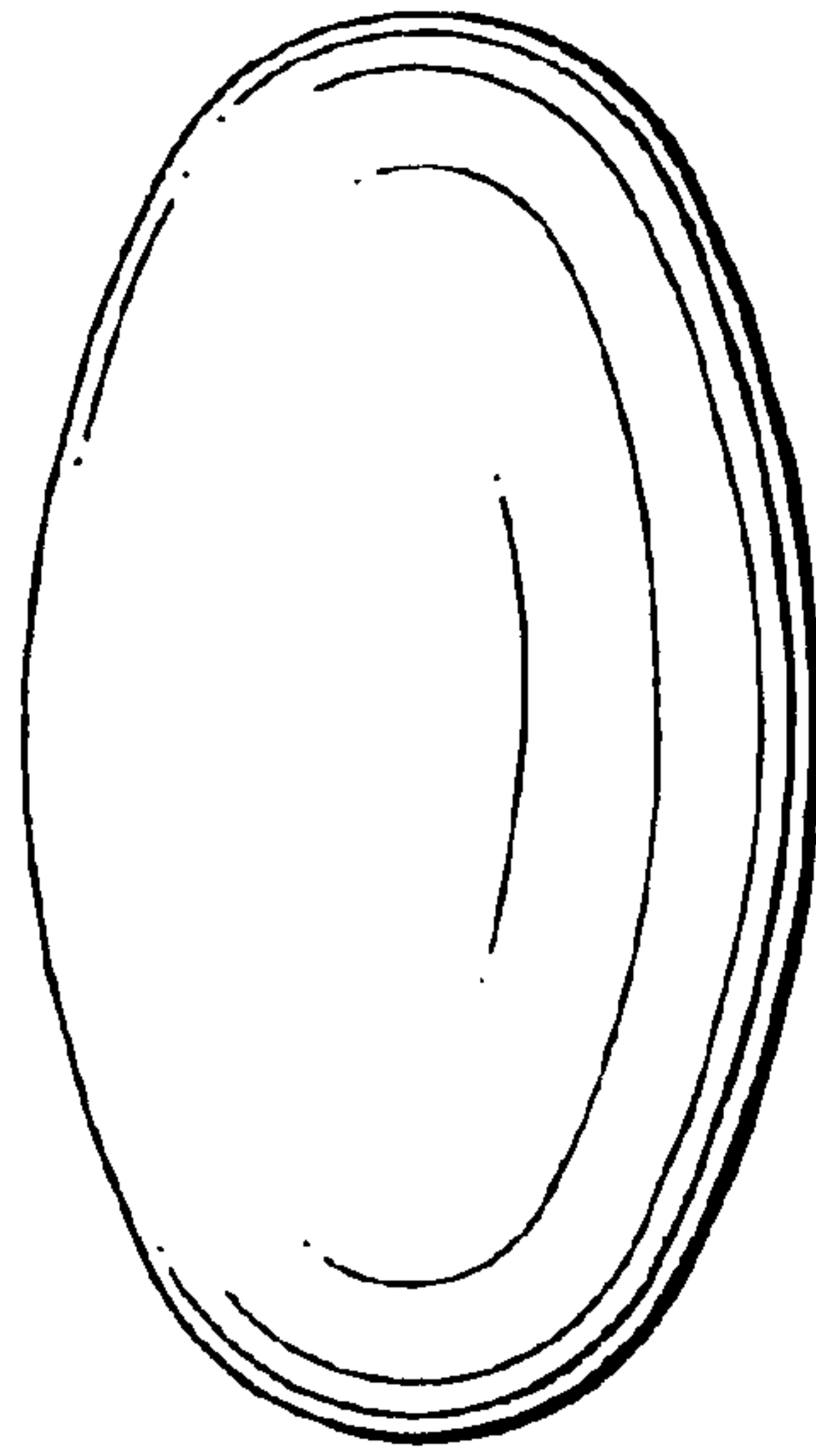

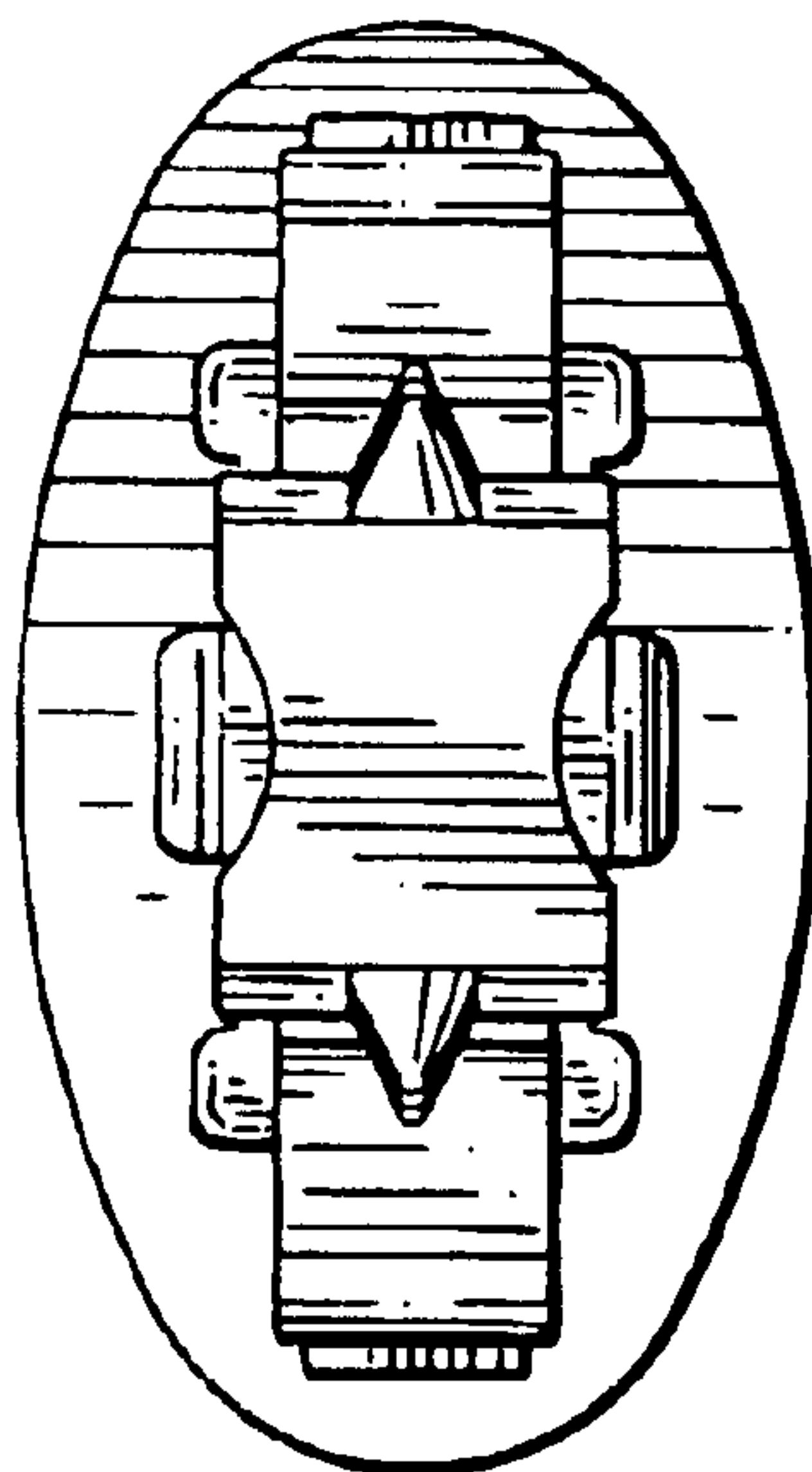

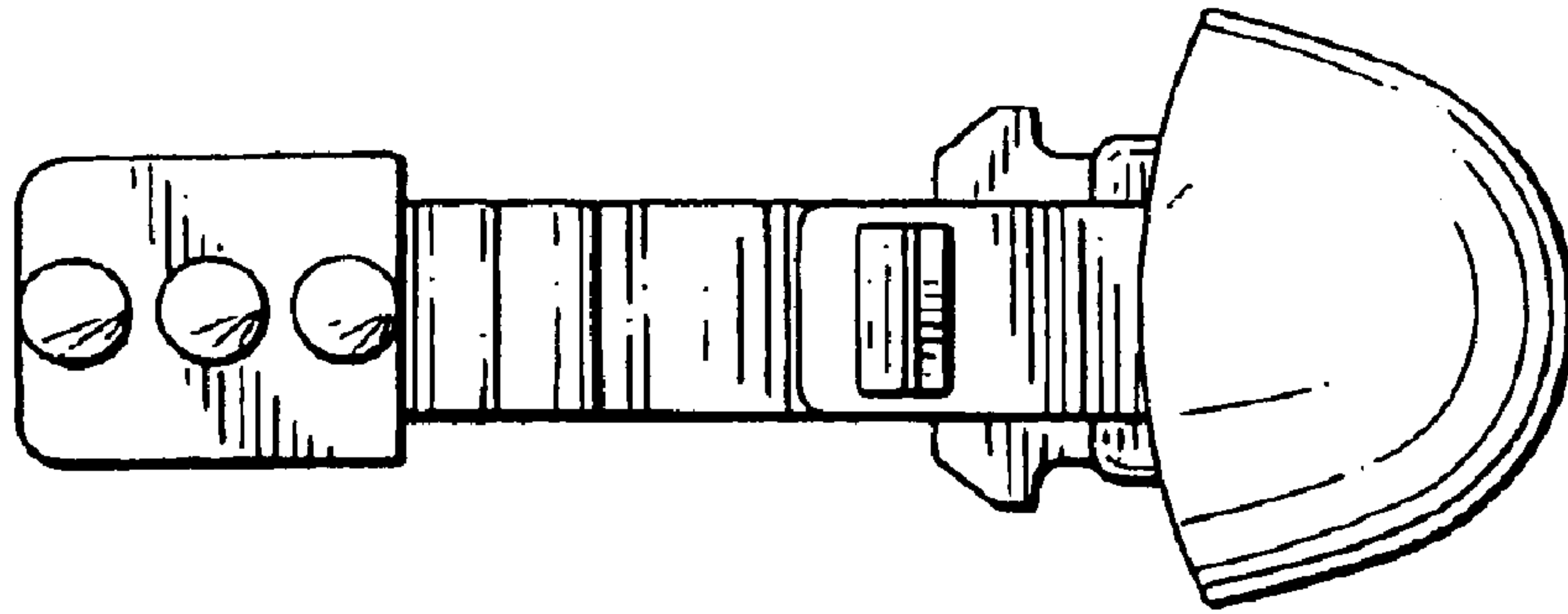

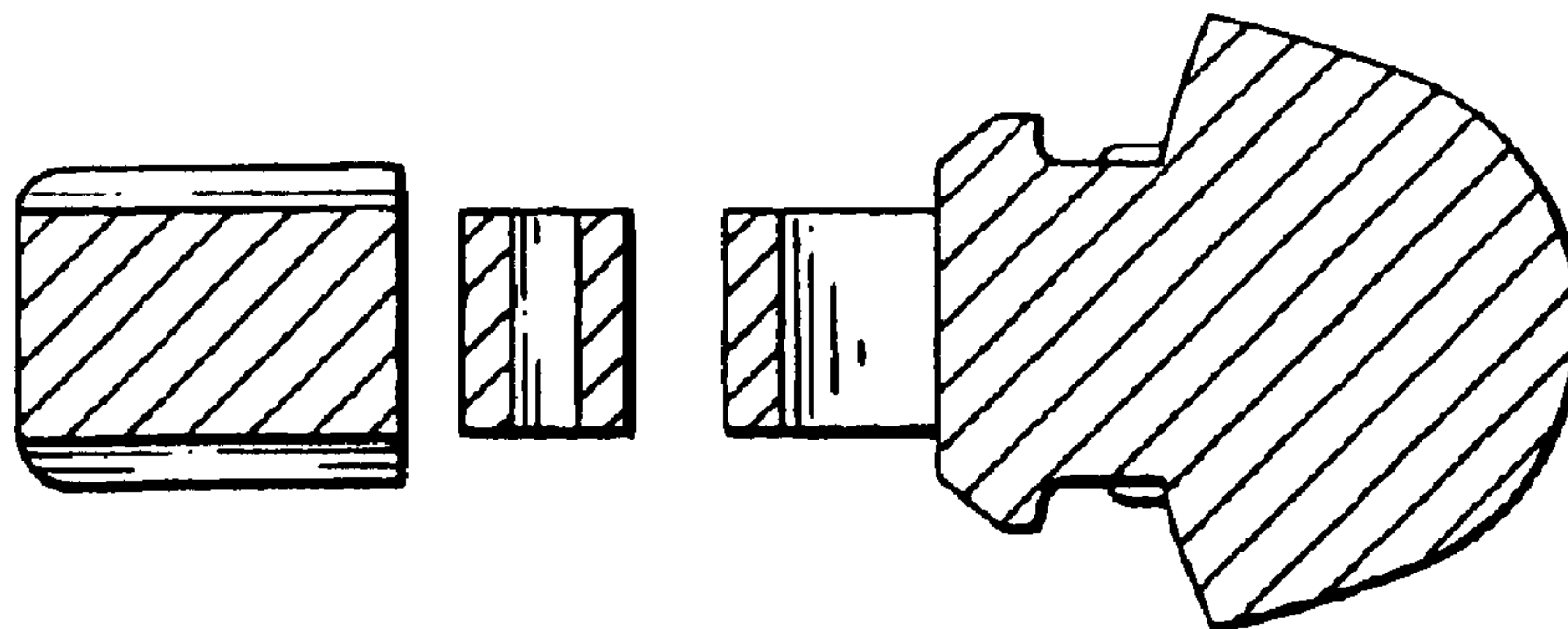

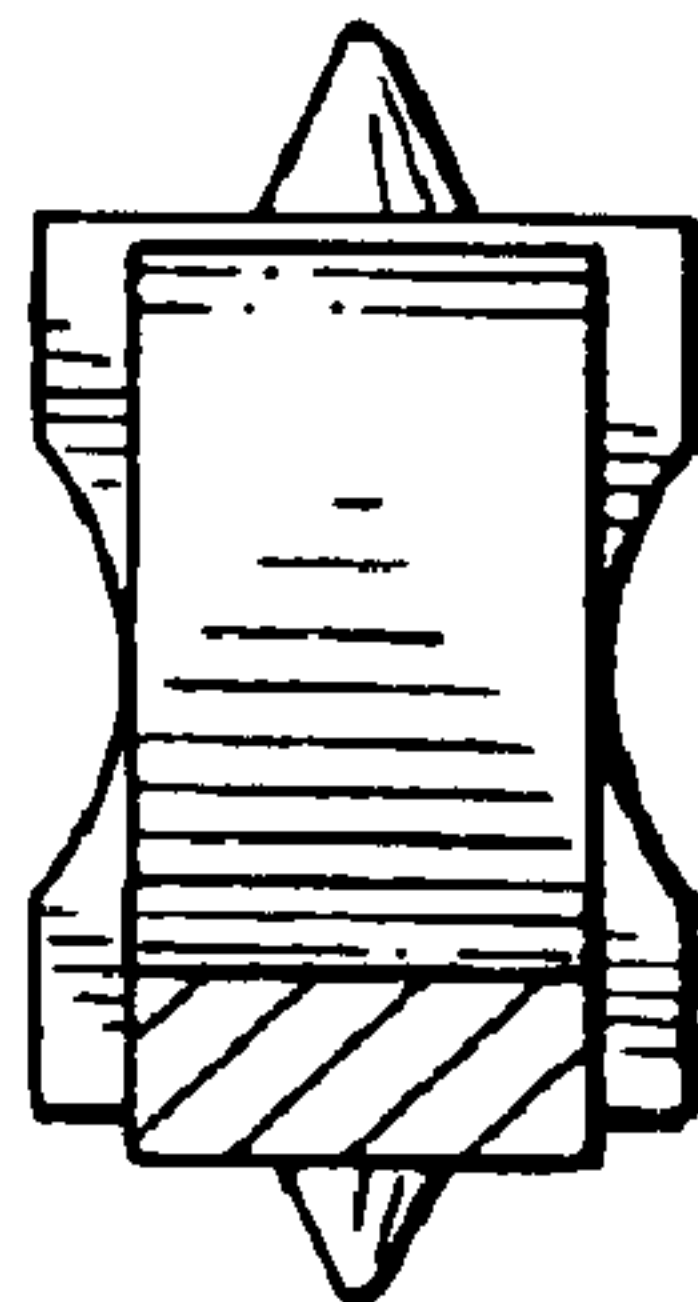

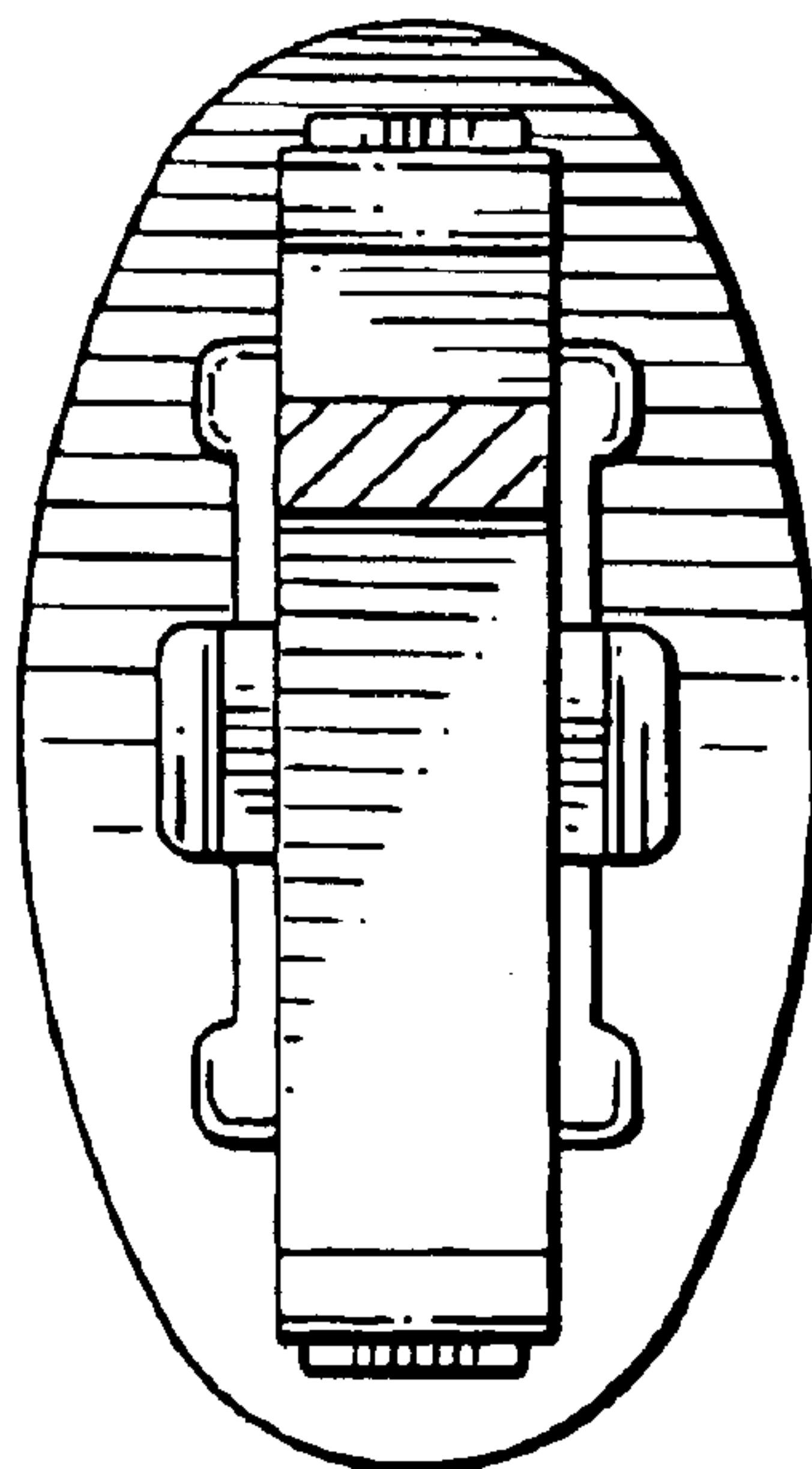

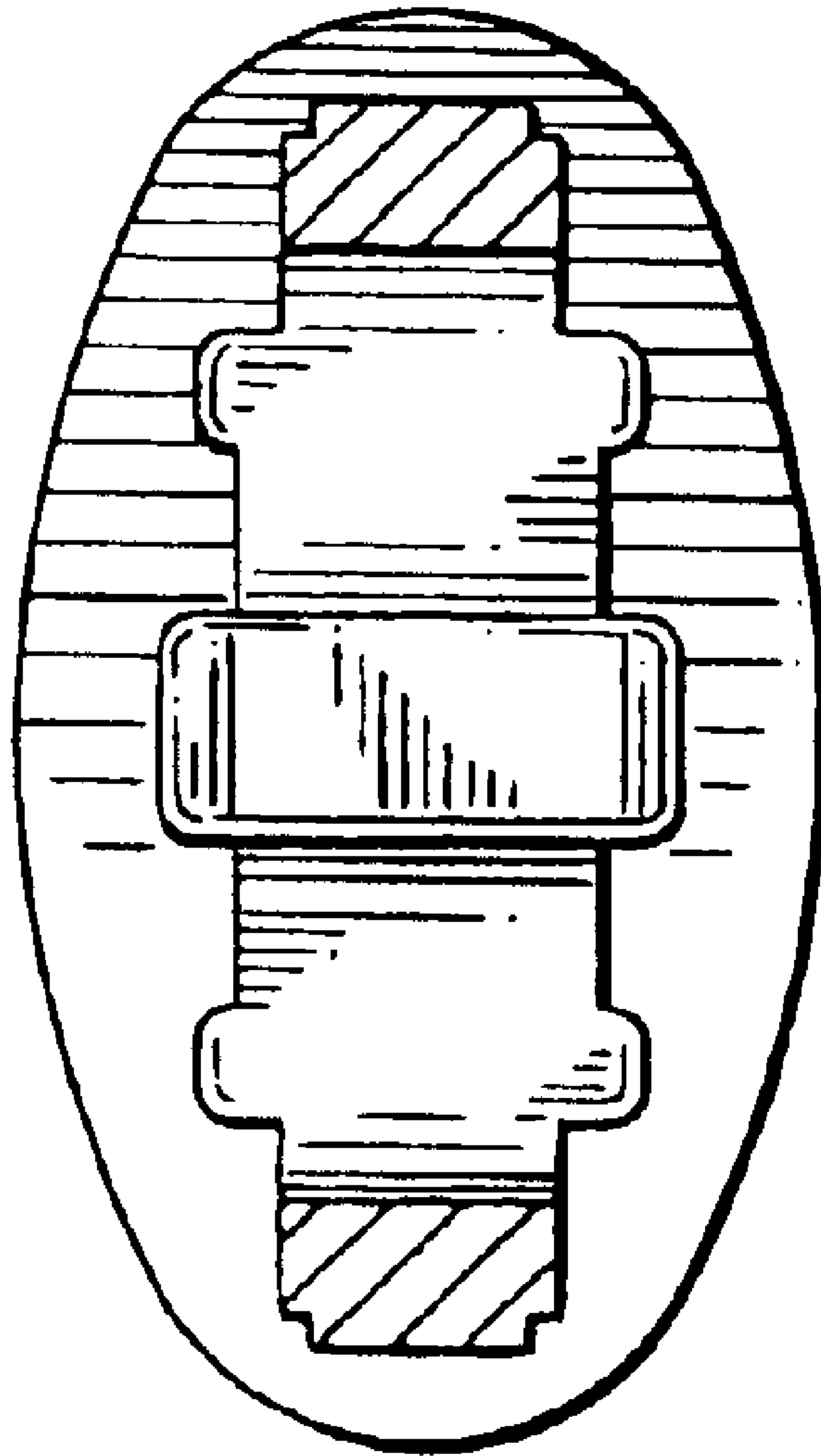

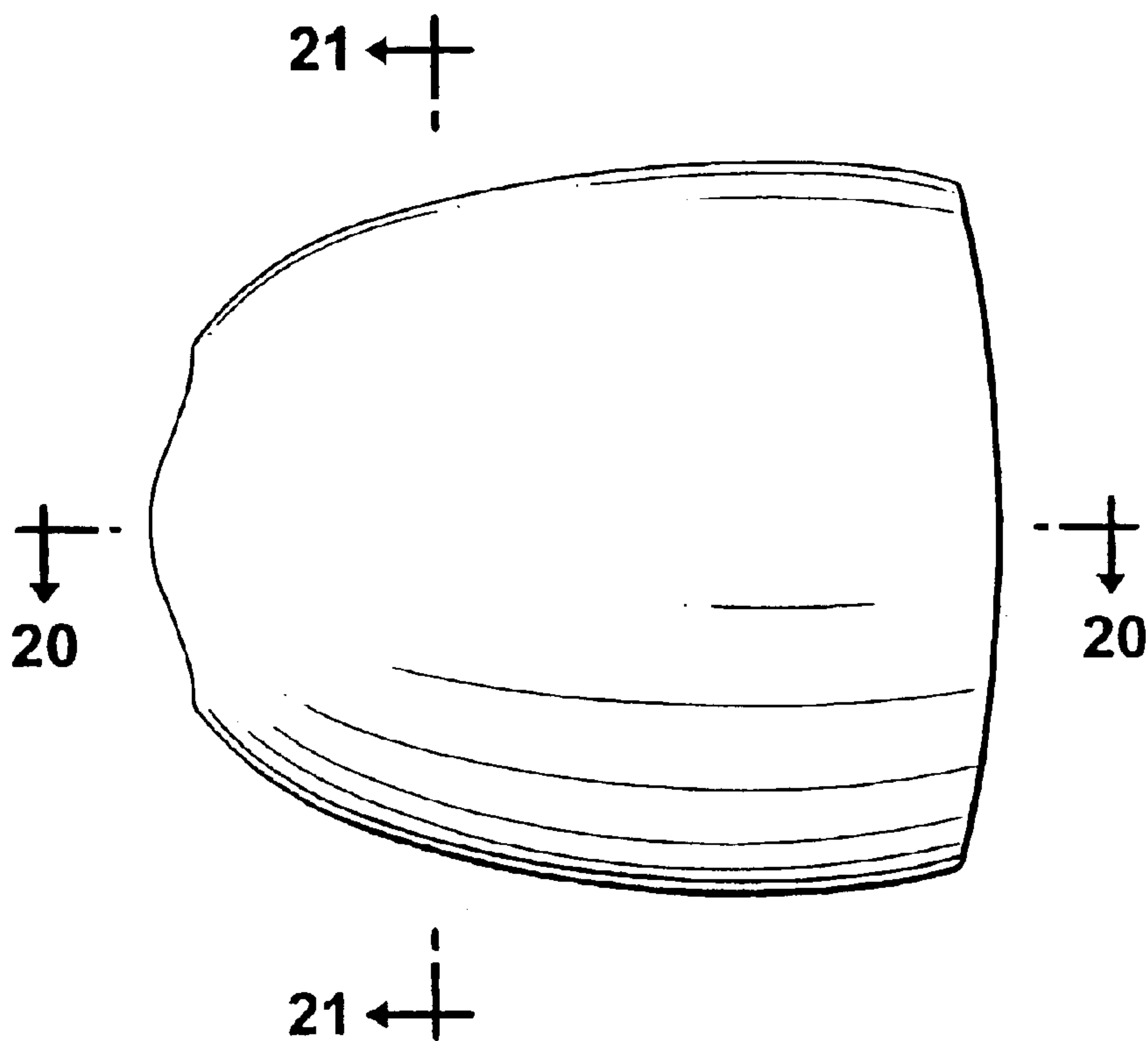

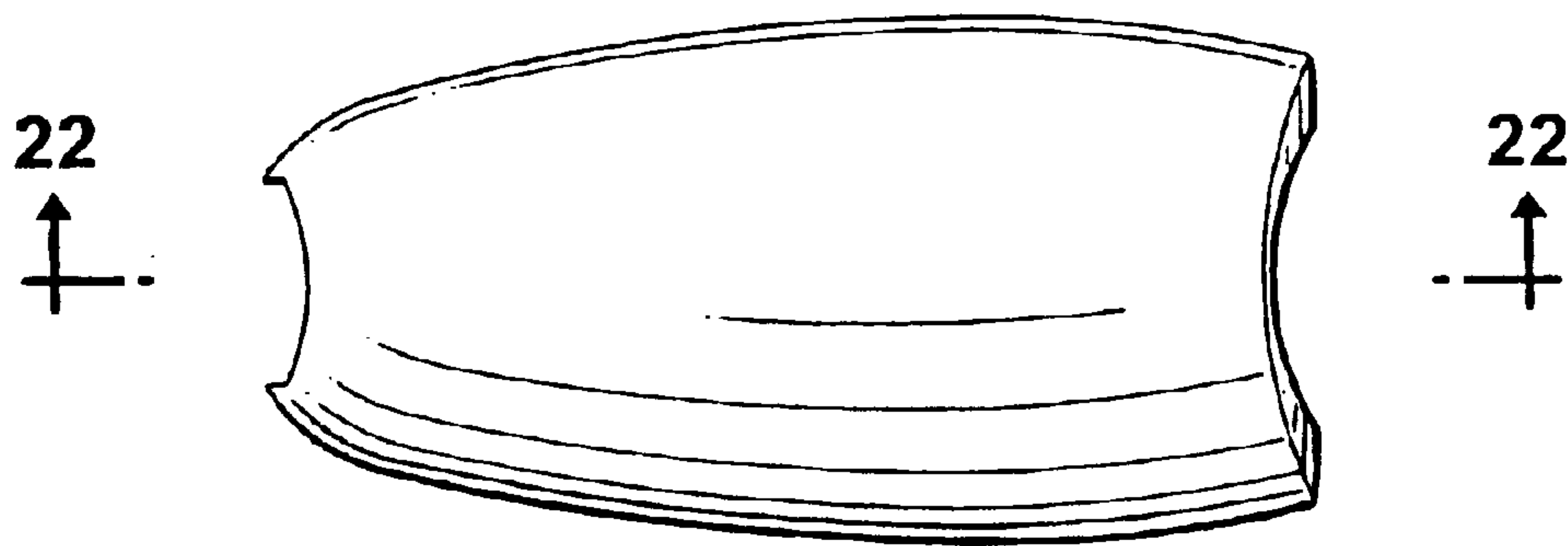

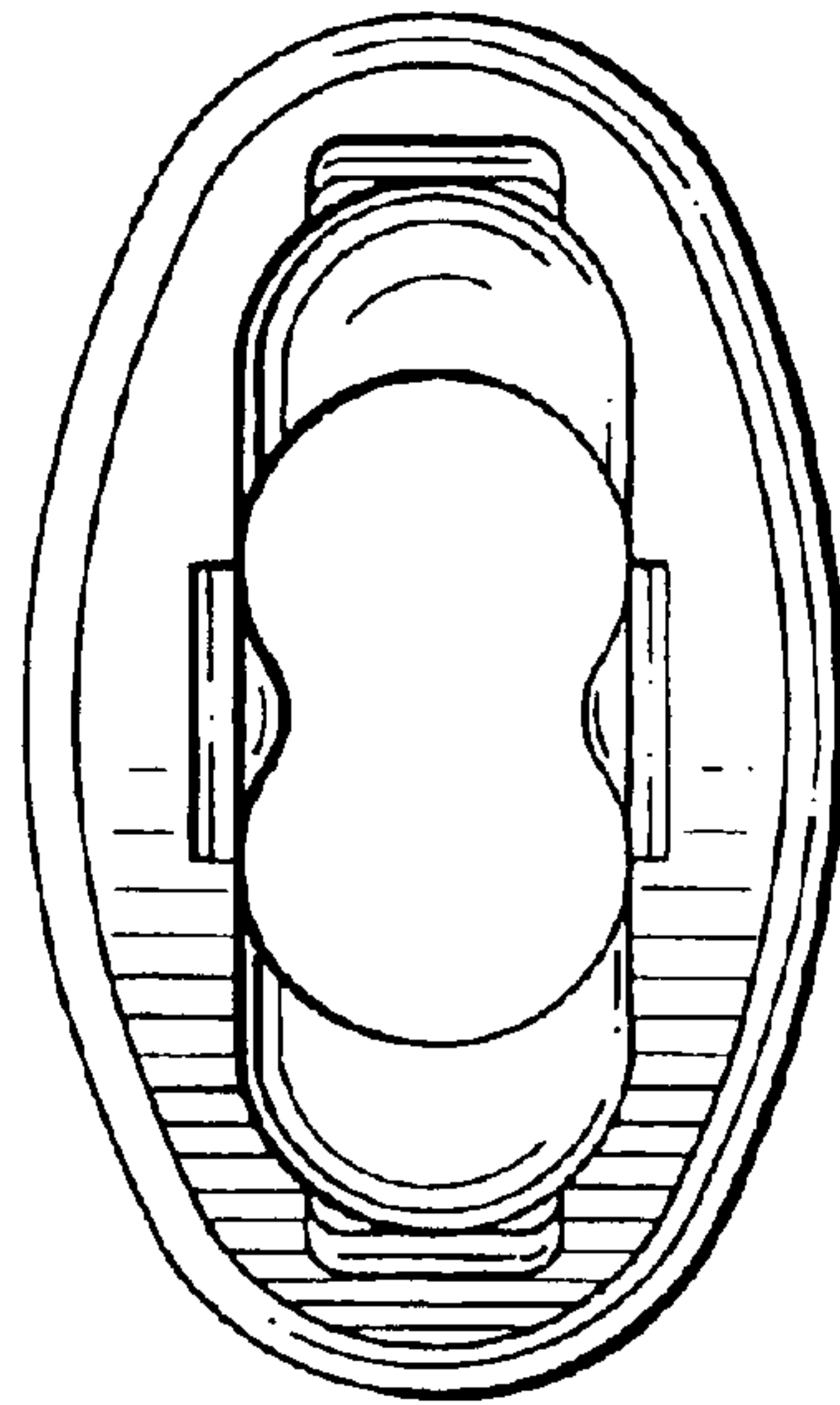

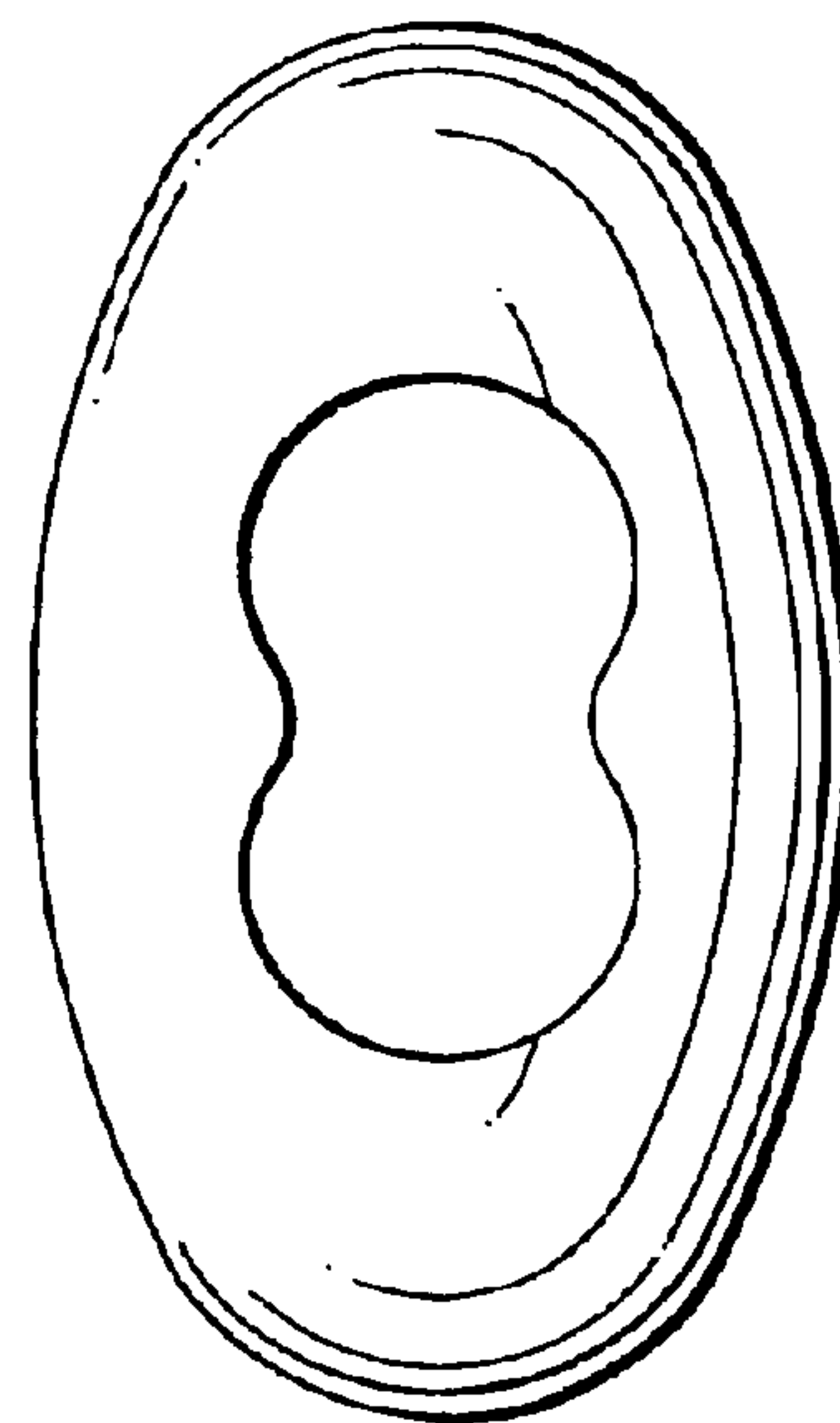

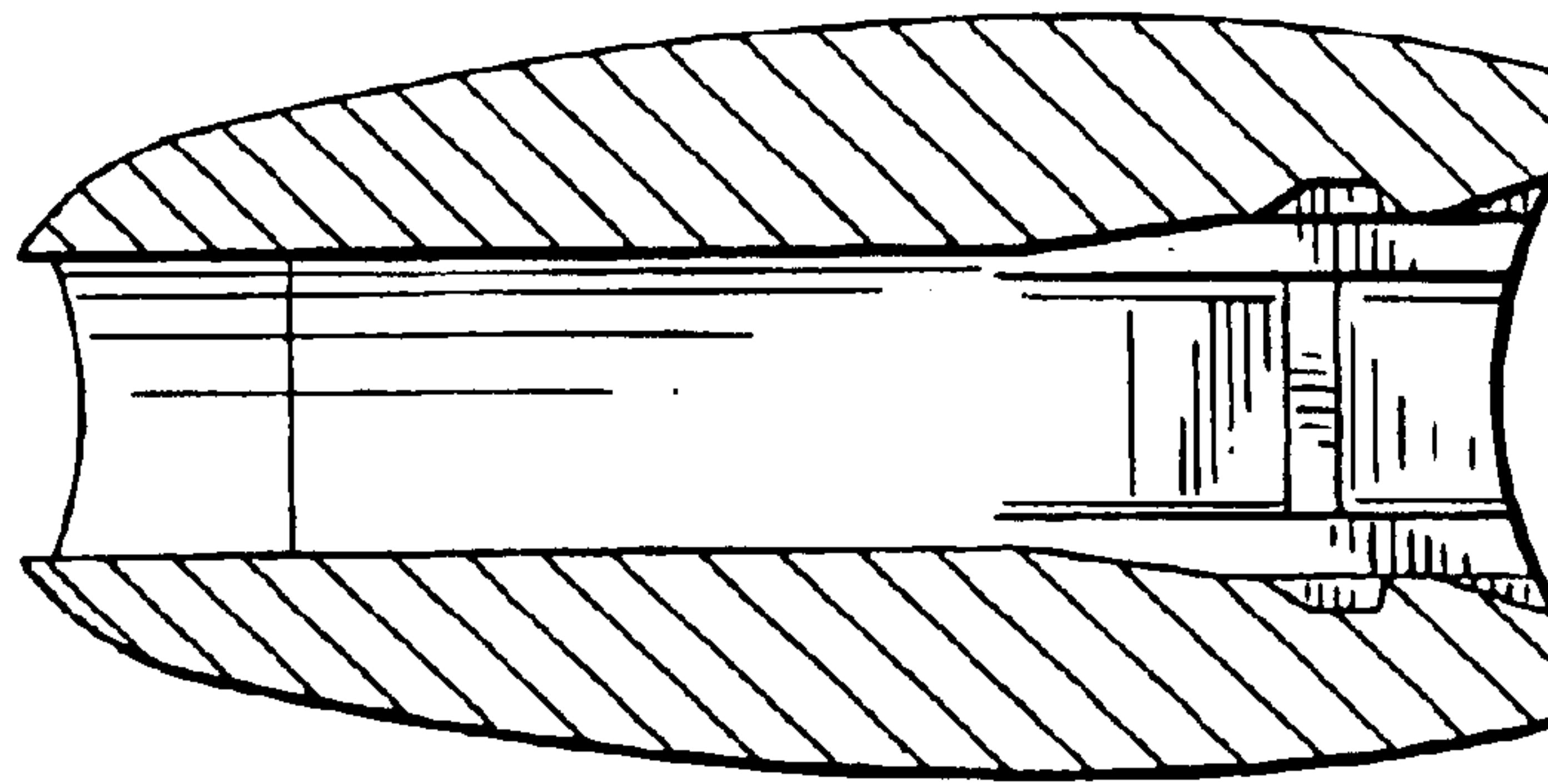

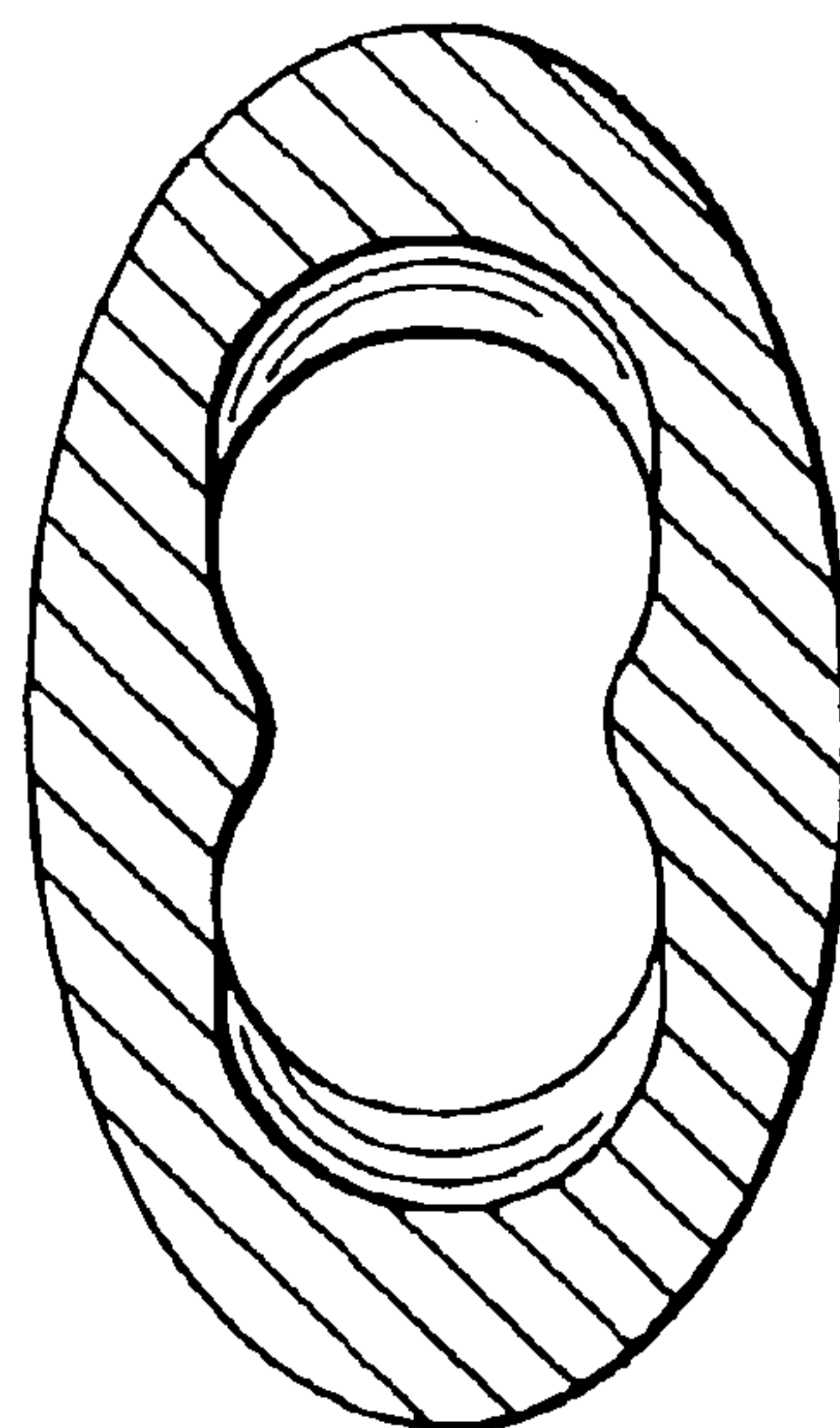

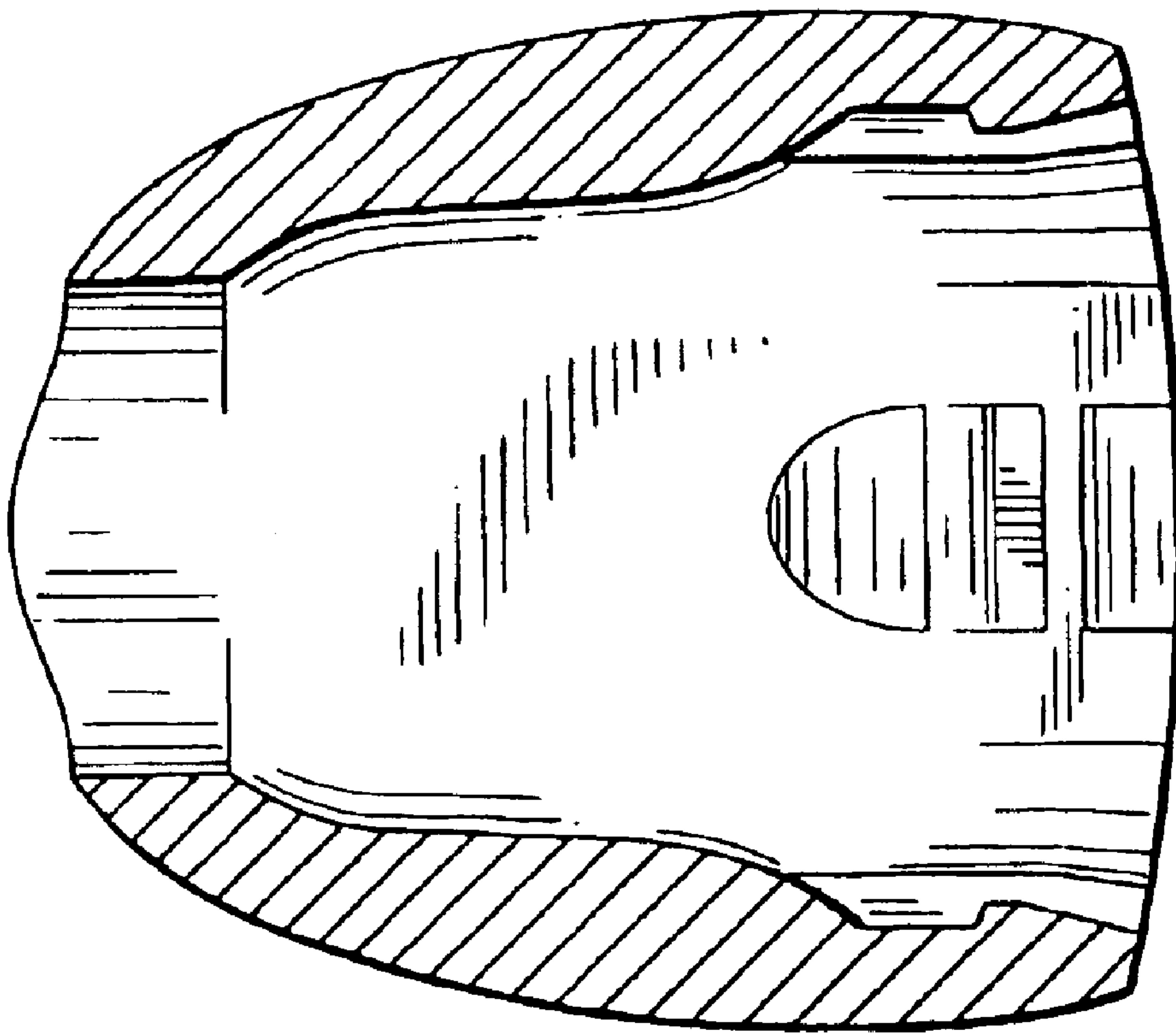
