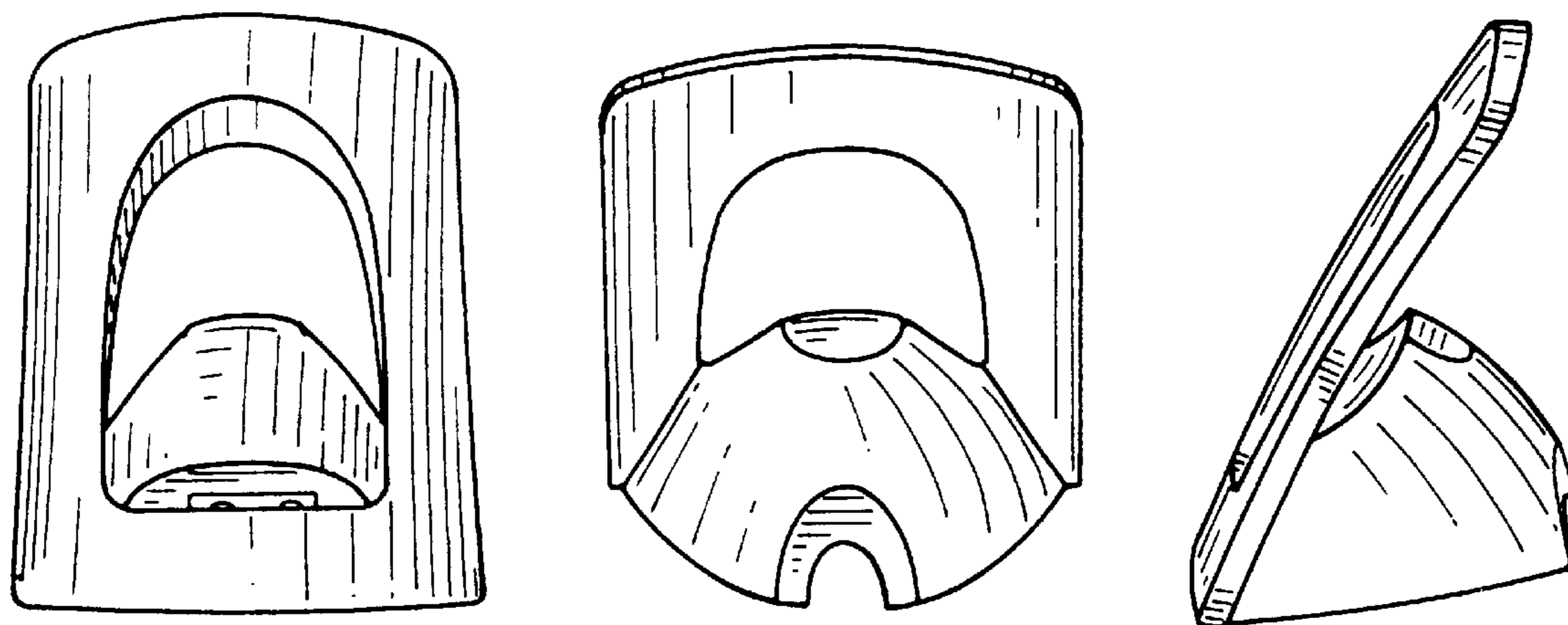
(57) **CLAIM**

FIG. 1 is a front side view of the docking station;

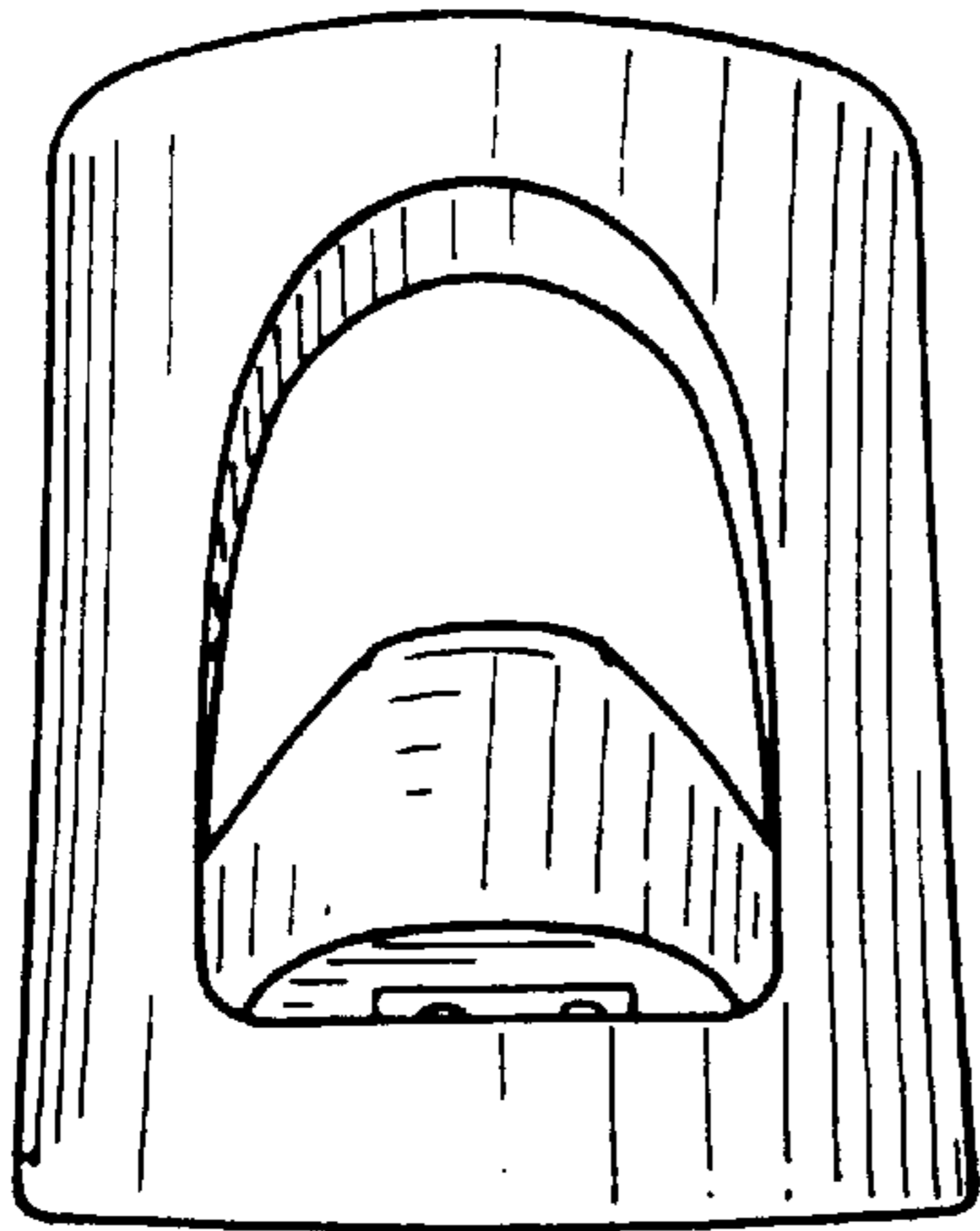

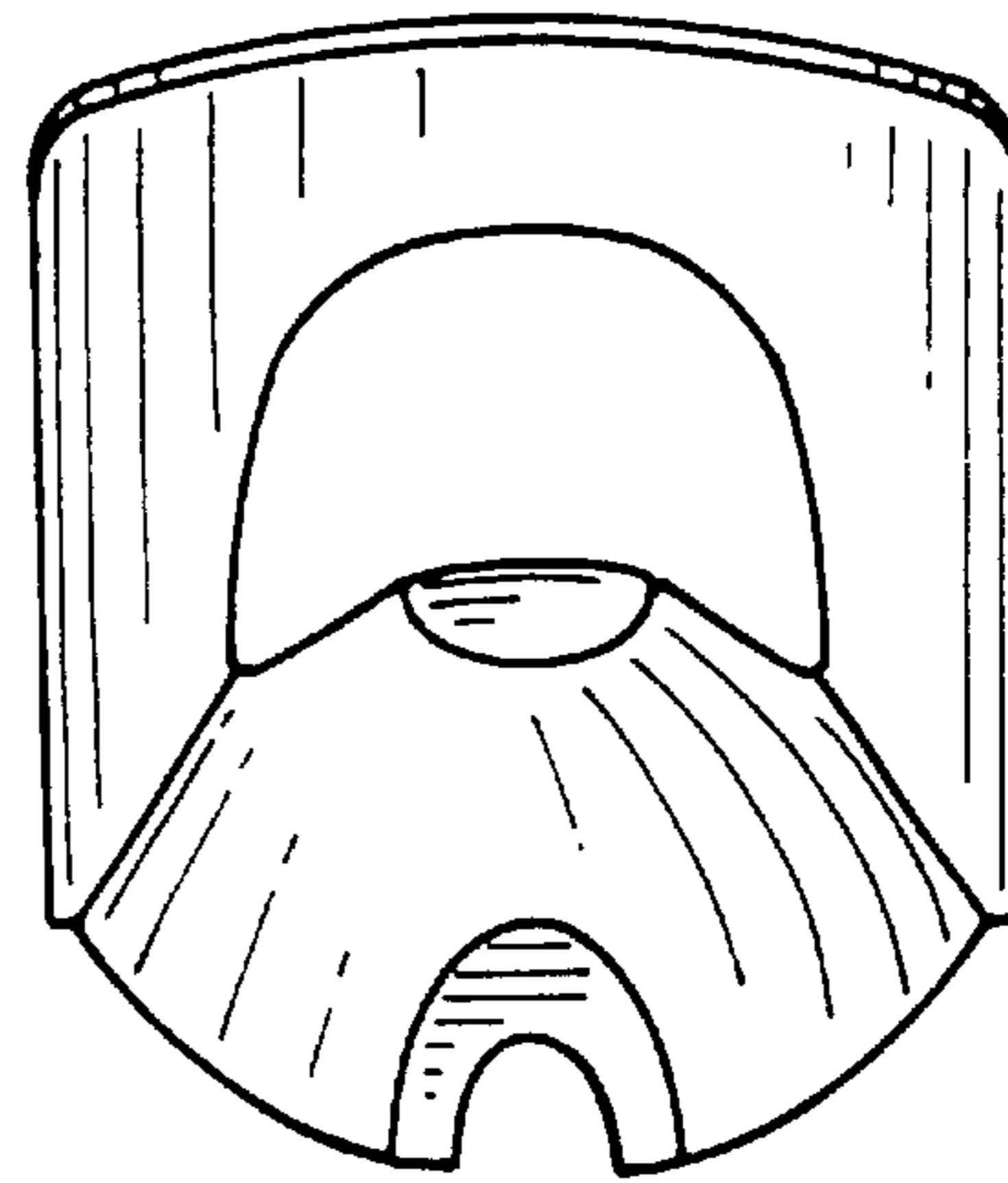

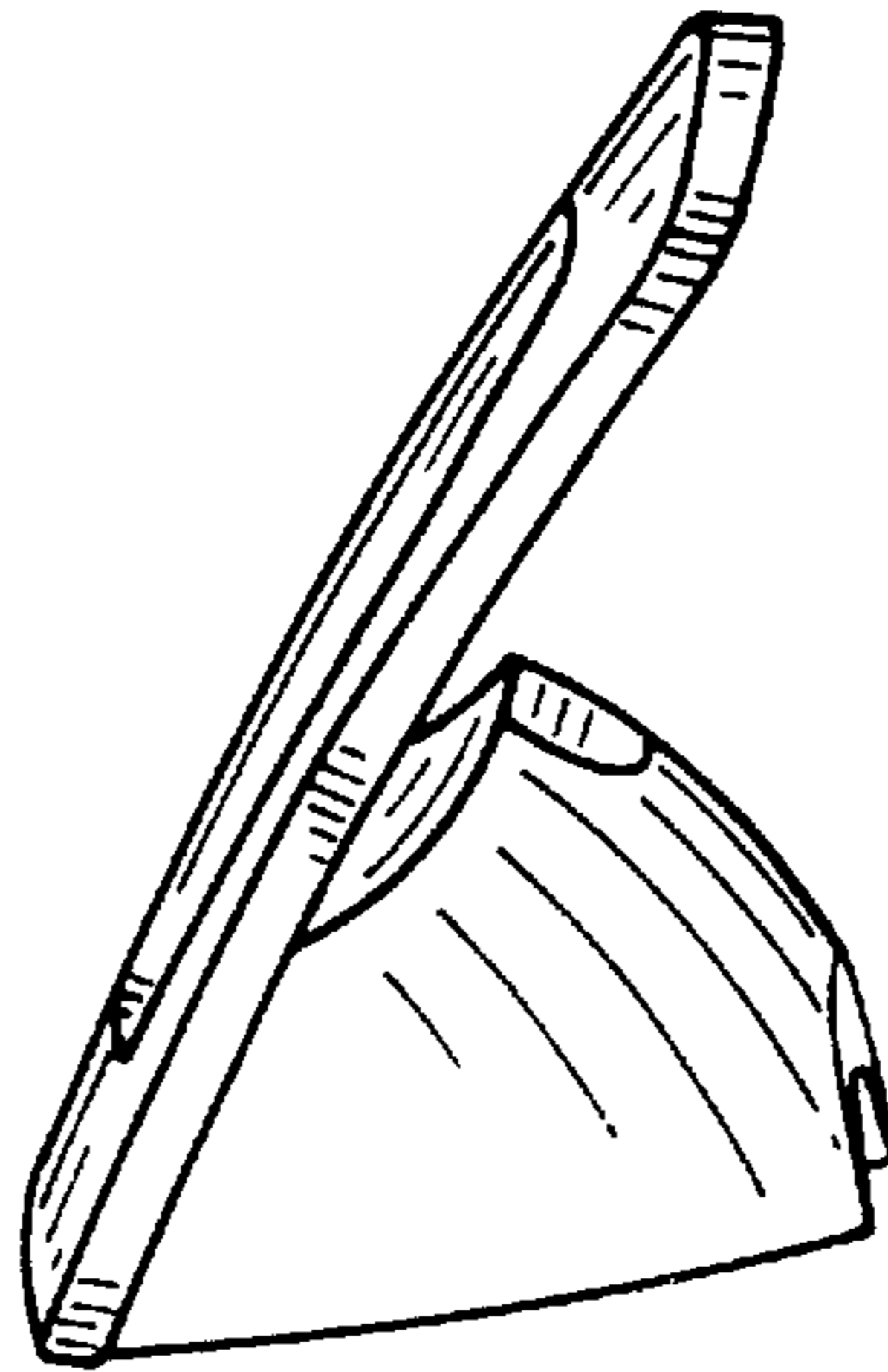

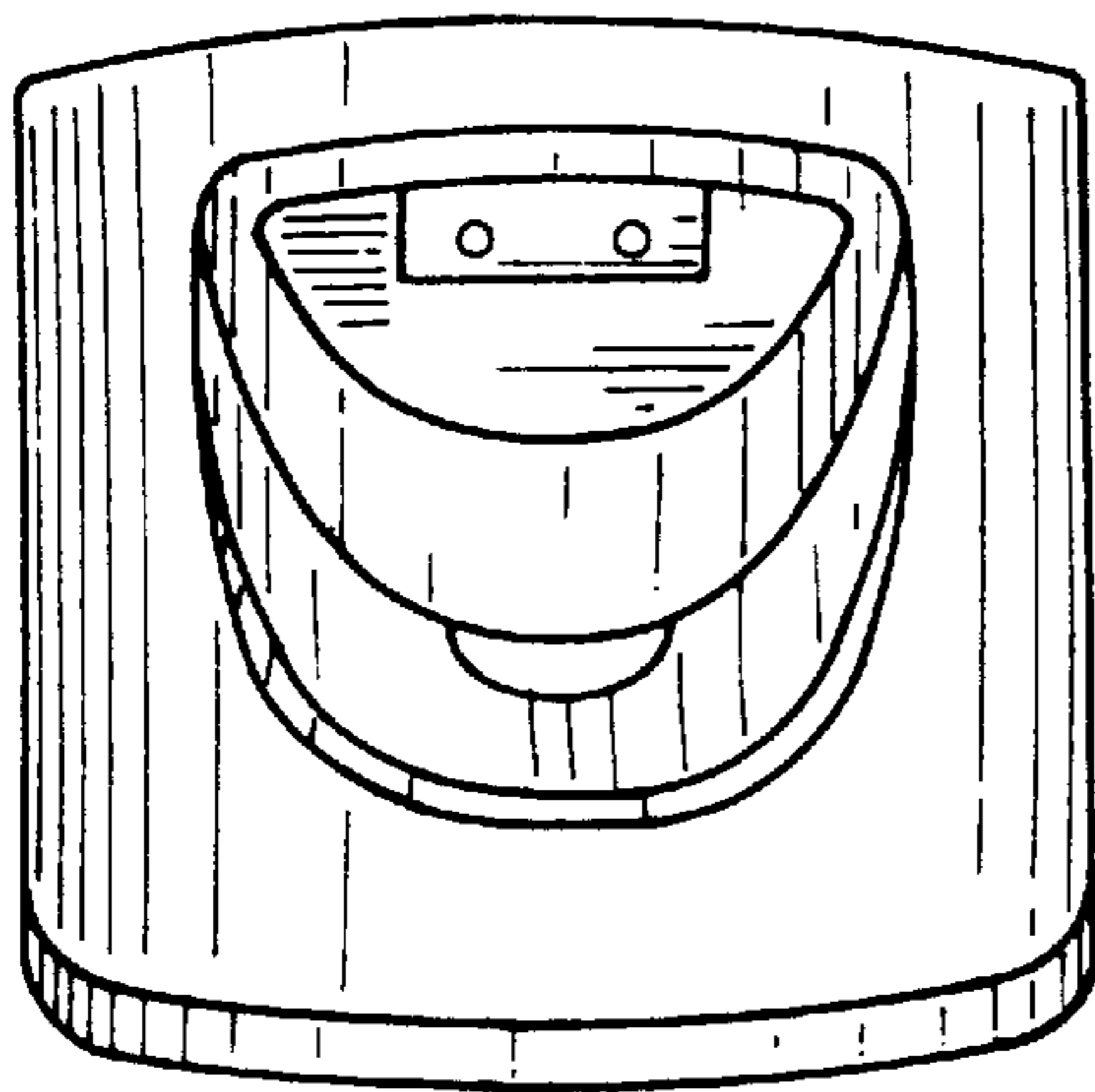

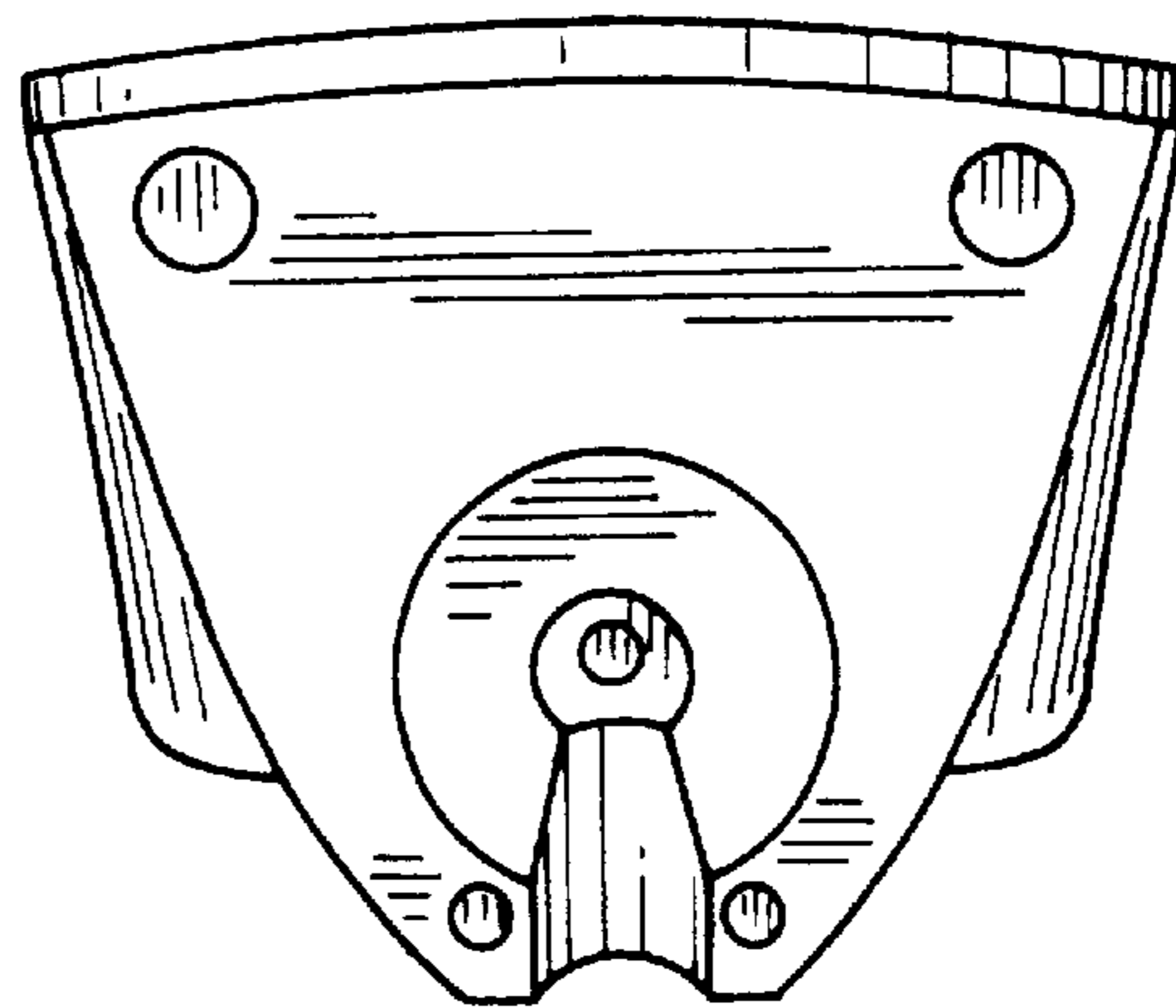
