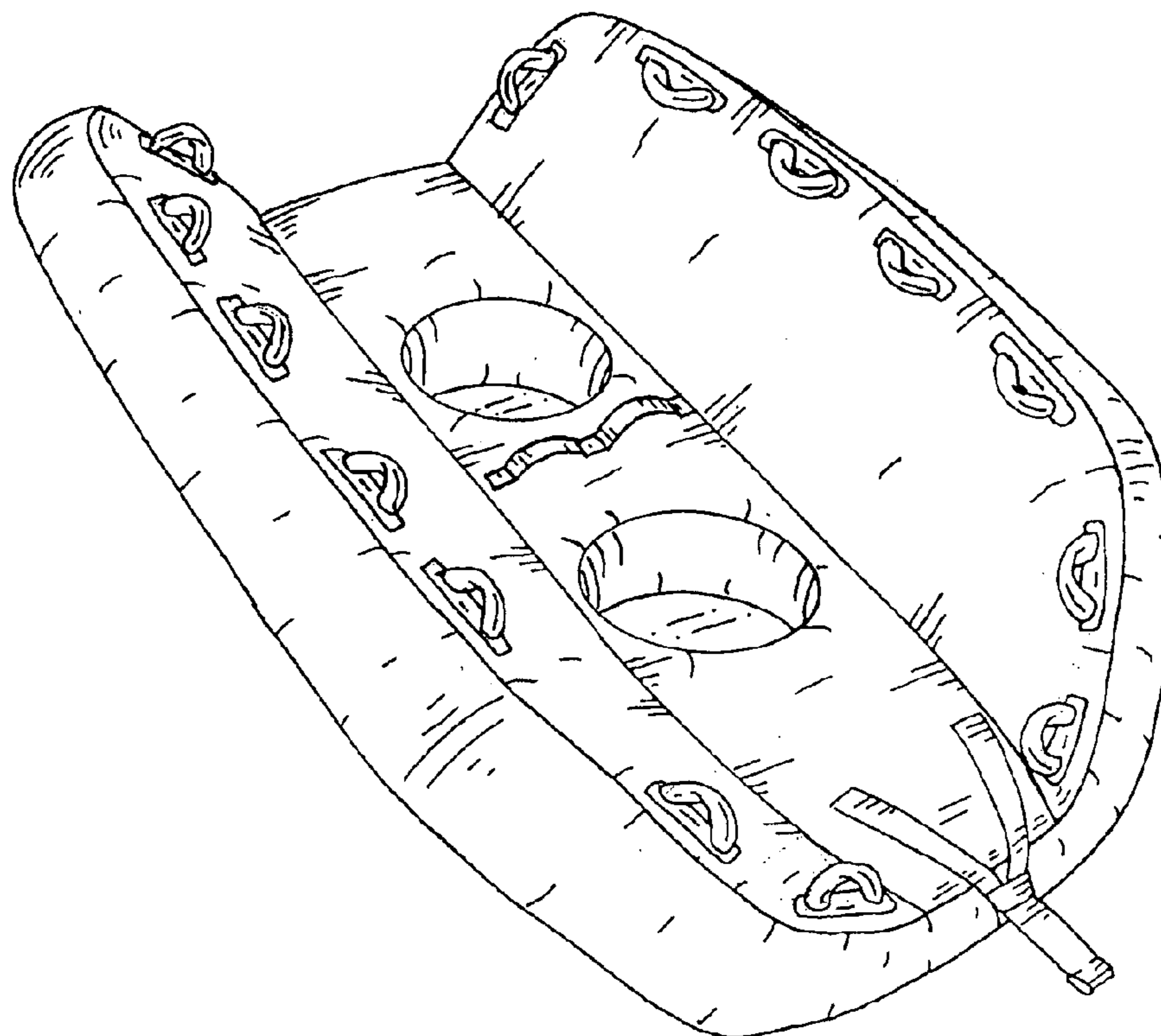

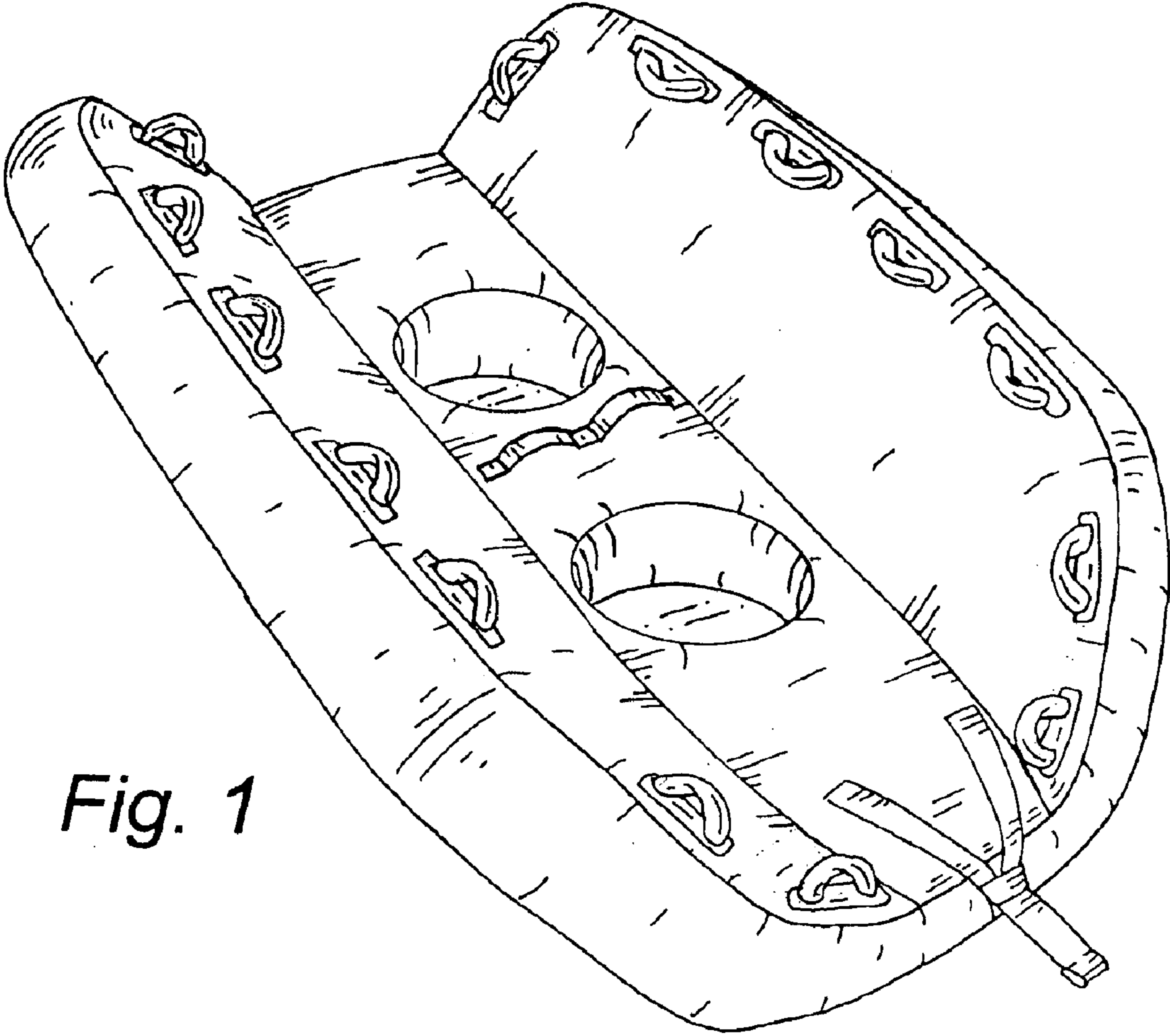

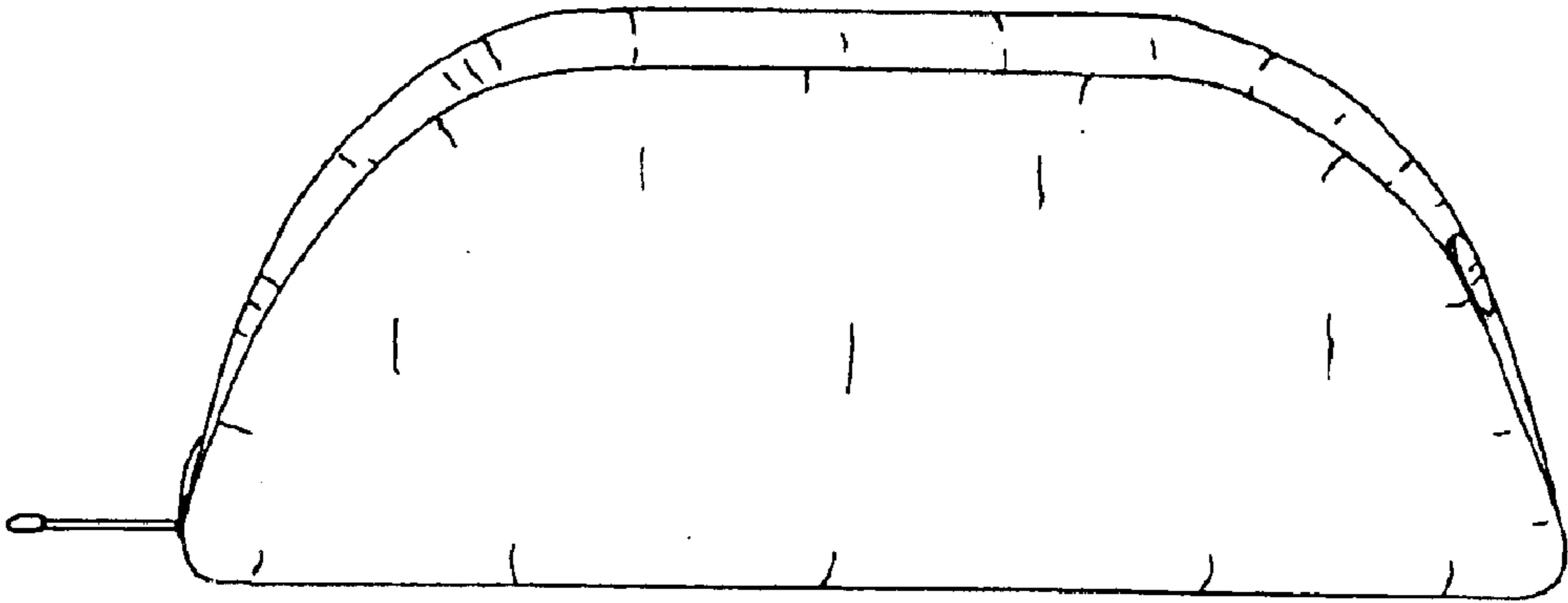
FIG. 1 is a perspective view of the inflatable towable vehicle showing my new design;

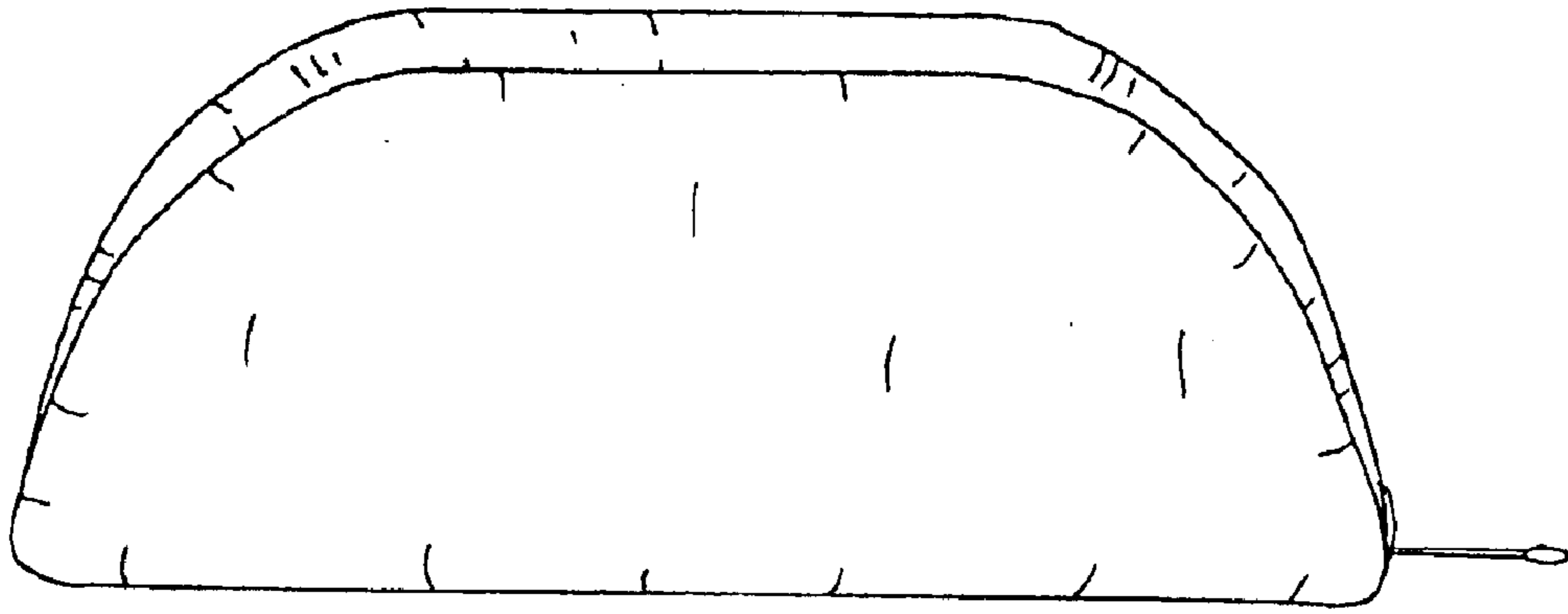




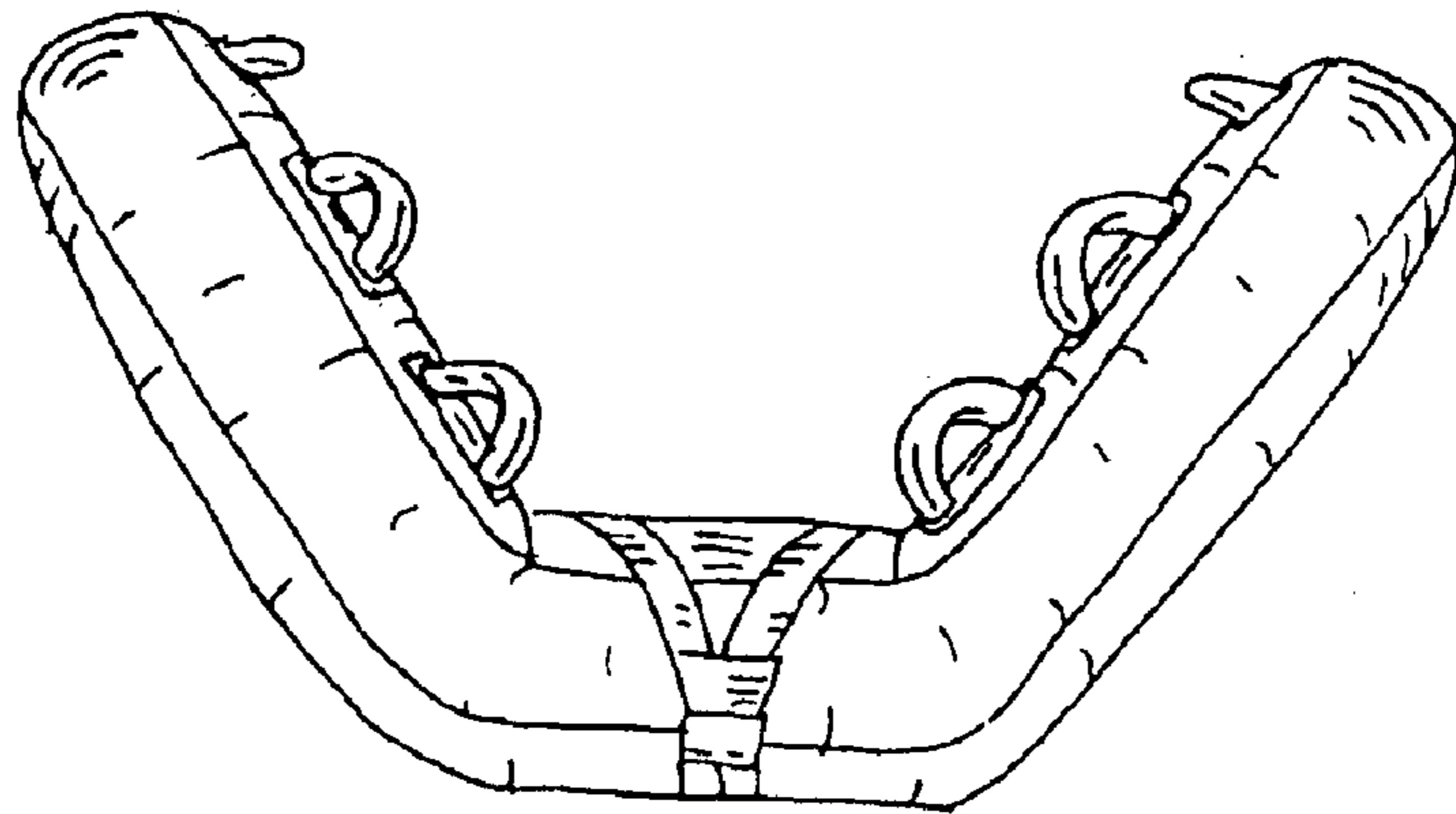

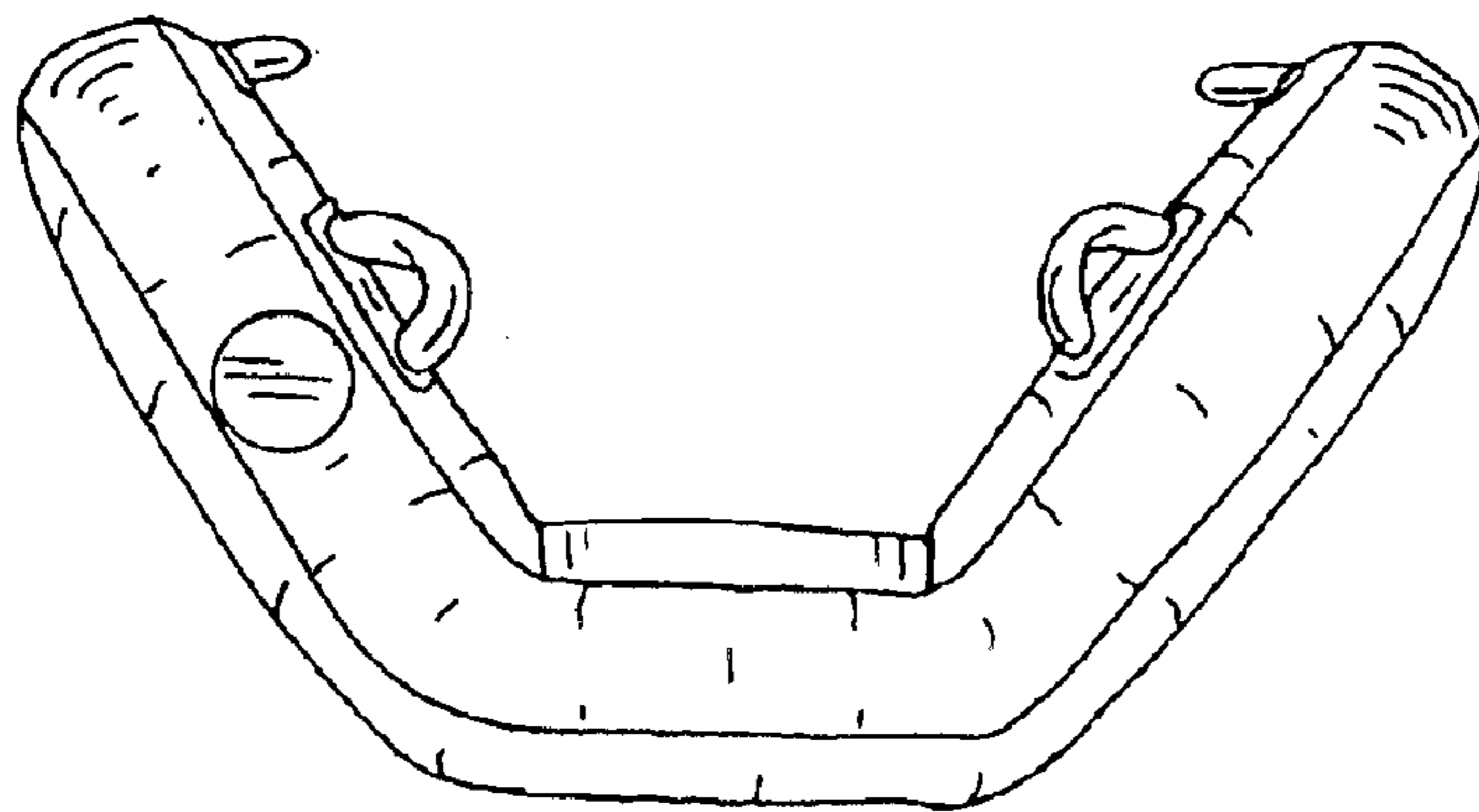

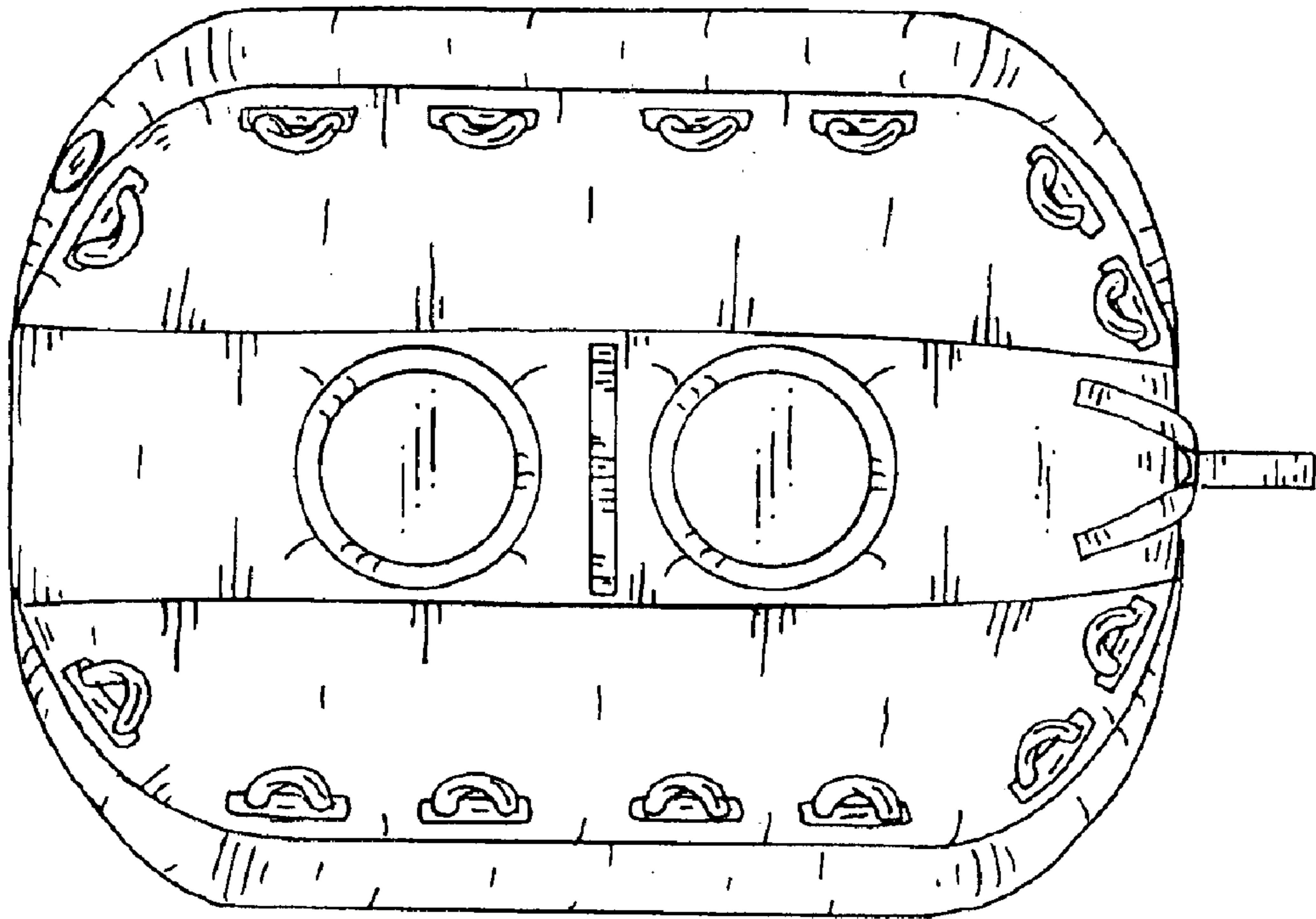

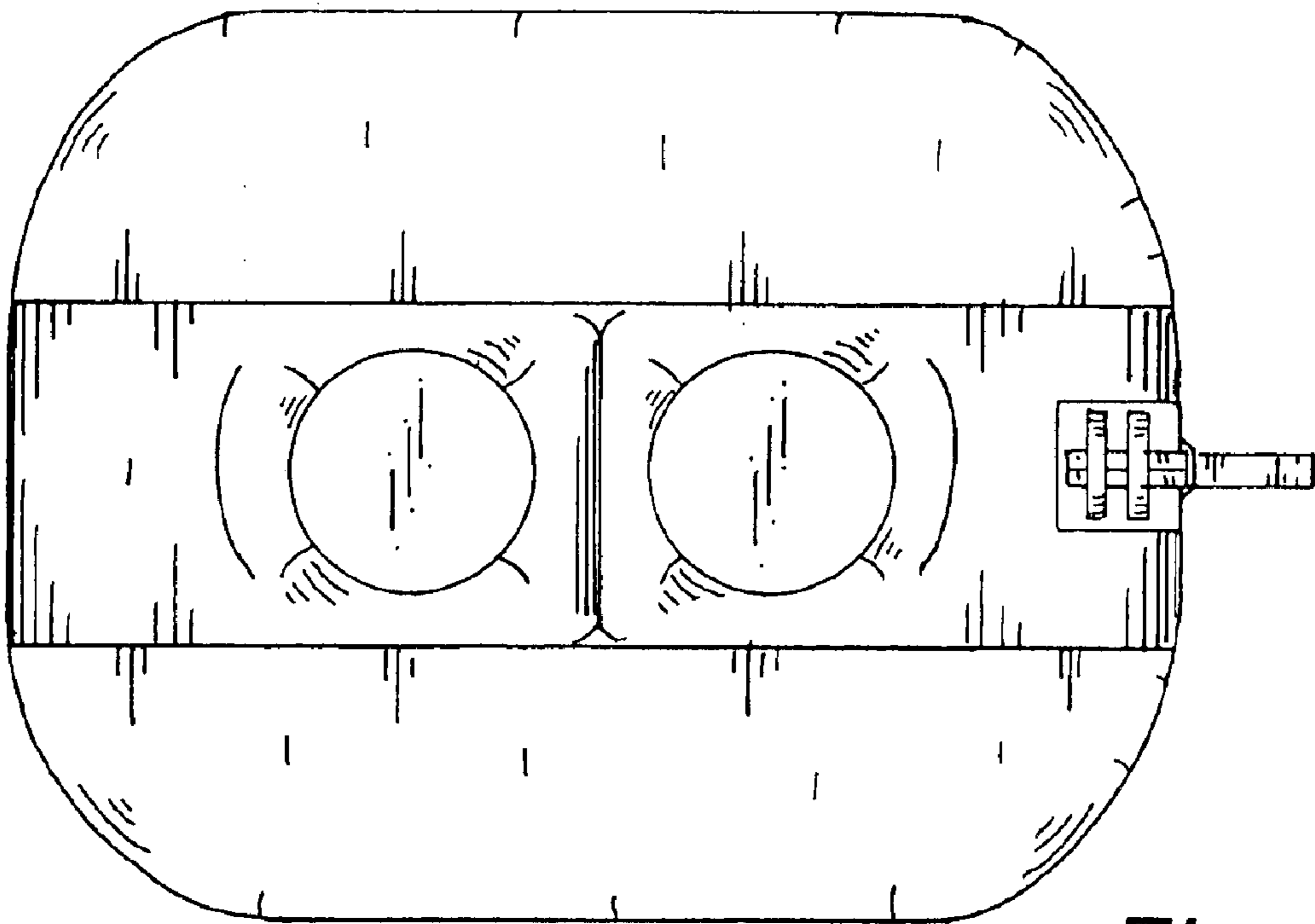
