DESCRIPTION

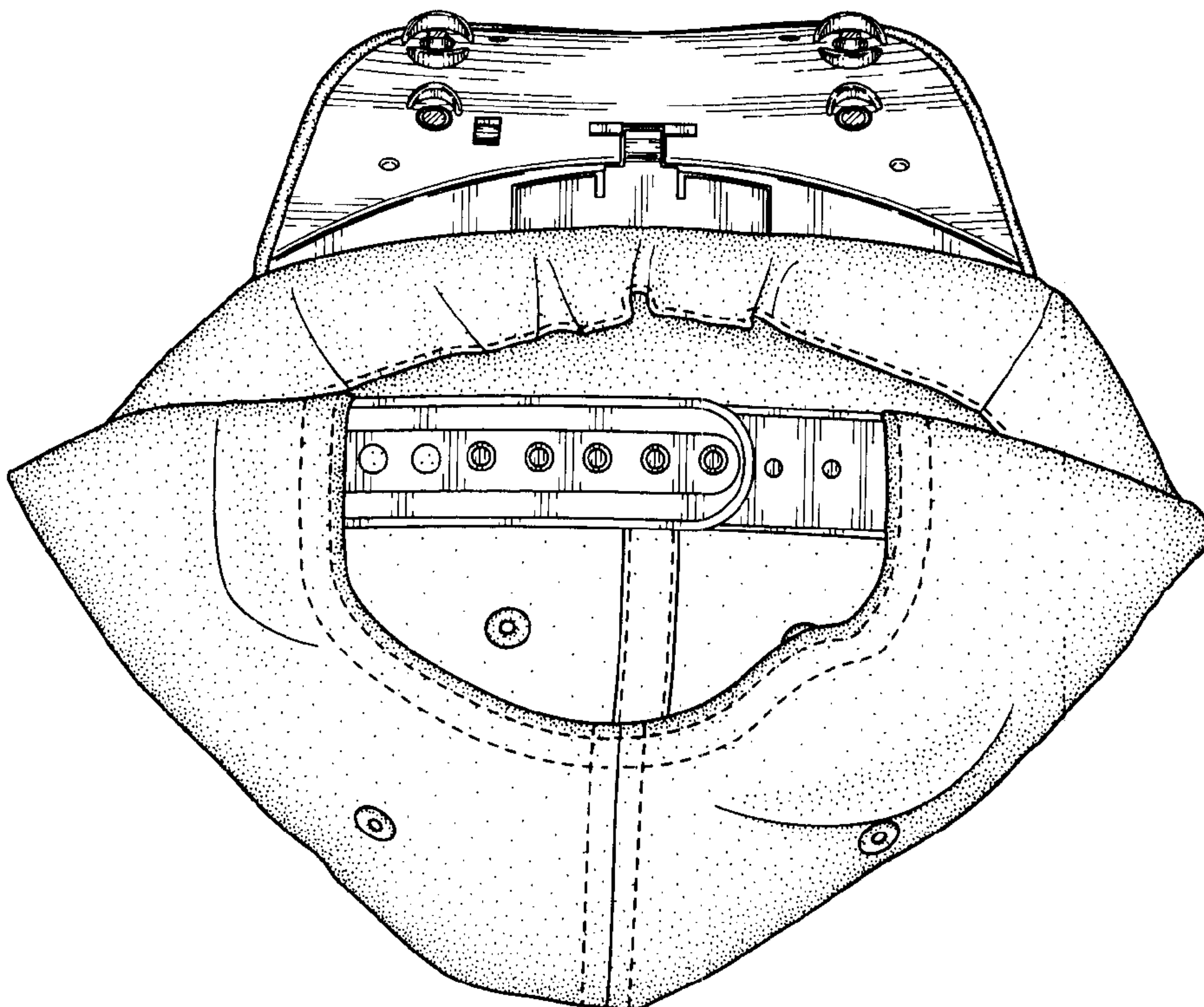
FIG. 1 is a top plan view of a cap with self-contained black light showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is the rear view thereof;
FIG. 4 is the left side view thereof;
FIG. 5 is the right side view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a right side perspective view thereof, the left side perspective view being a mirror image;
FIG. 8 is a rear perspective view thereof;
FIG. 9 is a rear perspective view with the battery pack partially removed from its slot; and,
FIG. 10 is a rear perspective view with the battery pack fully removed from its slot and rotated at 180° to show its content.

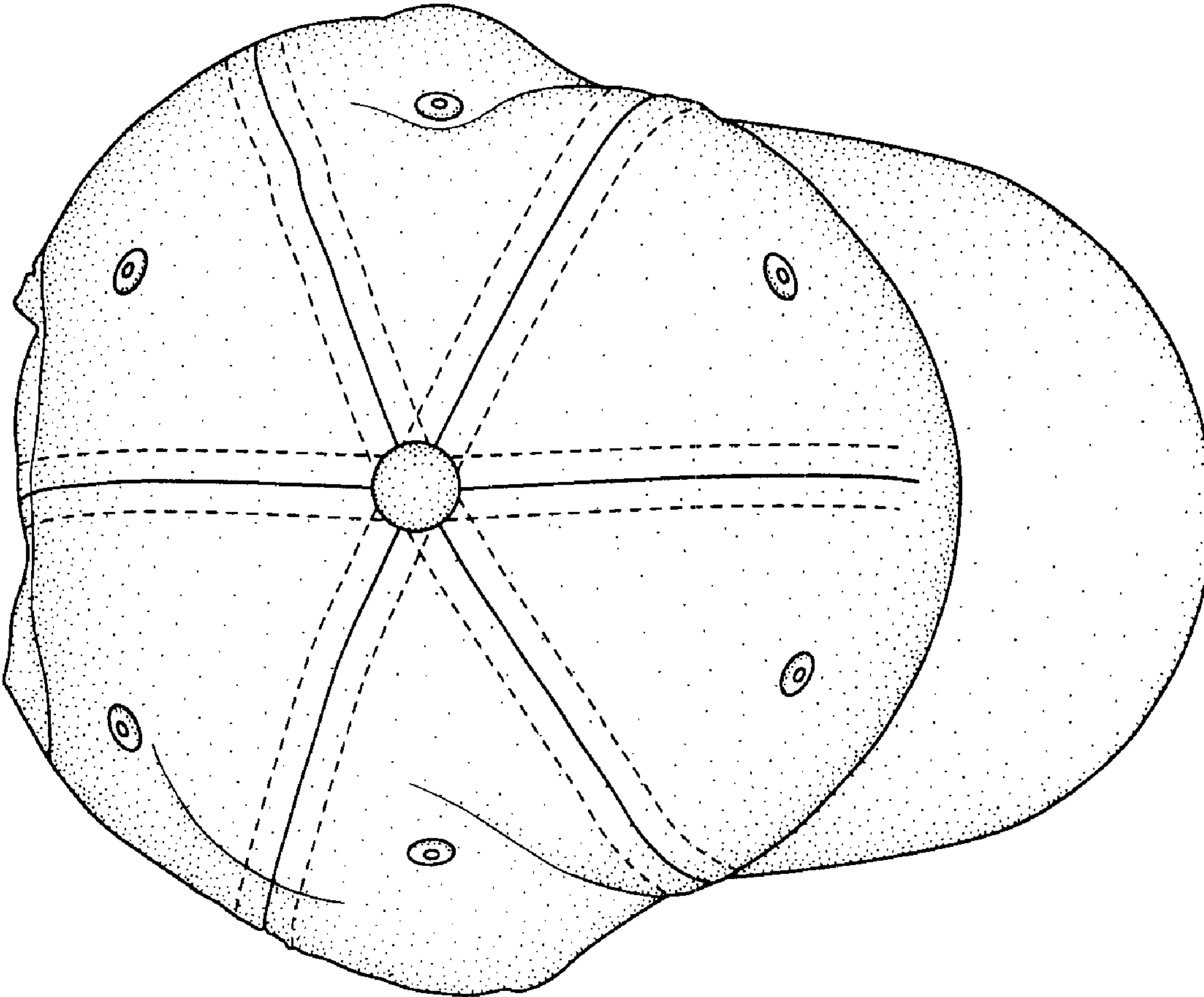

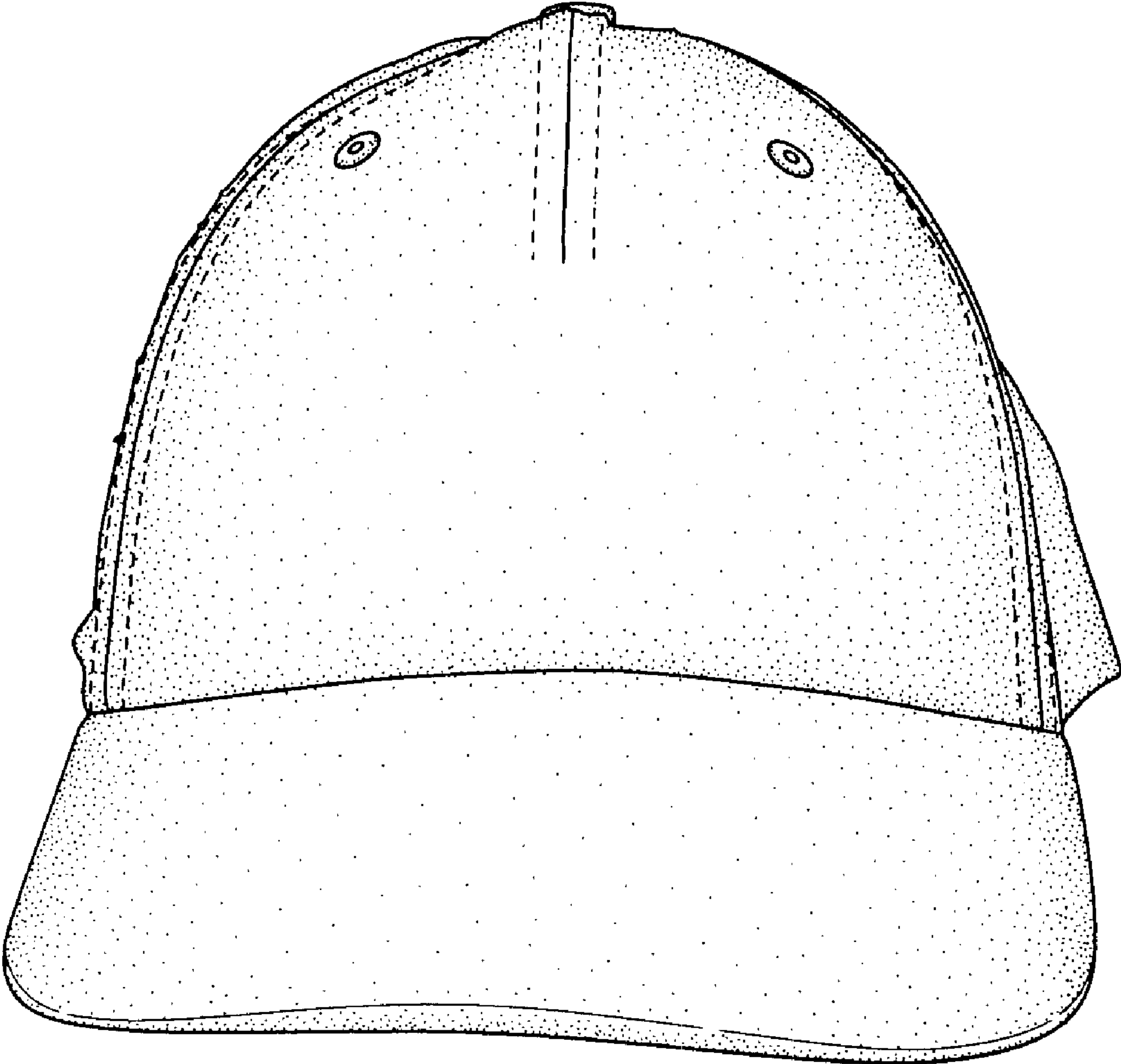

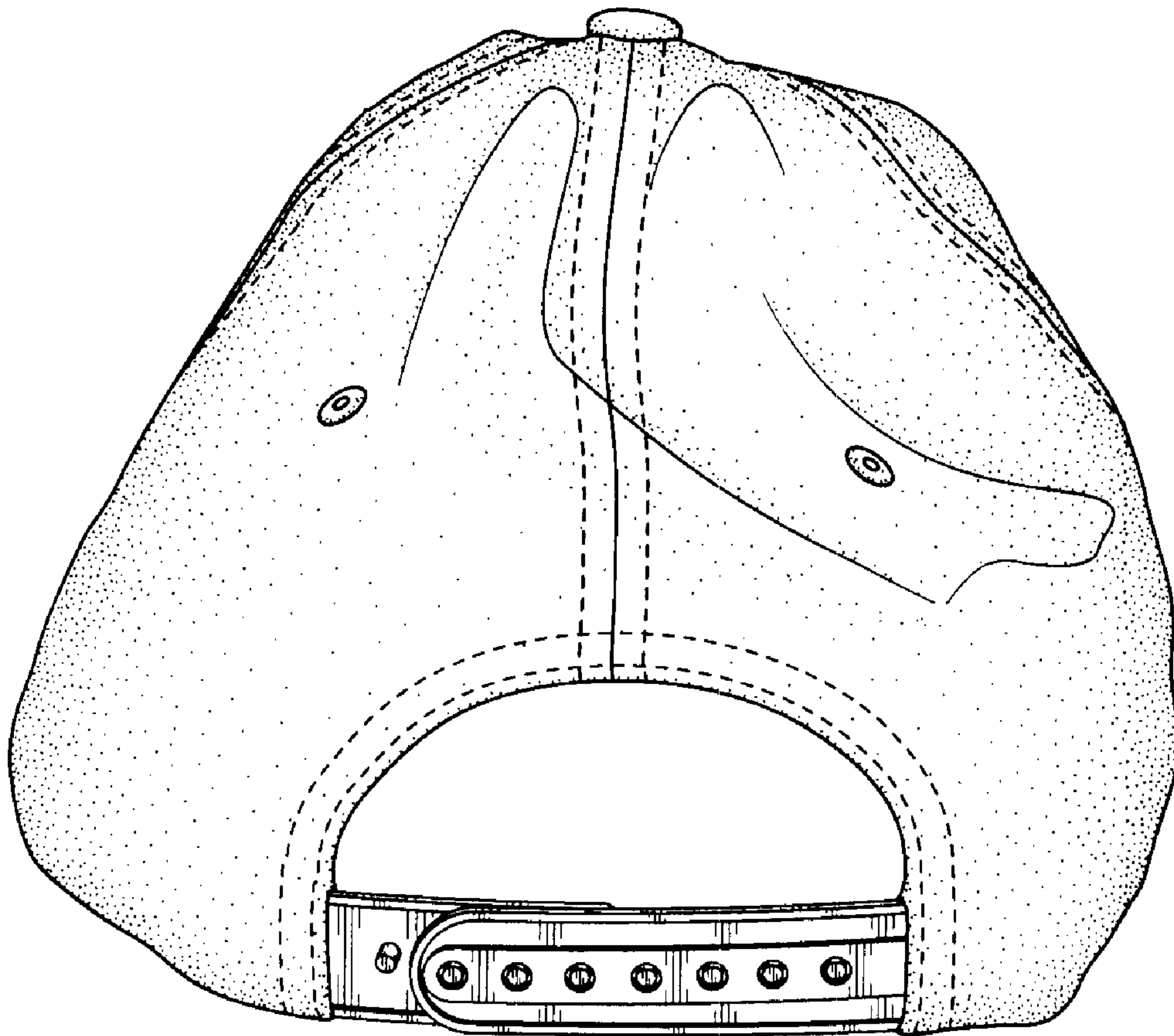

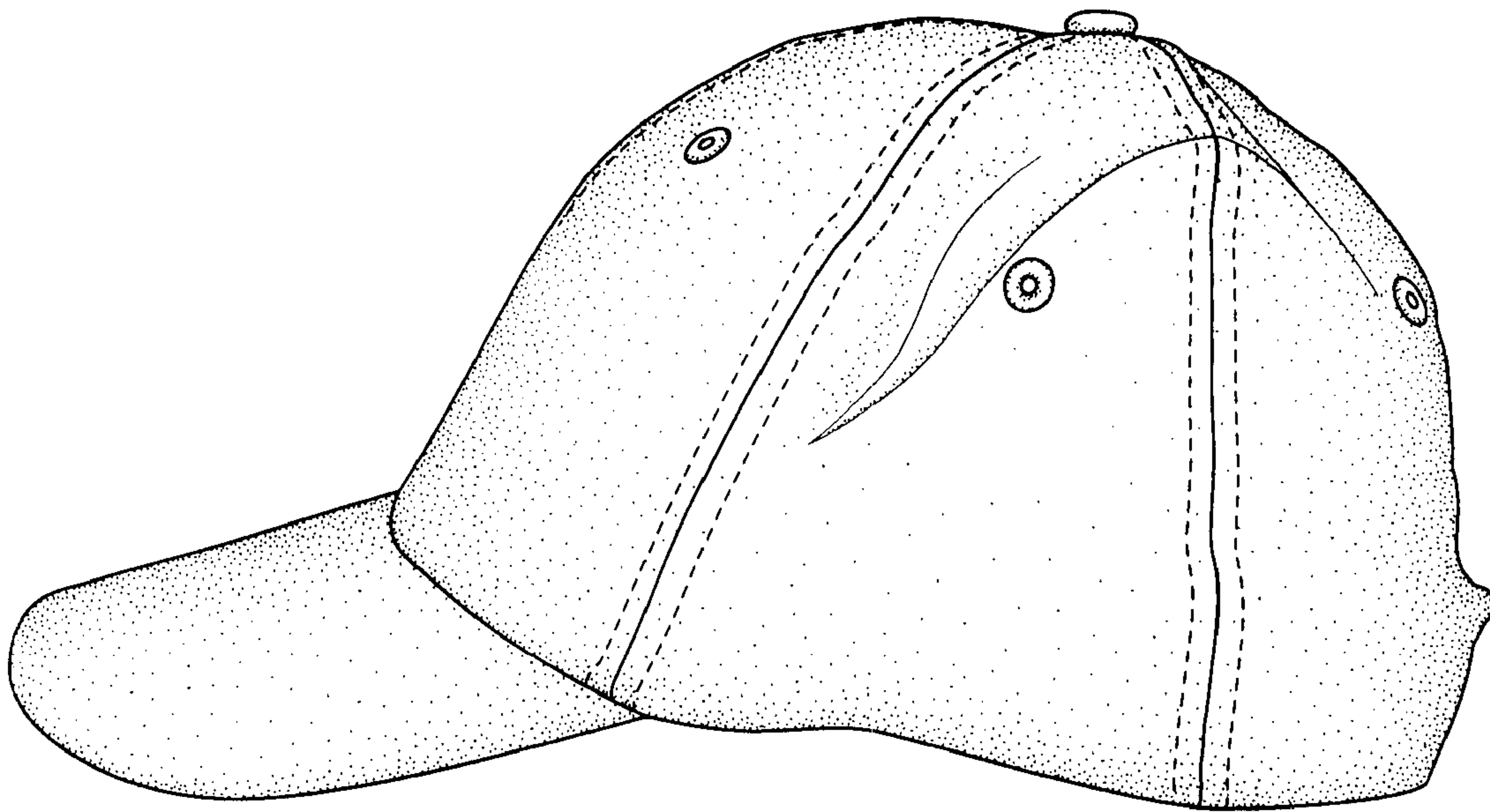

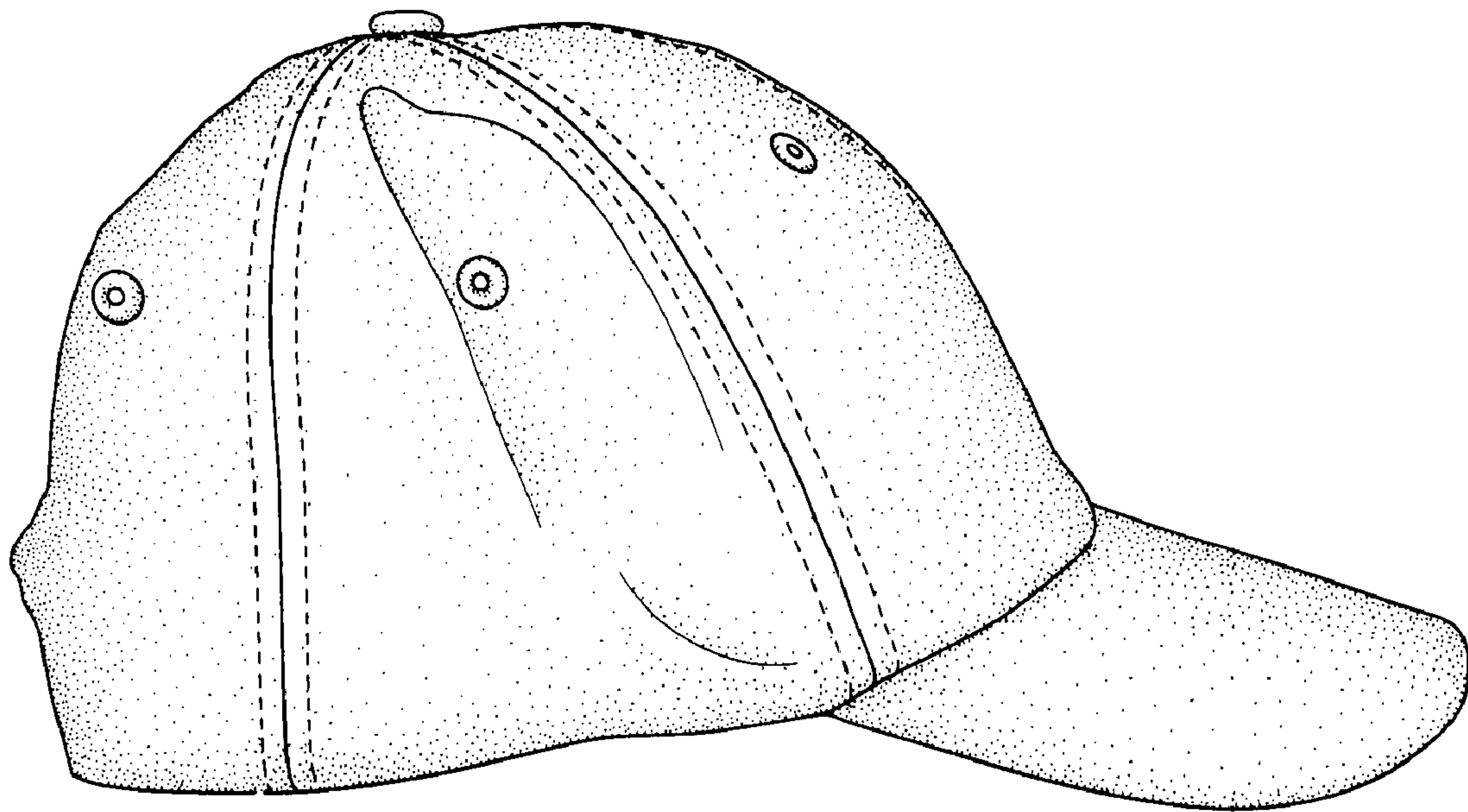

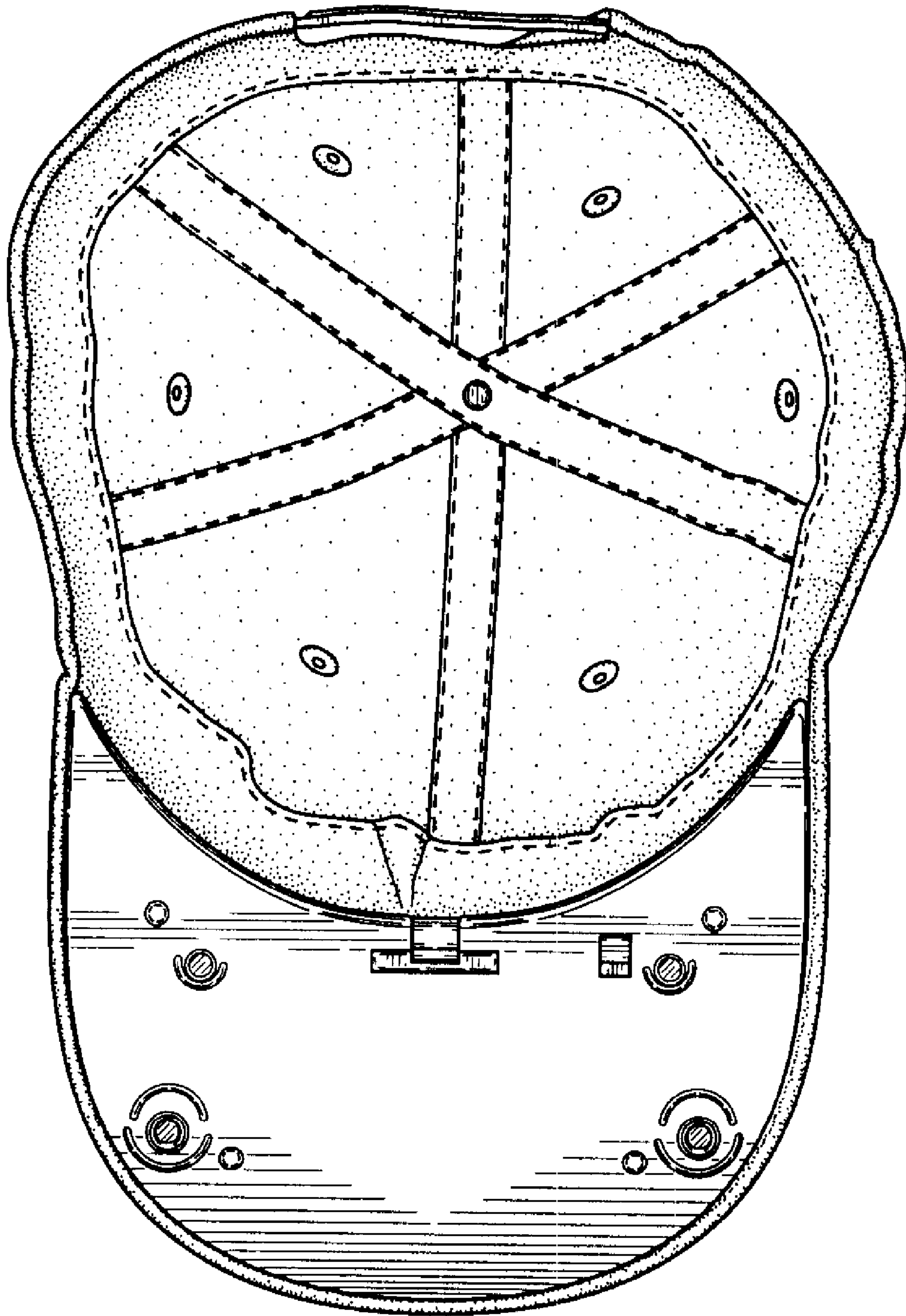

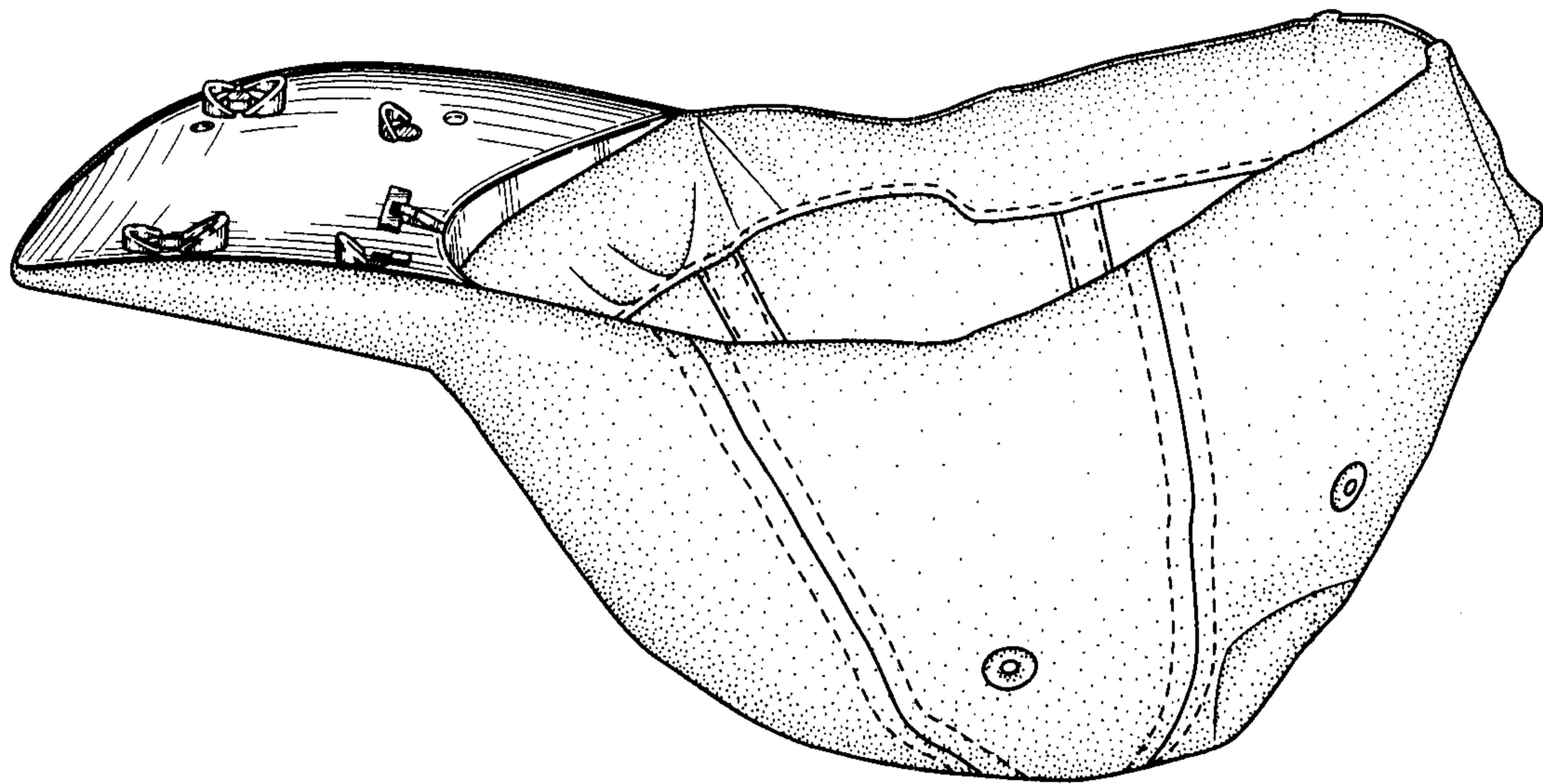

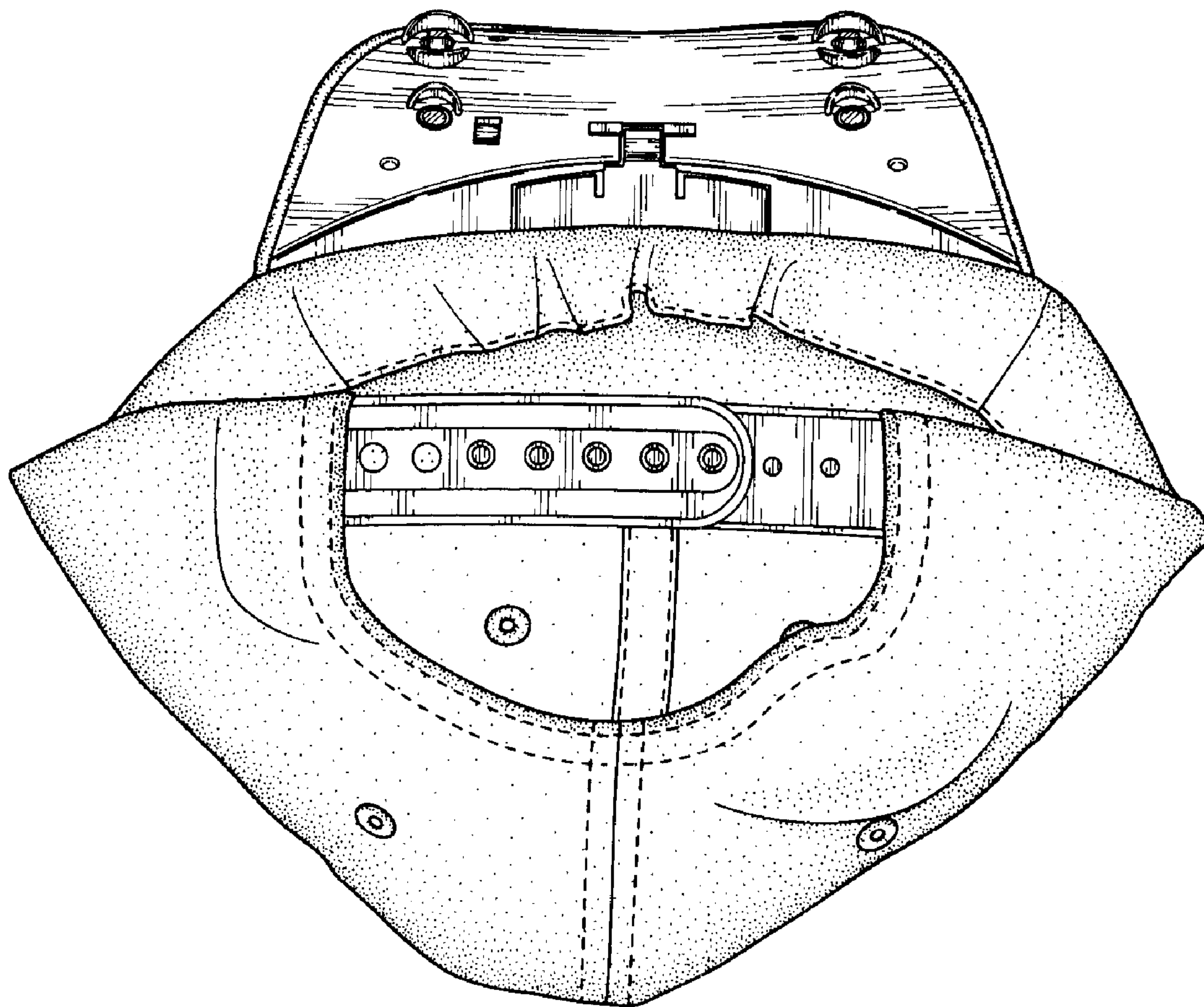

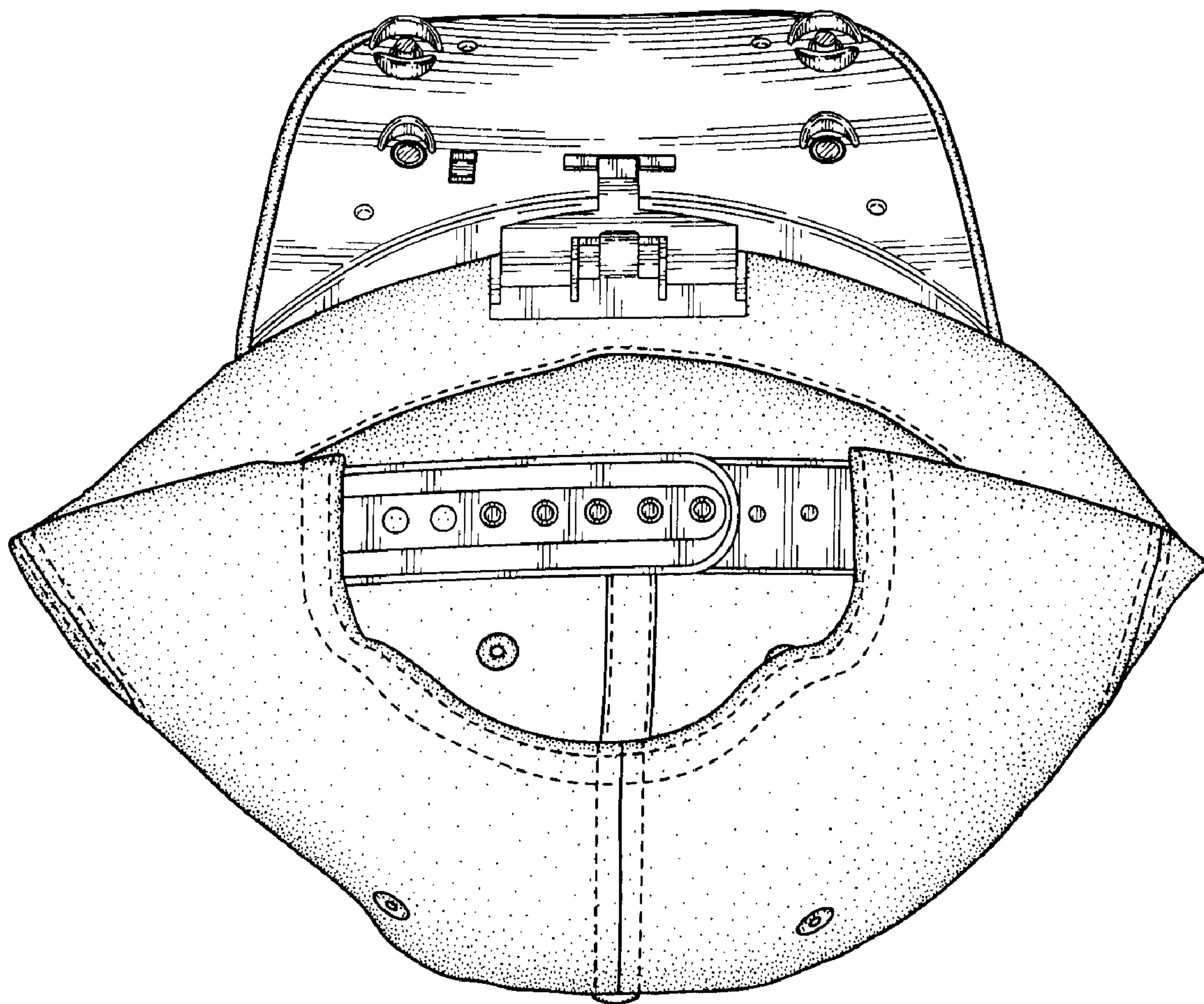

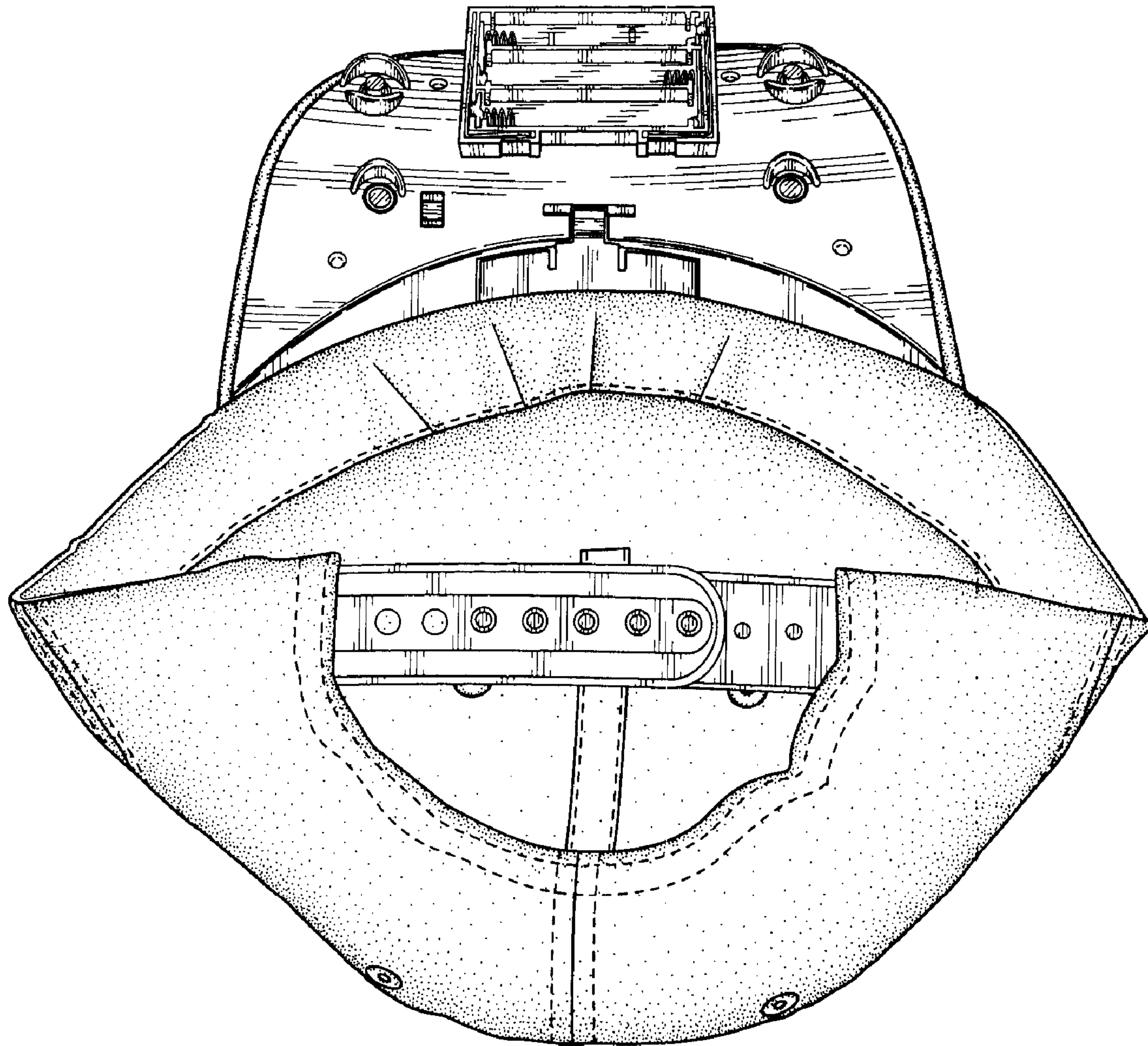
