(57) **CLAIM**

The ornamental design for a full wrap shoe sole, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a full wrap shoe sole showing my new design;  
 FIG. 2 is a bottom plan view thereof;  
 FIG. 3 is a left side elevational view thereof;  
 FIG. 4 is a cross-sectional view taken on line 4—4 of FIG. 2; and,  
 FIG. 5 is a cross-sectional view taken on line 5—5 of FIG. 2.

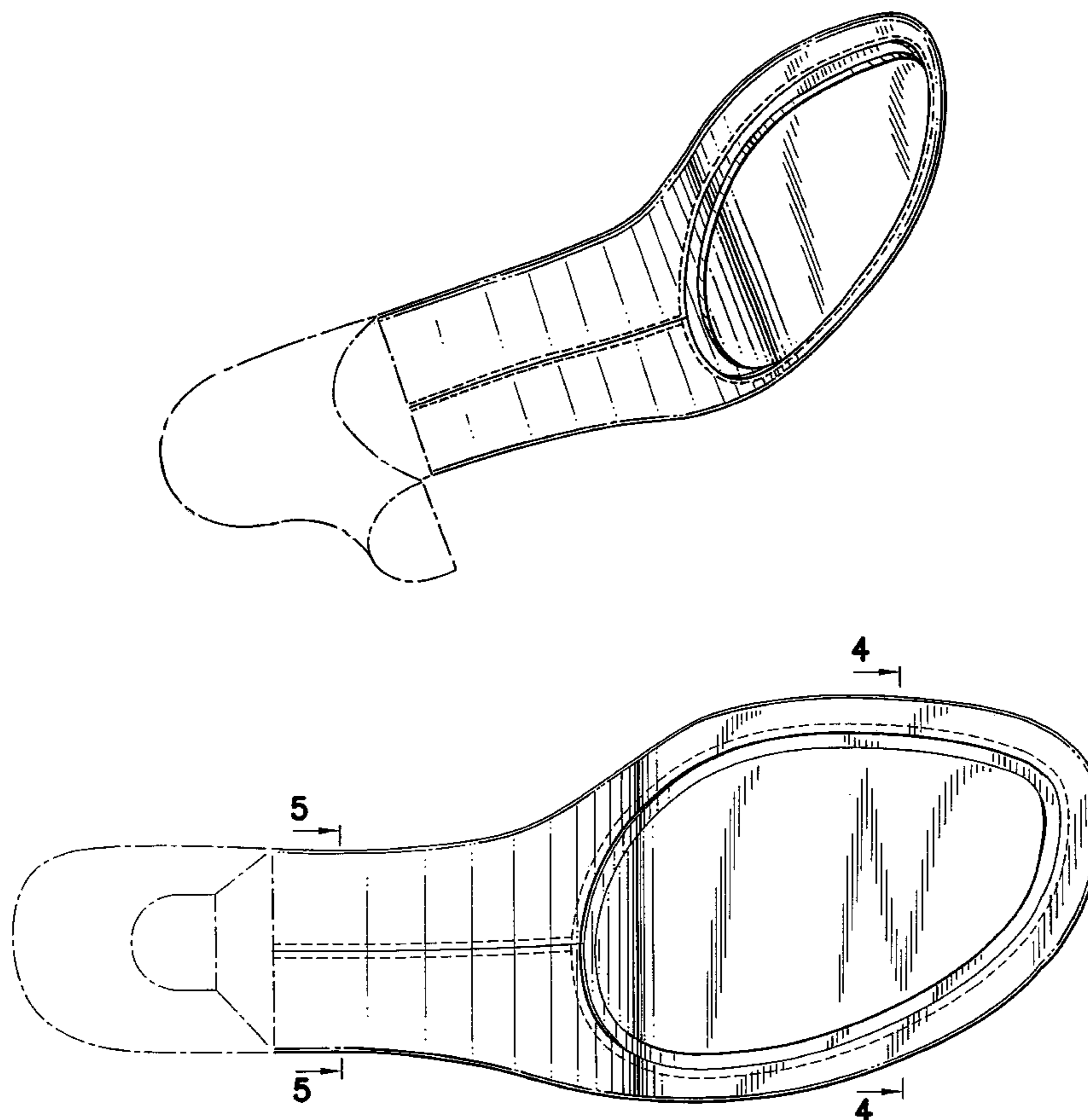
The broken line showing a heel in FIGS. 1-3, and the interior sections in FIGS. 4 and 5, illustrate the portions of the design that form no part of the claim.

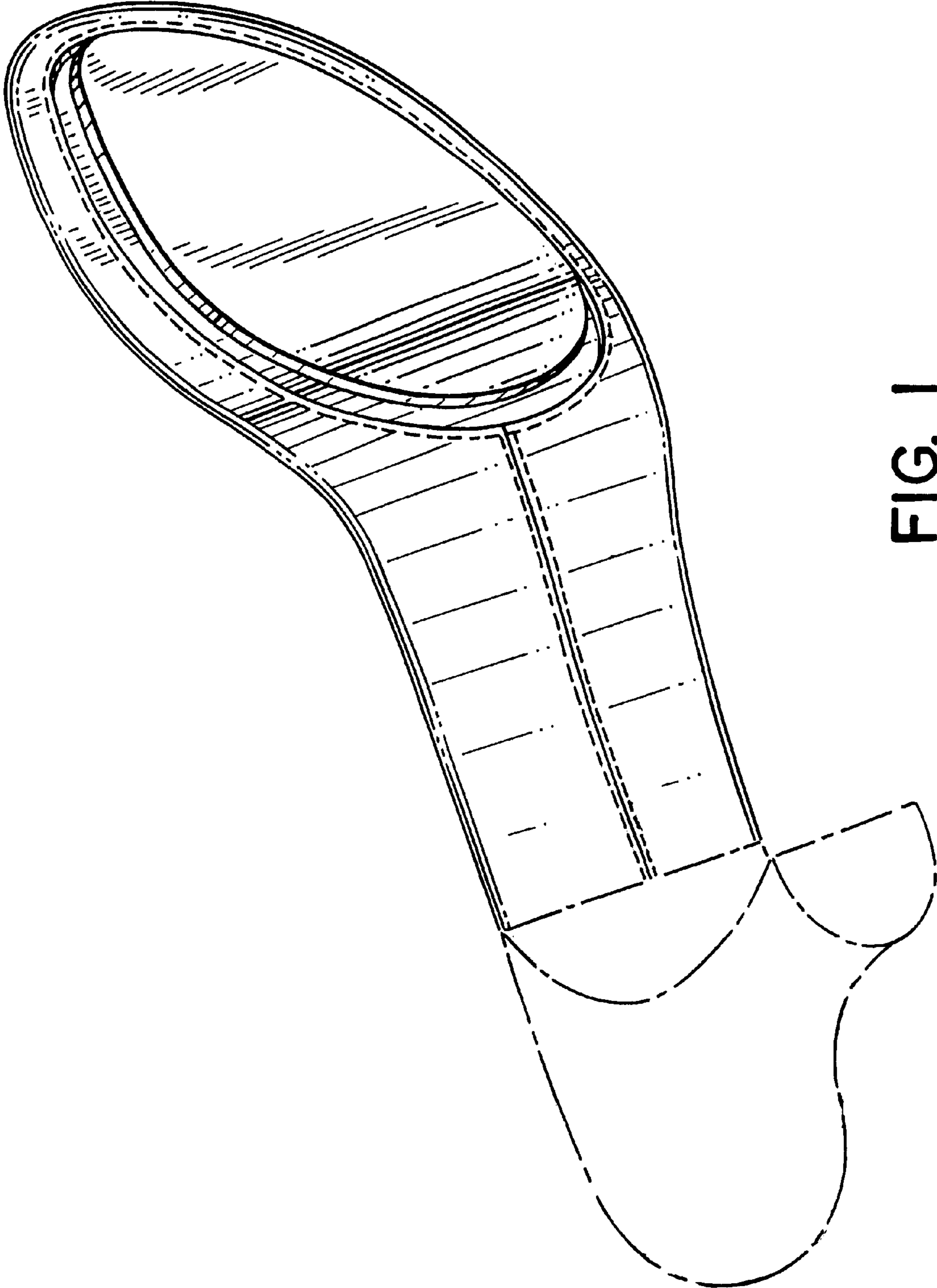

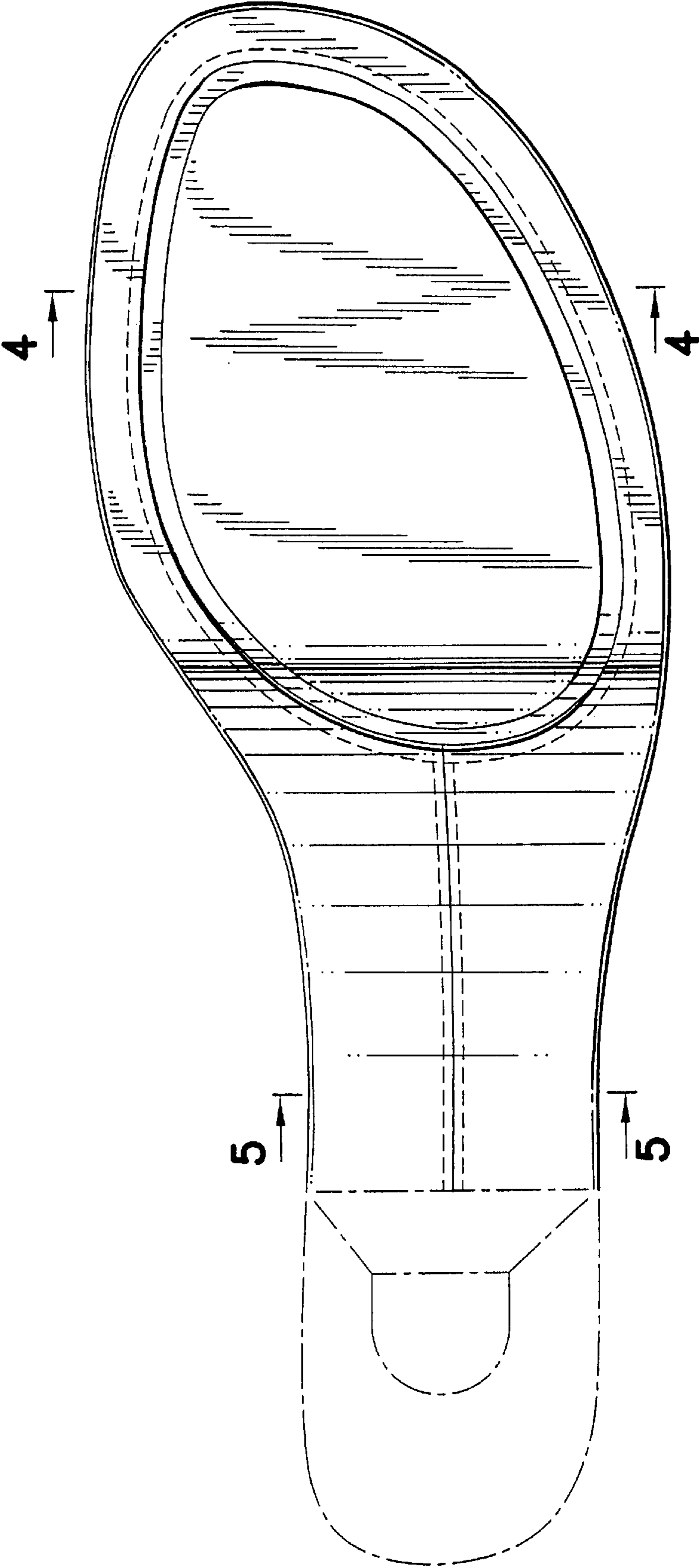

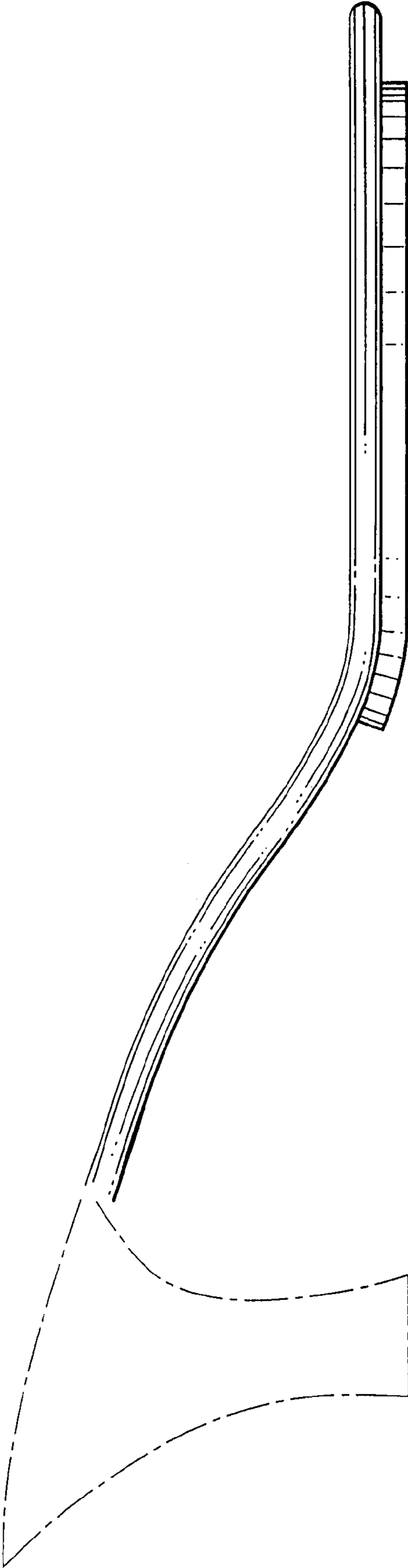

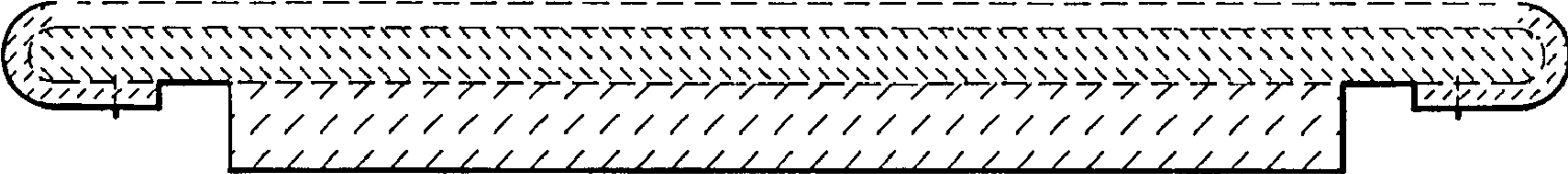

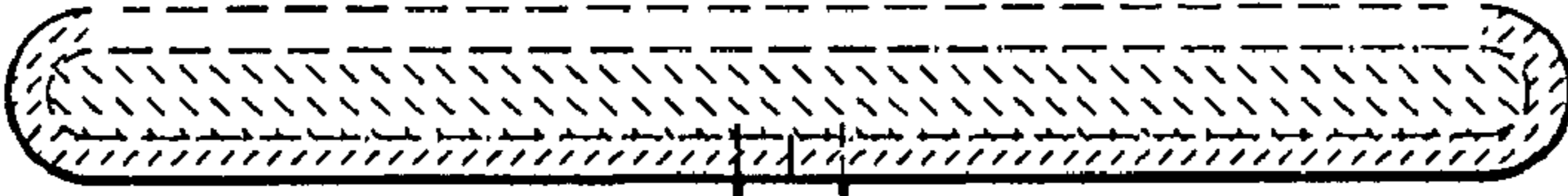
