The ornamental design for a storage container, as shown and described.

DESCRIPTION

FIG. 1 is a front, right, perspective view of a storage container showing our design;

FIG. 2 is a back, left, perspective view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a left, side view thereof, the right side view being a mirror image of the left, side view;

FIG. 6 is a front view thereof; and,

FIG. 7 is a back view thereof.

The broken lines showing mounting portions, openings, recesses, and auxiliary engaging structures are for illustrative purpose only and form no part of the claimed design.

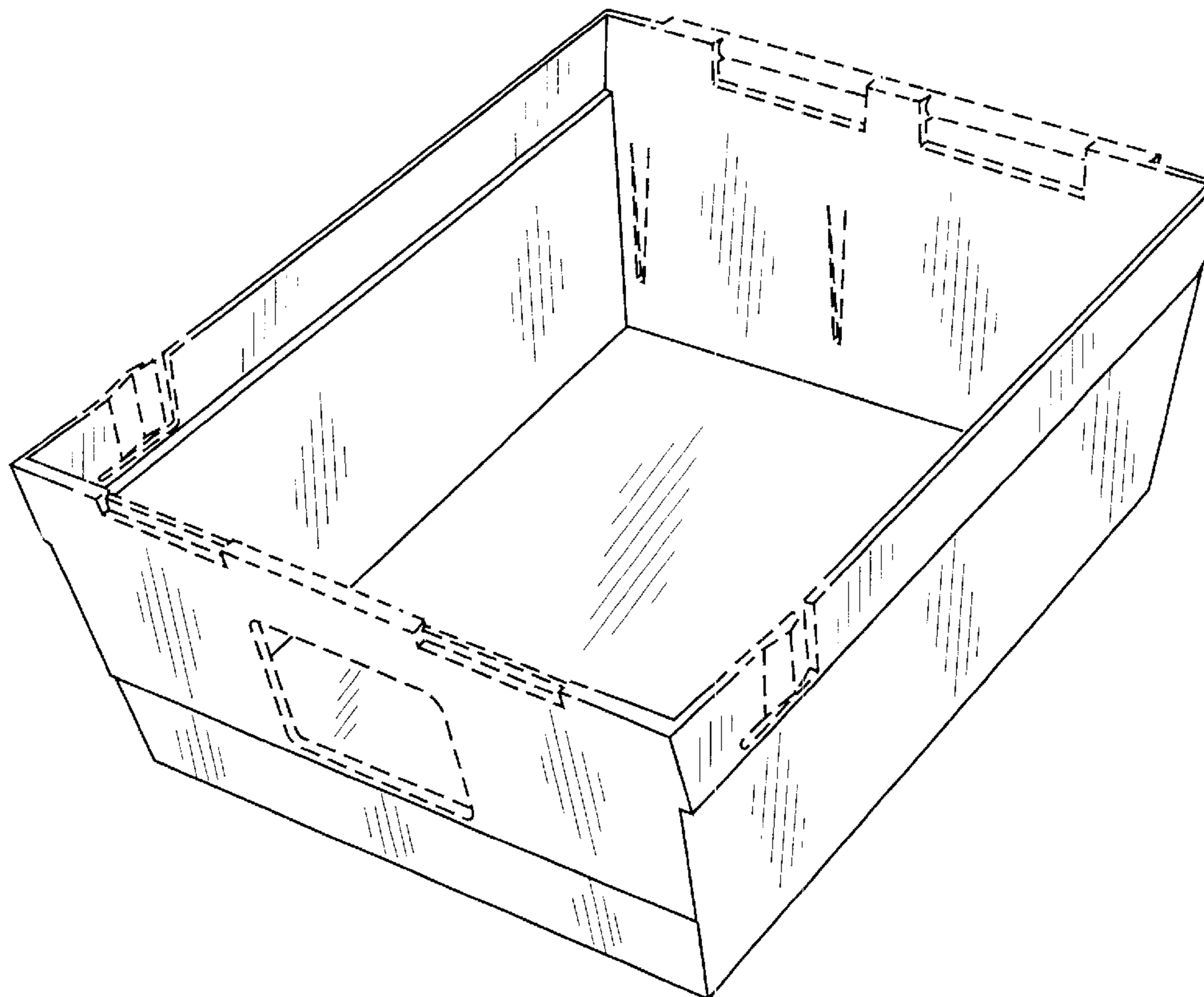

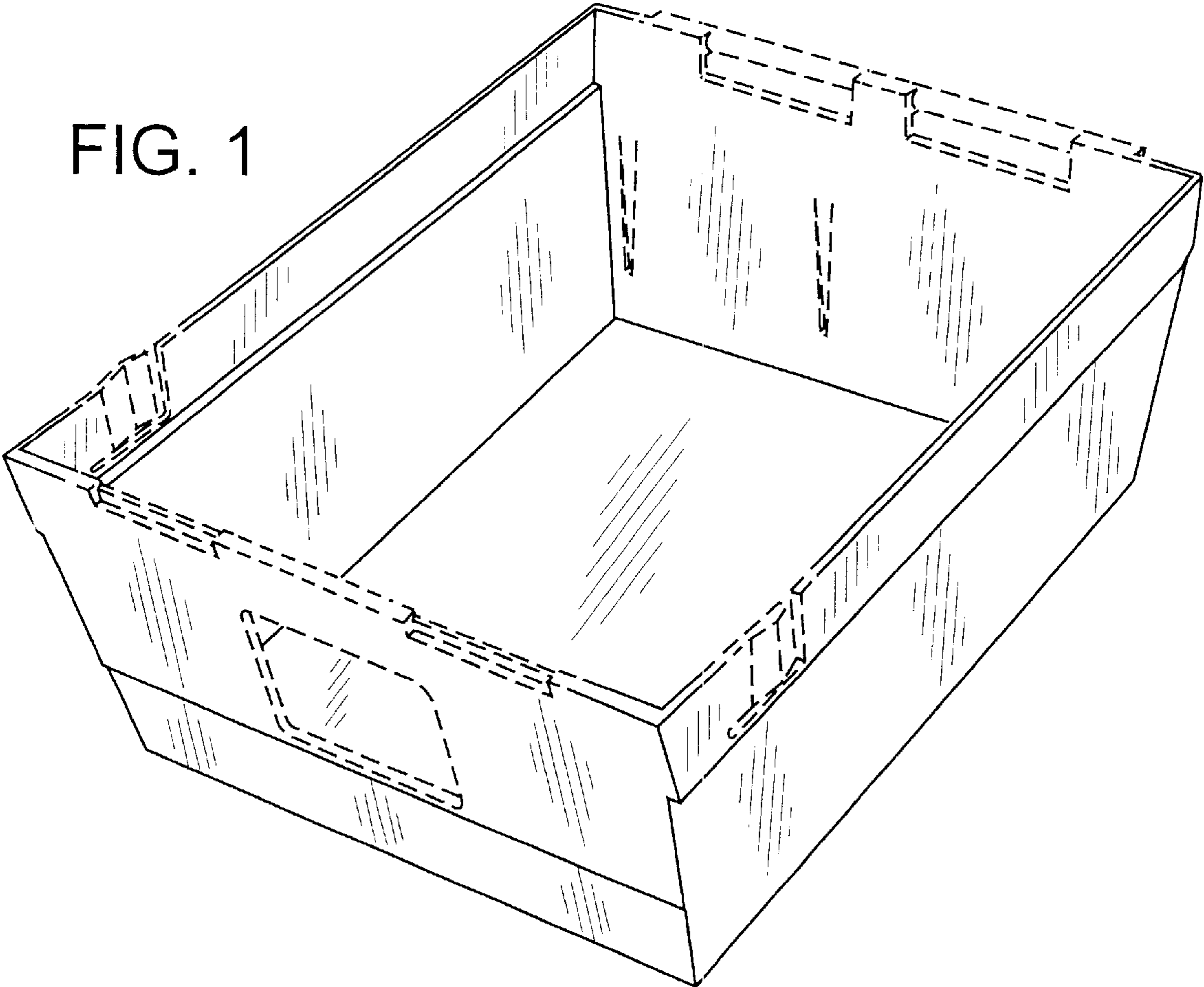

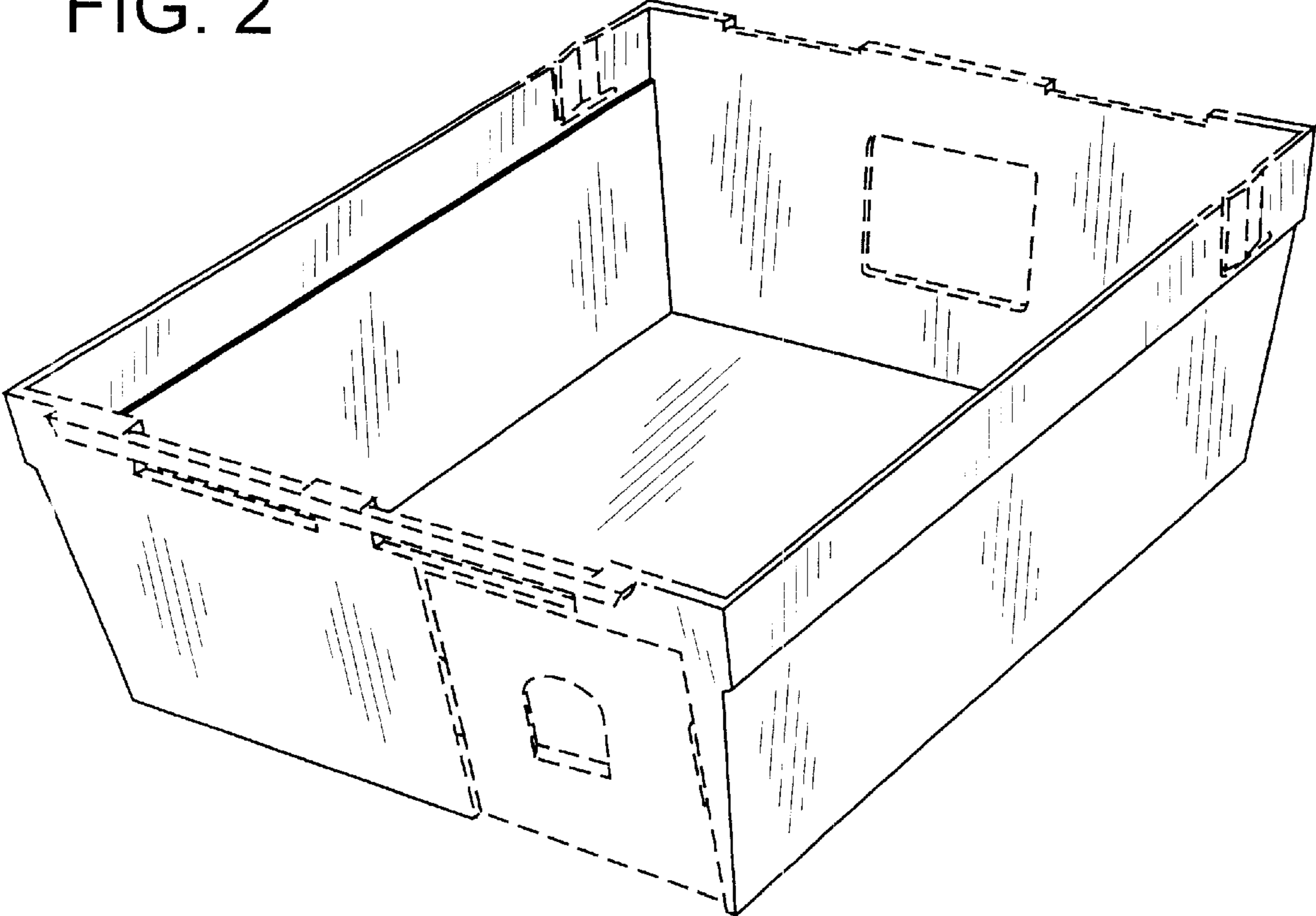

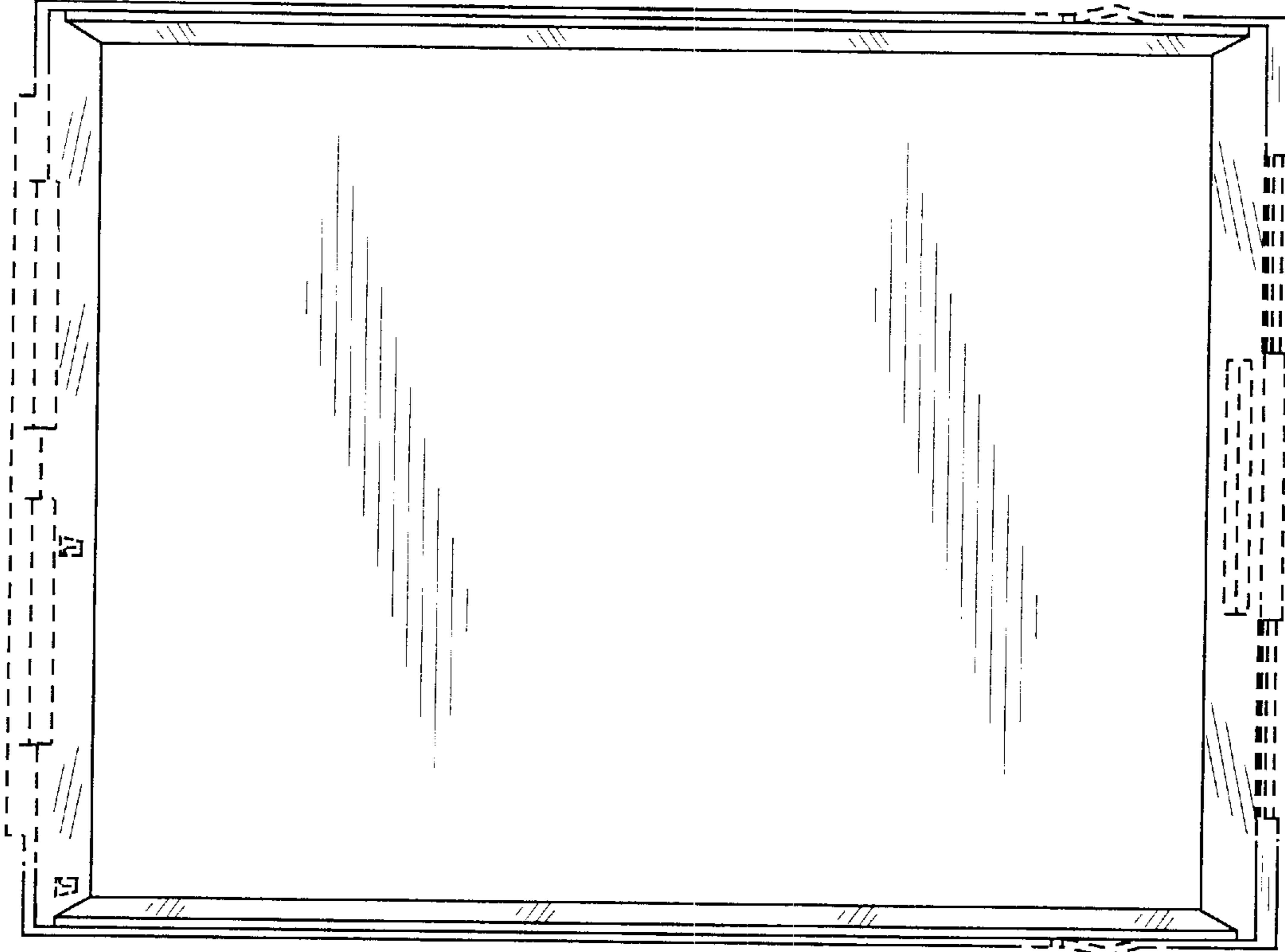

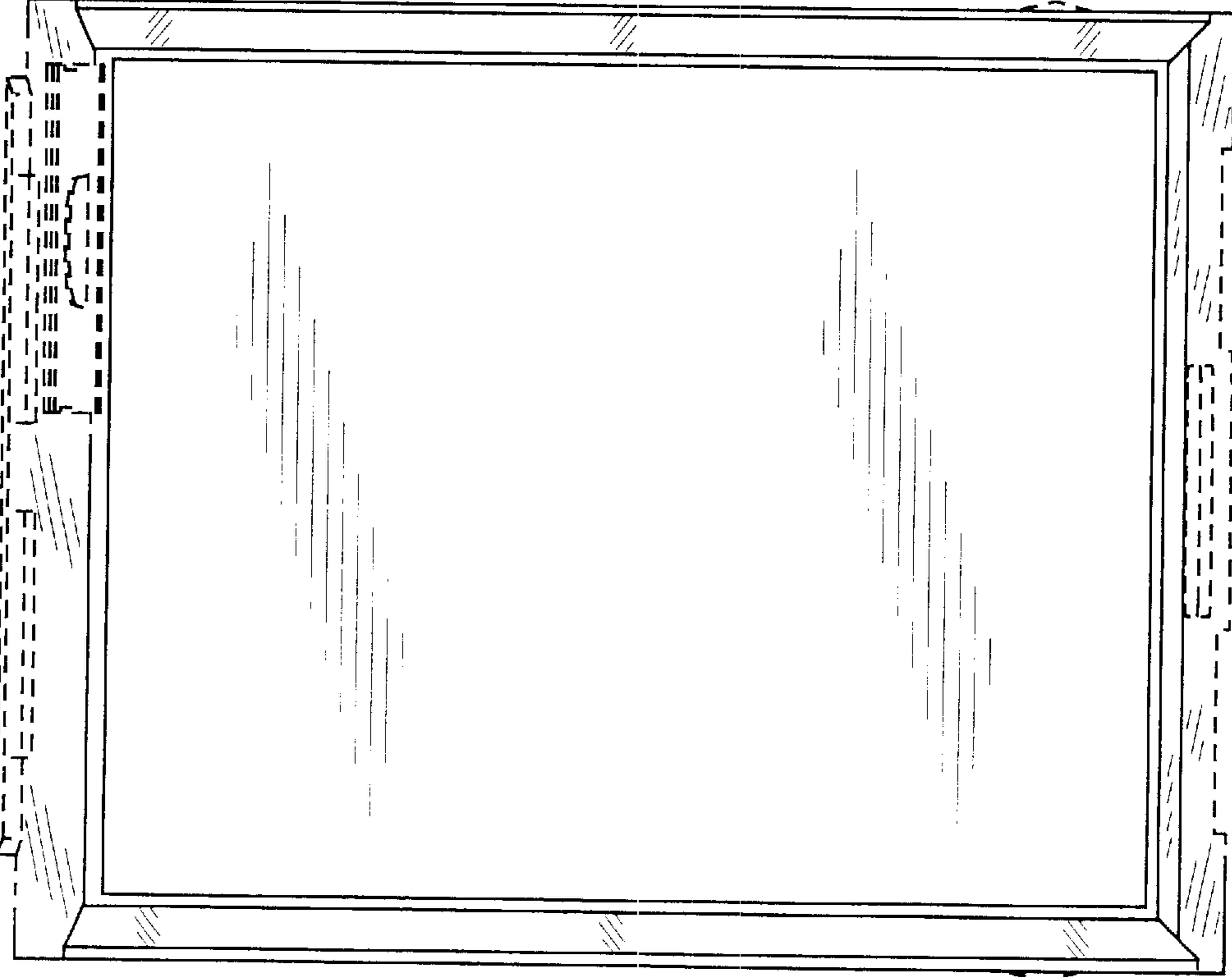

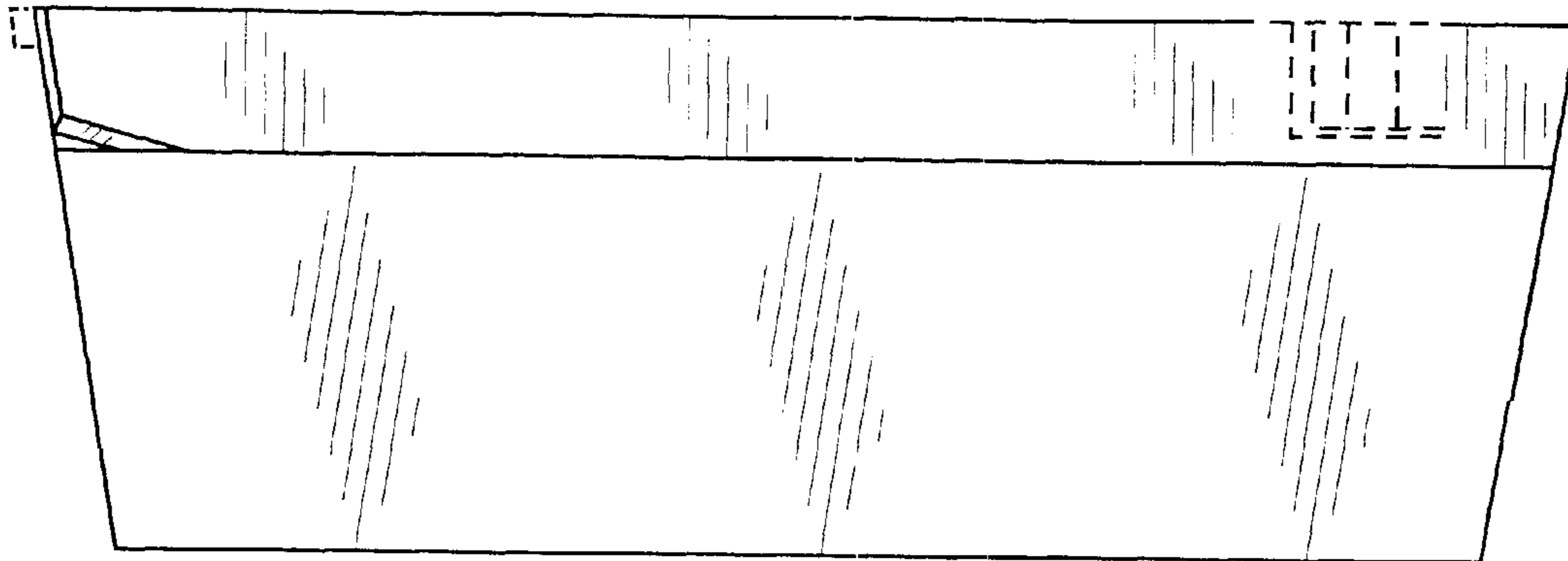

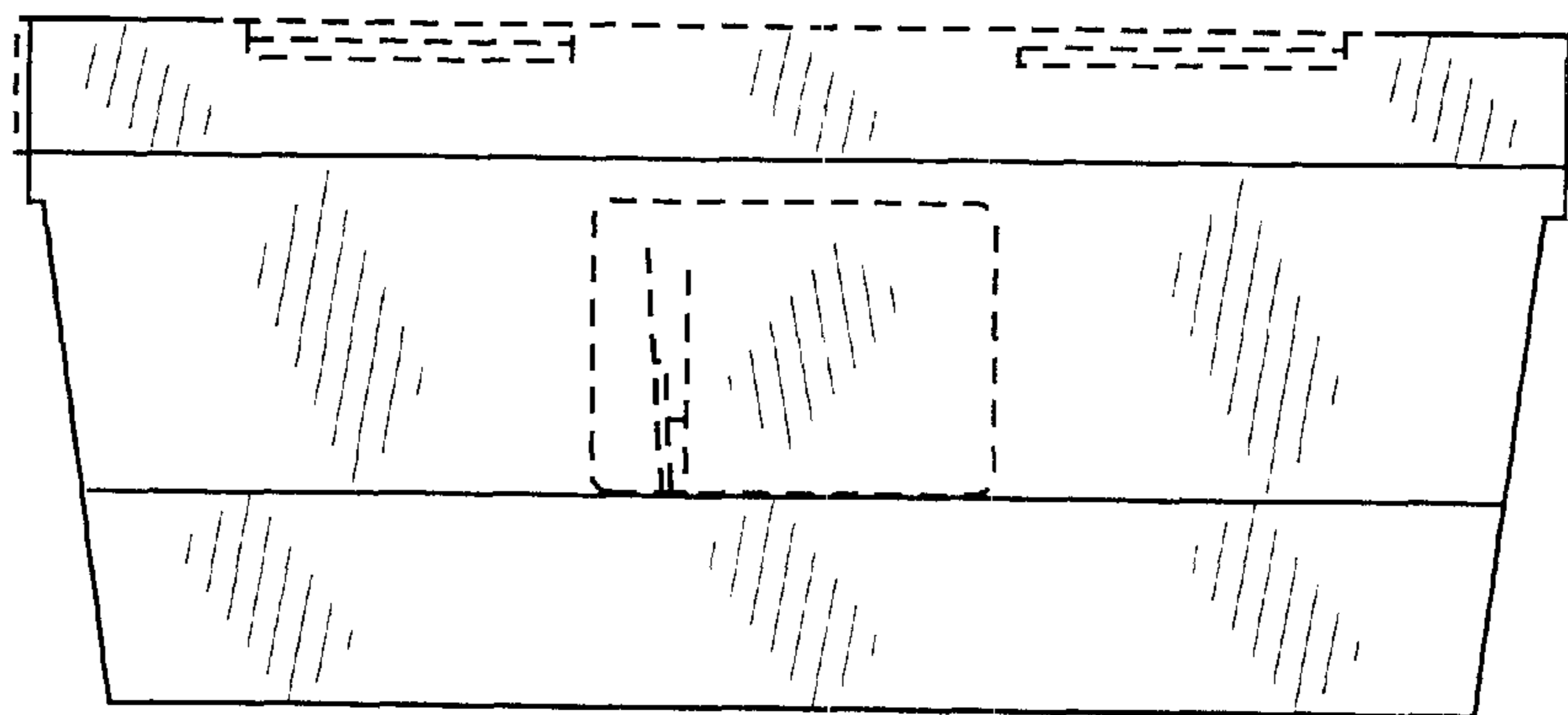
