The ornamental design for a shelf unit, as shown and described.

**DESCRIPTION**

FIG. 38 is a front elevational view of the shelf unit thereof;

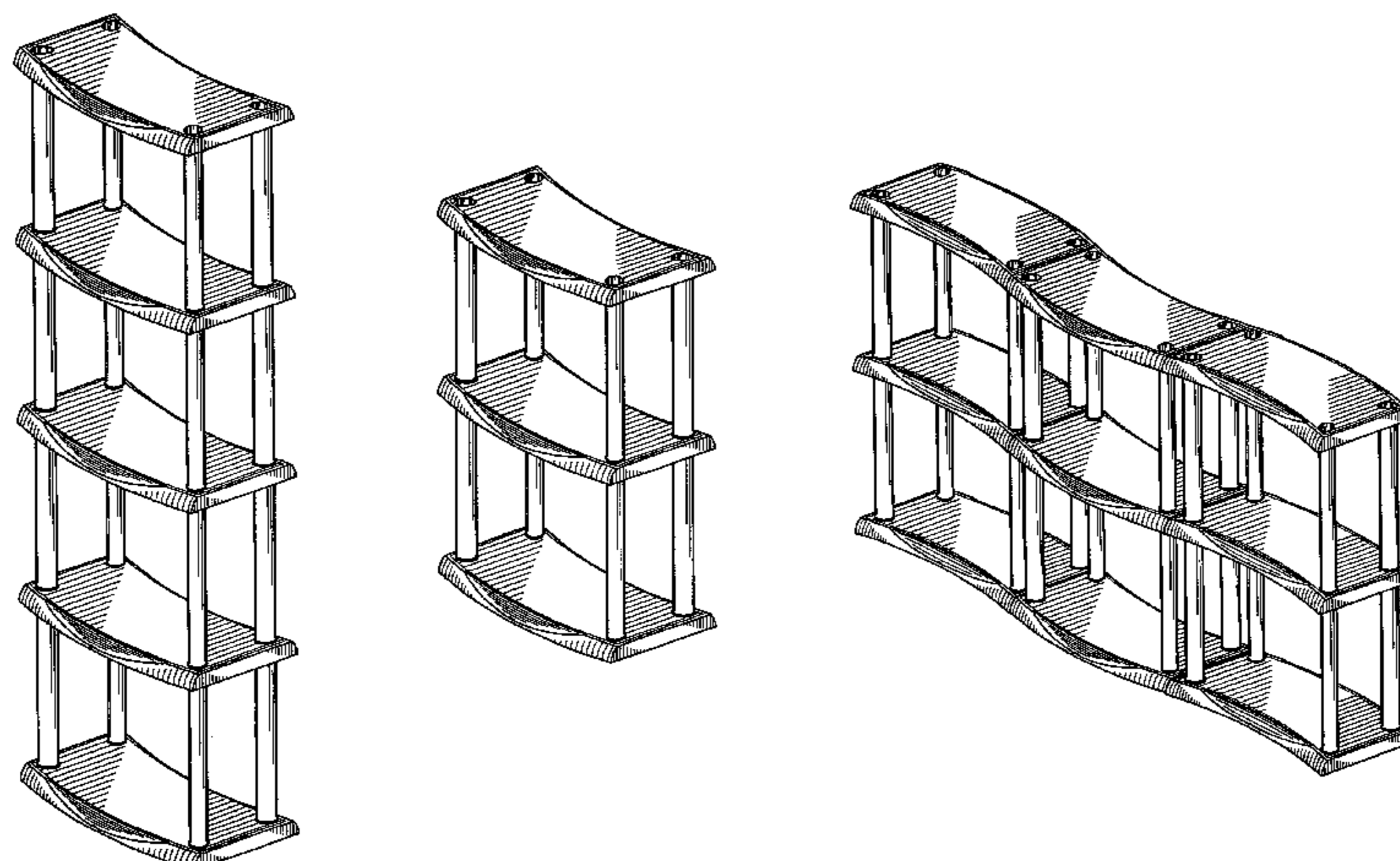
FIG. 39 is an end elevational view of the shelf unit thereof;

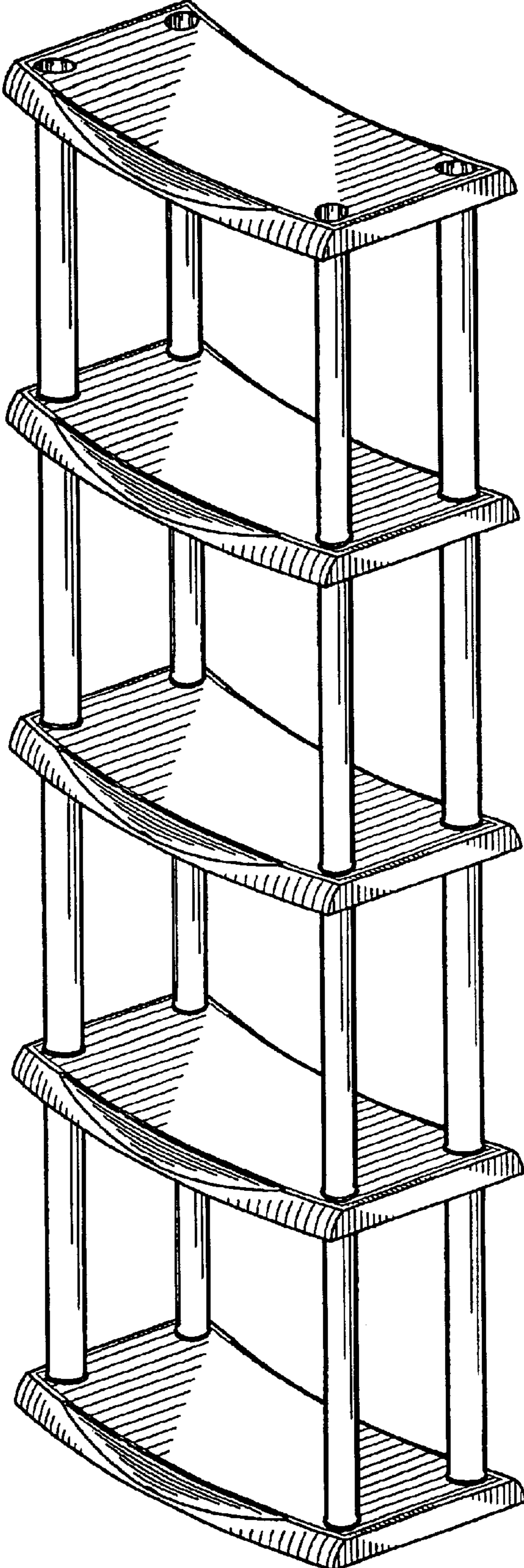

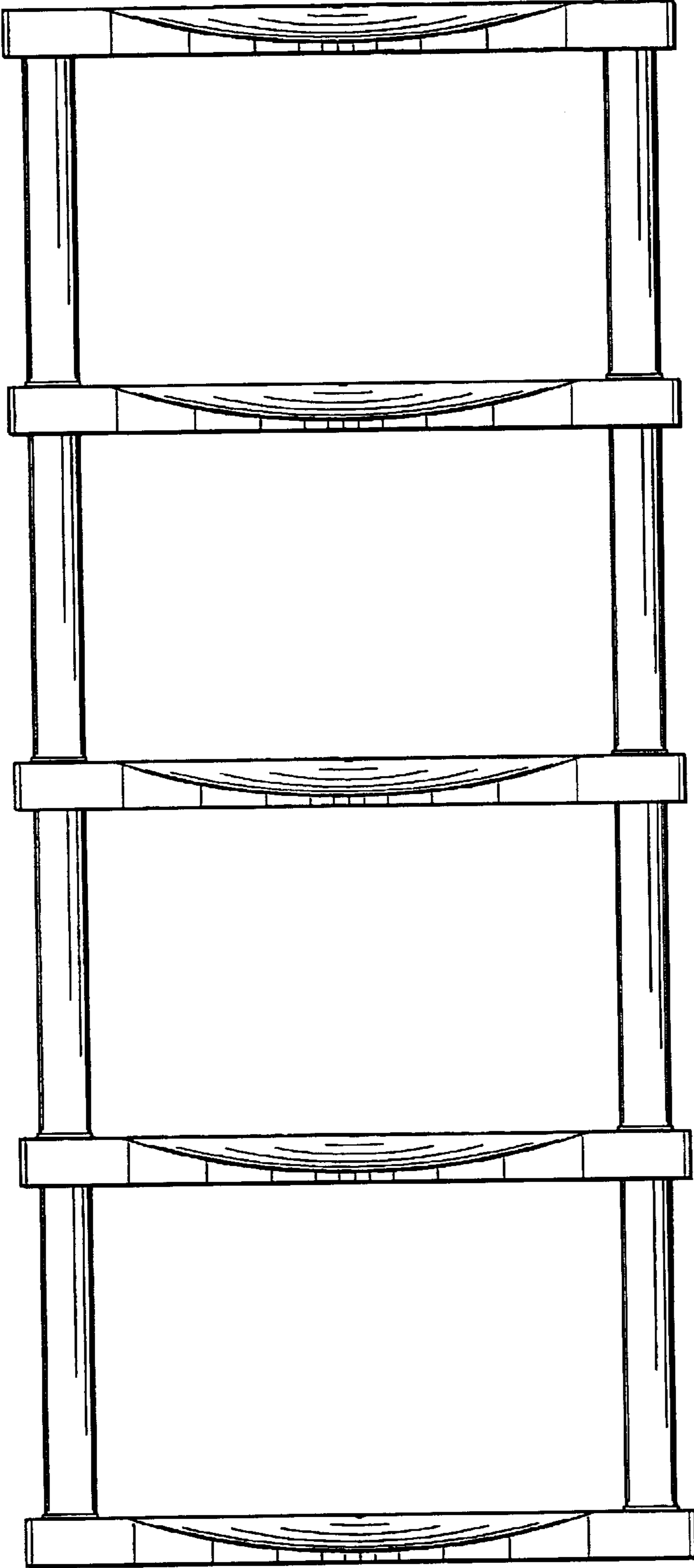

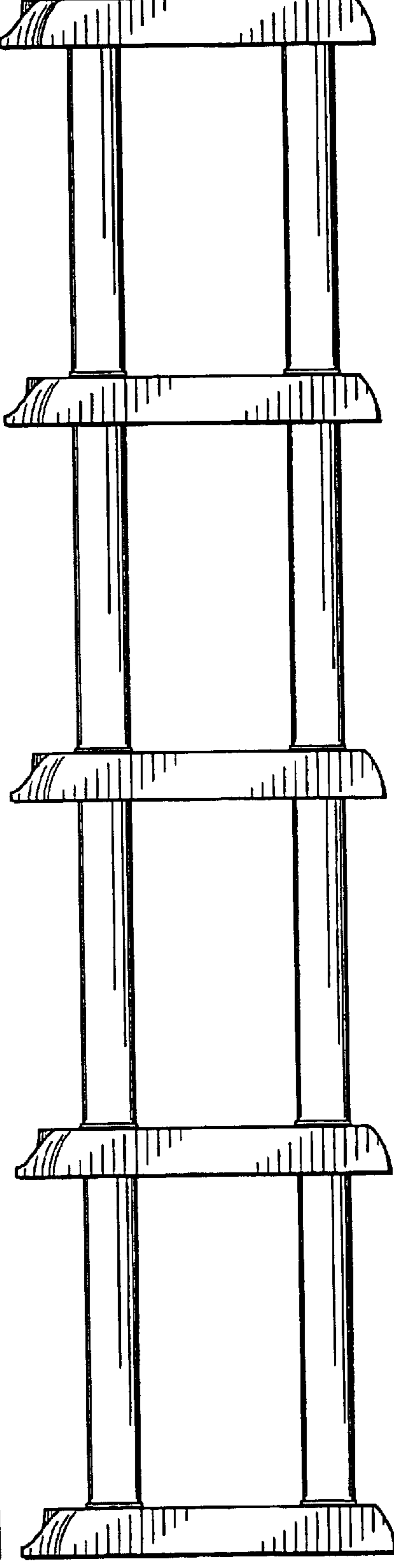

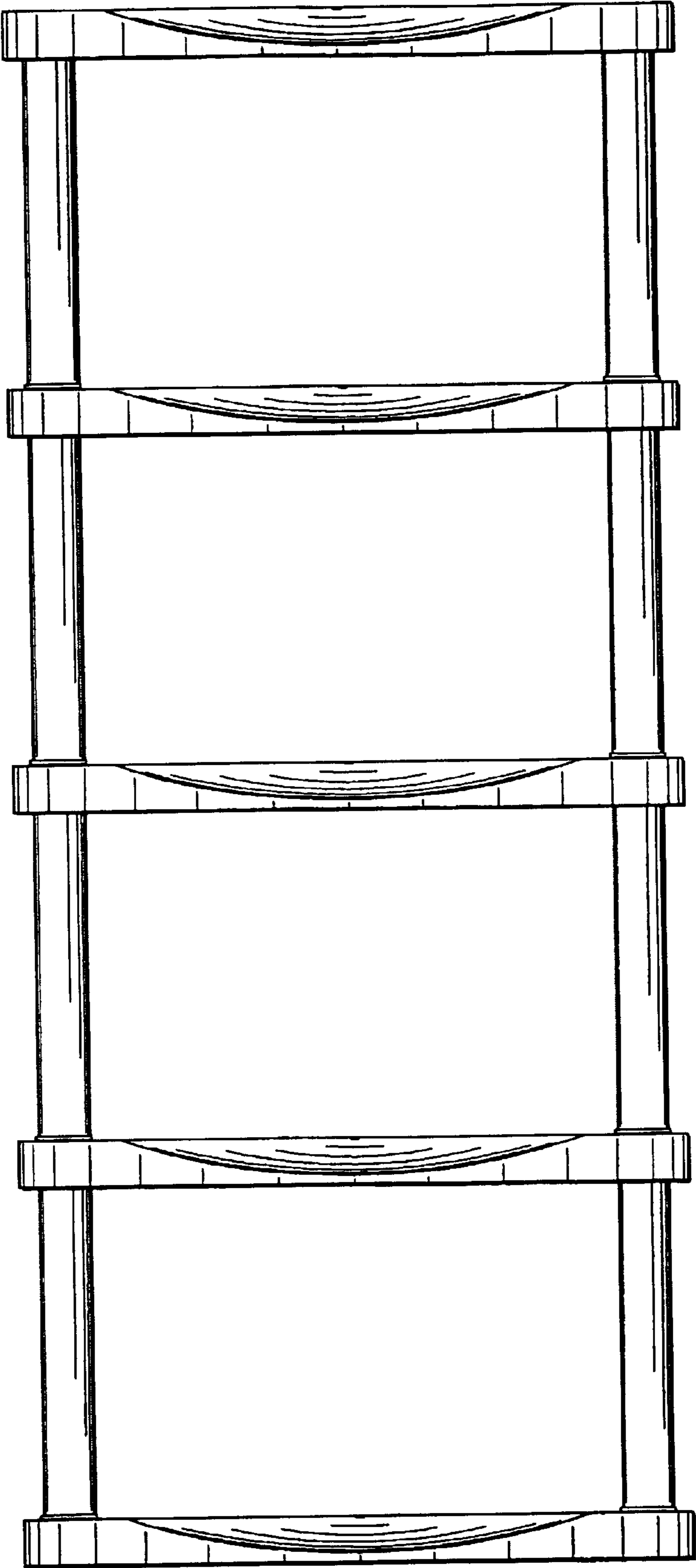

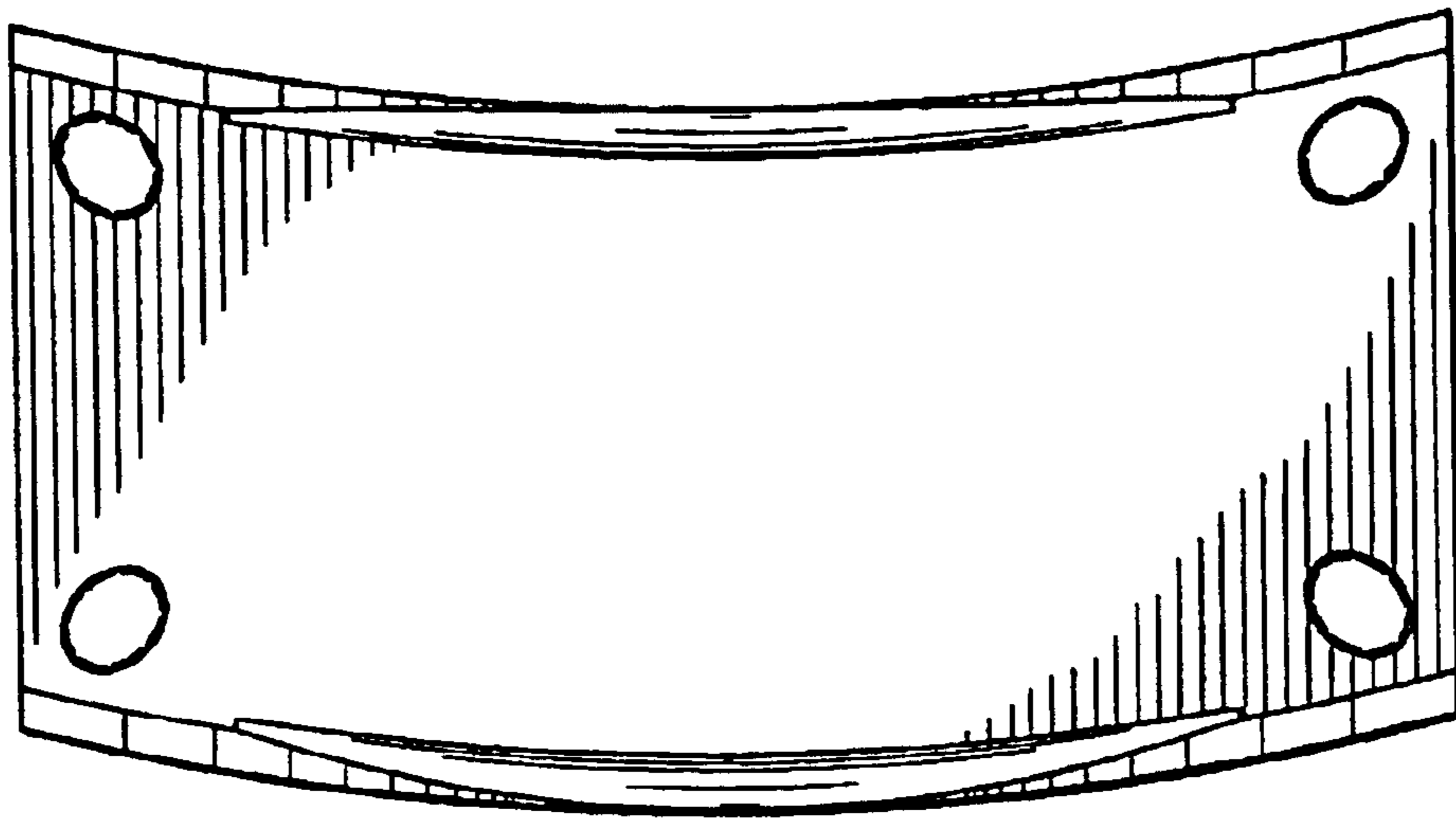

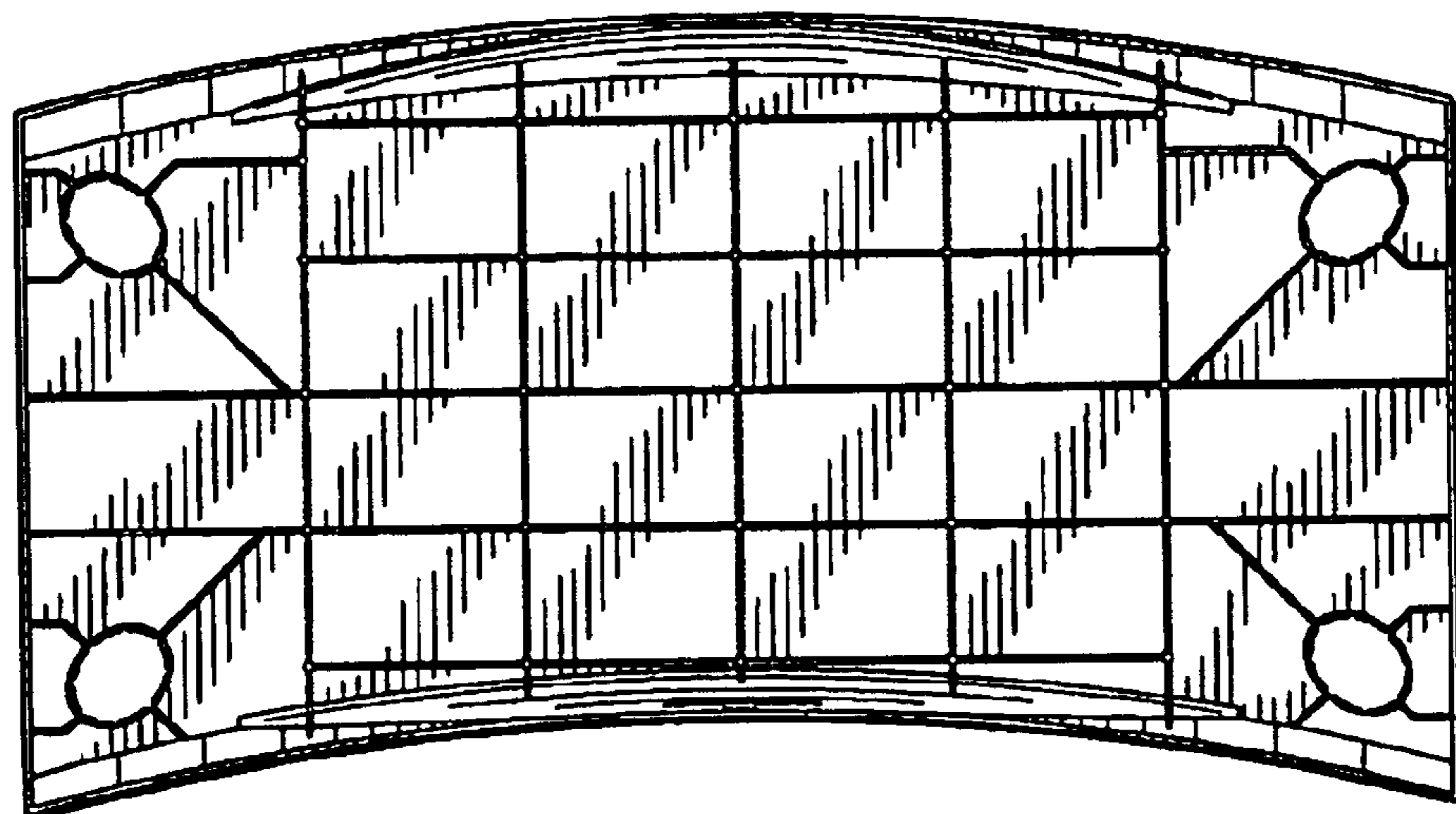

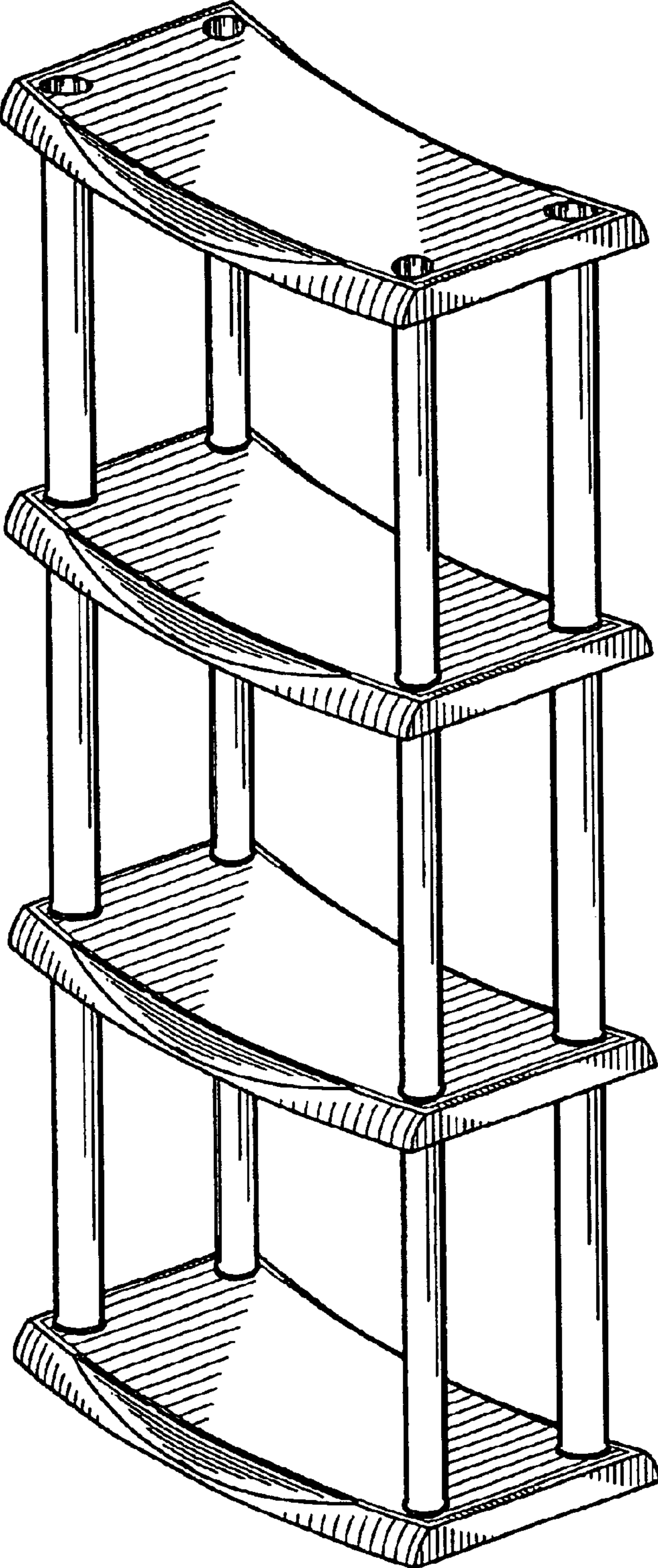

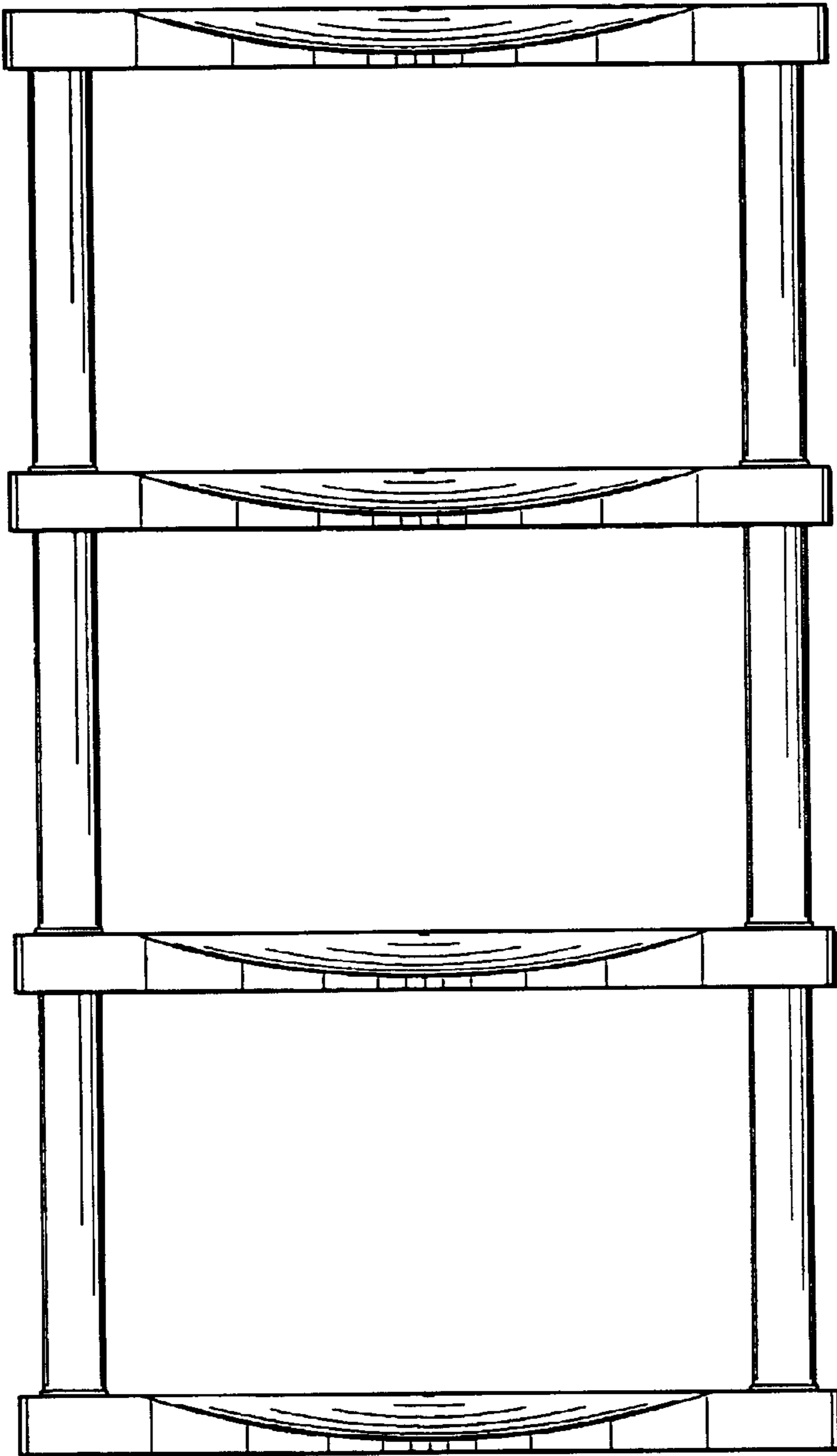

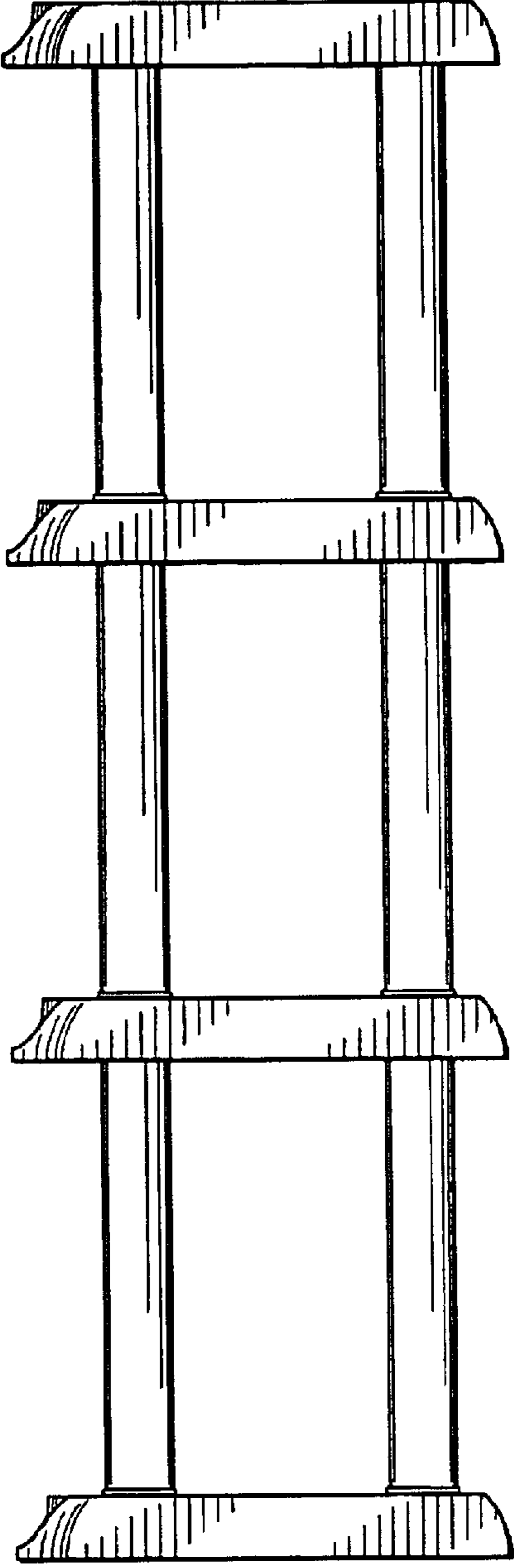

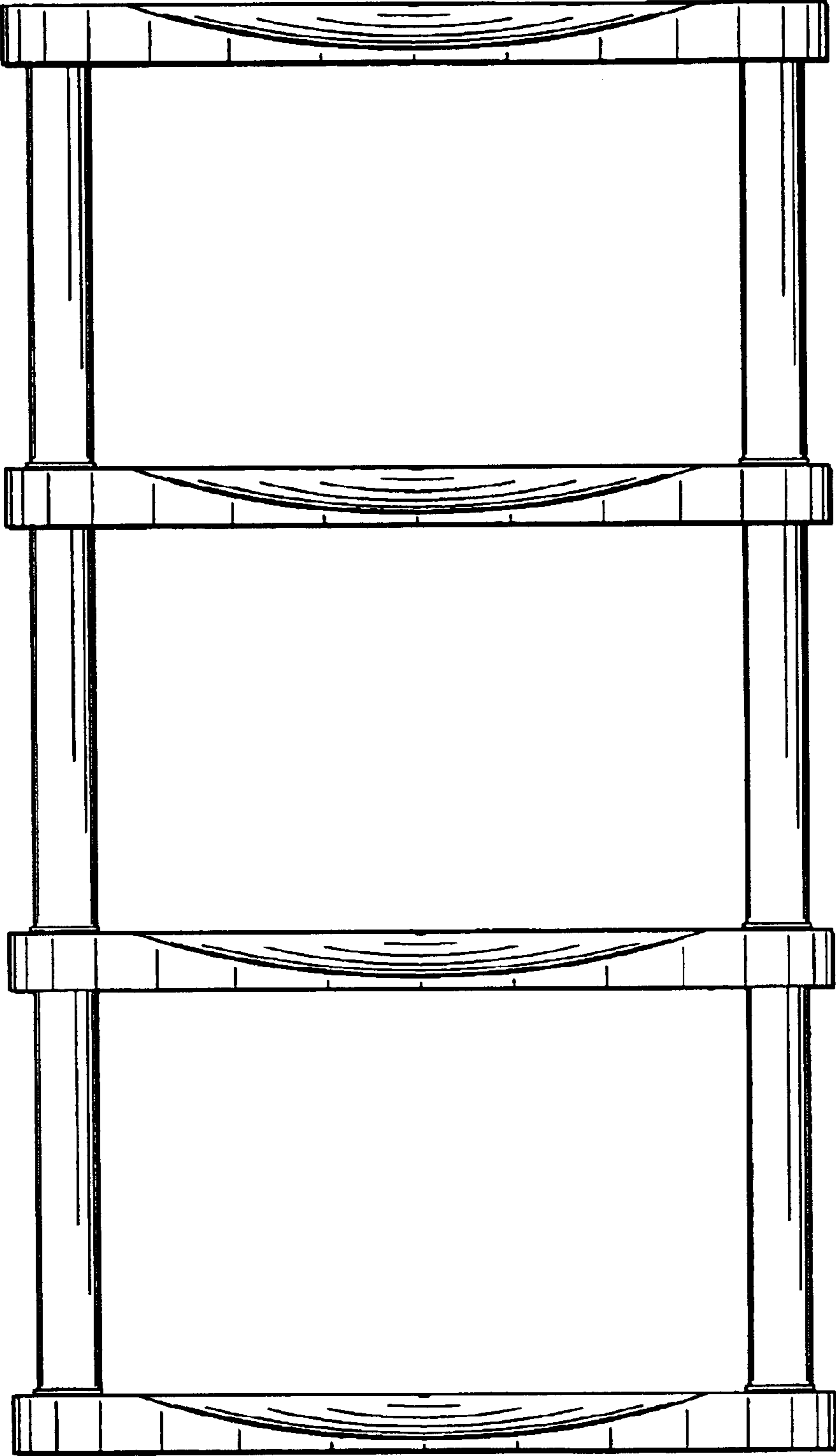

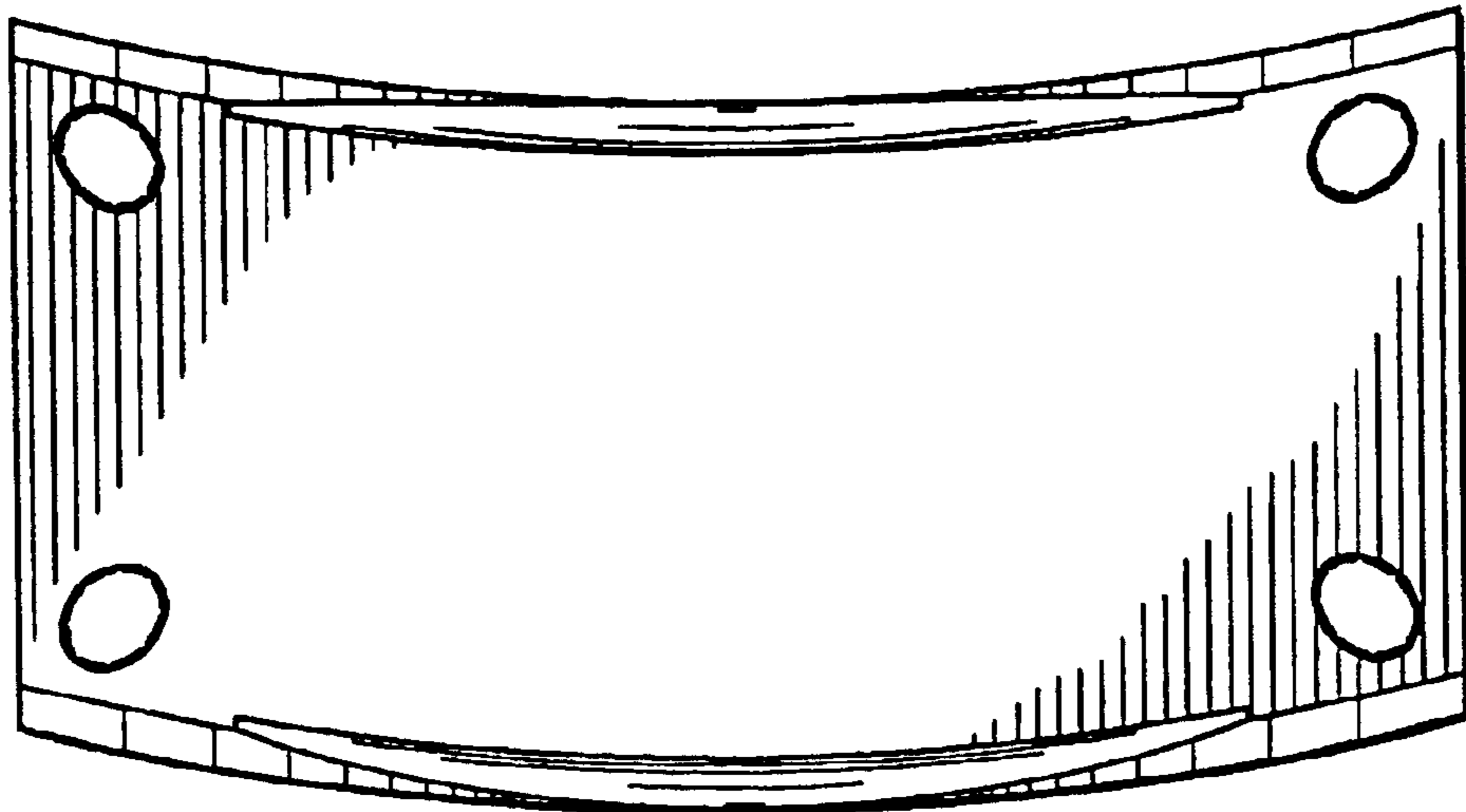

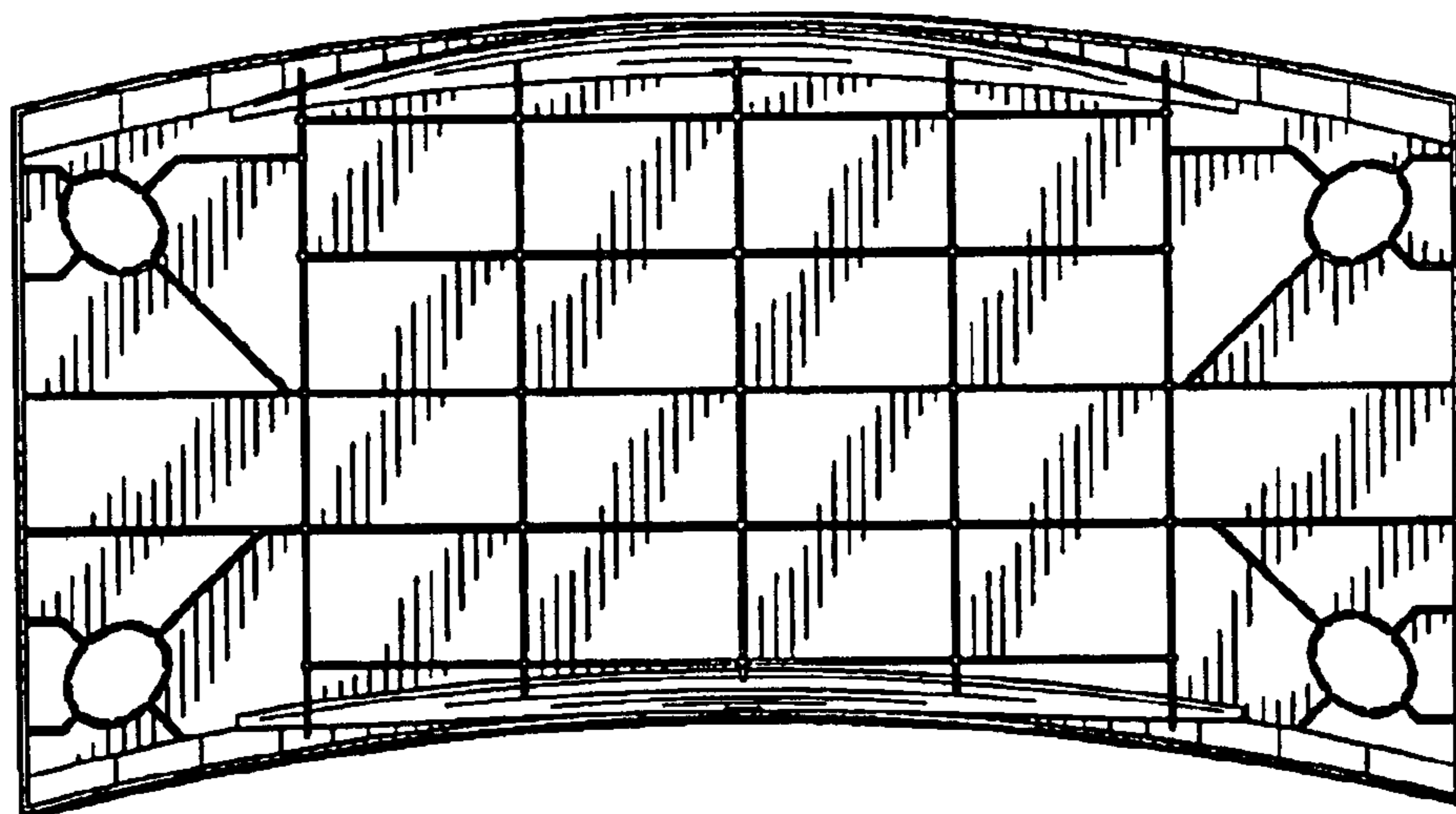

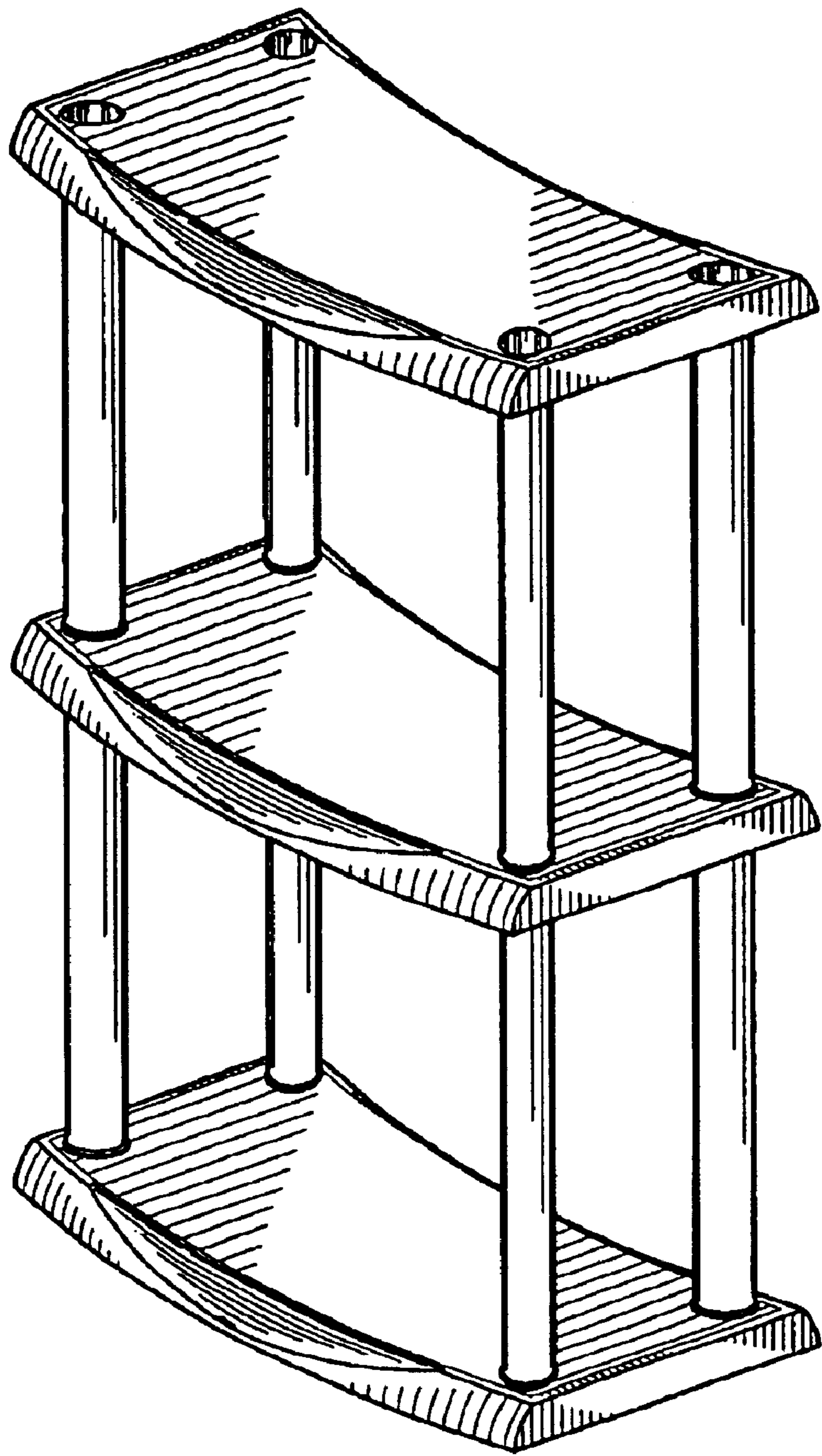

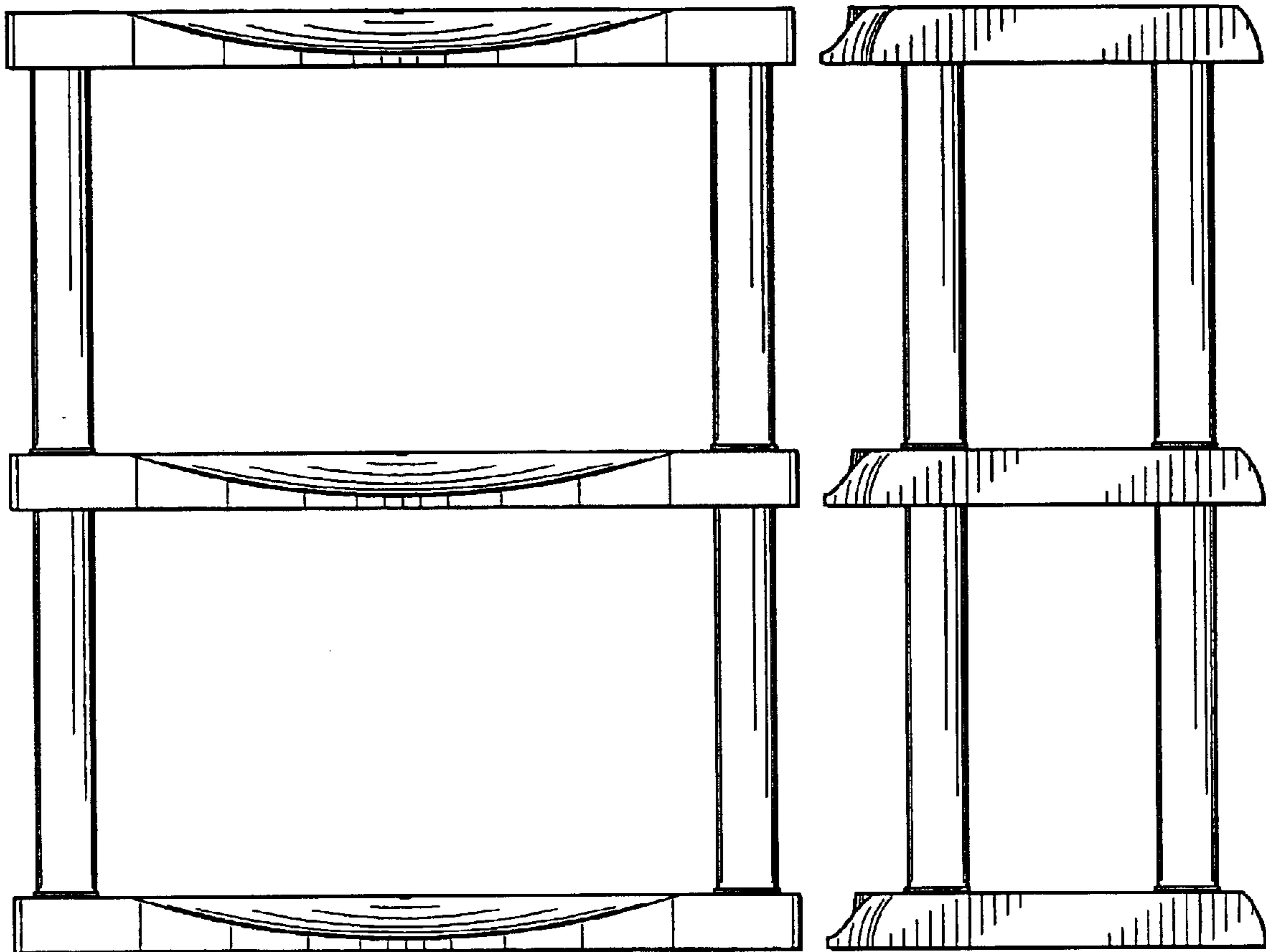

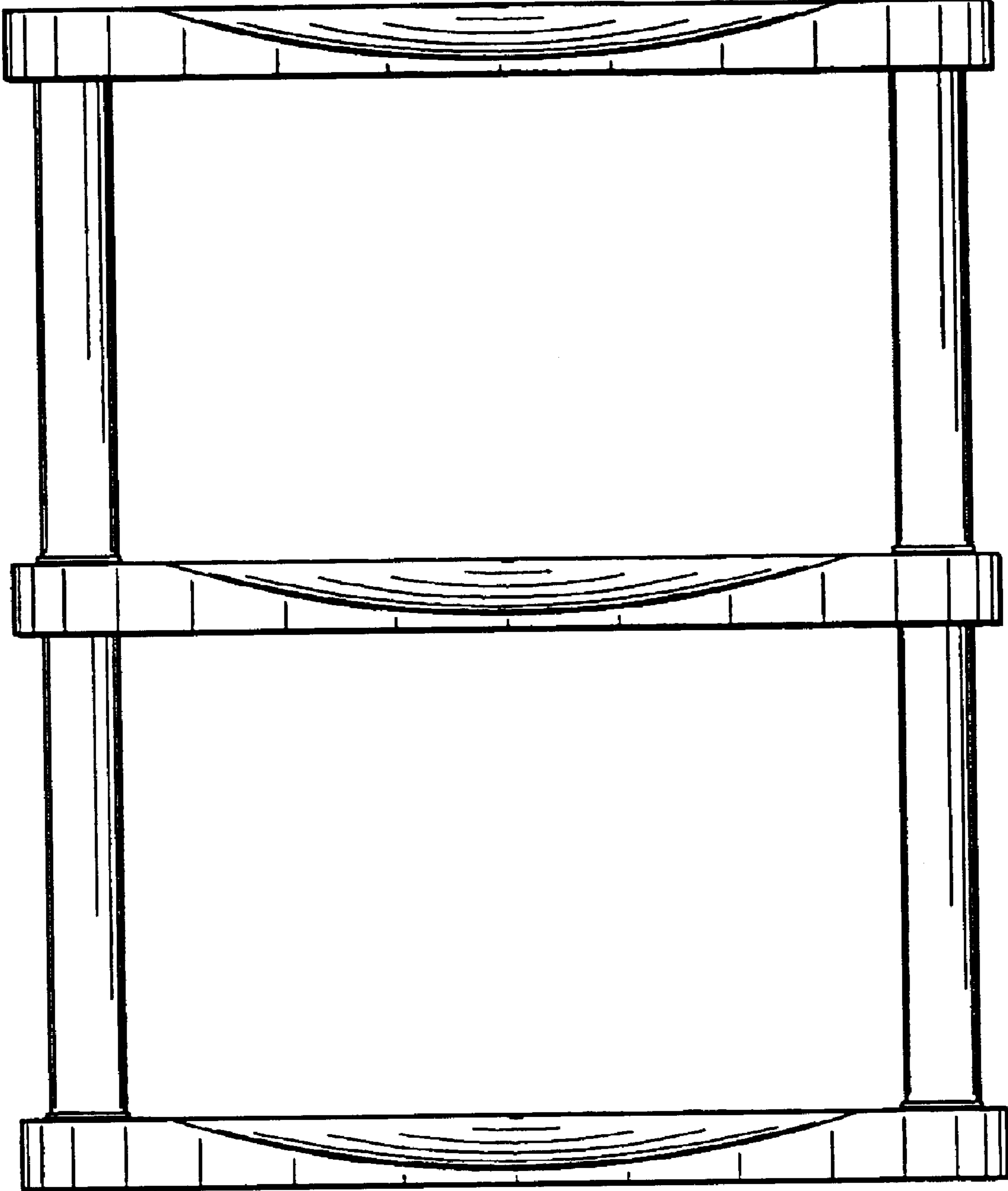

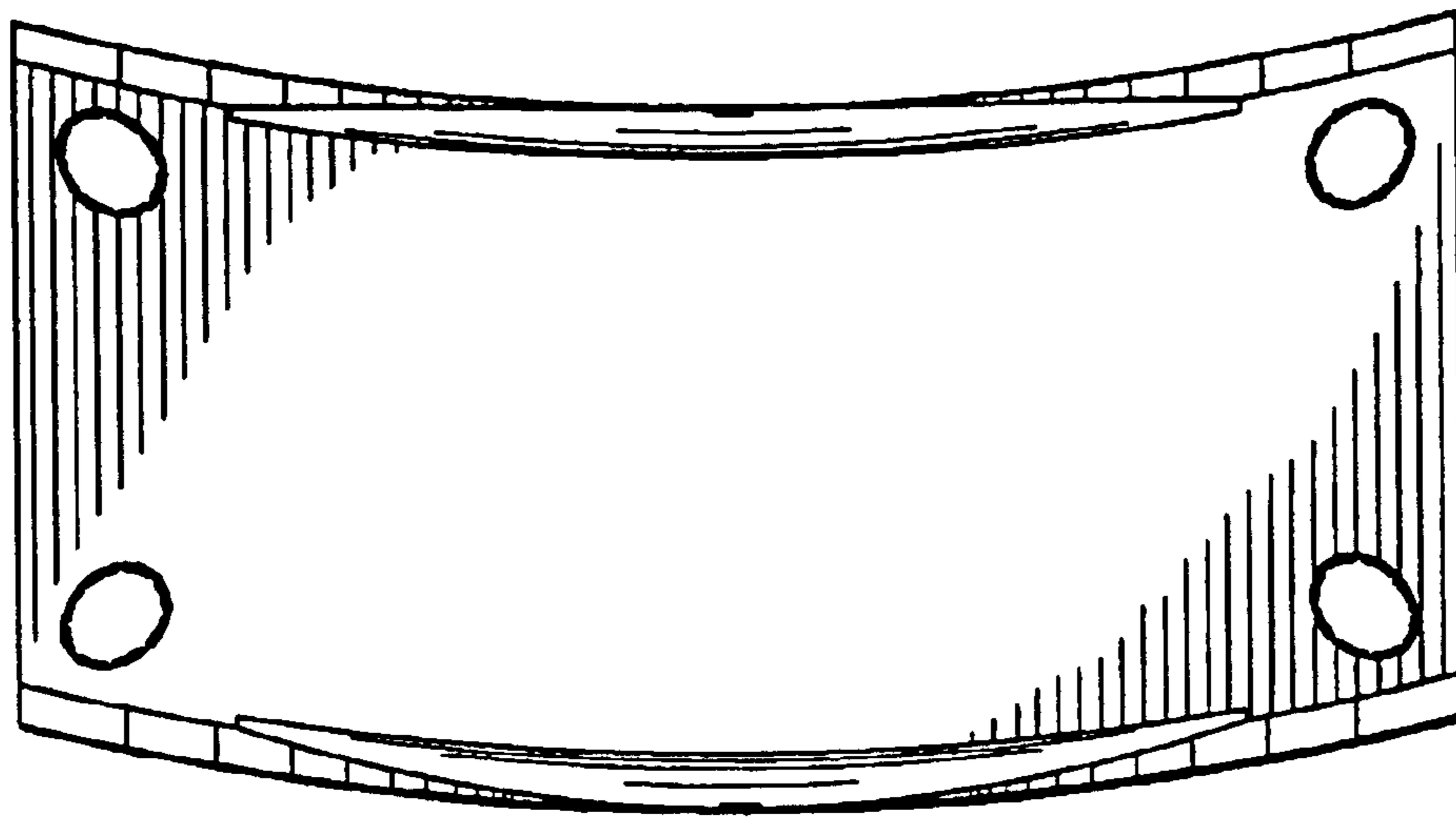

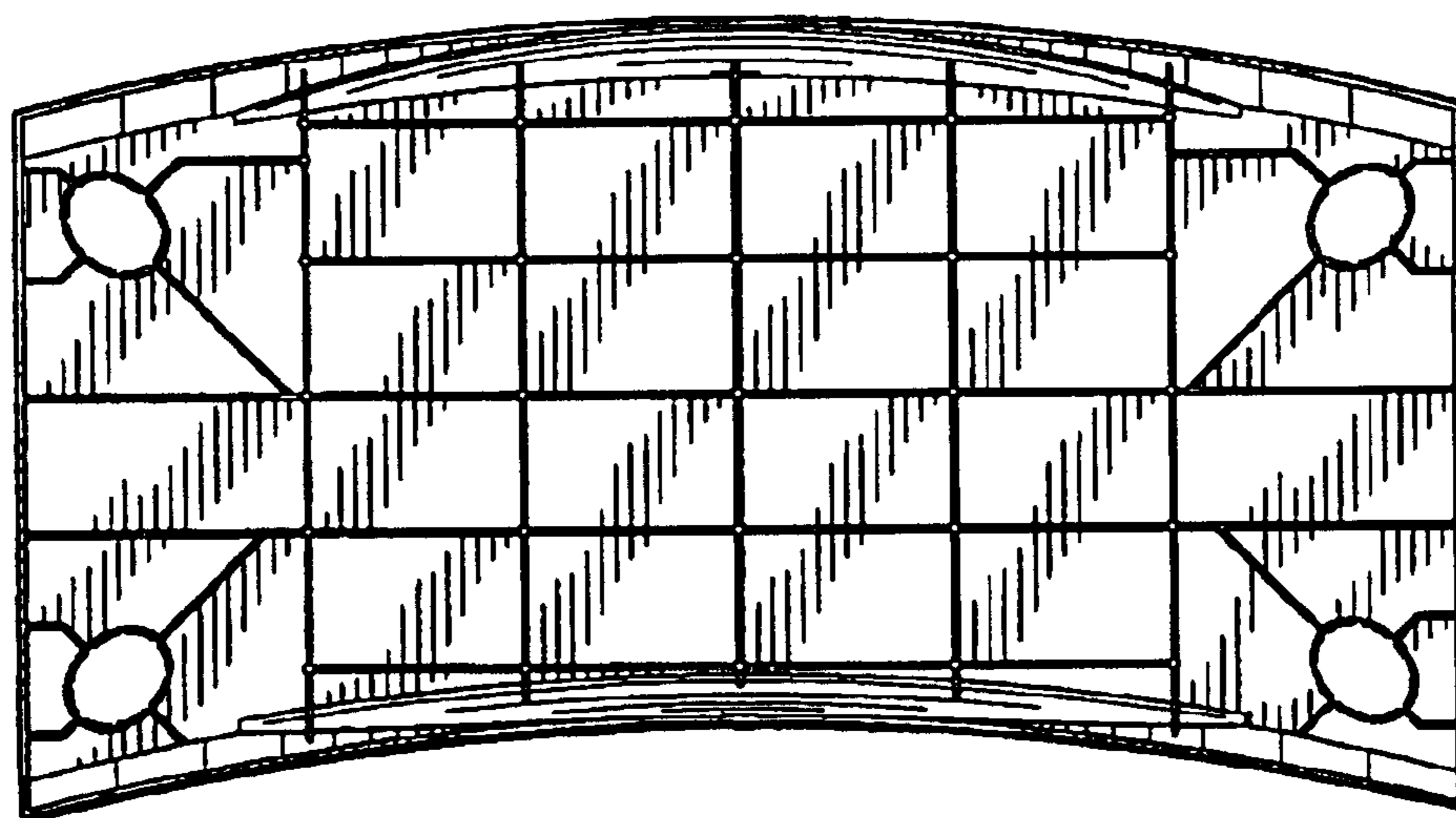

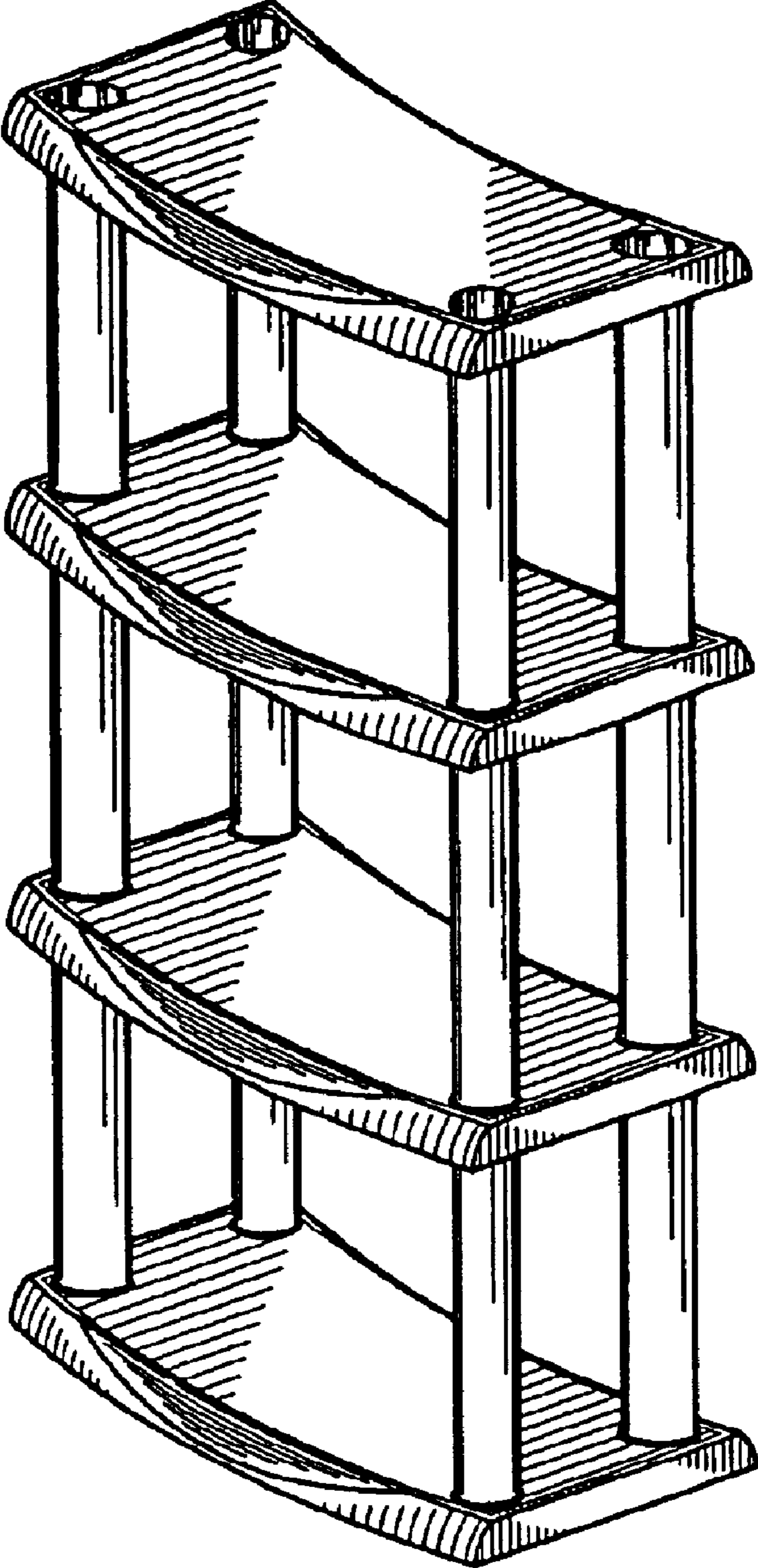

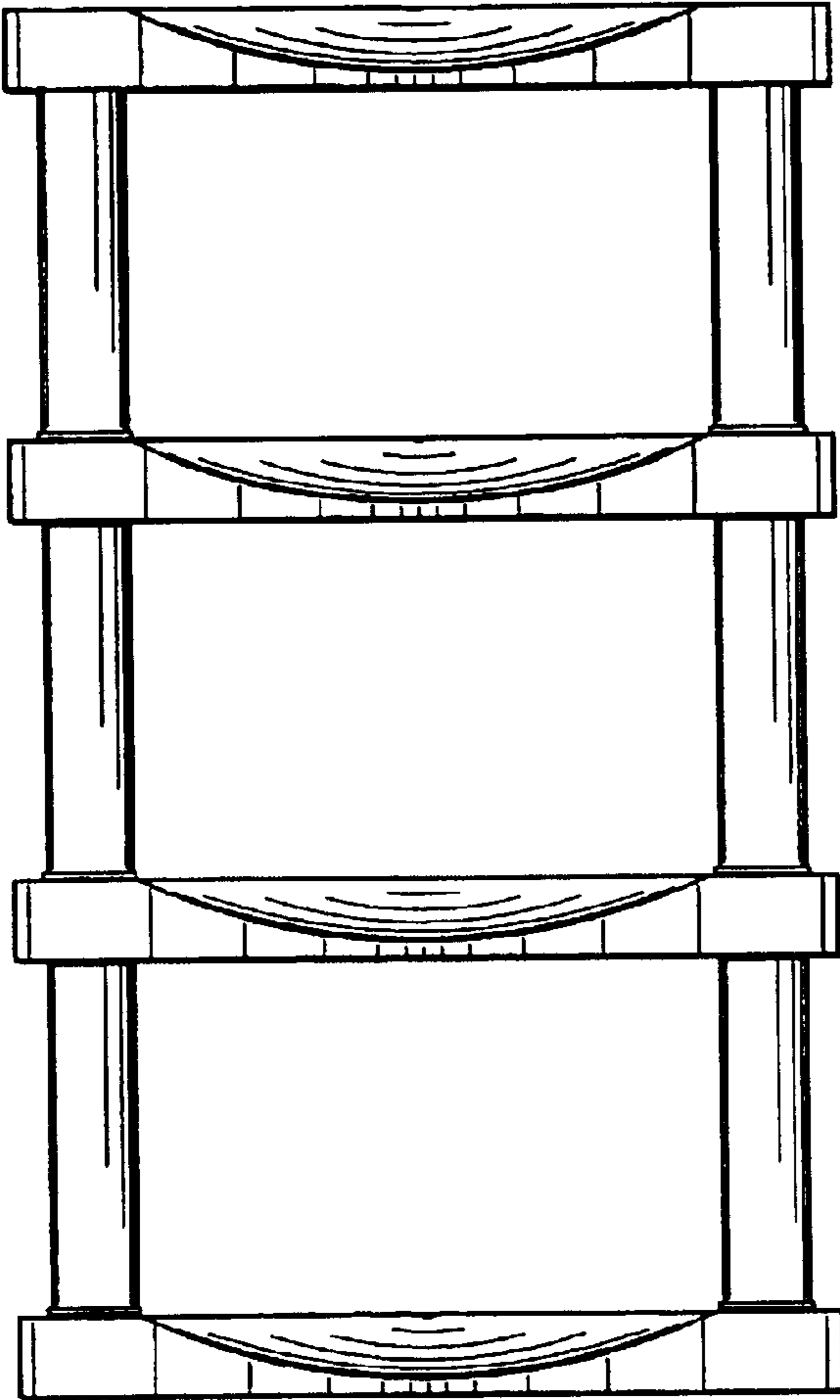

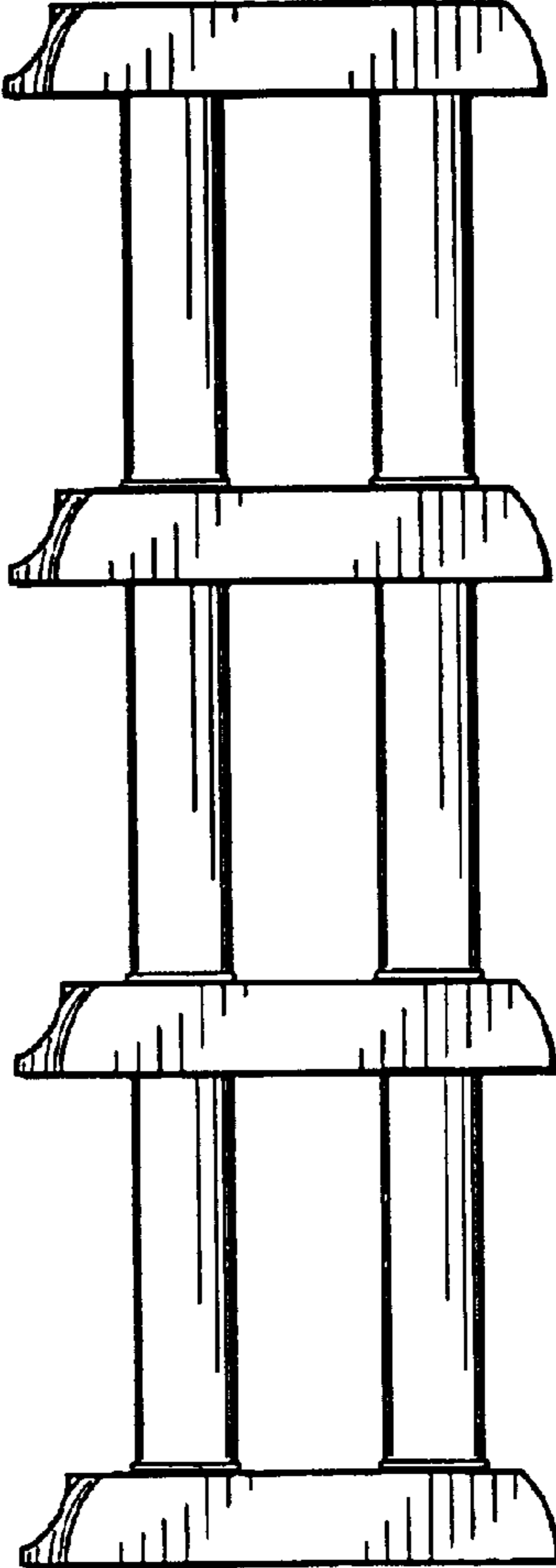

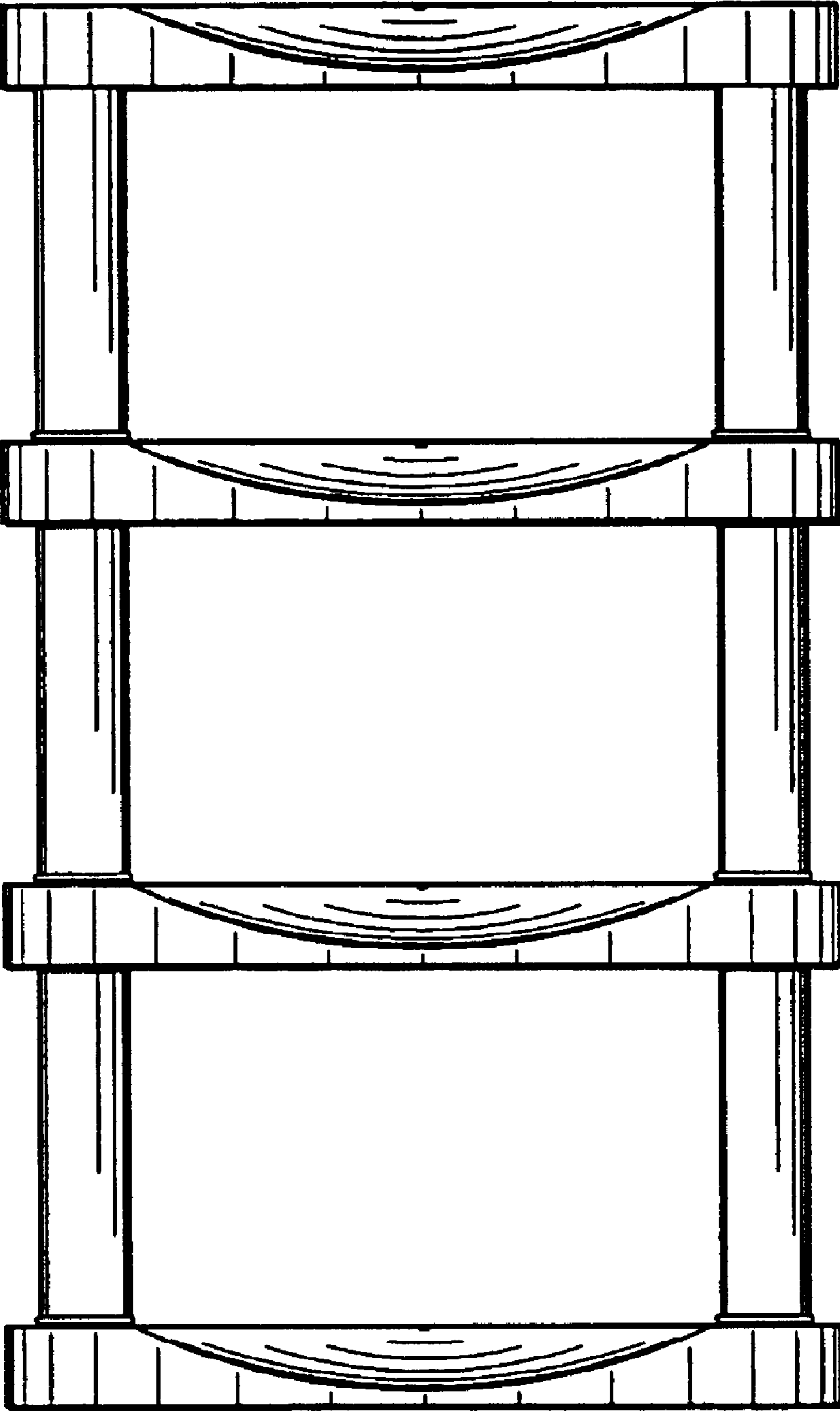

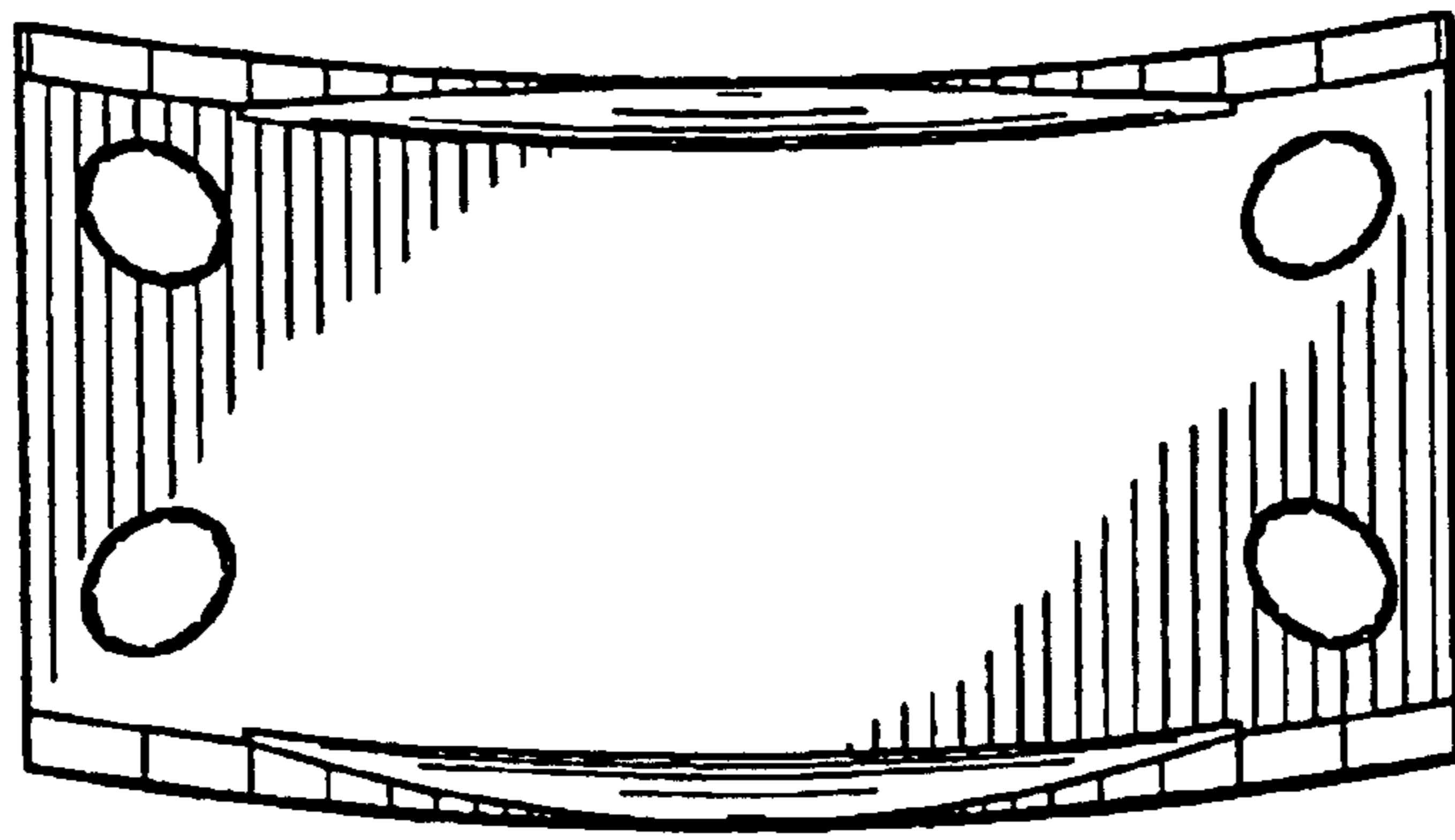

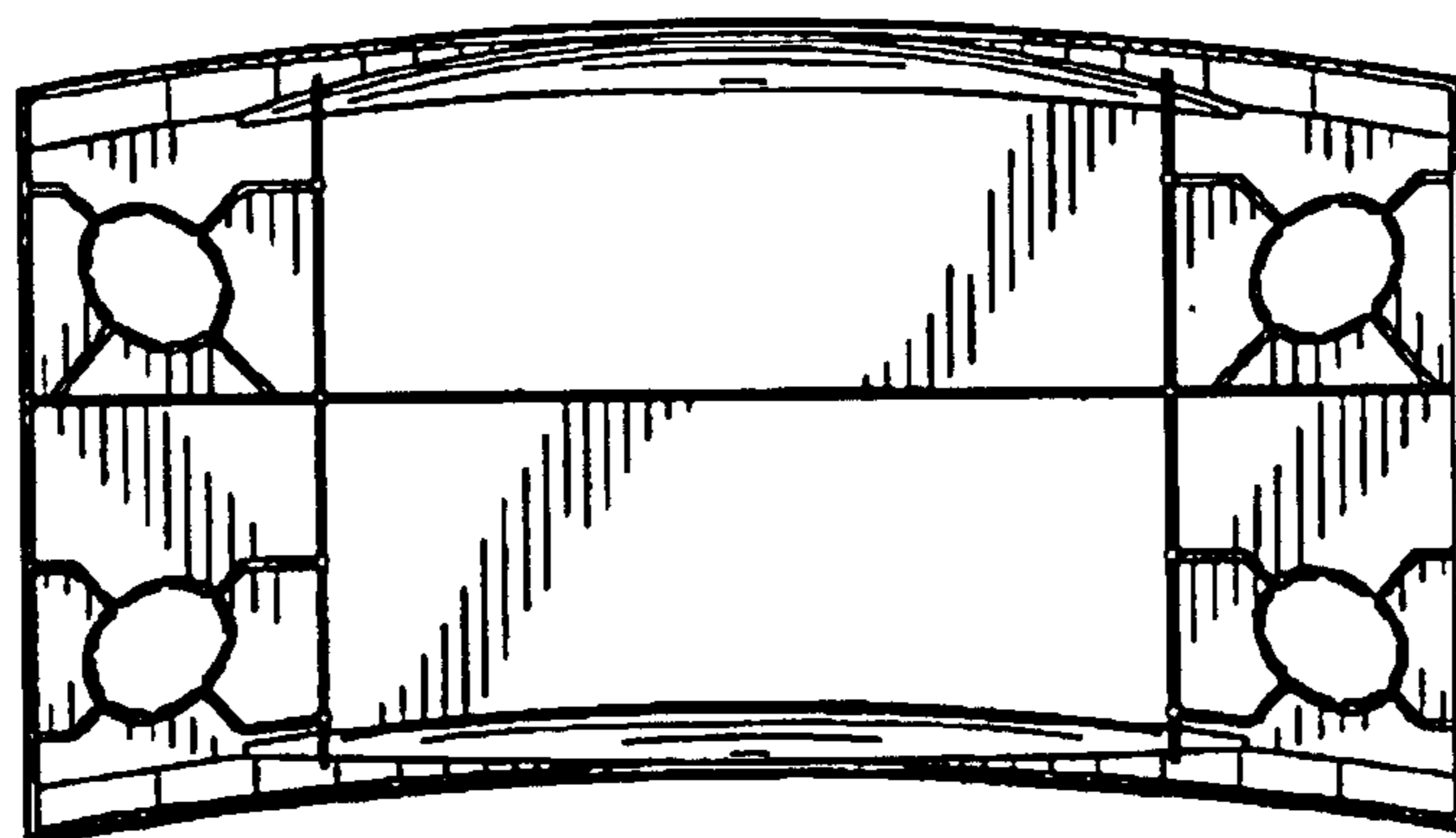

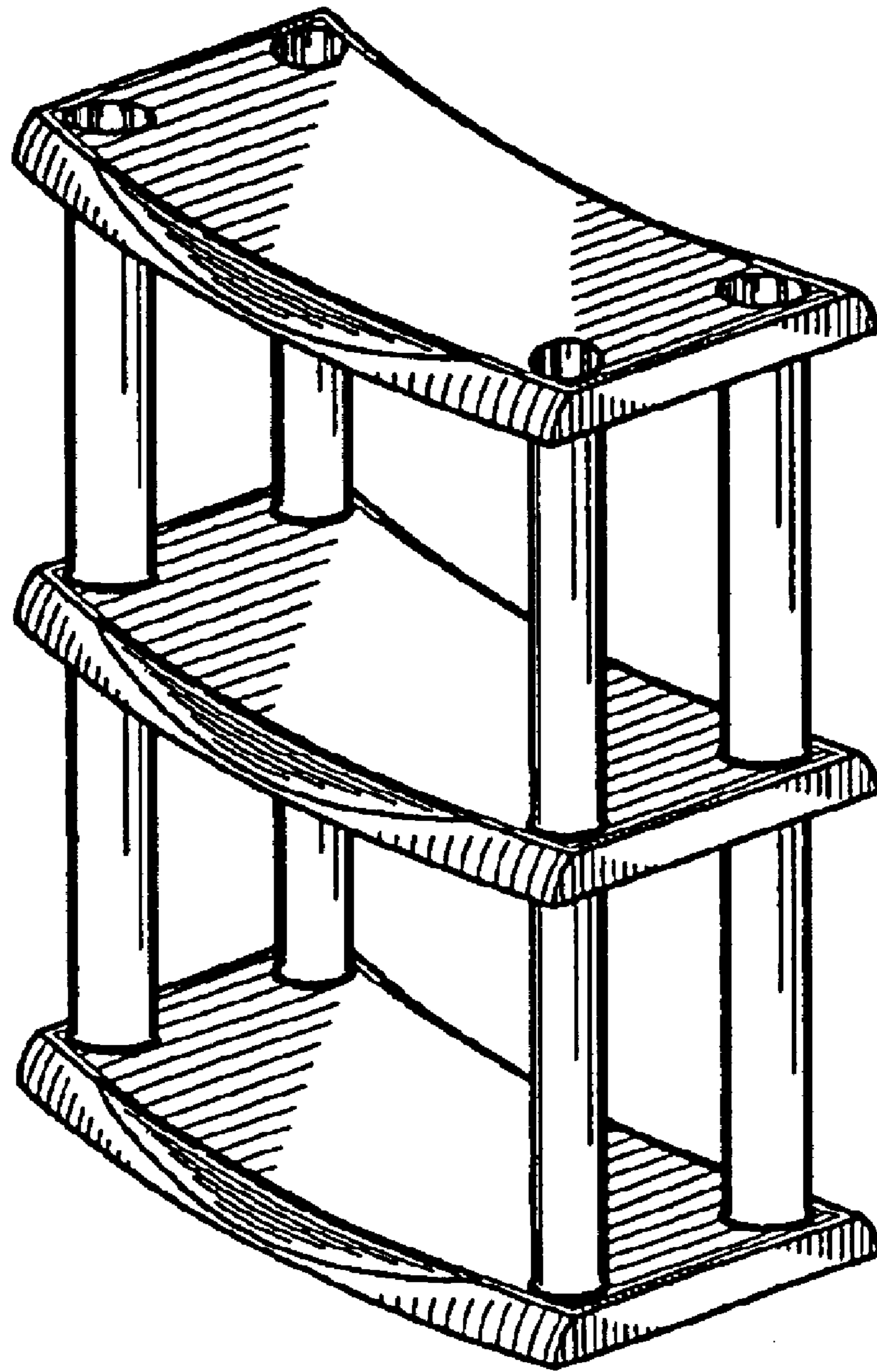

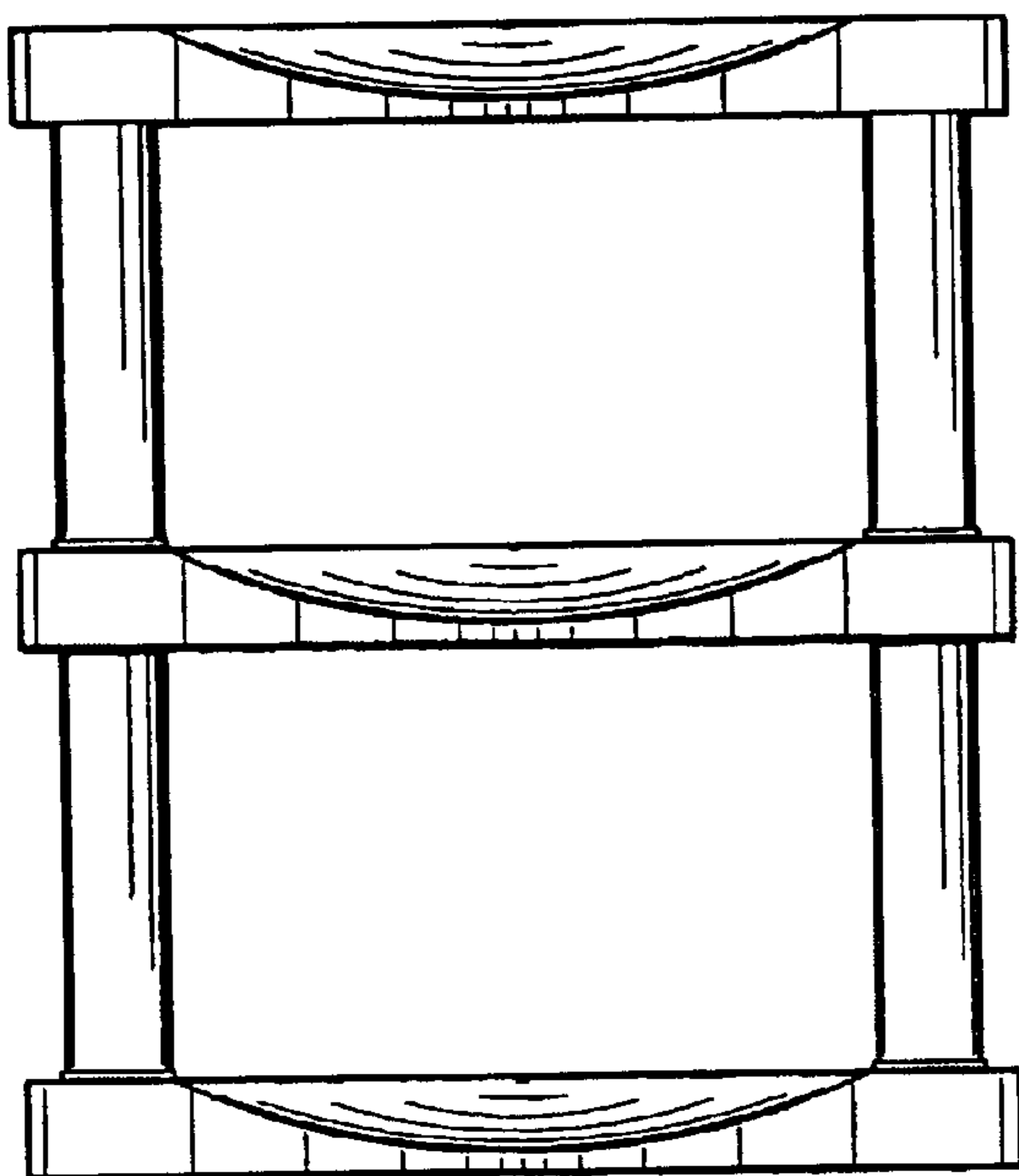

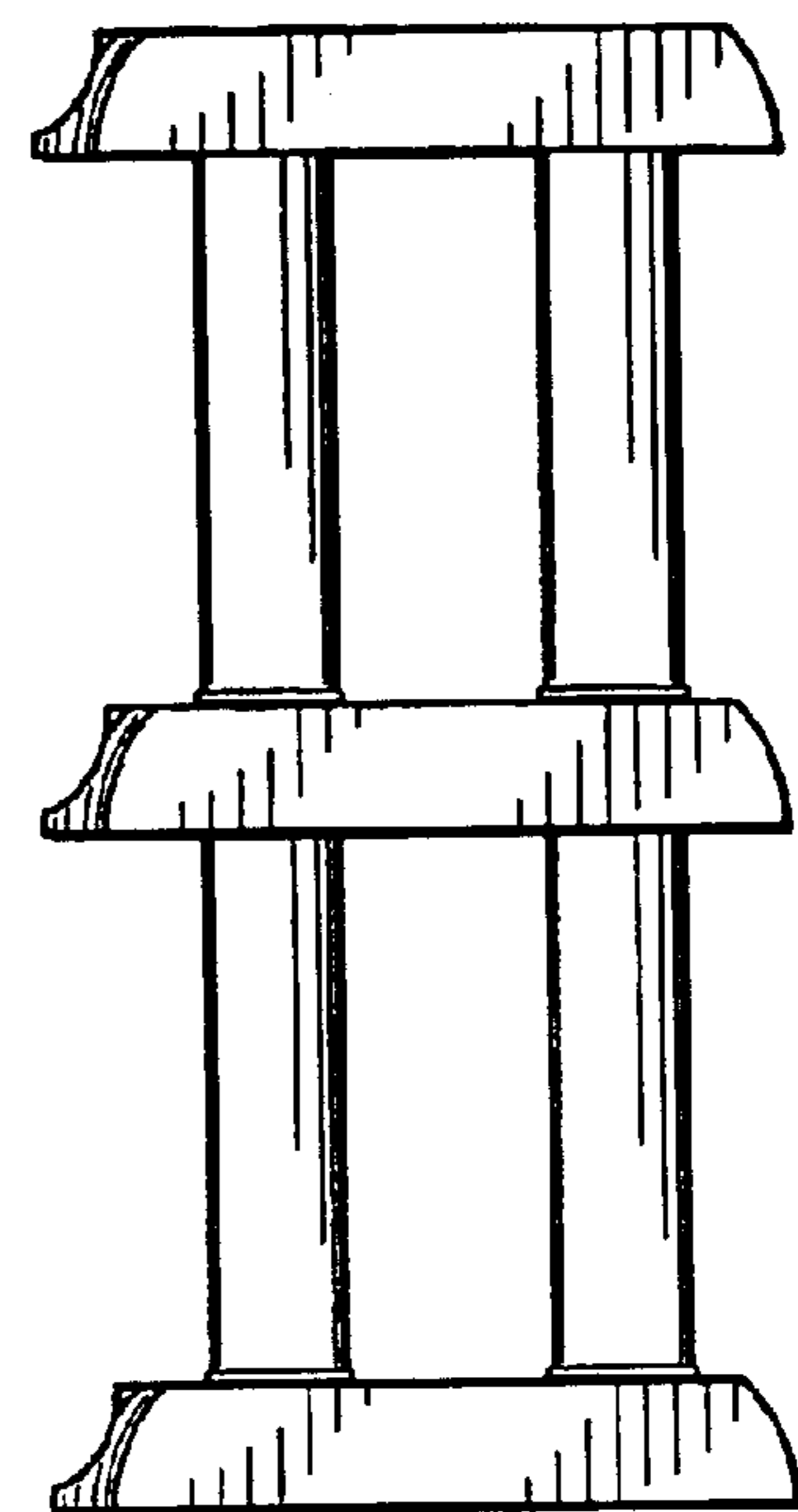

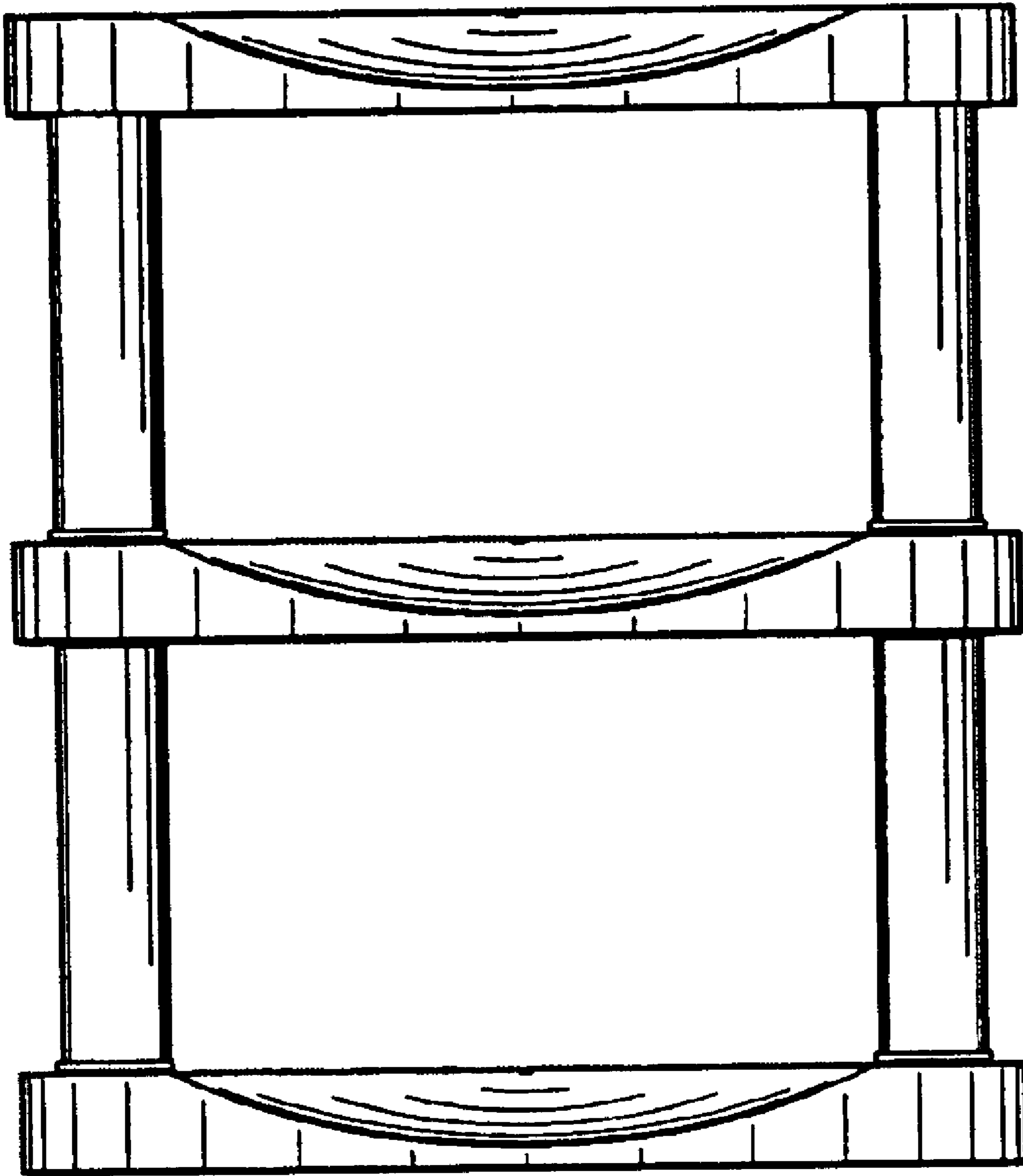

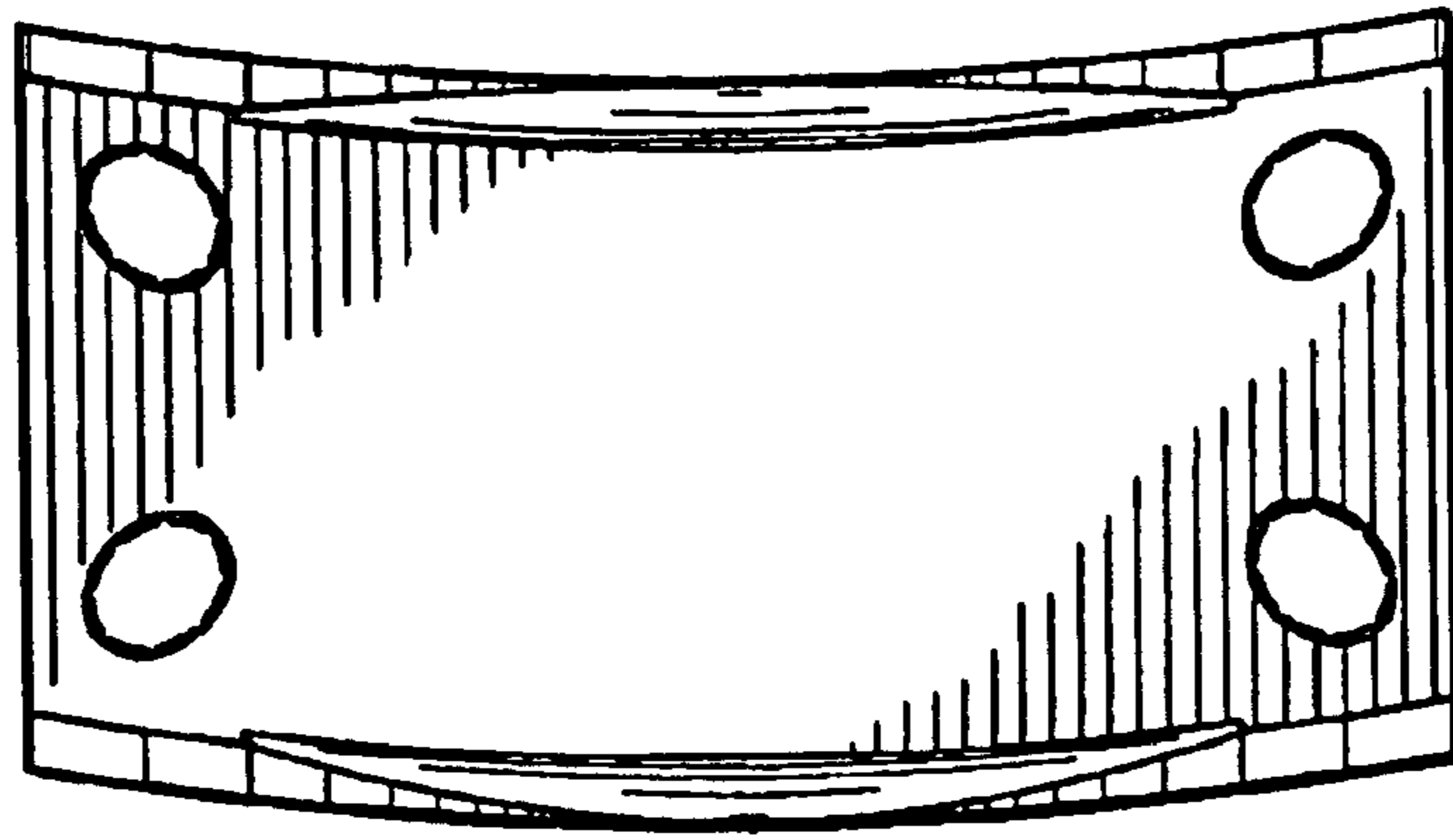

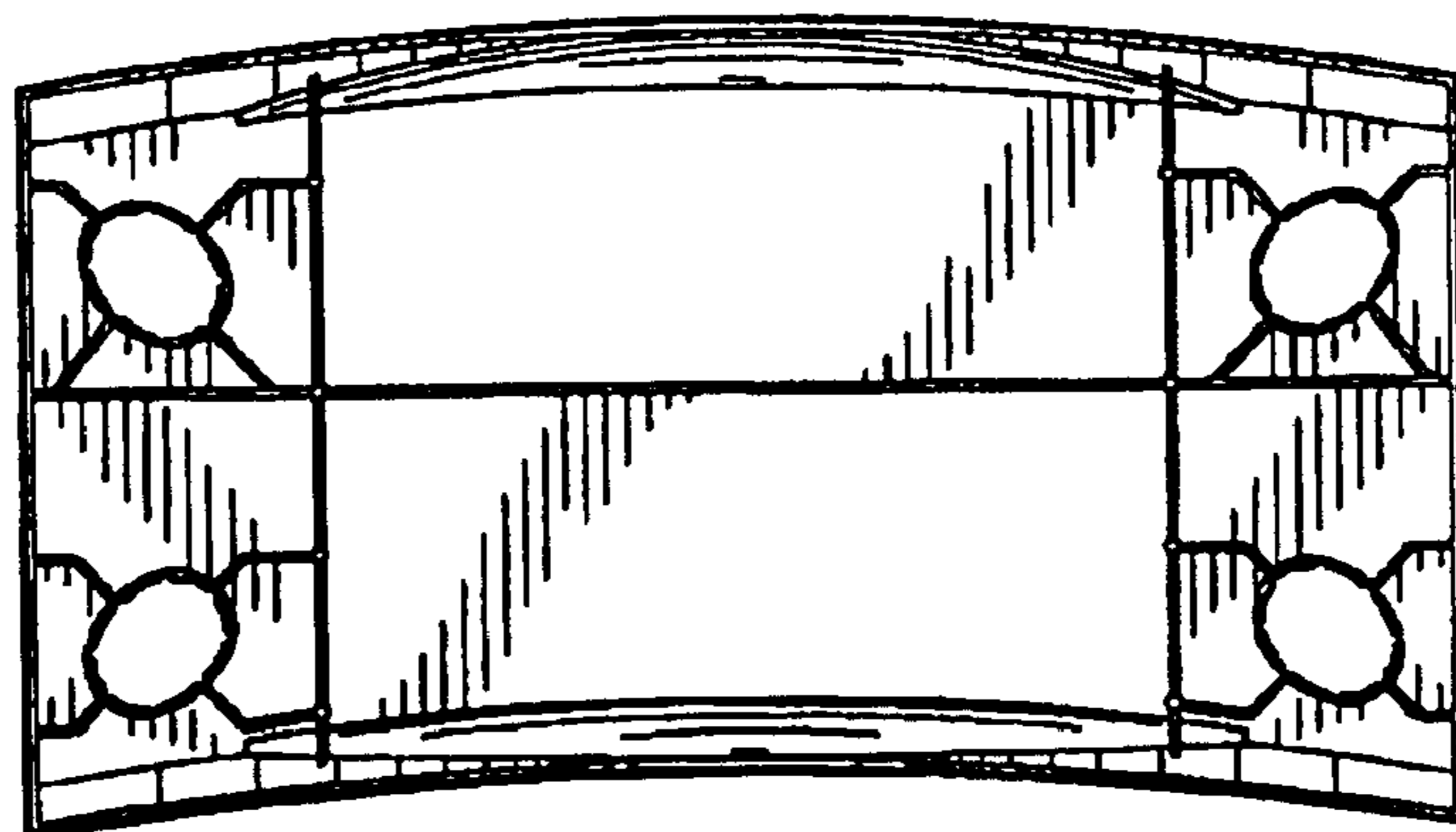

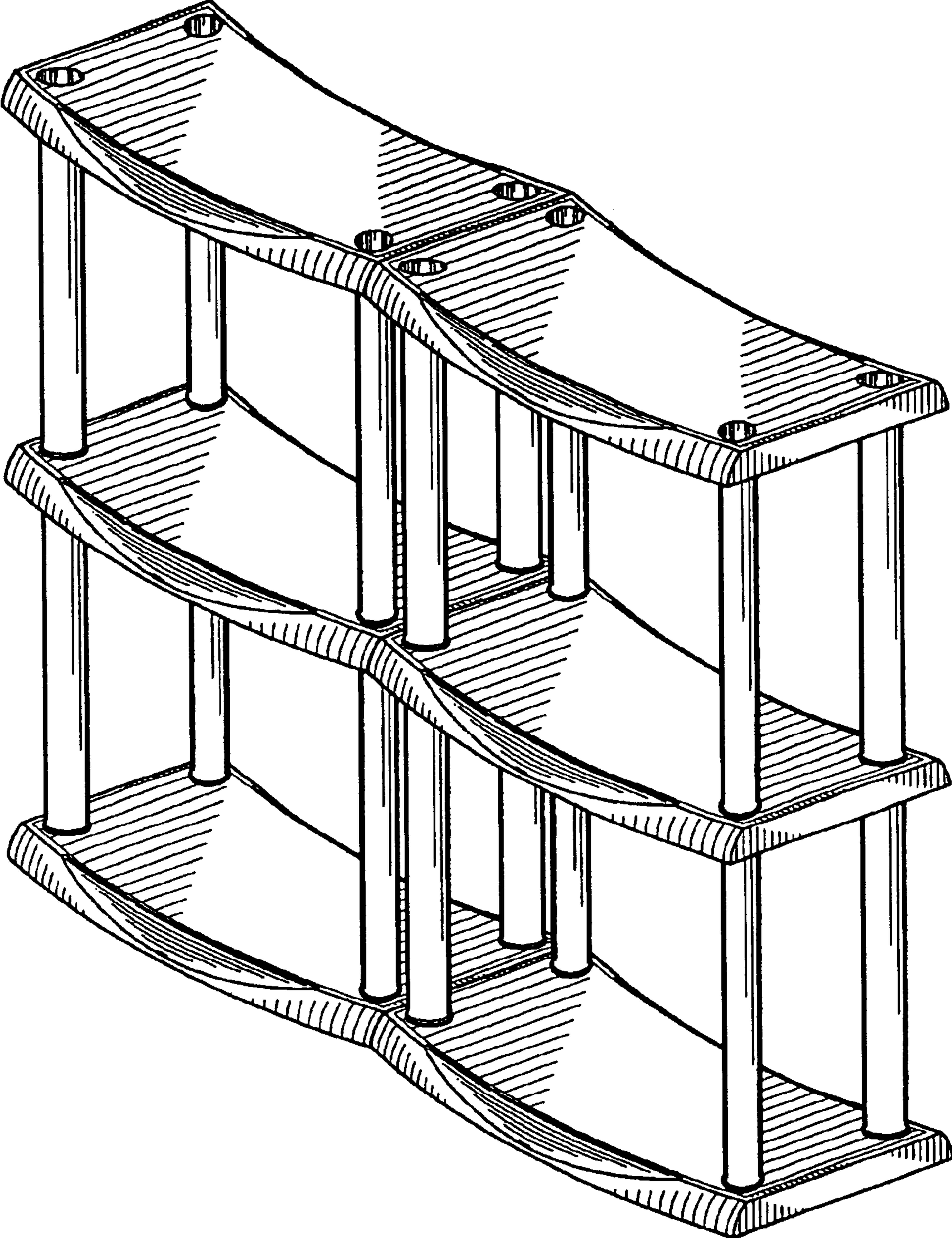

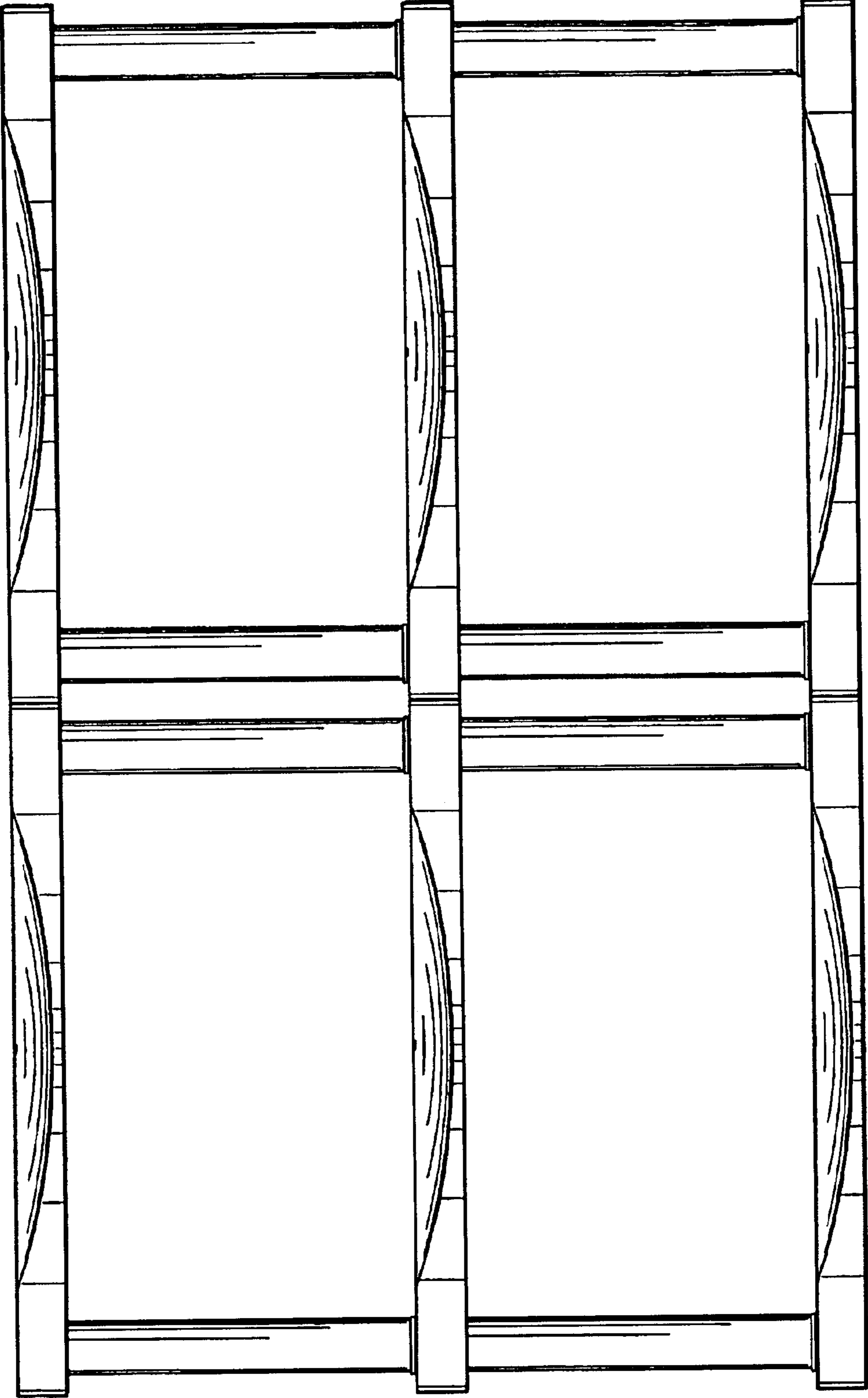

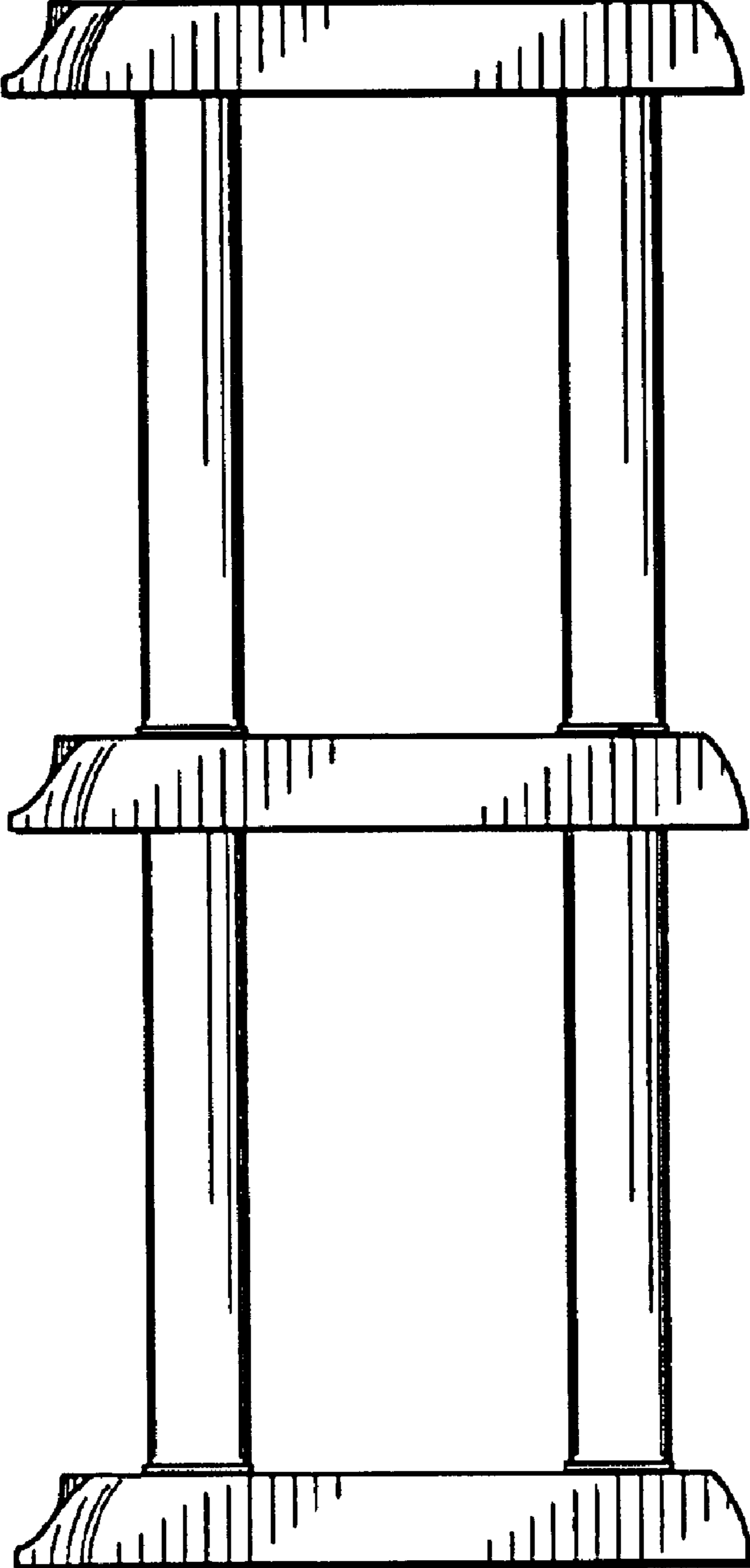

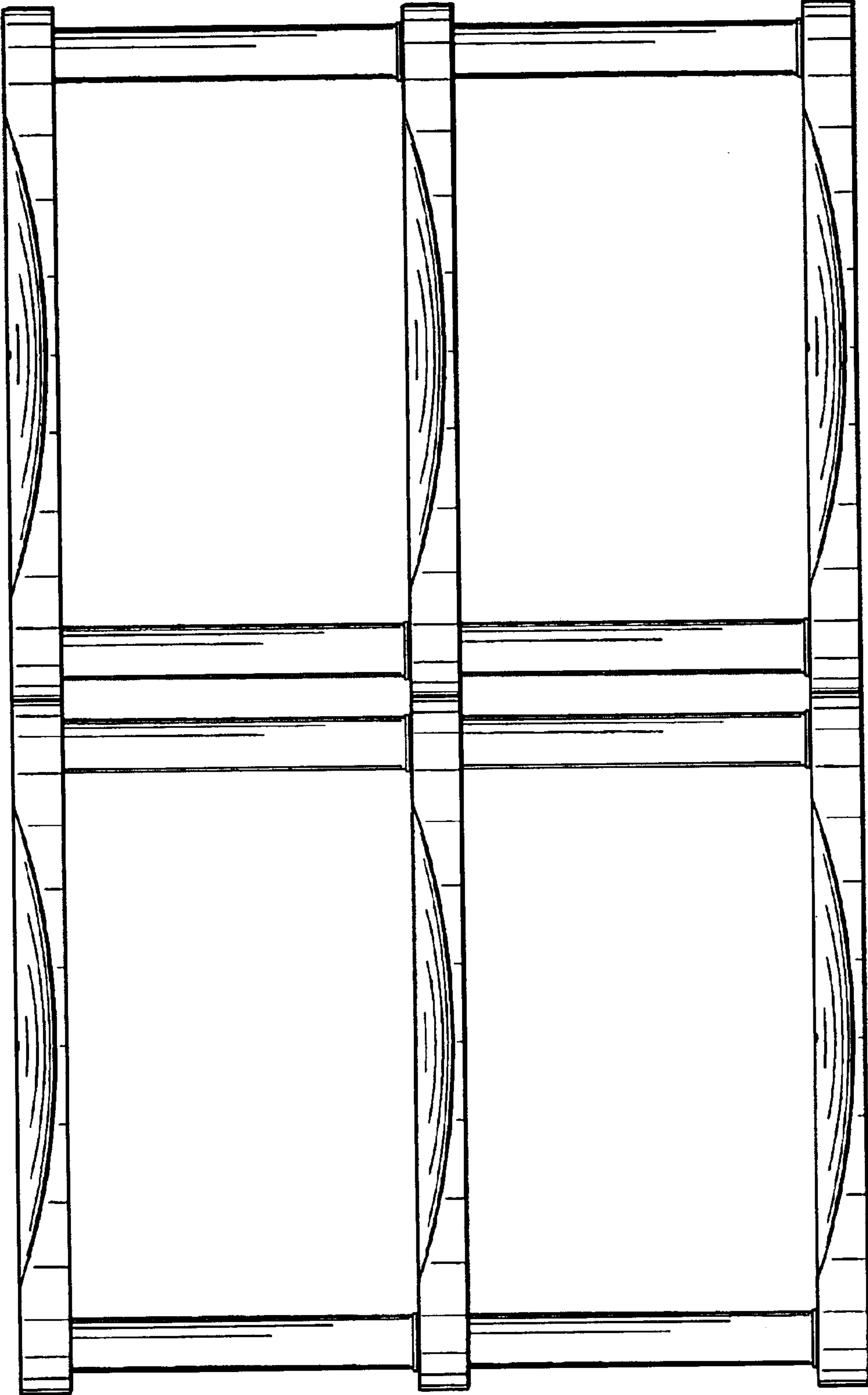

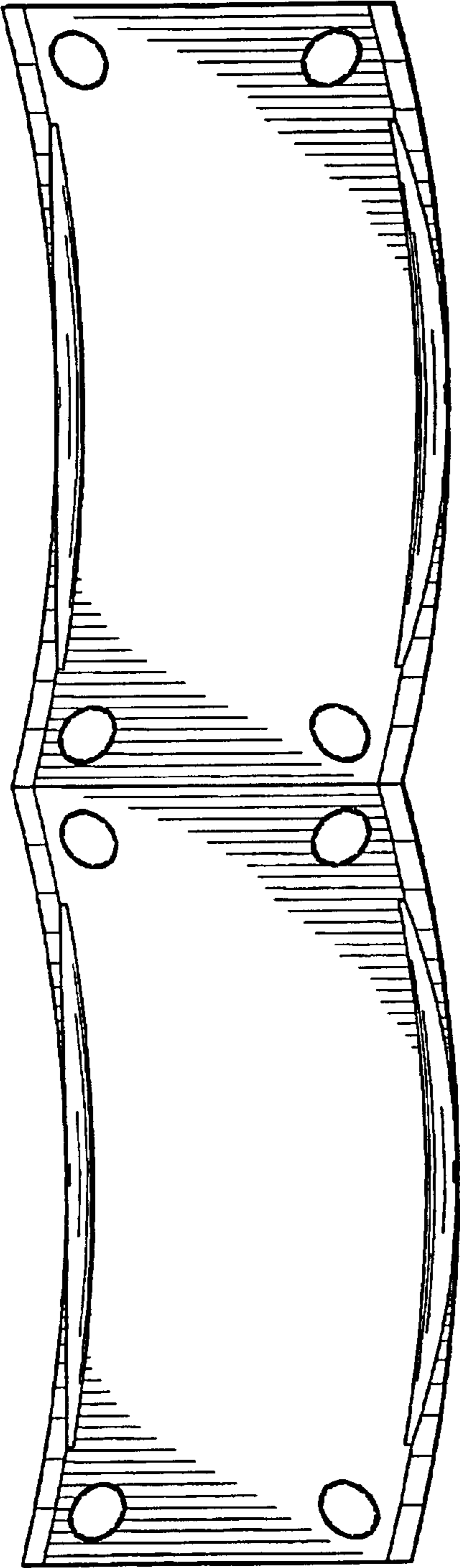

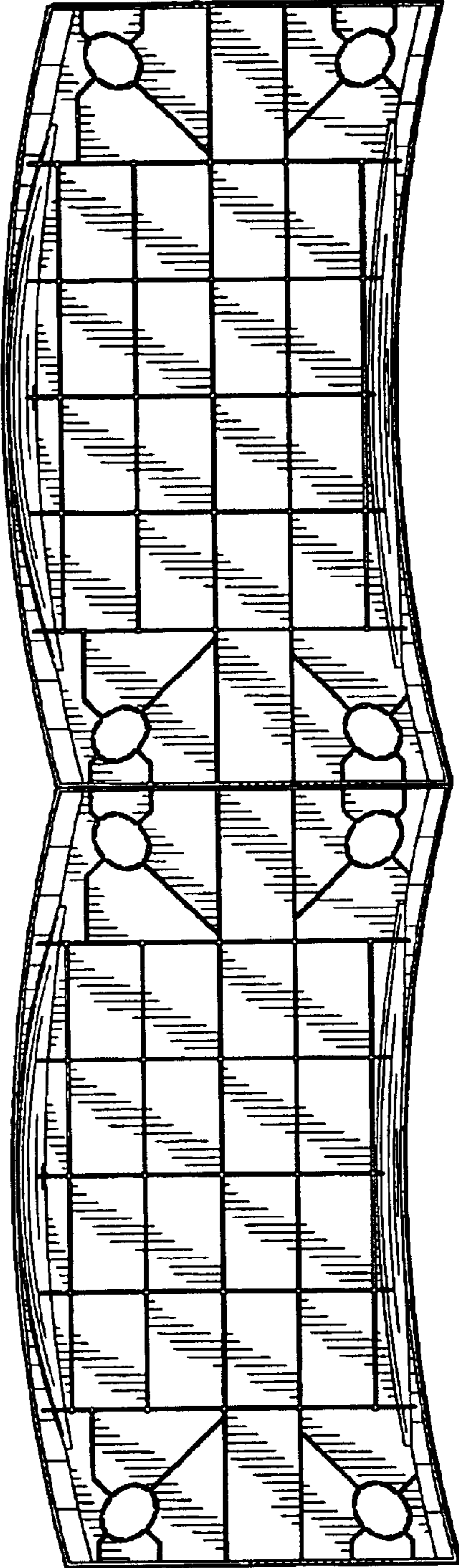

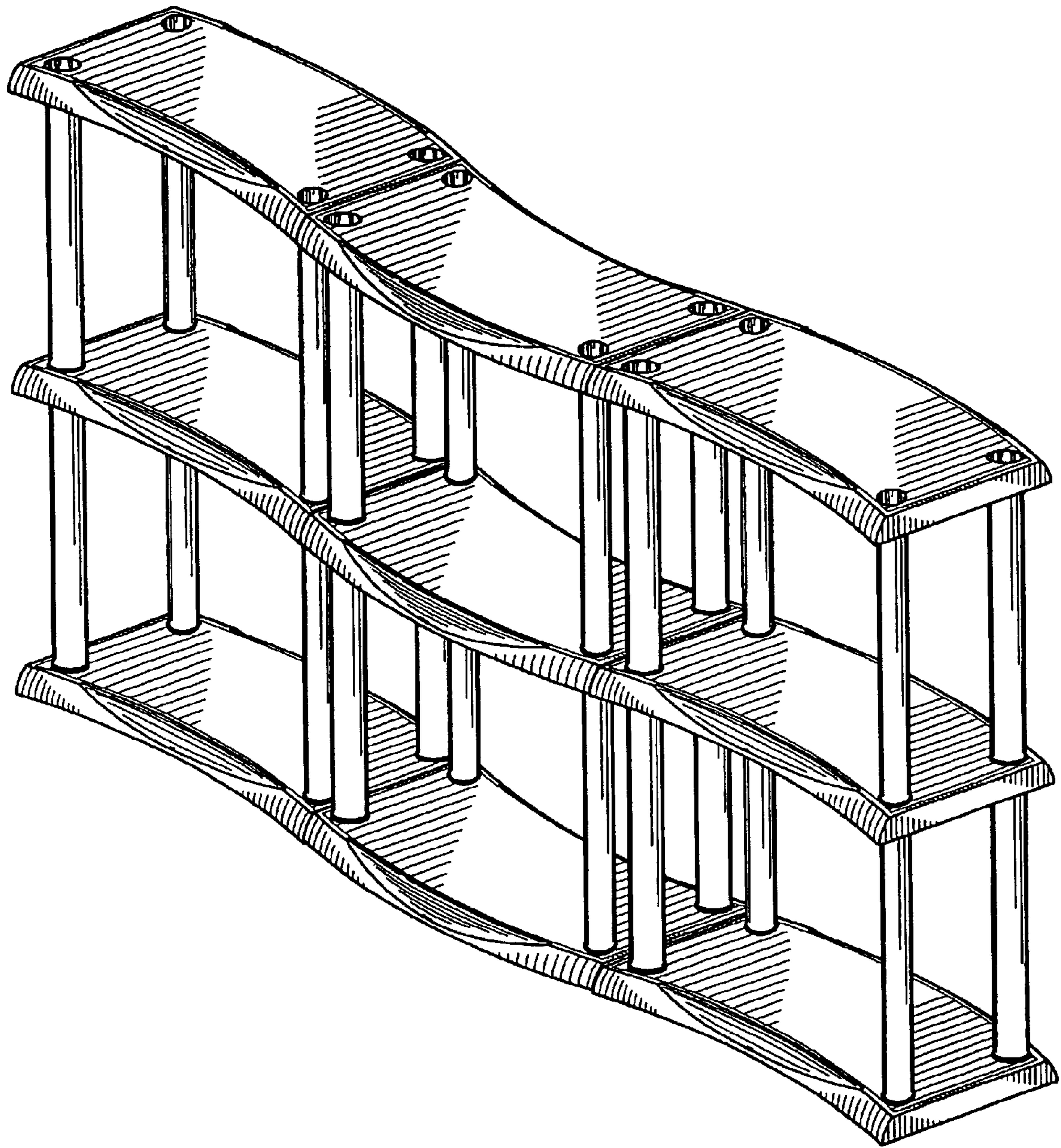

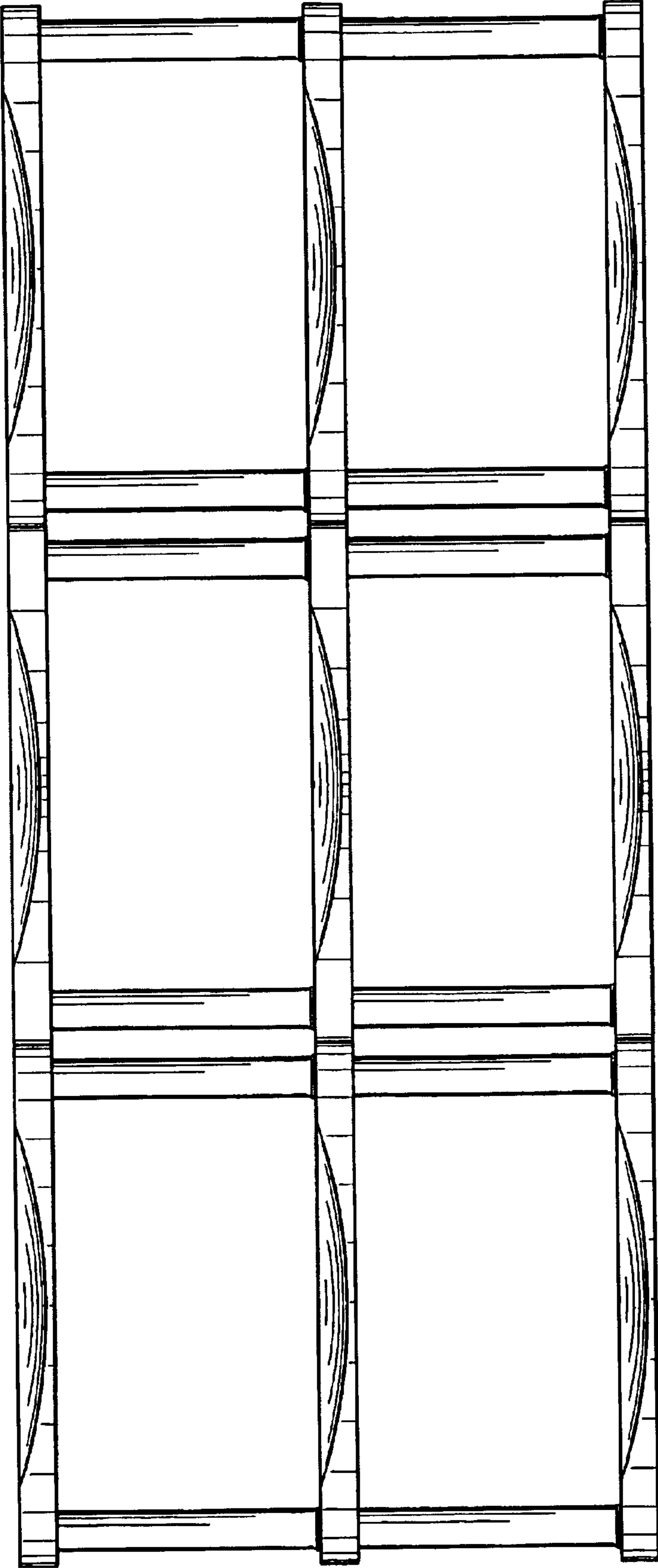

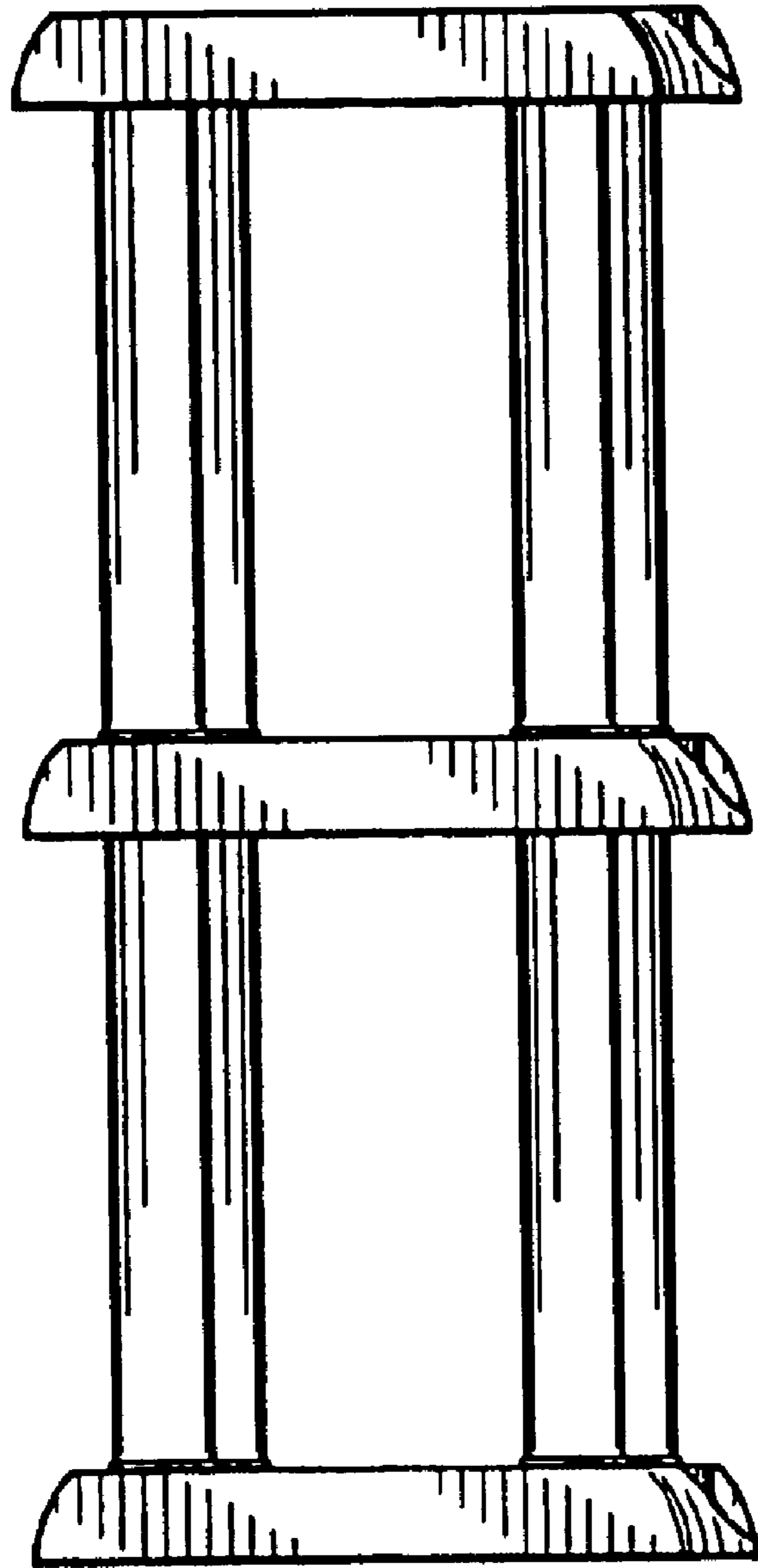

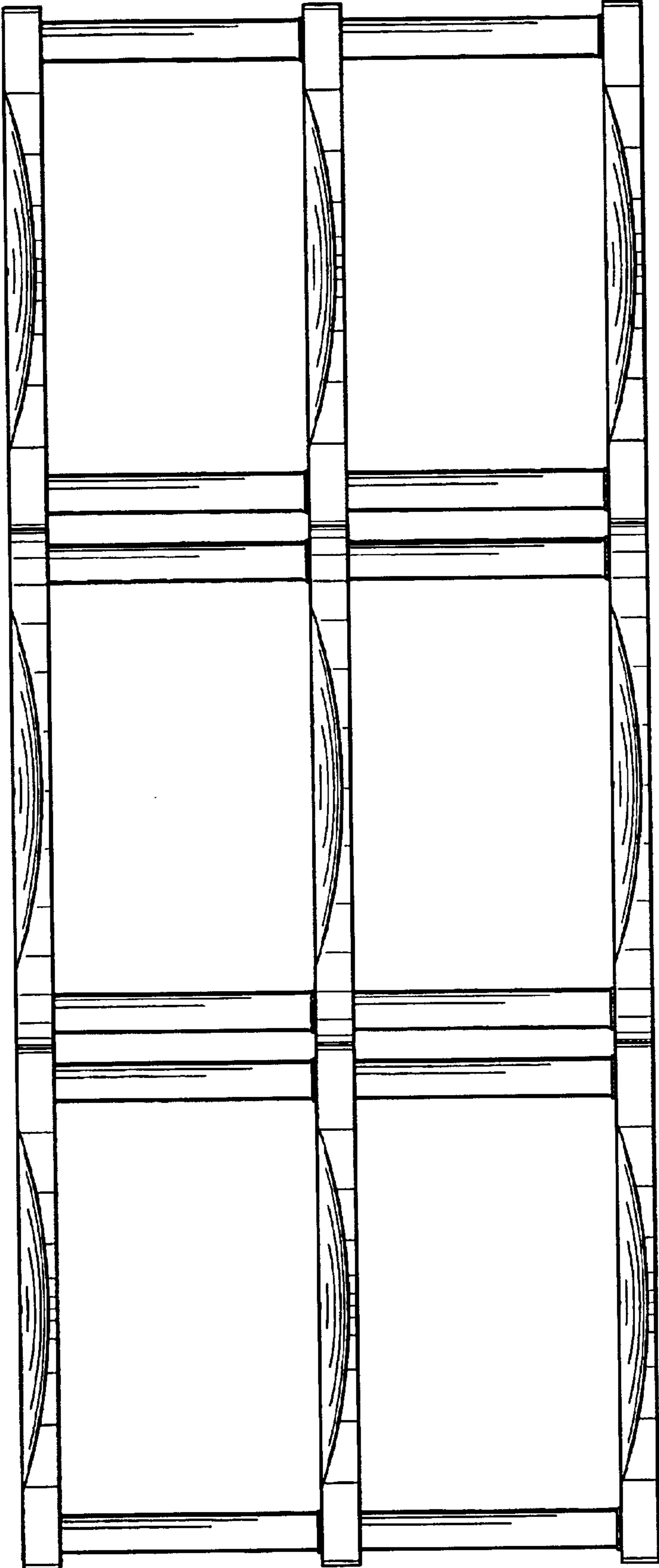

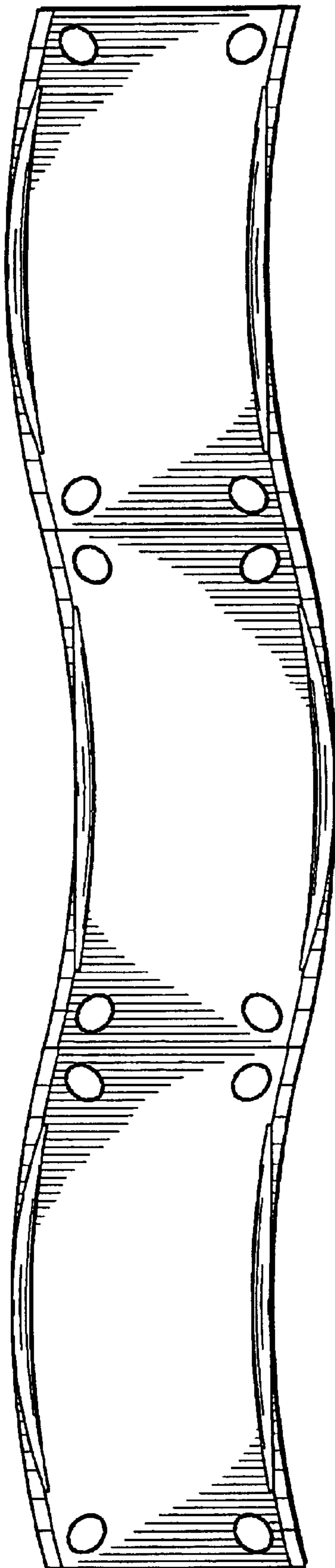

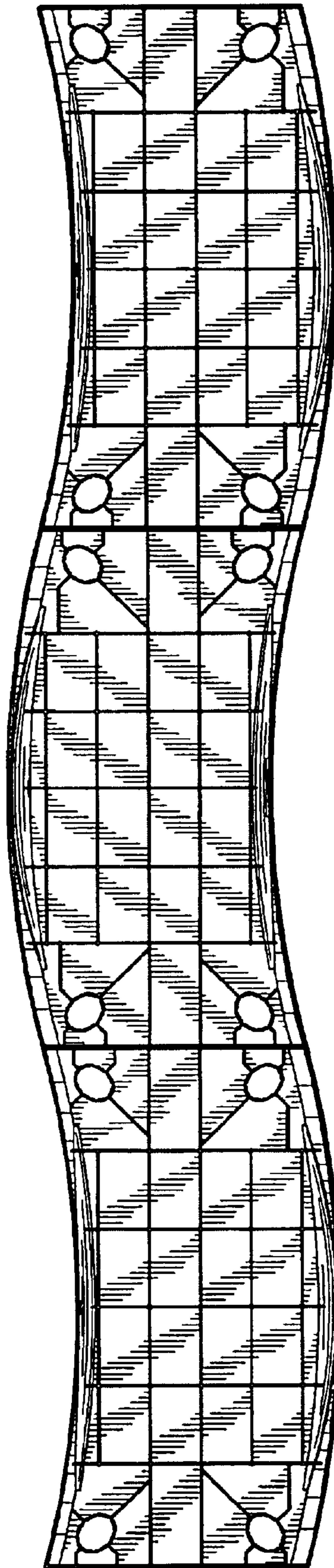
