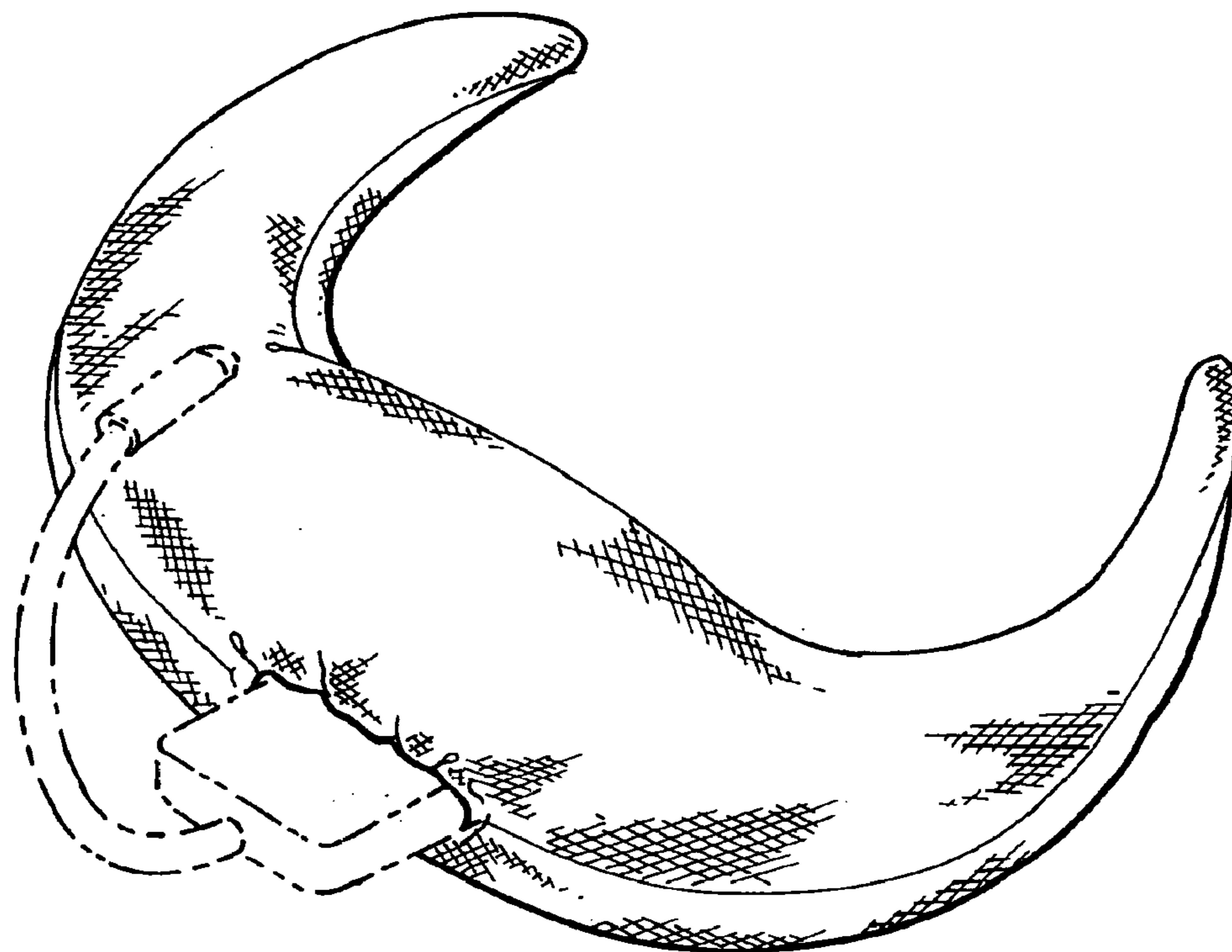

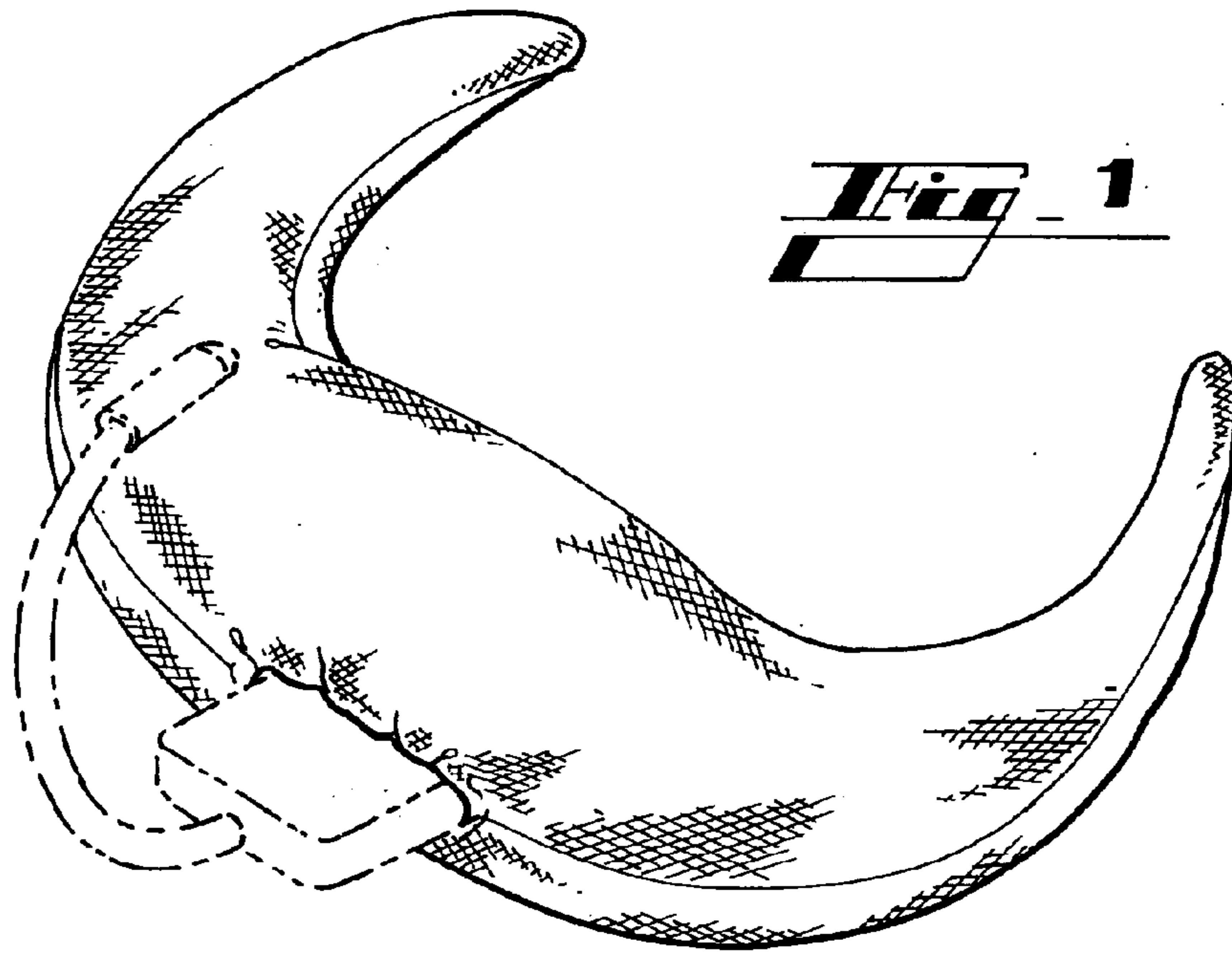
The ornamental design for a support pillow, as shown and described.

**DESCRIPTION**

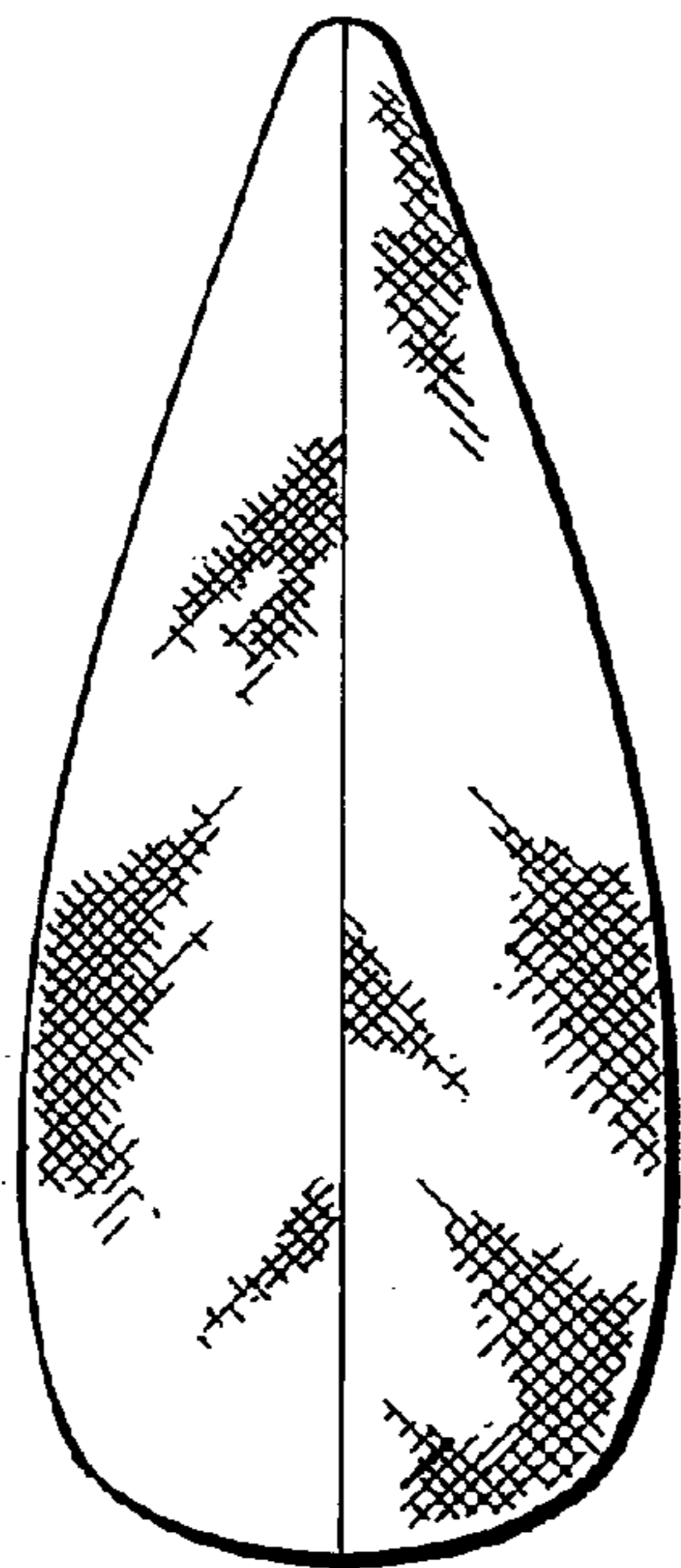
FIG. 1 is a top, front and right side perspective view of a support pillow showing our new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a front elevation view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a rear elevation view thereof;  
FIG. 6 is a left side elevation view thereof; and,  
FIG. 7 is a right side elevation view thereof.

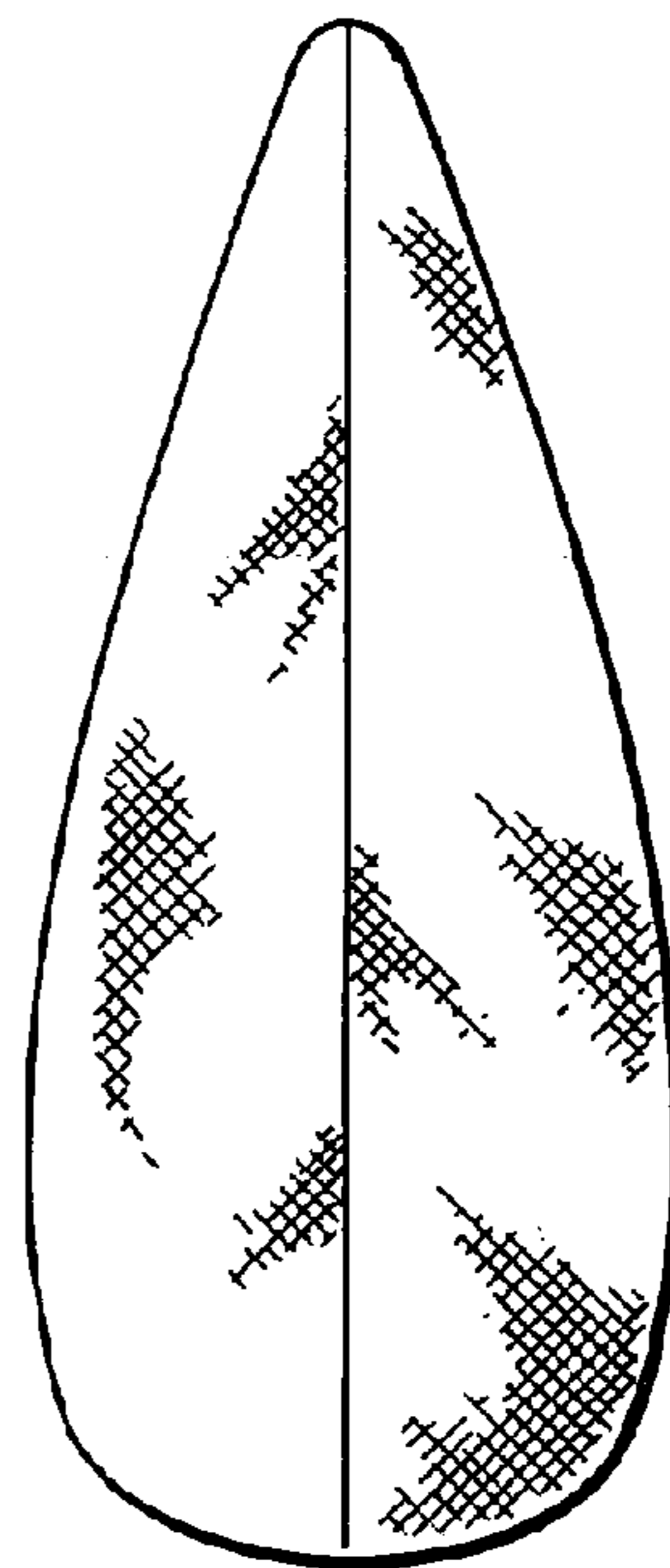

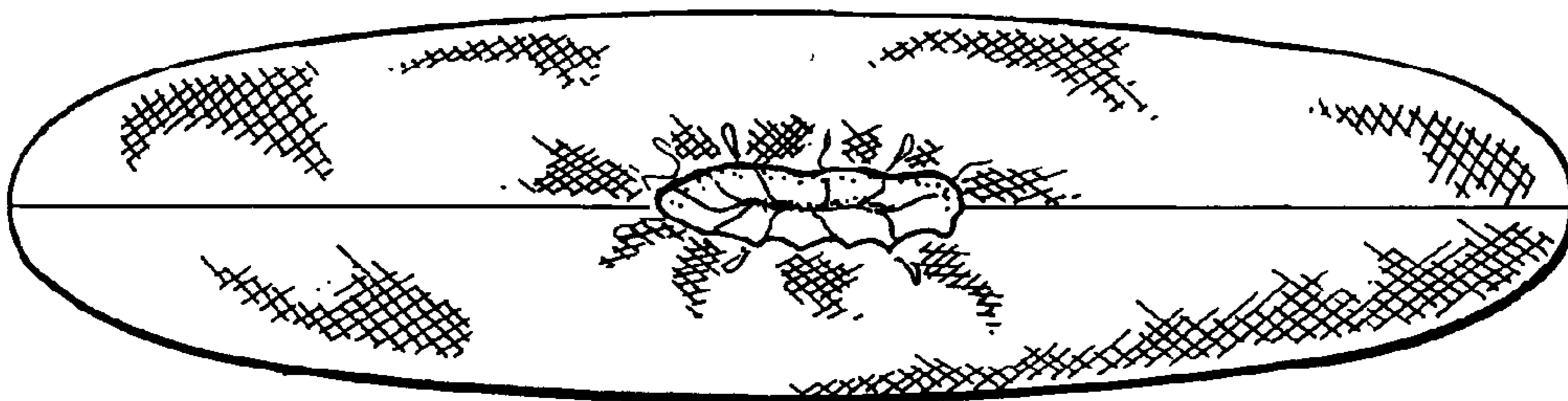
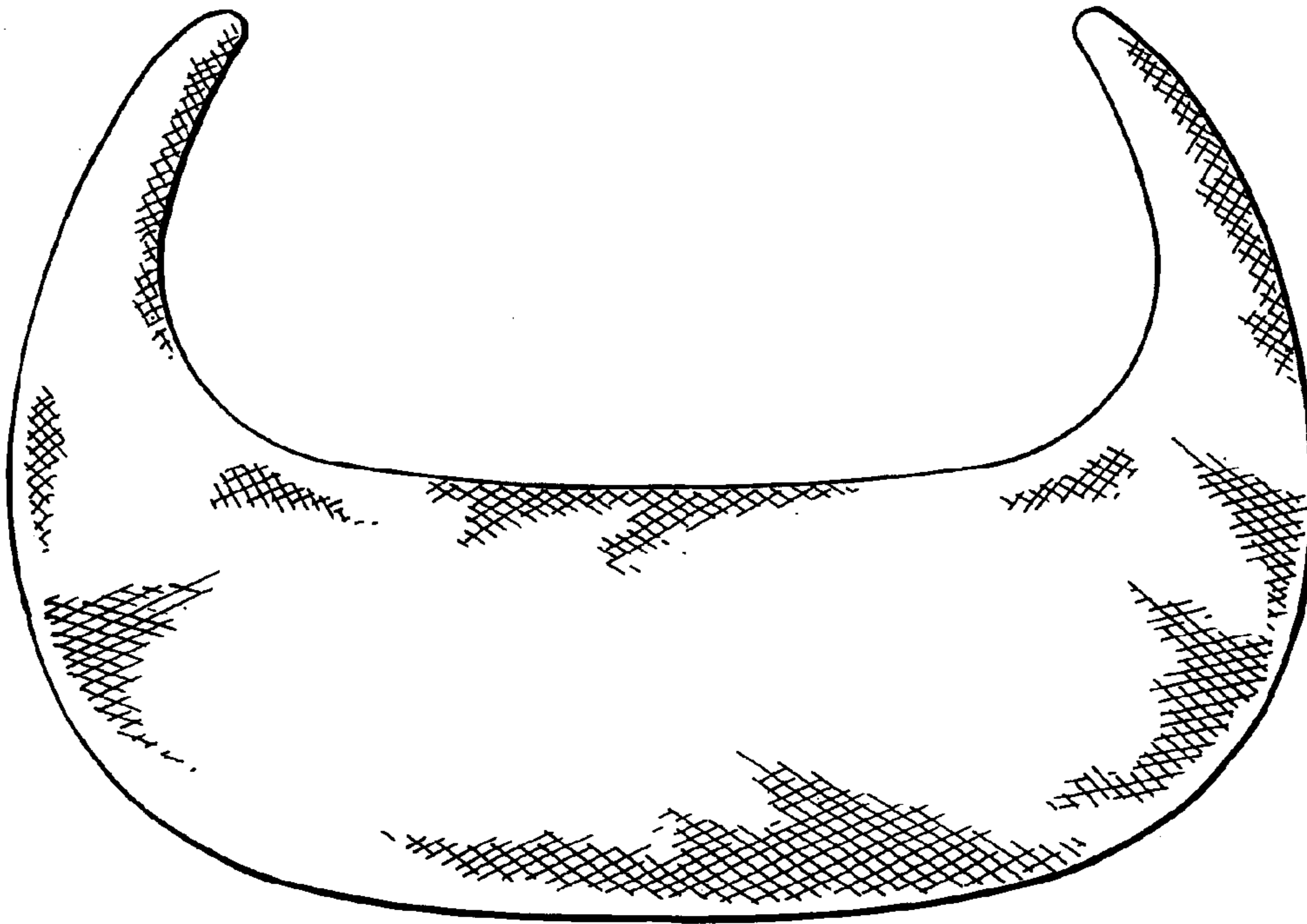

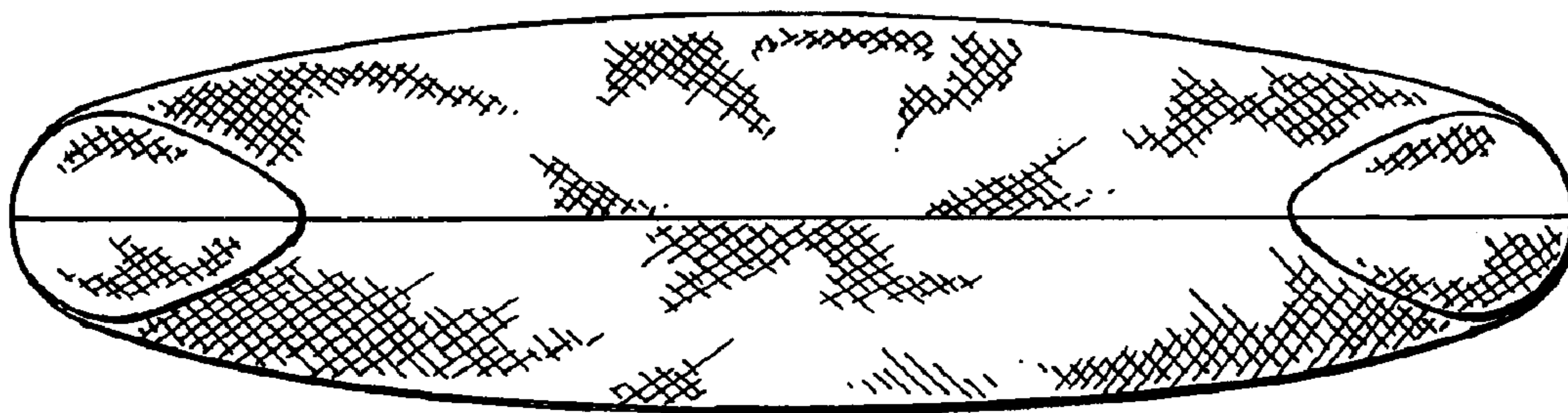
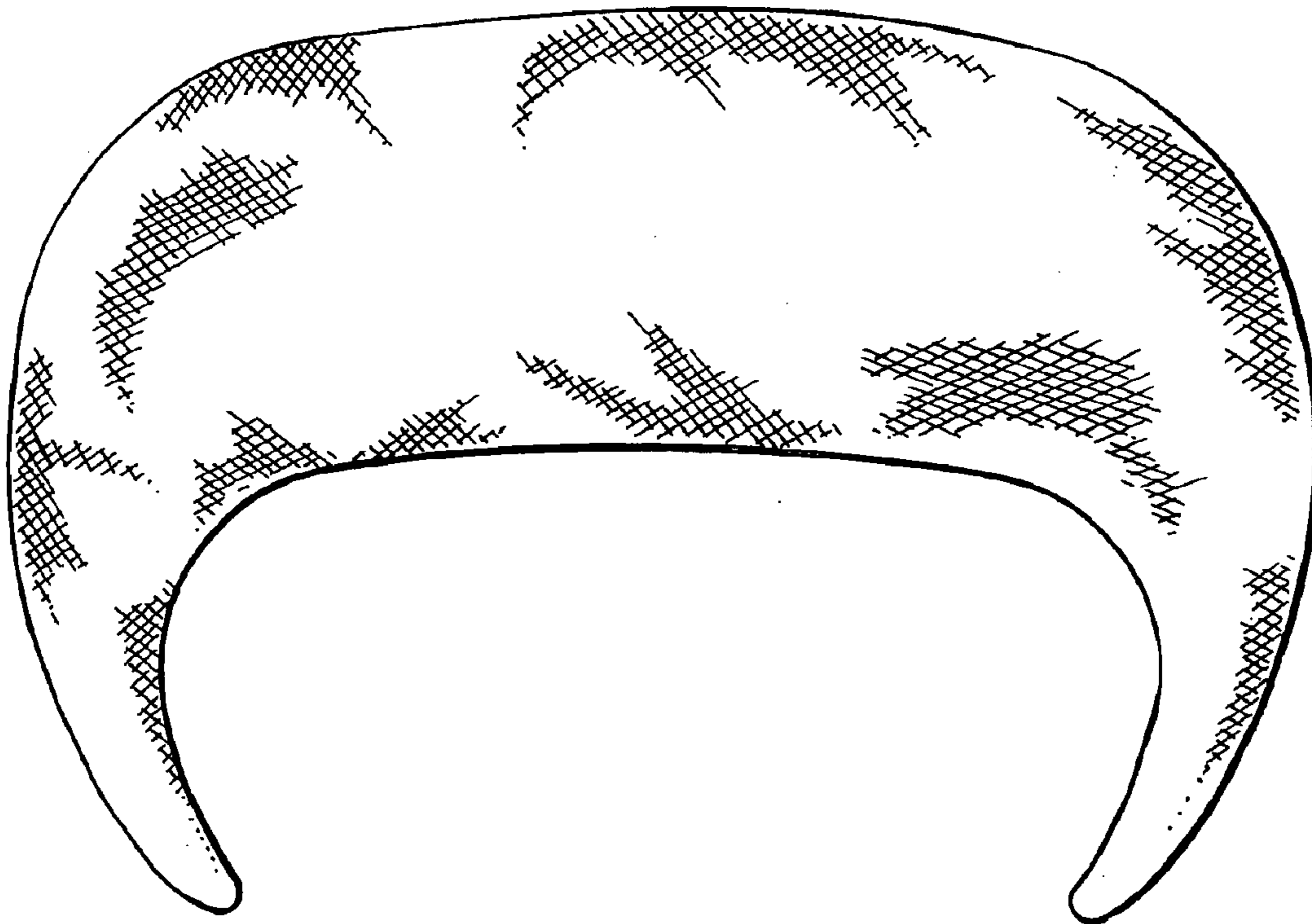
