(57) **CLAIM**

The ornamental design for a lighter and stand, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the lighter and stand showing my new design;

FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a right side elevational view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof; and,

FIG. 7 is an exploded perspective view thereof showing the lighter and stand.

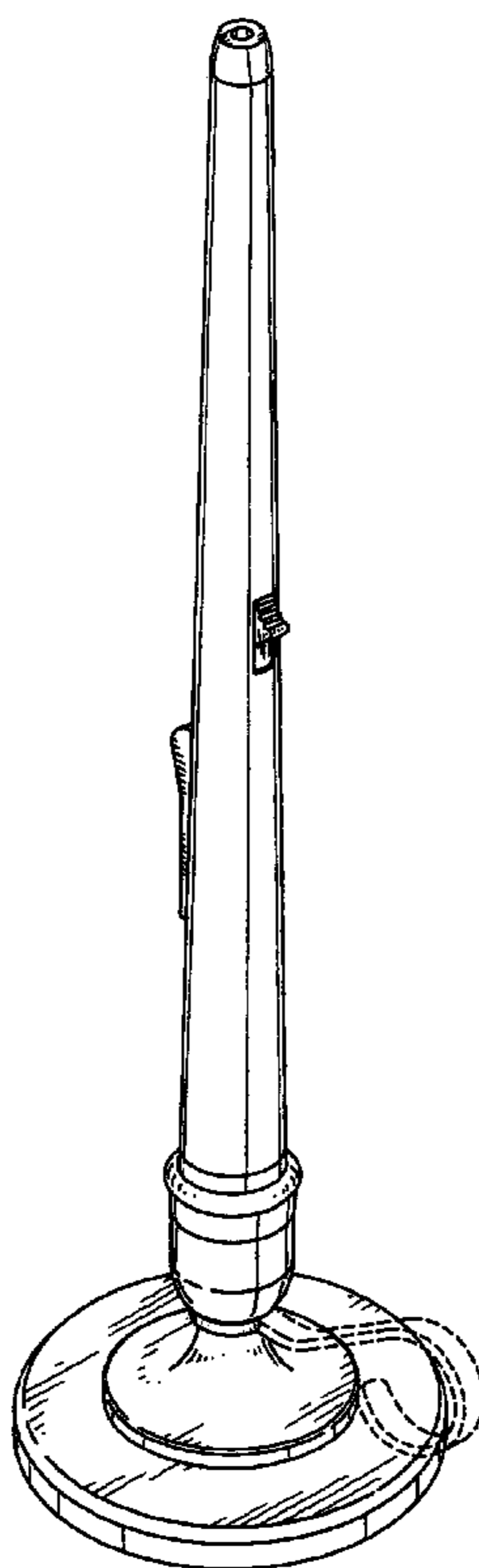
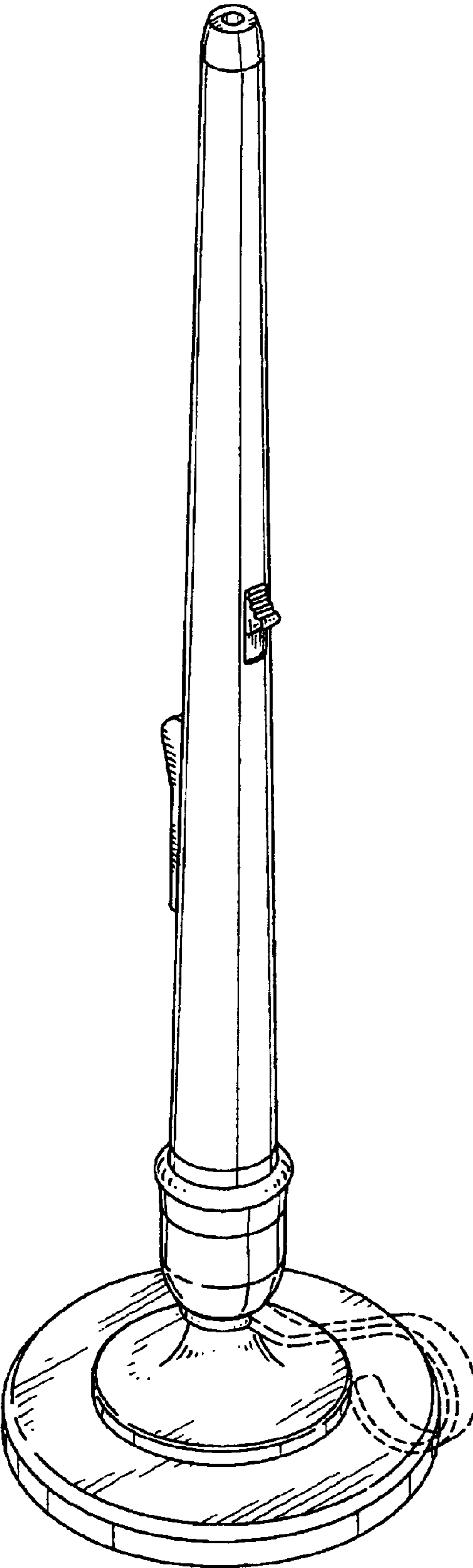

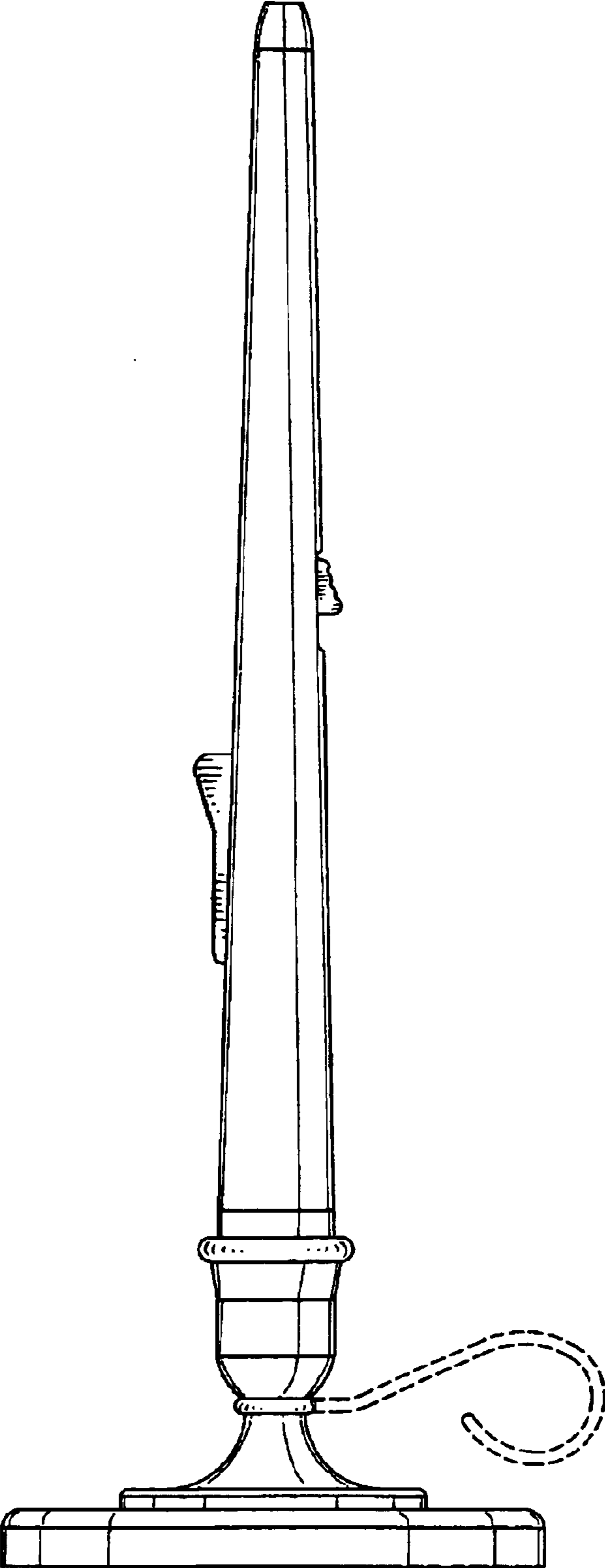

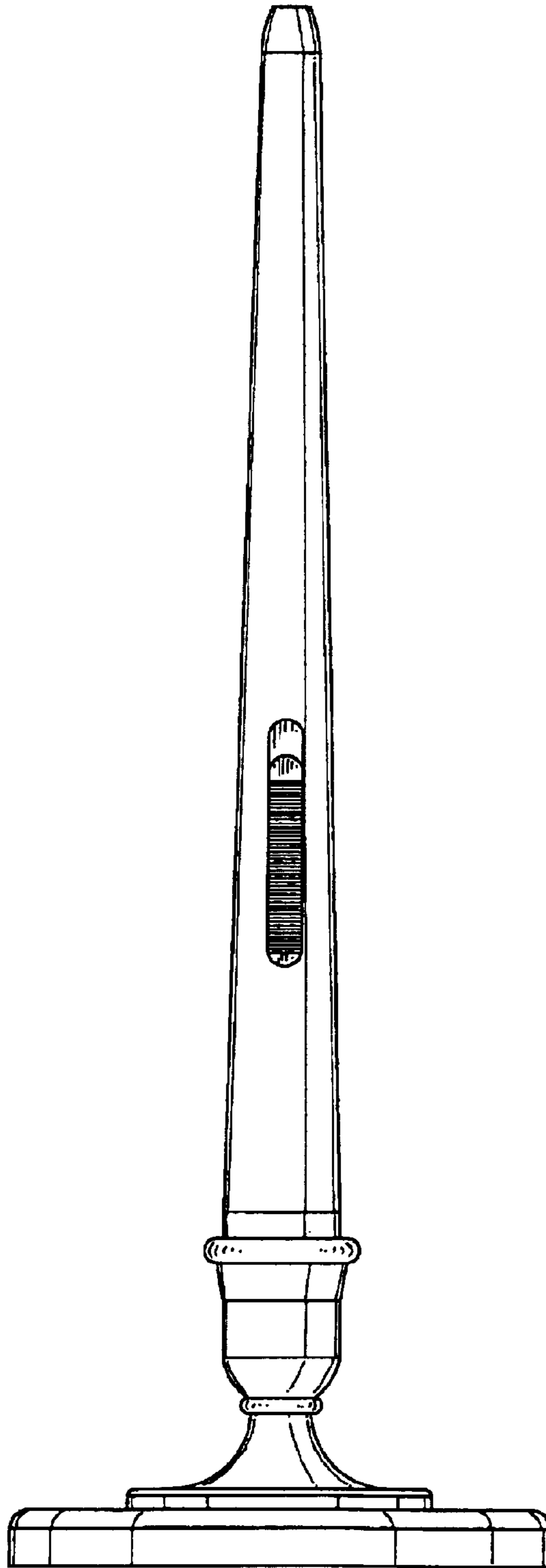

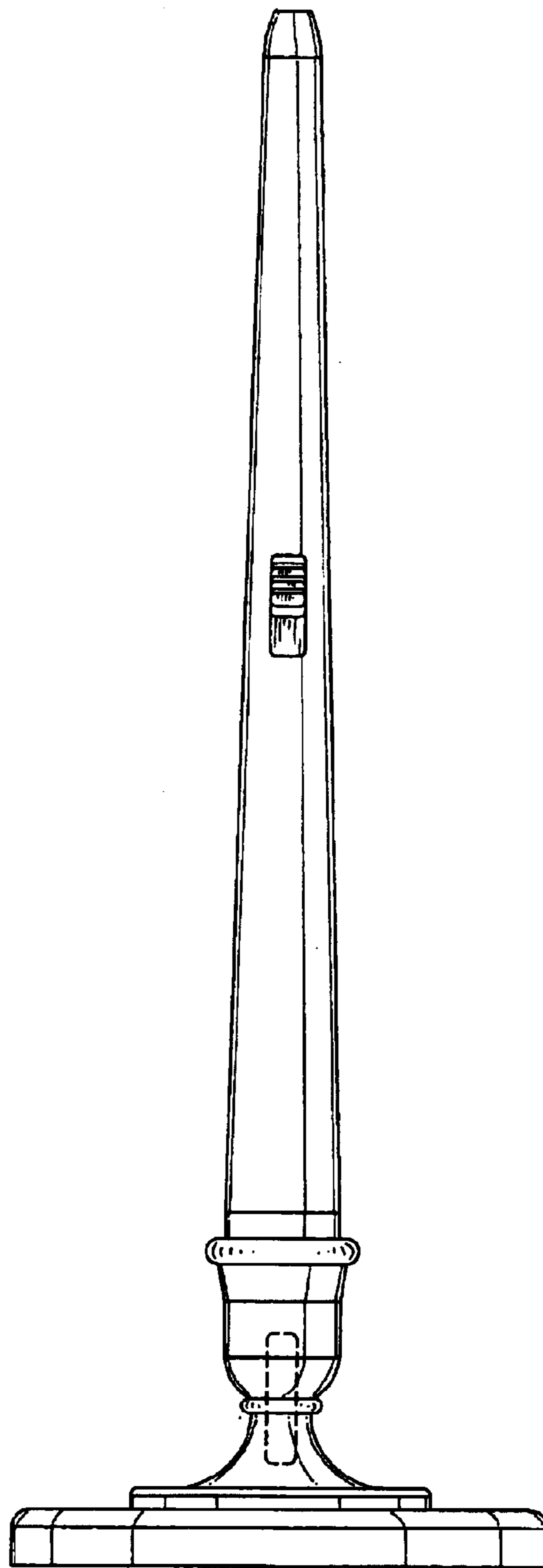

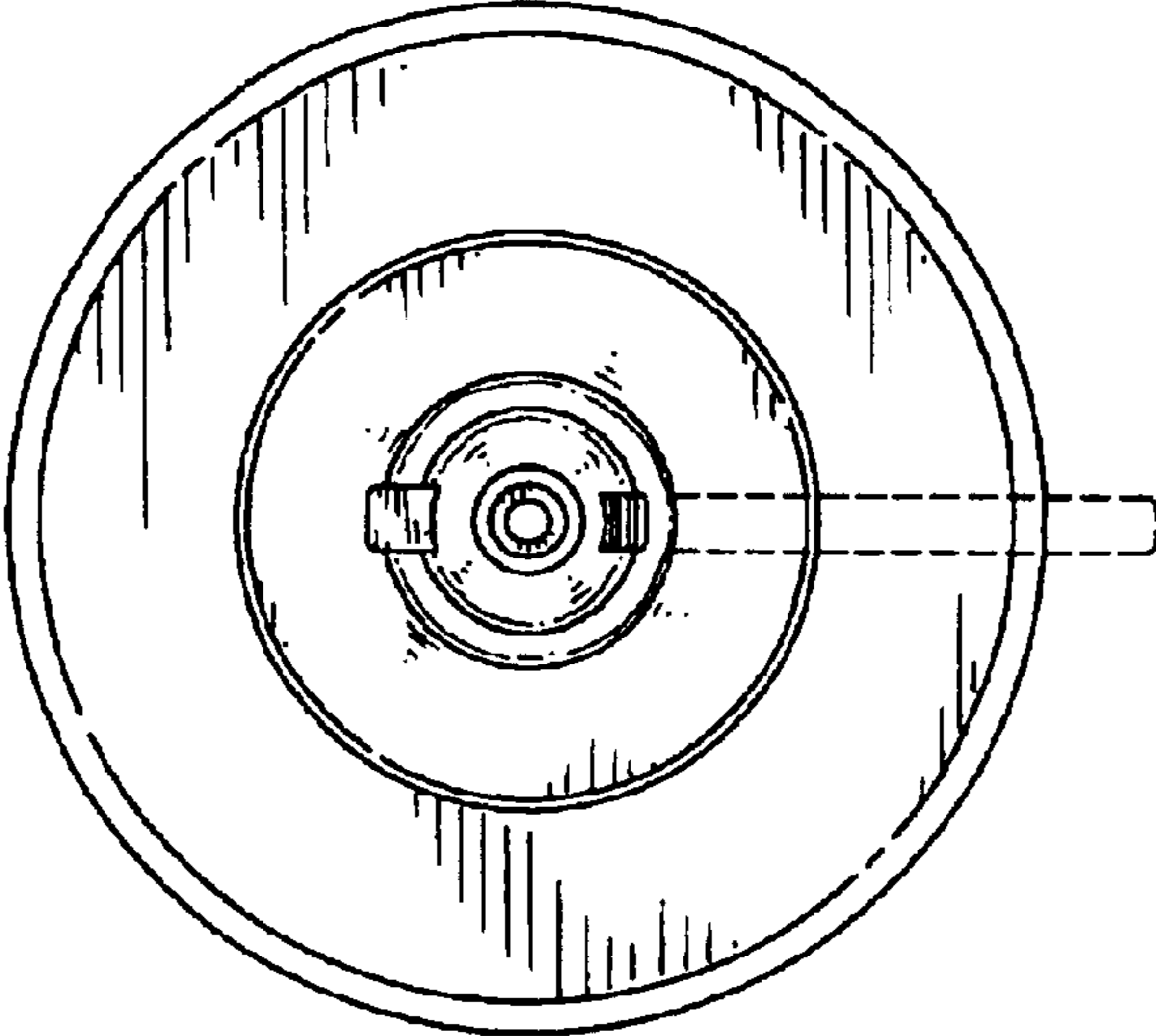

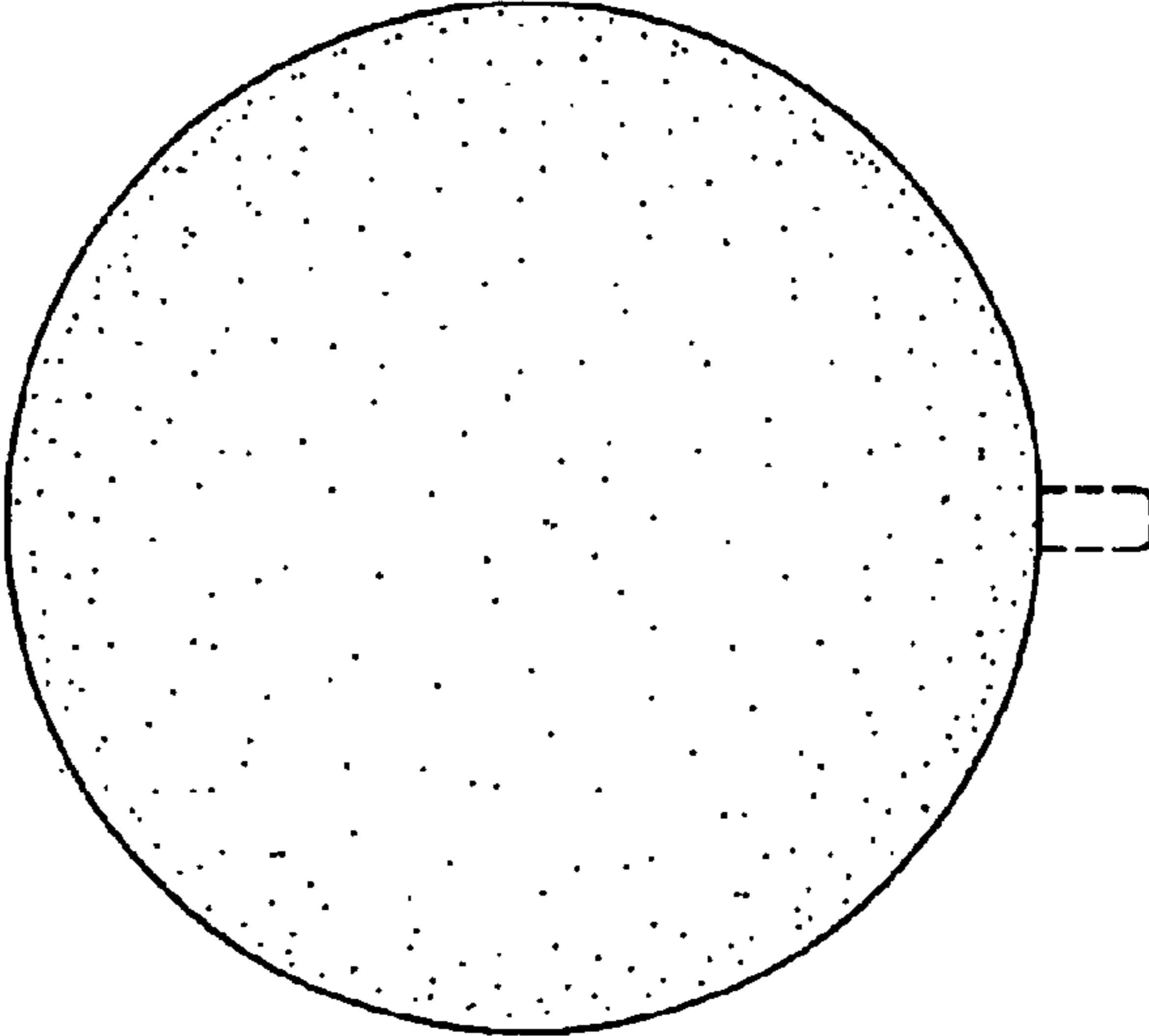
