DESCRIPTION

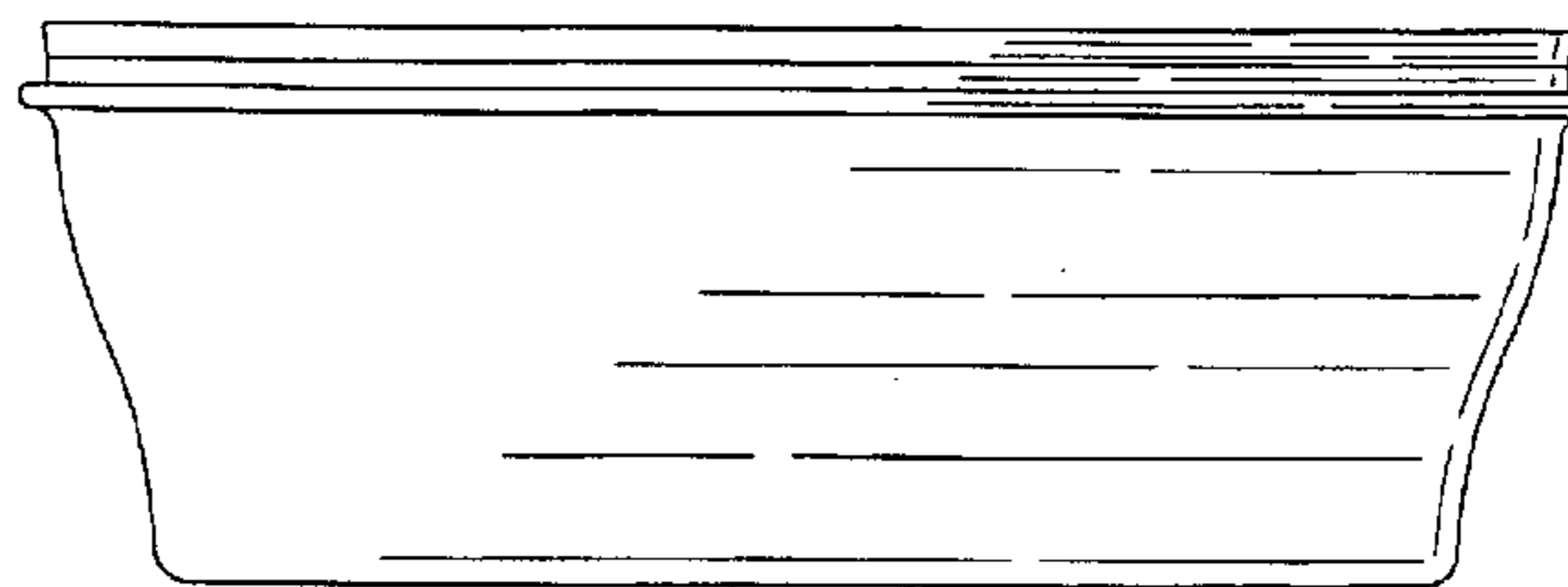
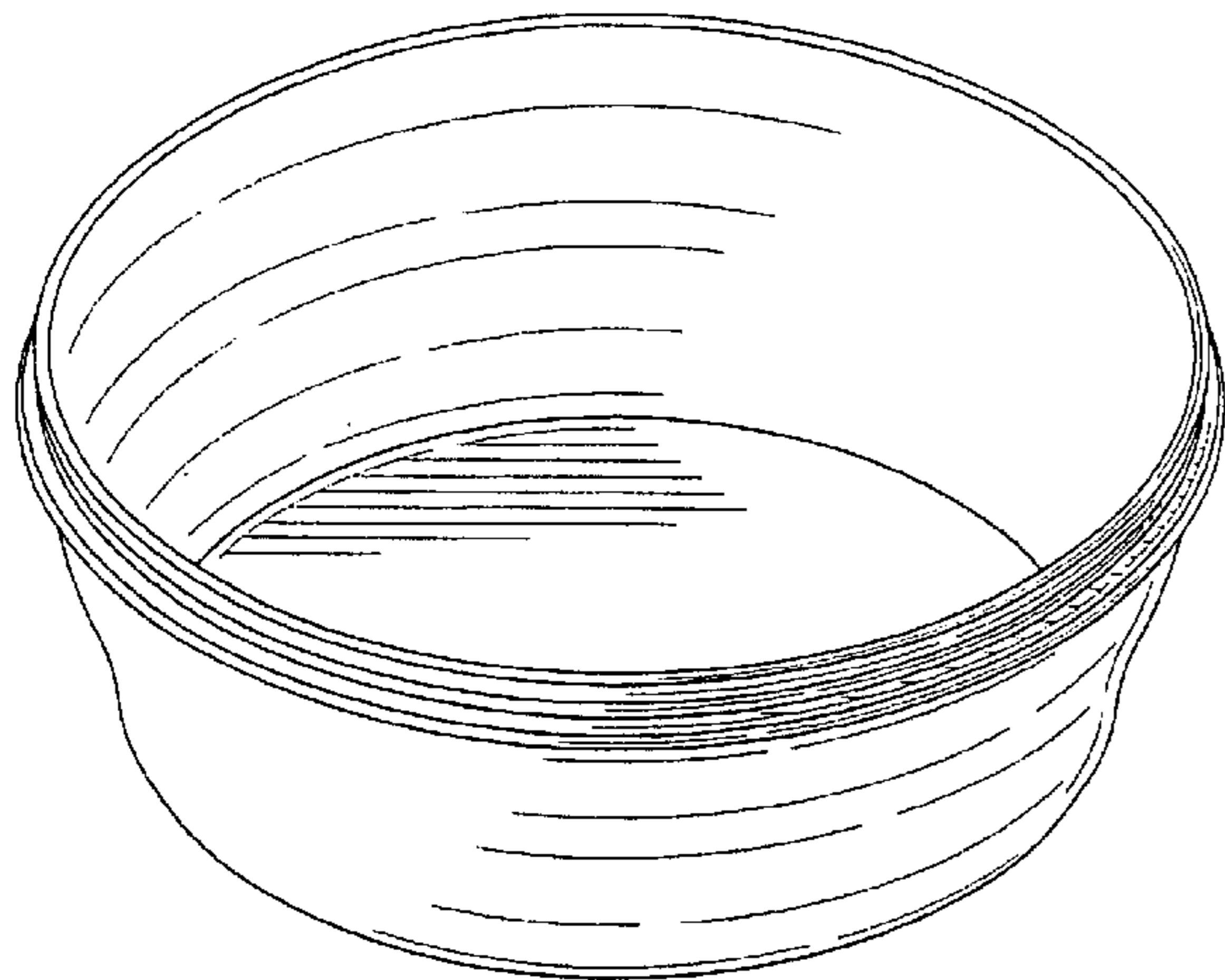
FIG. 1 is a top, side, front perspective view of a food container showing our new design;

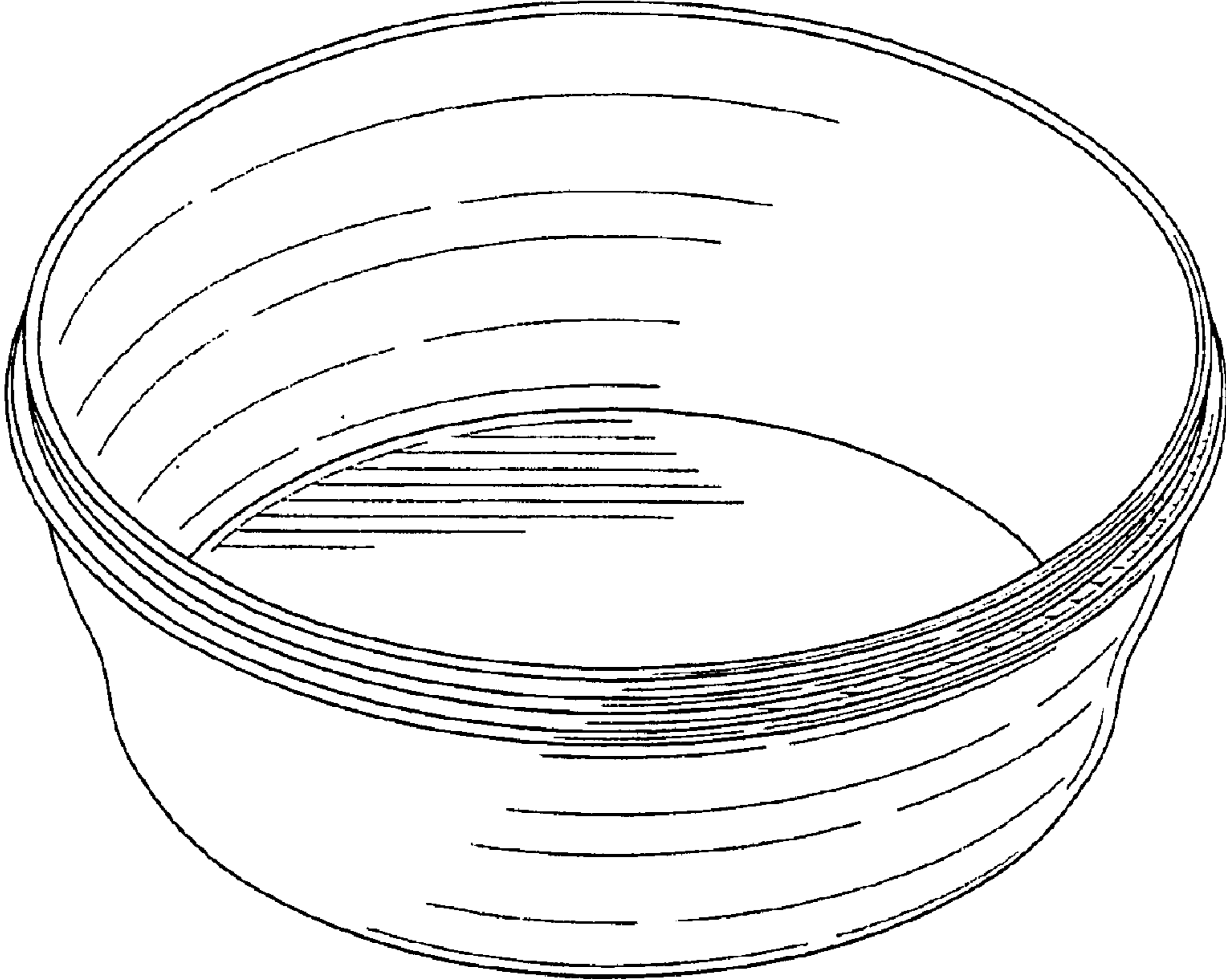

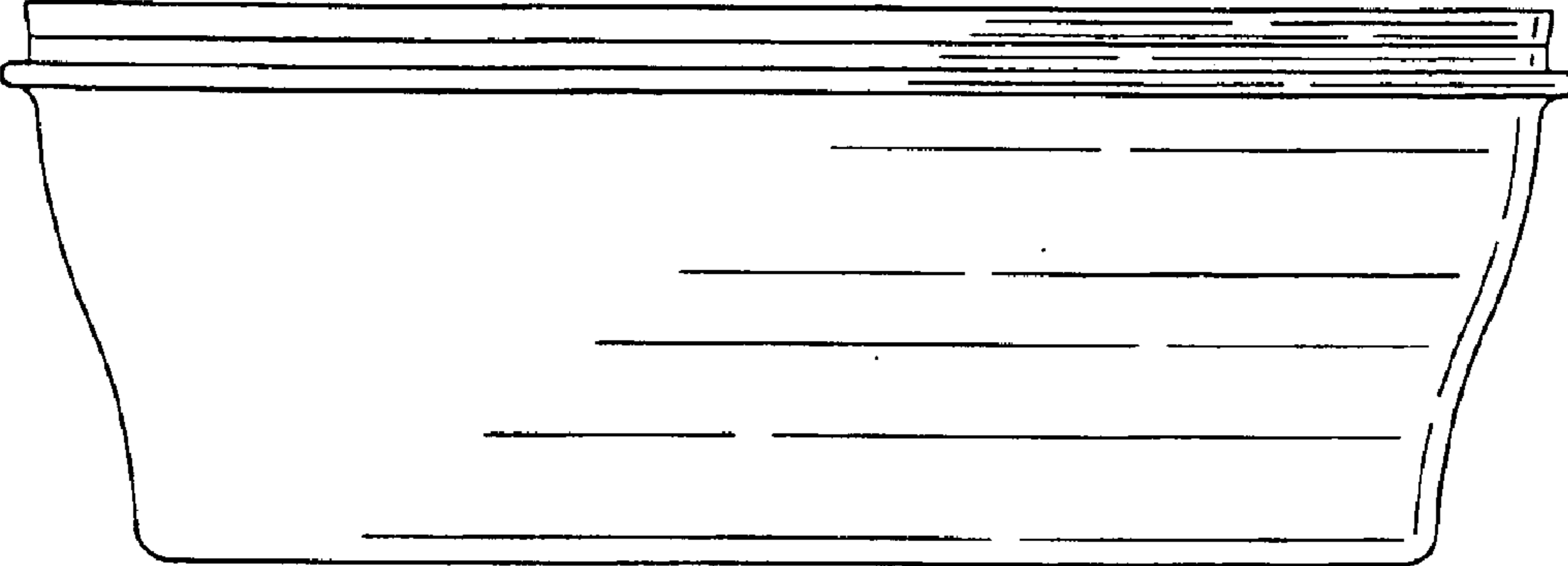

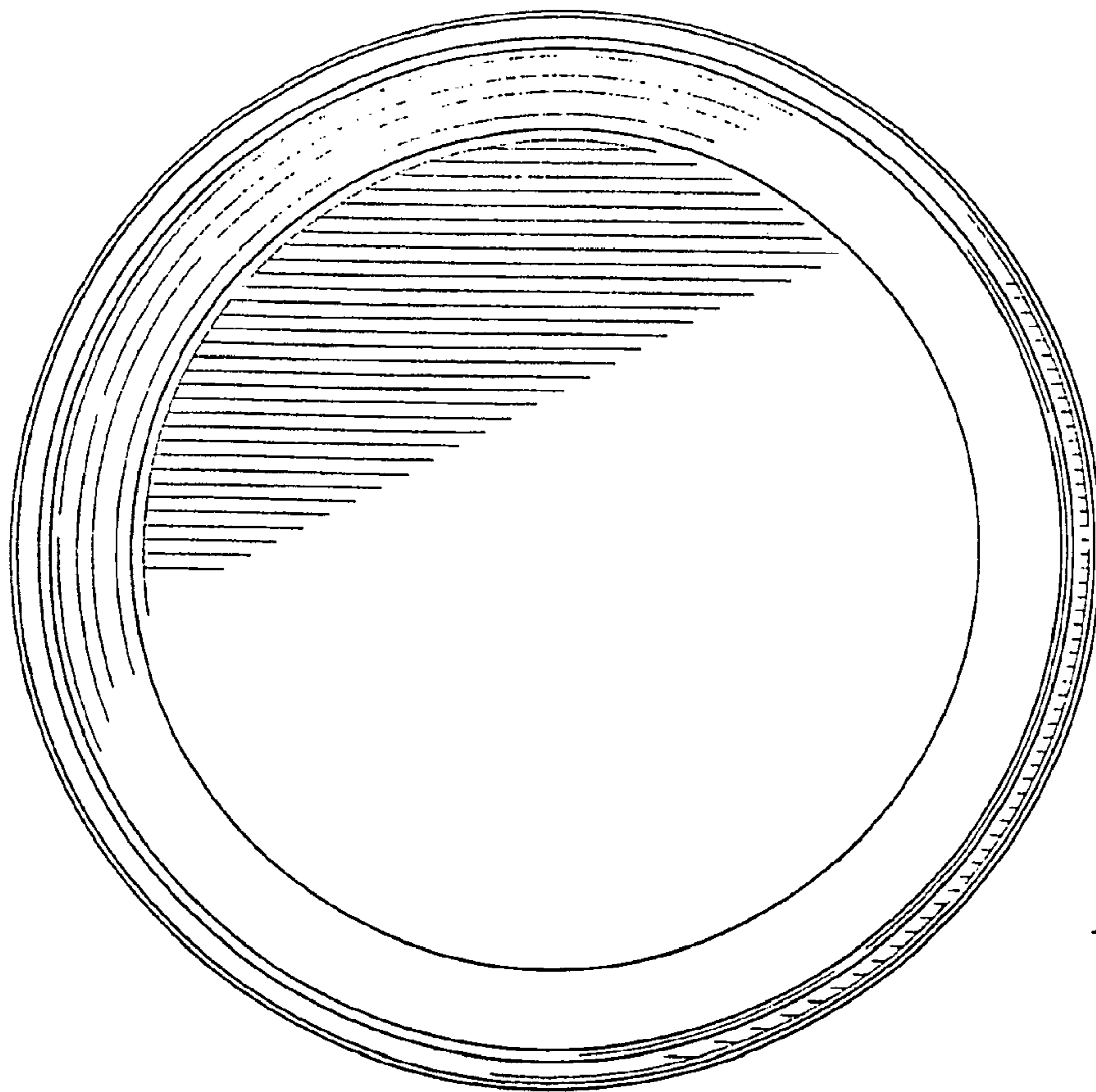

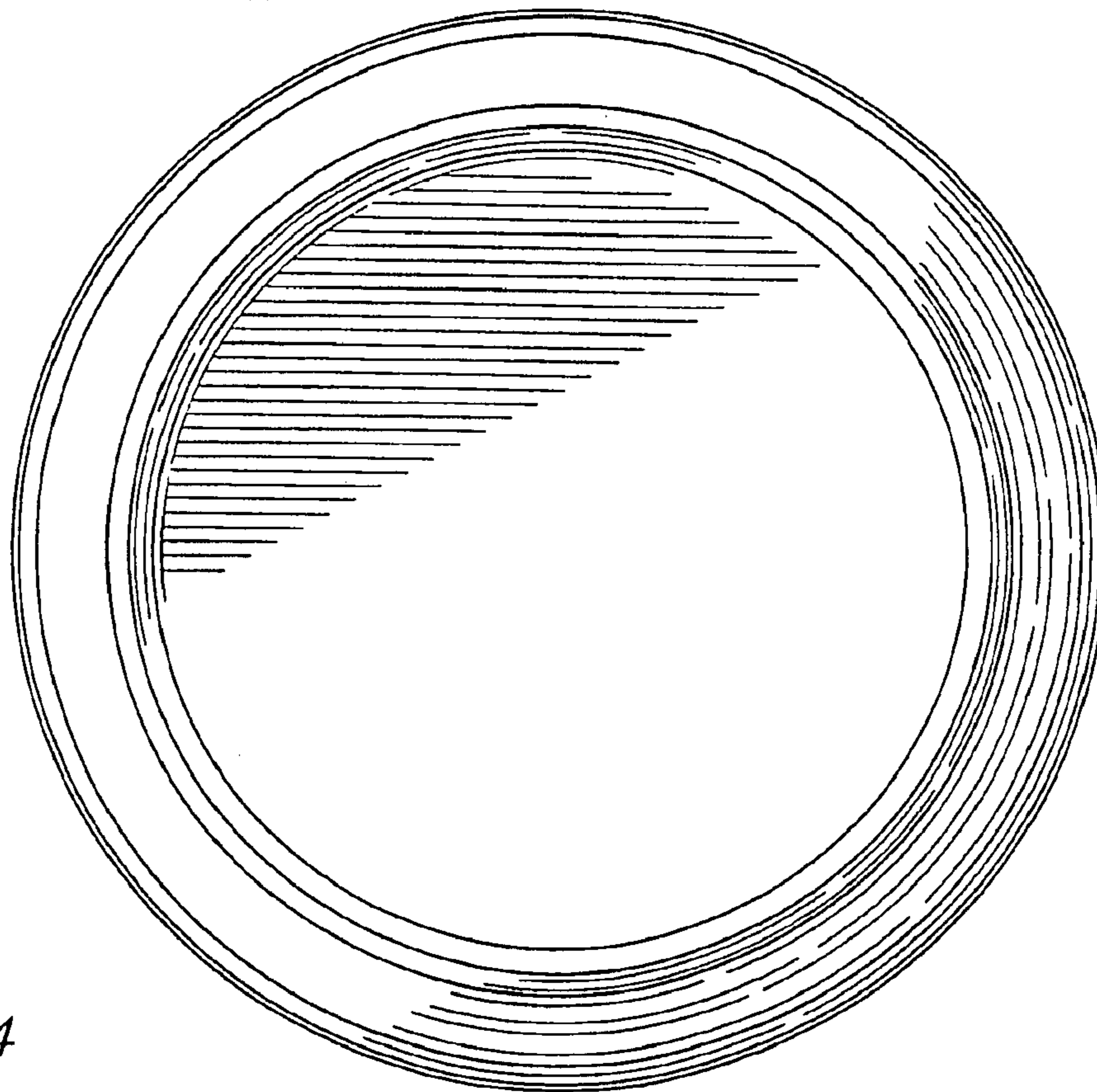
