(57) **CLAIM**

We claim the ornamental design for a pruner, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the claimed design. FIG. 2 is a front elevation view of the claimed design. FIG. 3 is a rear elevation view of the claimed design. FIG. 4 is a top view of the claimed design. FIG. 5 is a bottom view of the claimed design. The ornamental design which is claimed is shown in solid lines in the drawings. The broken lines in the drawings are for illustrative purposes only and form no part of the claimed design.

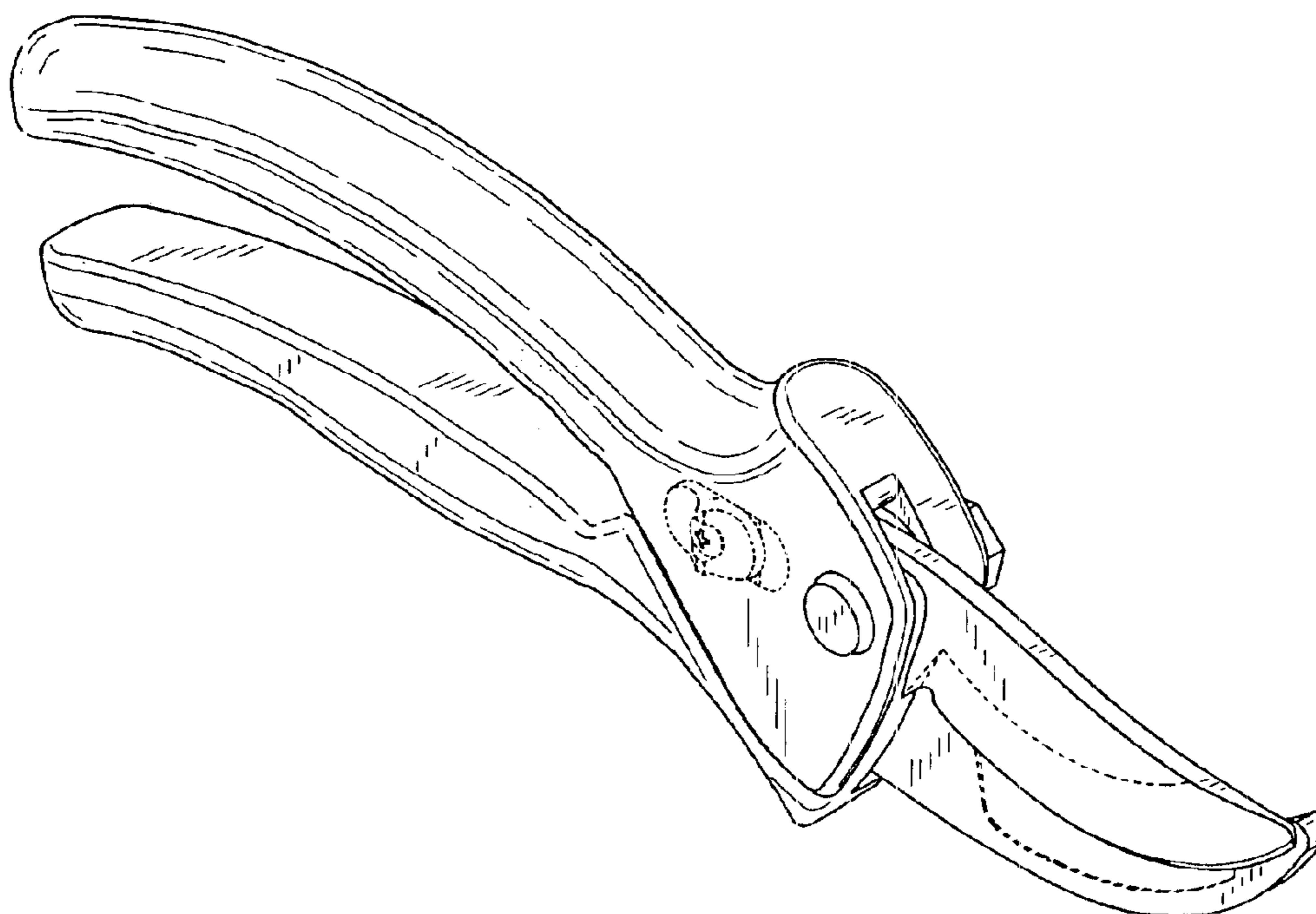

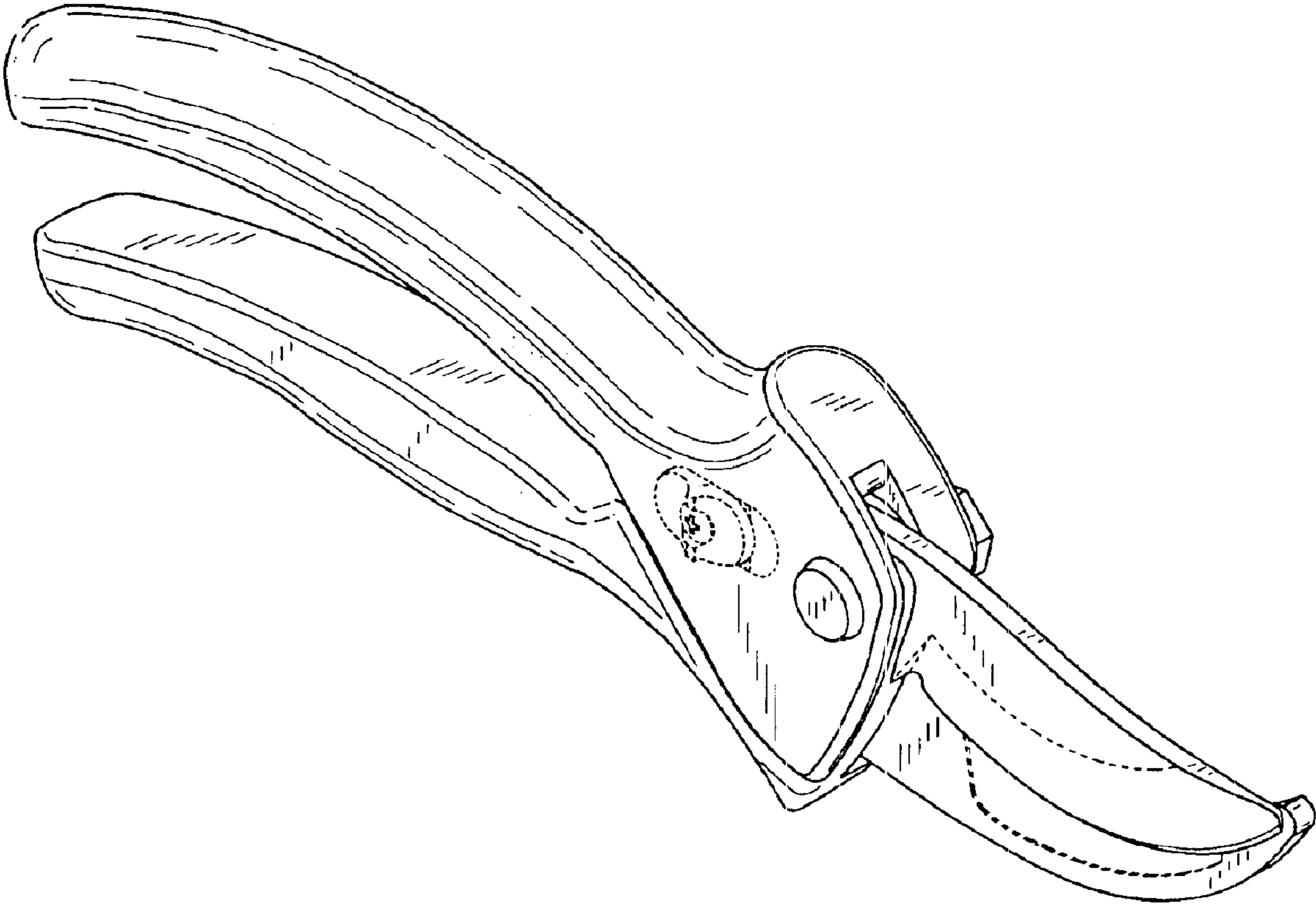

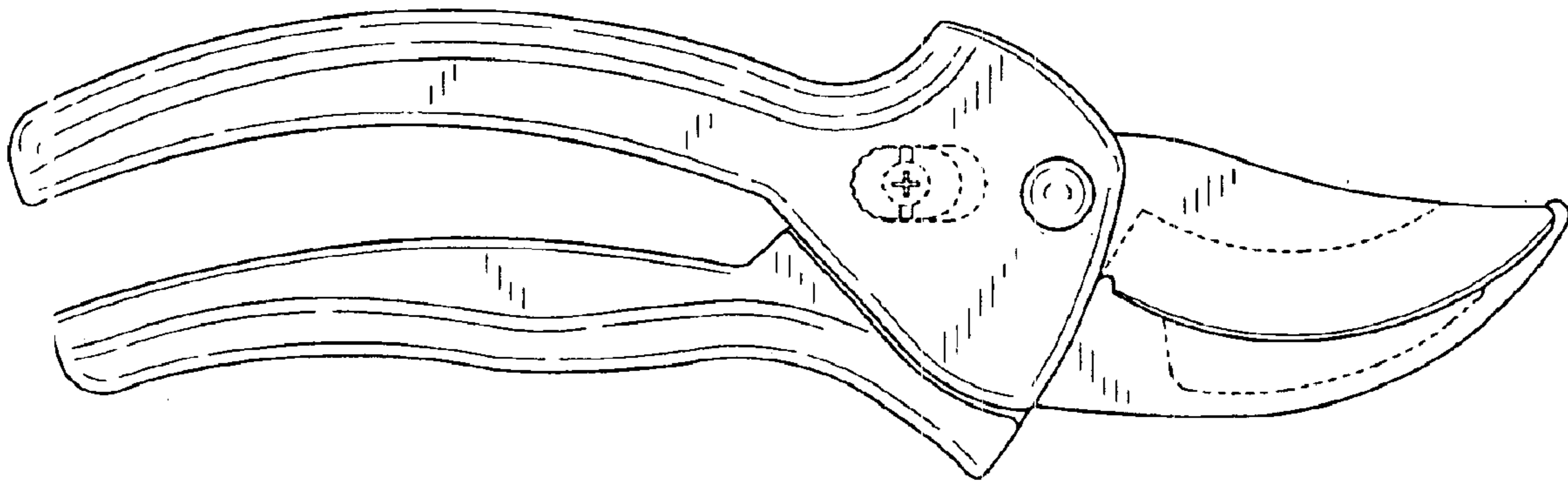

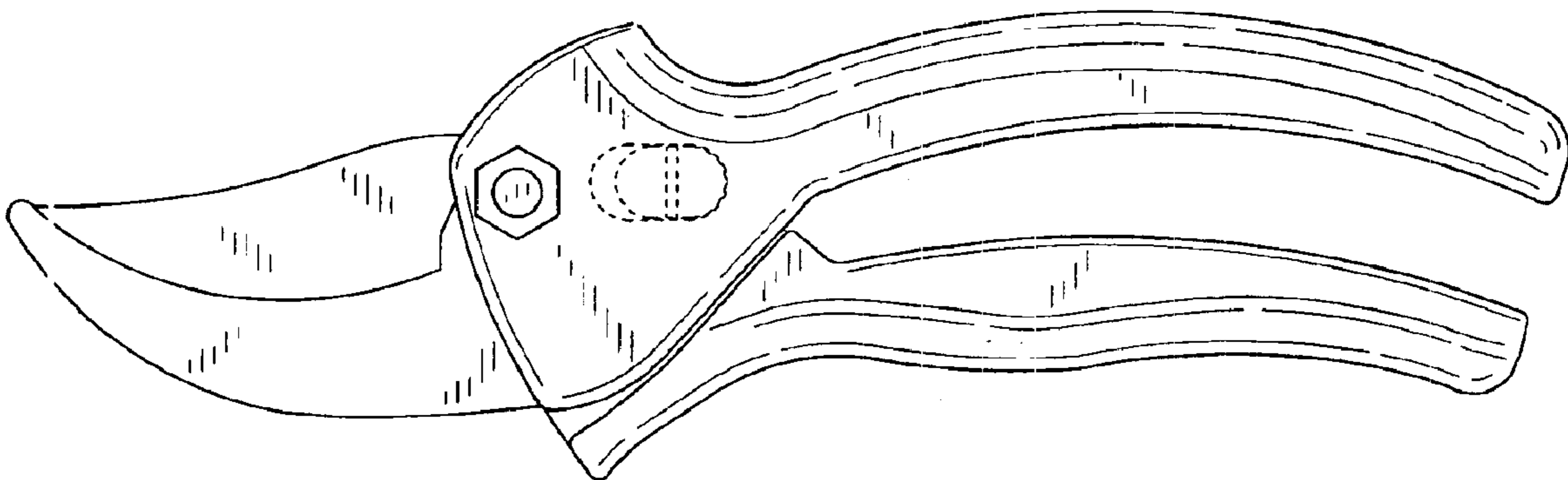

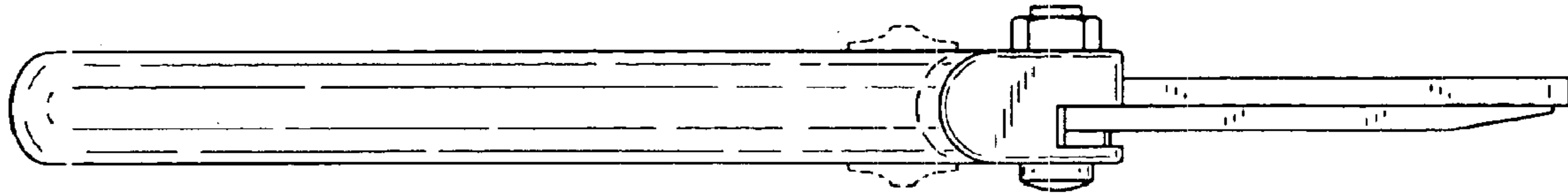

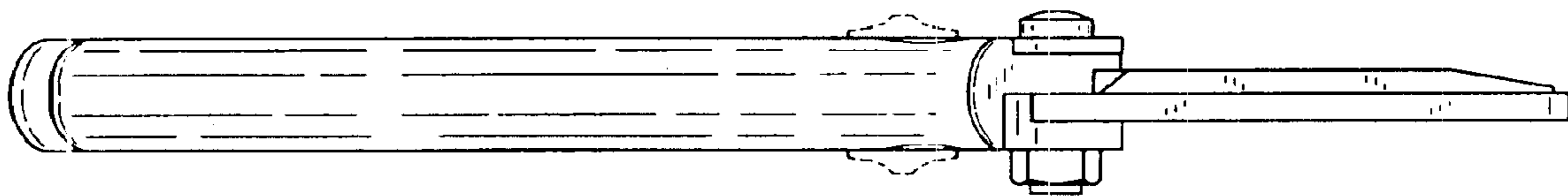

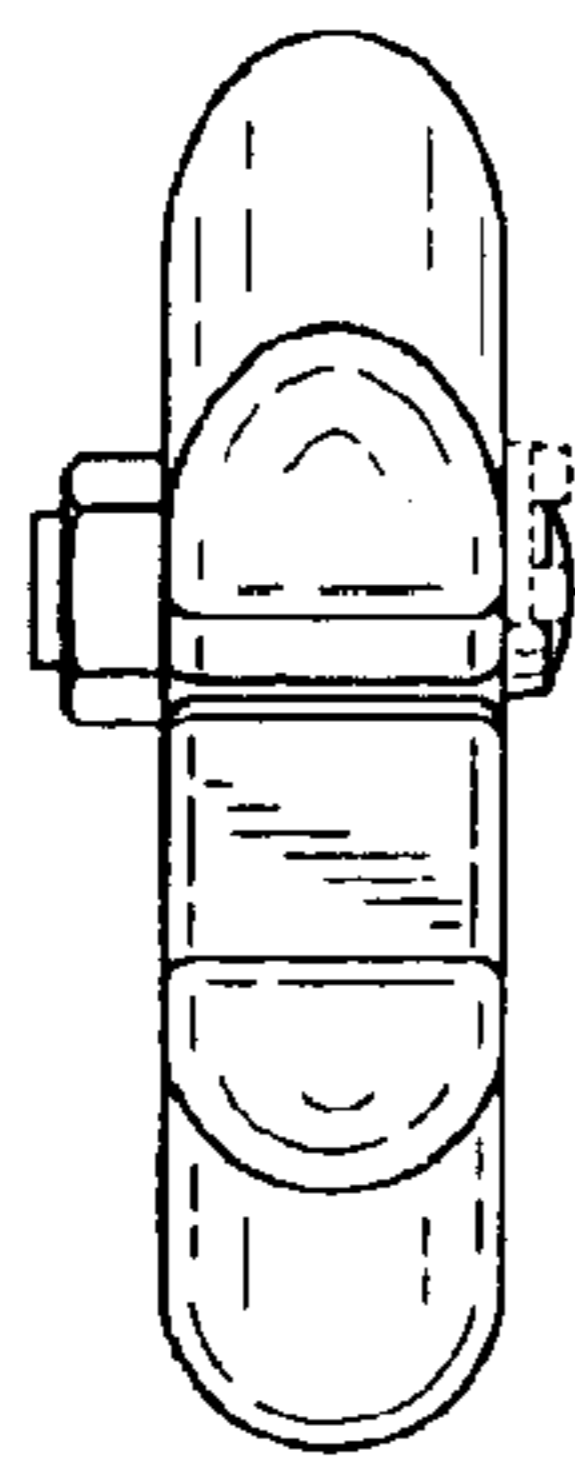
