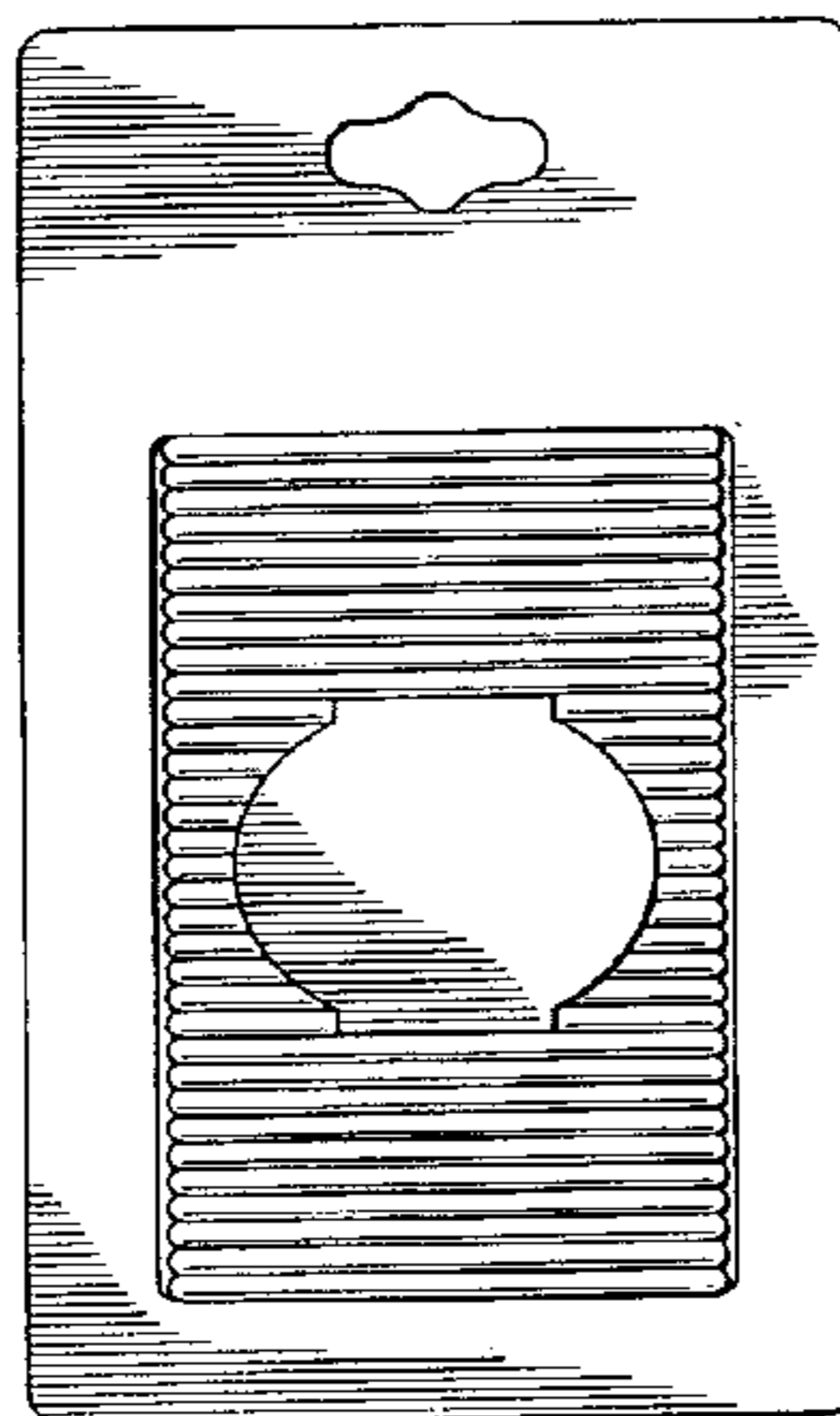
(57) **CLAIM**

FIG. 1 is a front elevational view of a display package showing our new design;

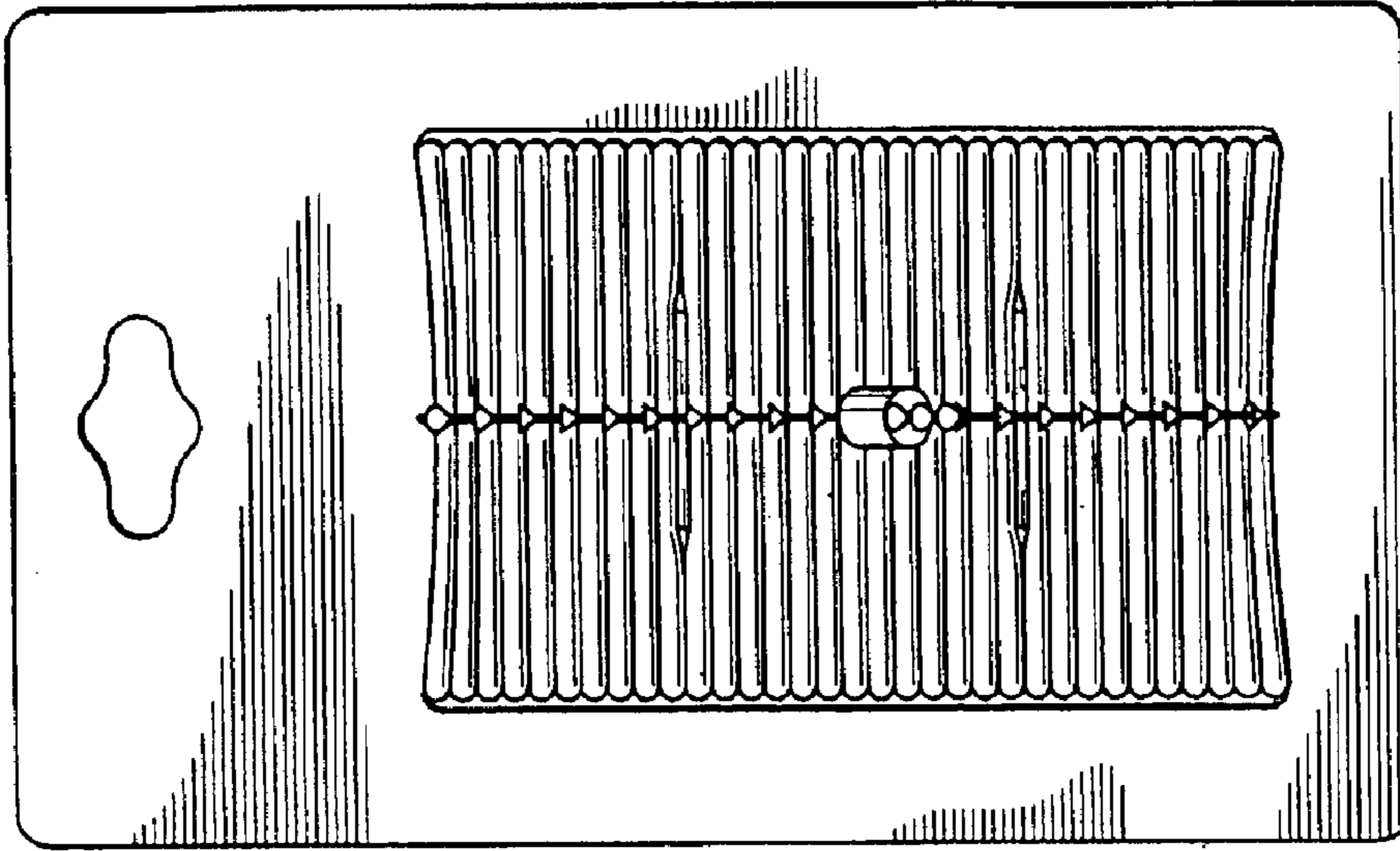

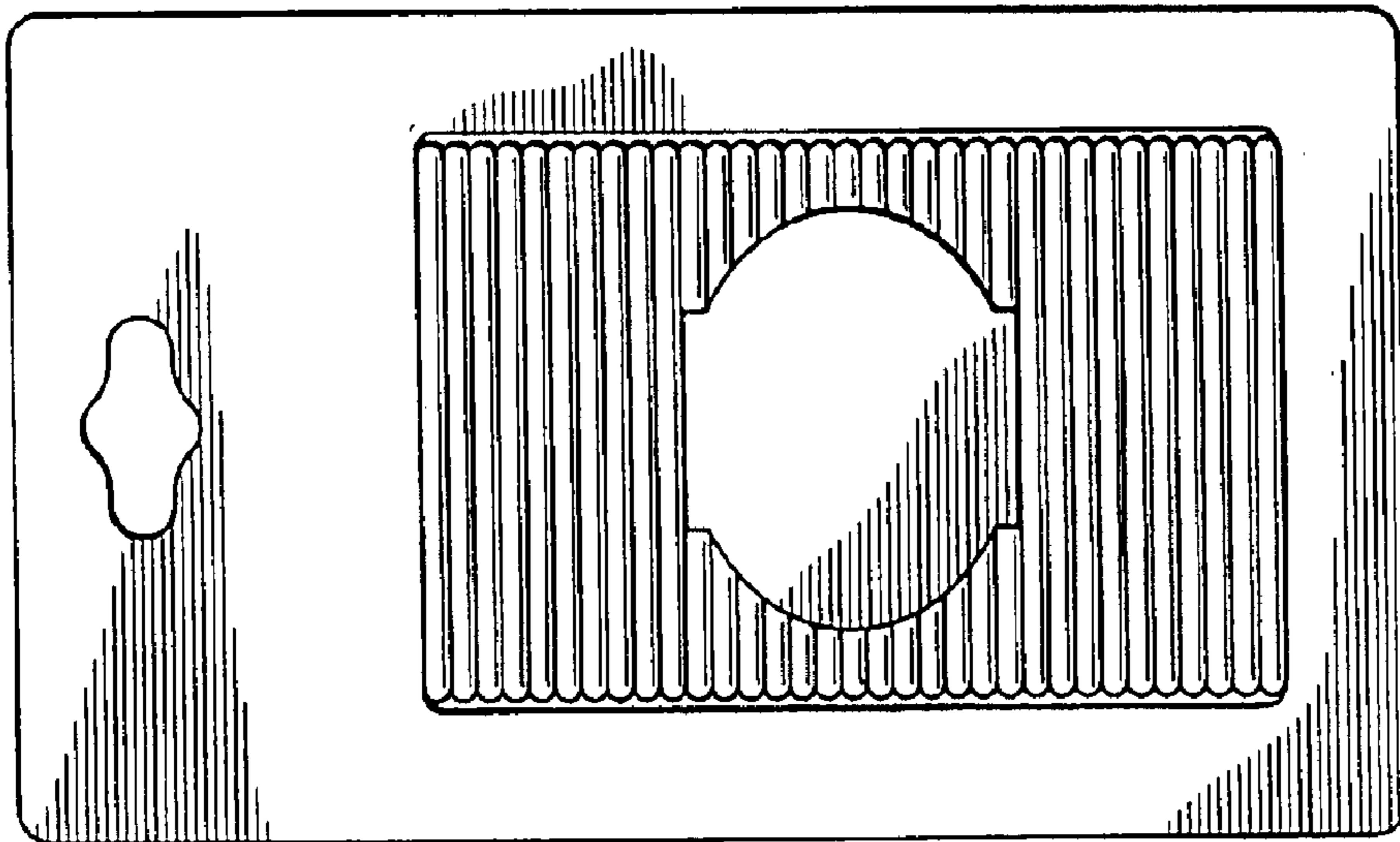

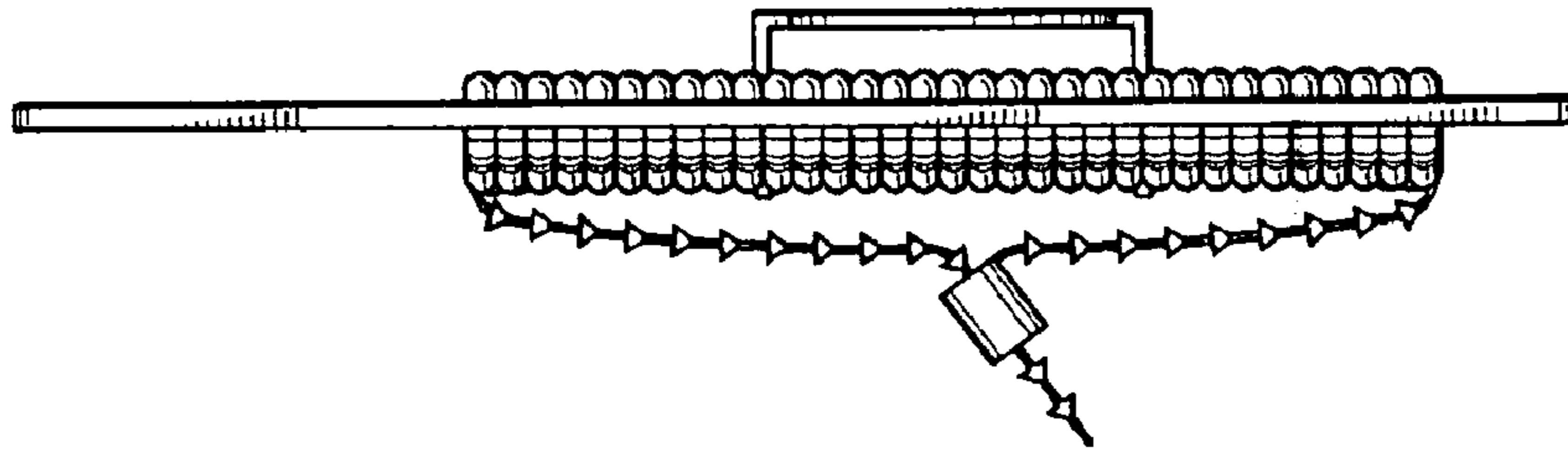

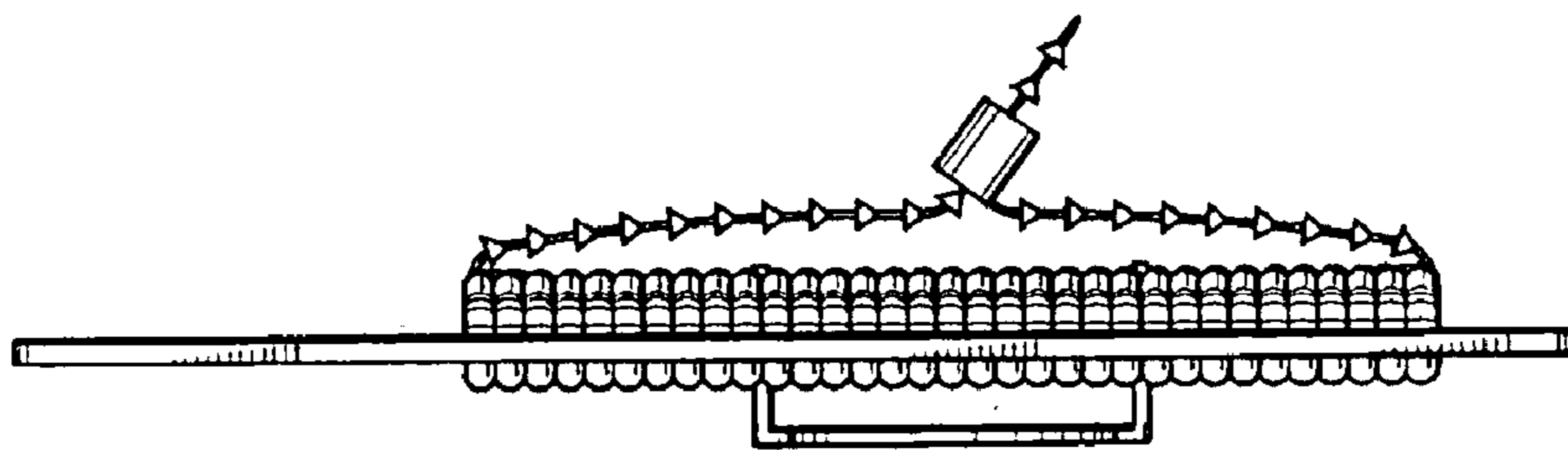

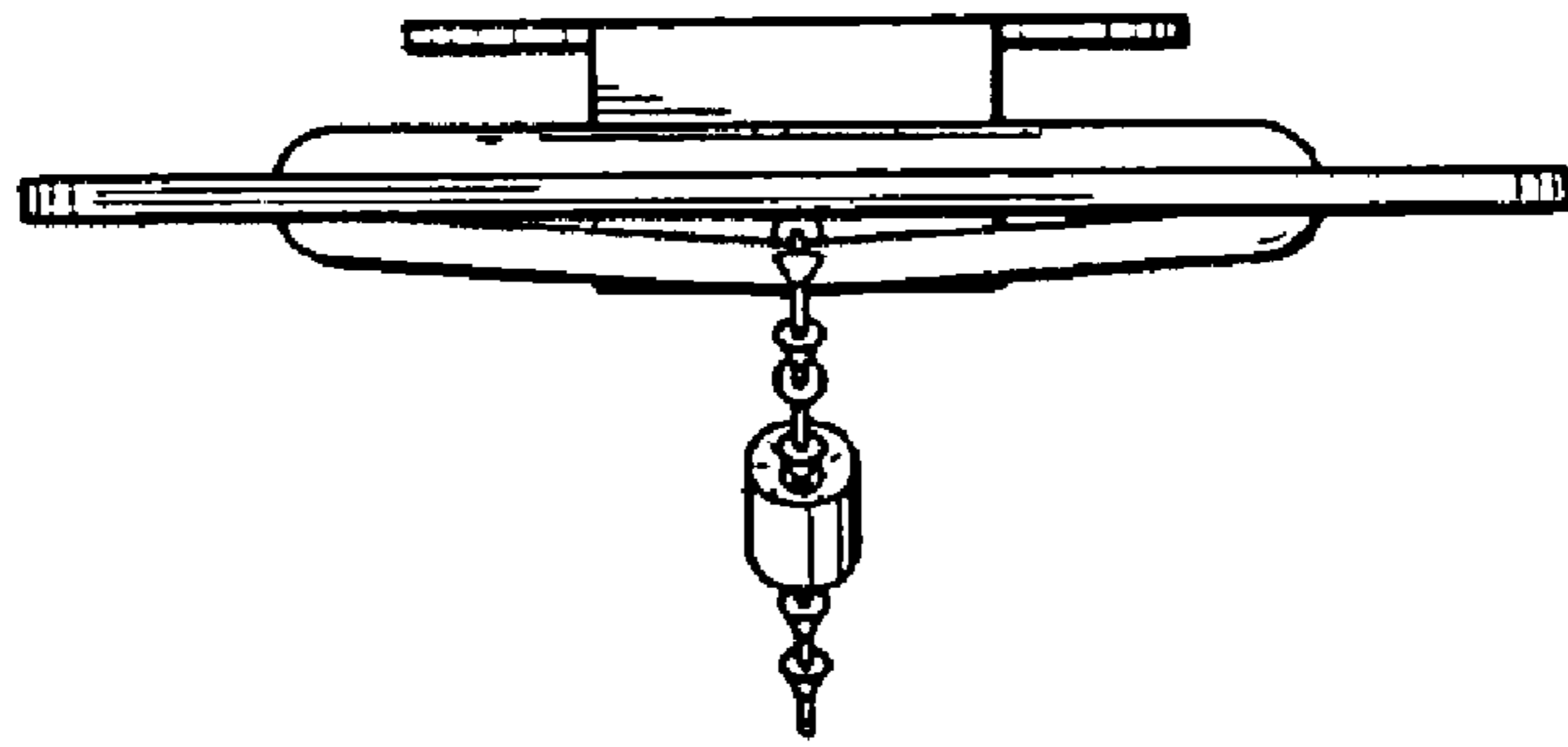

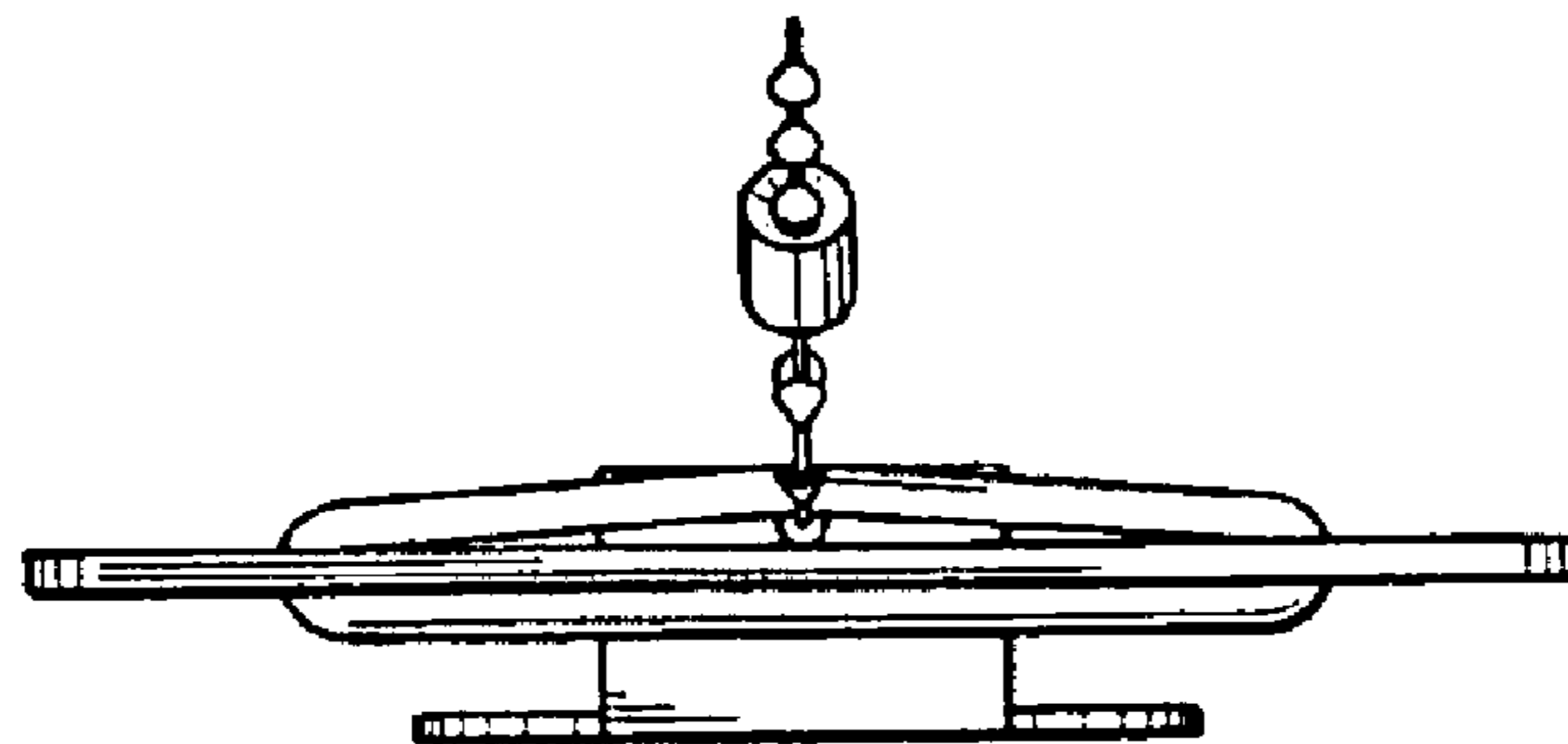
