DESCRIPTION

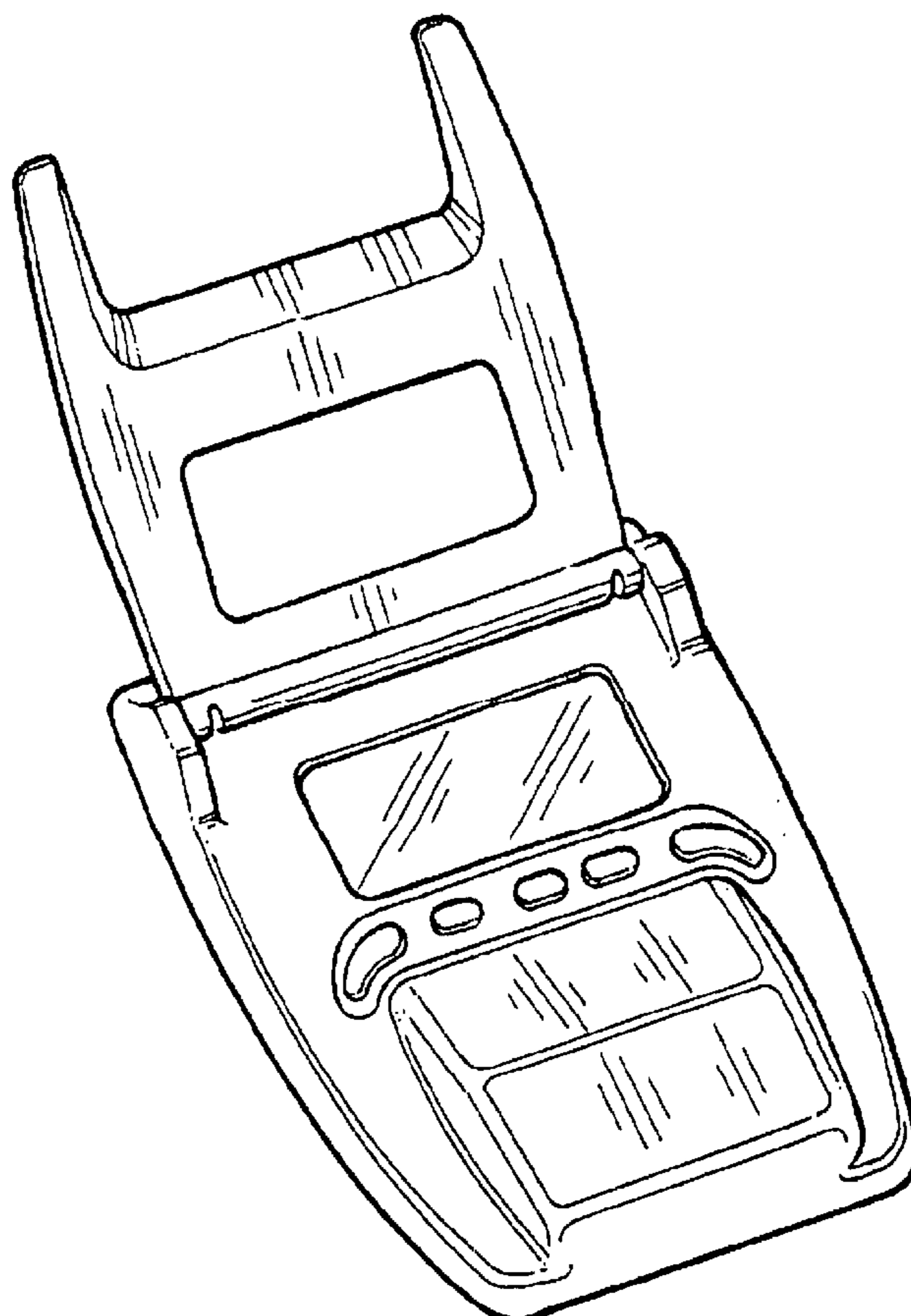
FIG. 1 is a front perspective view of a child proximity monitor shown in a cover-open position;

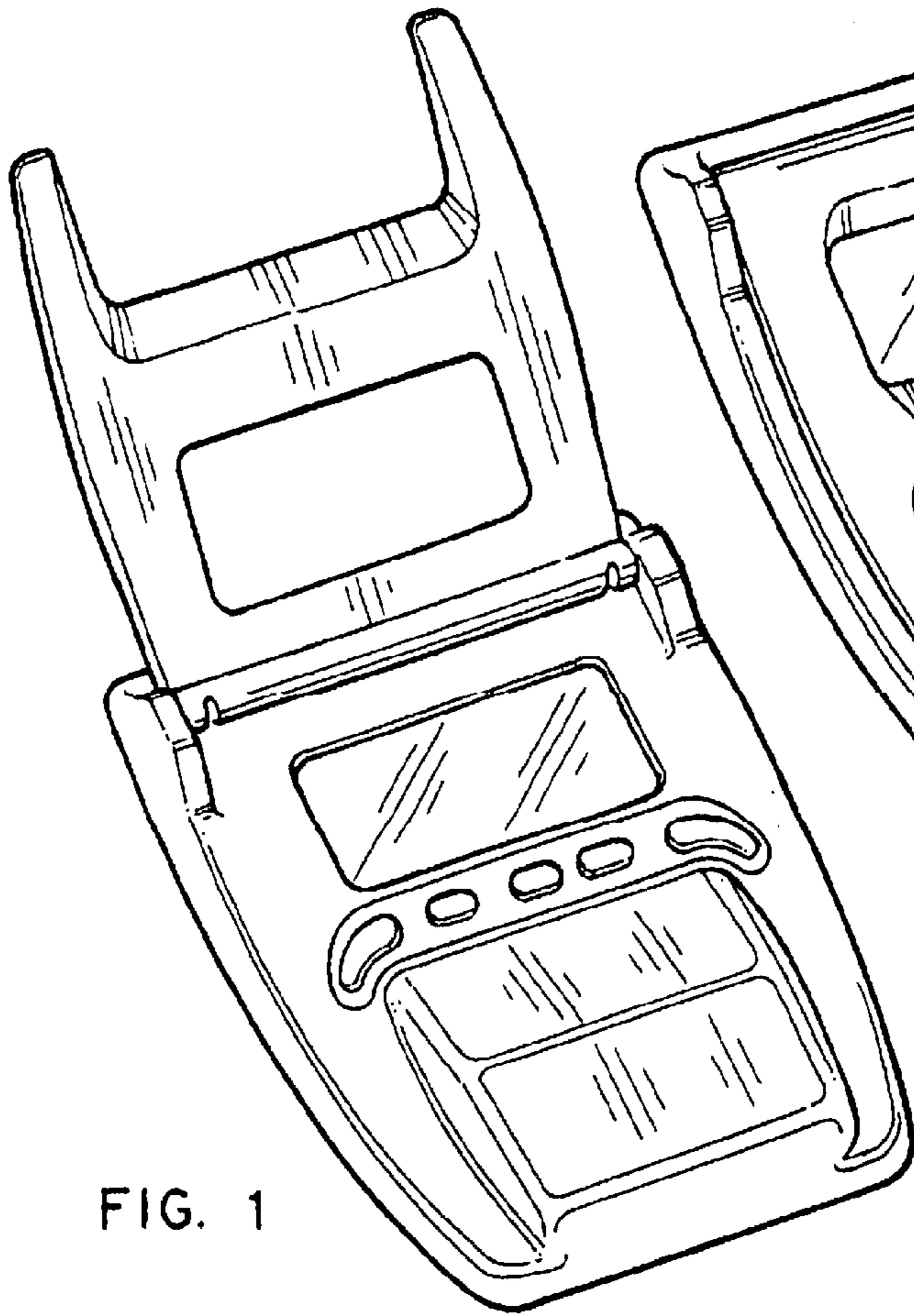

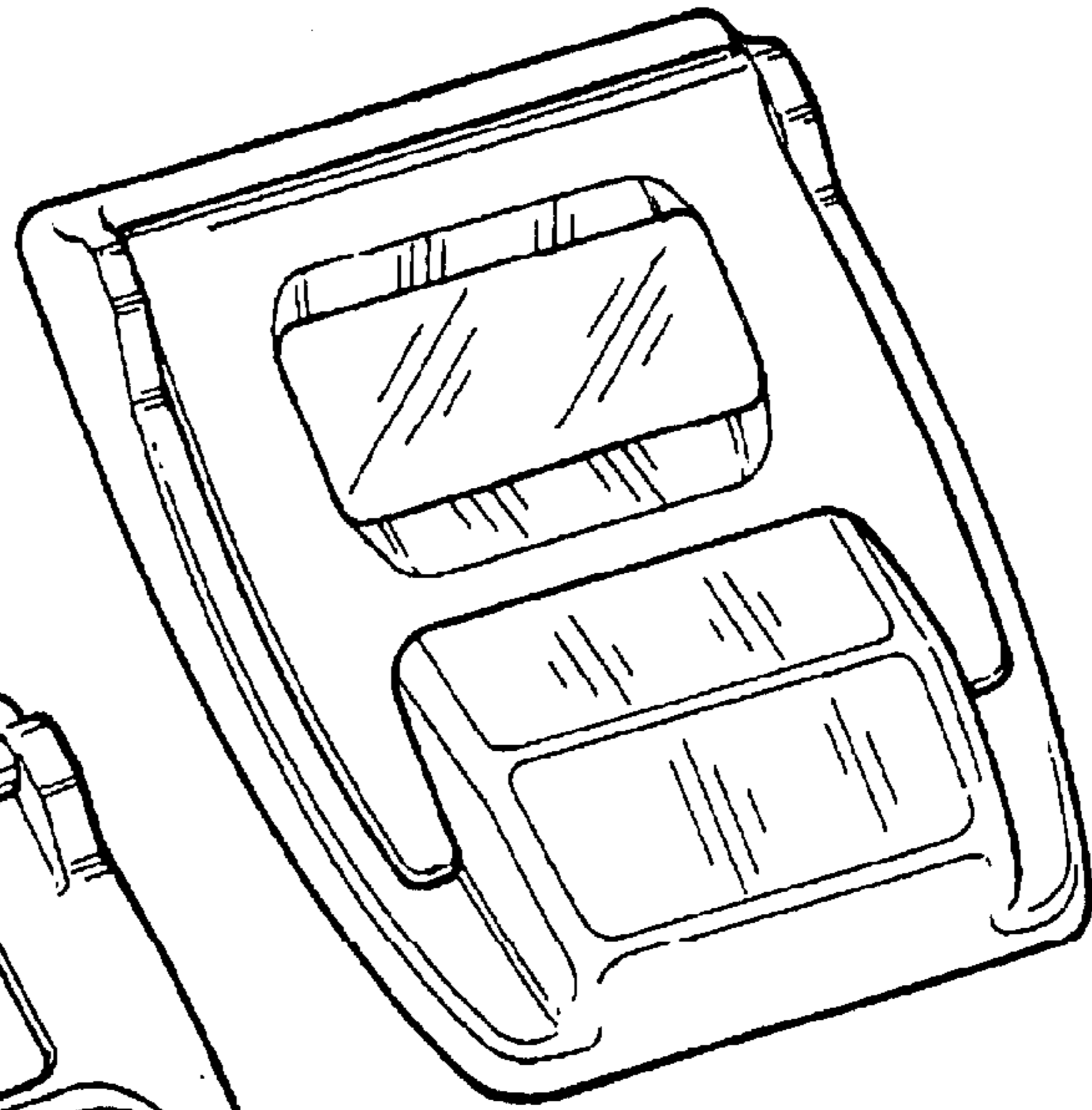

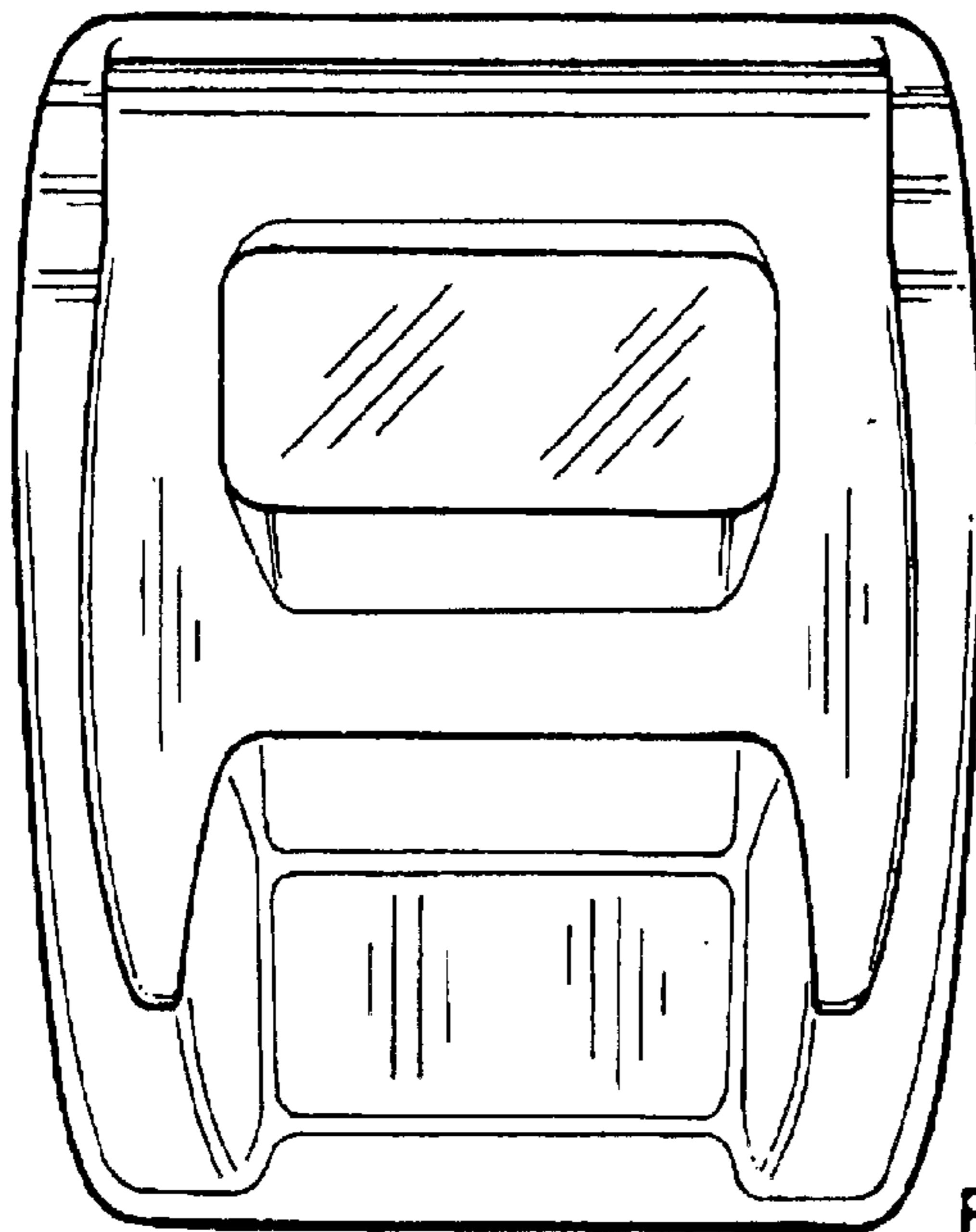

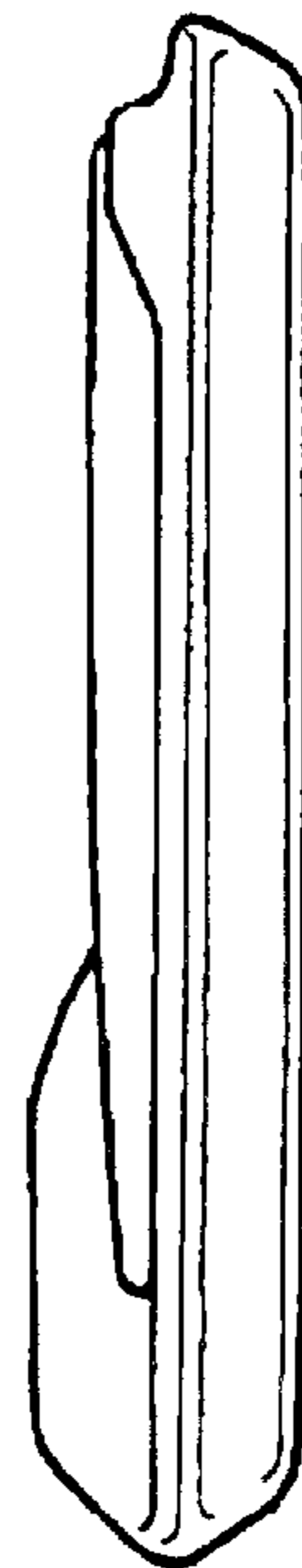

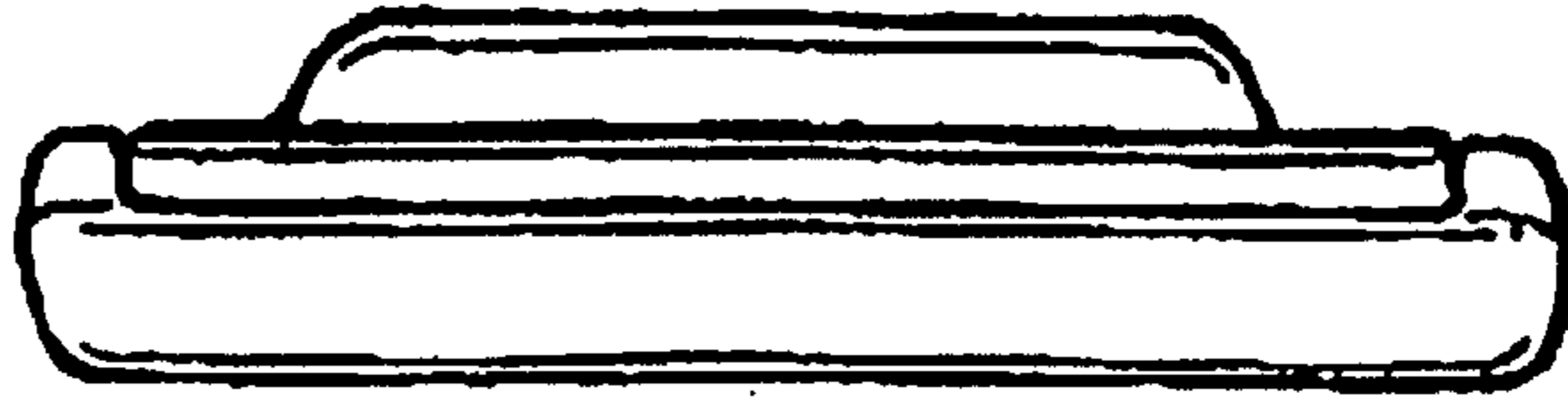

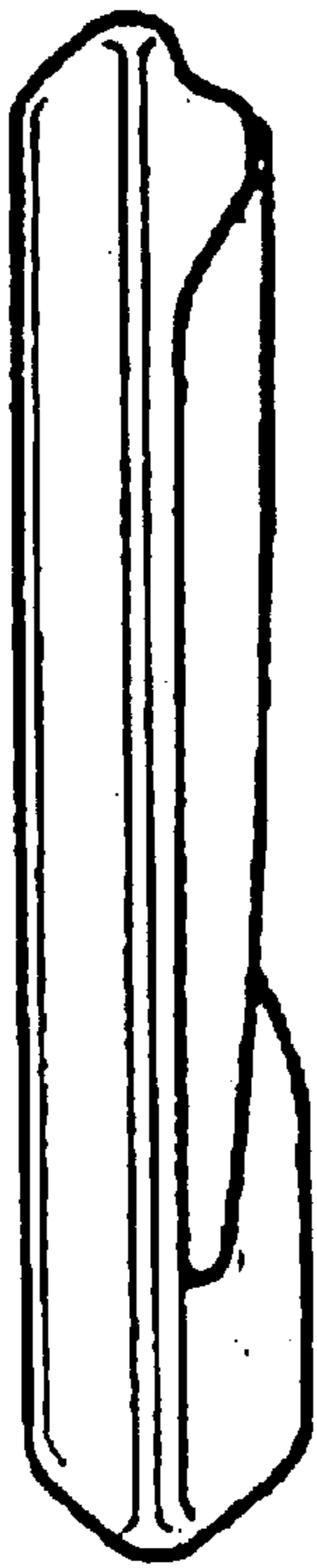

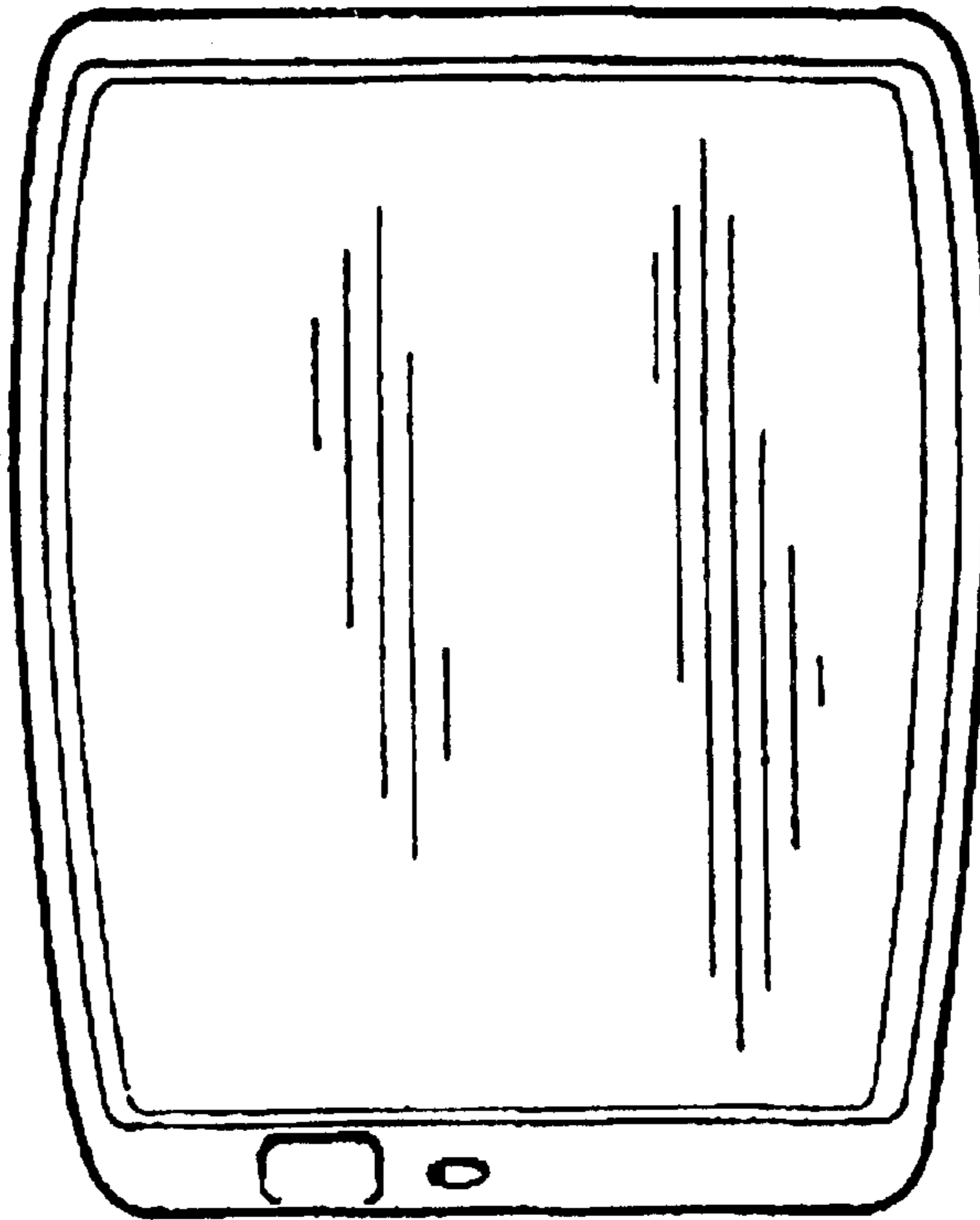

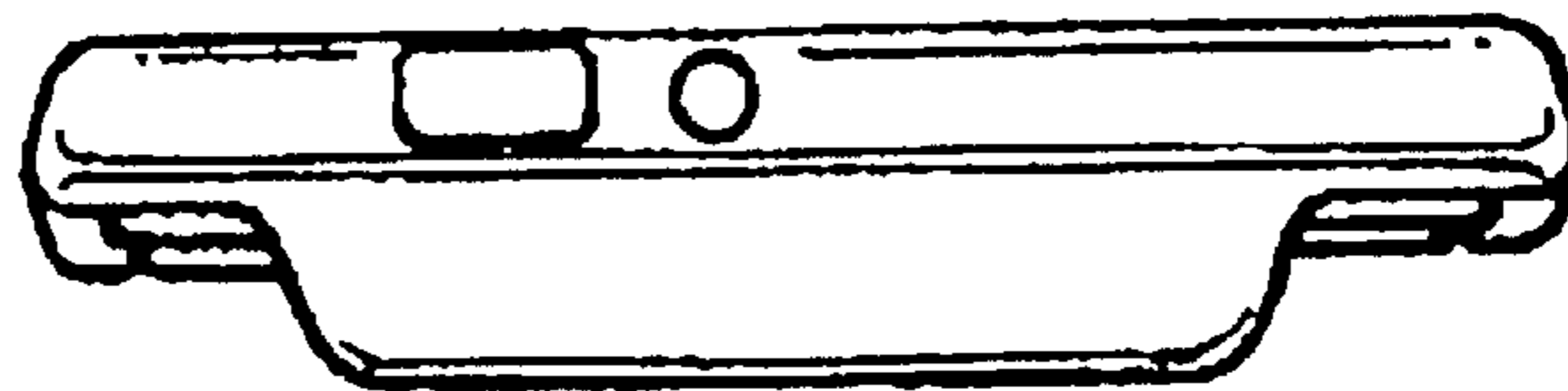
