(57) **CLAIM**

The ornamental design for a ceiling fan wall controller, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a ceiling fan wall controller showing my new design in a preferred form.

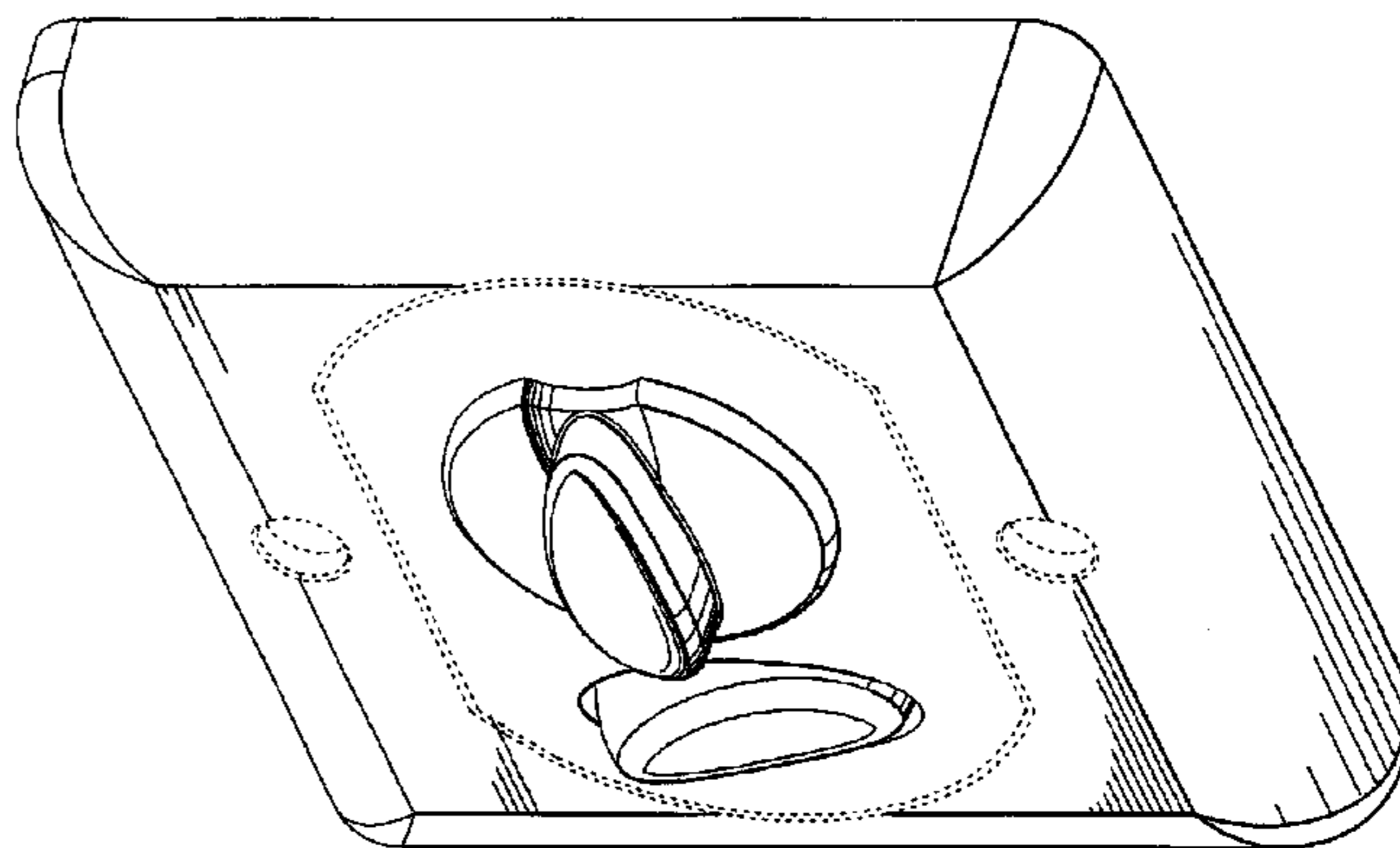
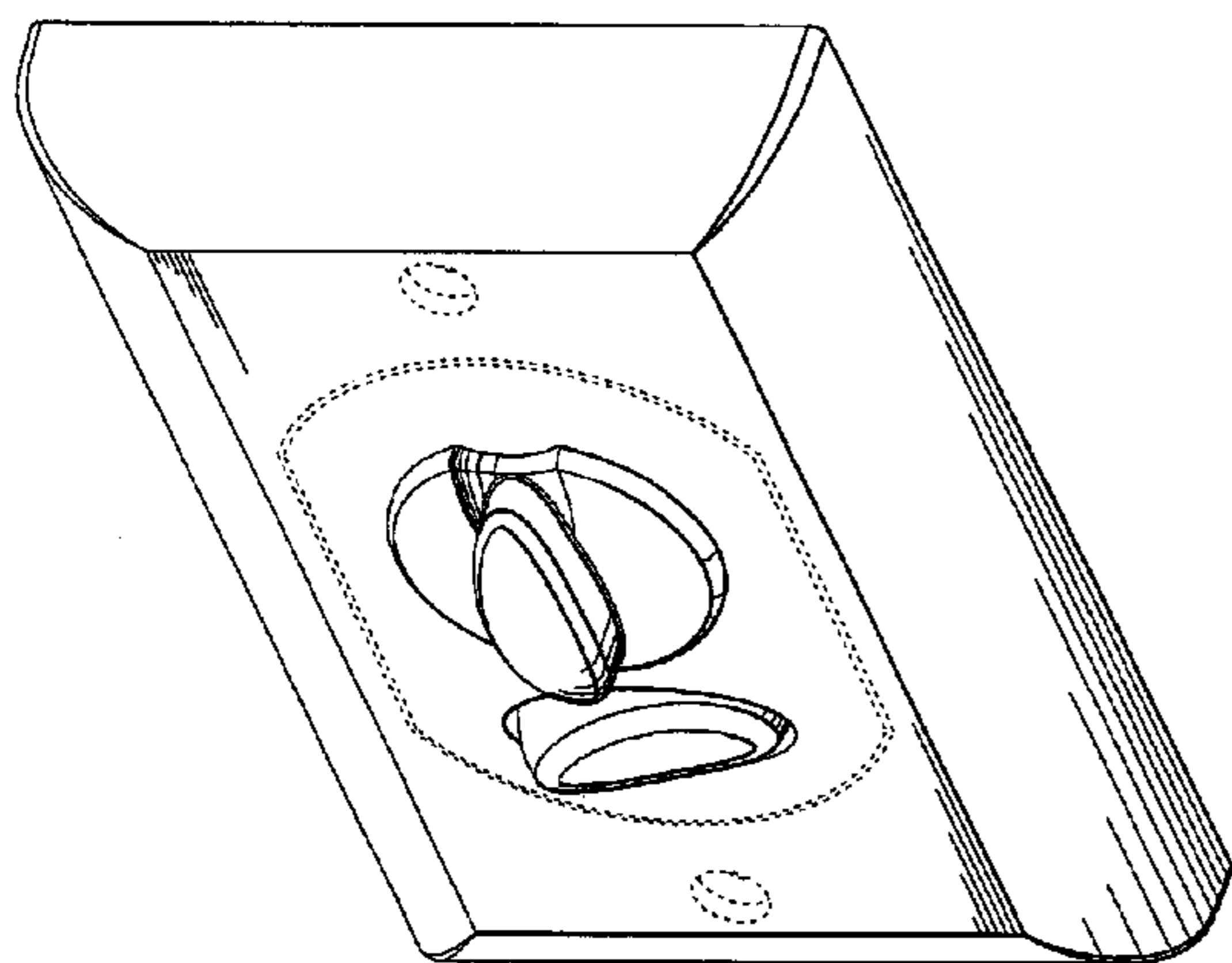

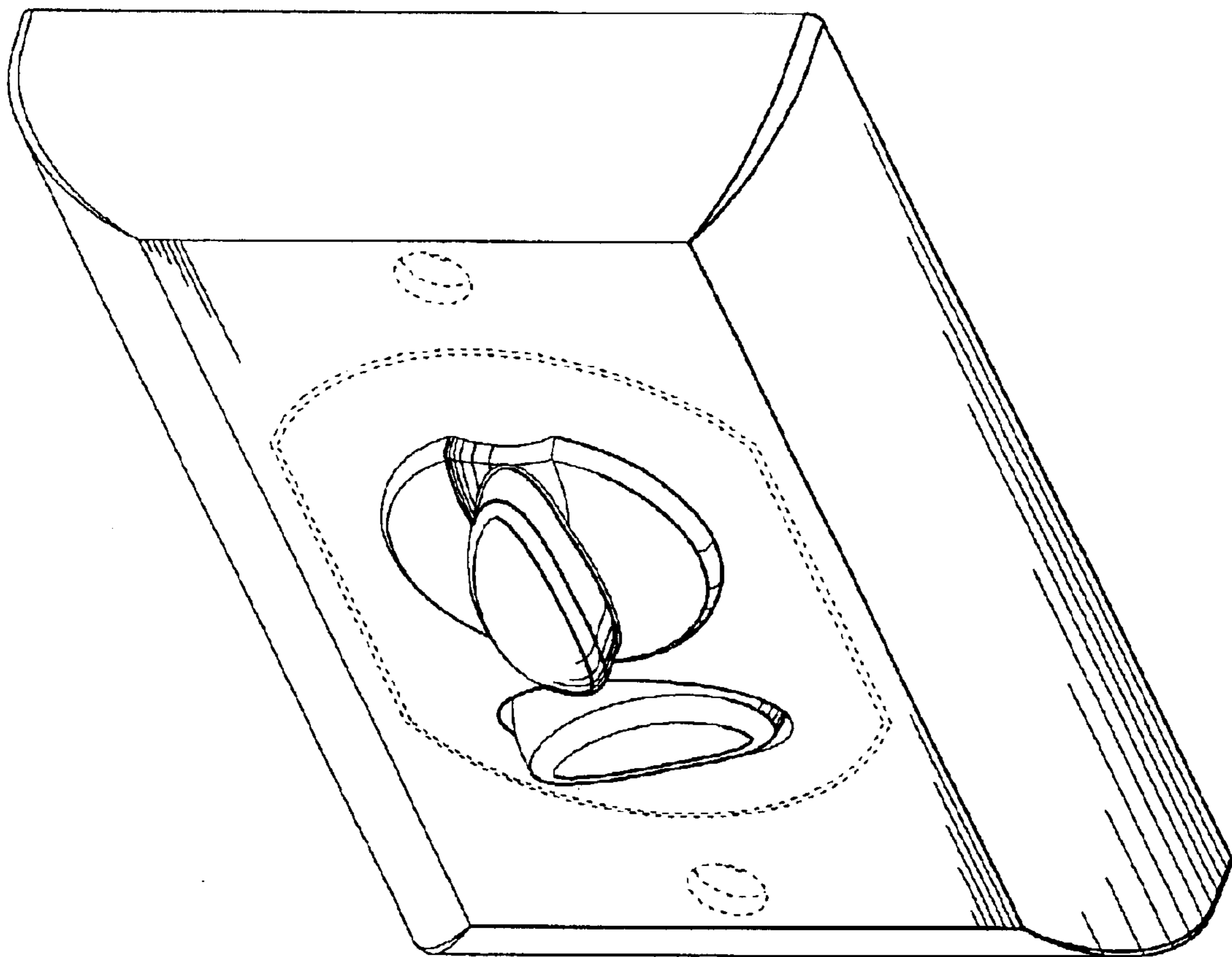

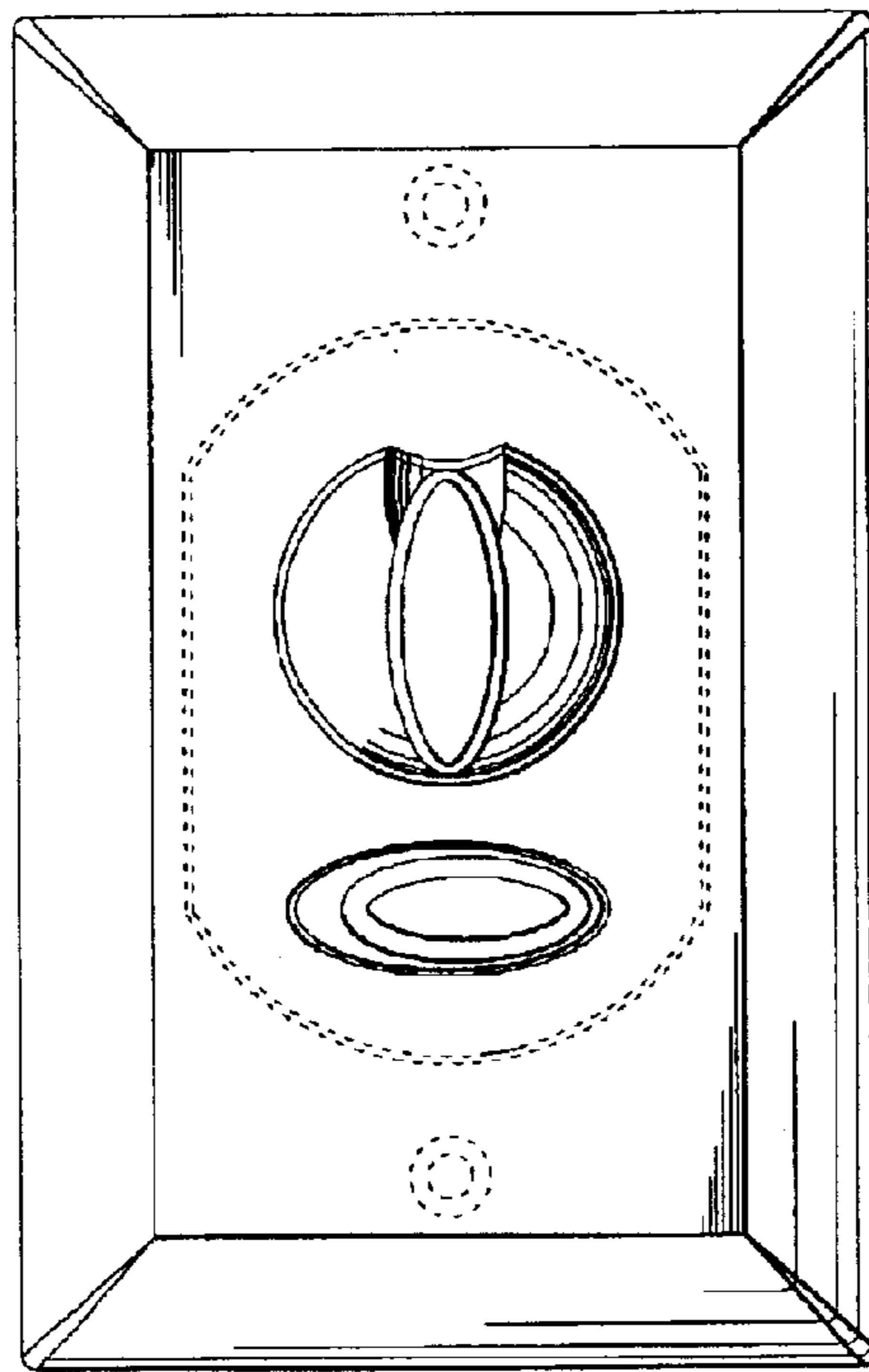

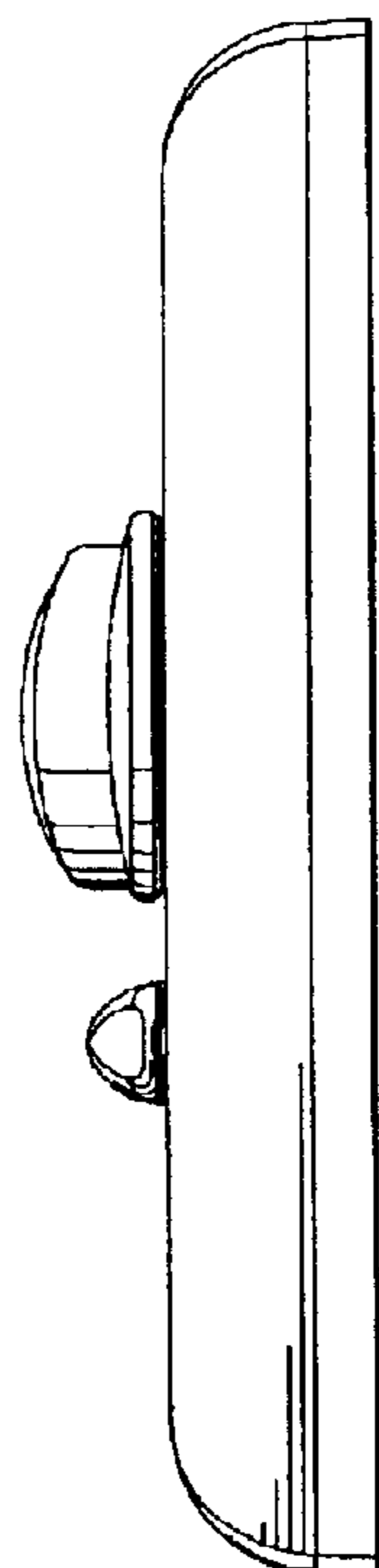

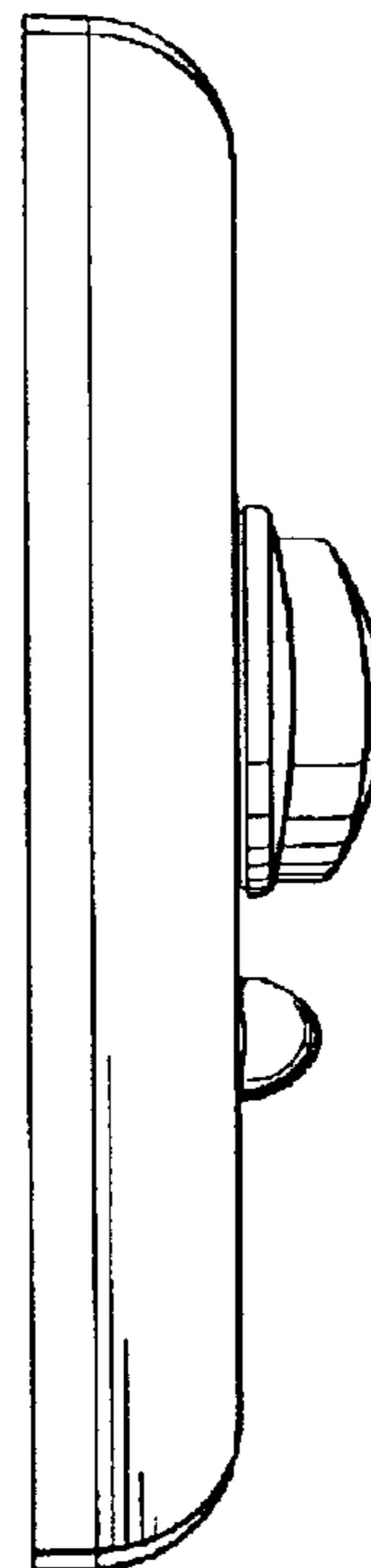

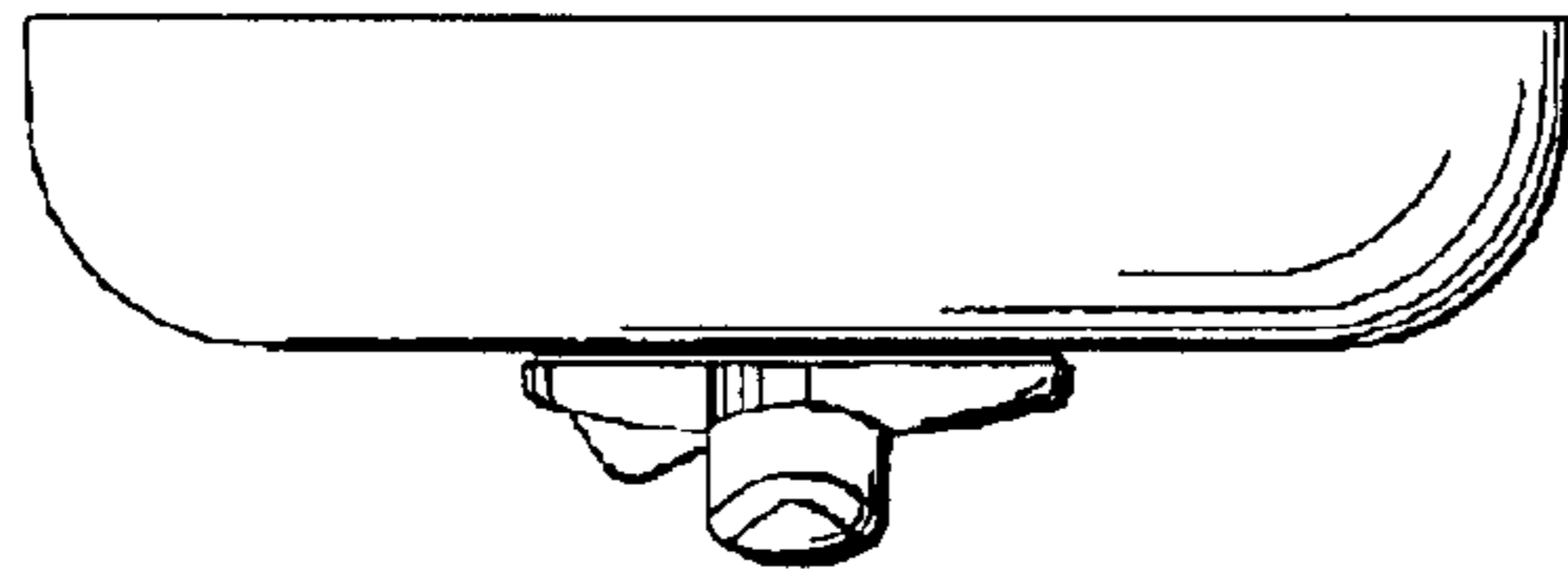

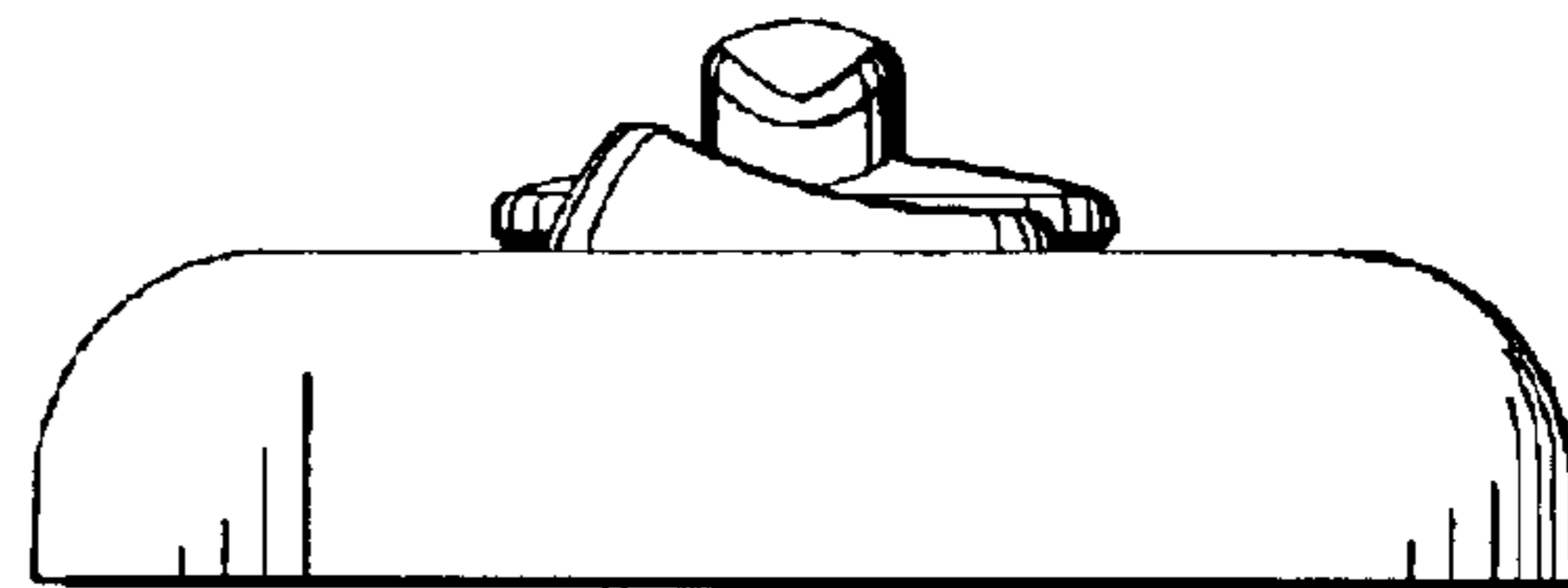

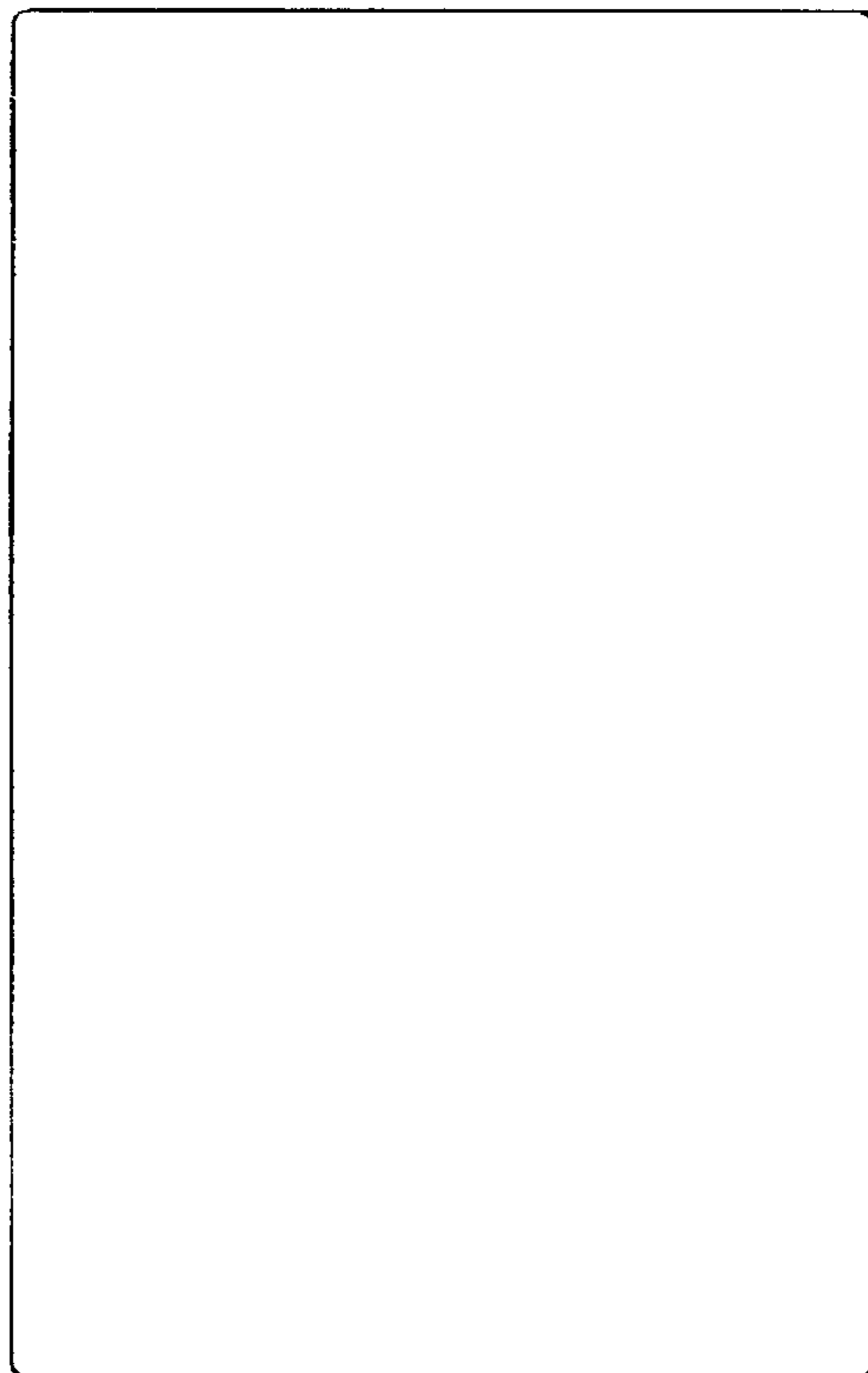

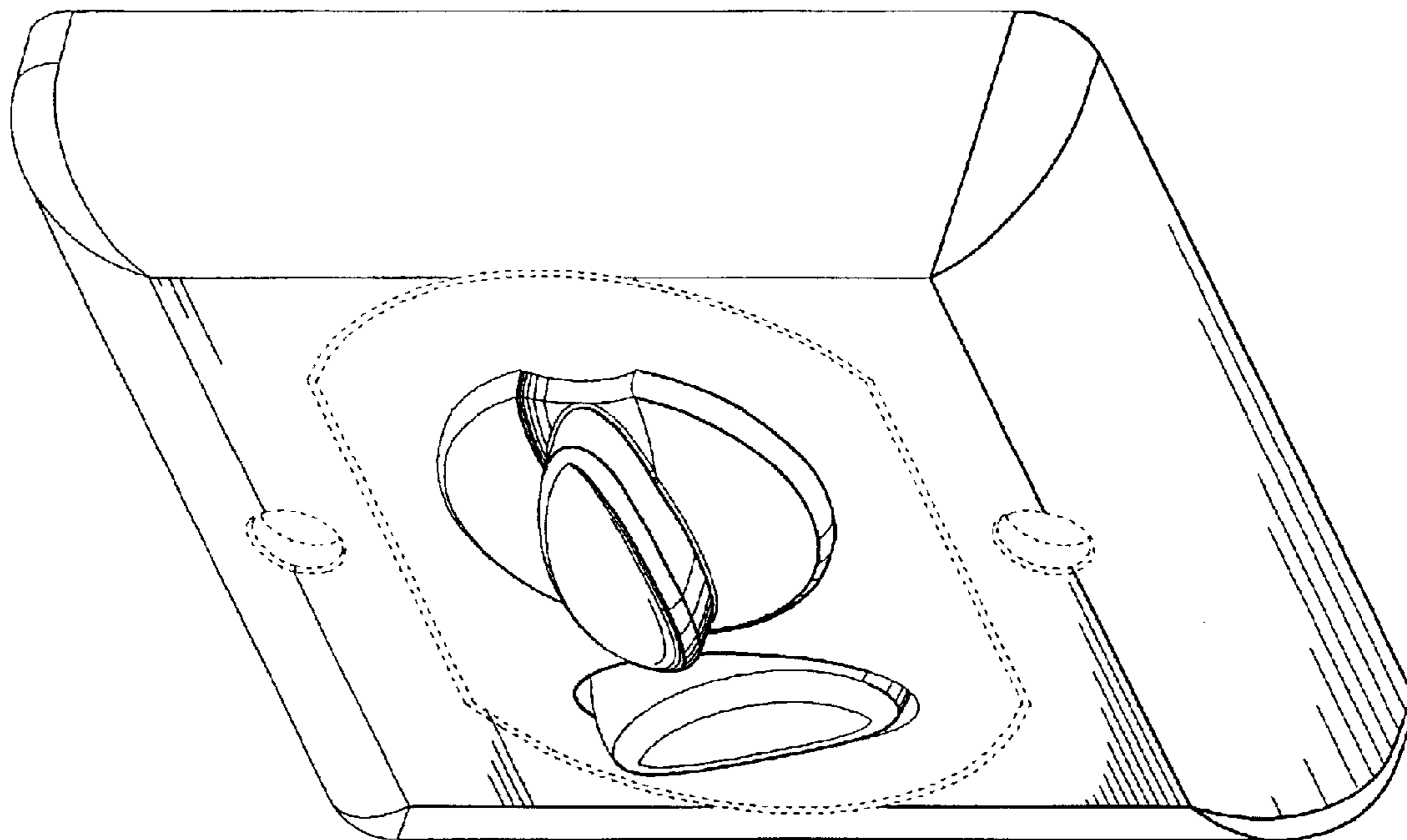

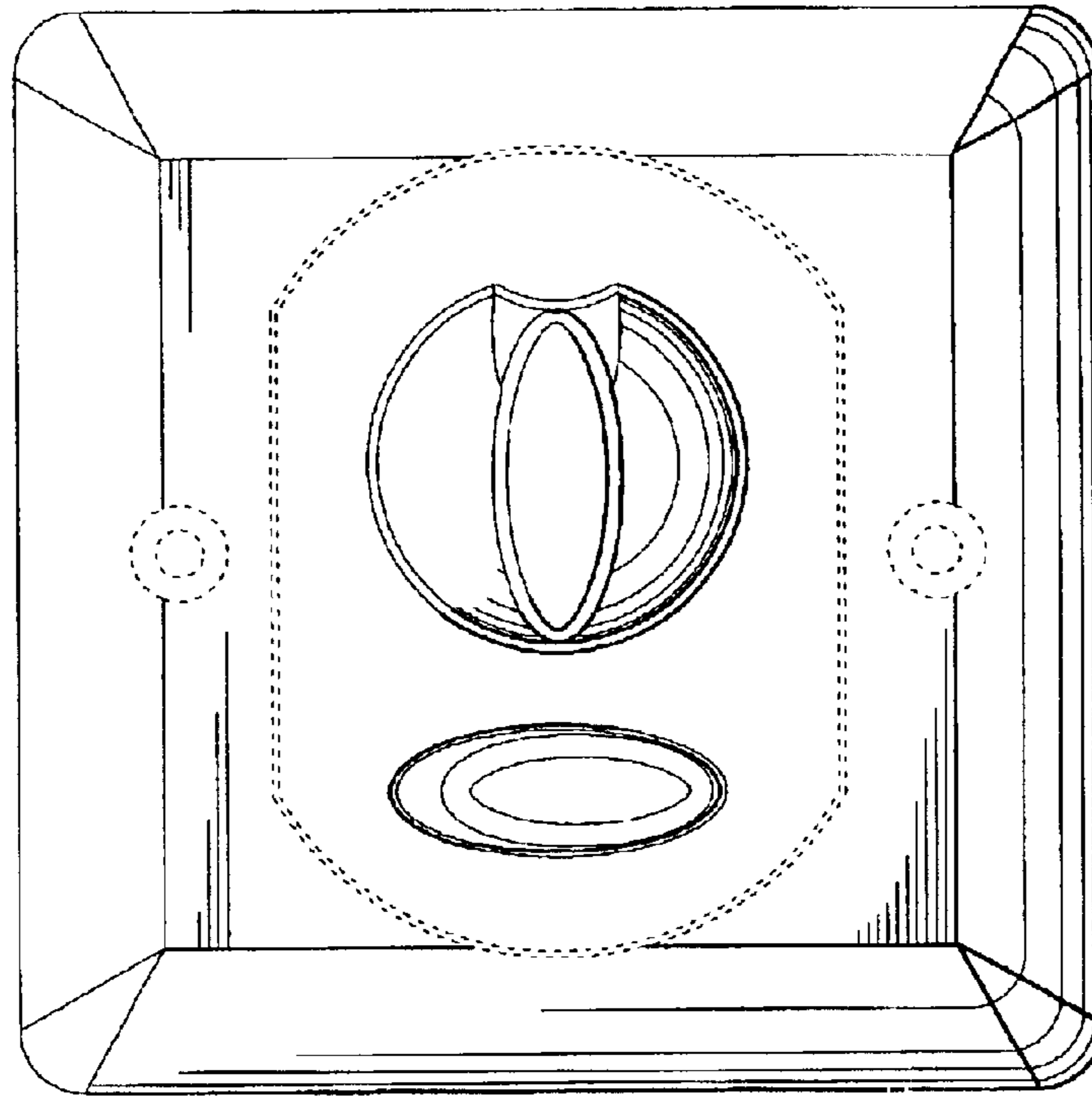

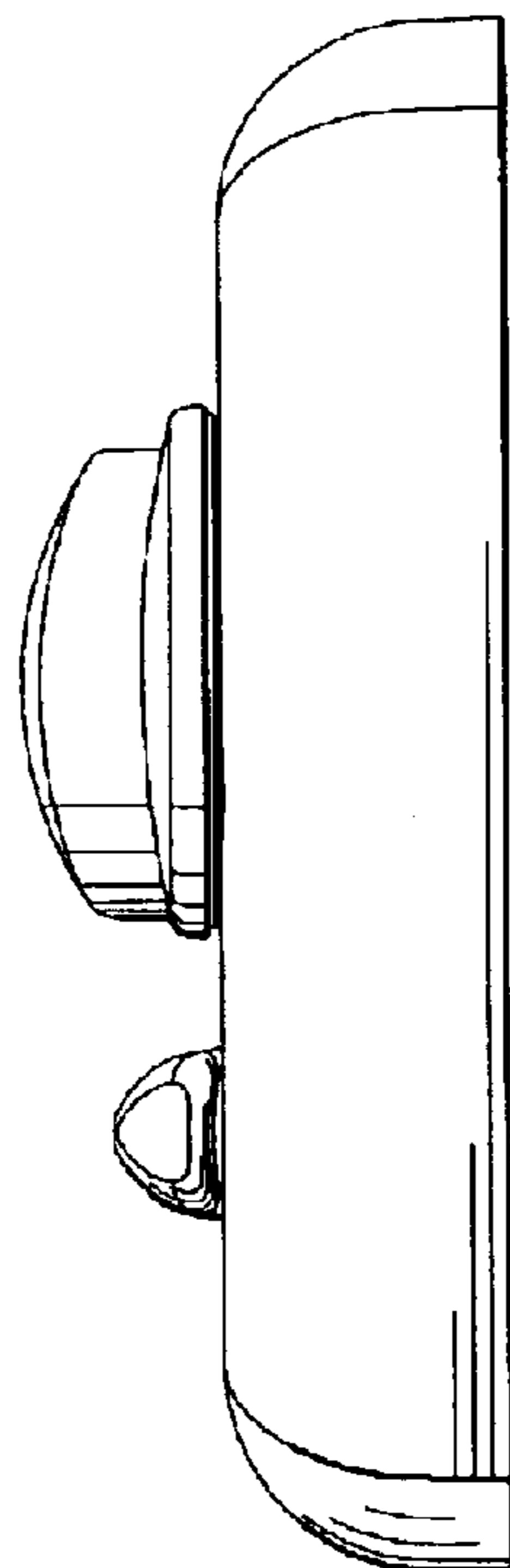

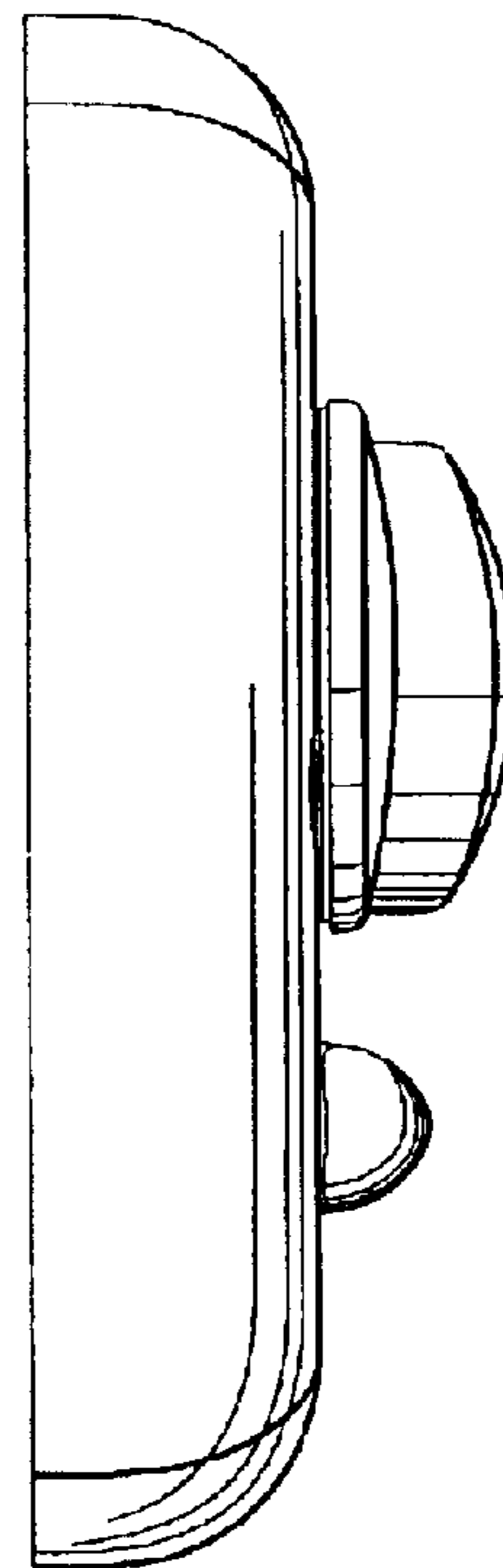

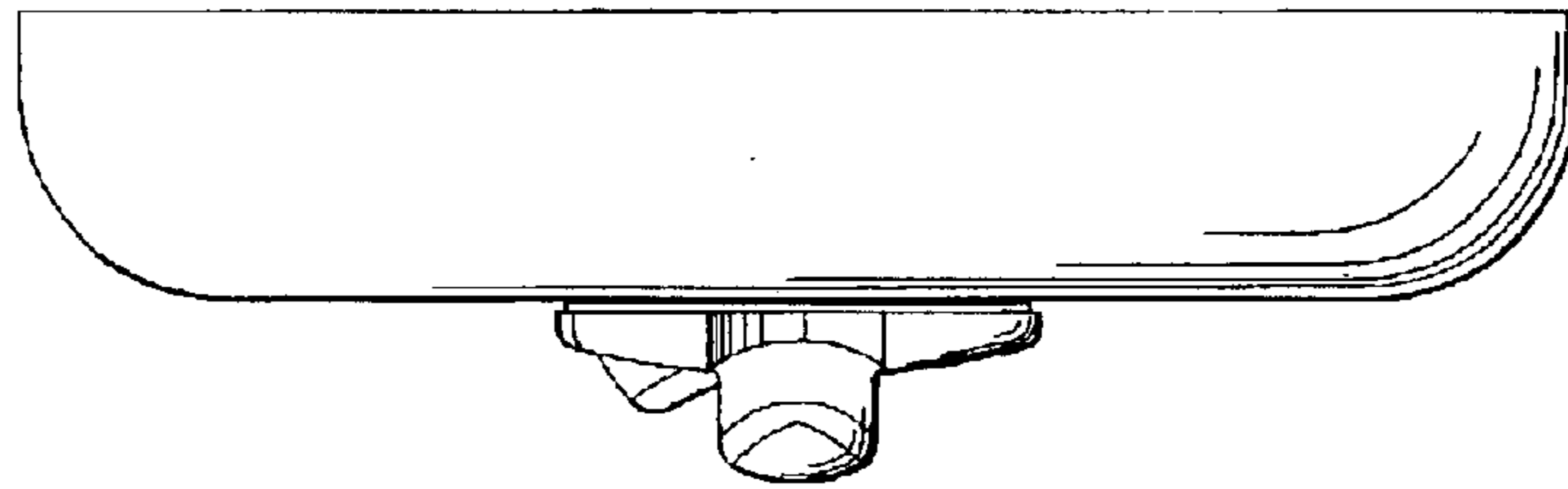

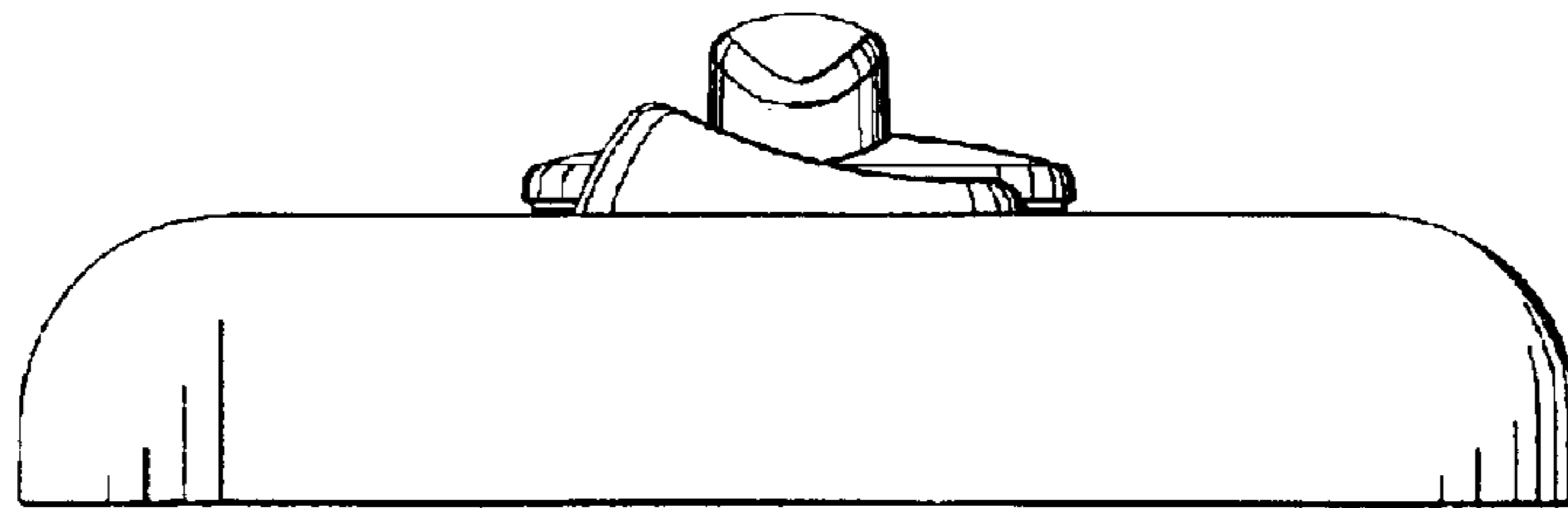
