DESCRIPTION

FIG. 12 is a front view of the boiler unit and handle portion with handle on;

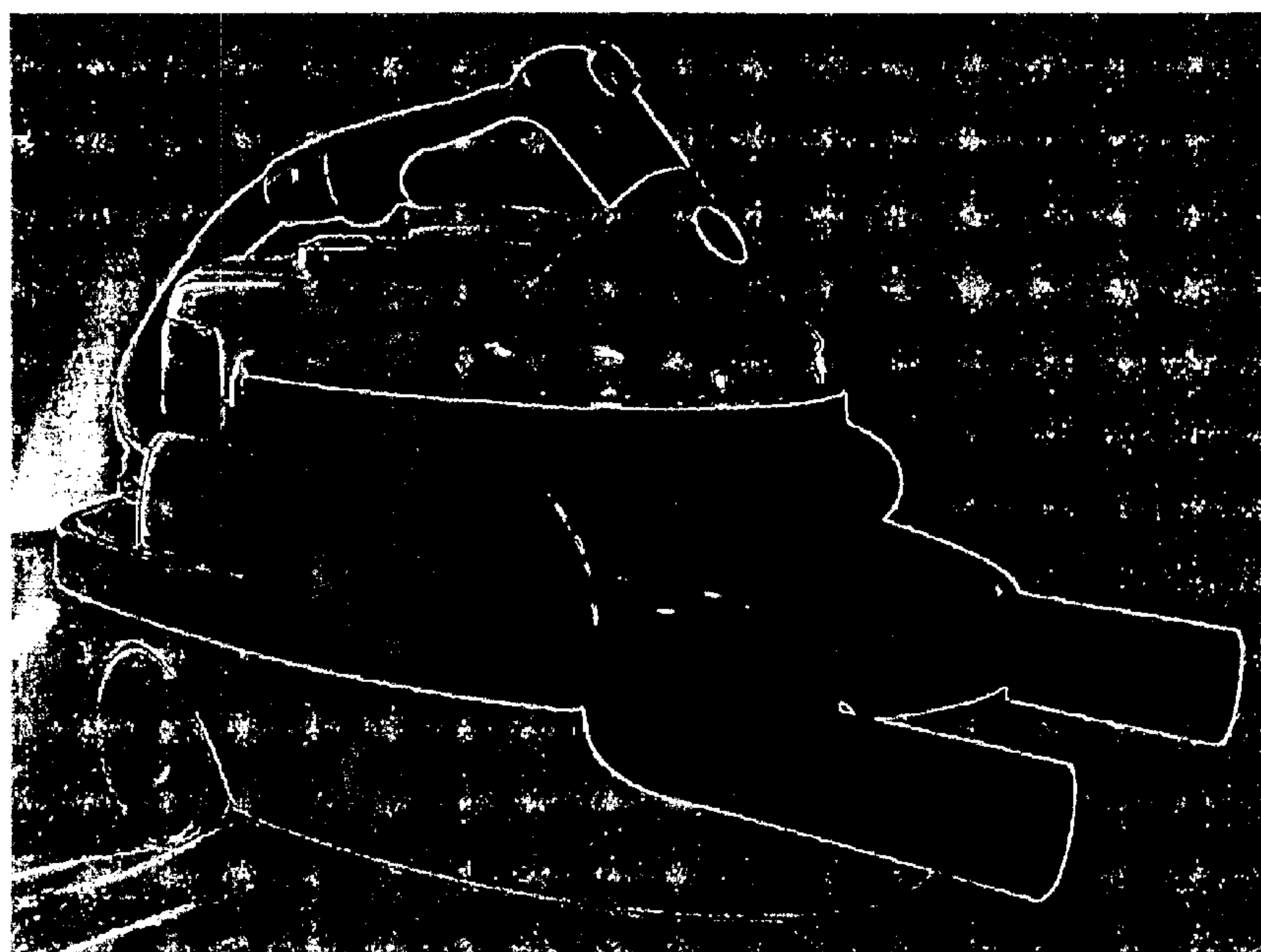
FIG. 13 is a rear view of the boiler unit and handle portion with handle removed;

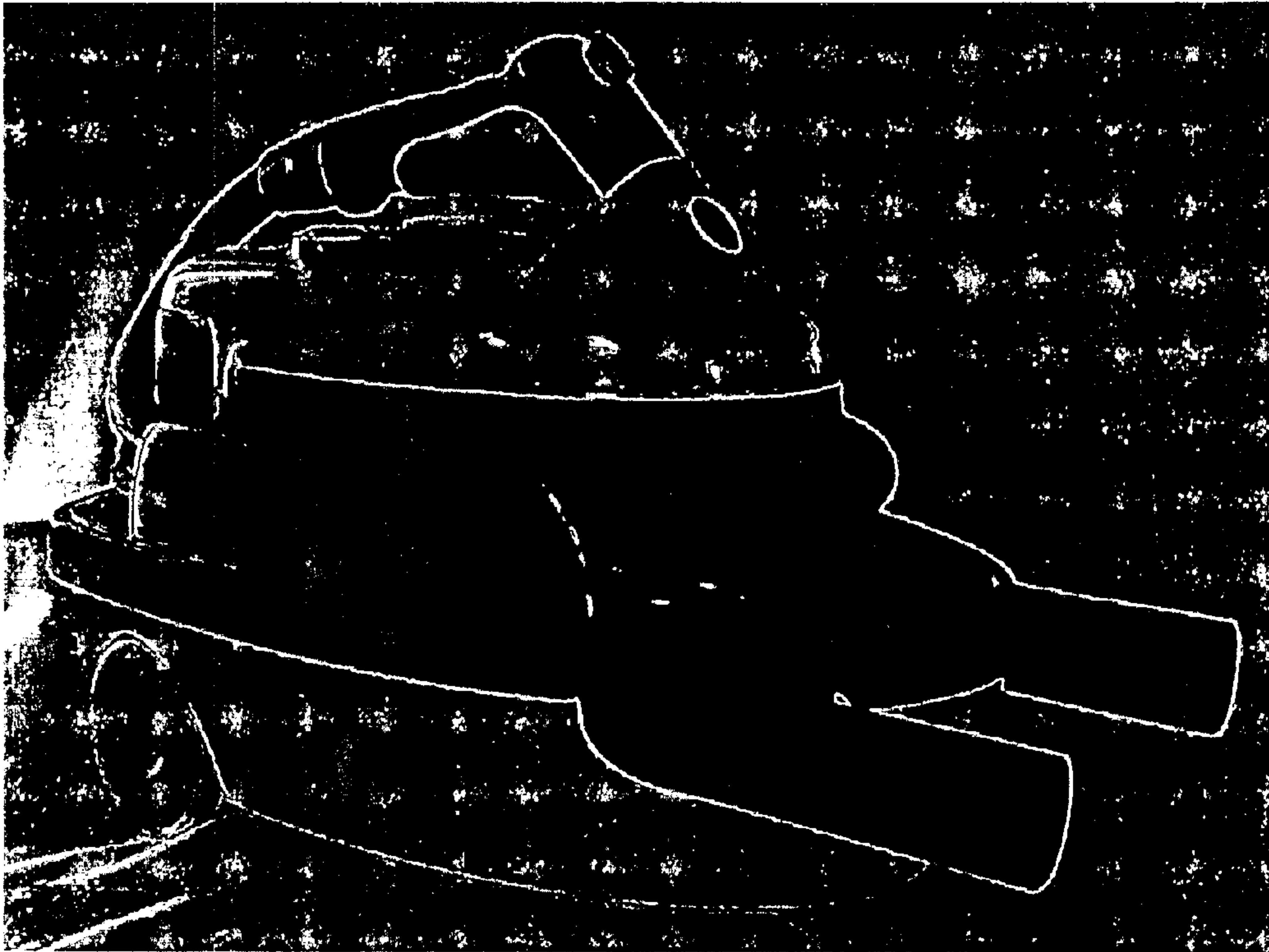

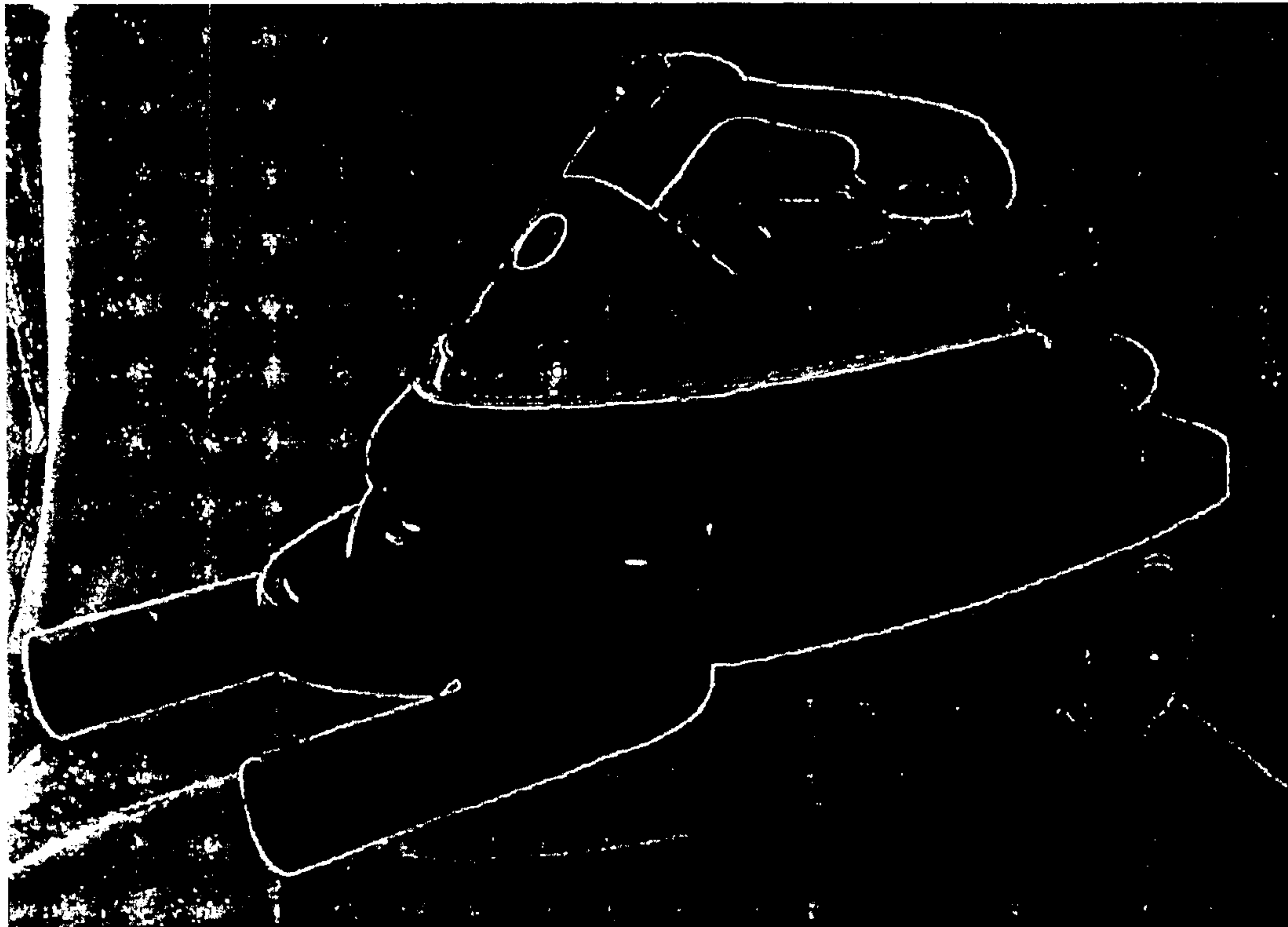

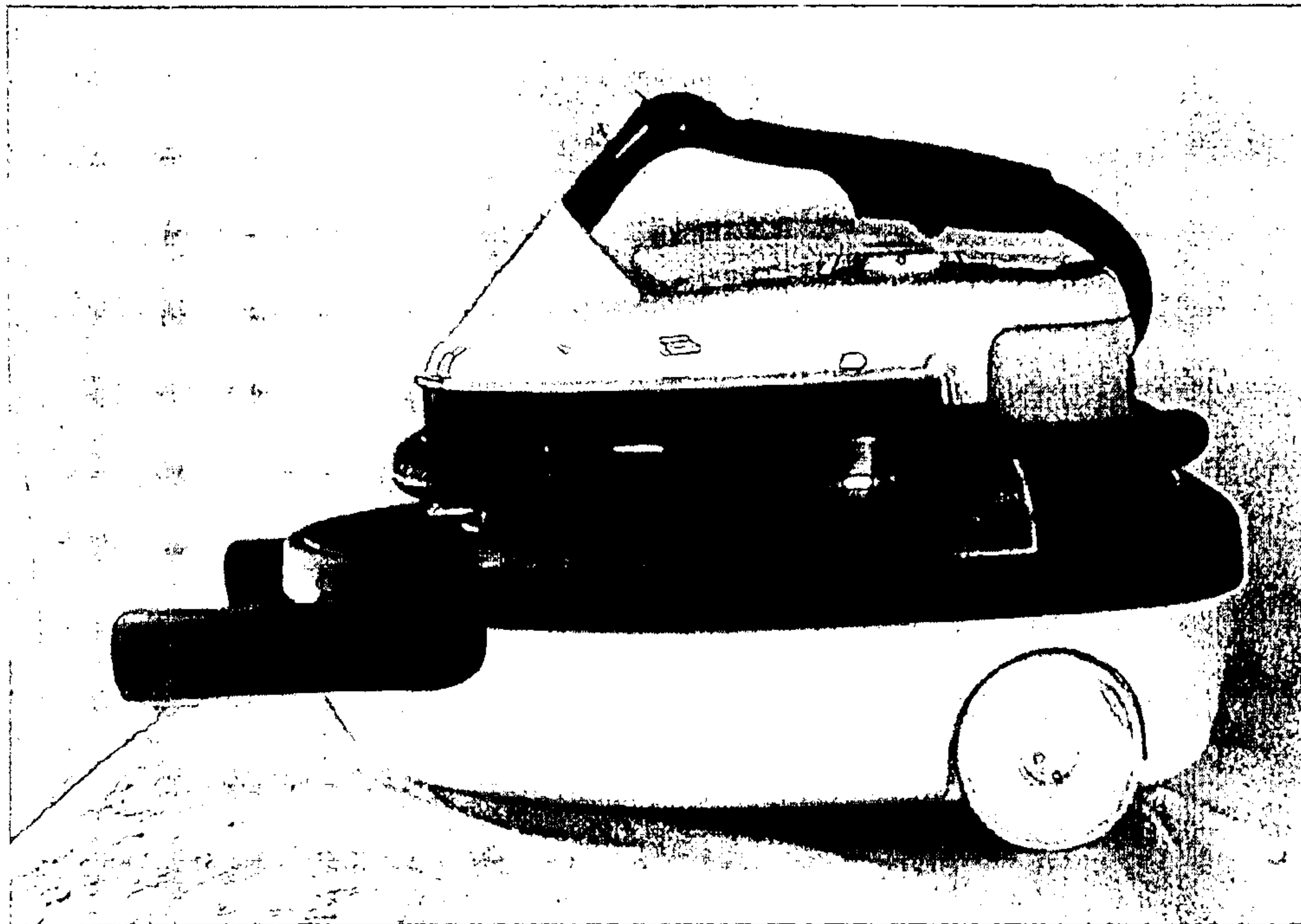

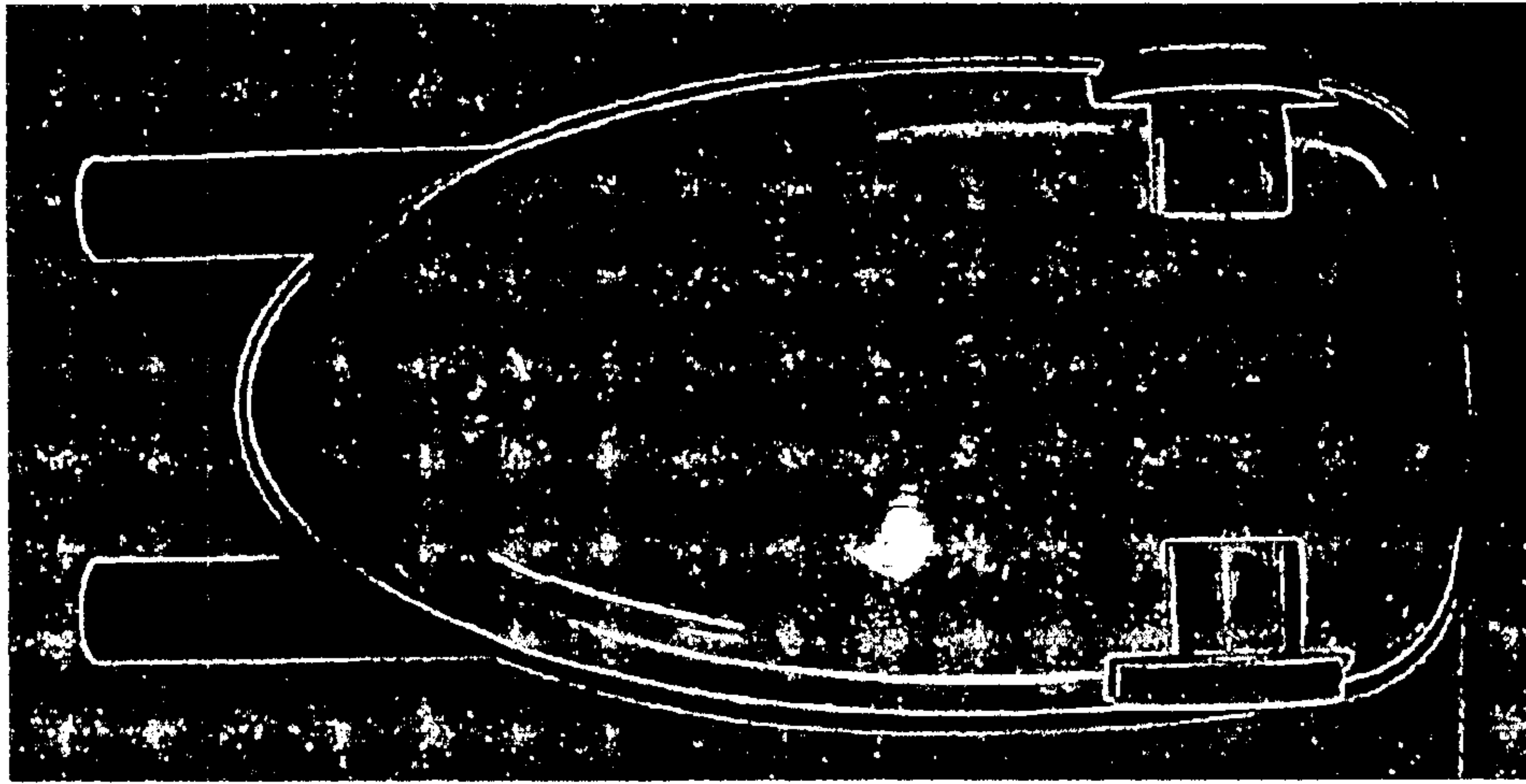

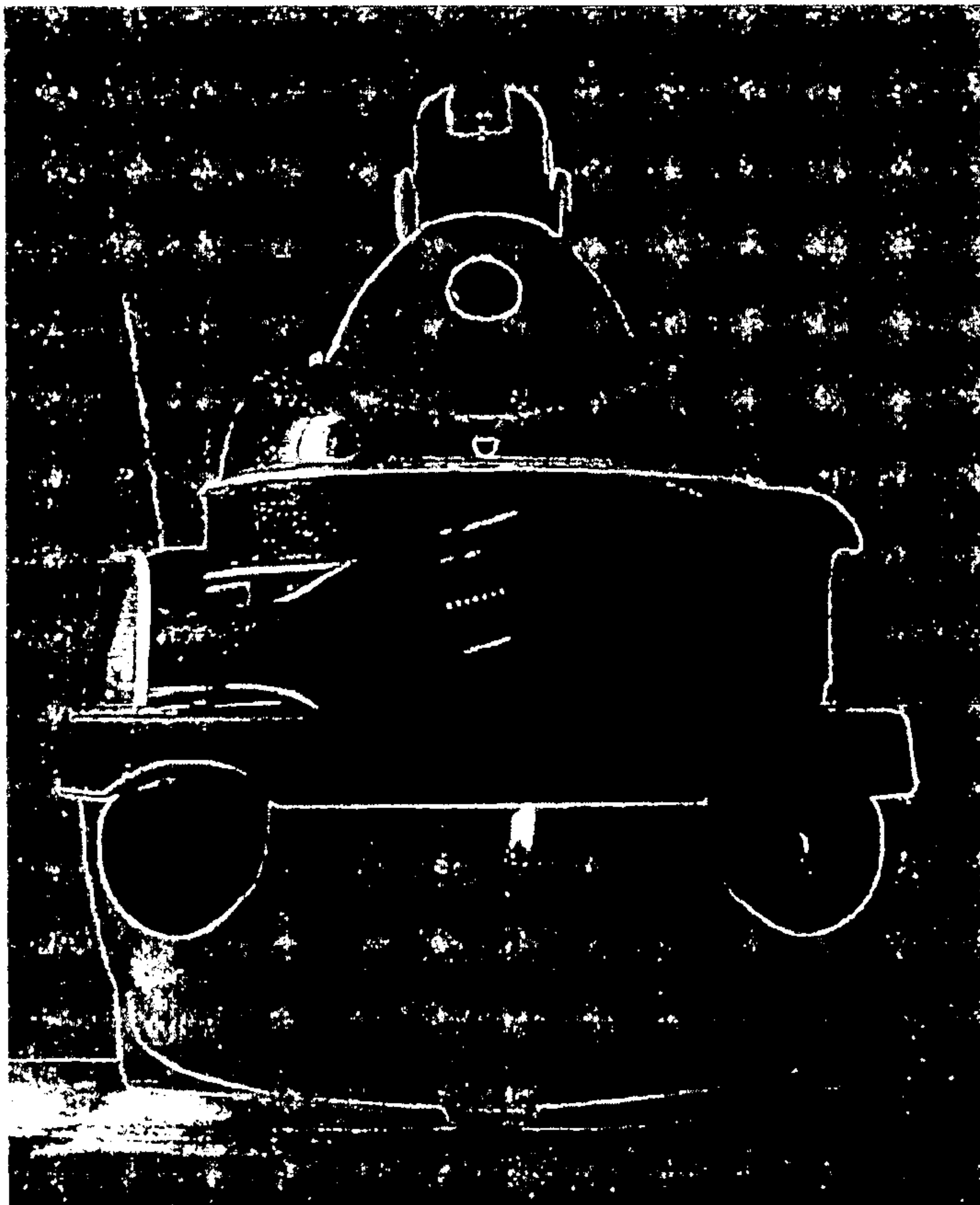

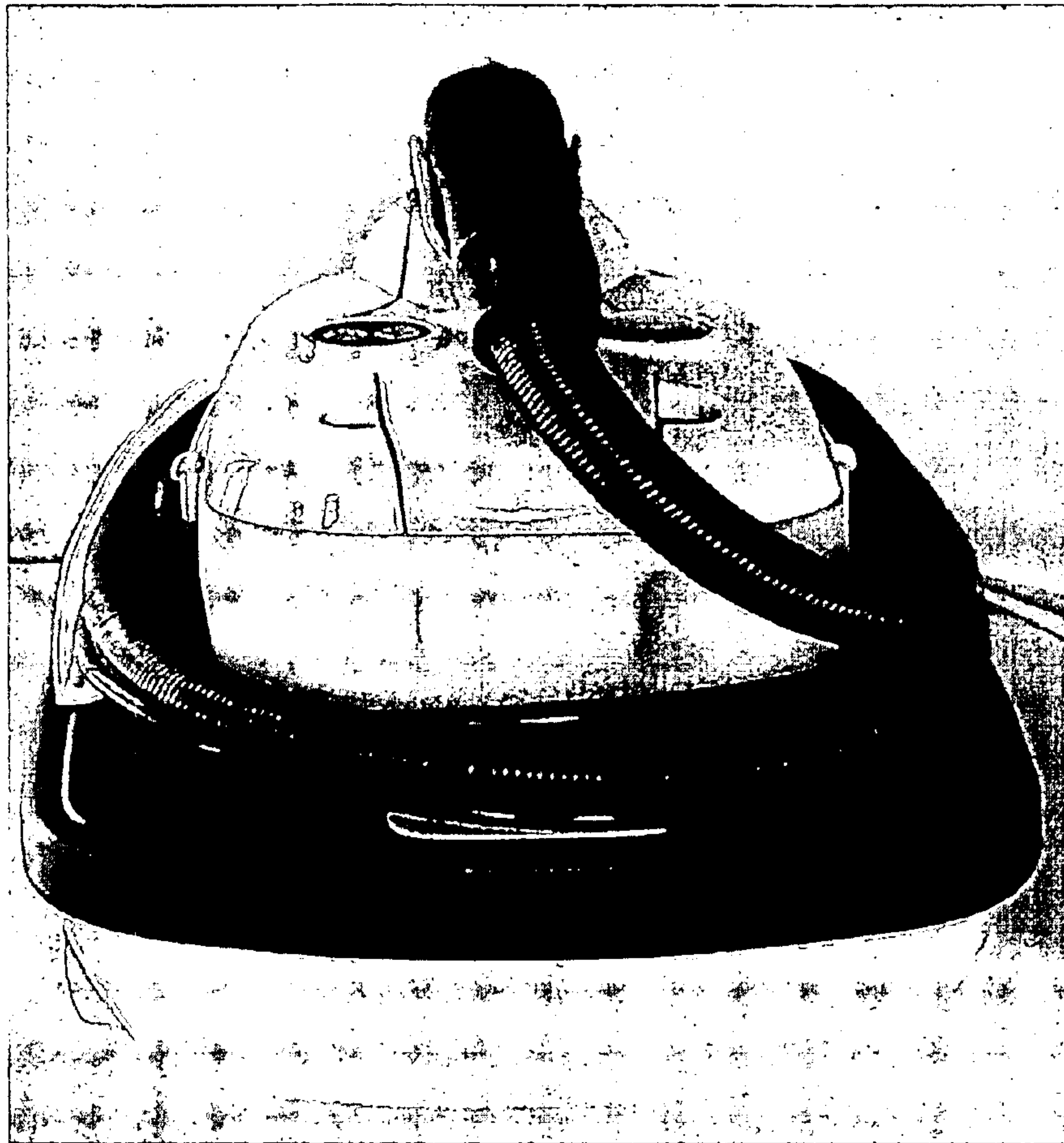

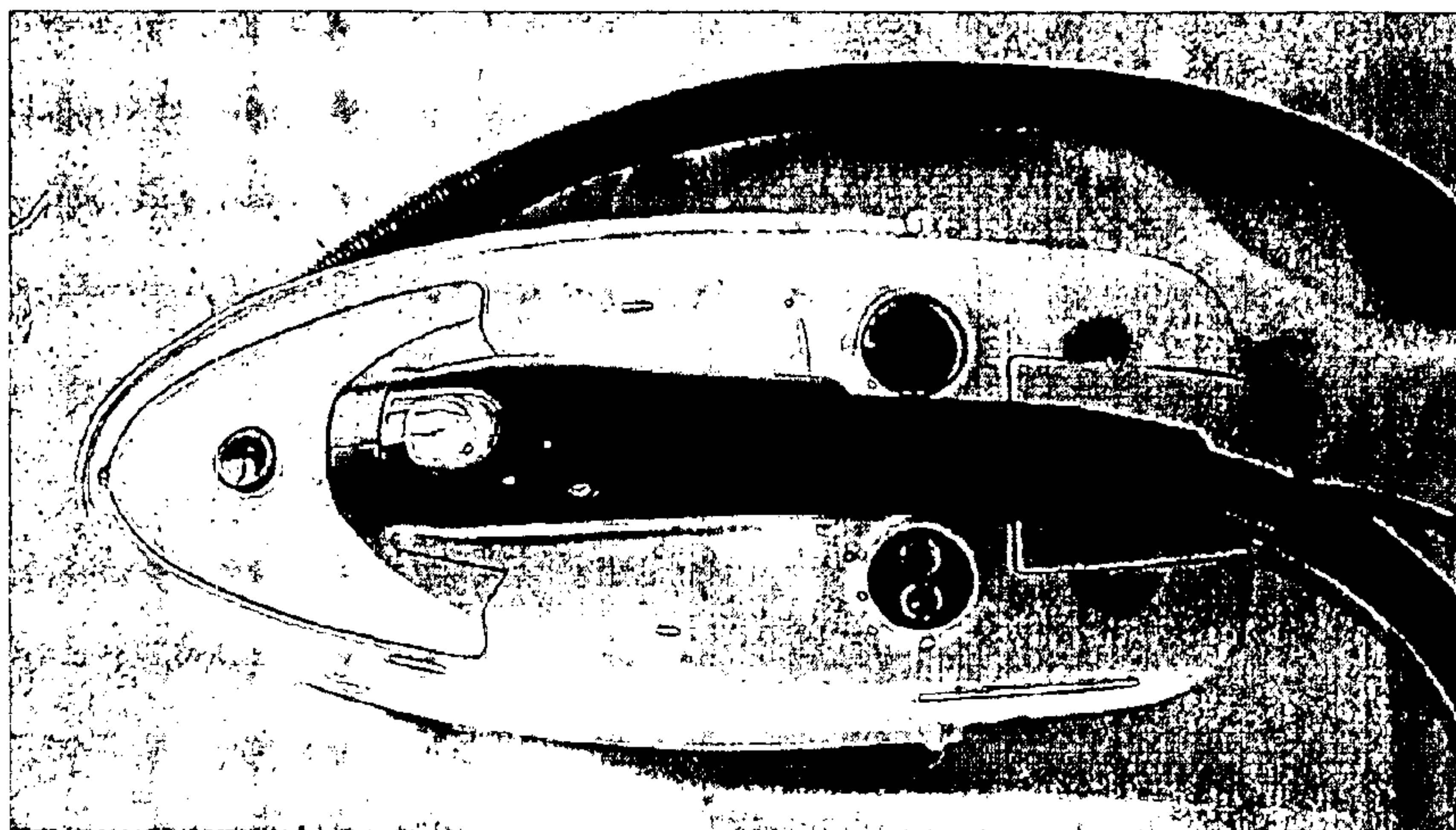

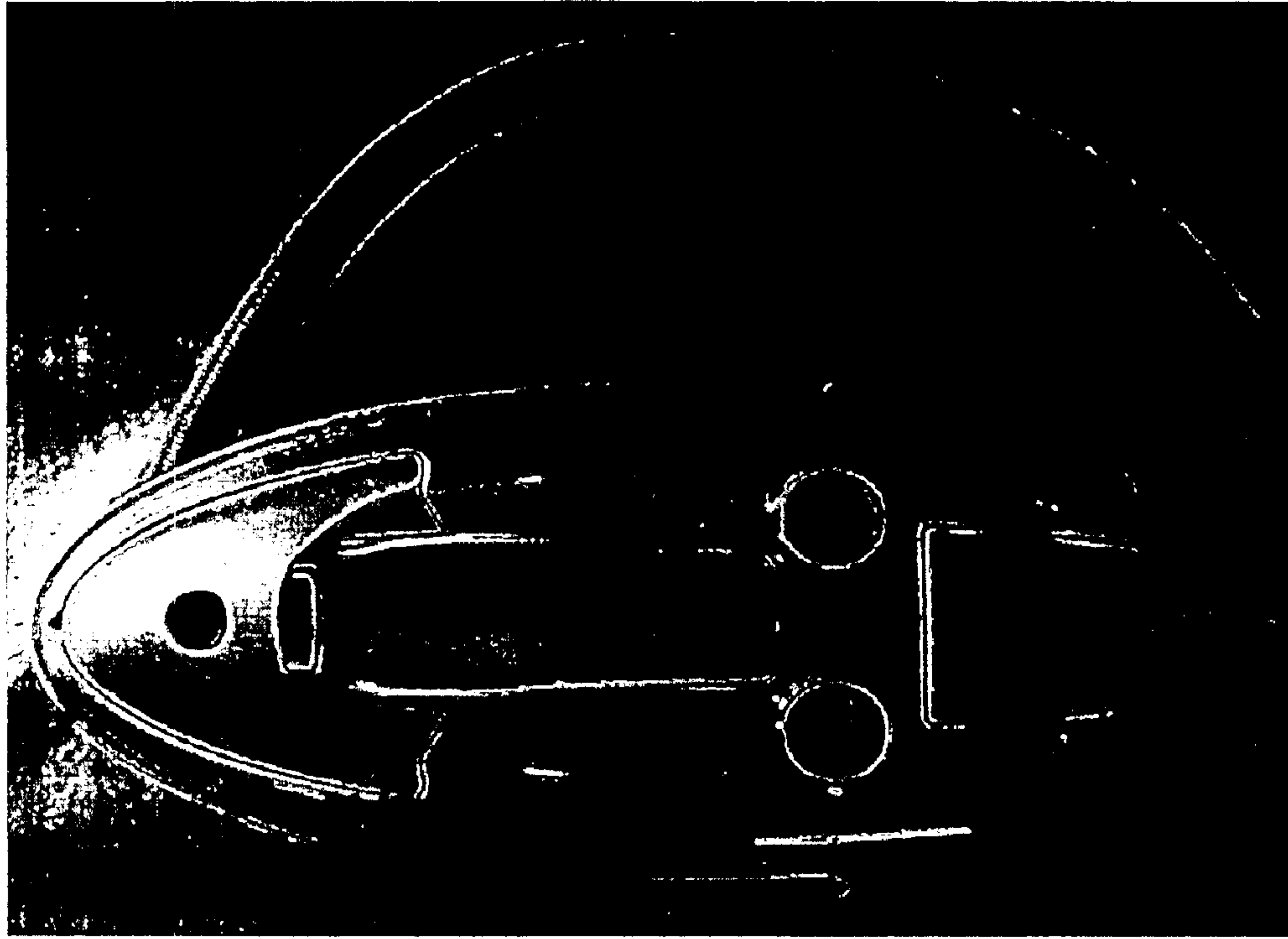

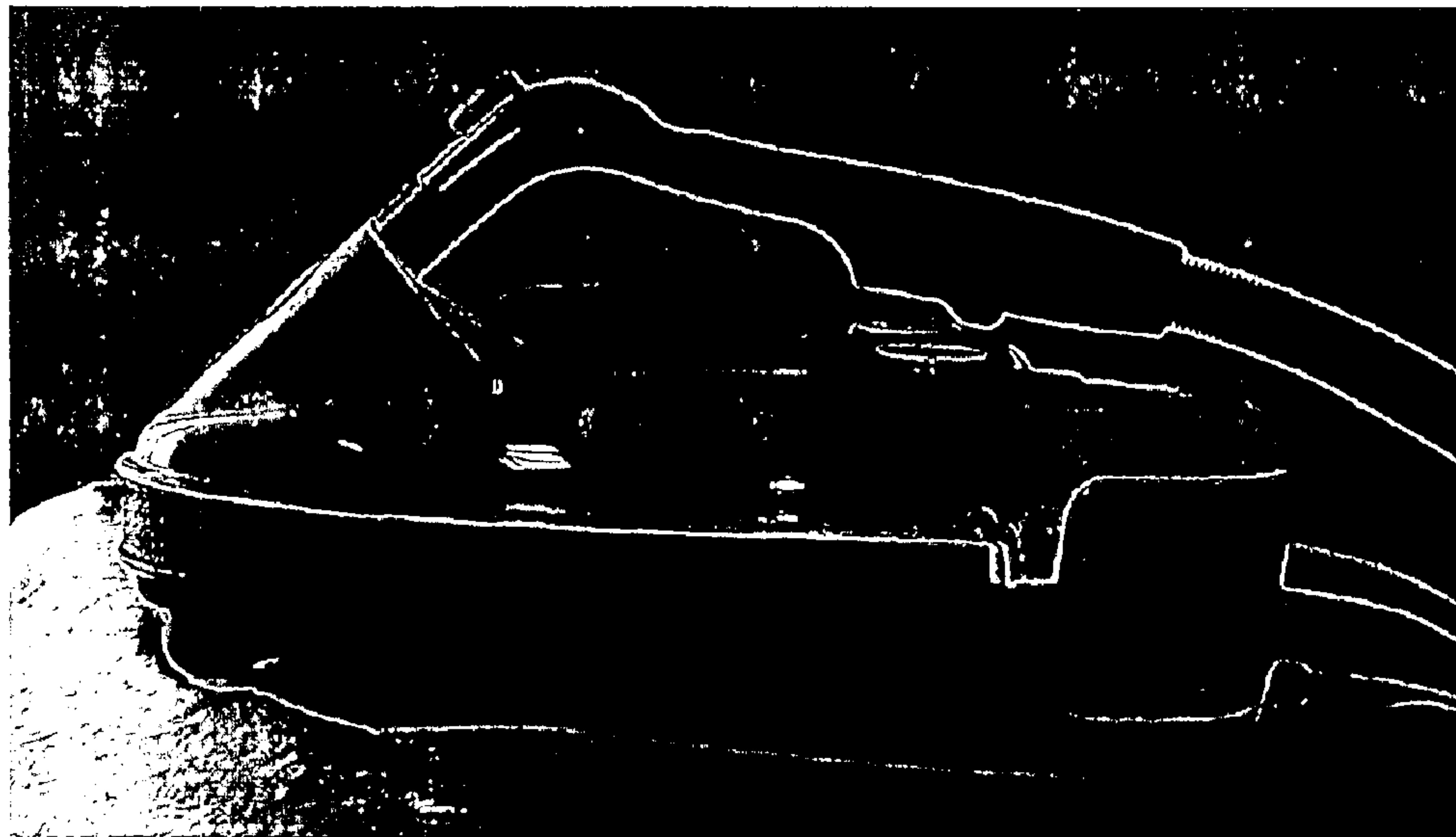

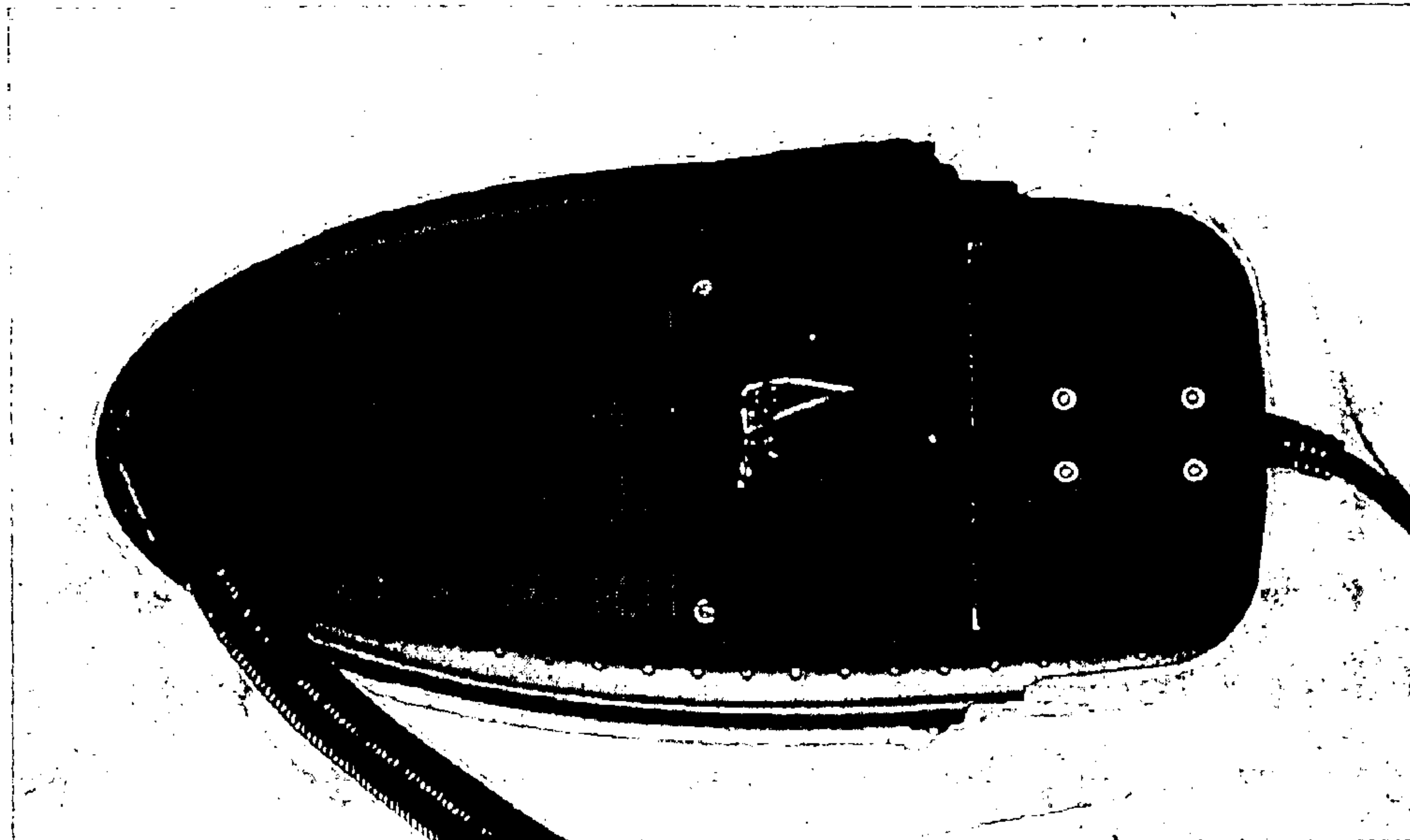

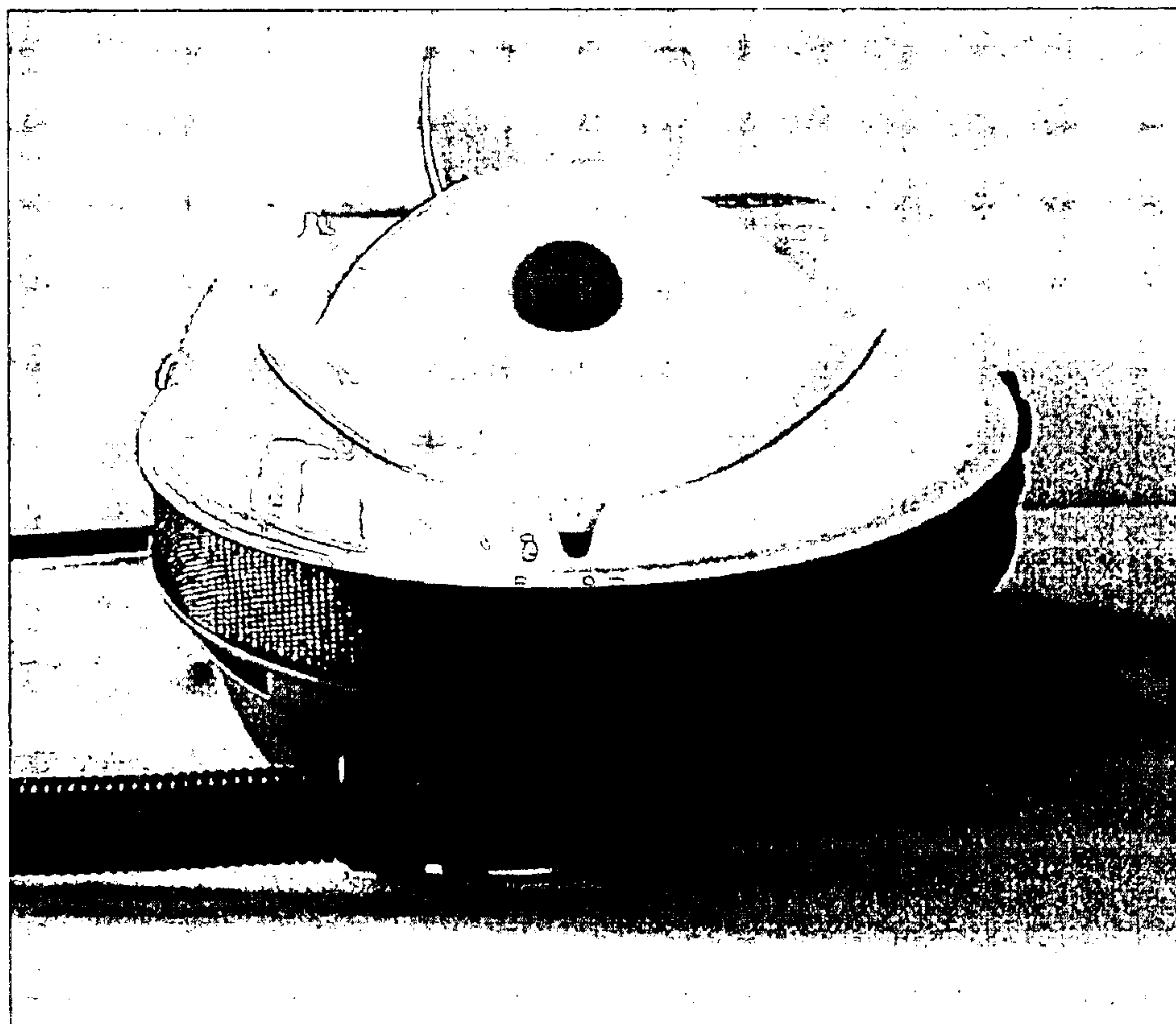

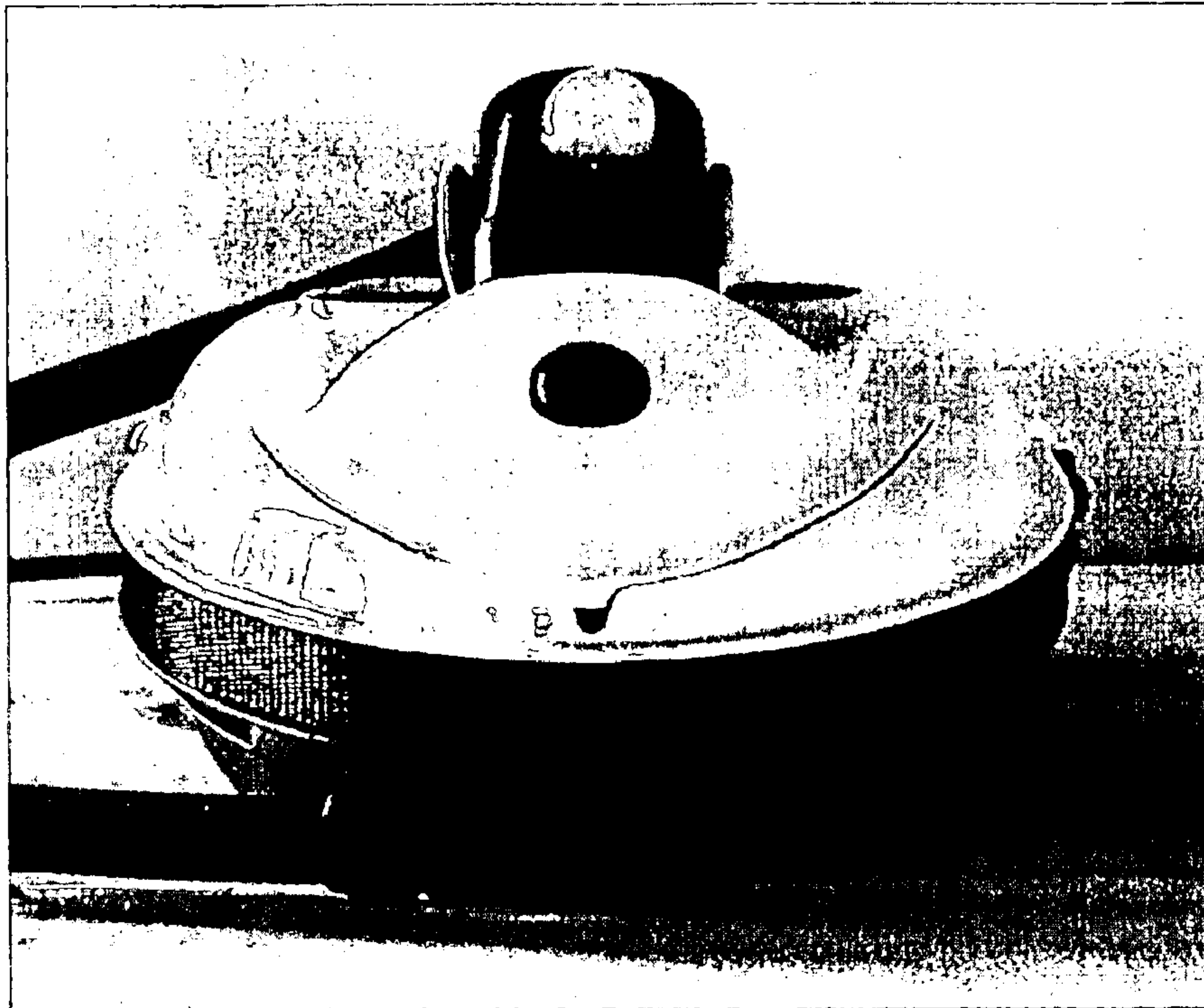

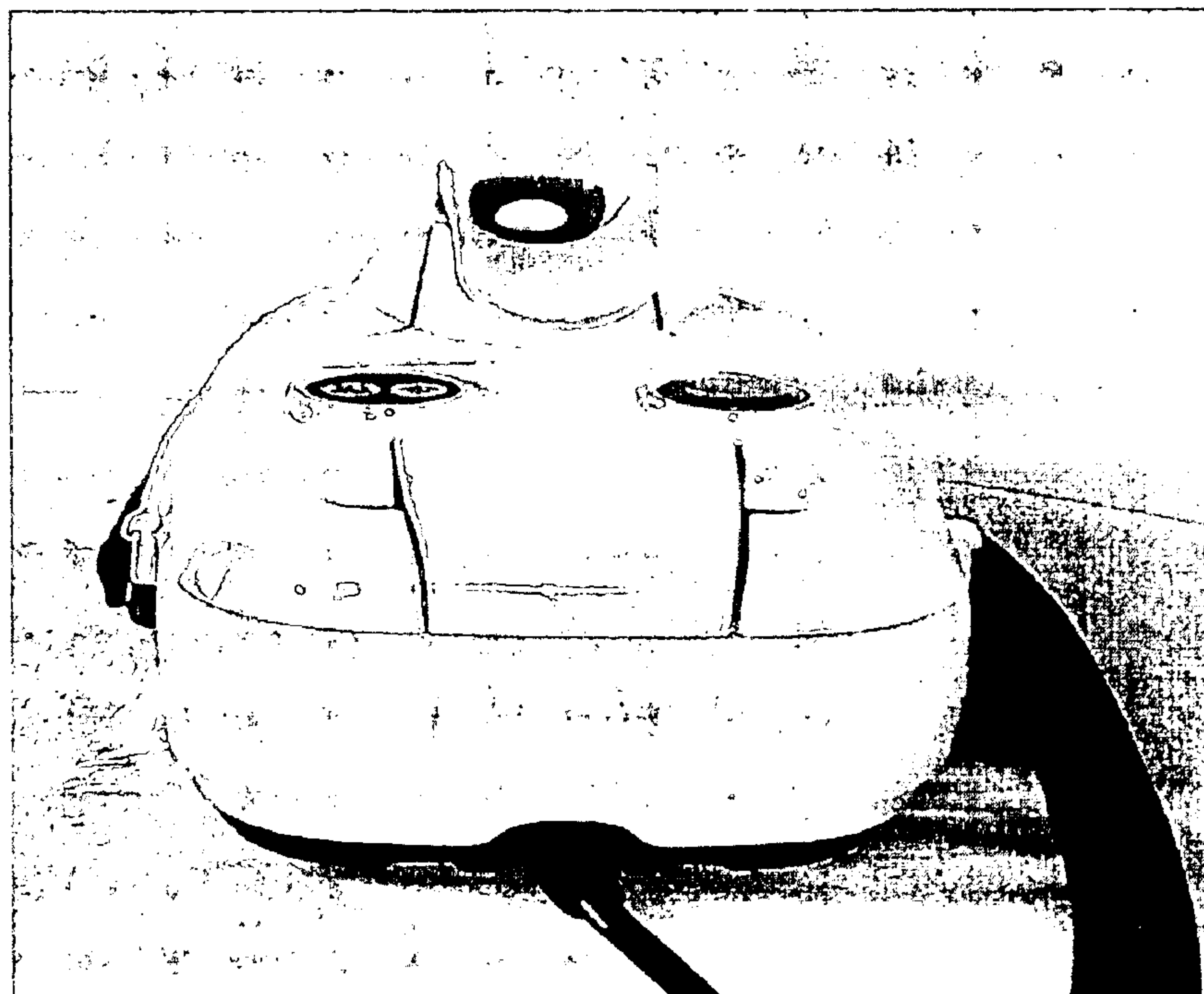

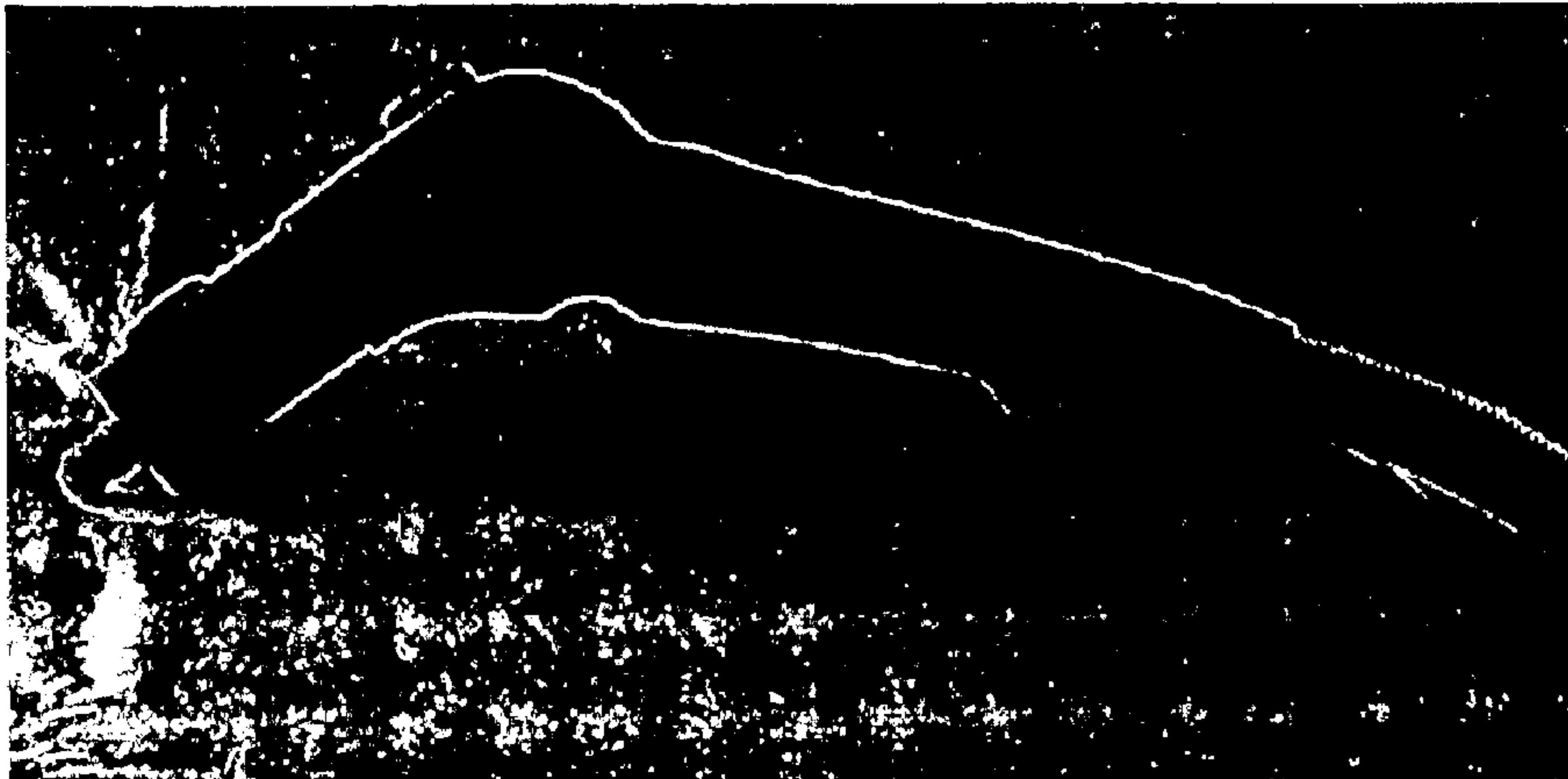

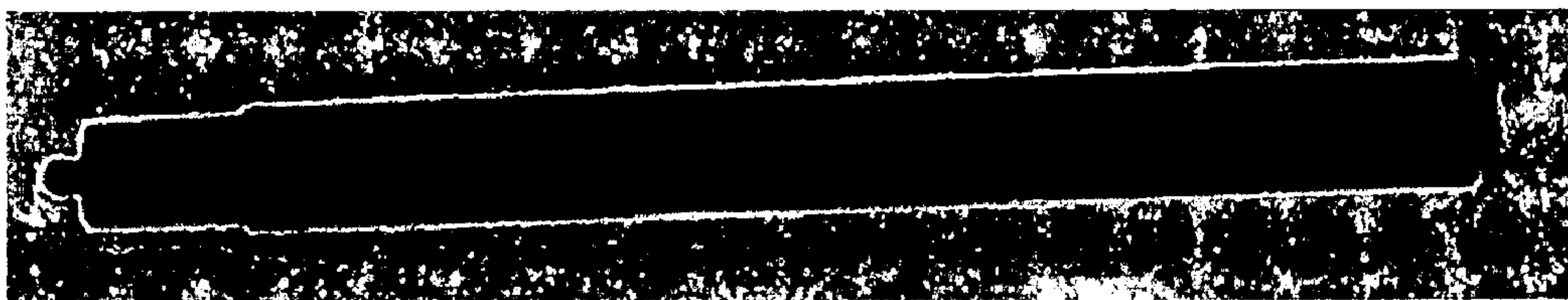
