FIG. 5 is a perspective view of a second embodiment of the design.

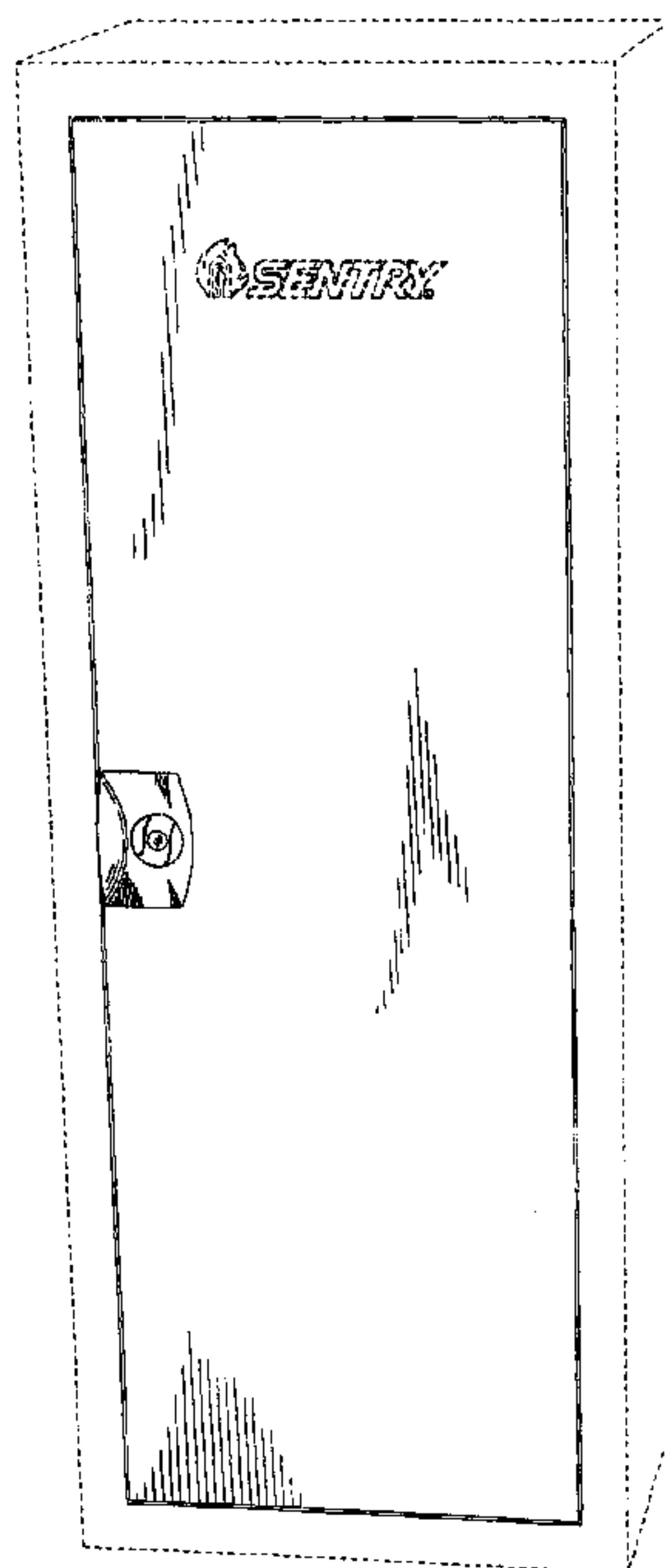
FIG. 6 is a top view of a second embodiment of the design.

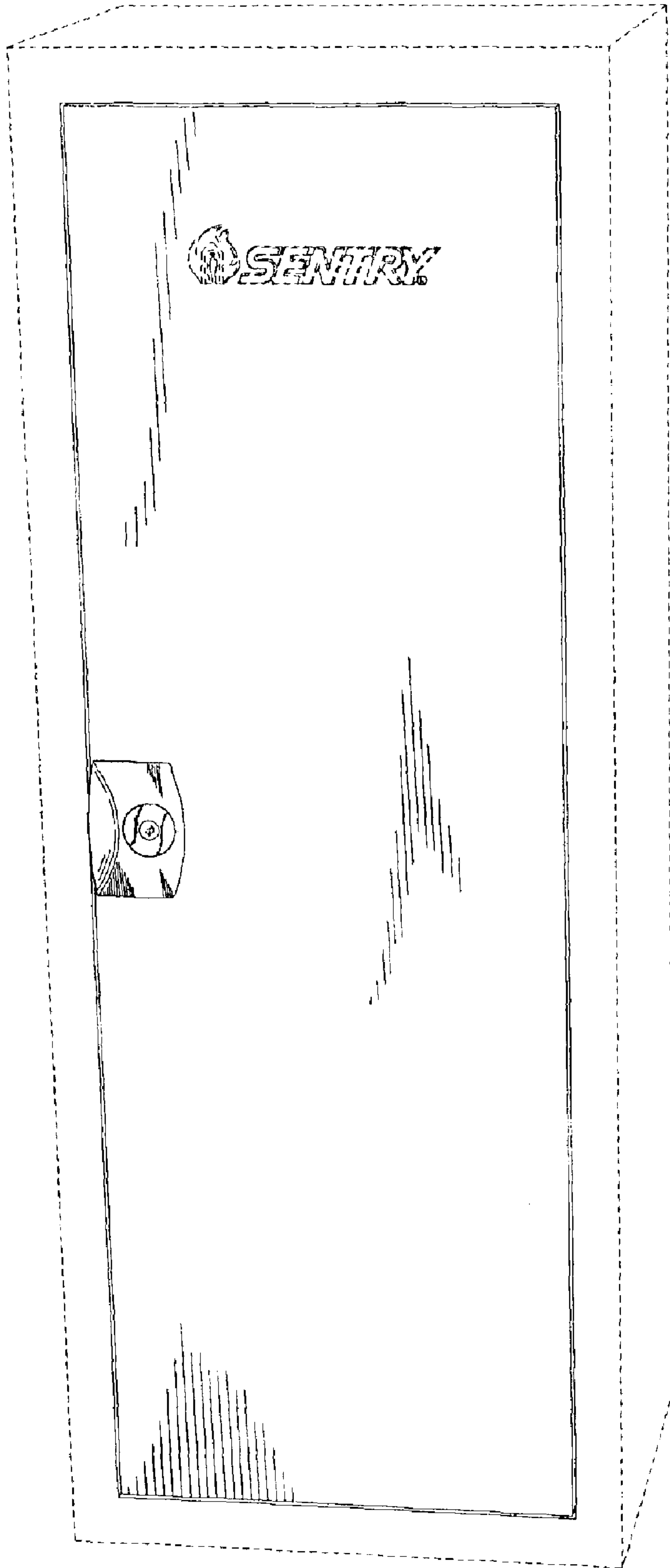

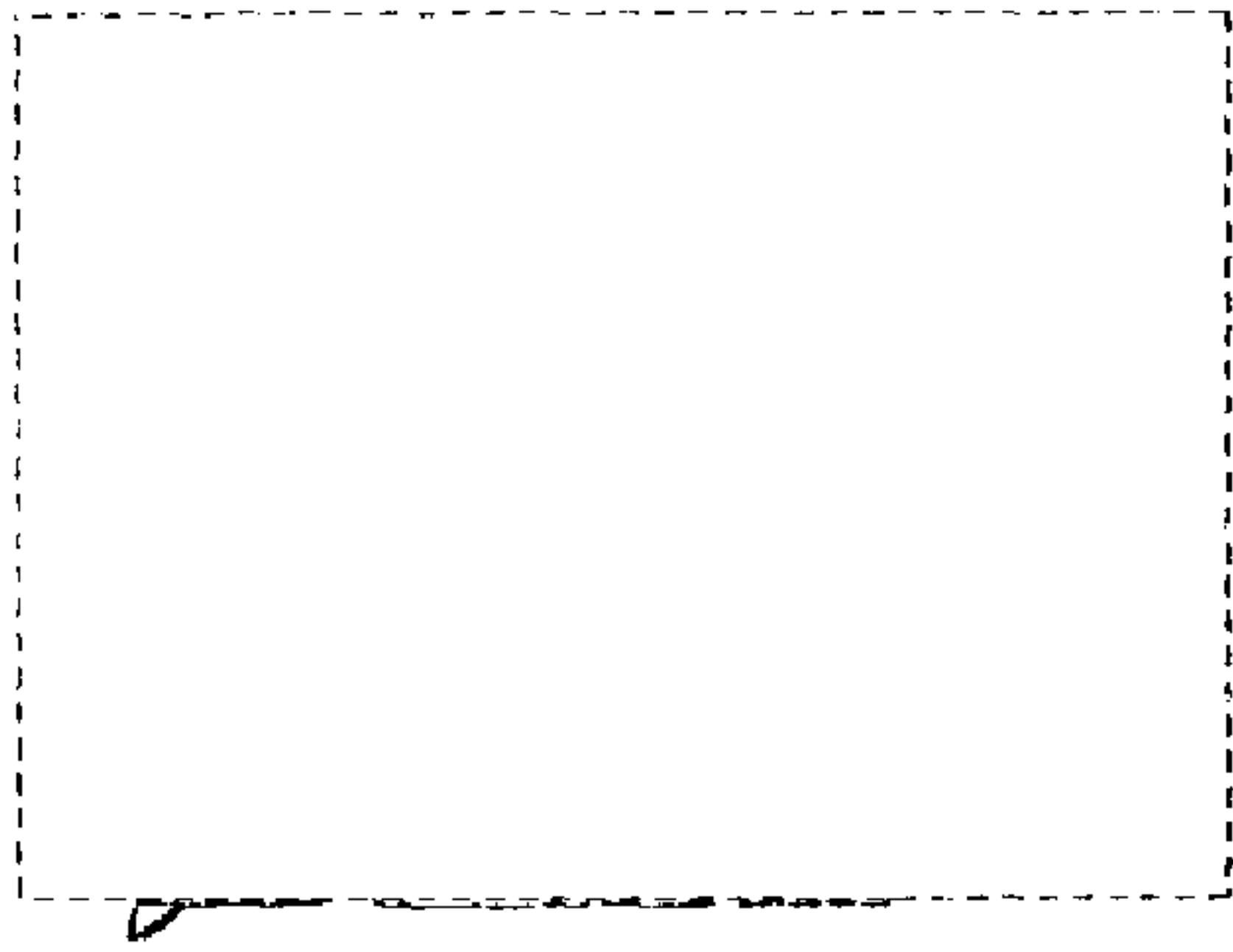

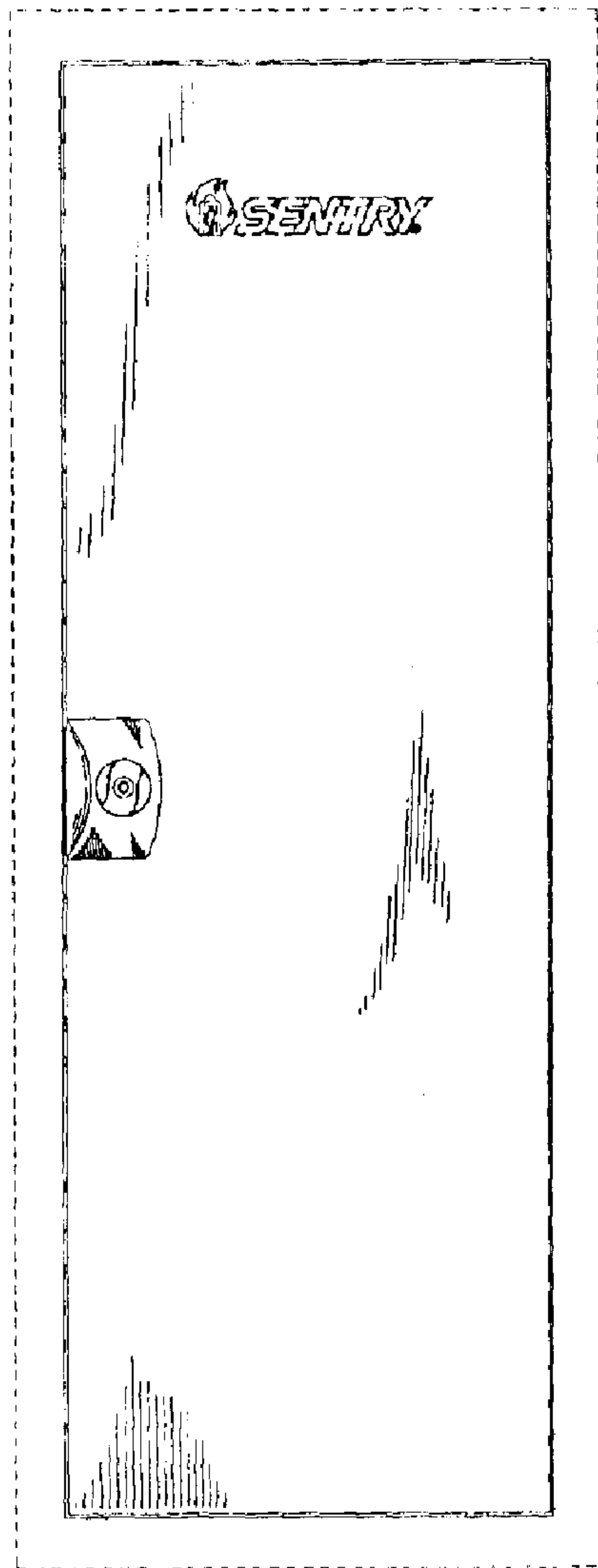

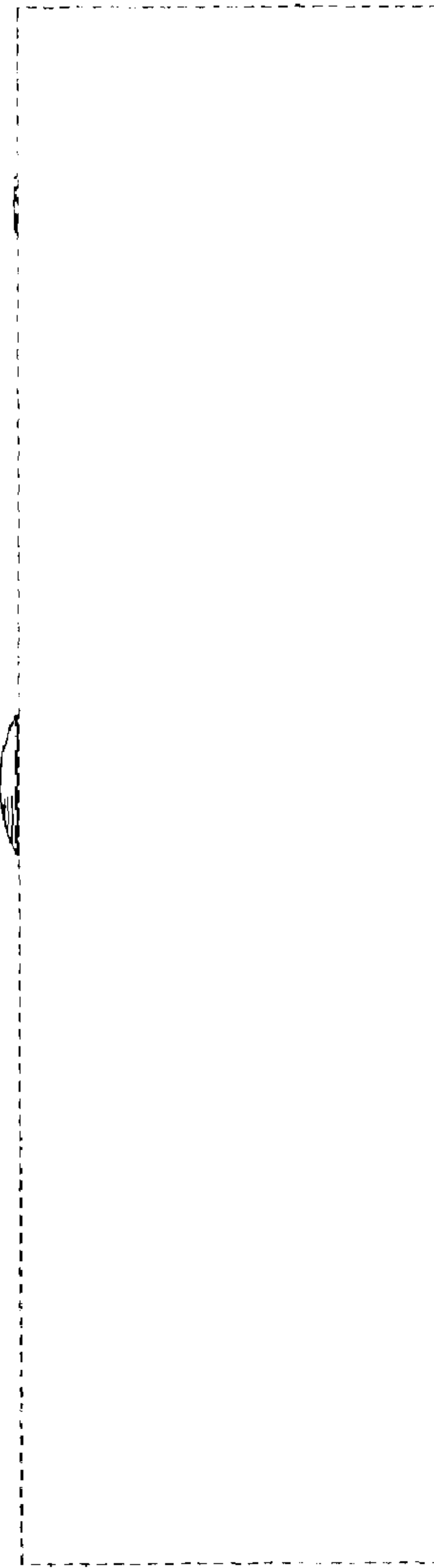

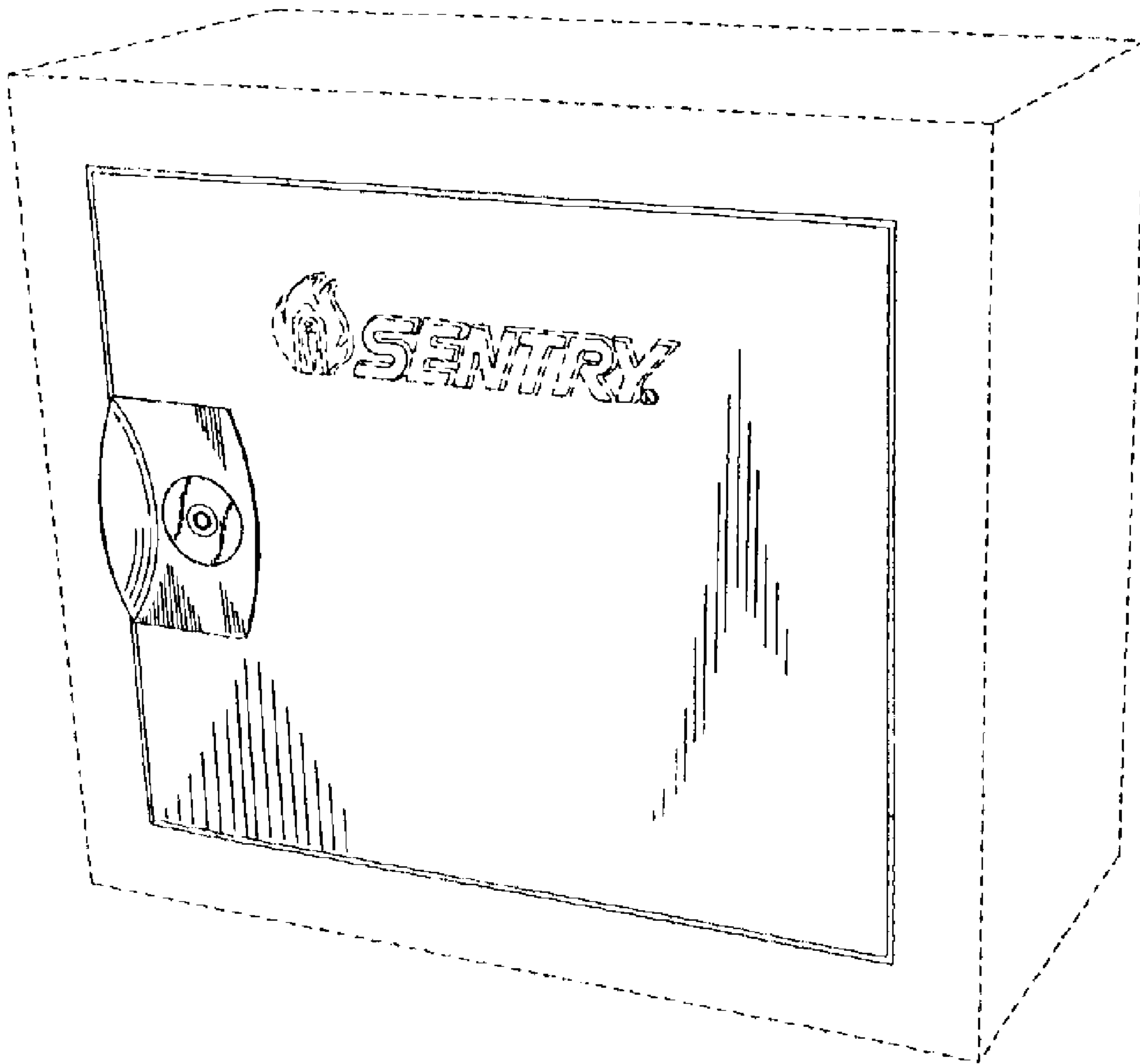

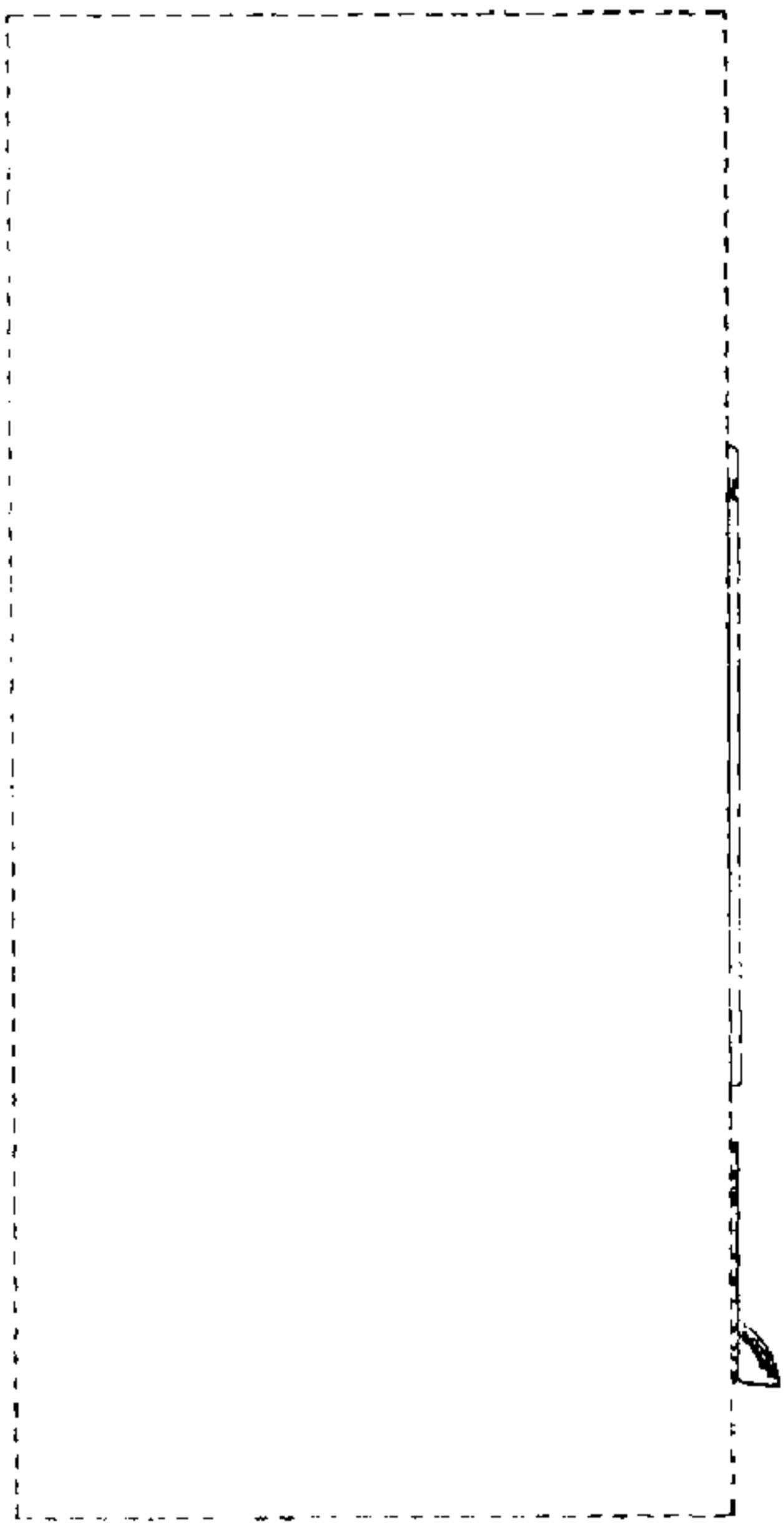

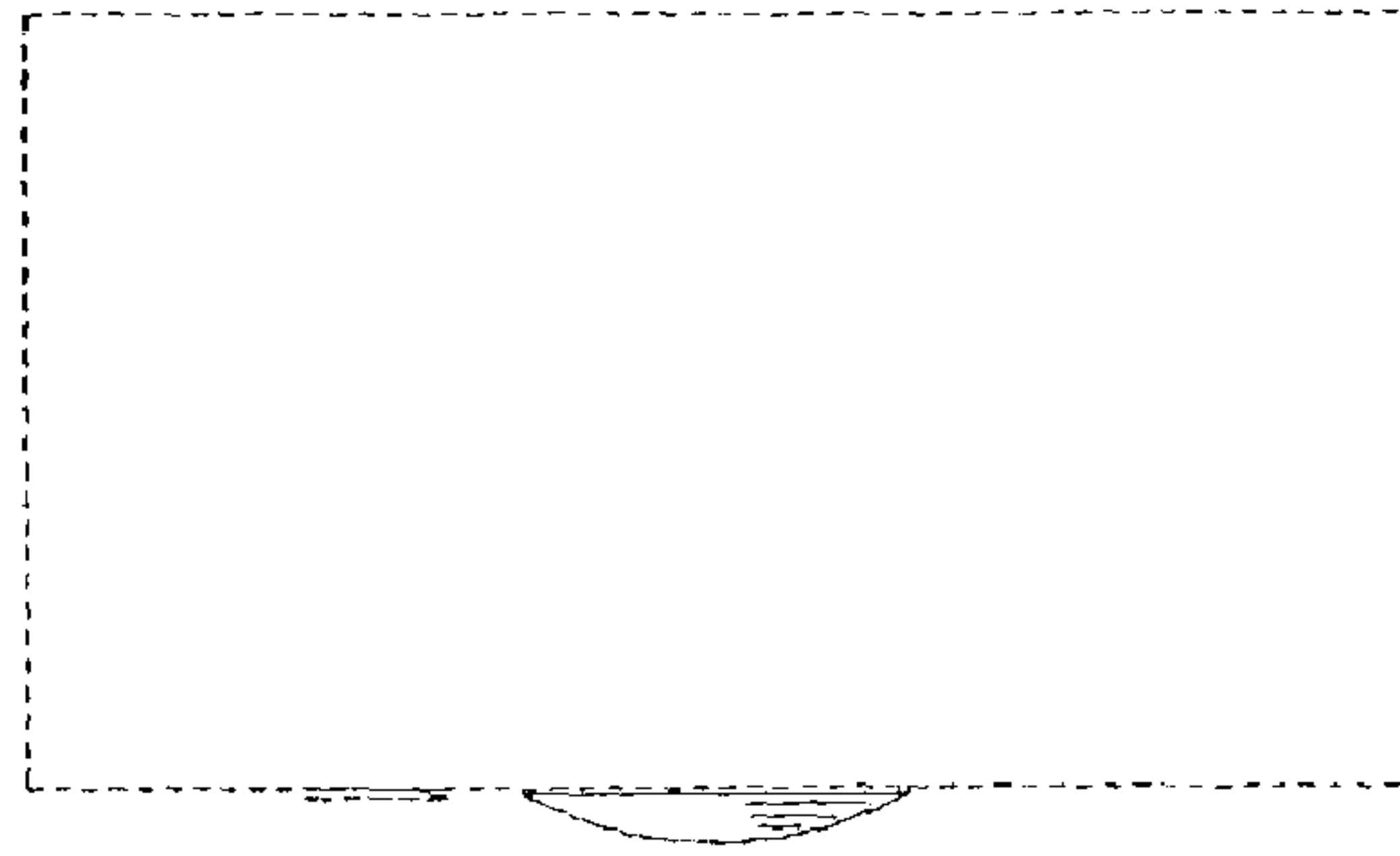
