**DESCRIPTION**

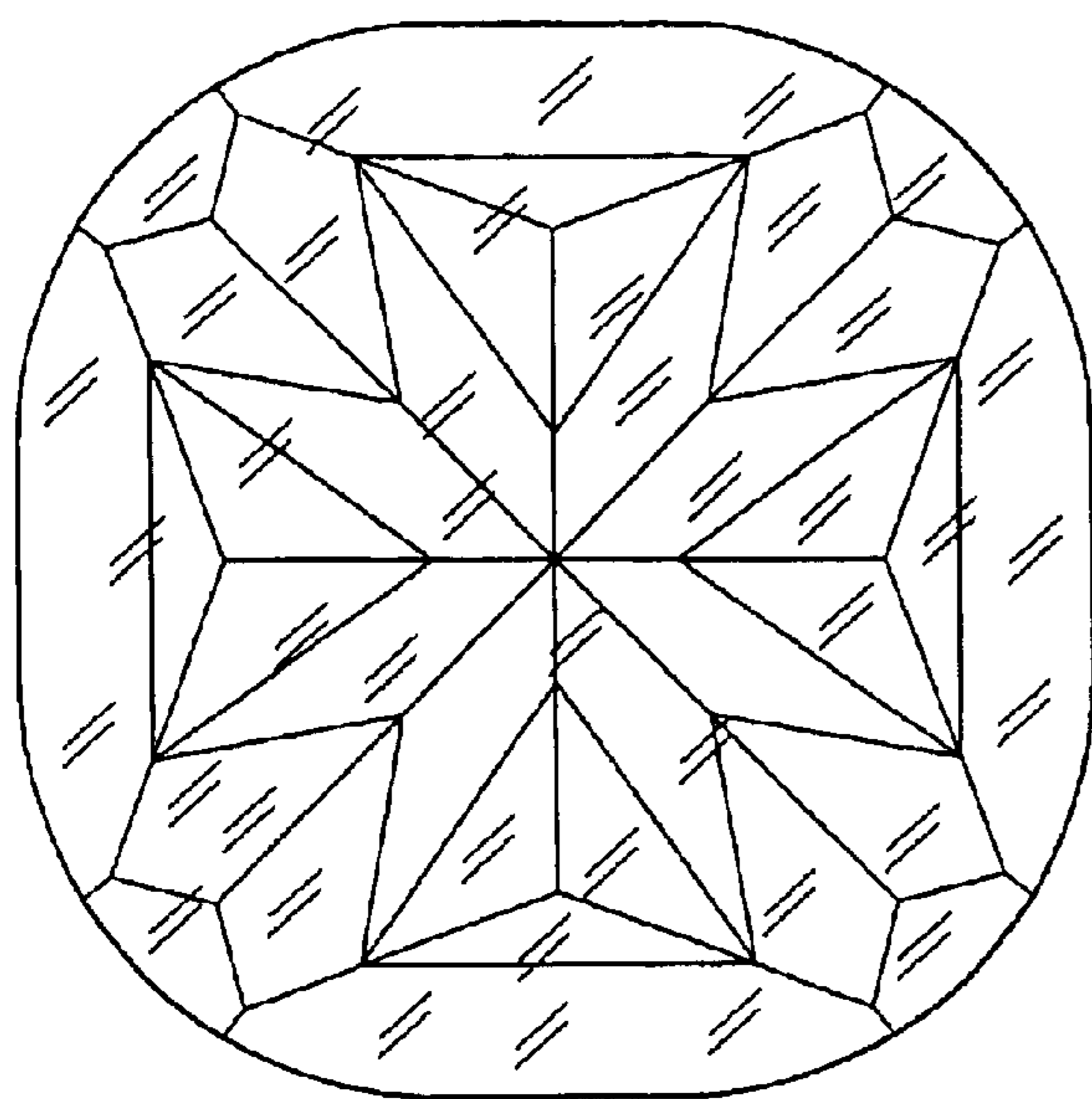

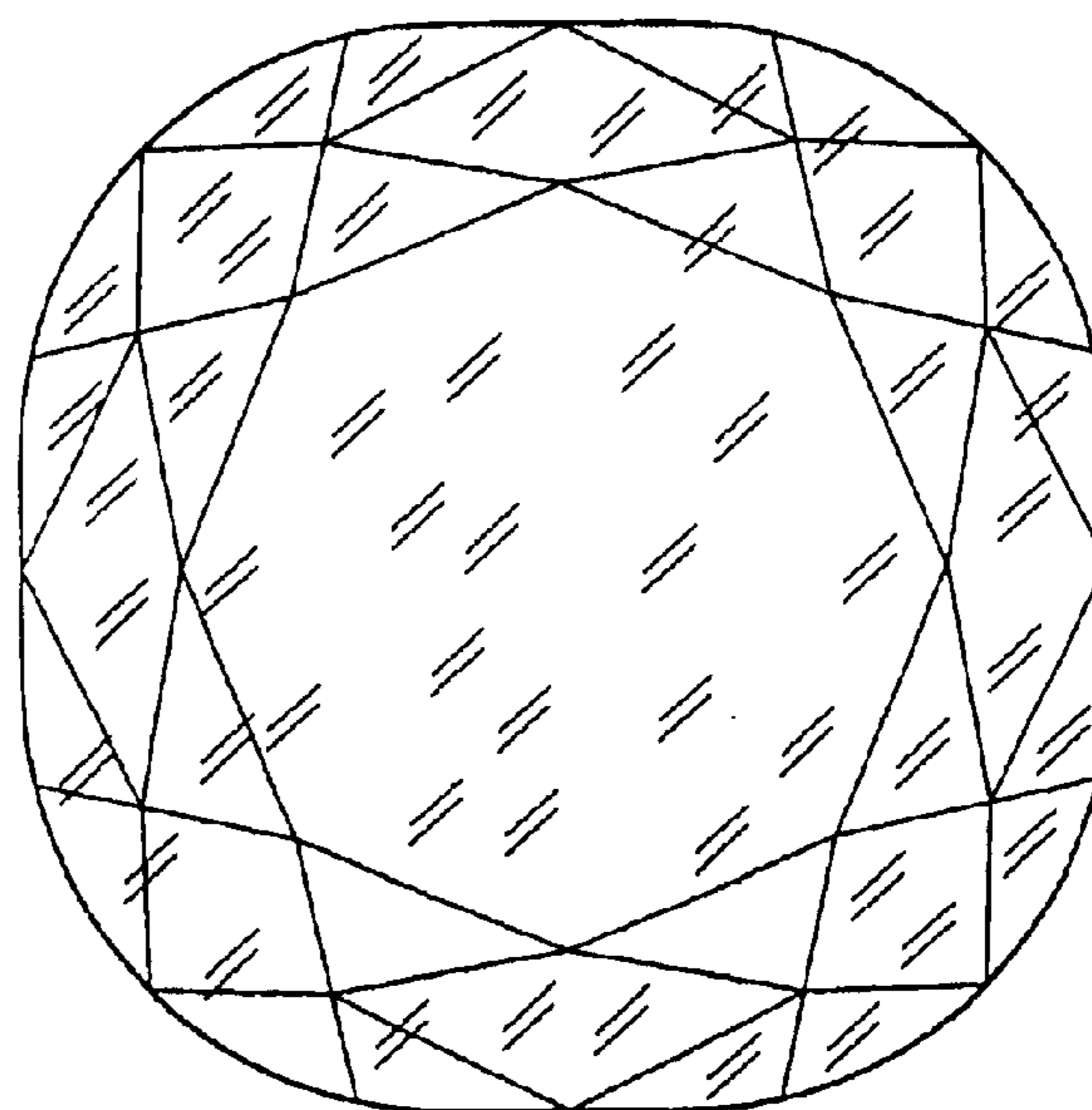

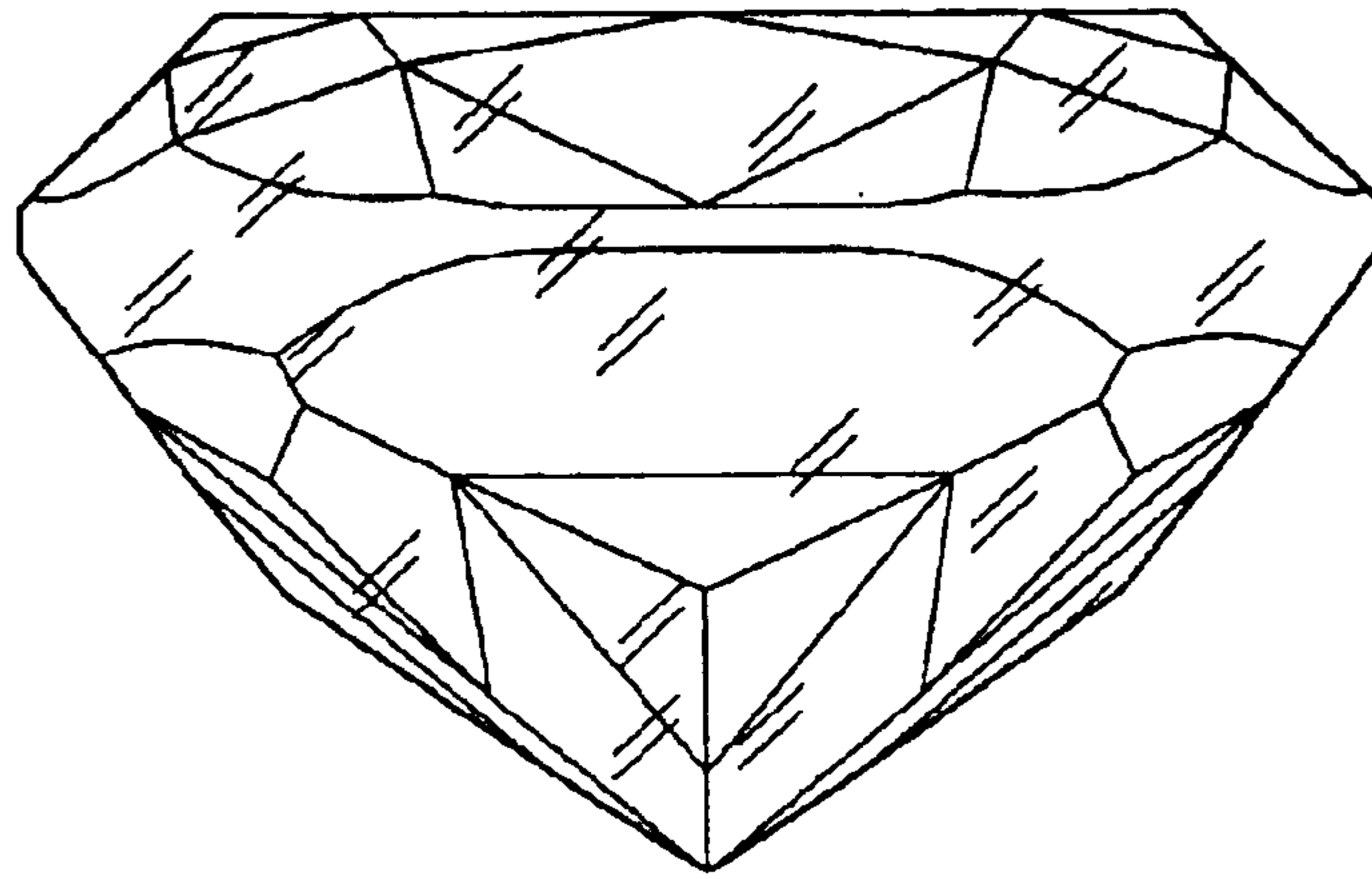

SIDE VIEW

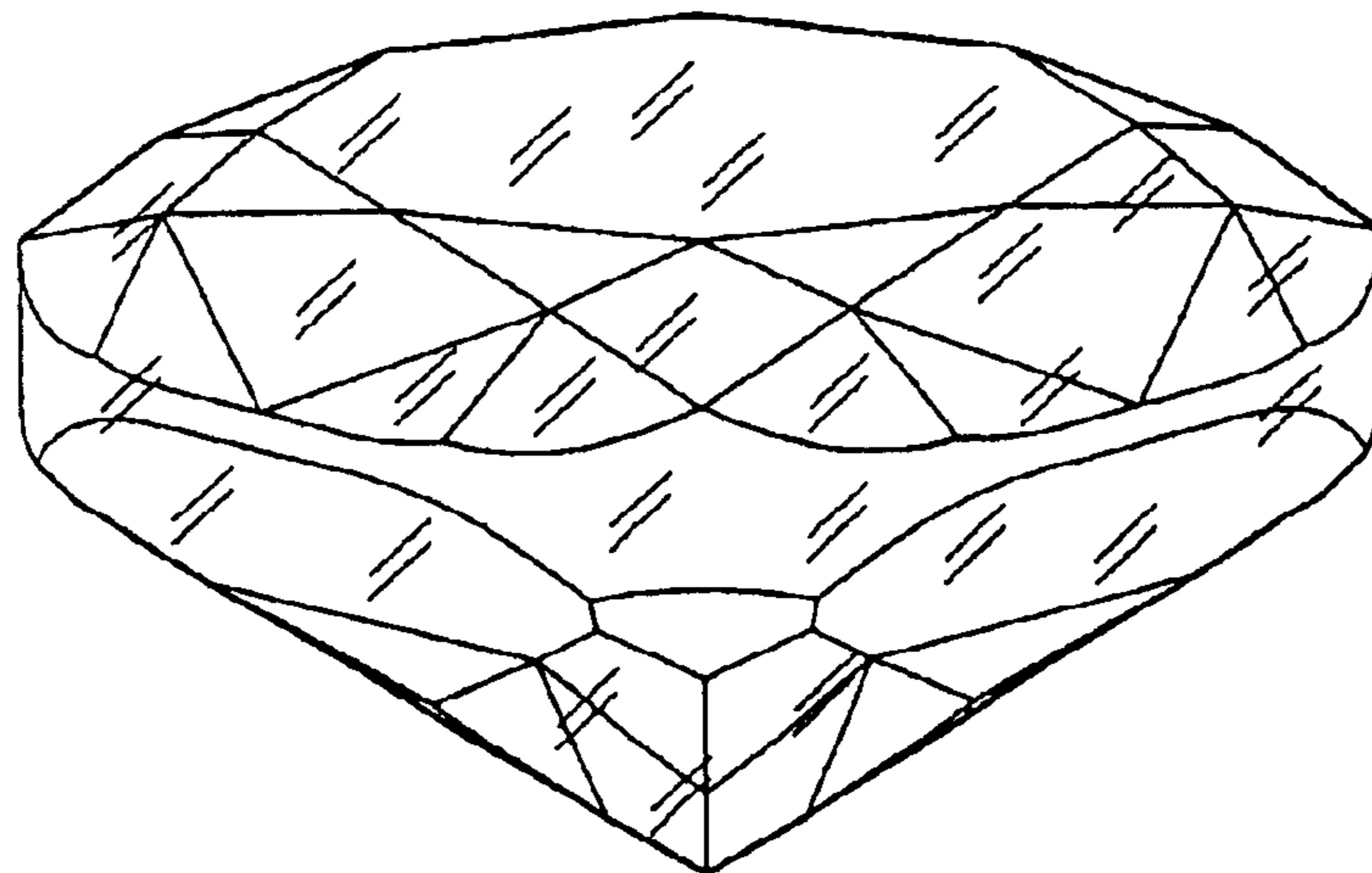

PERSPECTIVE VIEW

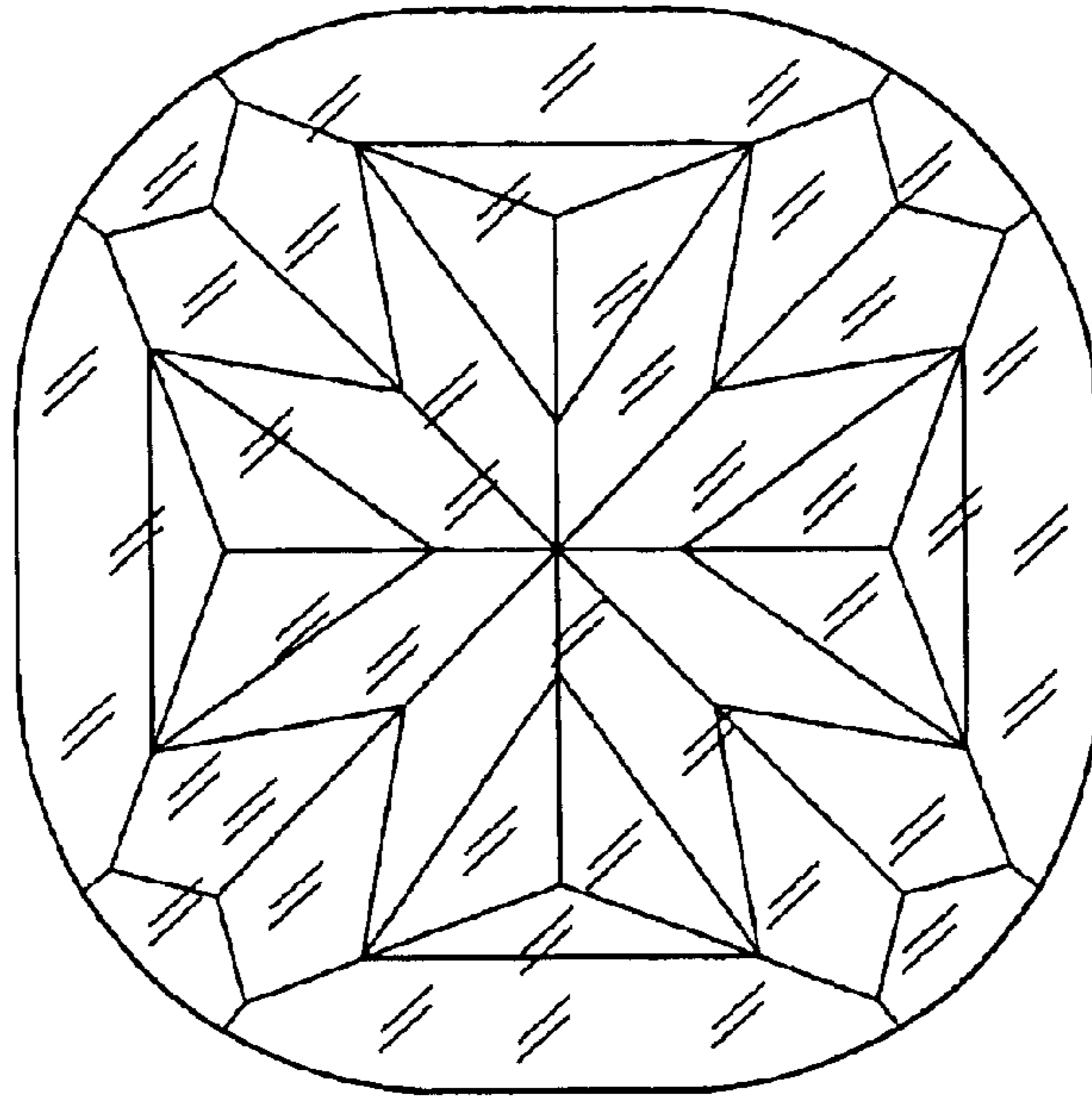

BOTTOM VIEW

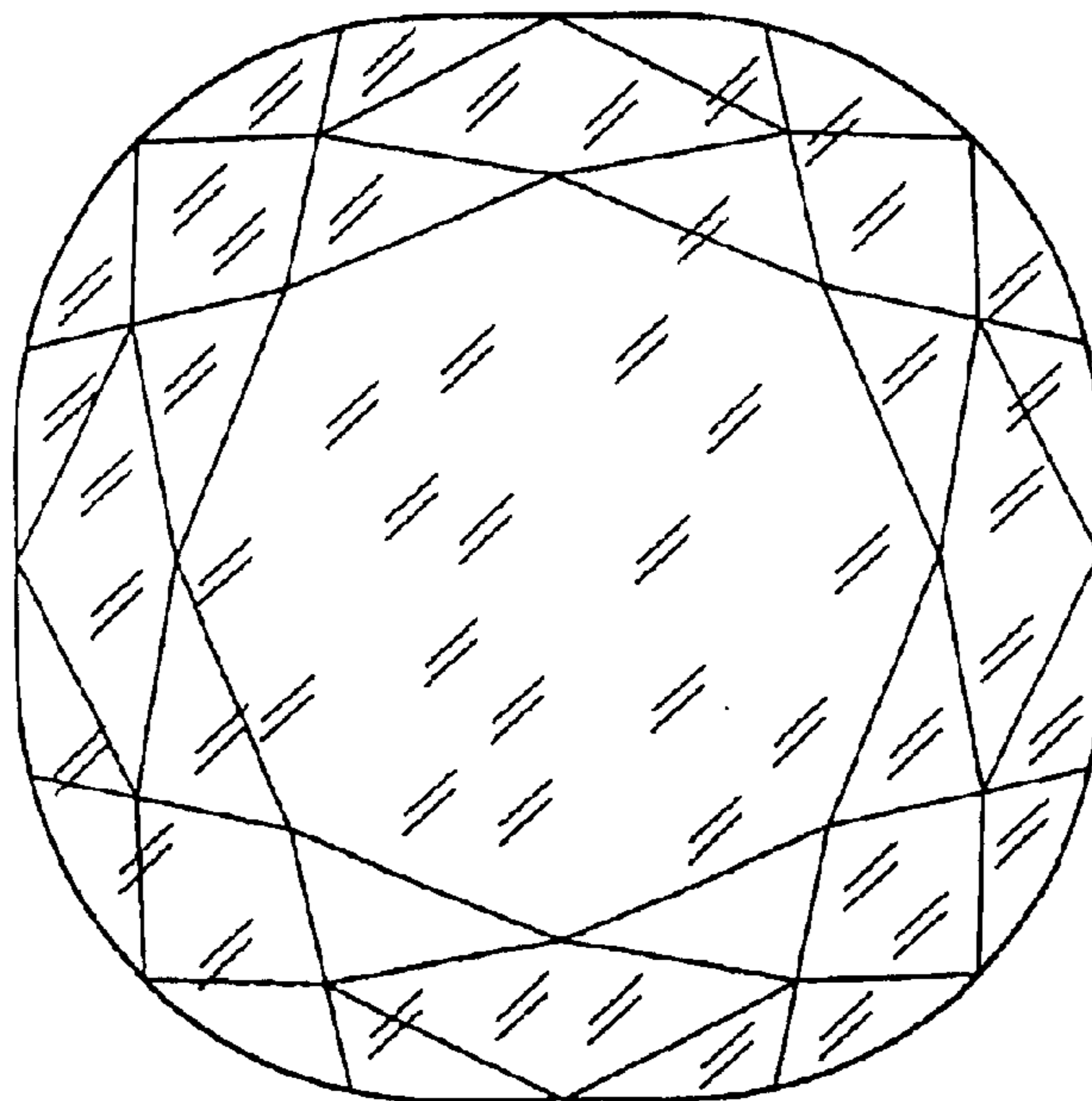
