The broken lines showing additional structure in FIGS. 1, 2, 3, 4, 7, and 8 are for illustrative purposes only and forms no part of the claimed design.

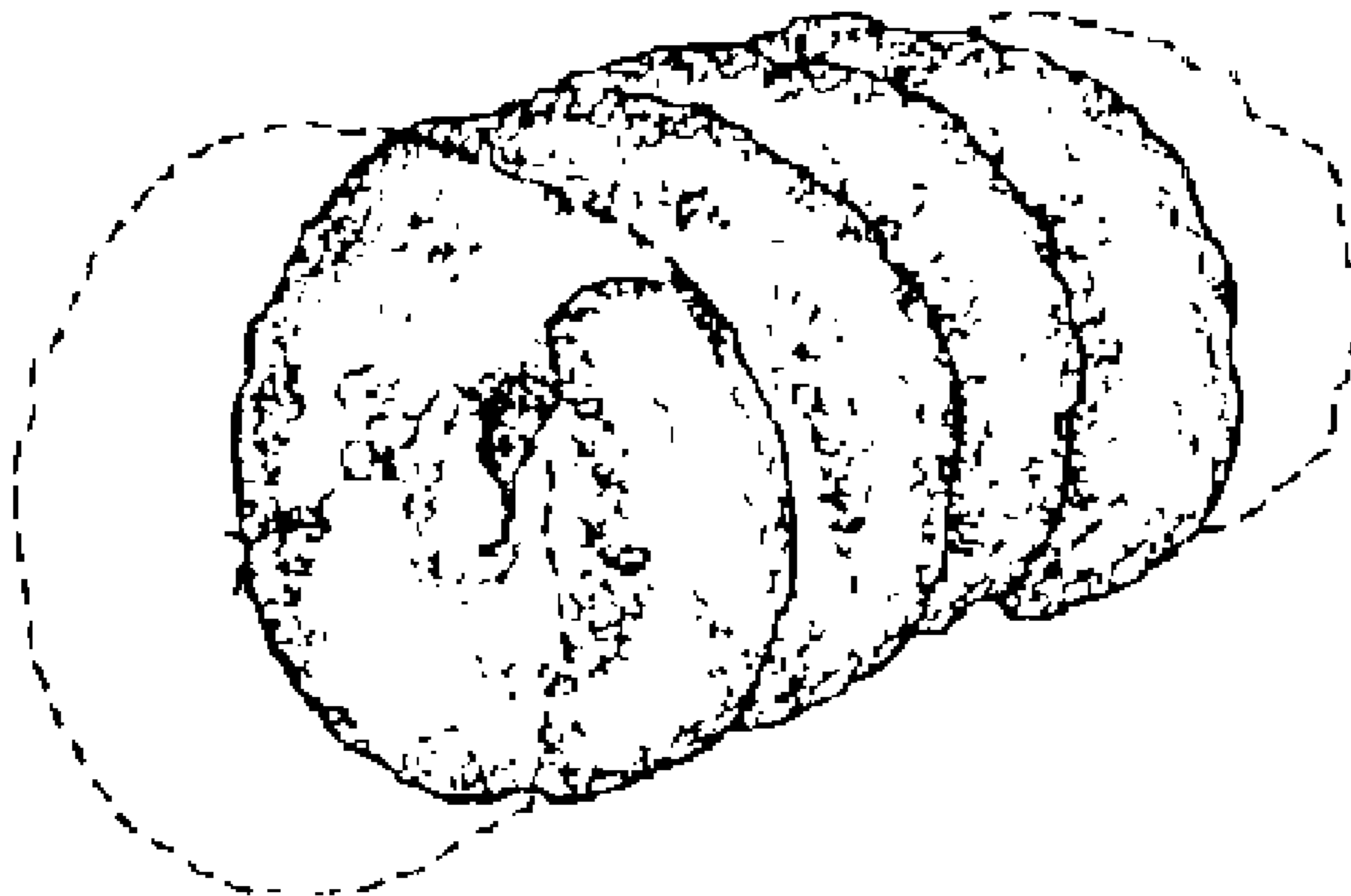

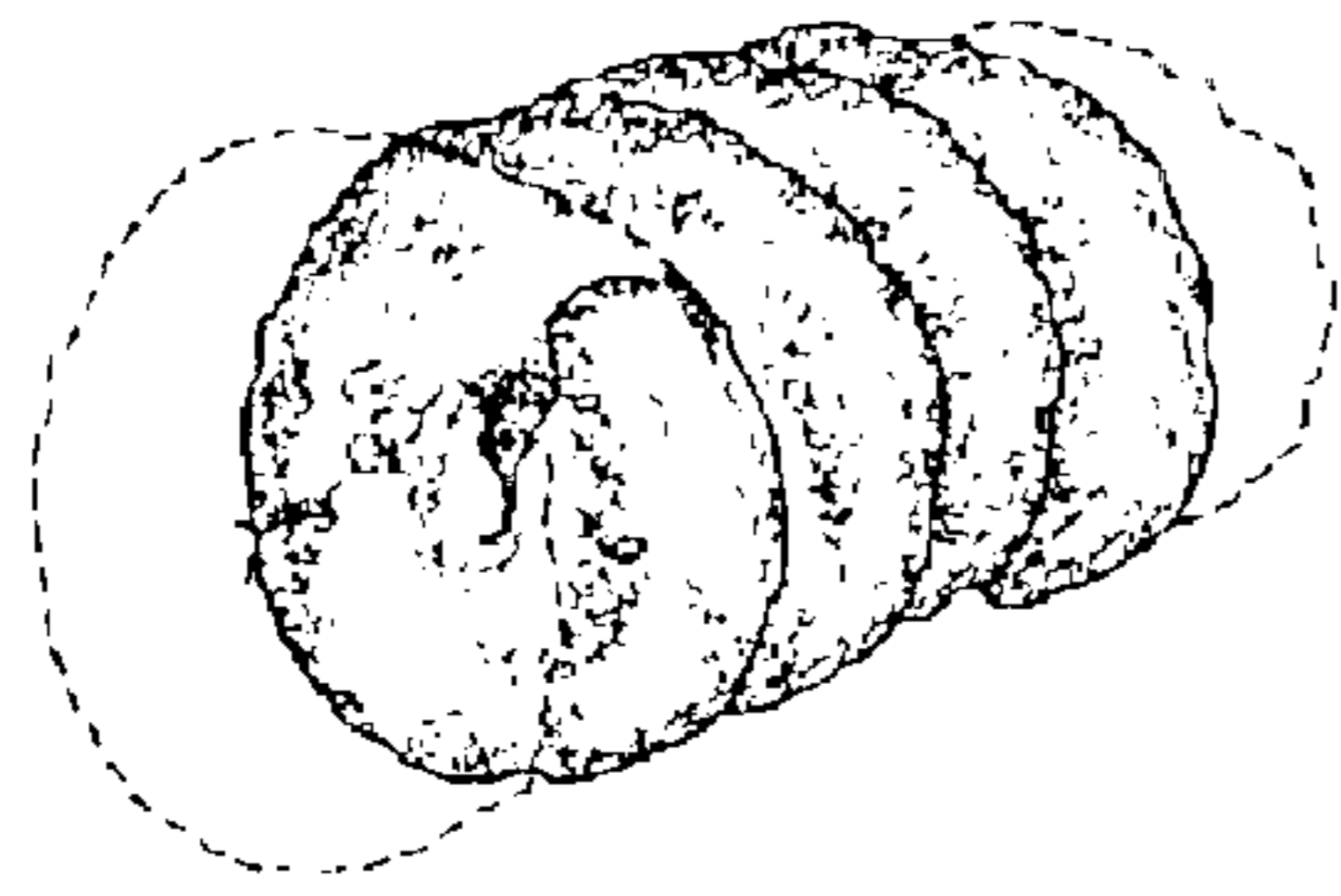

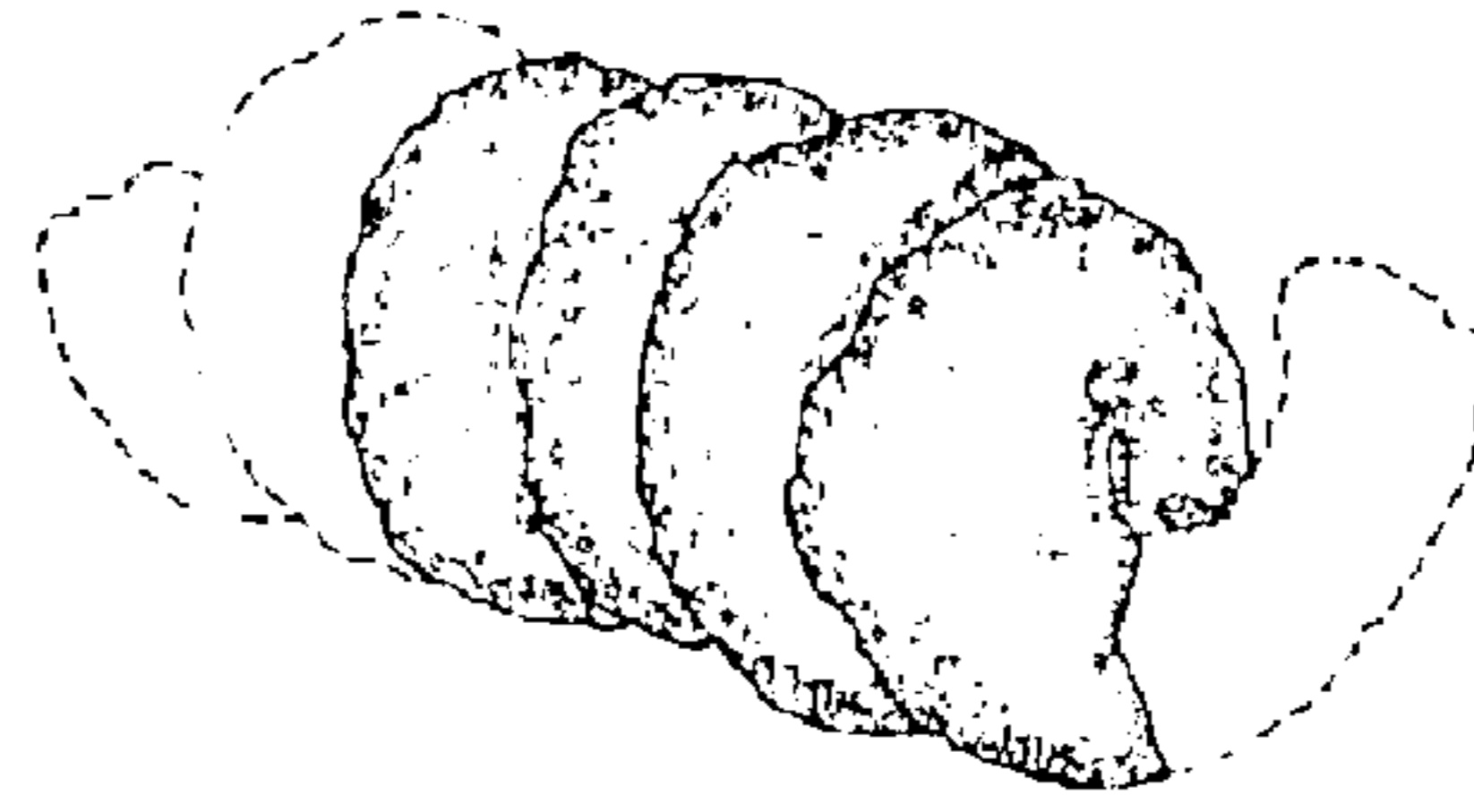

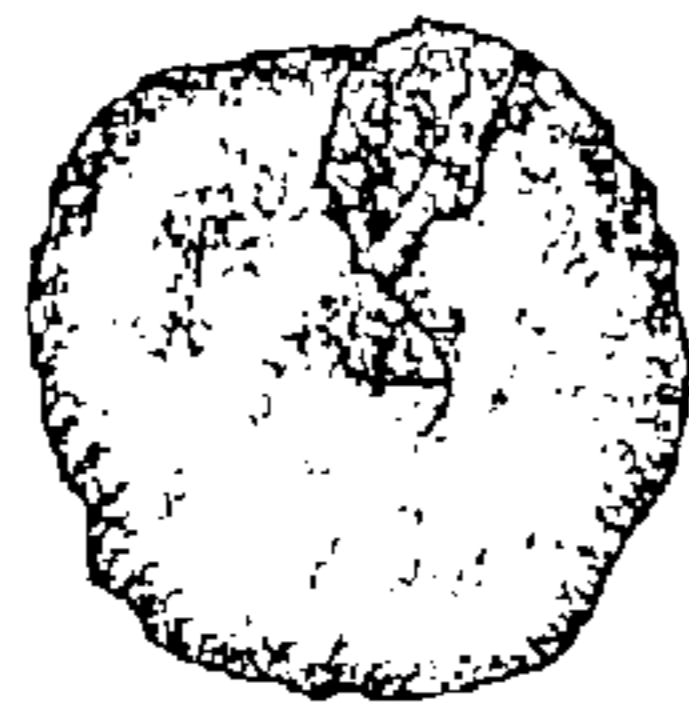
