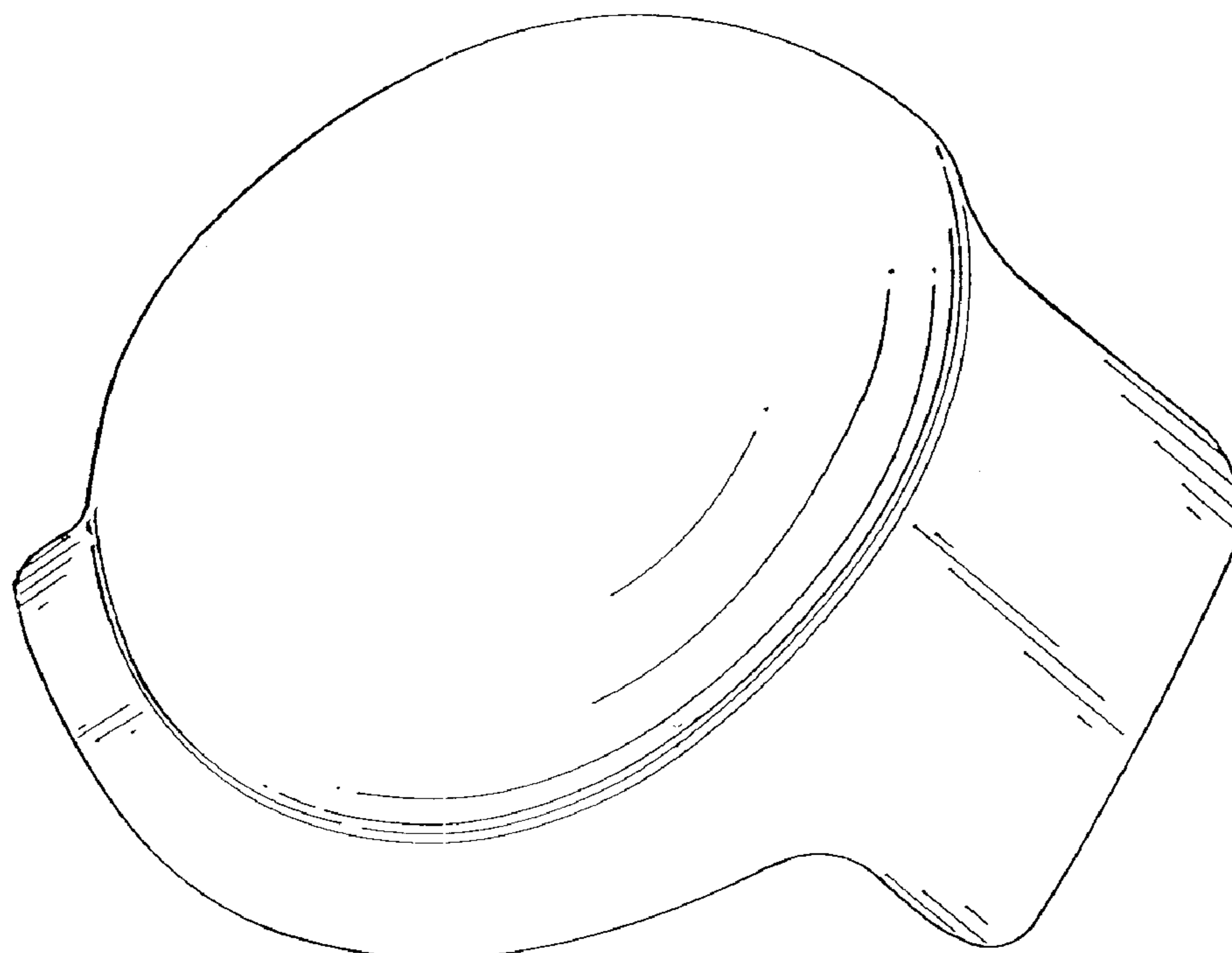
FIG. 1 is a front perspective view of our new strapless/backless enhanced cleavage bra design;

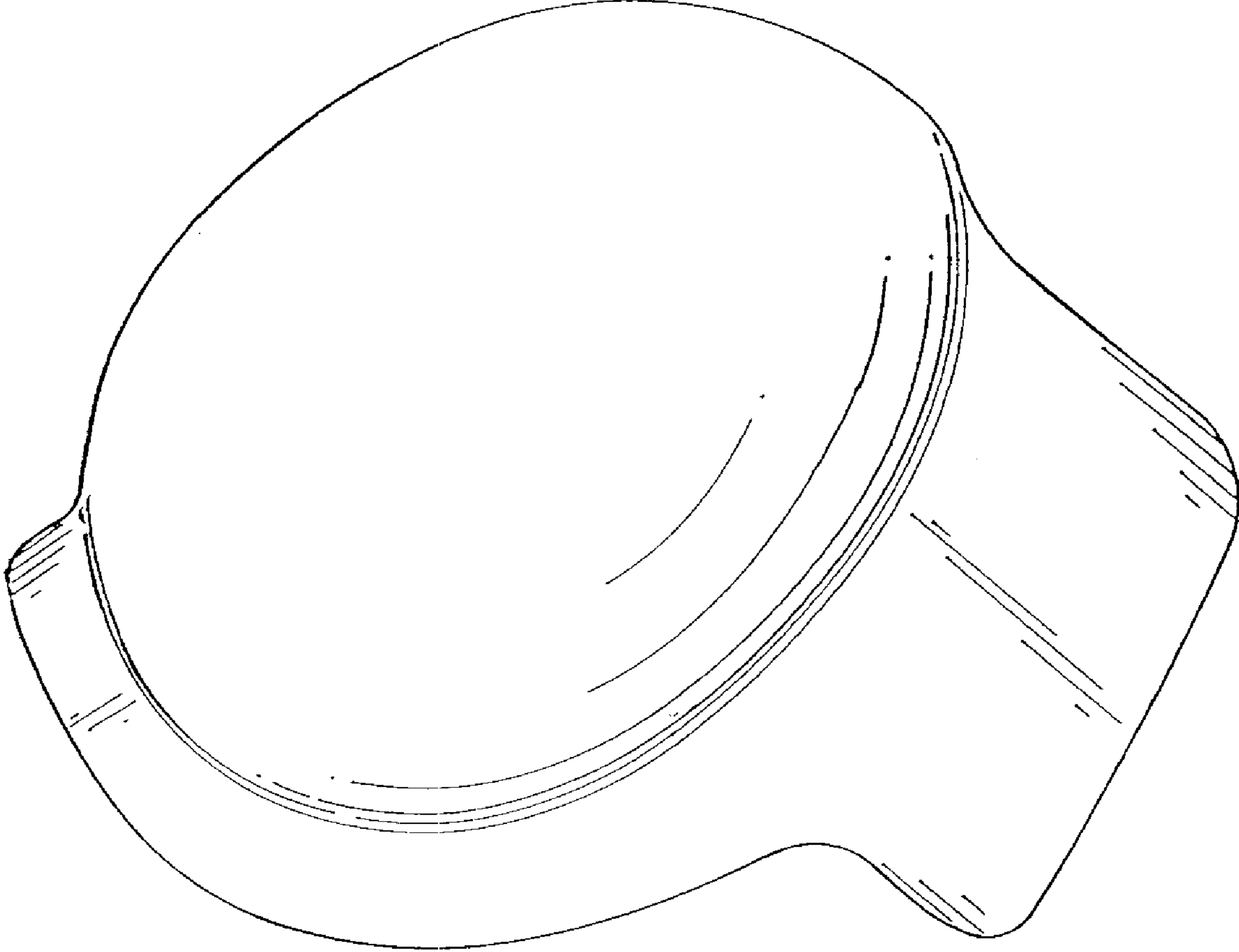

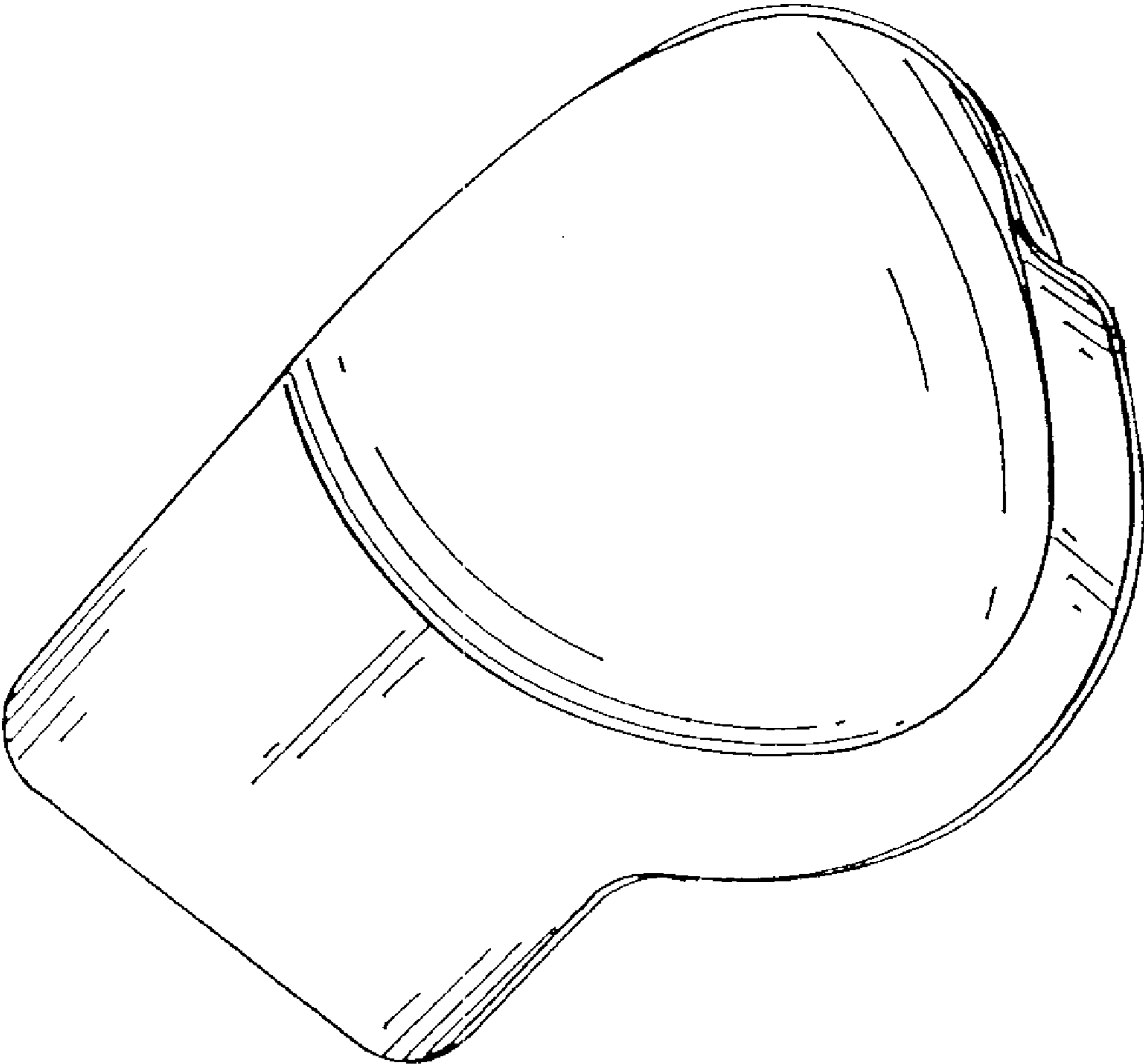

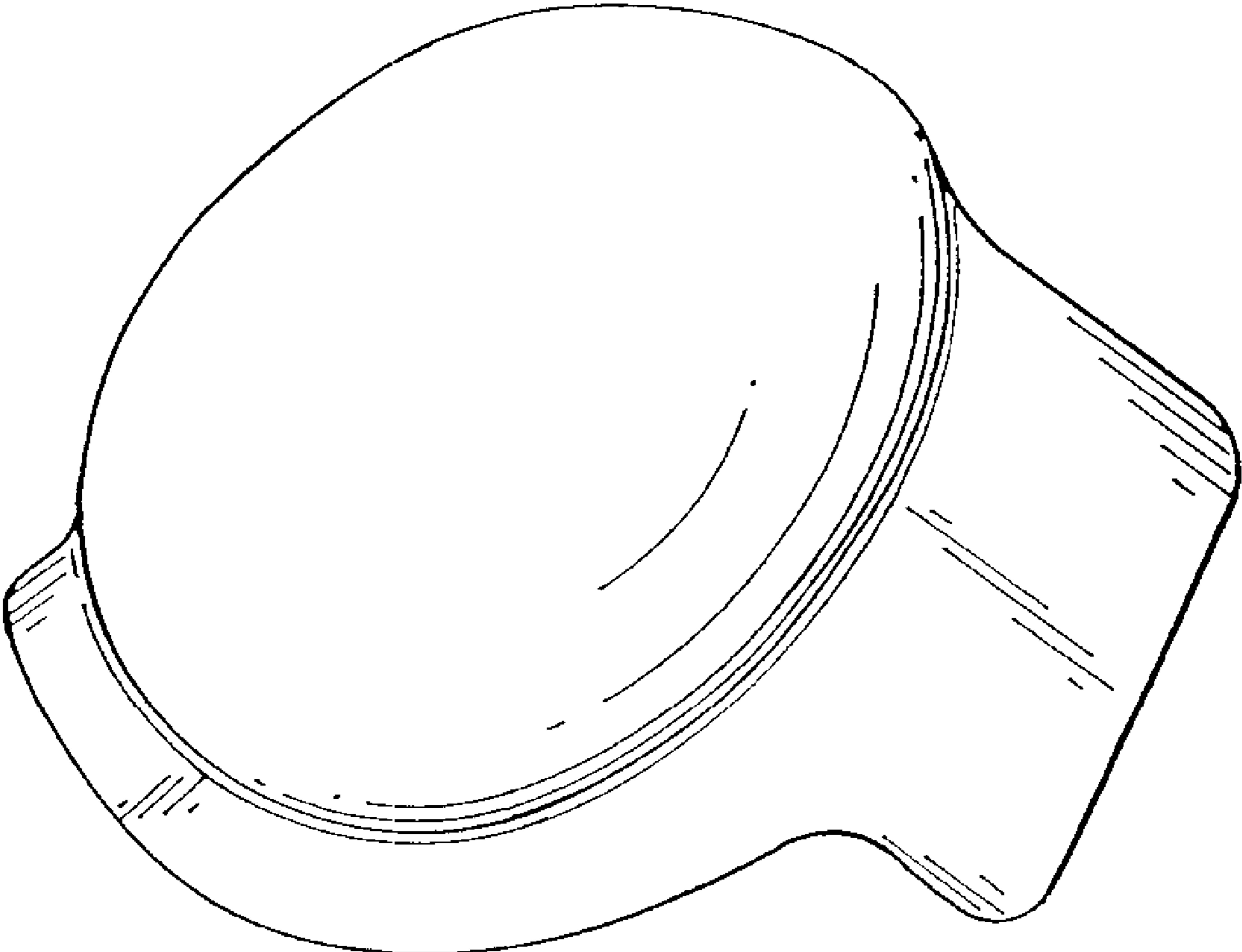

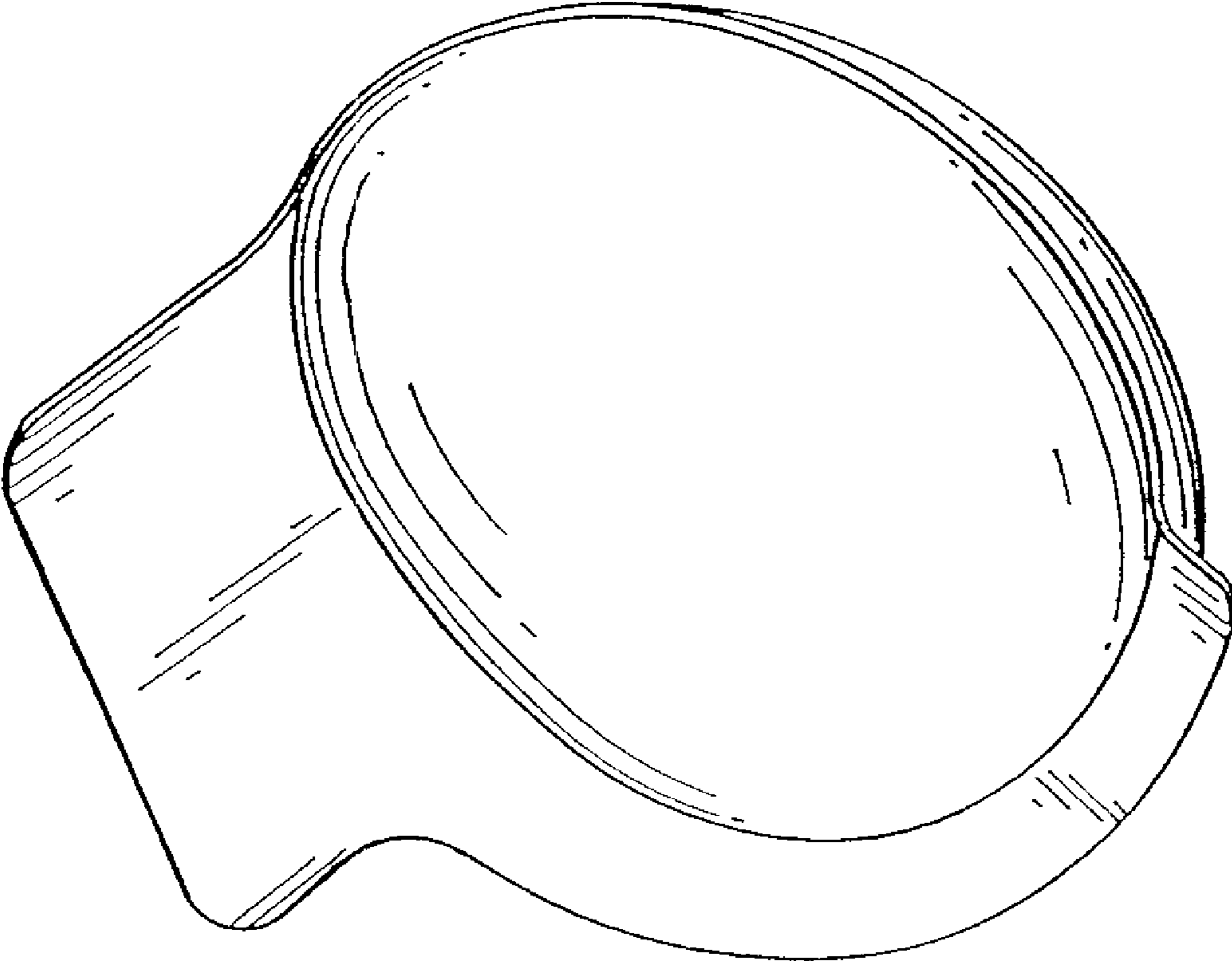

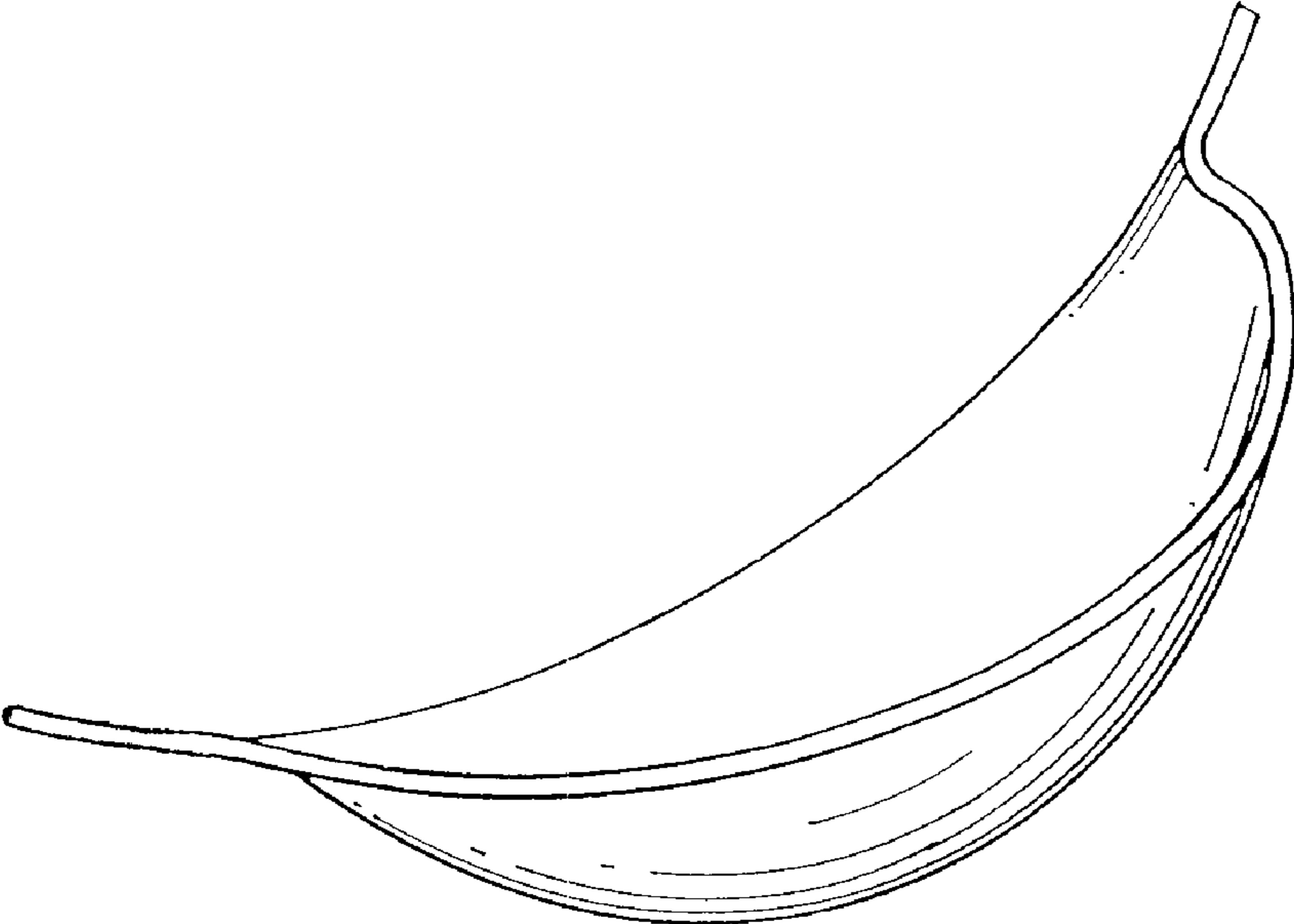

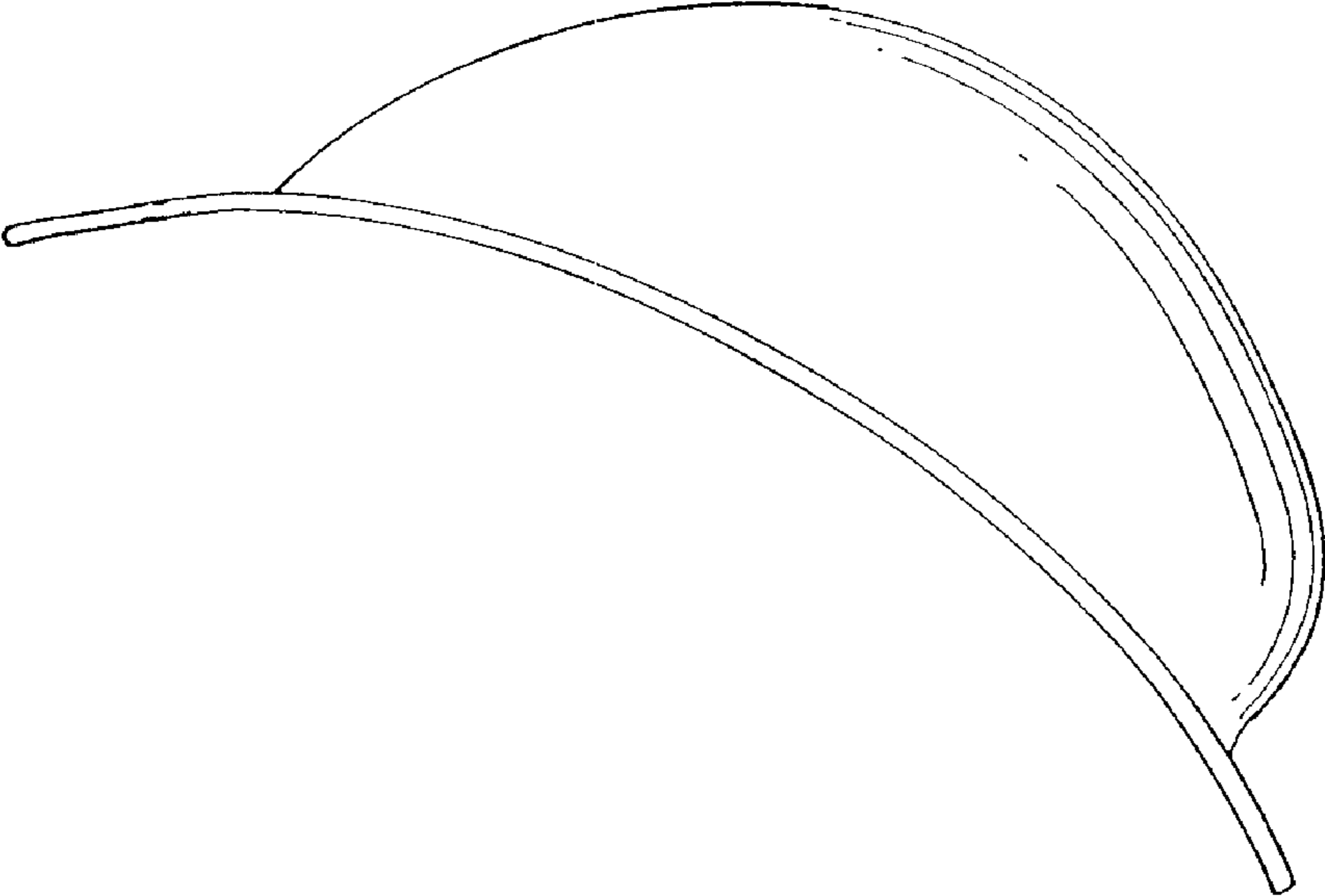

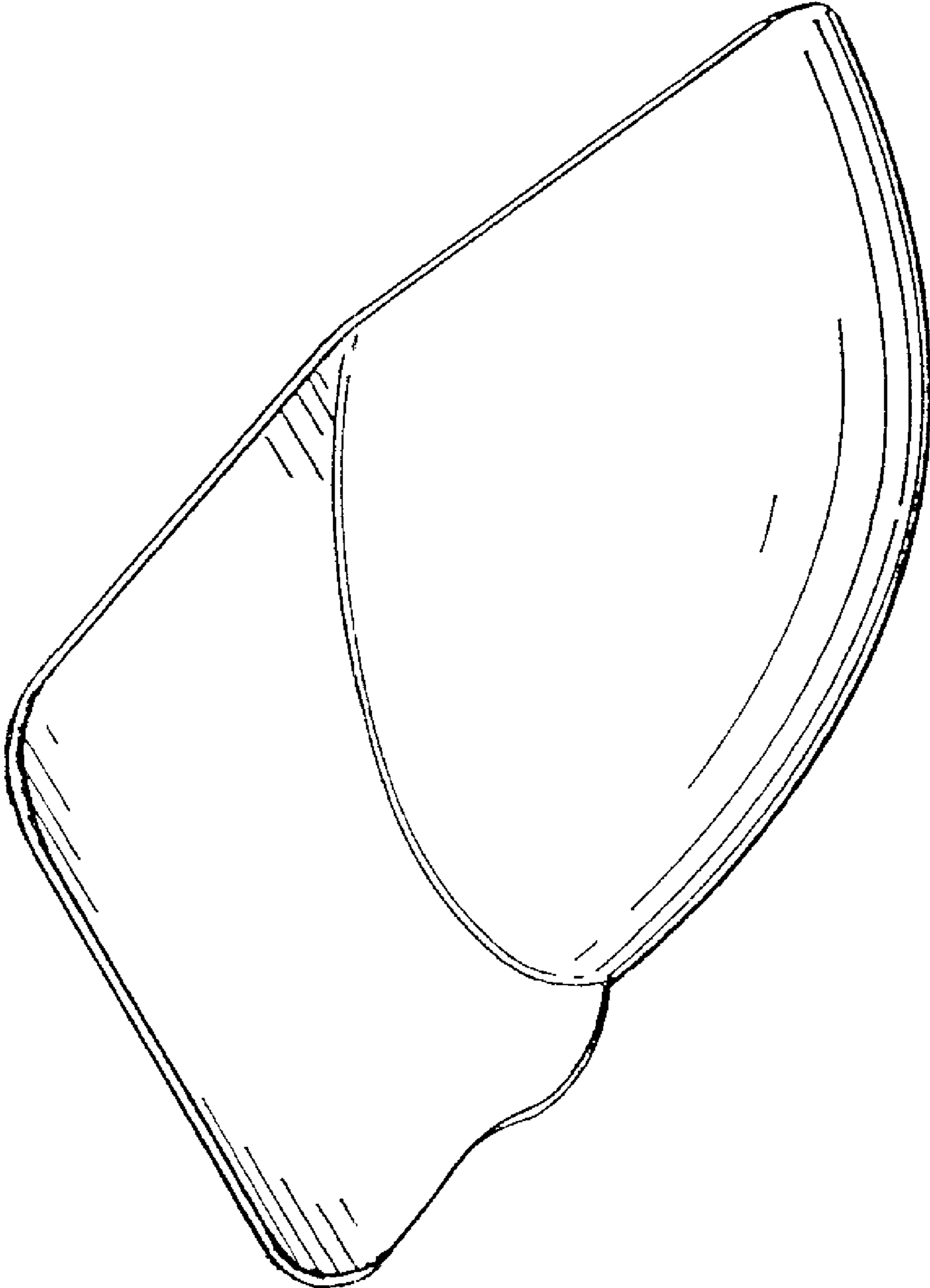
