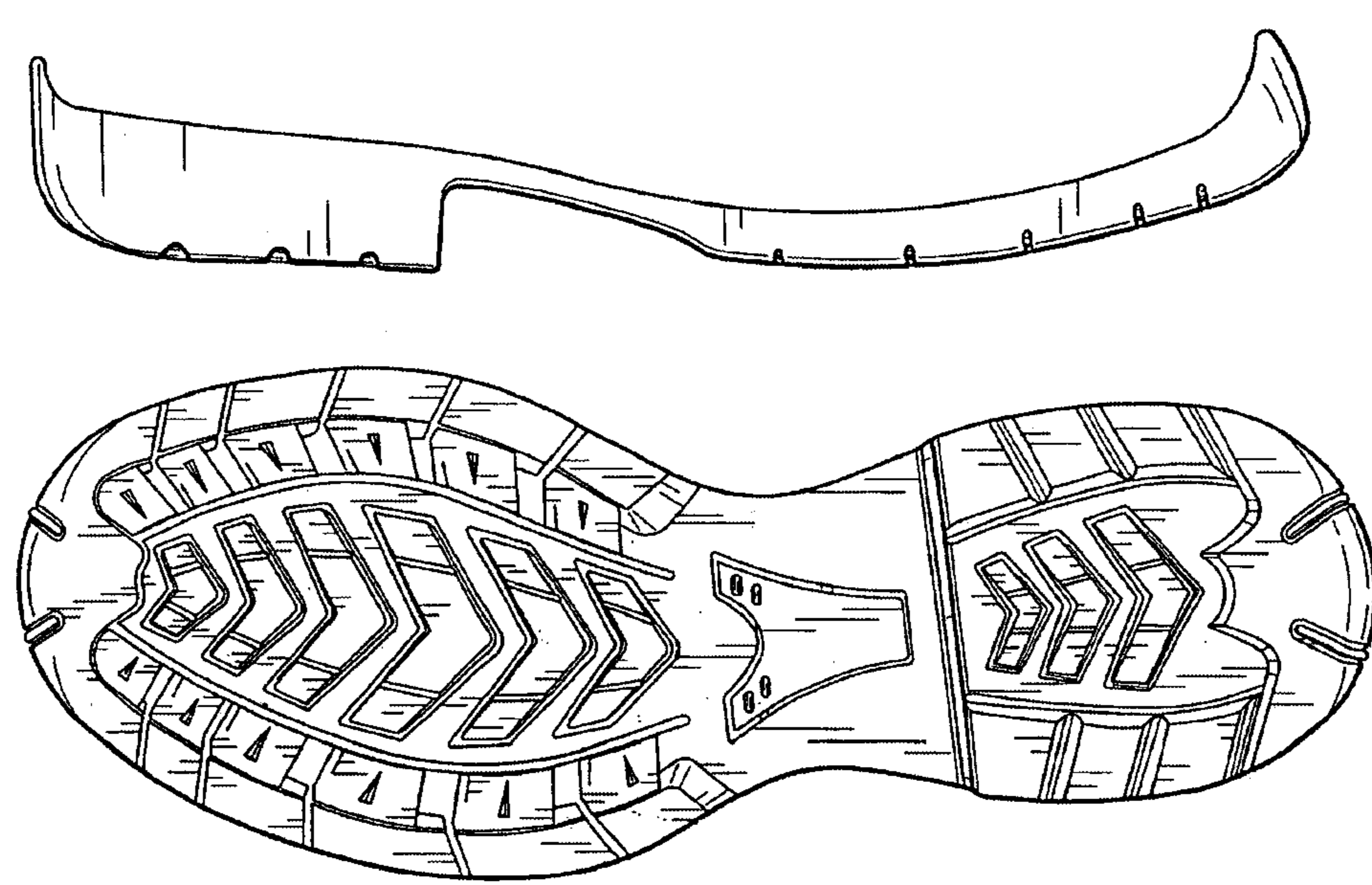

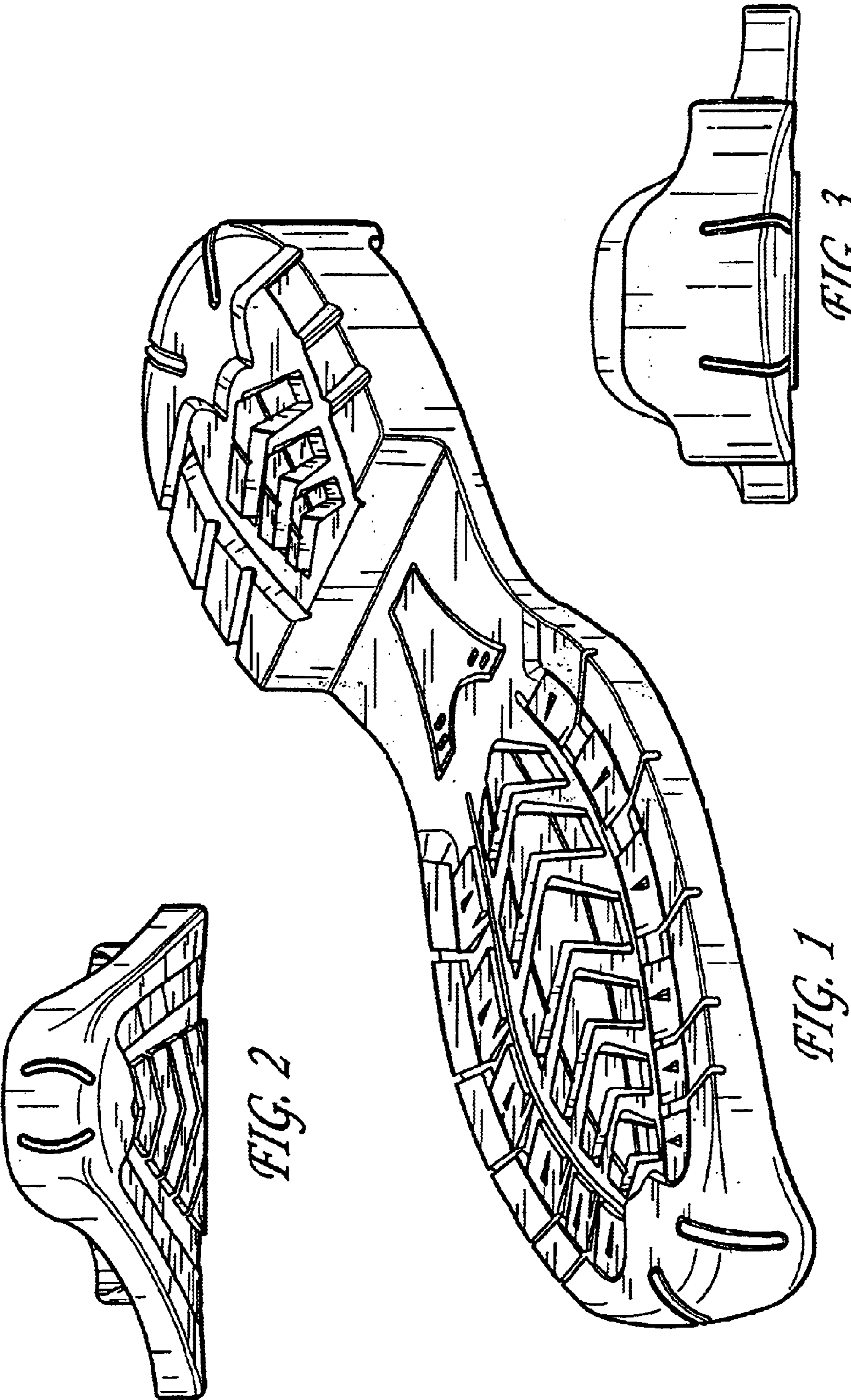
The ornamental design for the shoe outsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the shoe outsole showing a bottom, front, and left sides of the new design;  
 FIG. 2 is a front view of the shoe outsole of FIG. 1;  
 FIG. 3 is a rear view of the shoe outsole of FIG. 1;  
 FIG. 4 is a right side view of the shoe outsole of FIG. 1;  
 FIG. 5 is a left side view of the shoe outsole of FIG. 1;  
 FIG. 6 is a bottom view of the shoe outsole of FIG. 1; and,

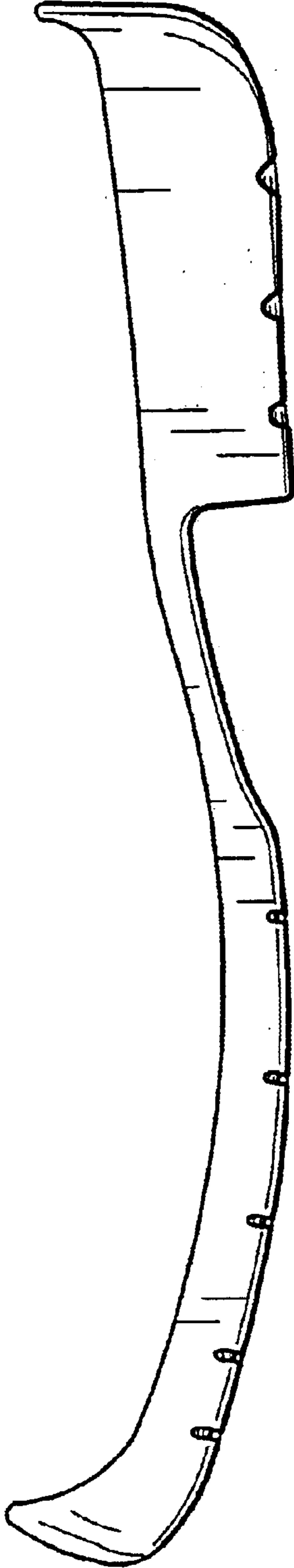

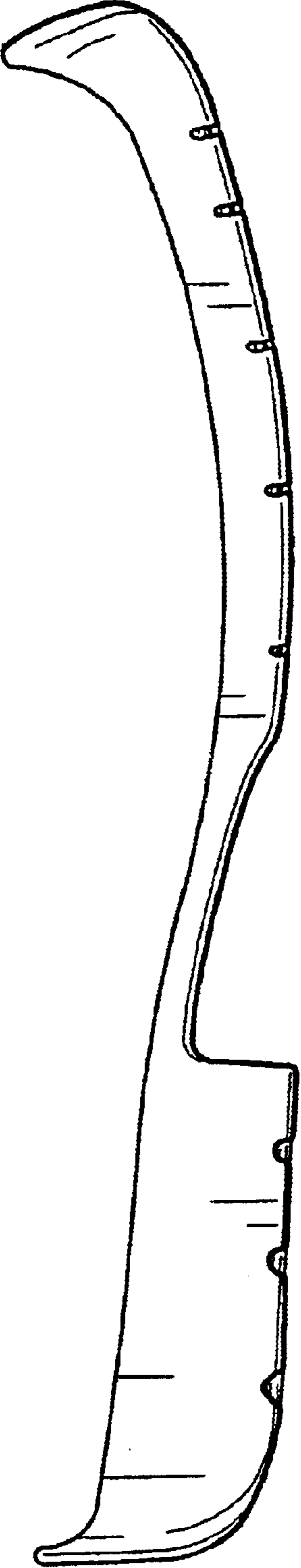

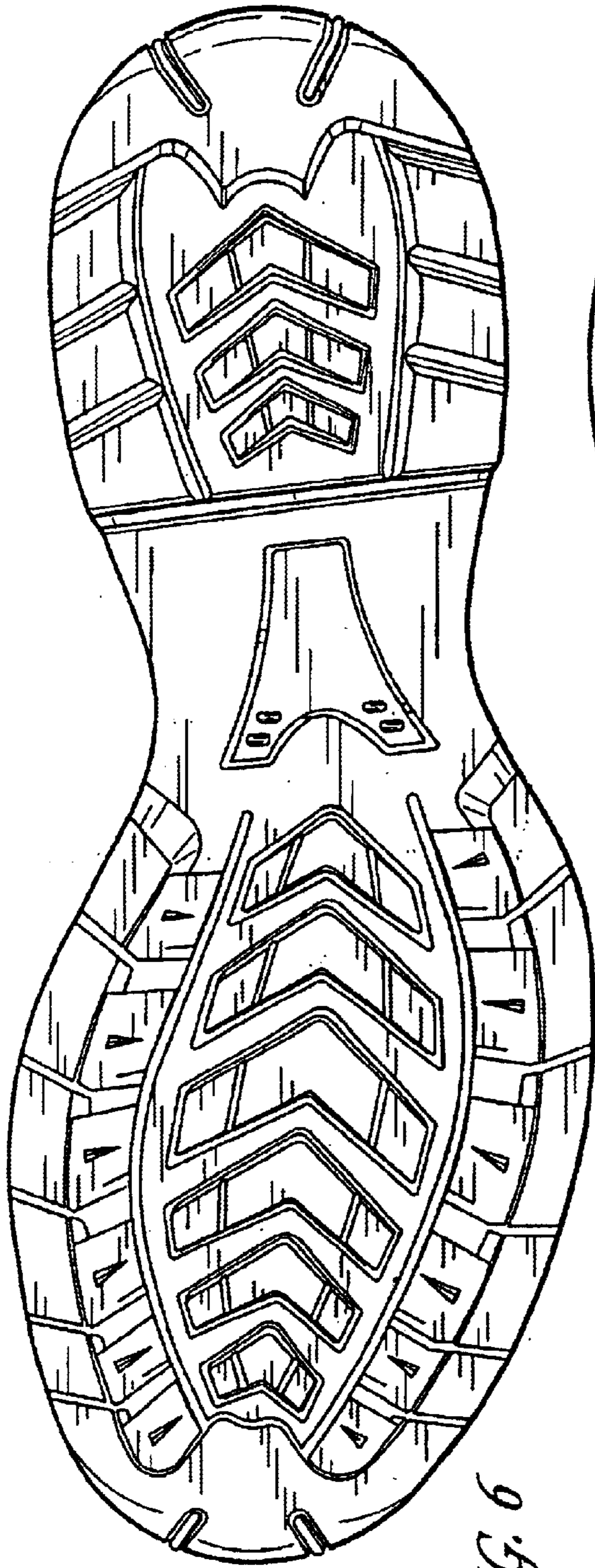

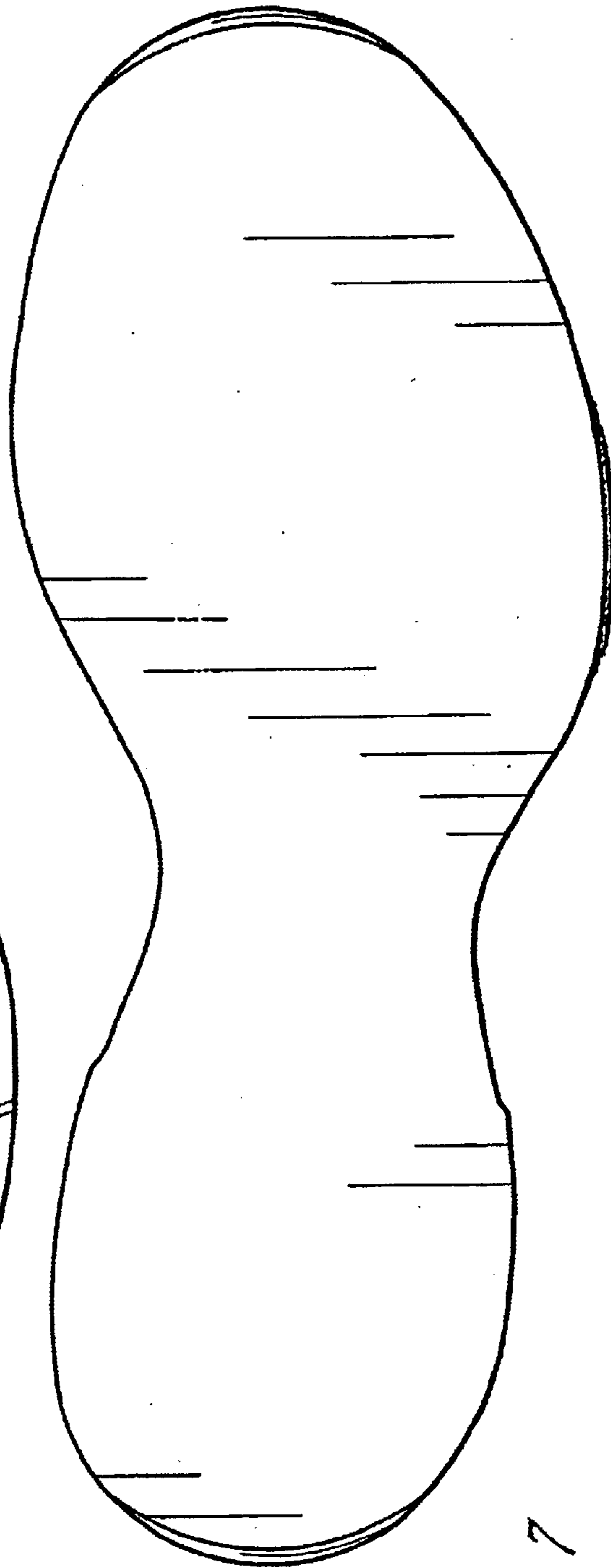
