design.

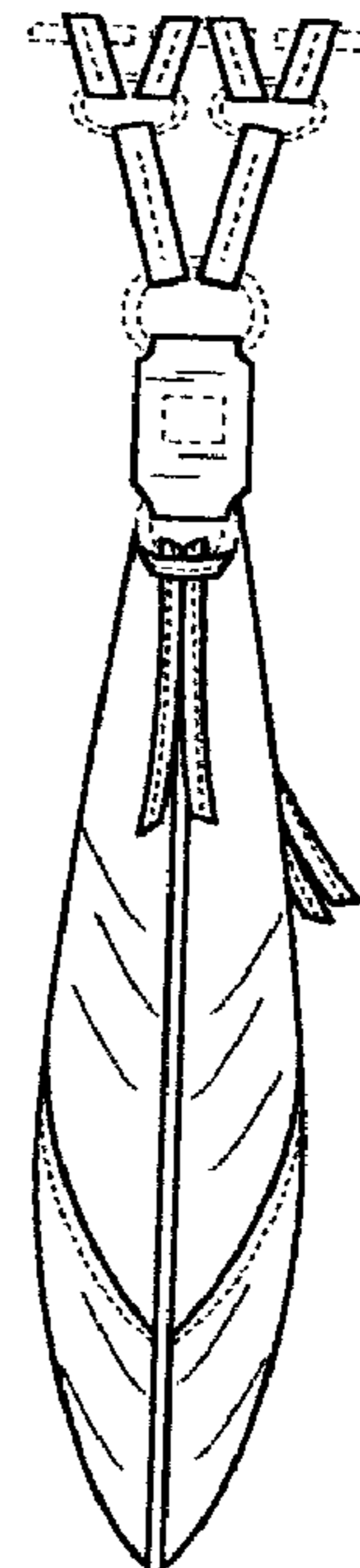
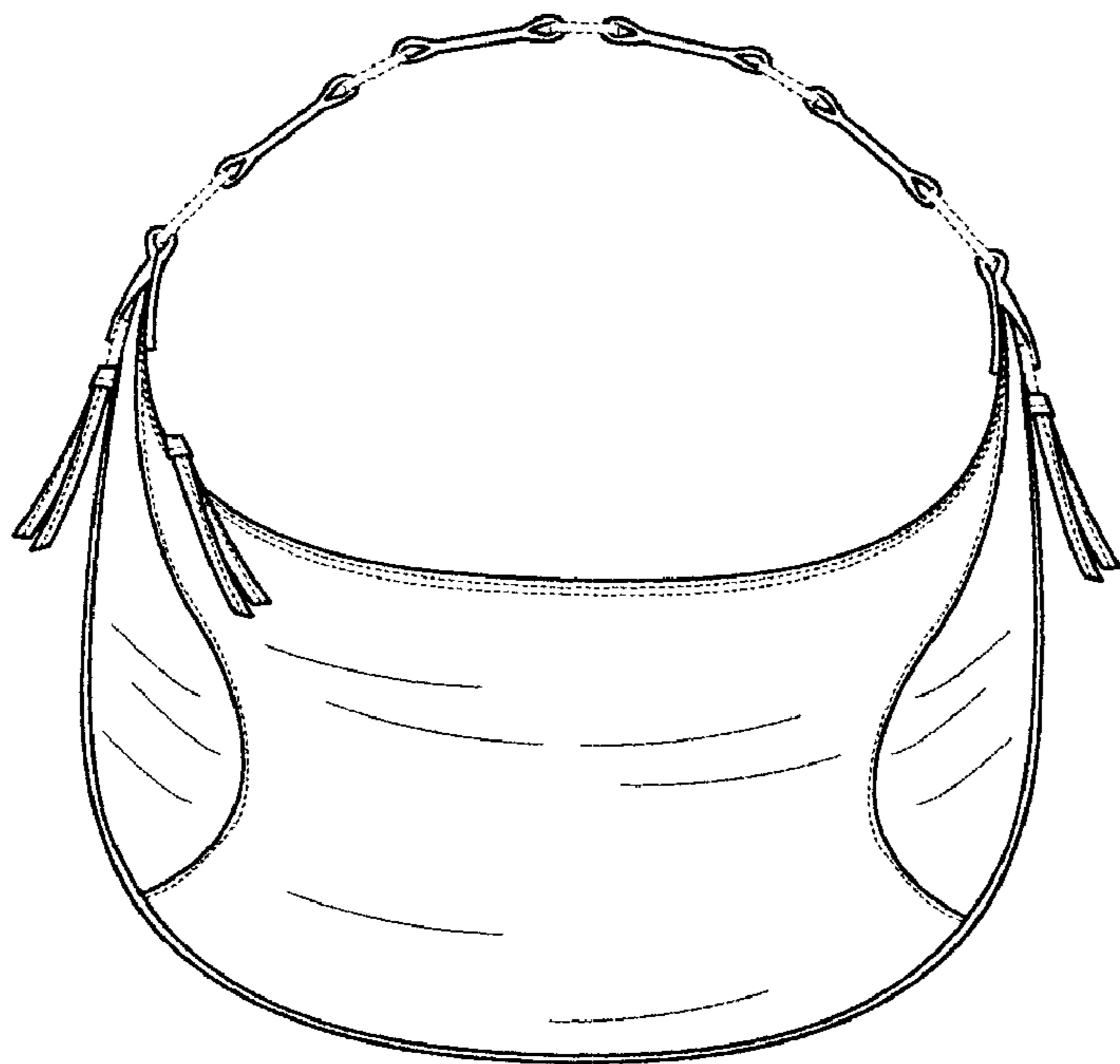
FIG. 2 is a front elevation view thereof;

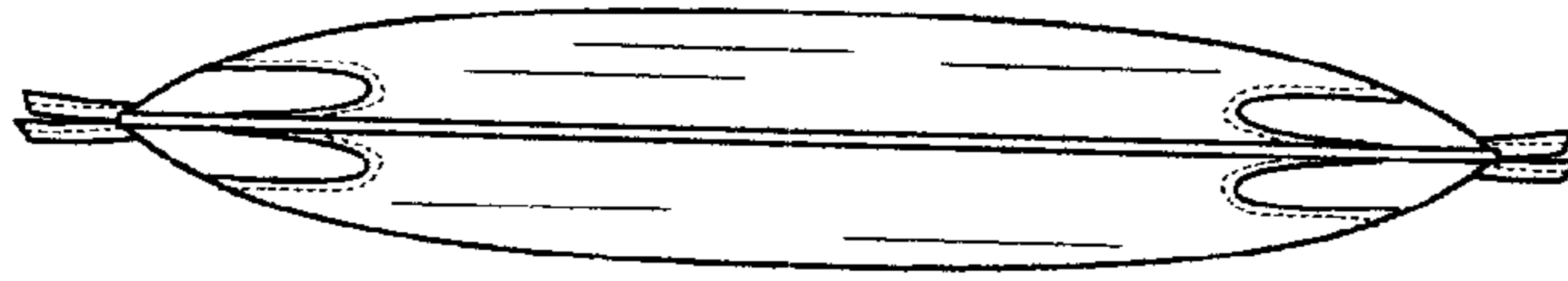

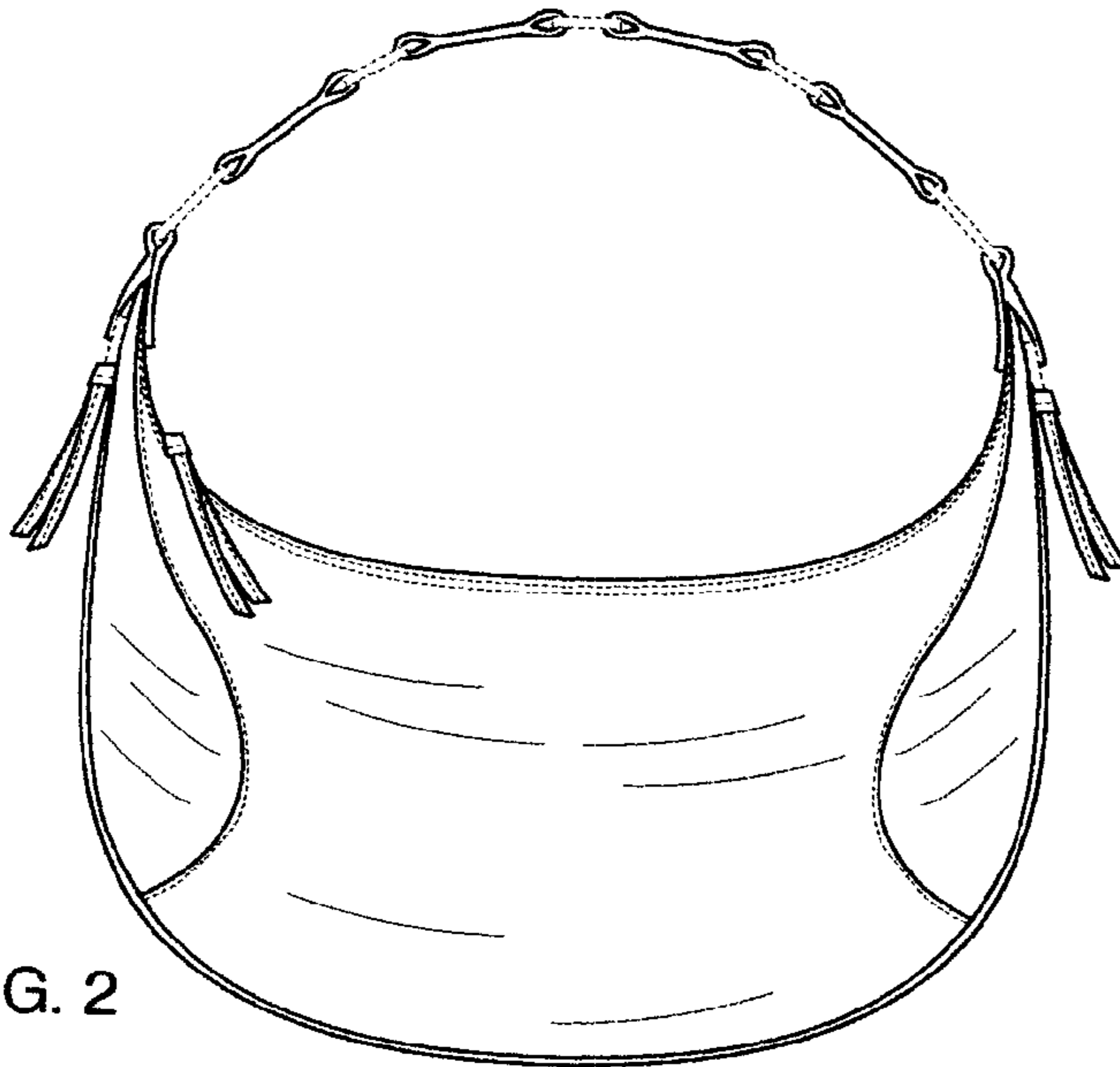

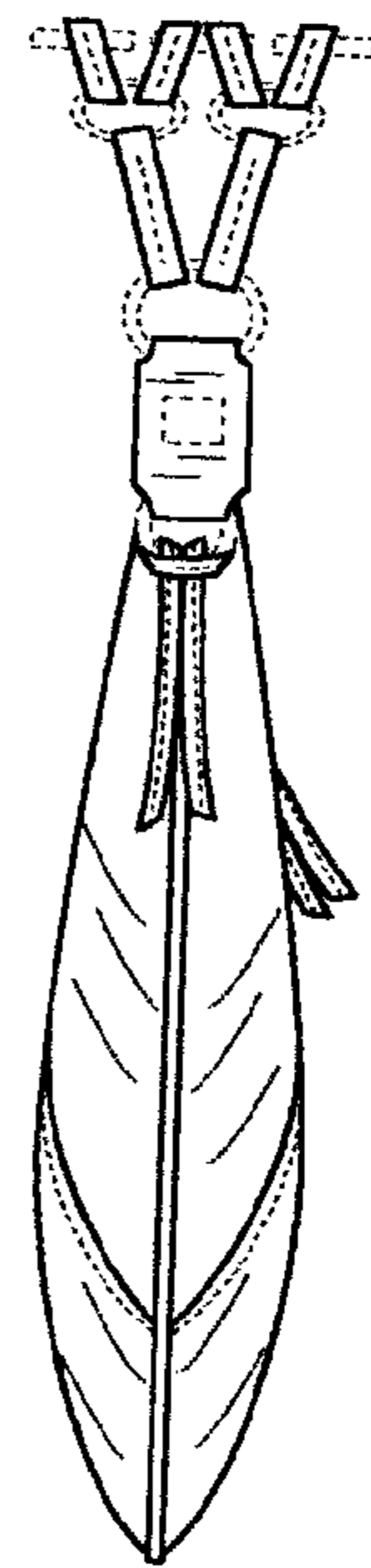

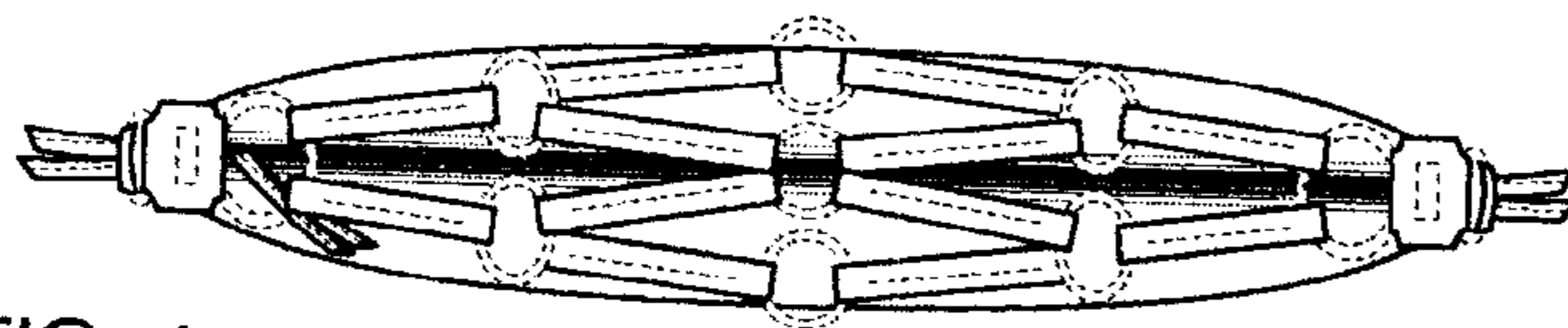
