(57) **CLAIM**

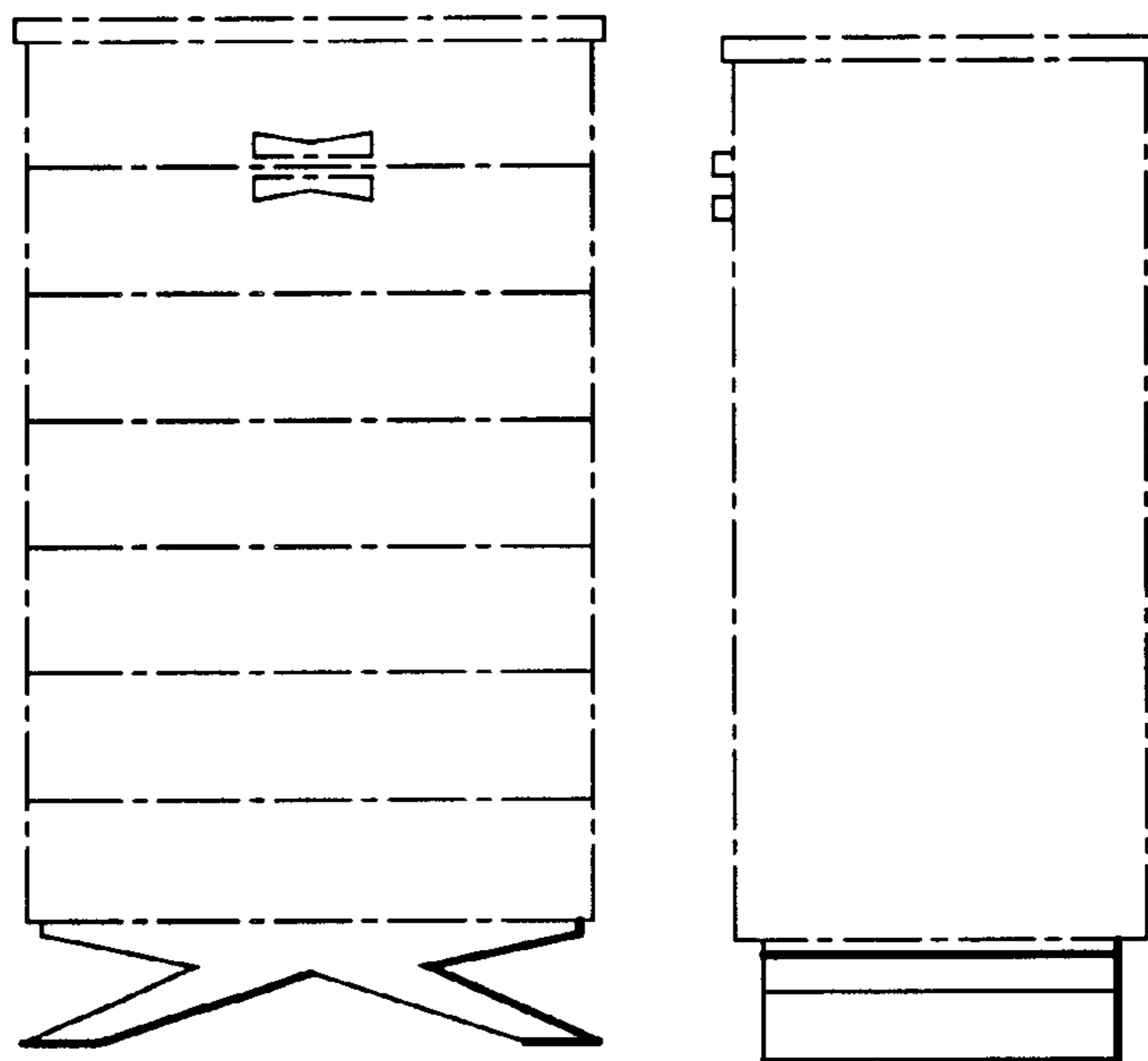
The ornamental design for a decorative brushed steel scissor-shaped base for furniture, as shown and described.

**DESCRIPTION**

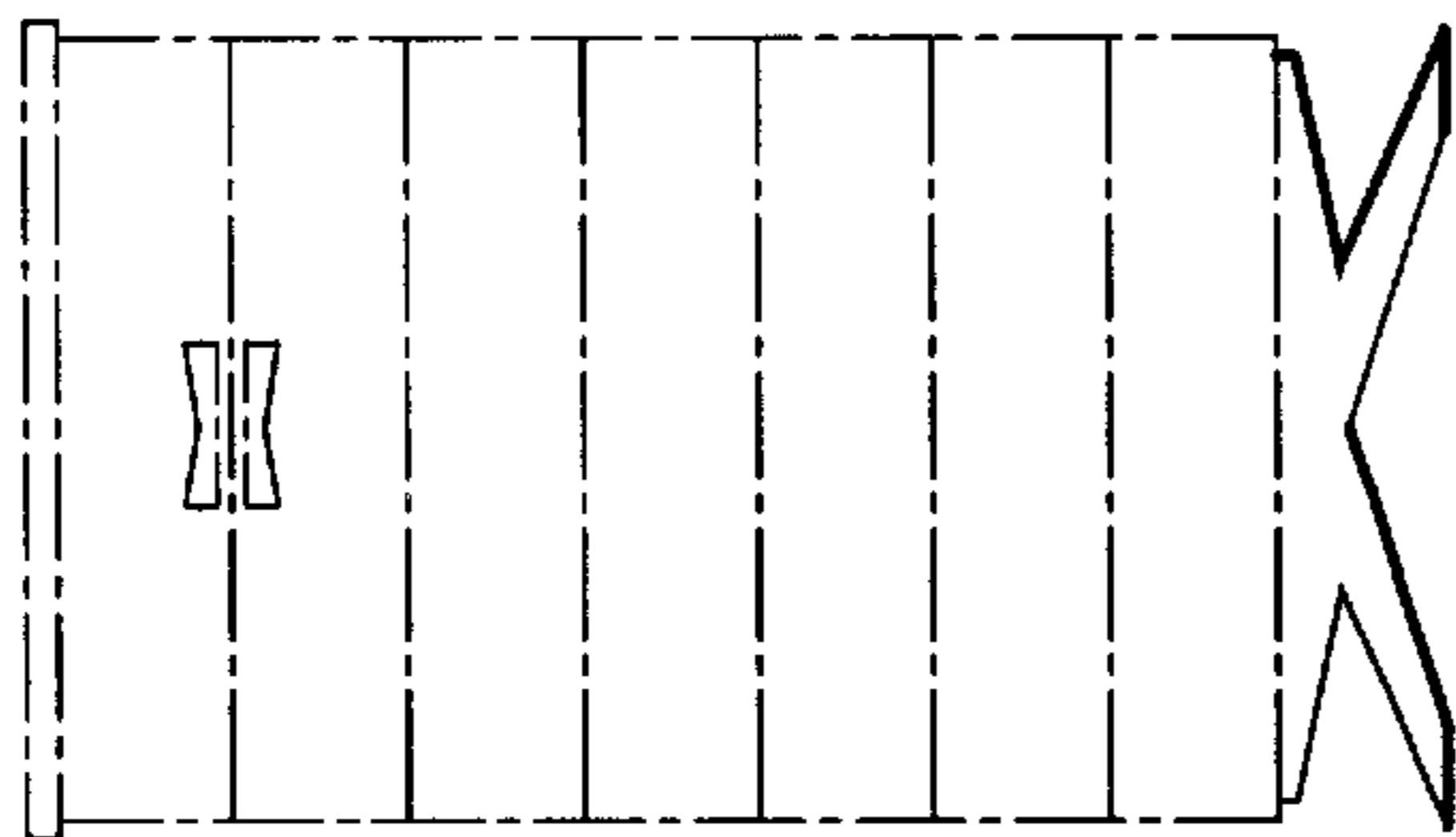

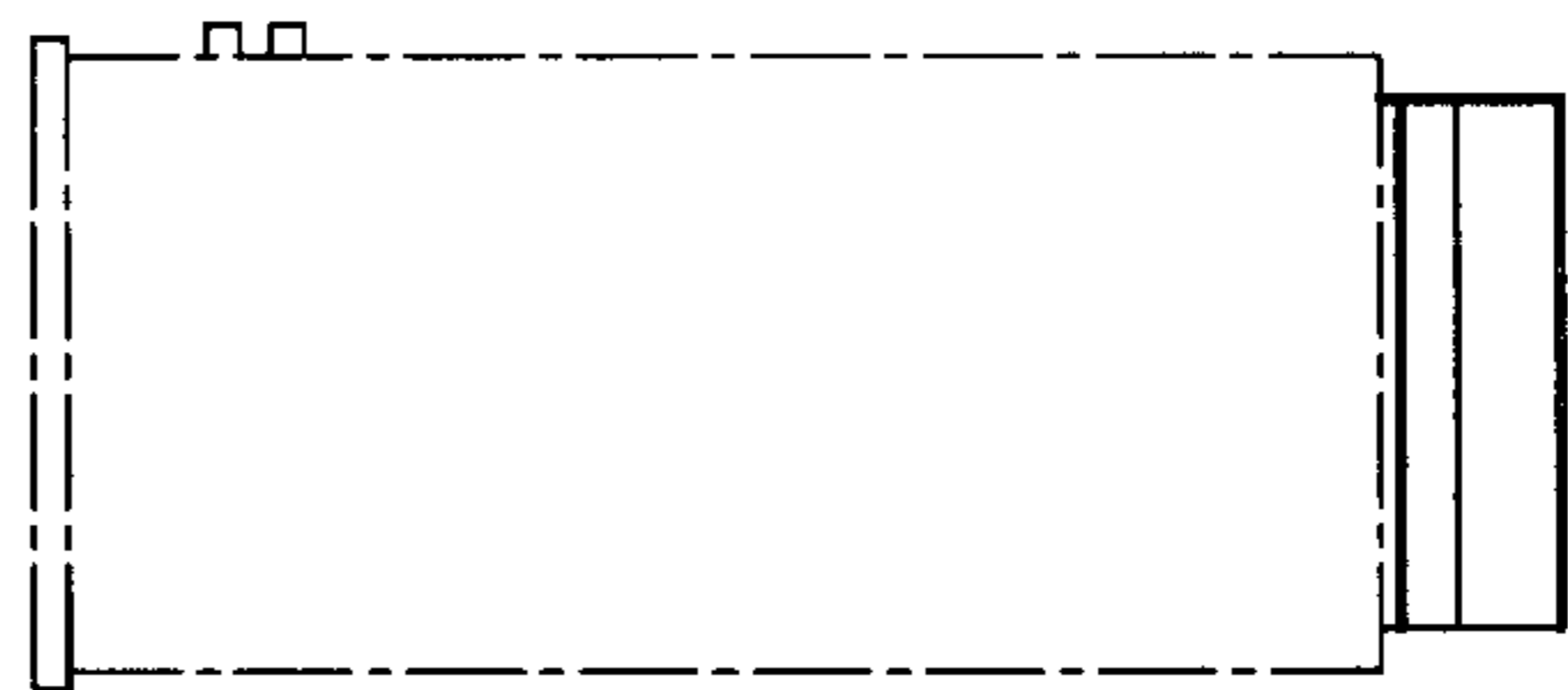

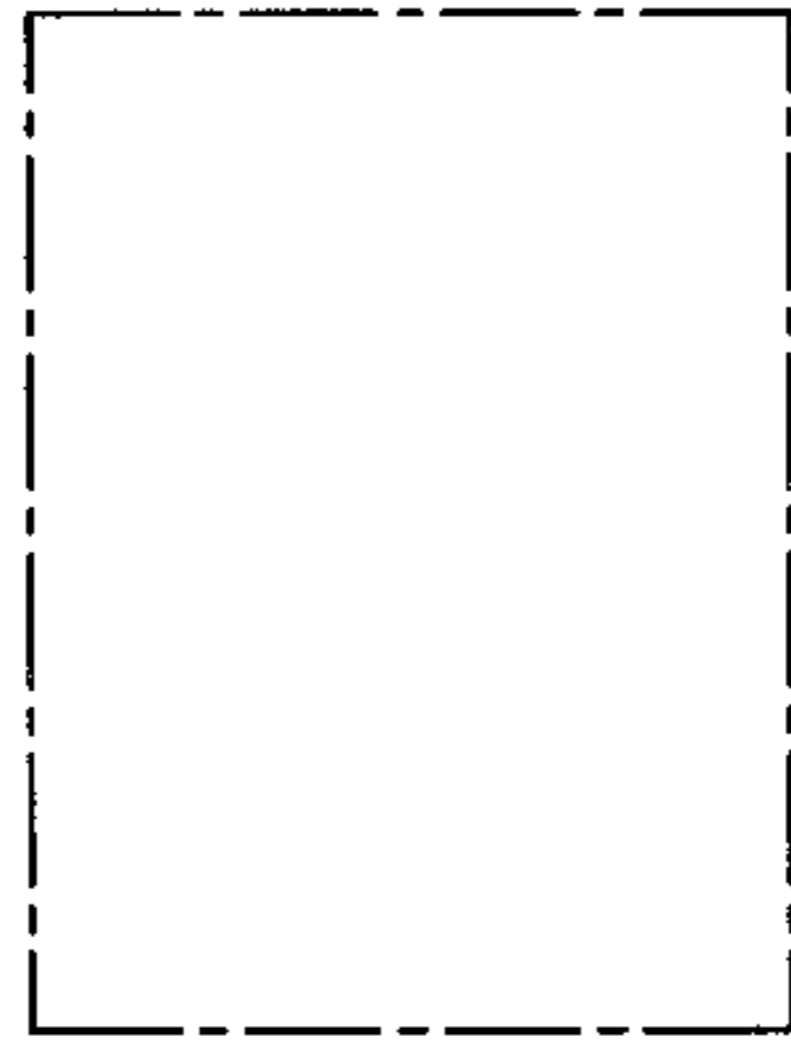

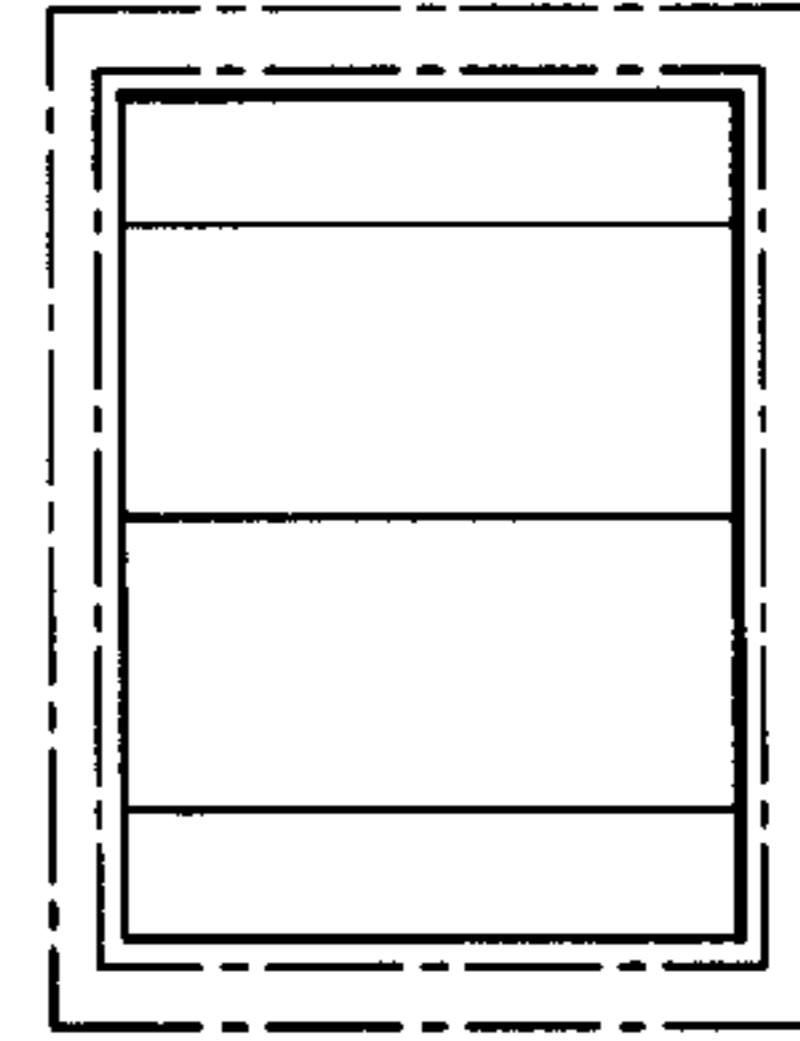

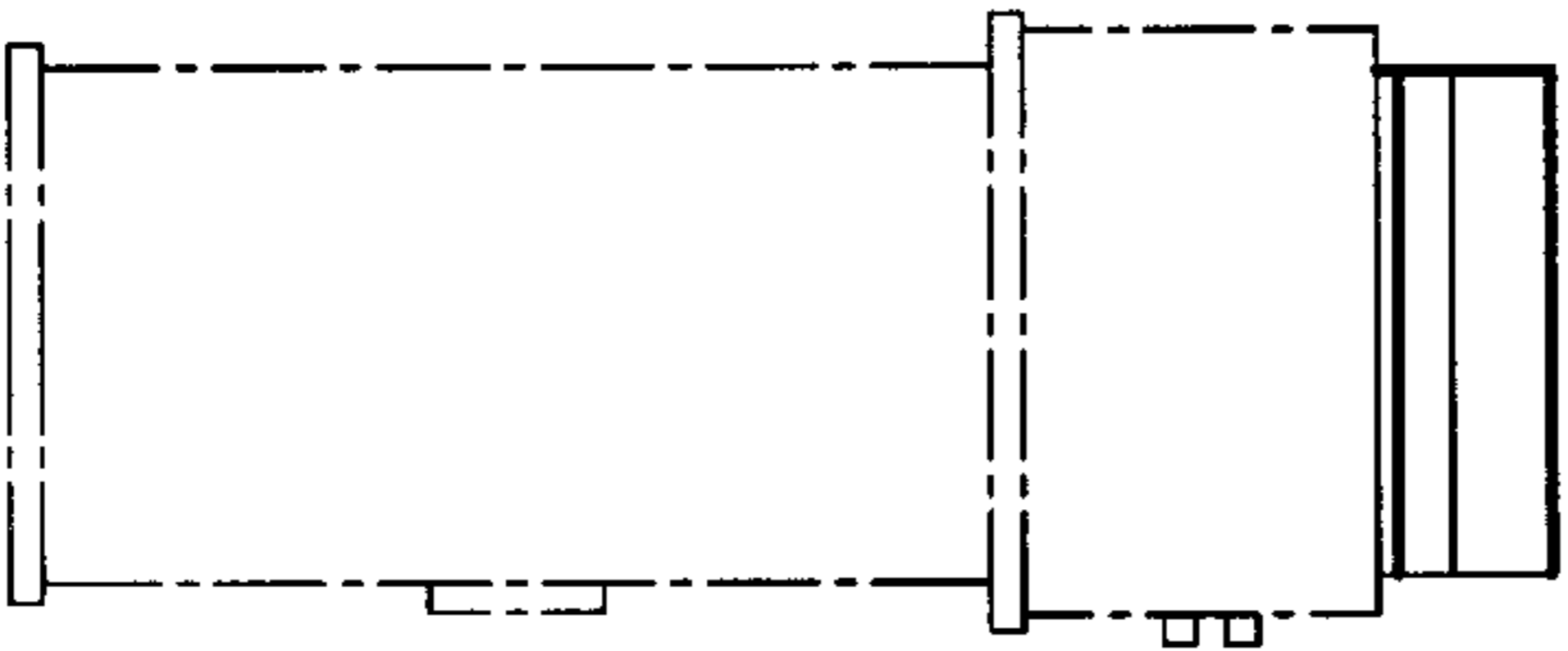

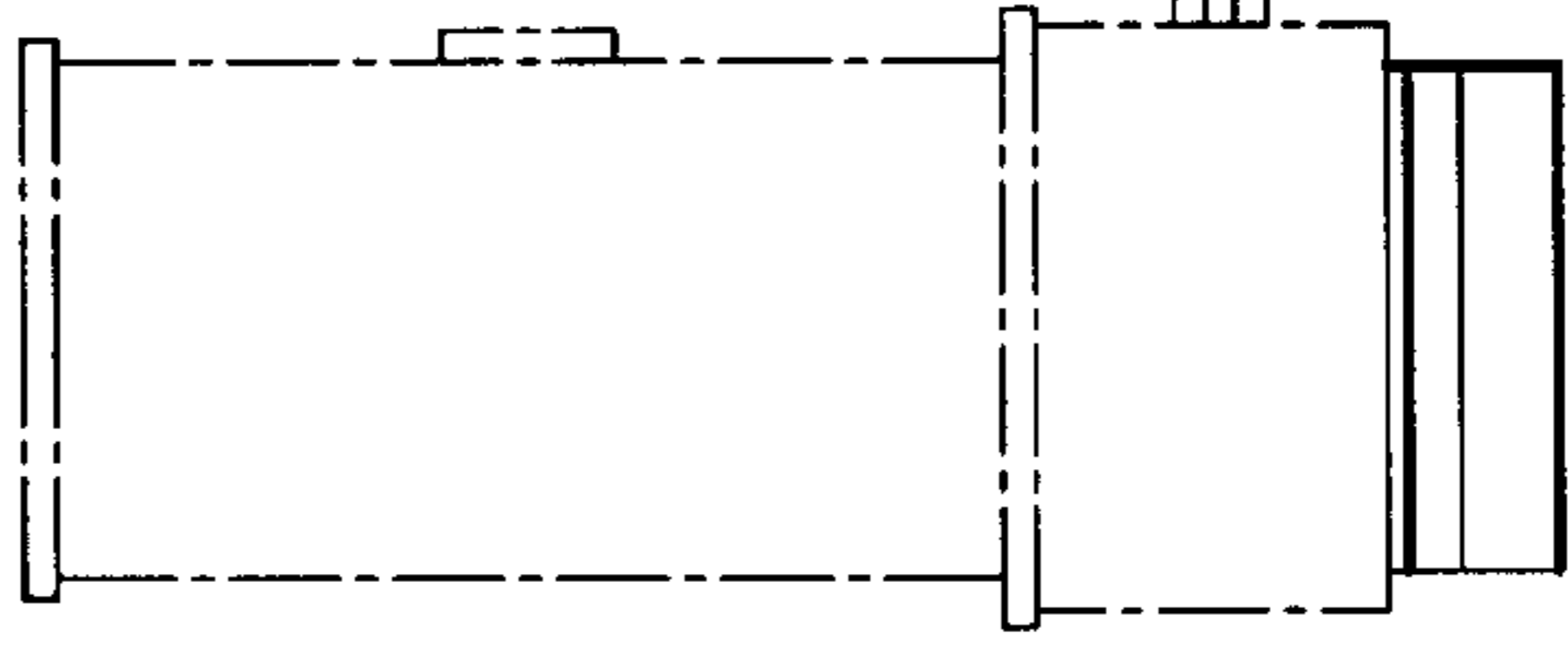

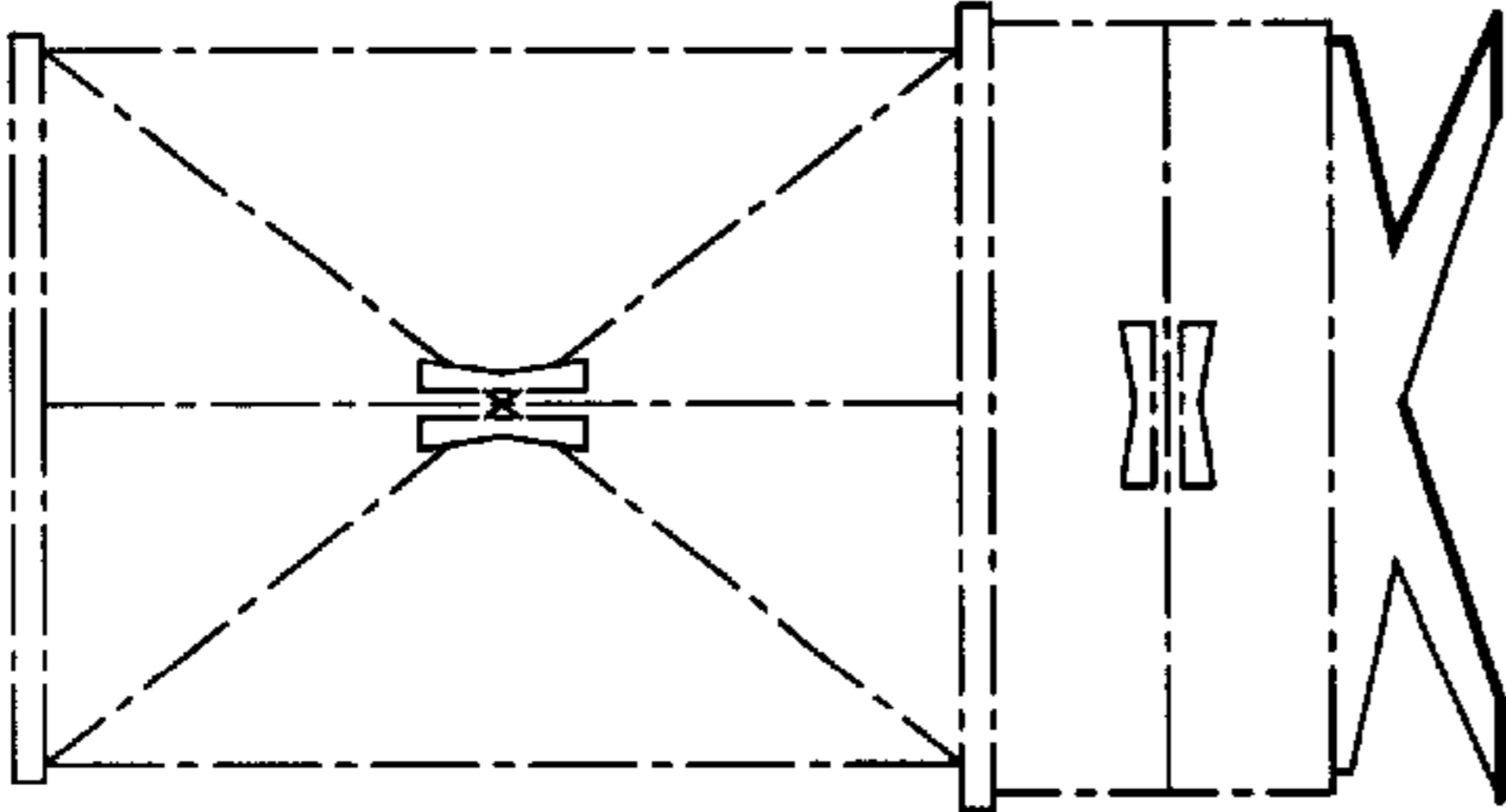

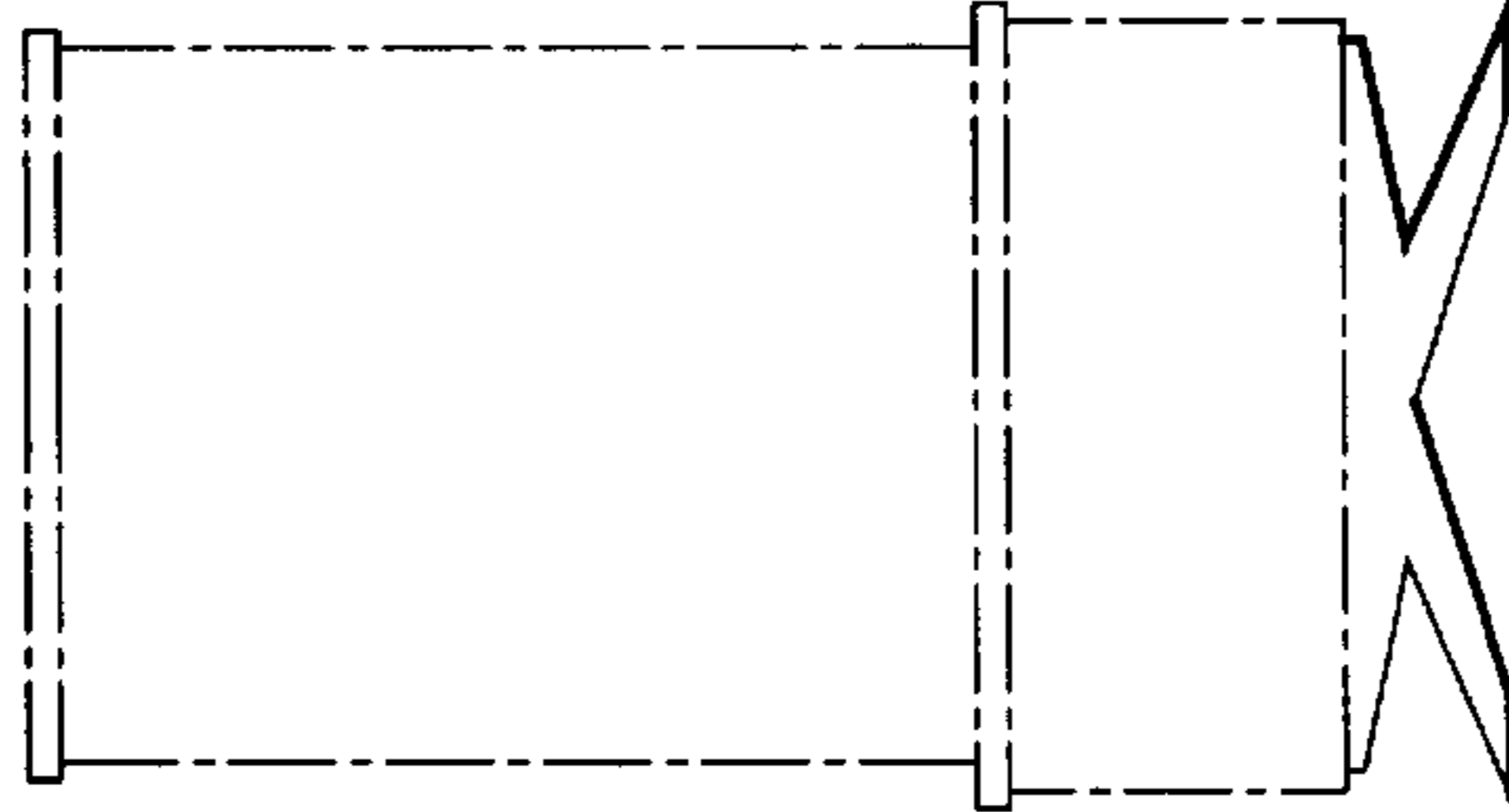

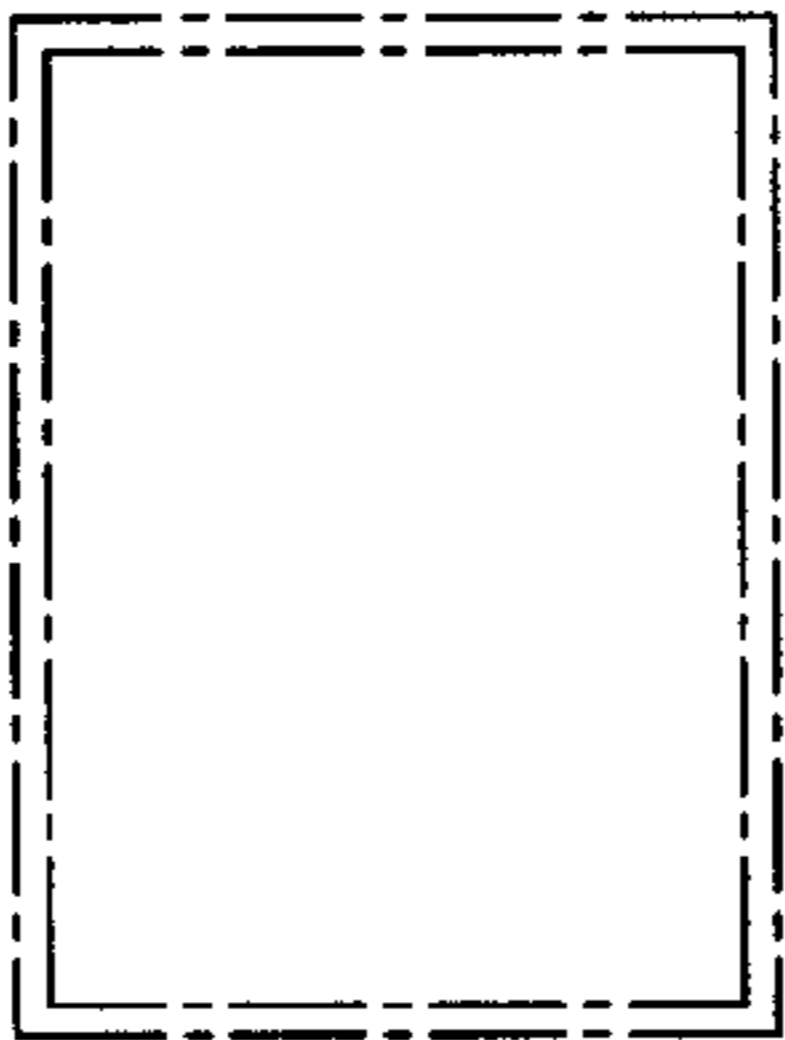

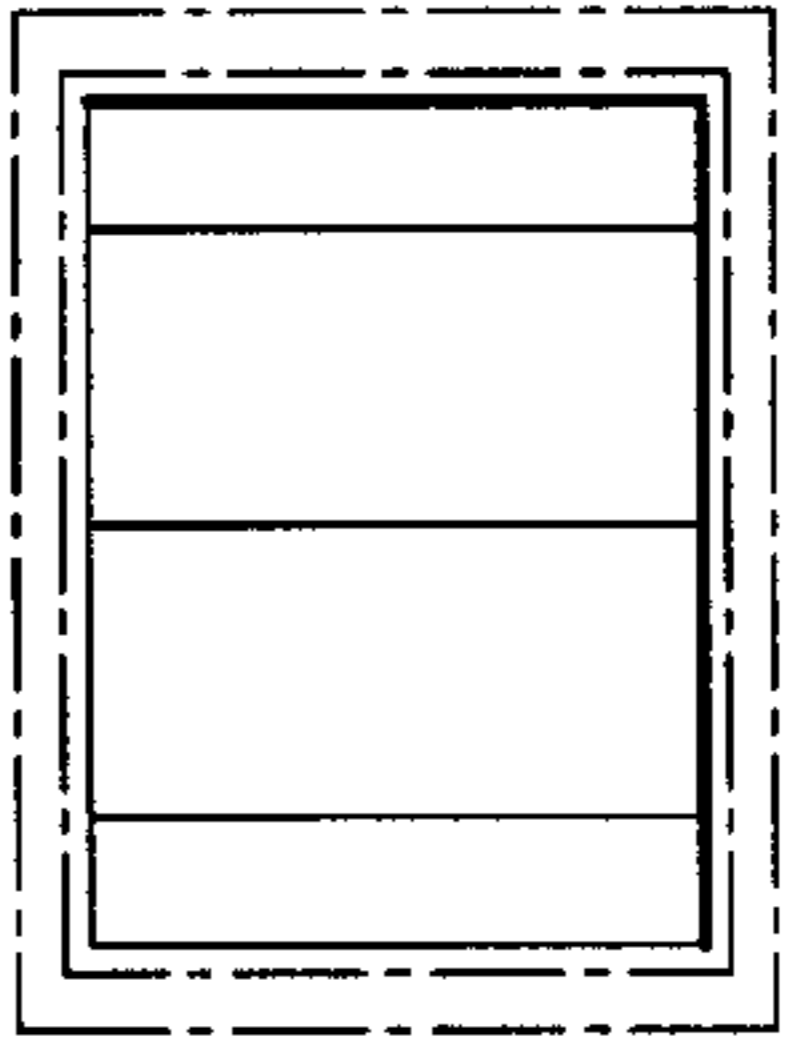

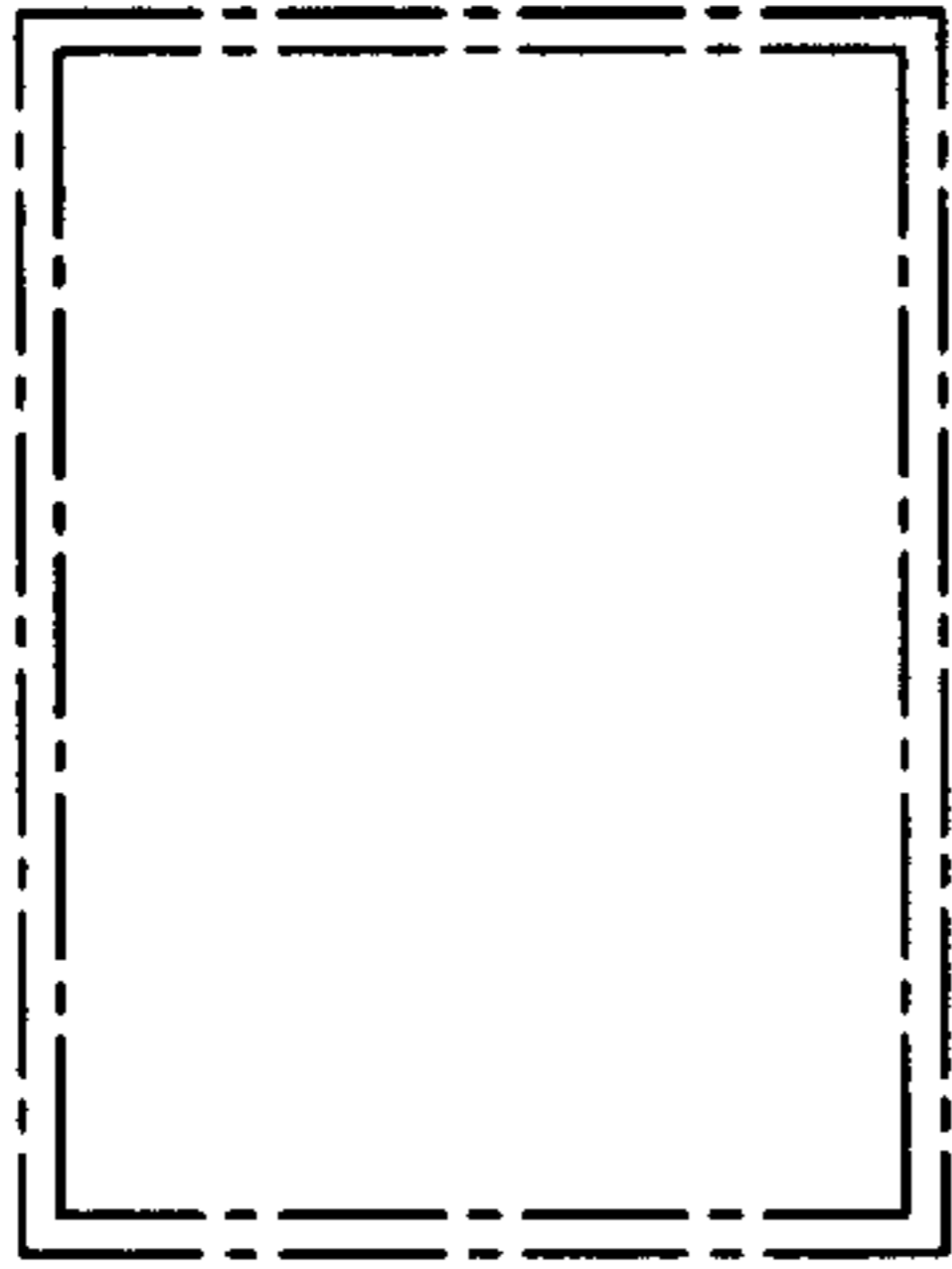

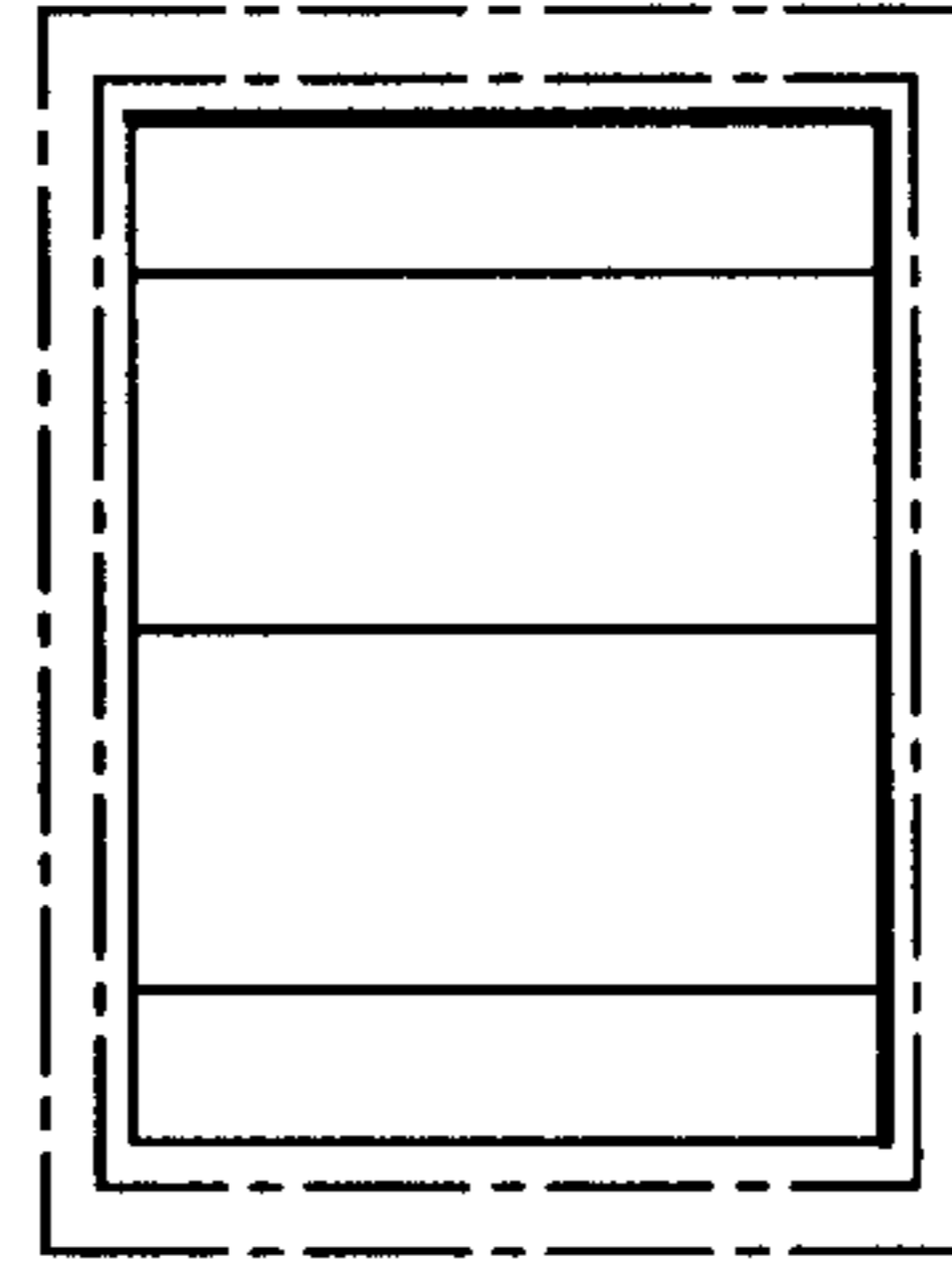

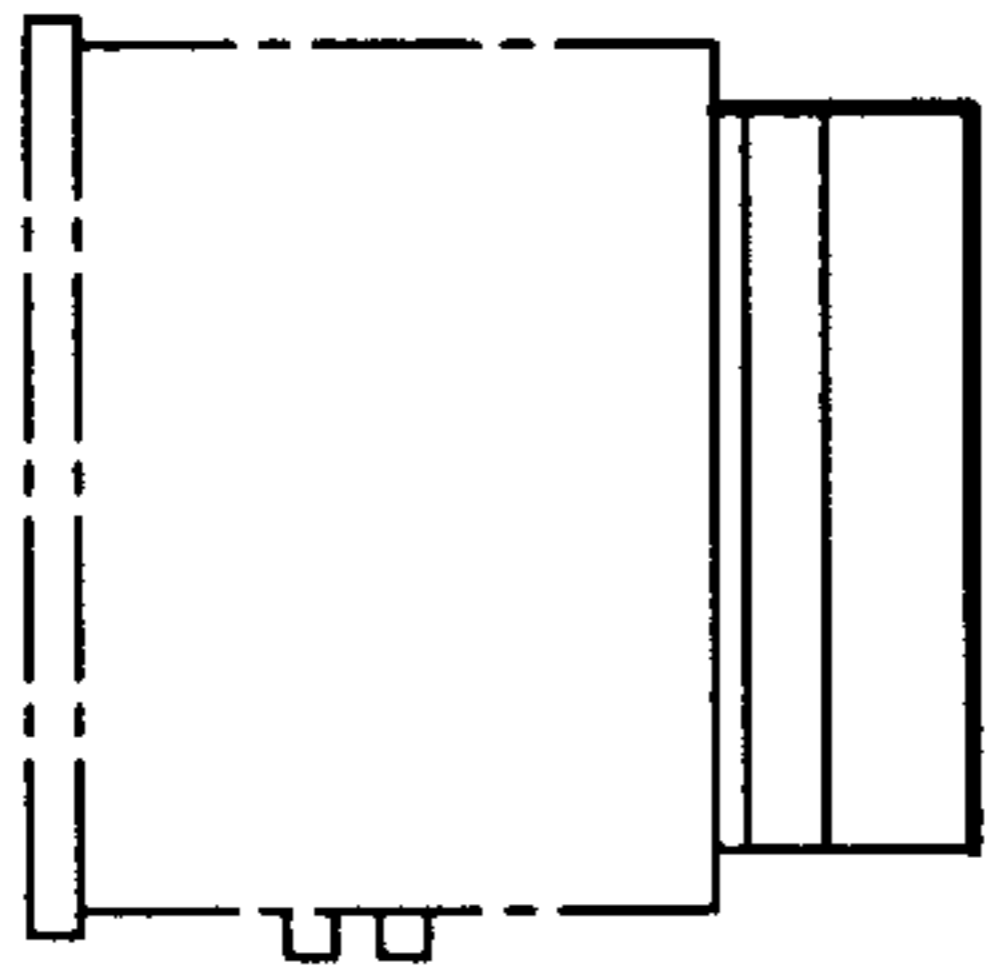

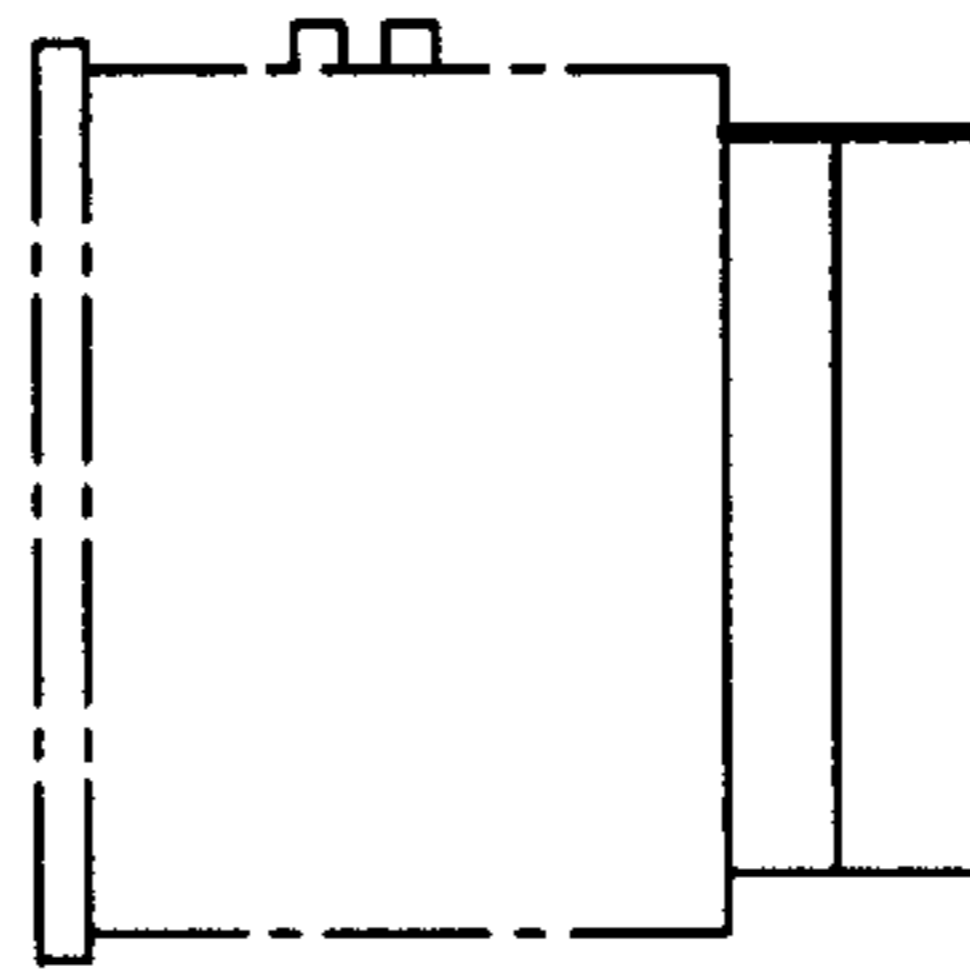

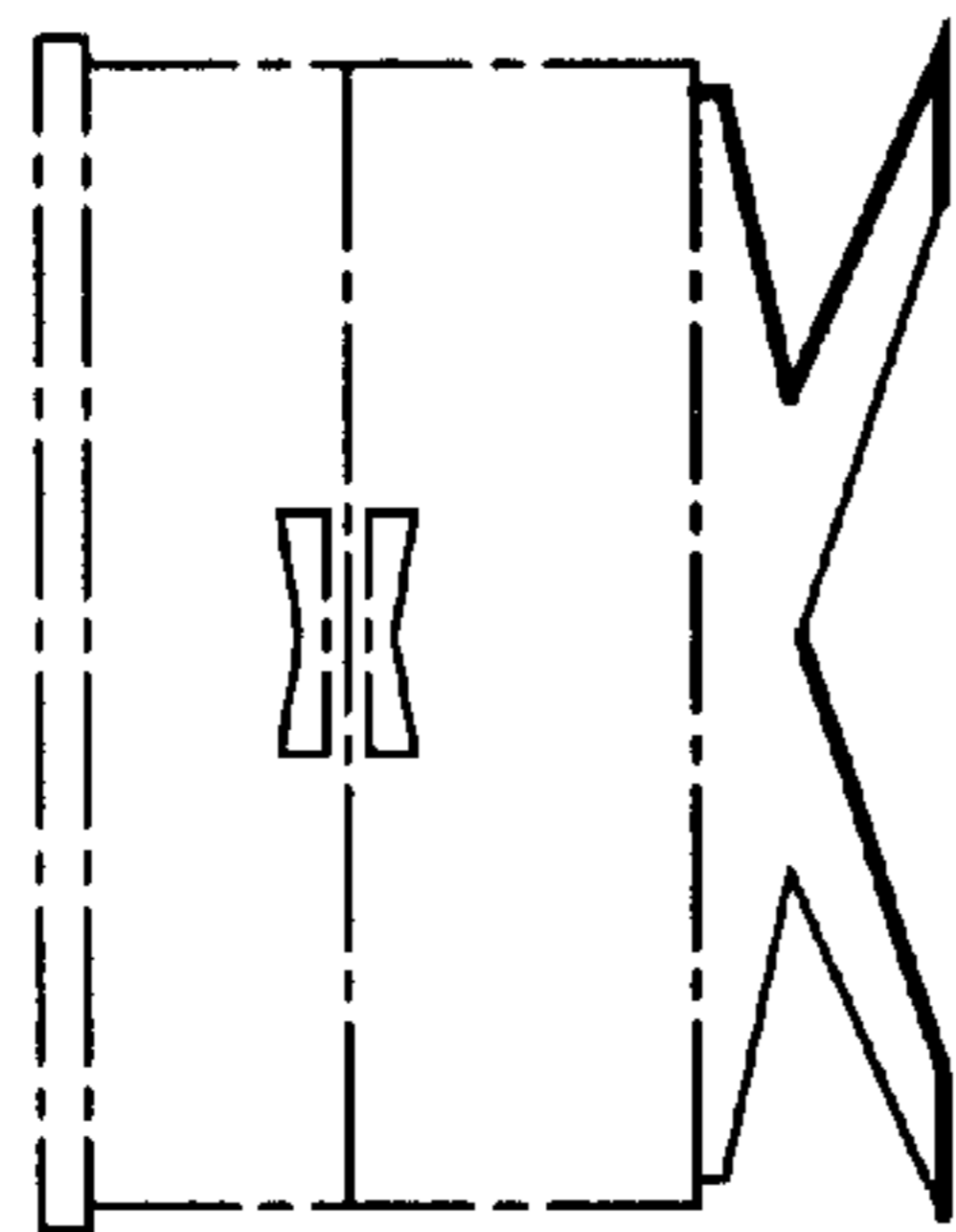

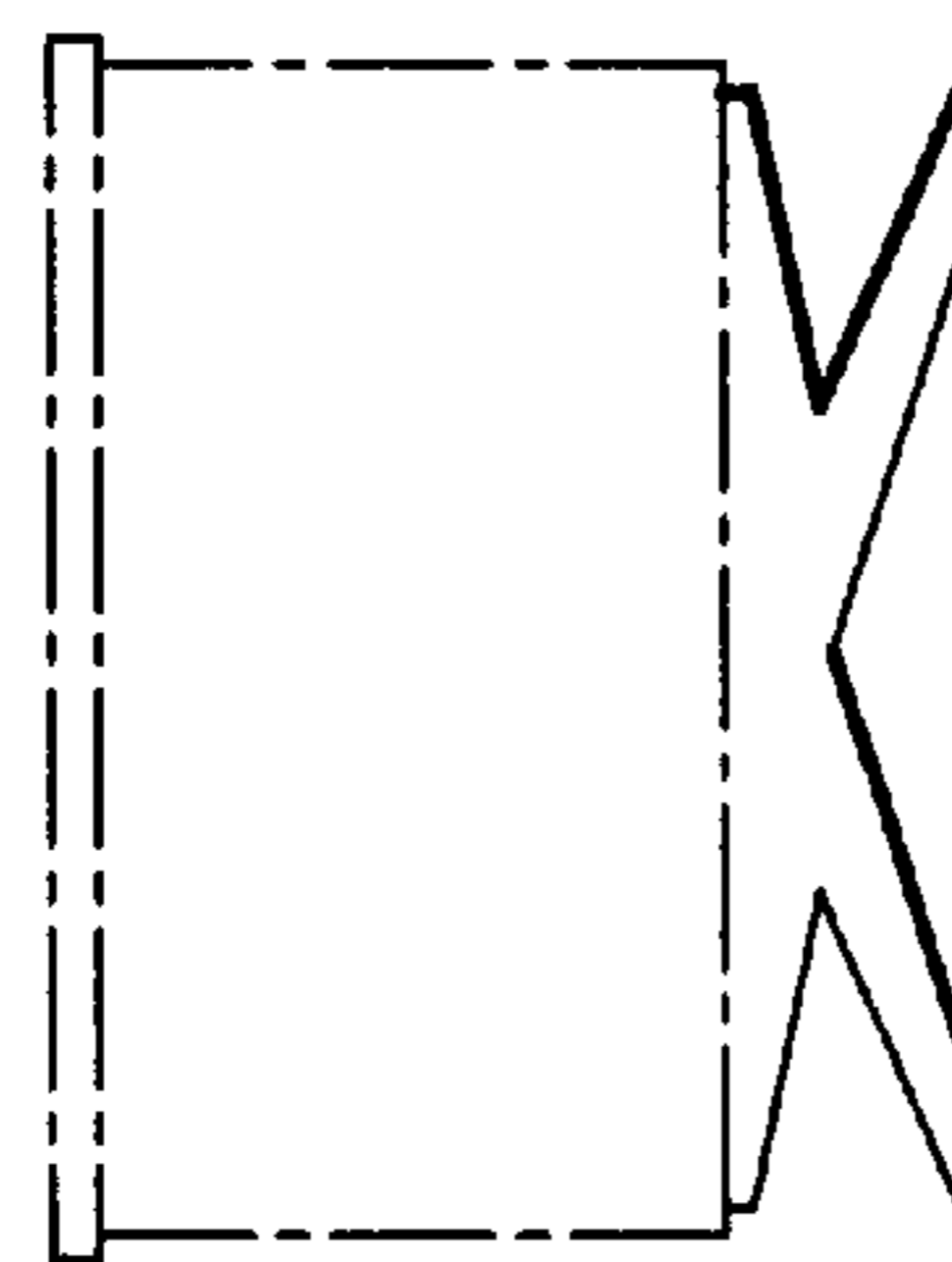

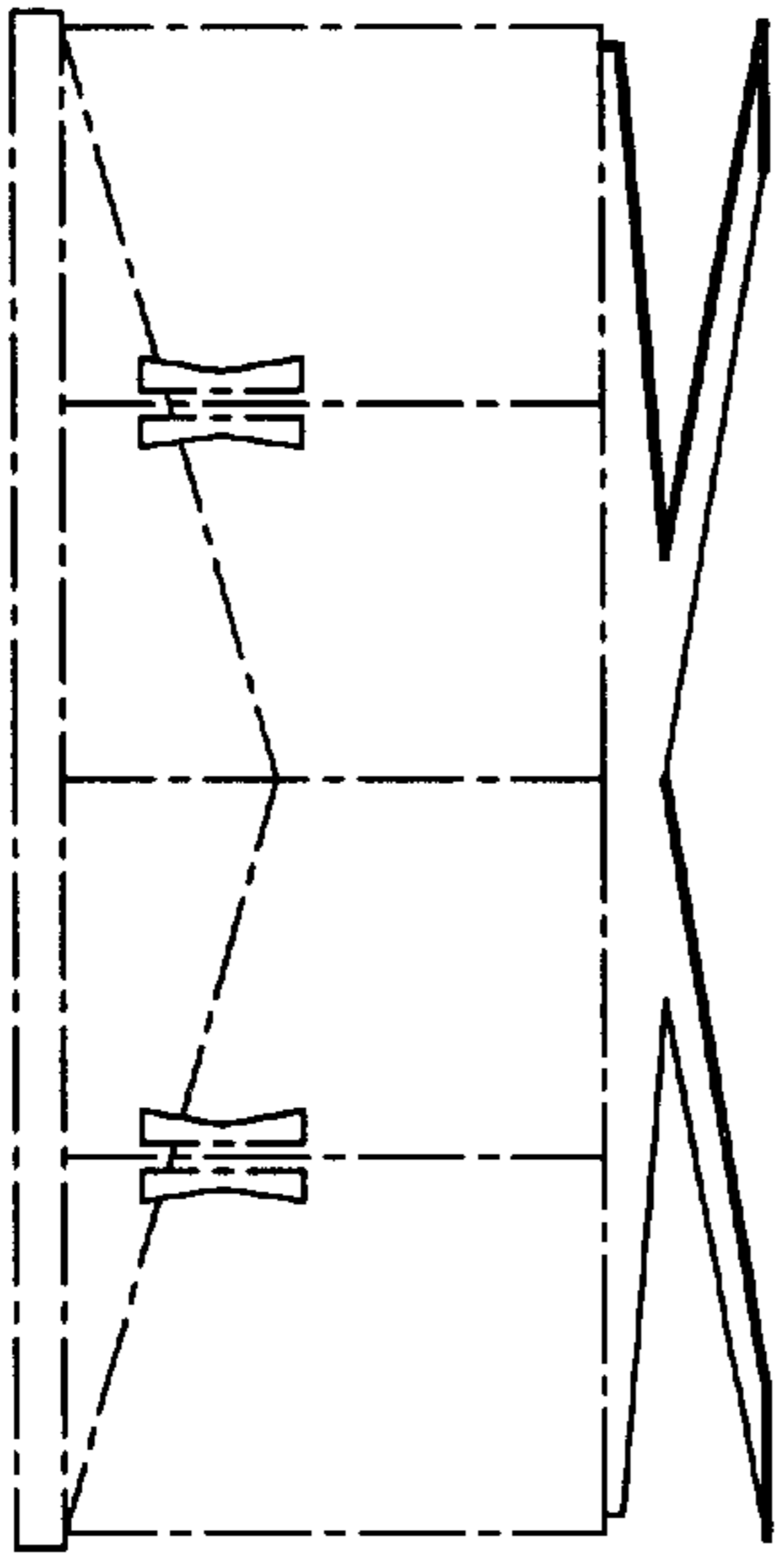

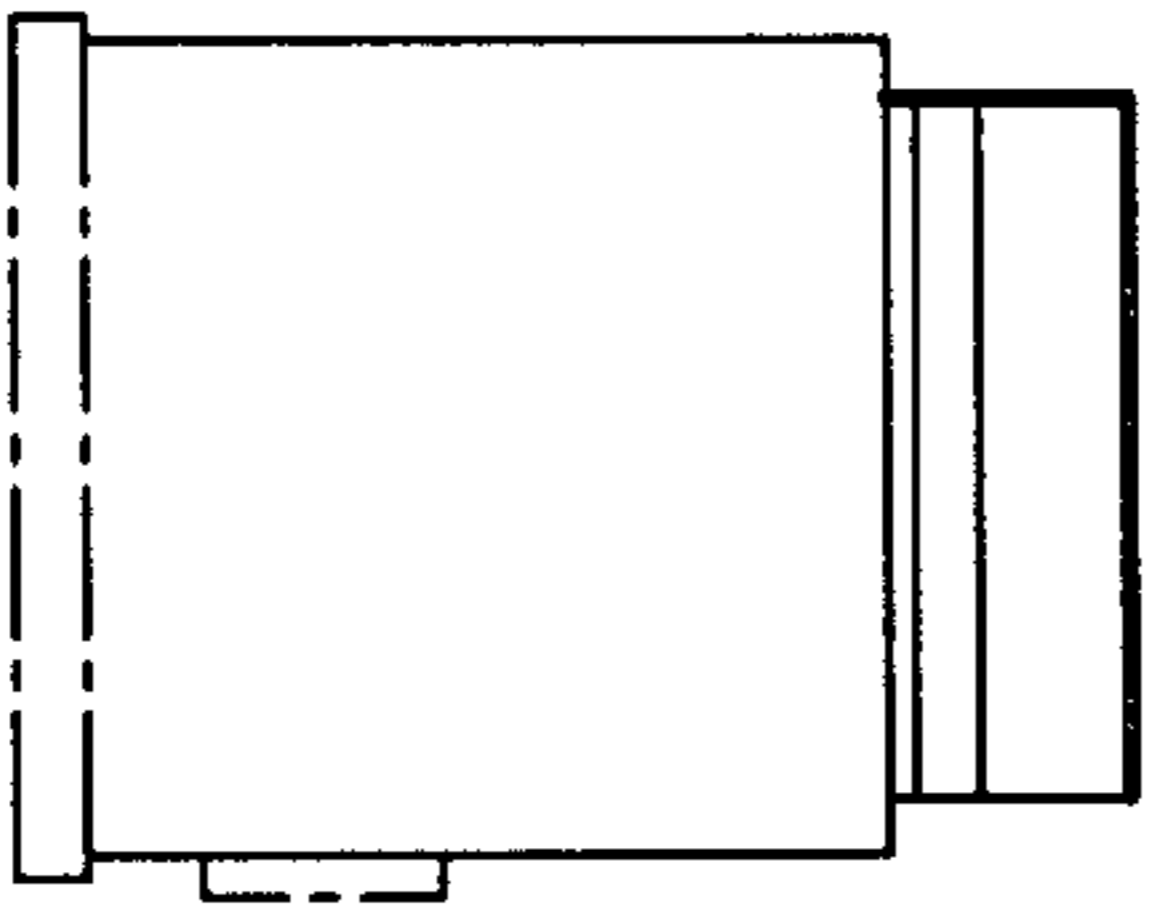

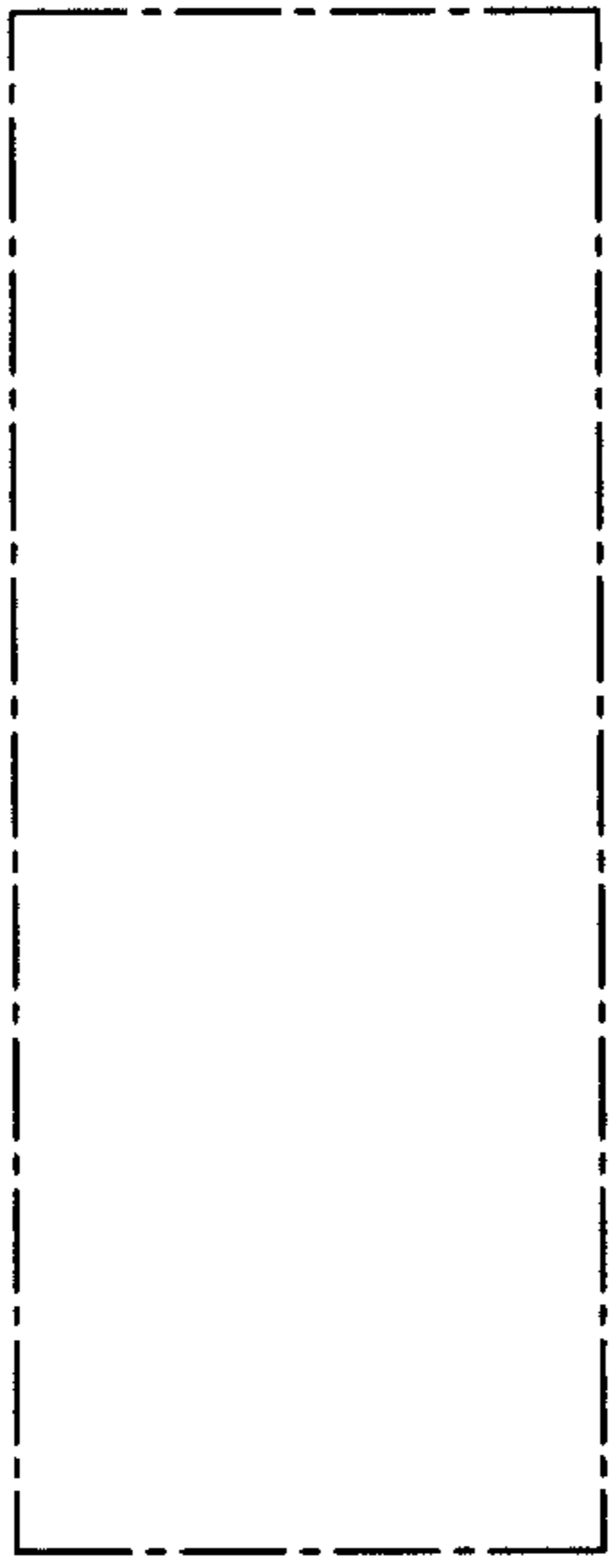

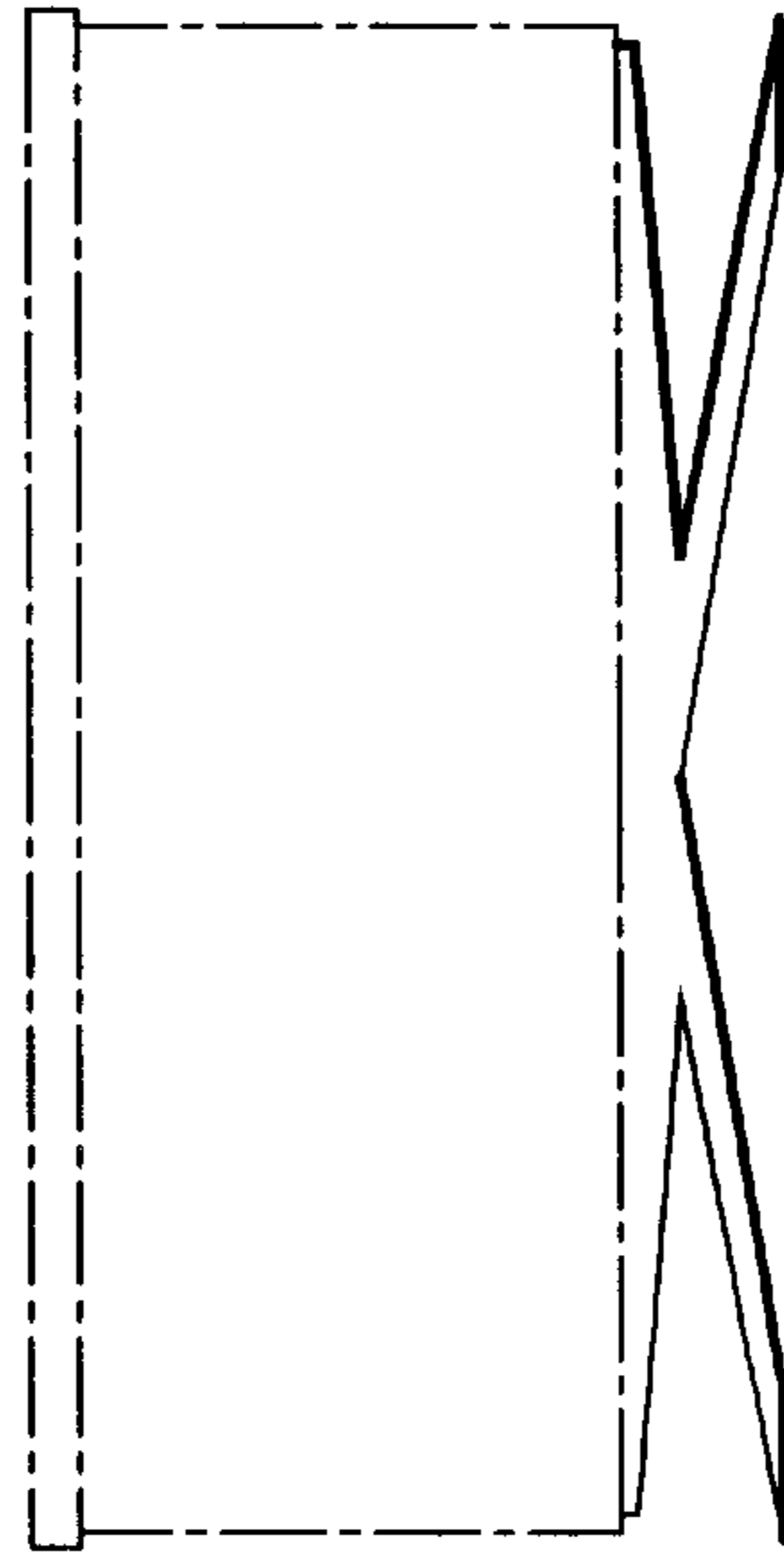

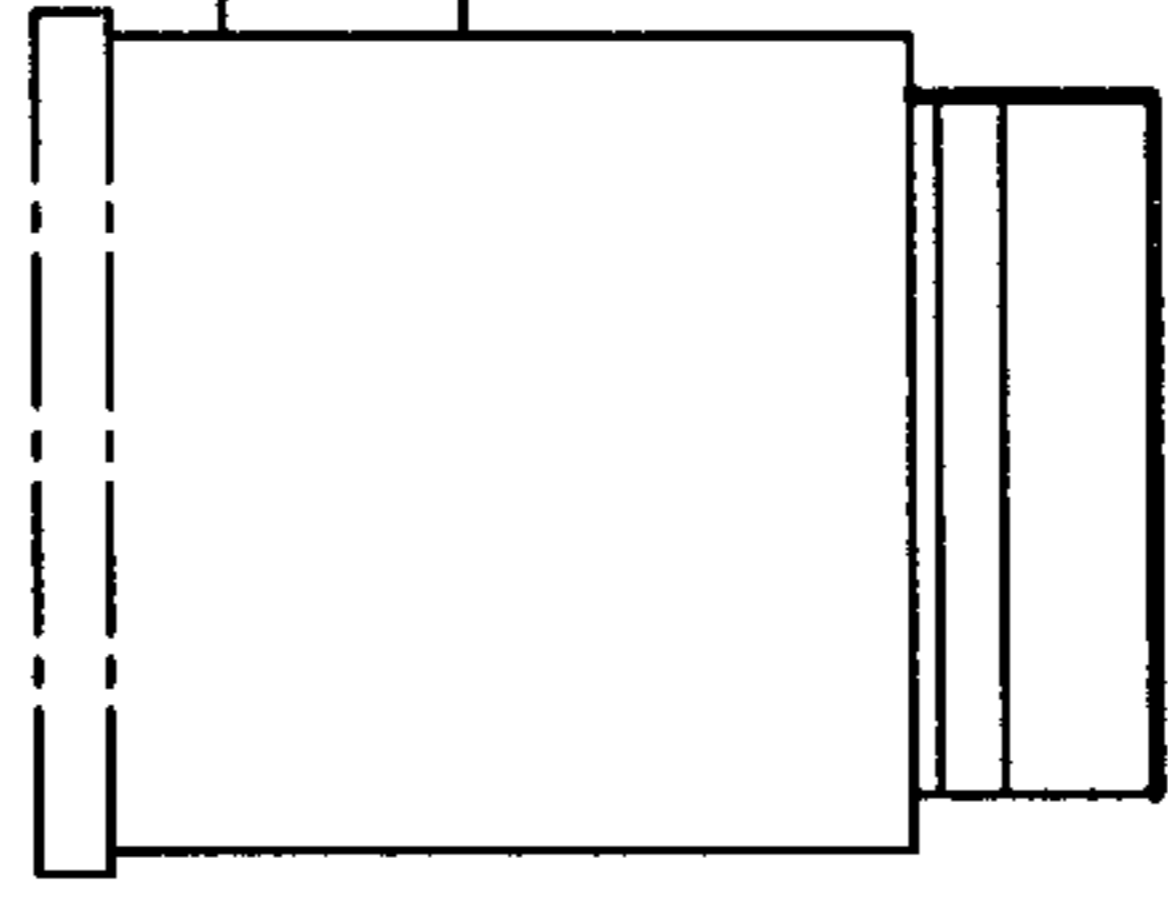

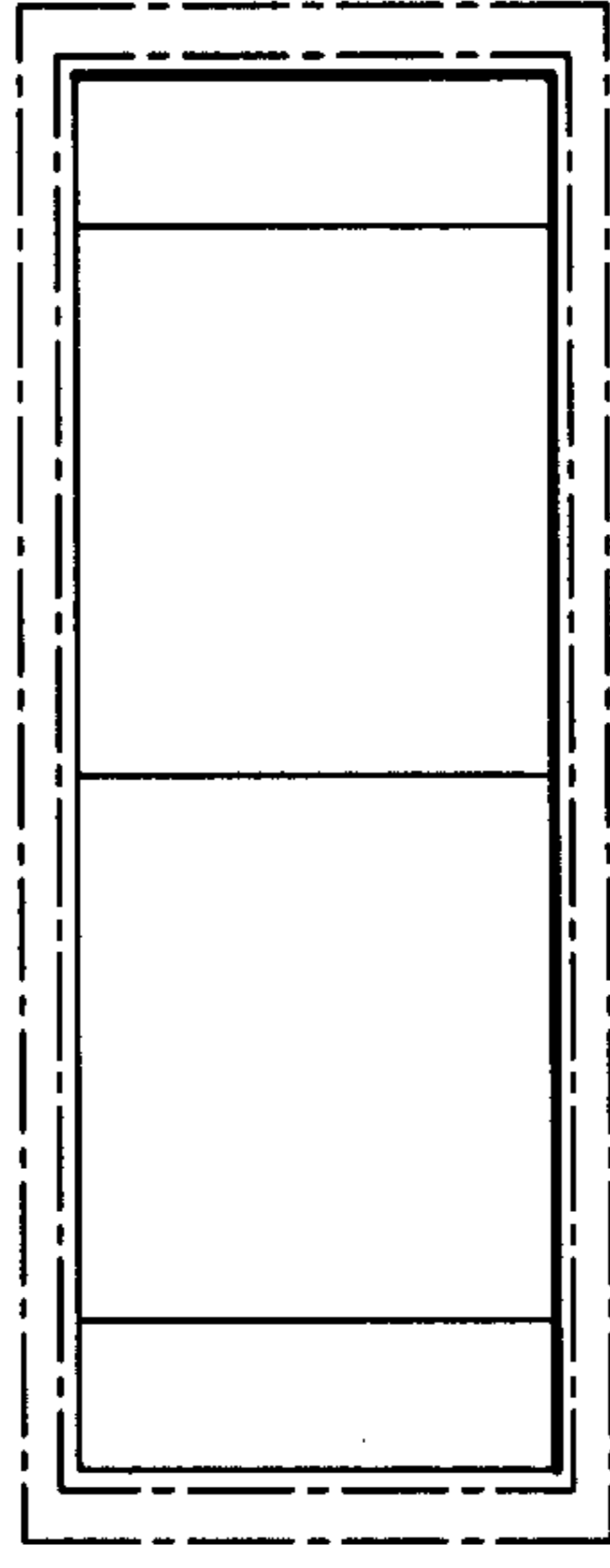

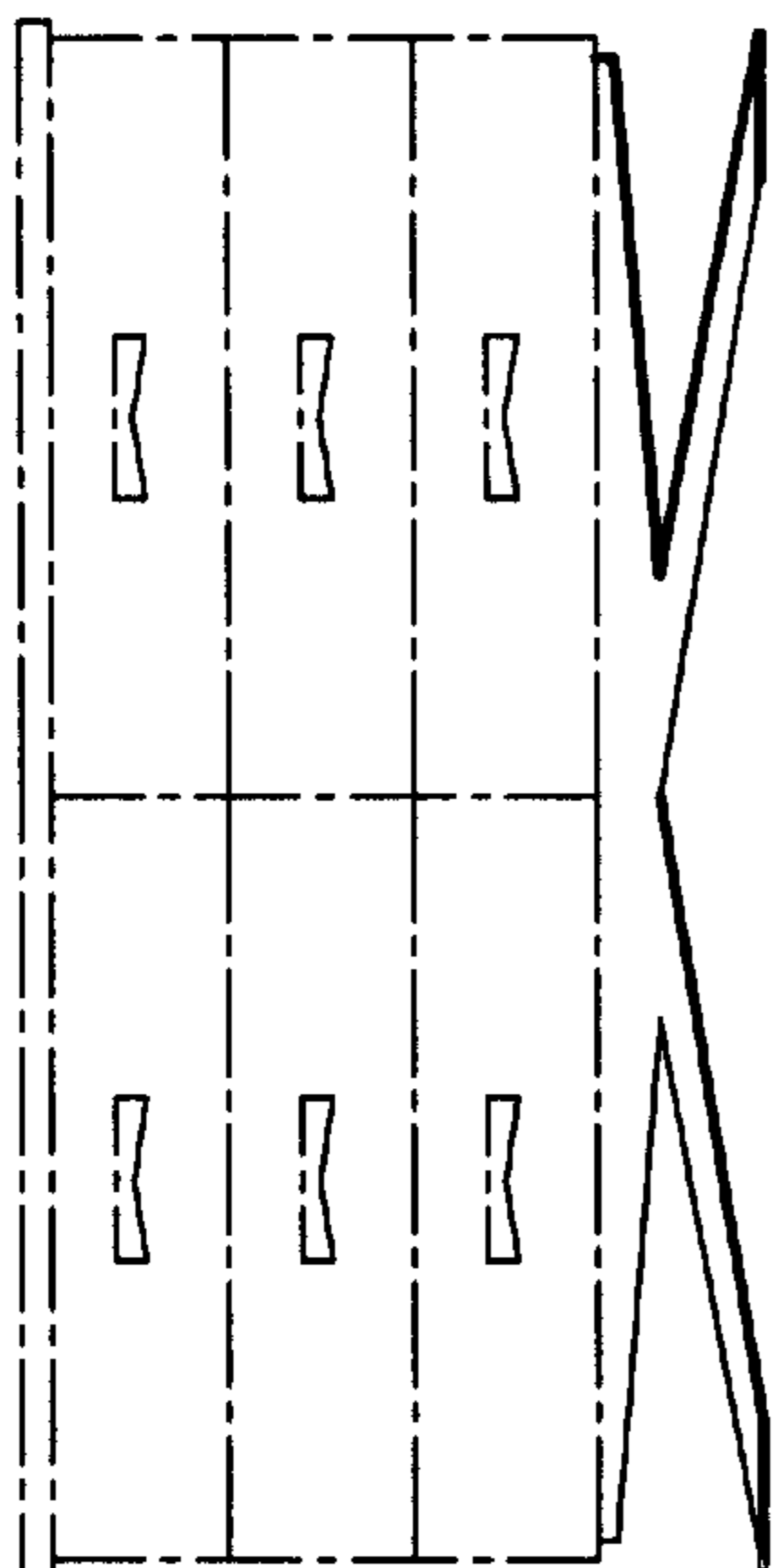

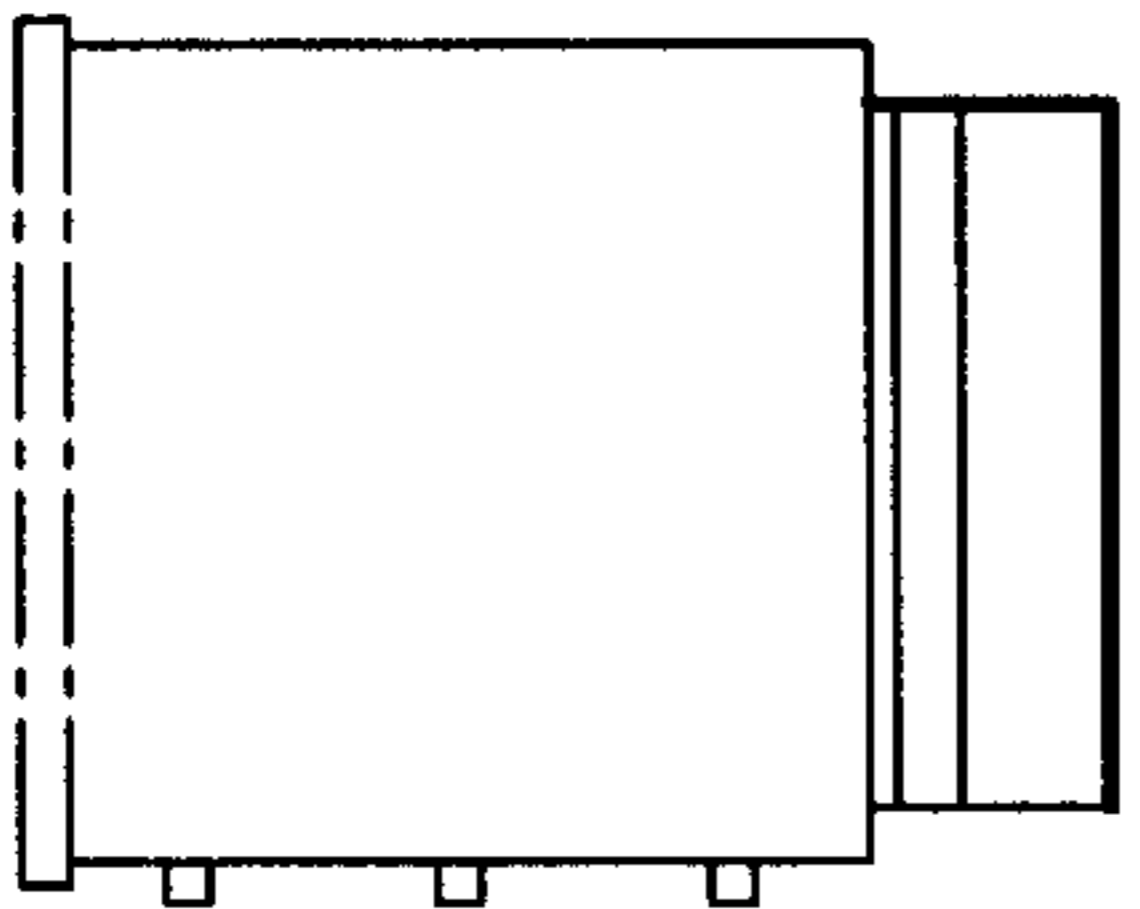

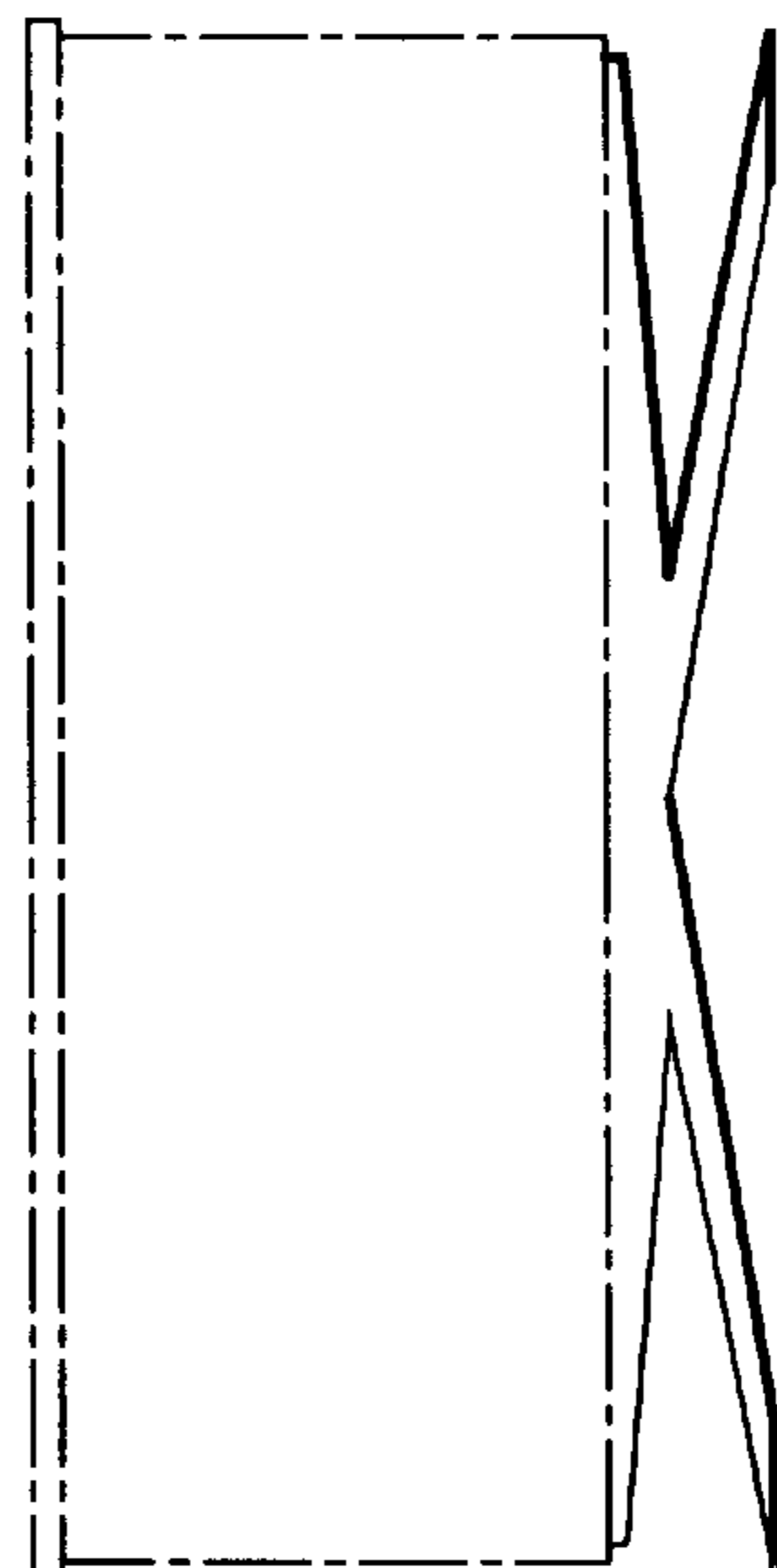

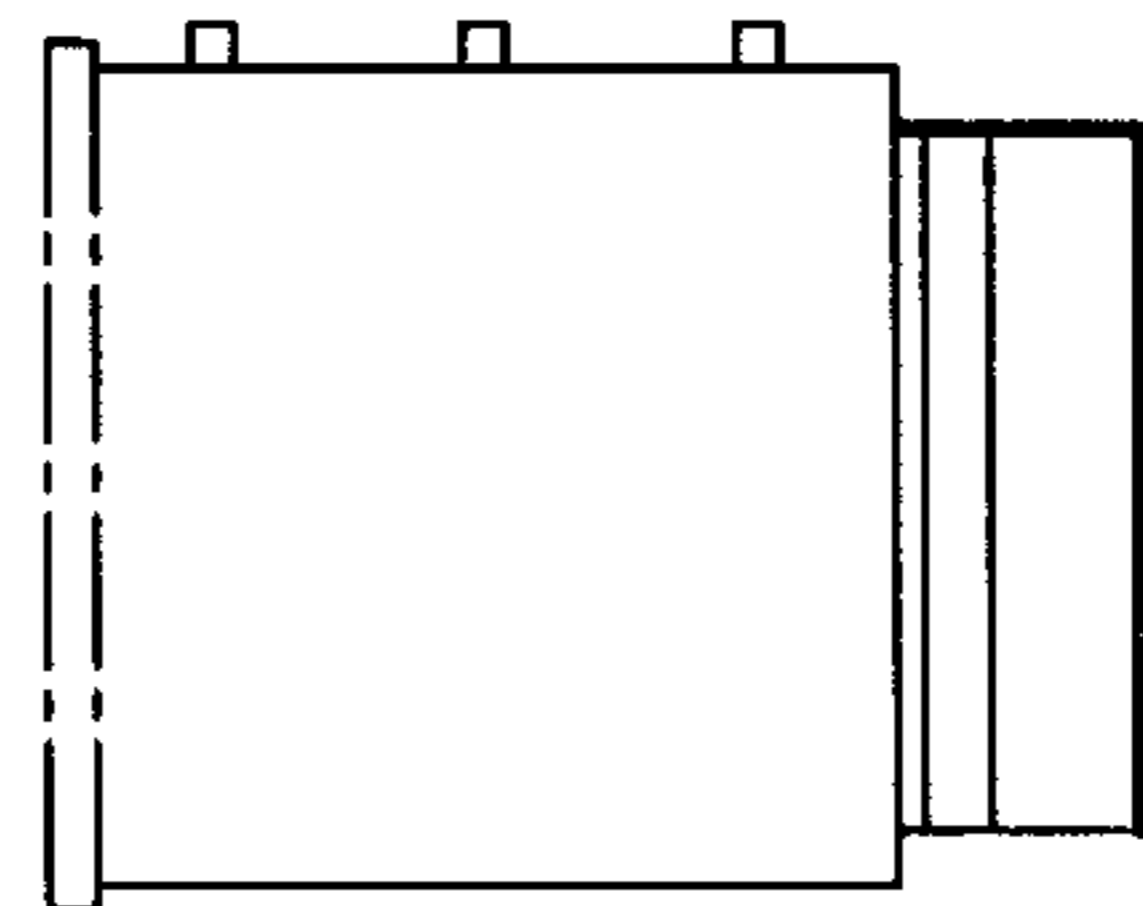

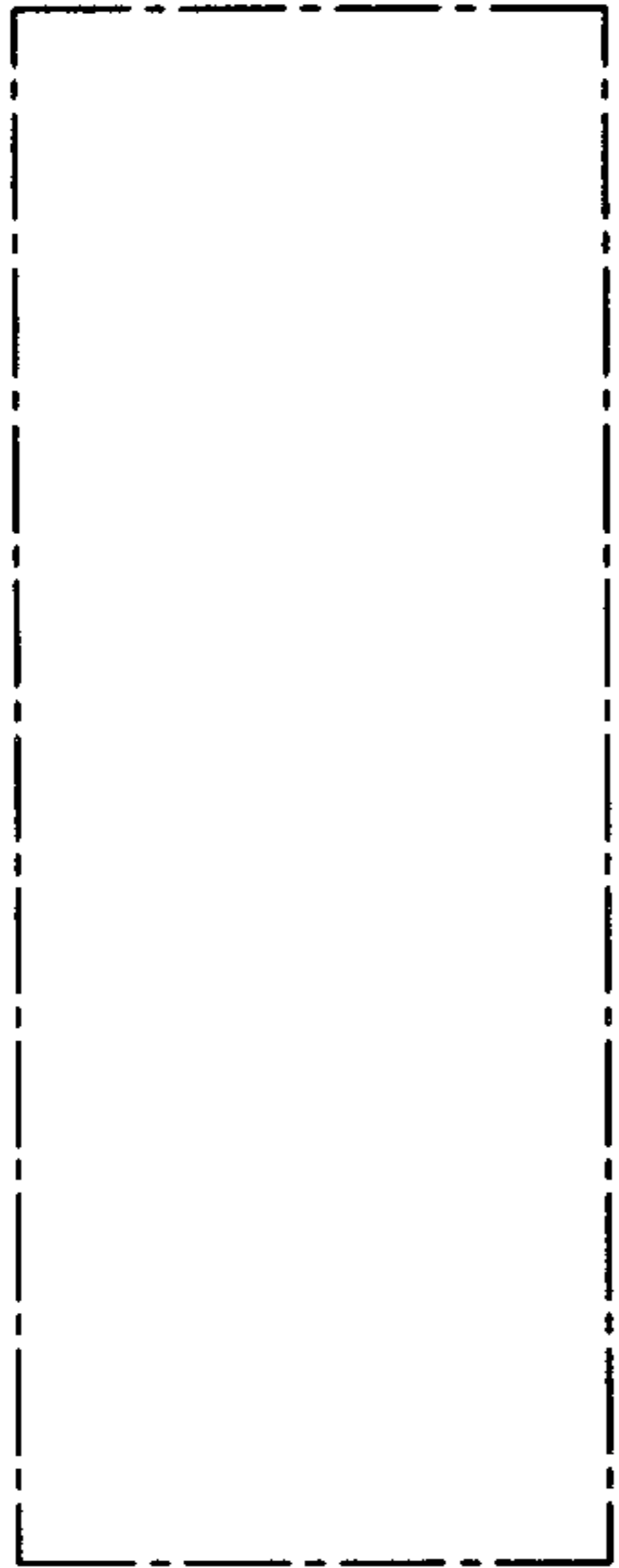

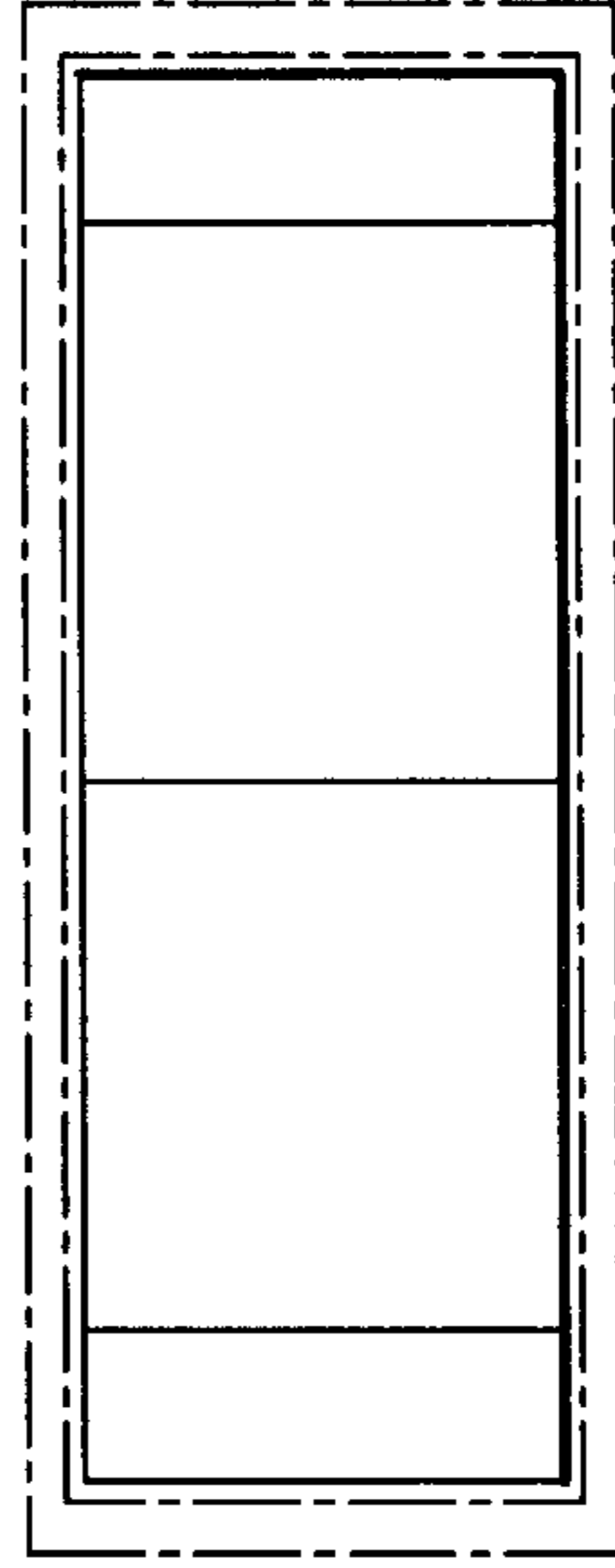
