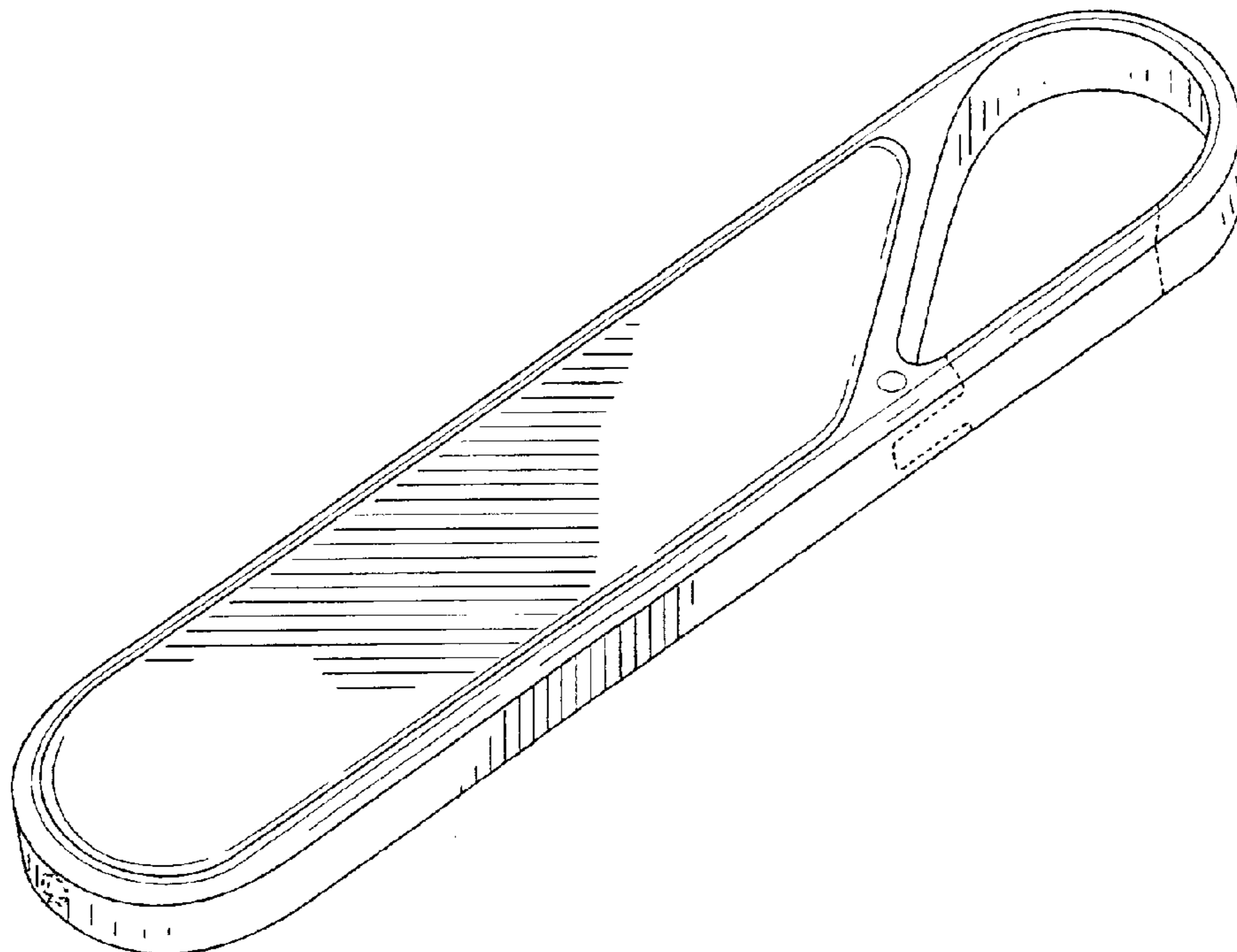
(57) **CLAIM**

The ornamental design for a tool housing with integral clip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tool housing with integral clip, showing my new design, a lighting element is indicated in dashed lines for environmental purposes only; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a front view thereof; FIG. 5 is a rear view thereof; FIG. 6 is a left side view thereof; FIG. 7 is a right side view thereof; FIG. 8 is an alternate perspective view of the tool housing with integral clip, wherein a retractable knife blade is indicated in dash lines for environmental purposes only; FIG. 9 is a top view of FIG. 8; FIG. 10 is a bottom view of FIG. 8; FIG. 11 is a front view of FIG. 8; FIG. 12 is a rear view of FIG. 8; FIG. 13 is a left side view of FIG. 8; and, FIG. 14 is a right side view of FIG. 8. The subject matter illustrated in dashed lines in FIGS. 1 through 14 has been shown for illustrative purposes only and forms no part of the claimed design.

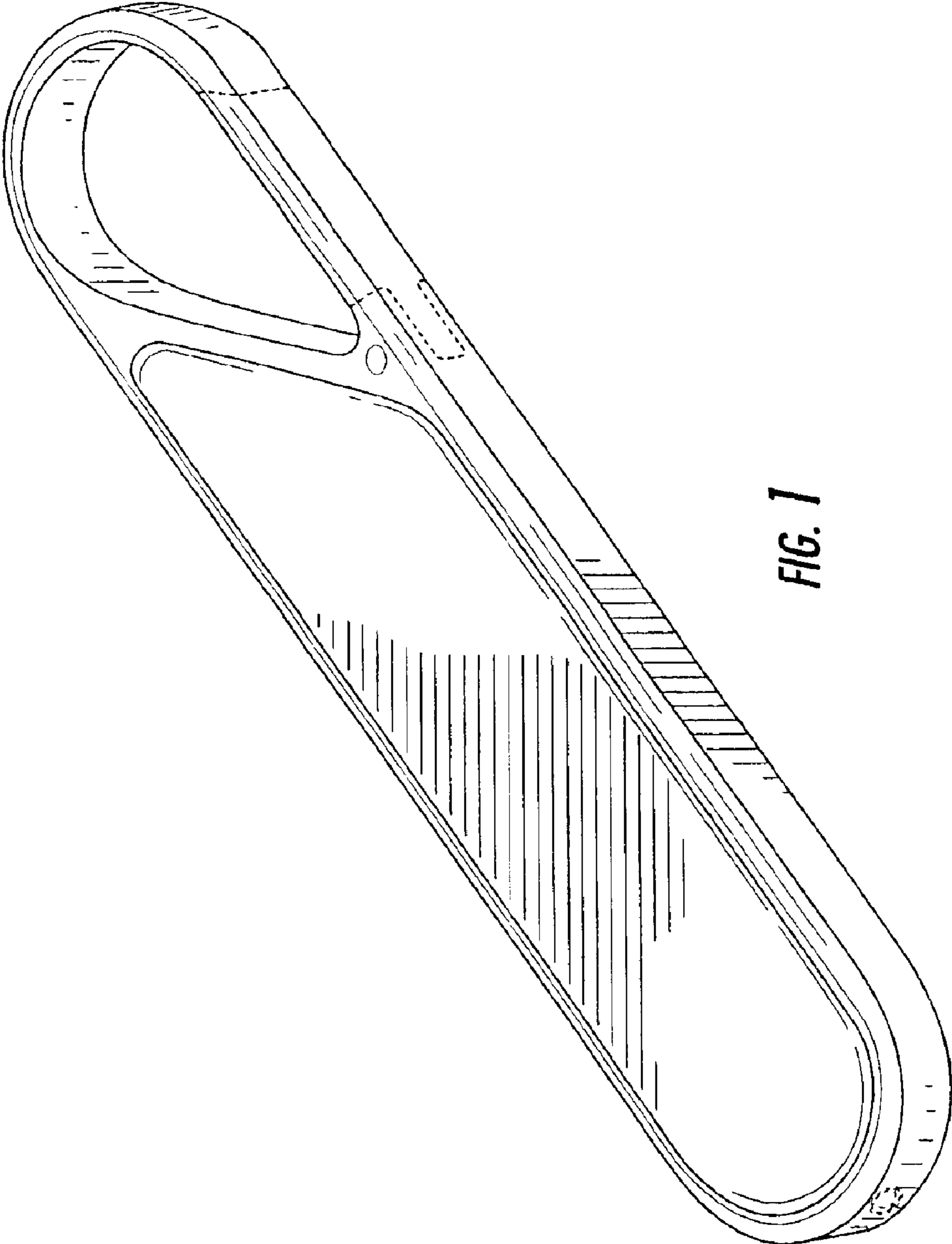

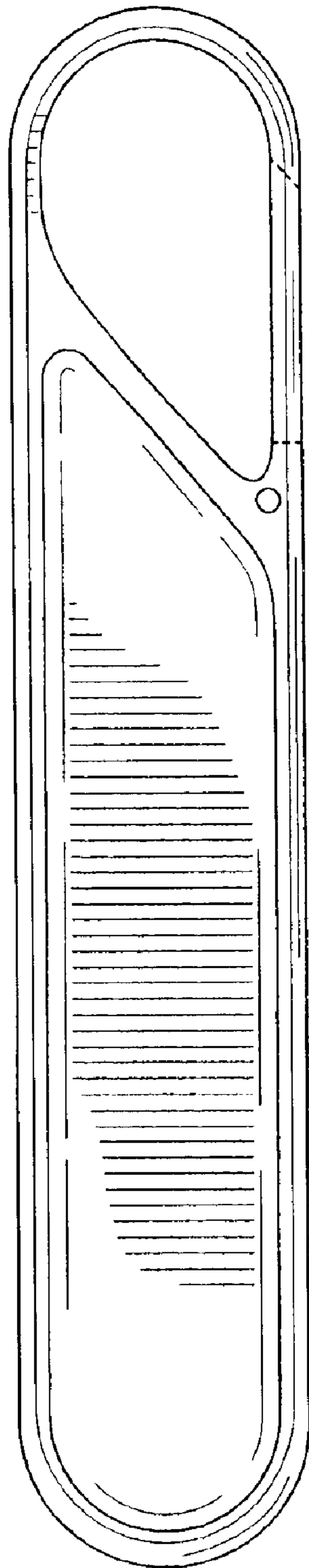

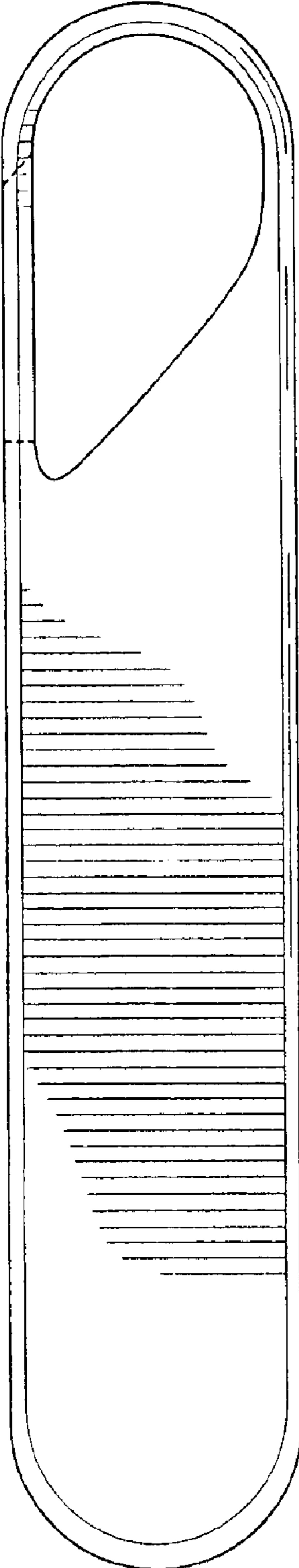

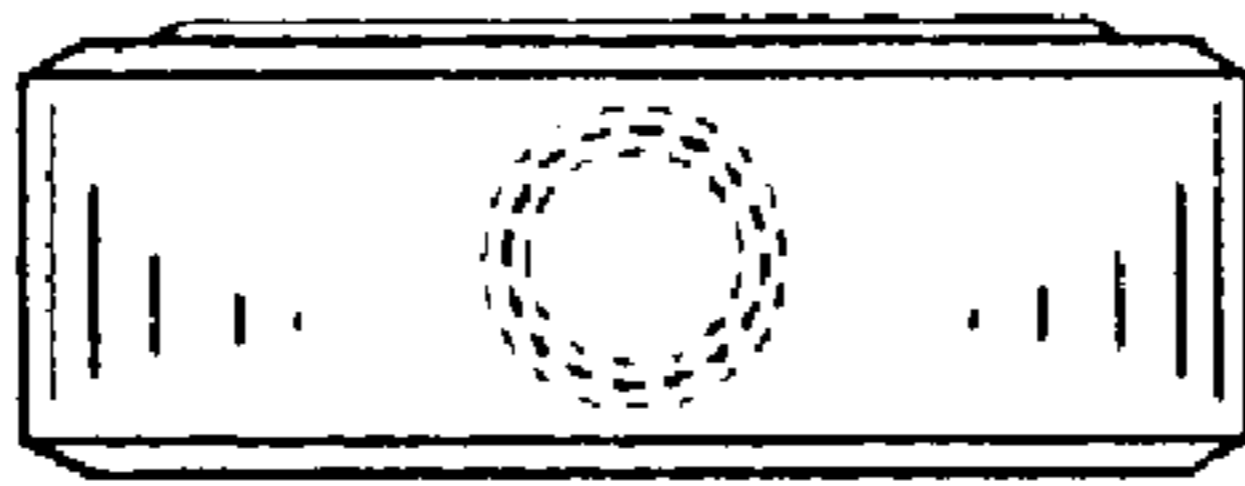

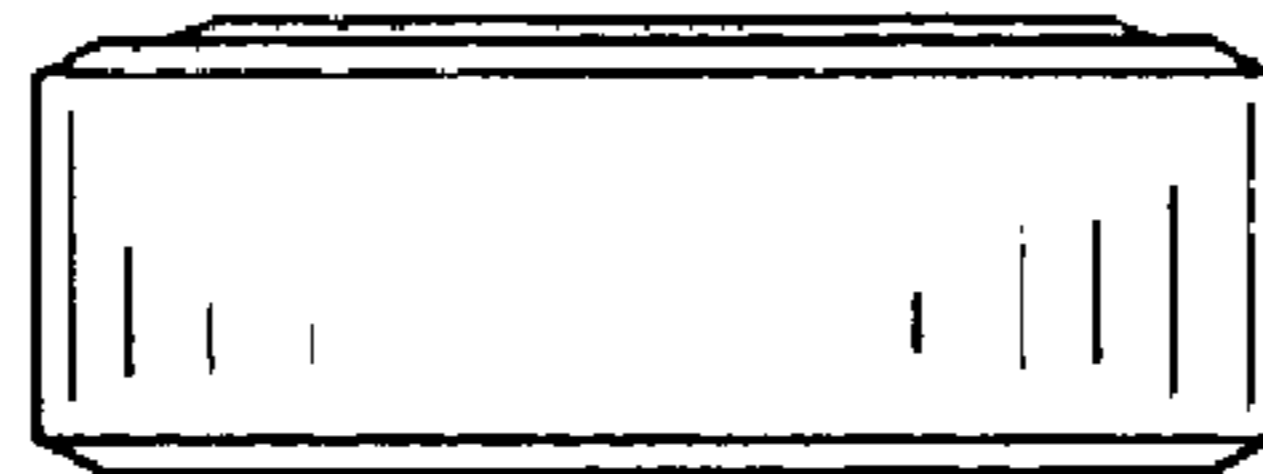

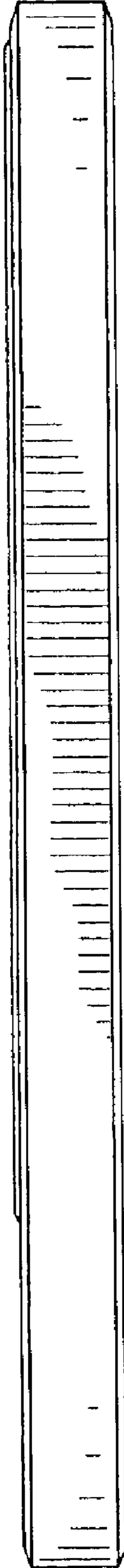

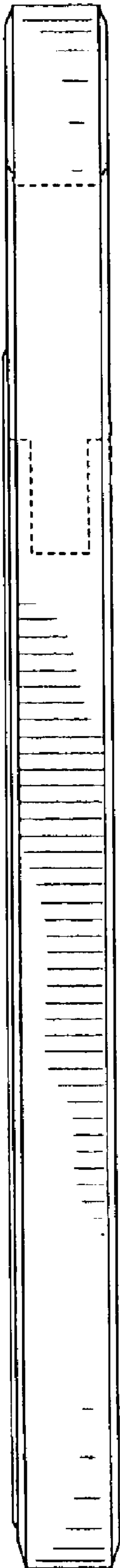
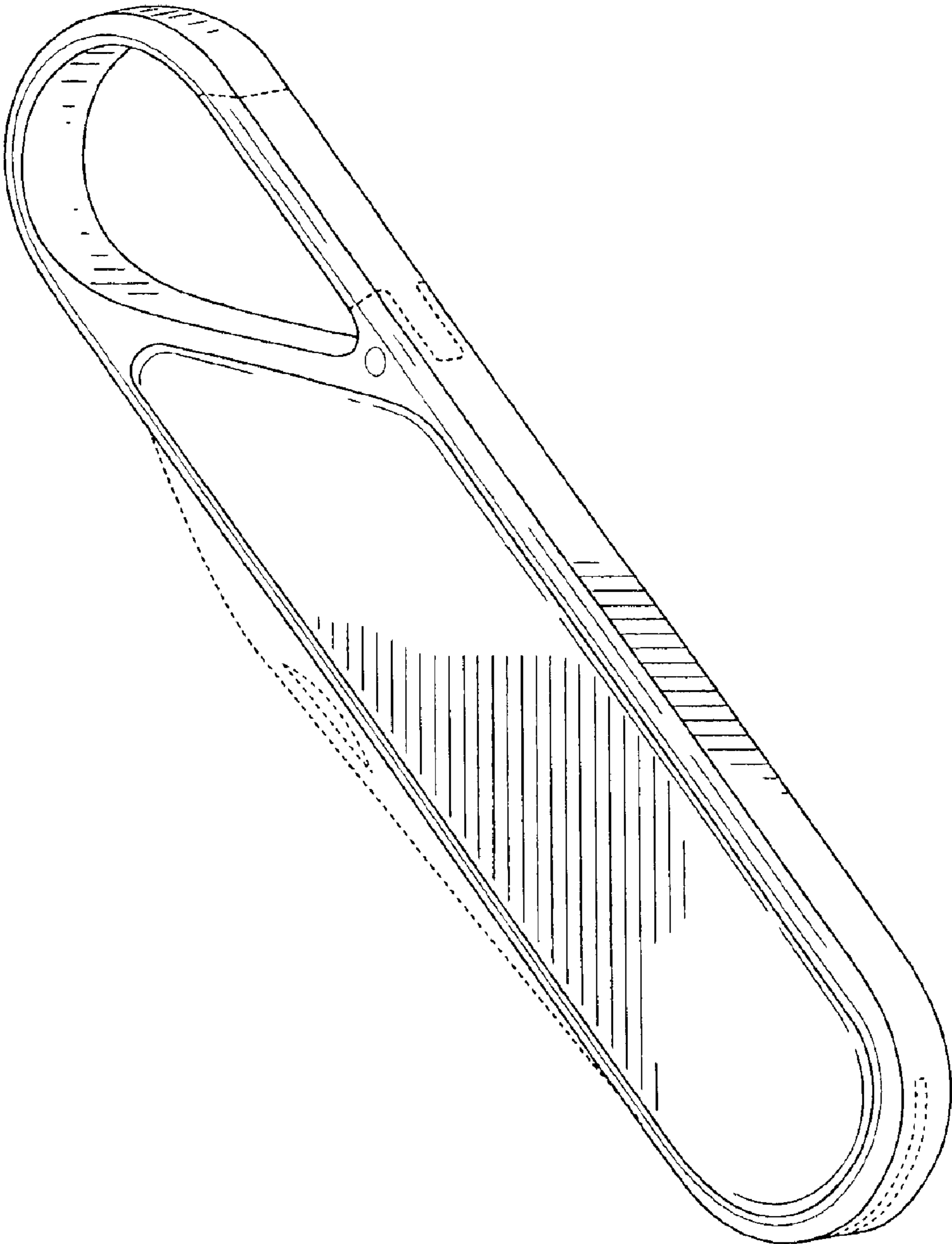

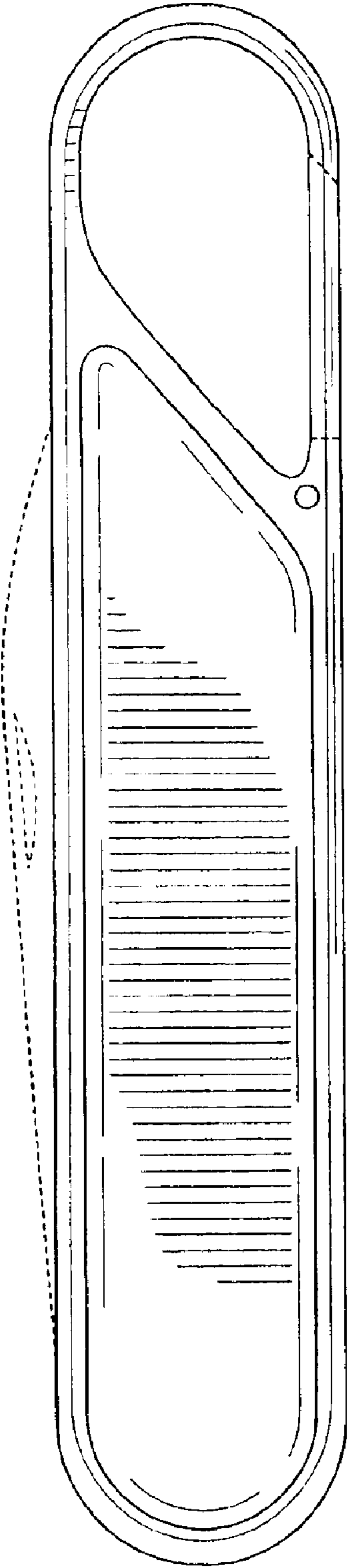

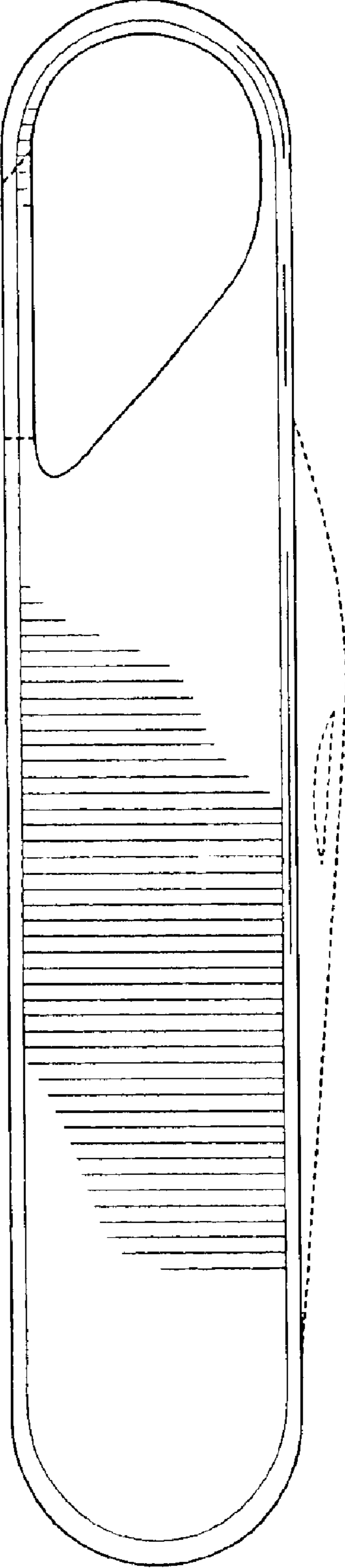

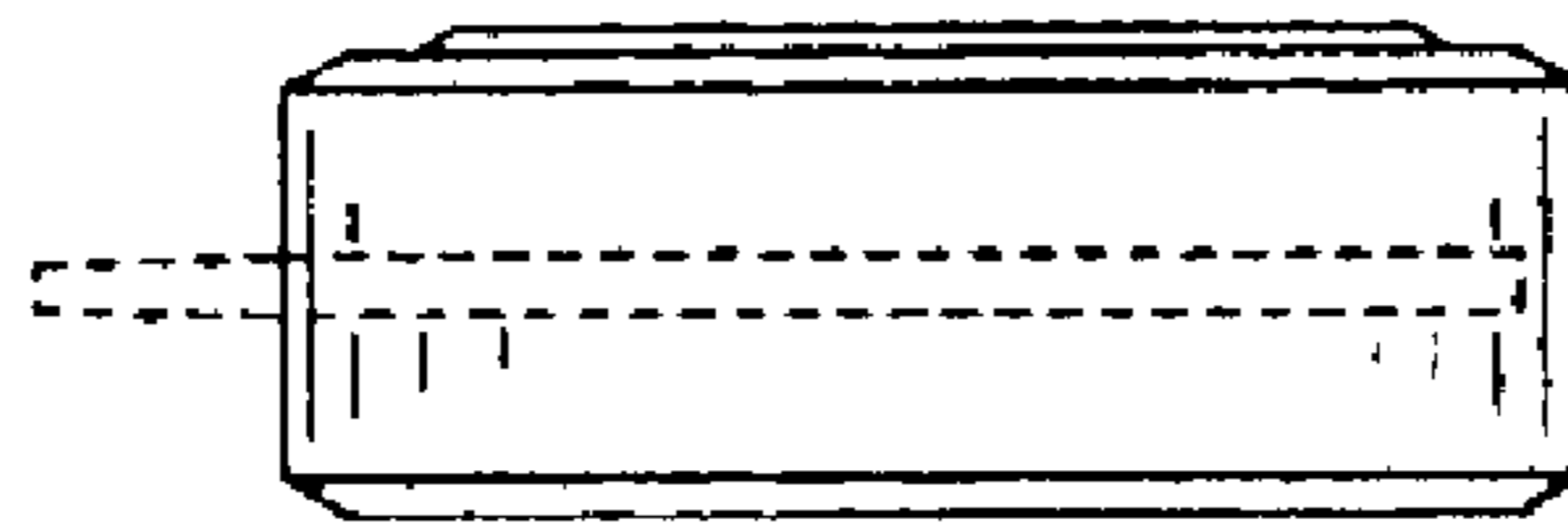

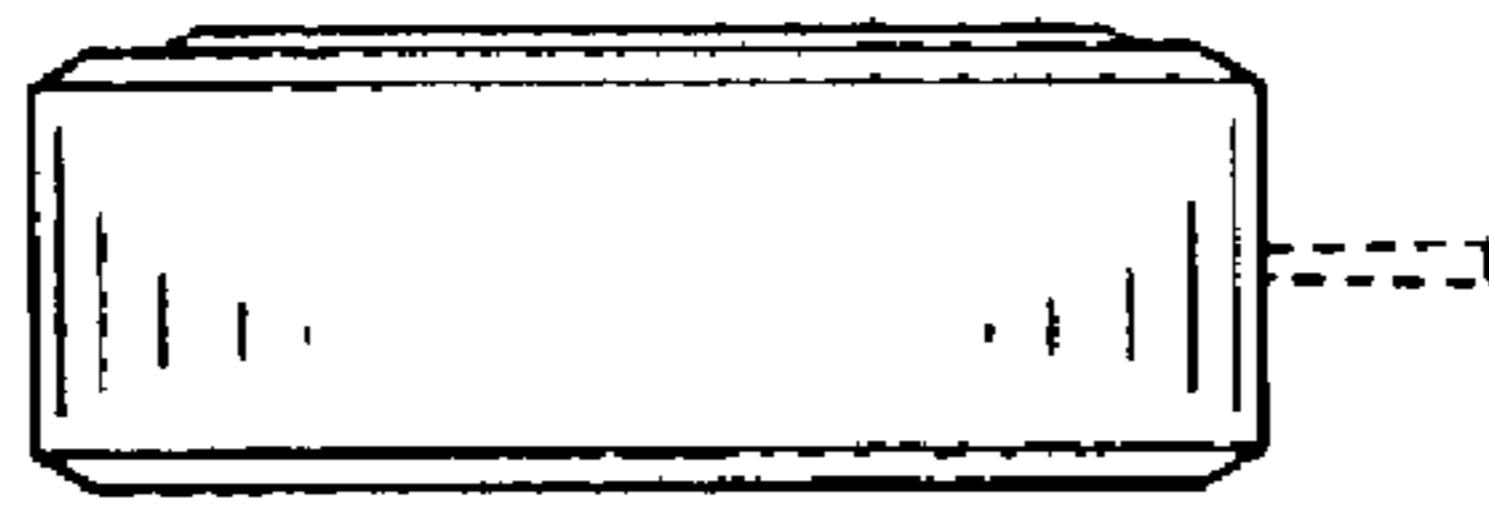

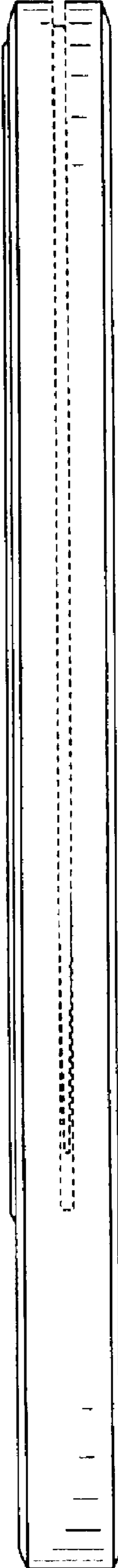

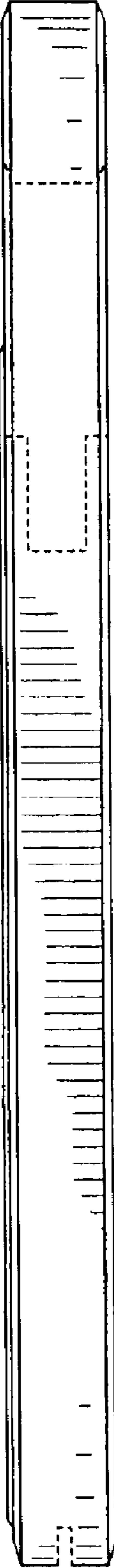
