FIG. 1 is a top perspective view of a bottle in accordance with my new design,

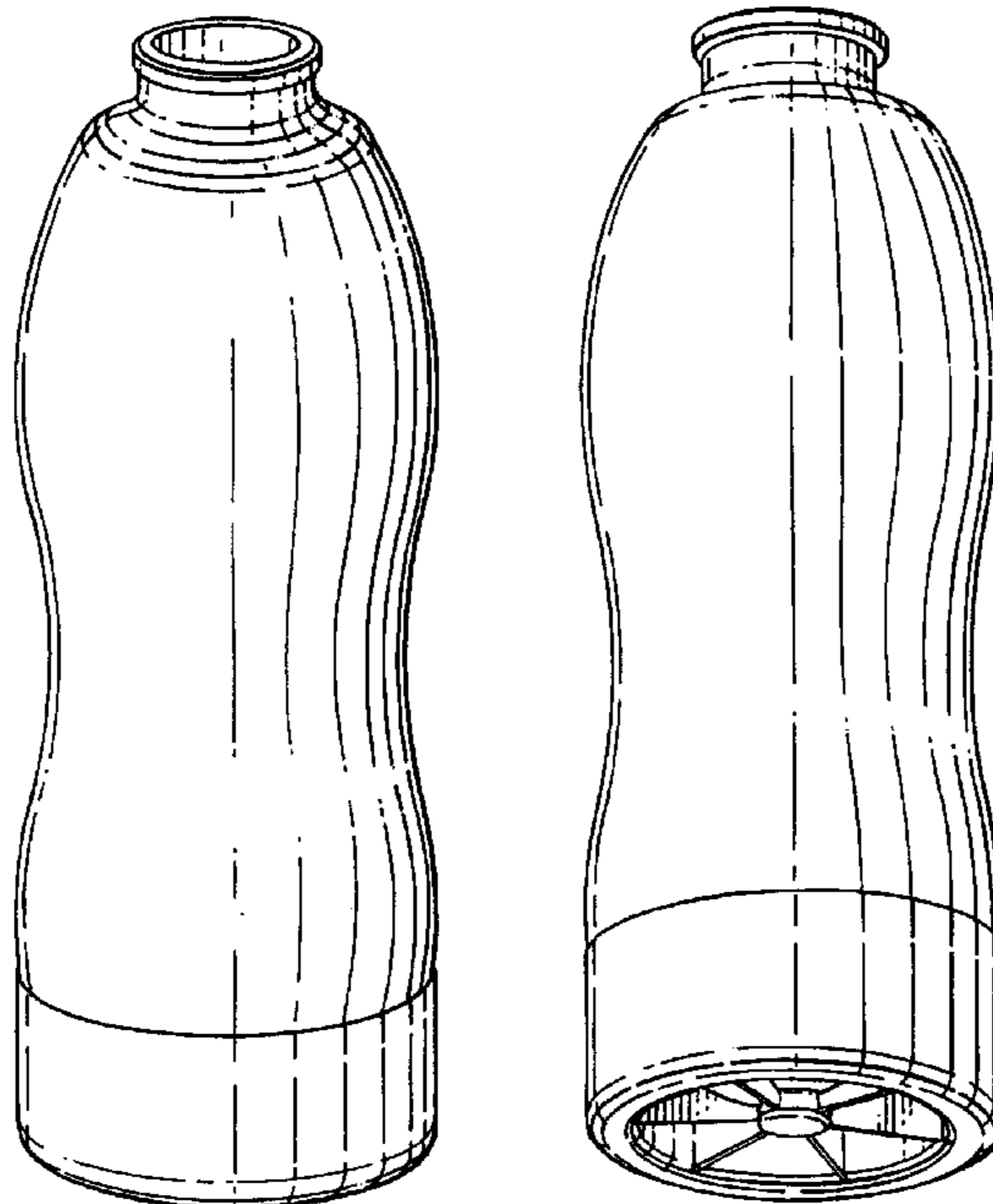
FIG. 2 is a side view of a bottle in accordance with my new design,

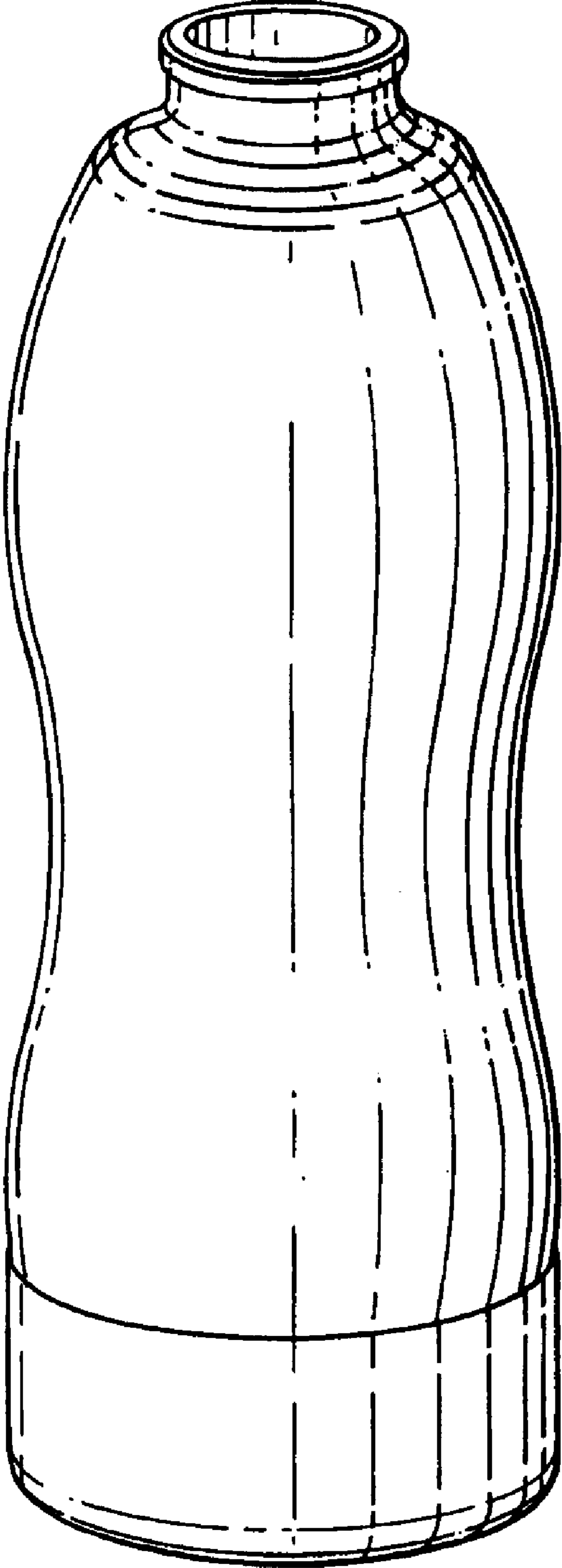

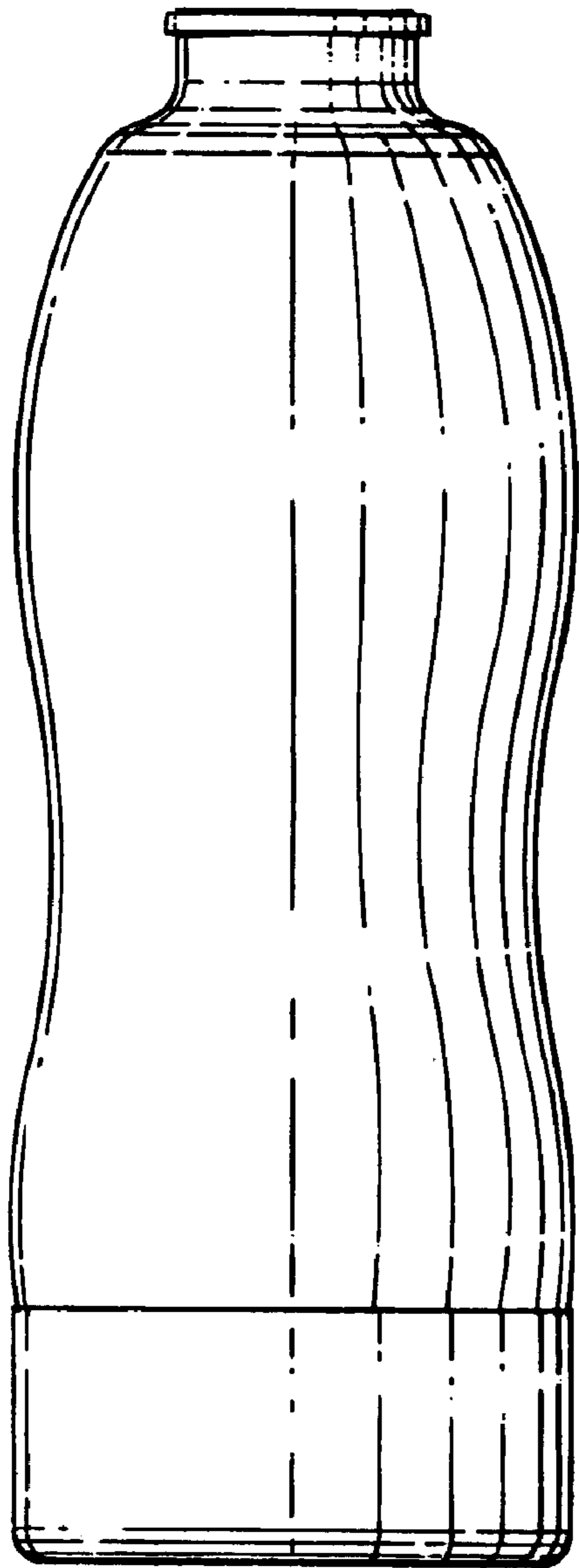

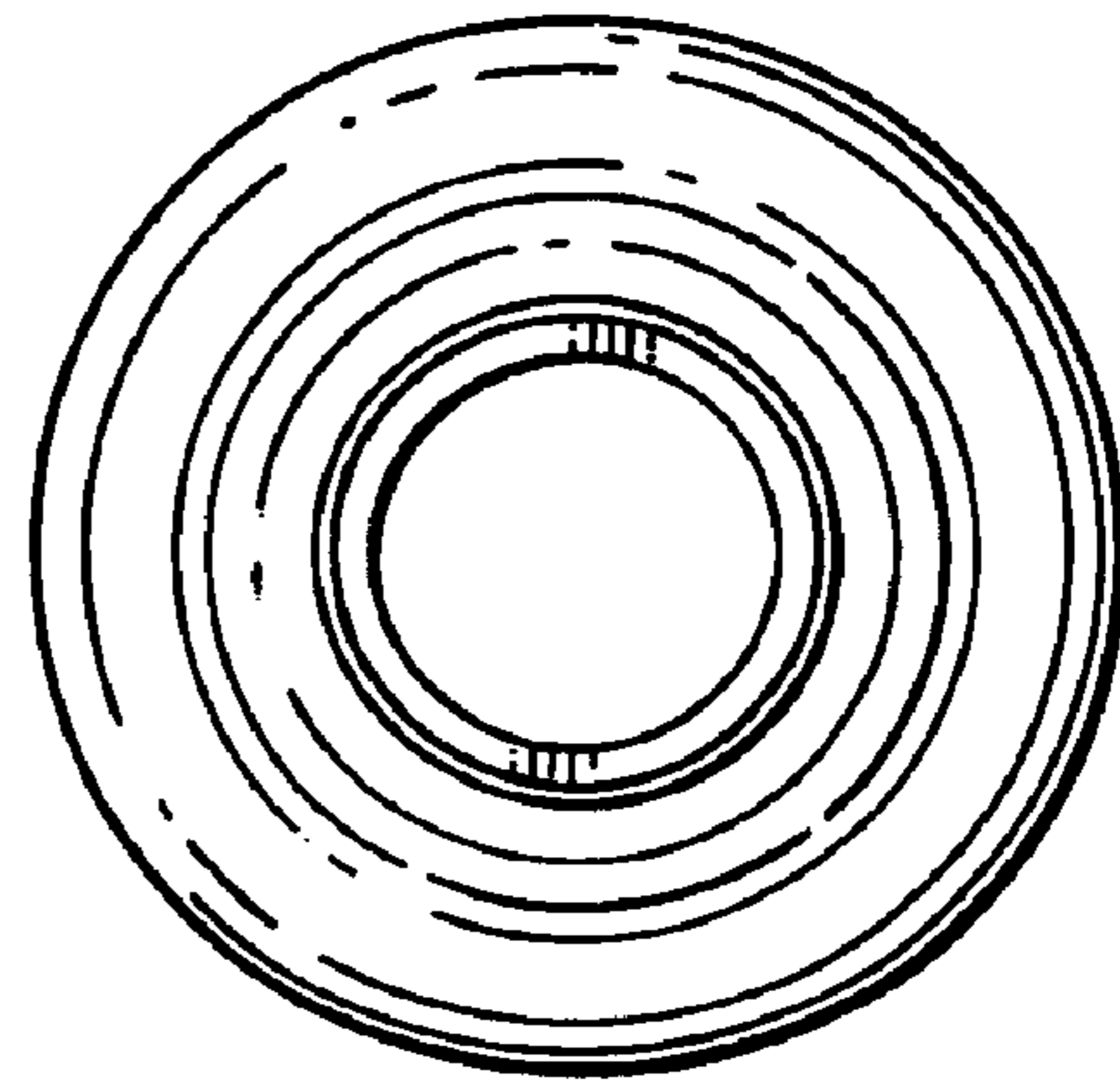

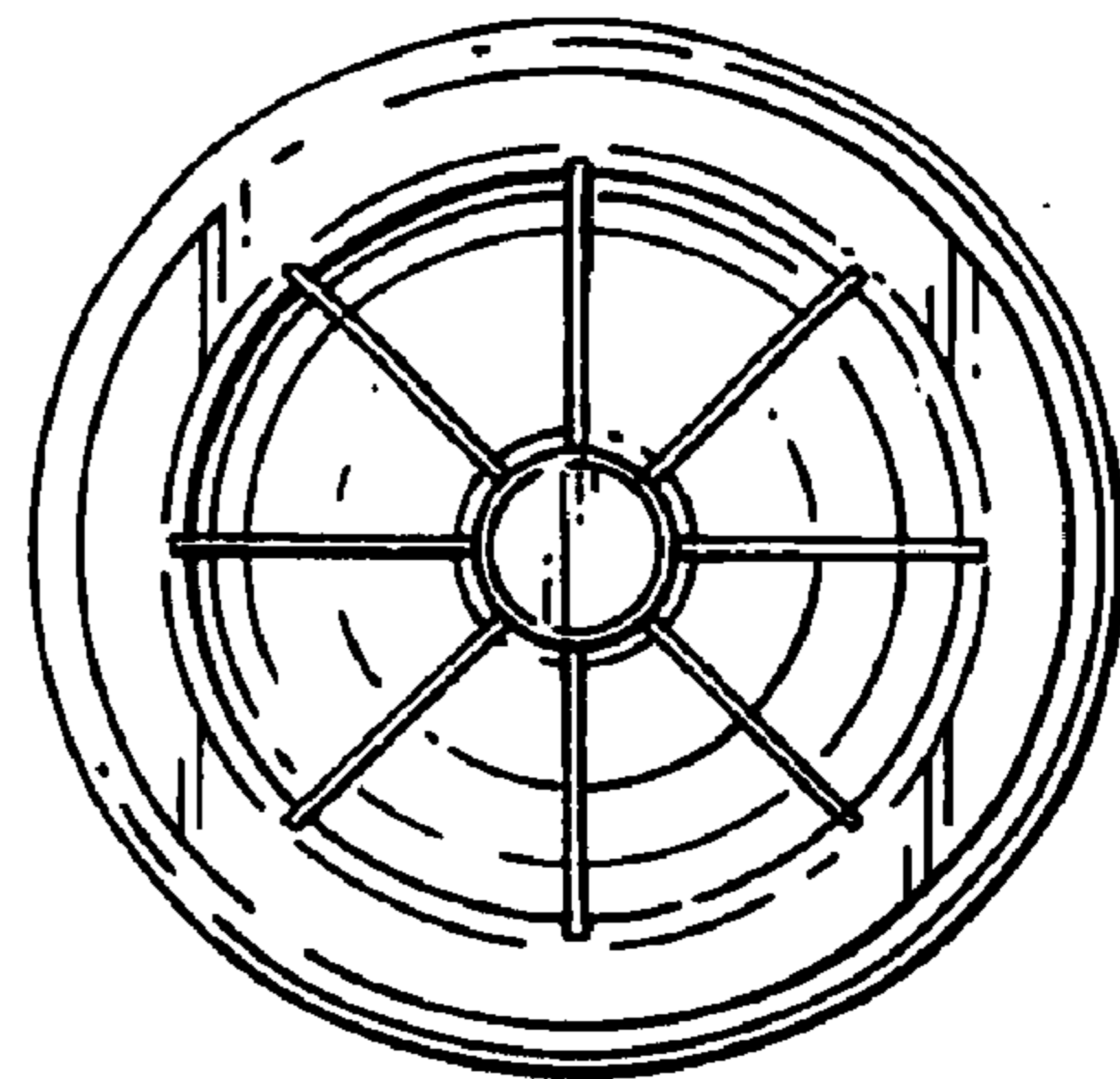

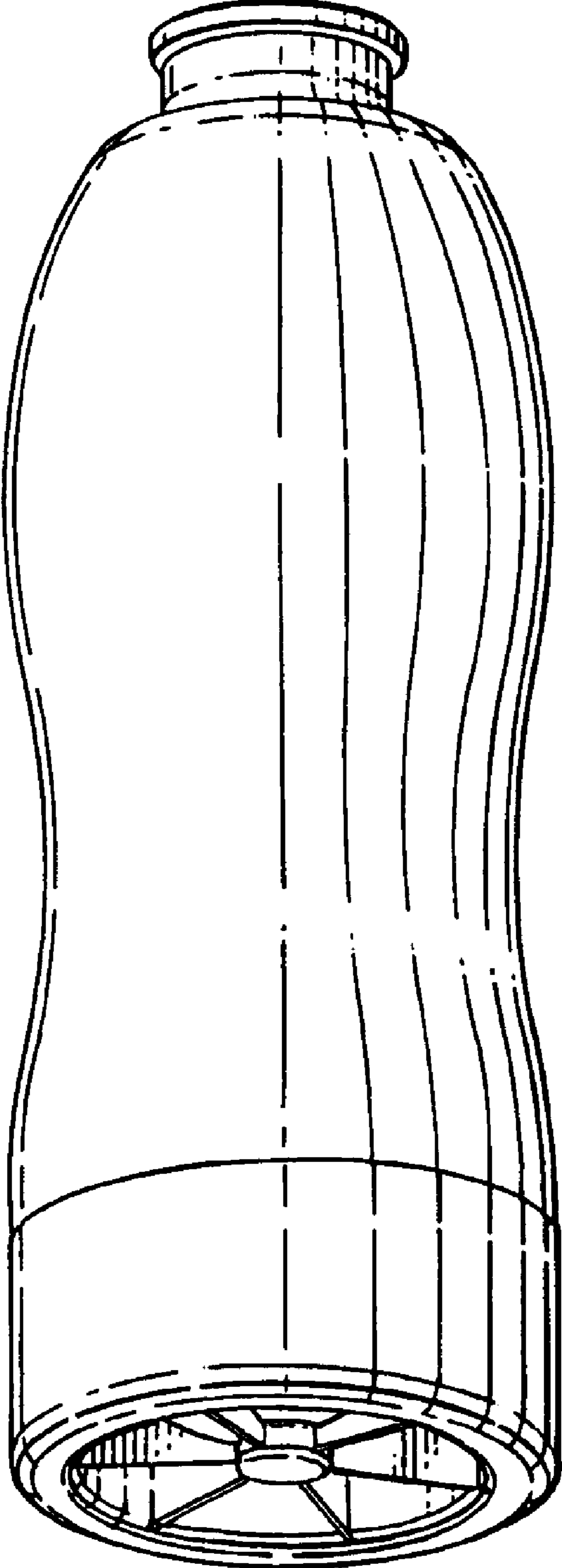
