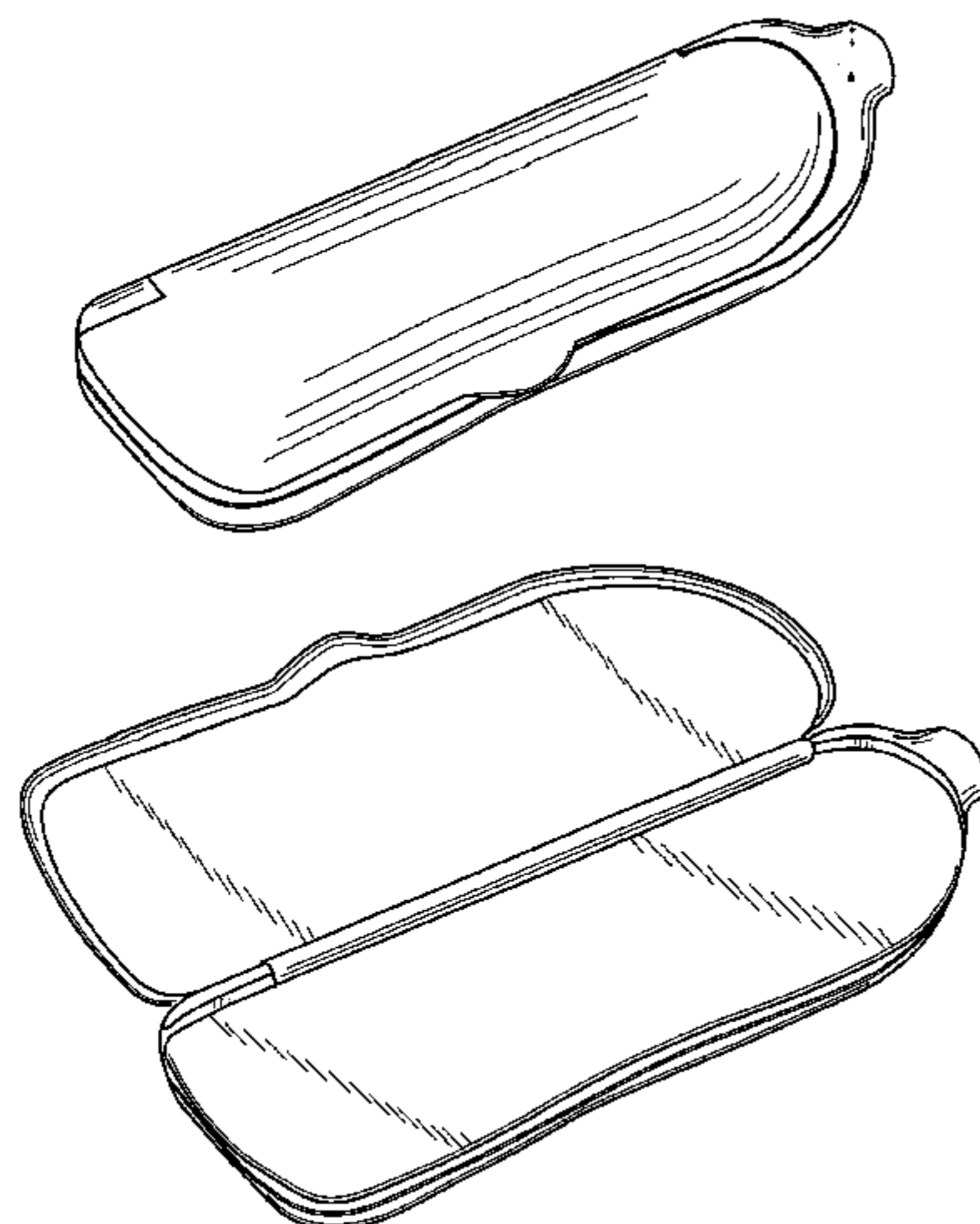
(57) **CLAIM**

I claim the ornamental design for an alphanumeric input device with cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view thereof, with the cover closed; FIG. 2 is a bottom view thereof, with the cover closed; FIG. 3 is a top view thereof, with the cover closed; FIG. 4 is a left side view thereof, with the cover closed; FIG. 5 is a right side view thereof, with the cover closed; FIG. 6 is a rear view thereof, with the cover closed; FIG. 7 is a front view thereof, with the cover closed; FIG. 8 is a perspective view thereof, with the cover open; FIG. 9 is a top view thereof, with the cover open; FIG. 10 is a bottom view thereof, with the cover open; FIG. 11 is a right side view thereof, with the cover open; FIG. 12 is a left side view thereof, with the cover open; FIG. 13 is a rear view thereof, with the cover open; and, FIG. 14 is a front view thereof, with the cover open.

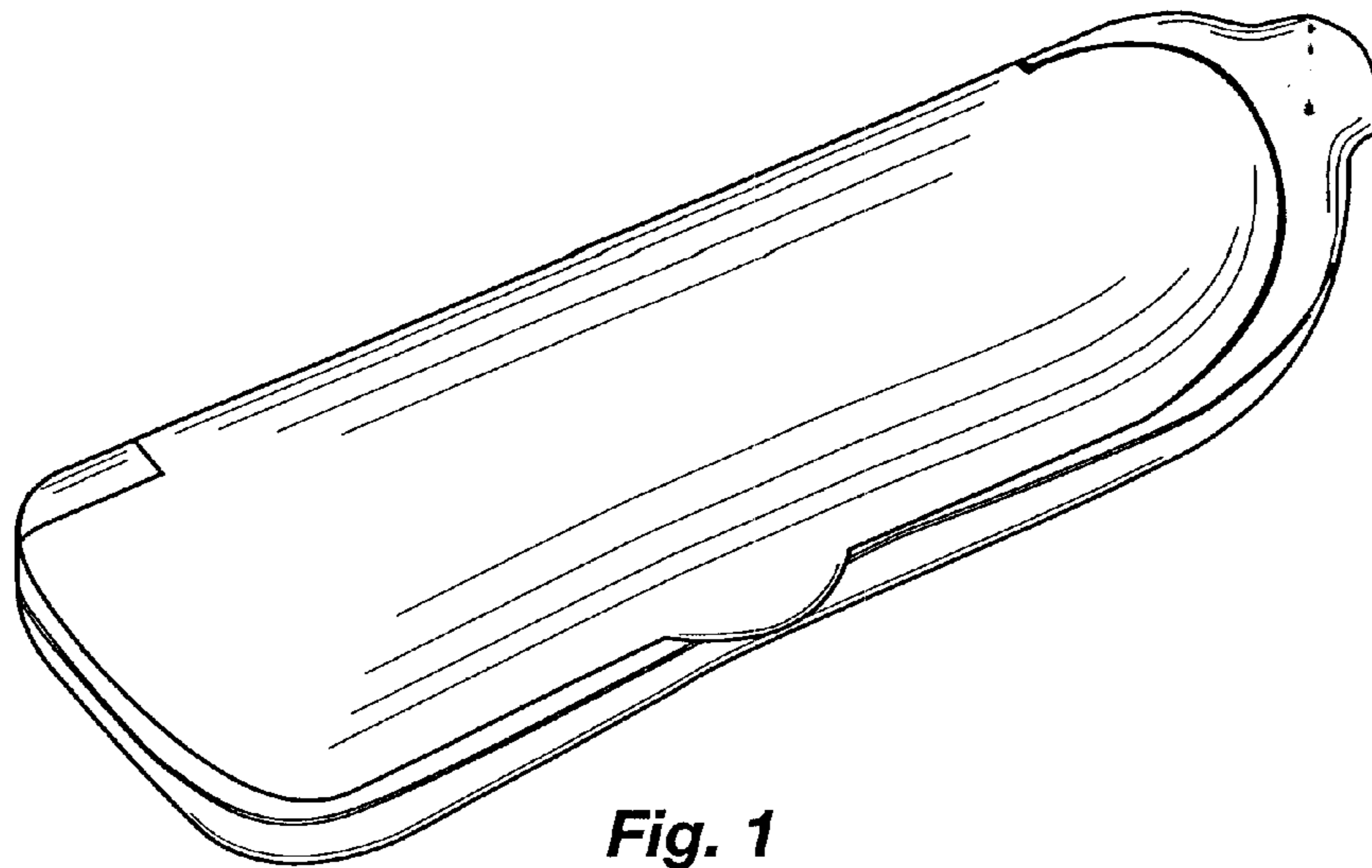

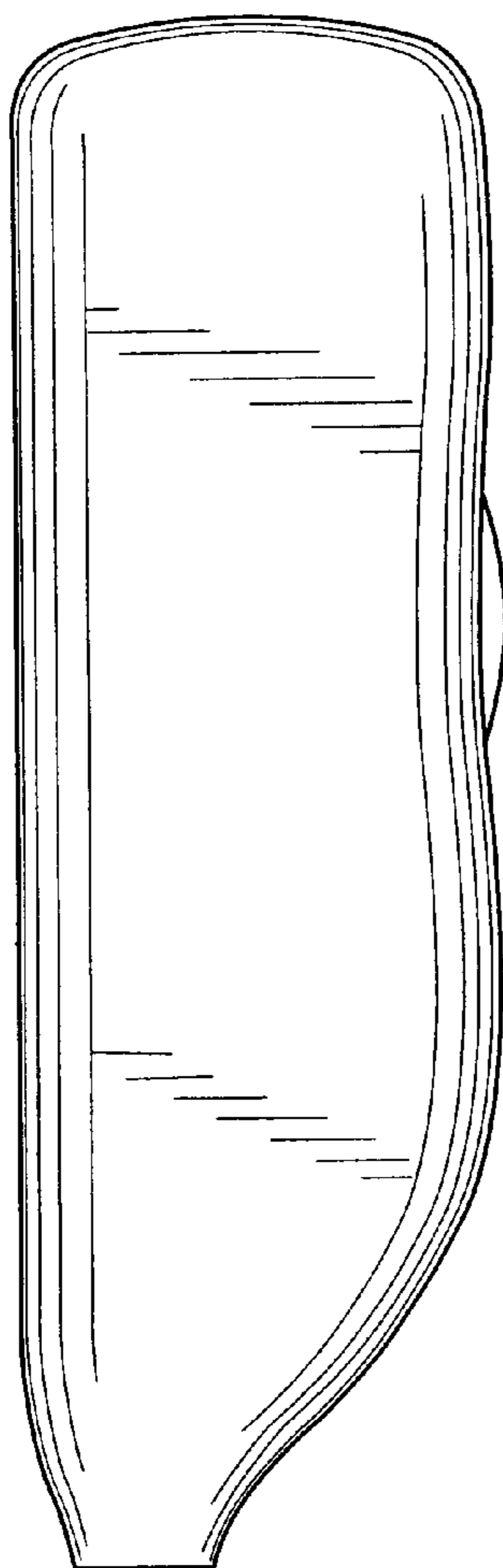

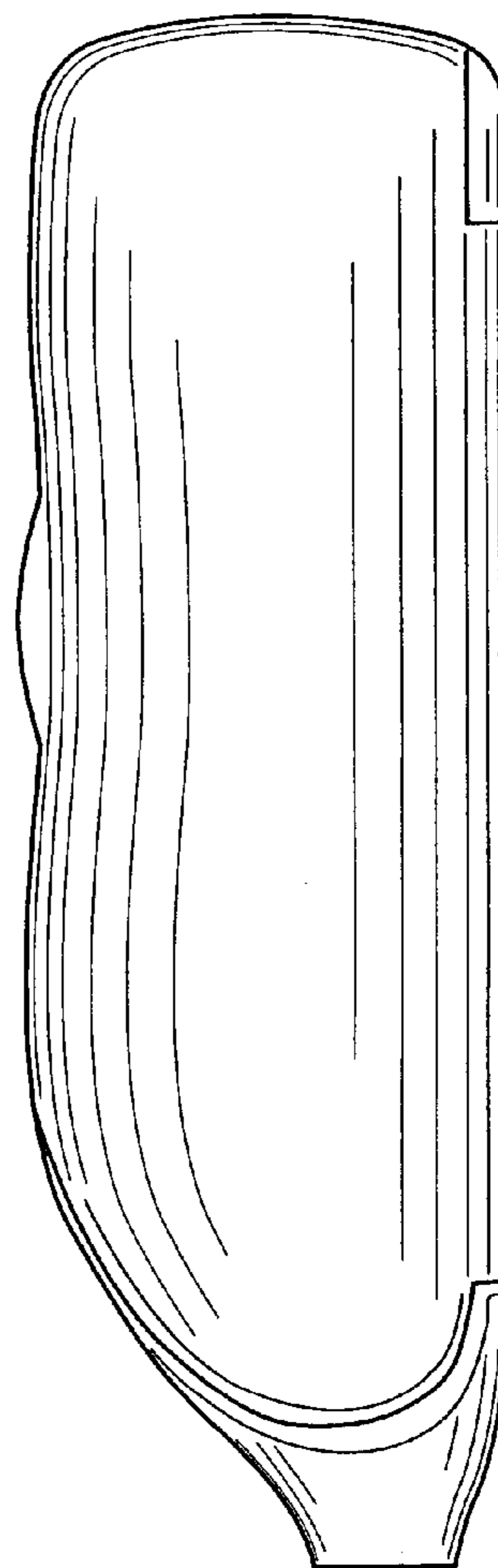

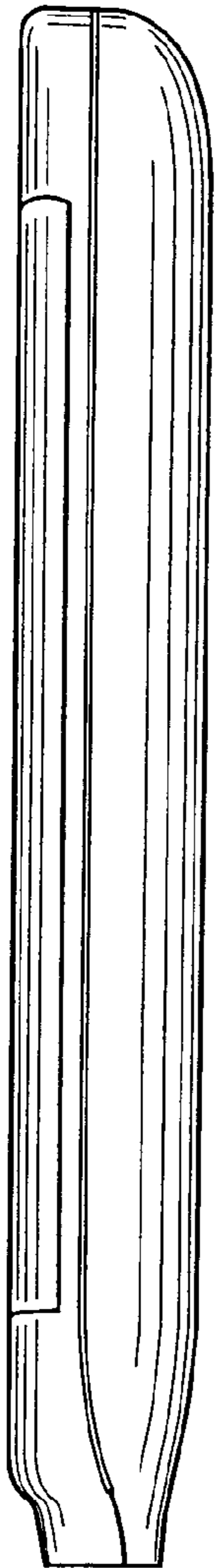

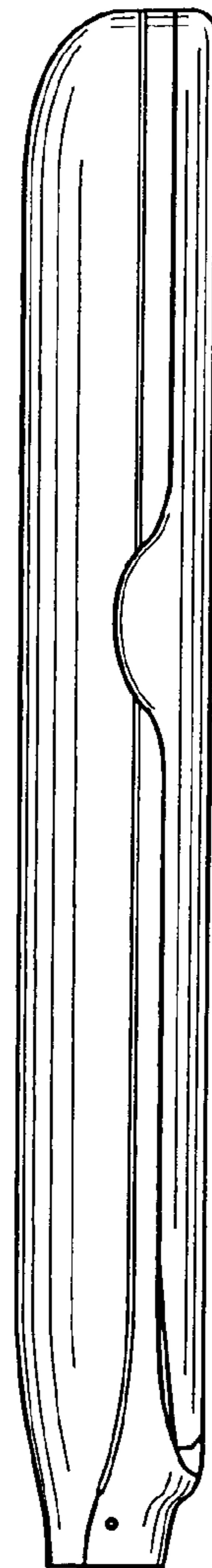

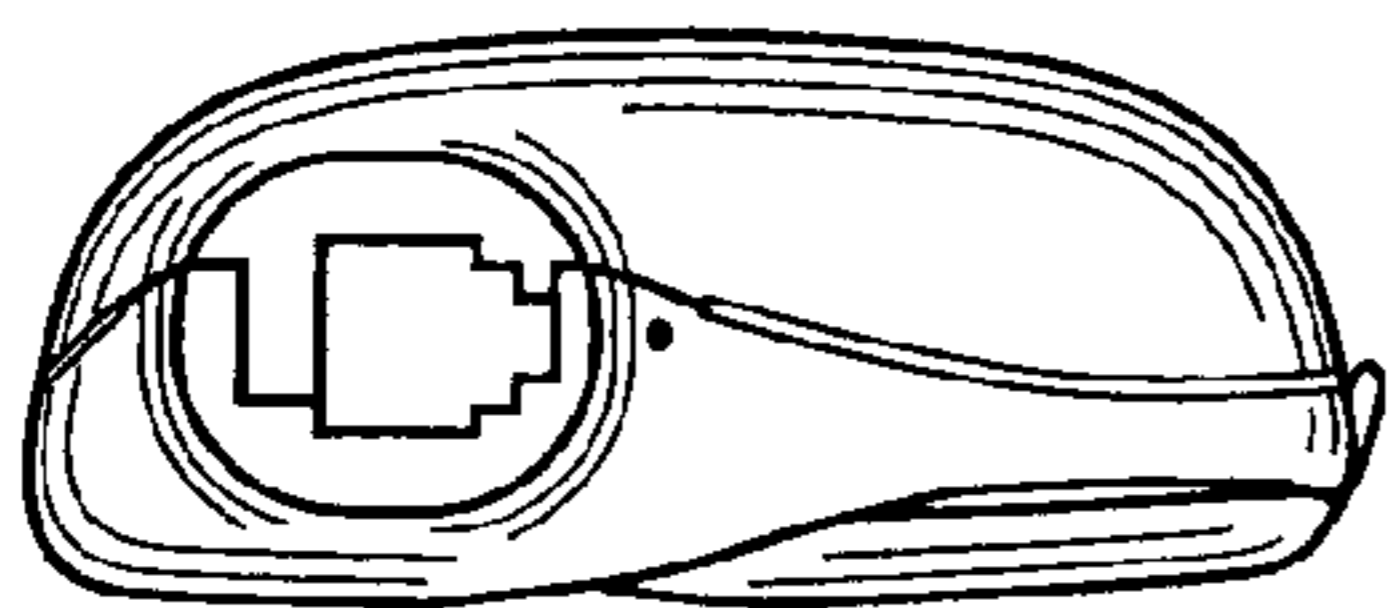

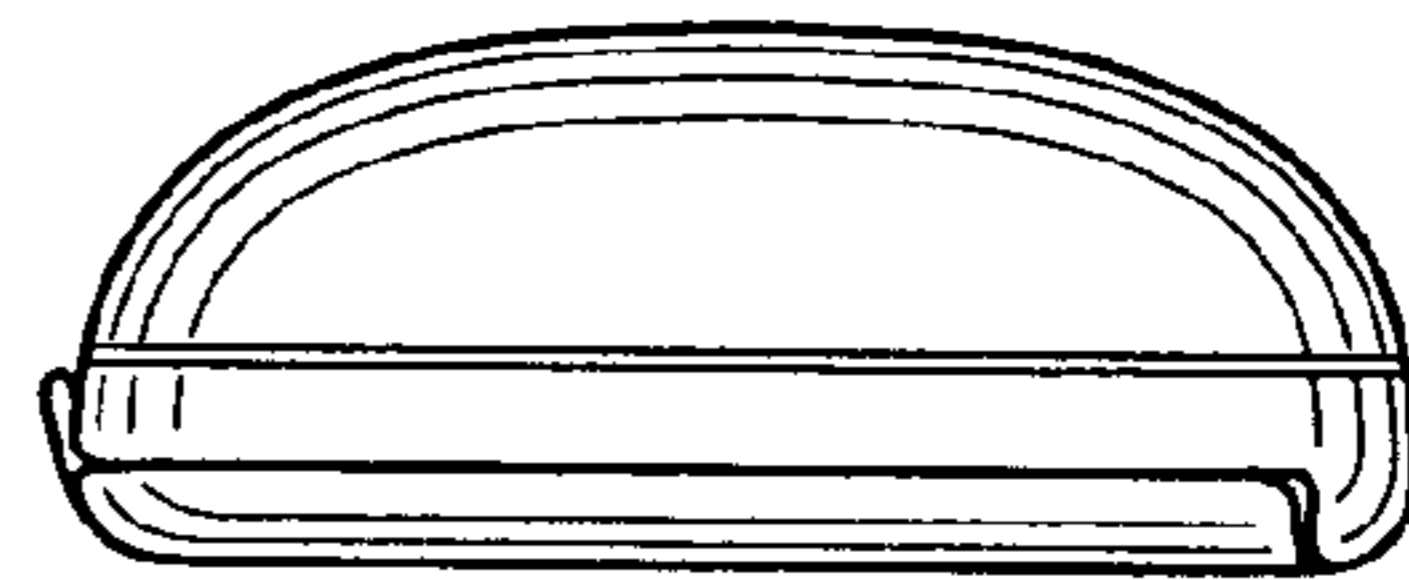

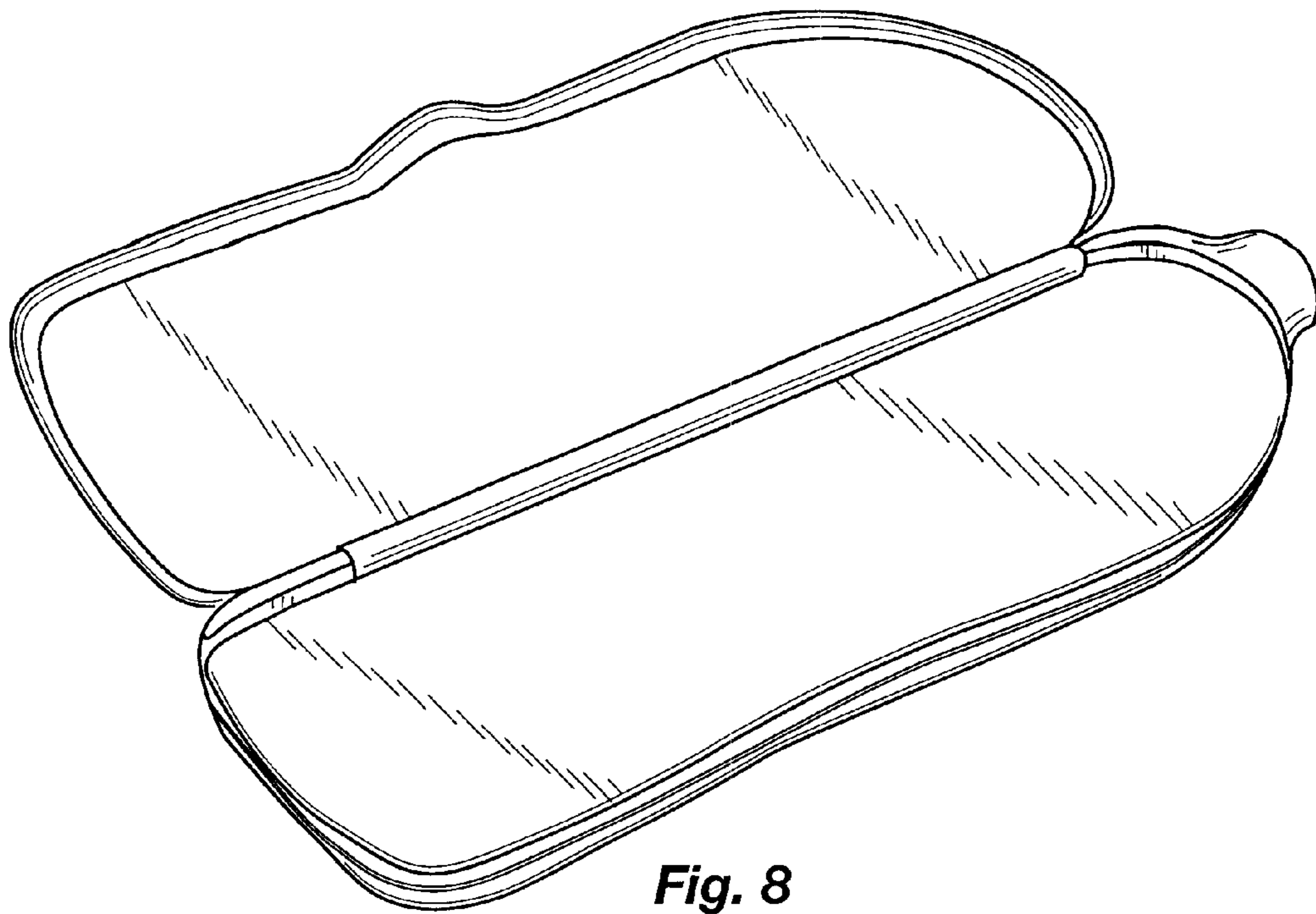

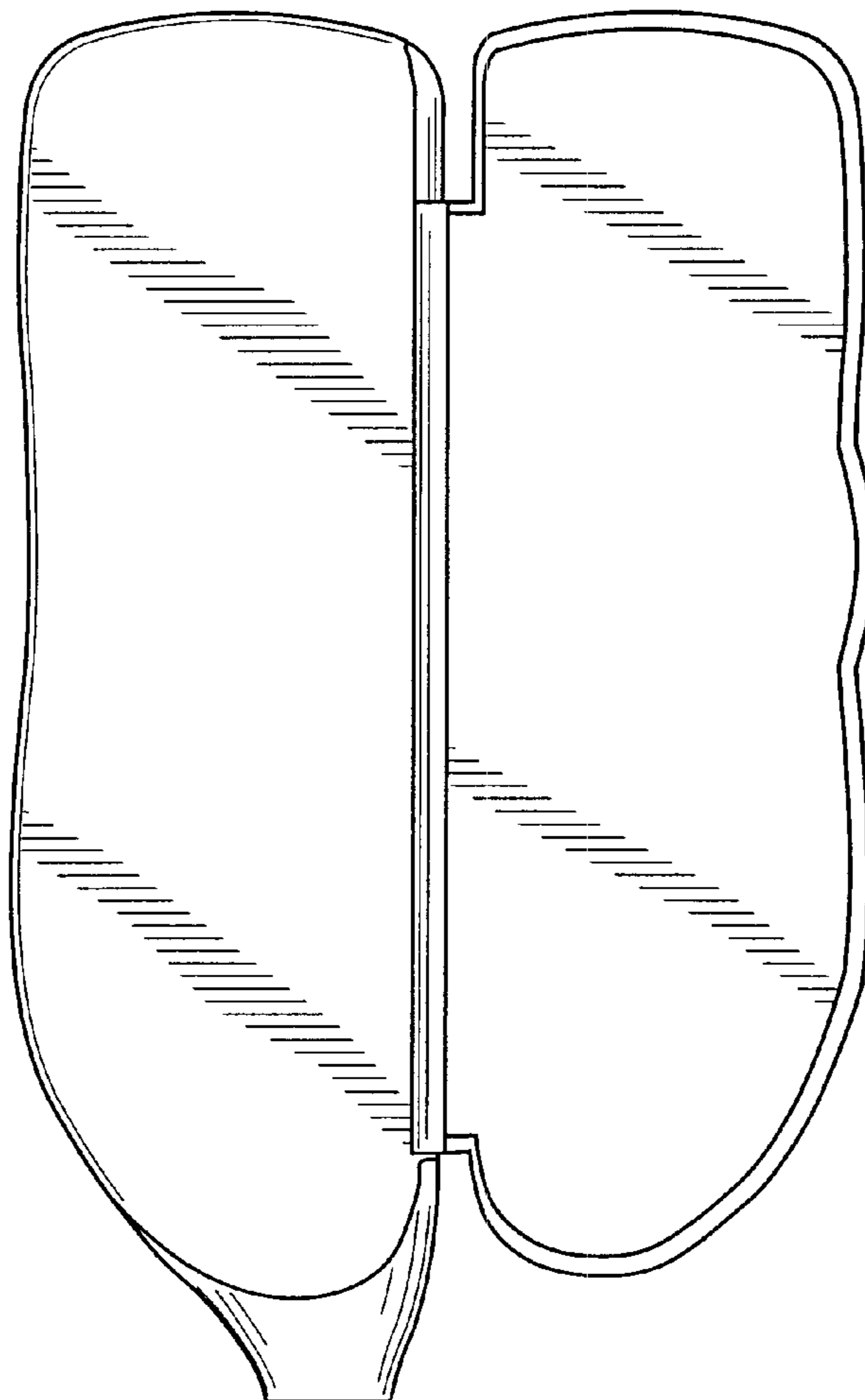

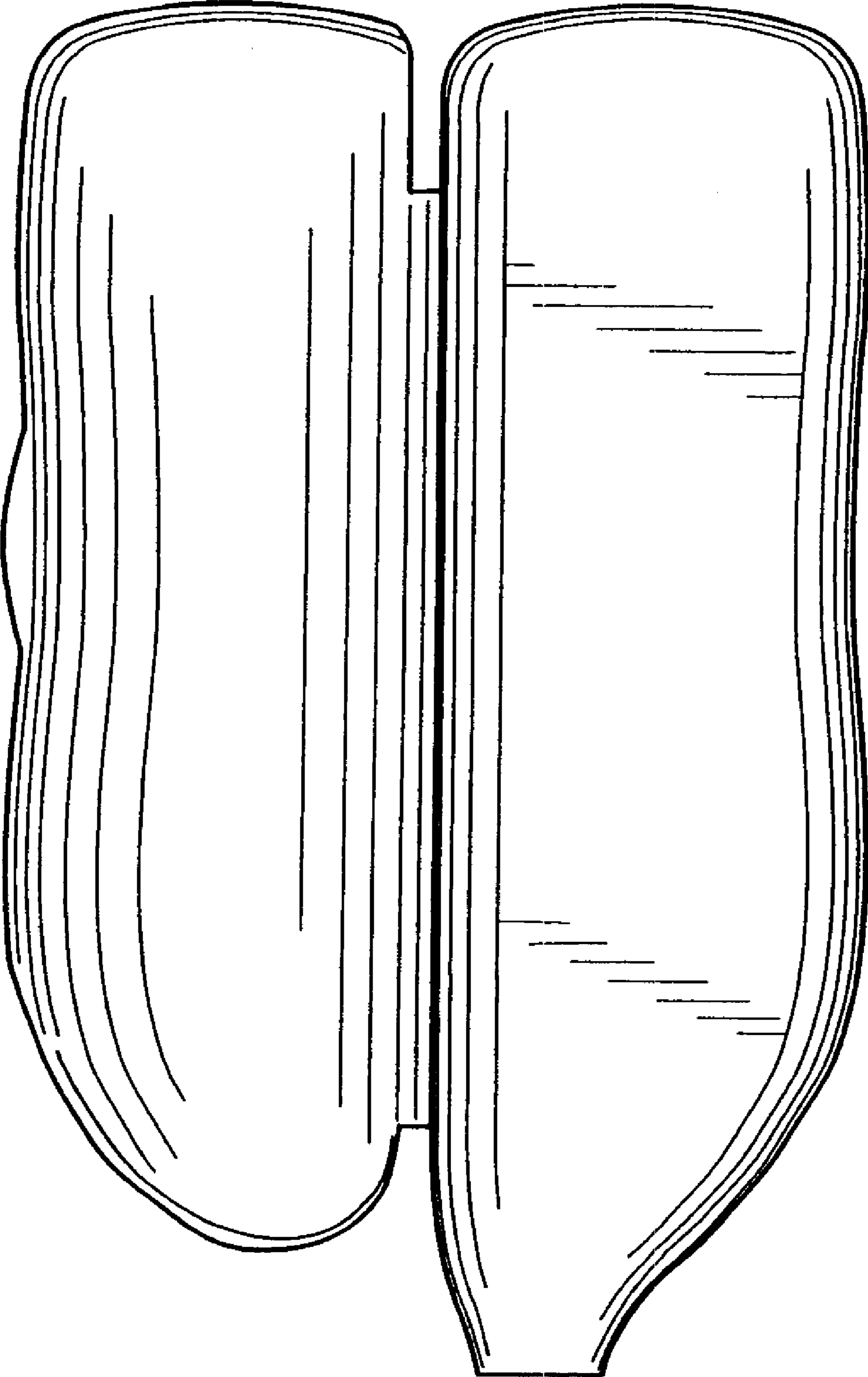

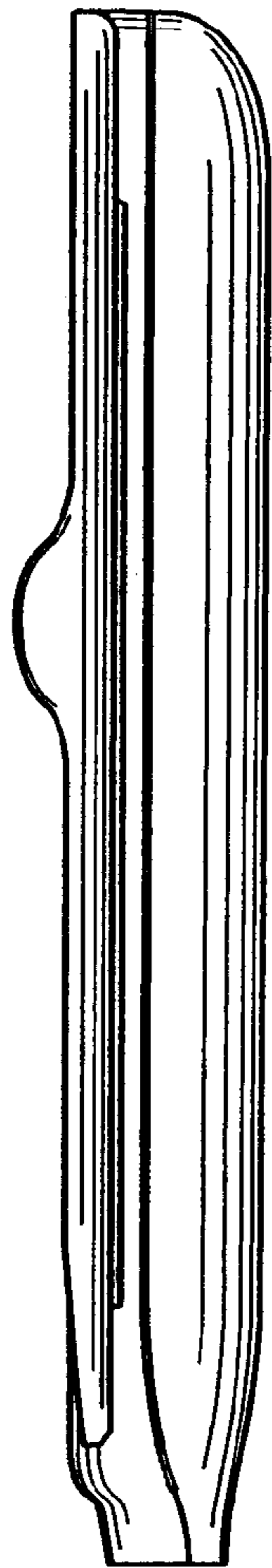

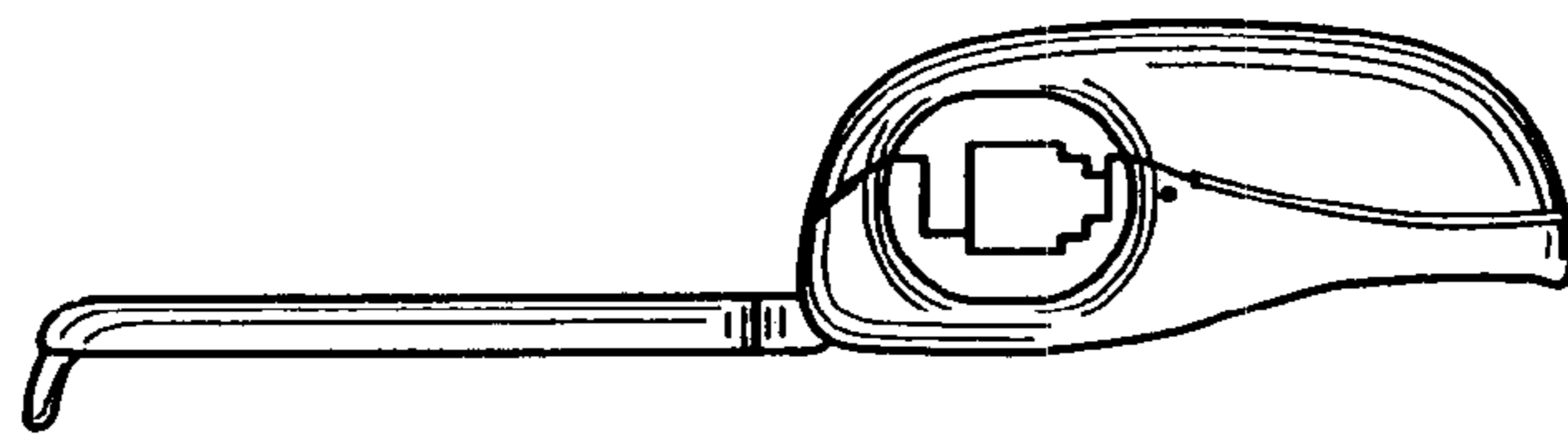

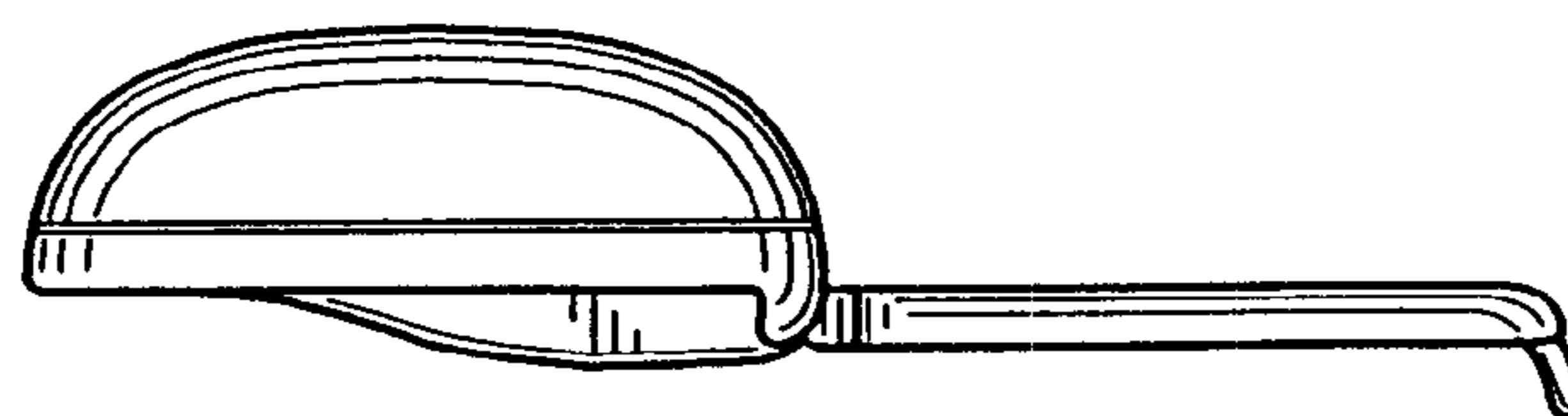
