FIG. 3 is a rear elevation view thereof.

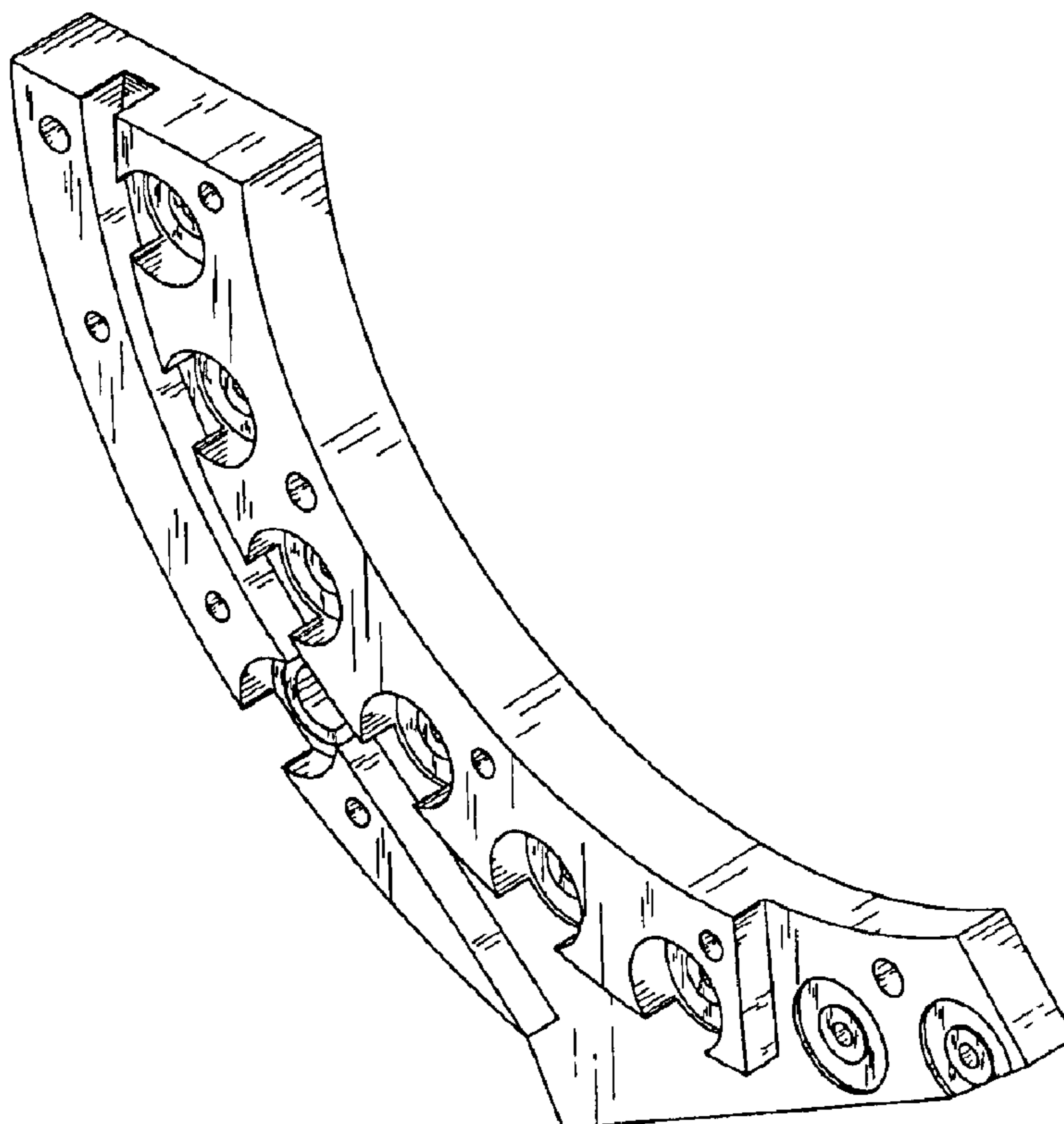
FIG. 4 is a left elevation view thereof.

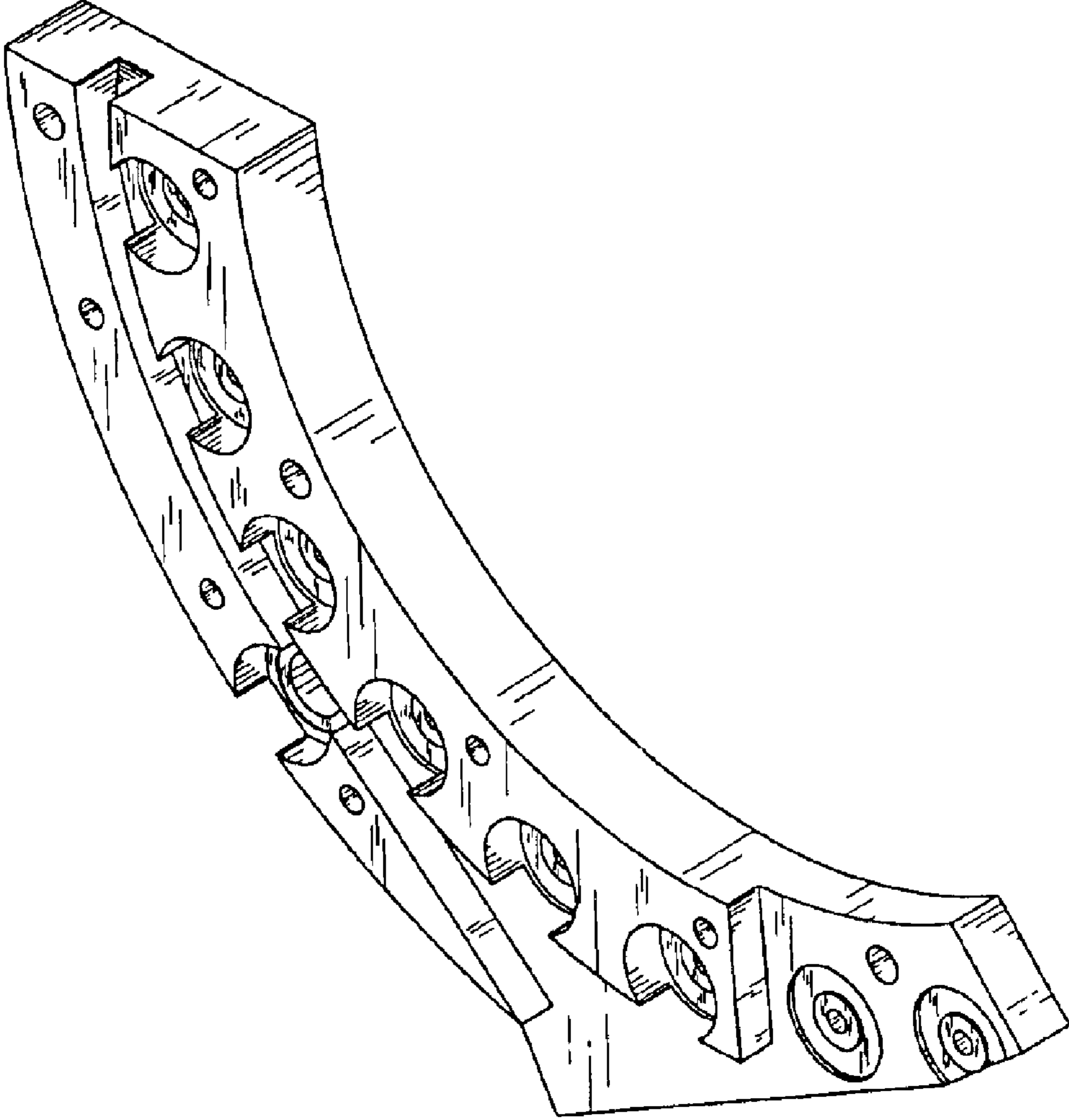
FIG. 5 is a right elevation view thereof.

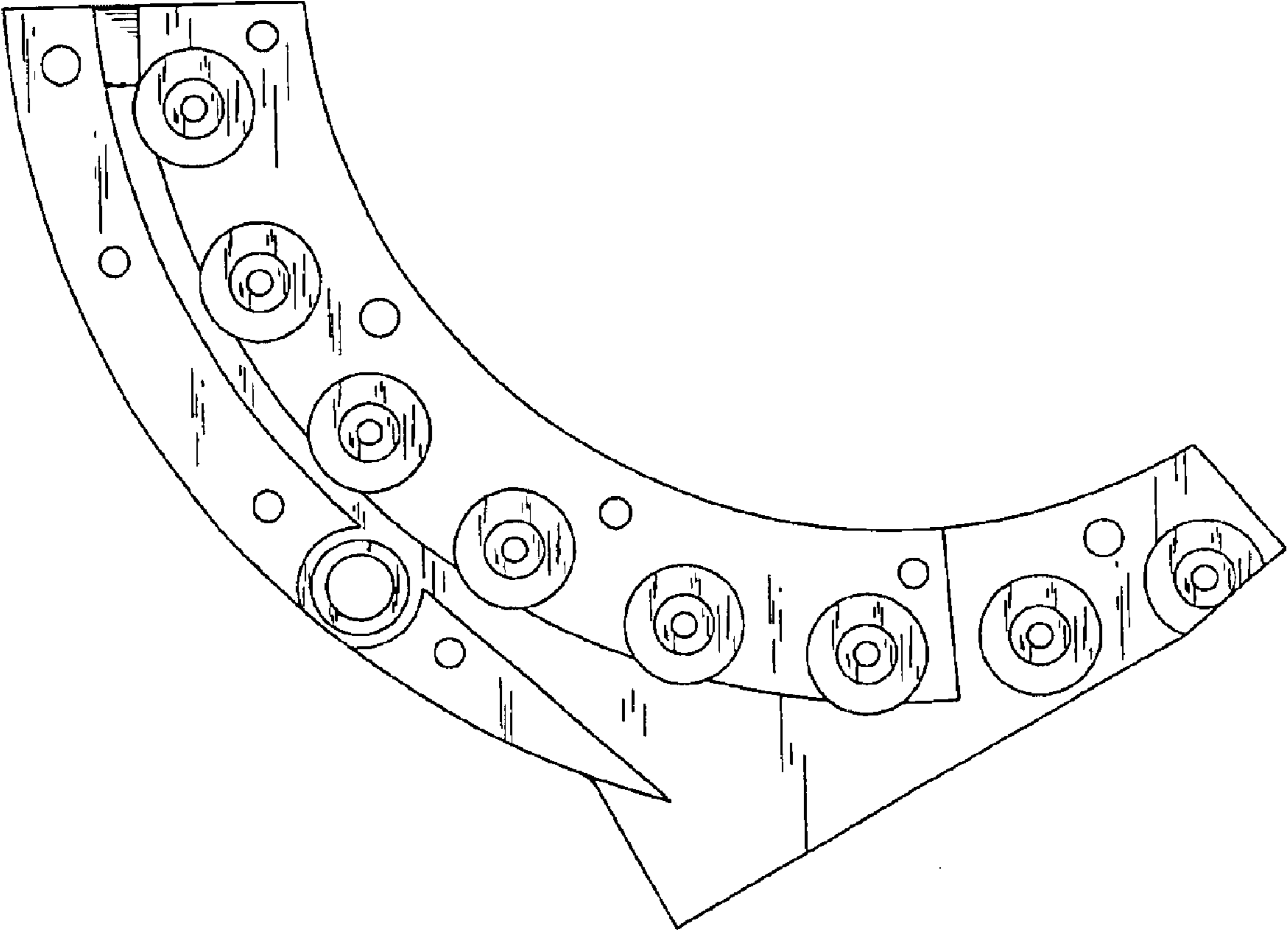
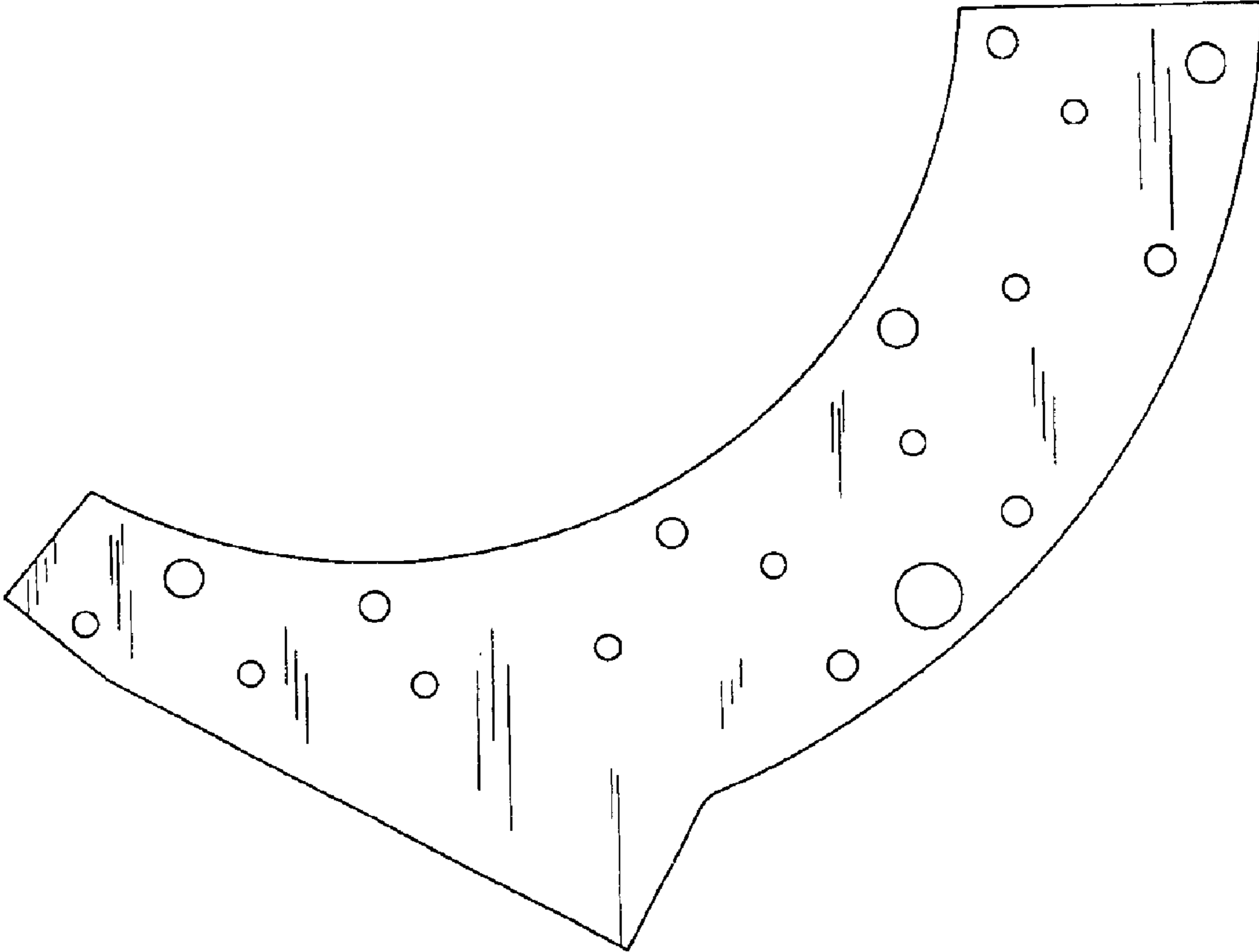
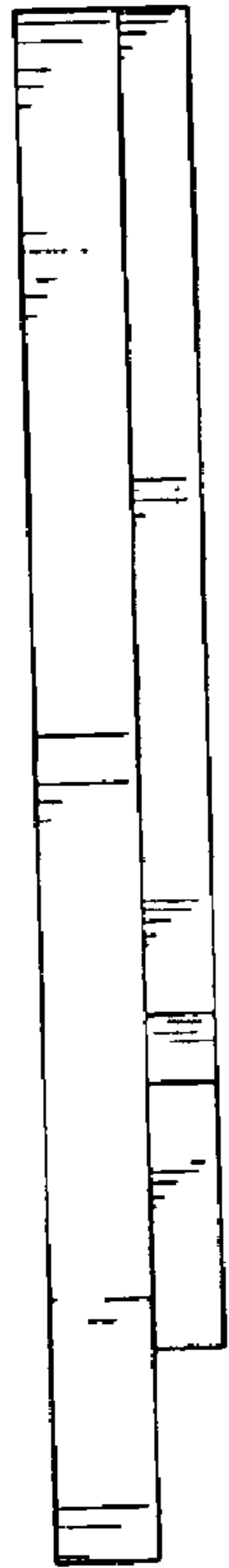


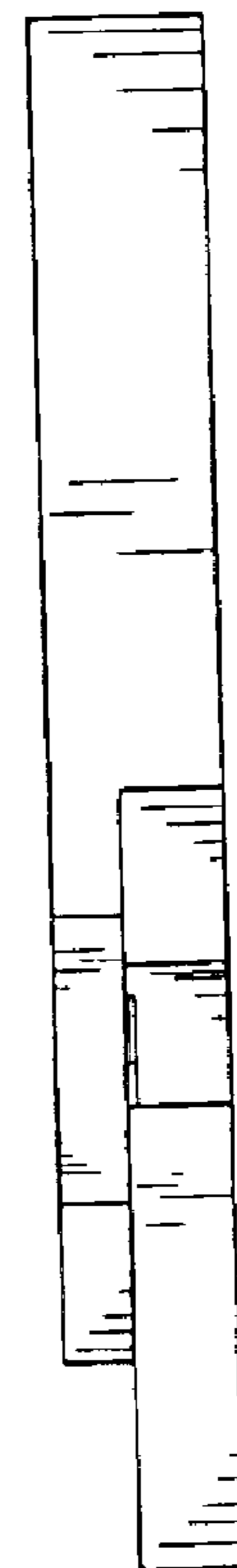

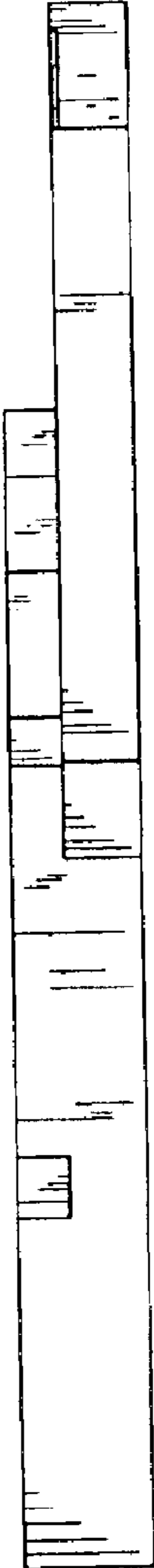
