(57) **CLAIM**

The ornamental design for an electronic pen, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an electronic pen showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a left side elevational view, the right side being a mirror image thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a typical side elevational view of the pen body with the cap member removed for ease of illustration.

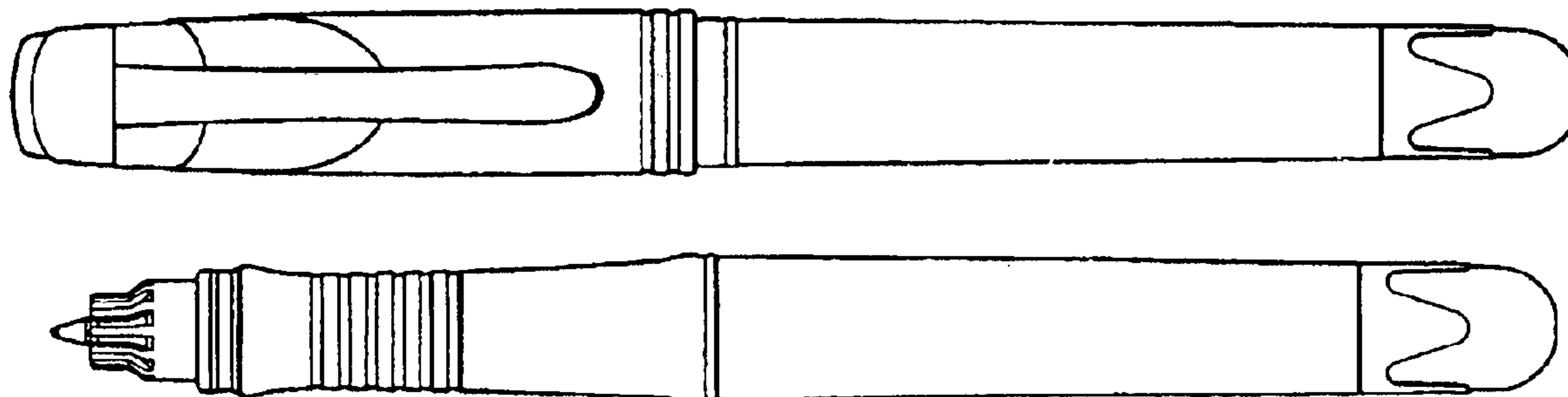

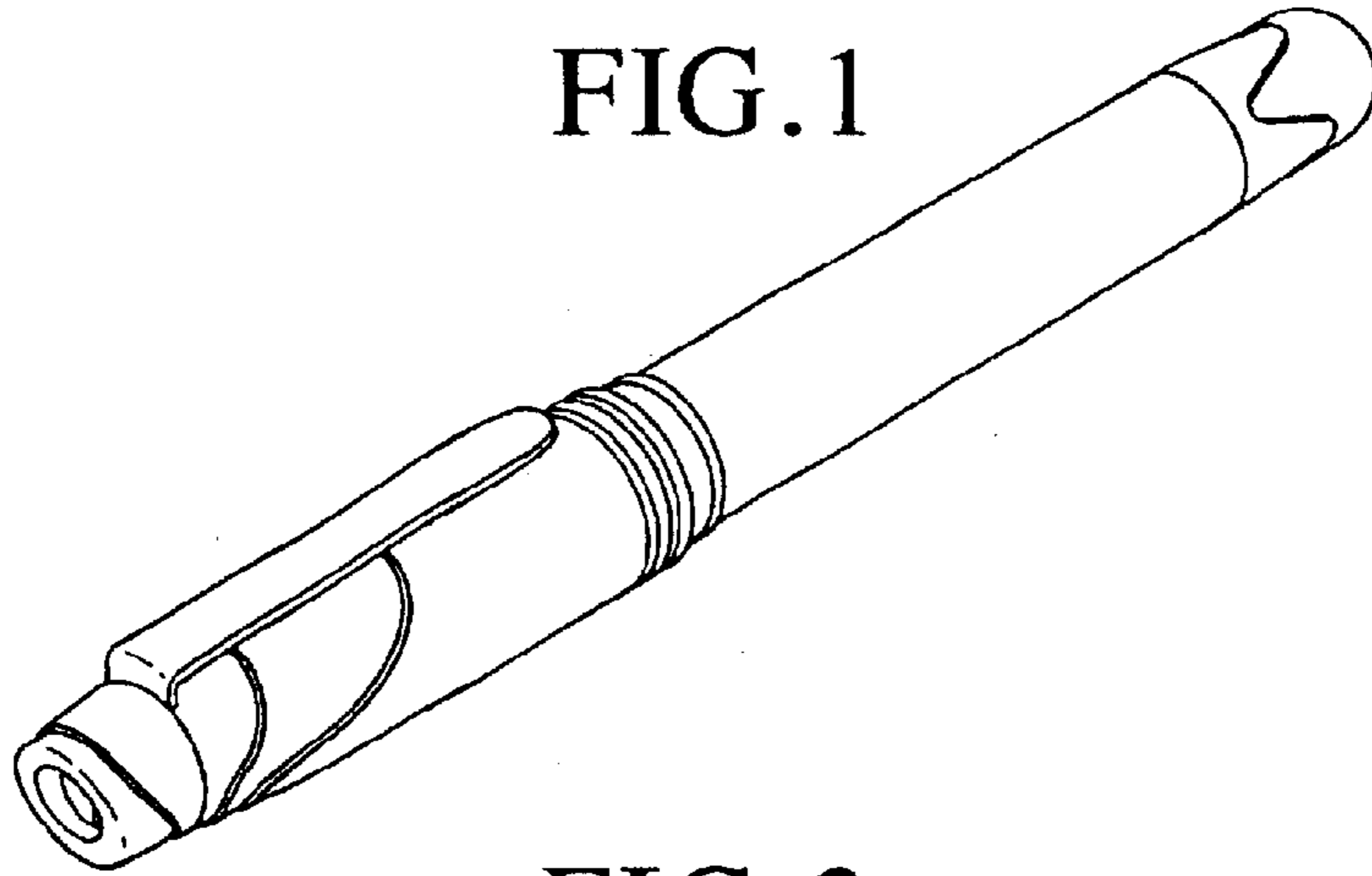

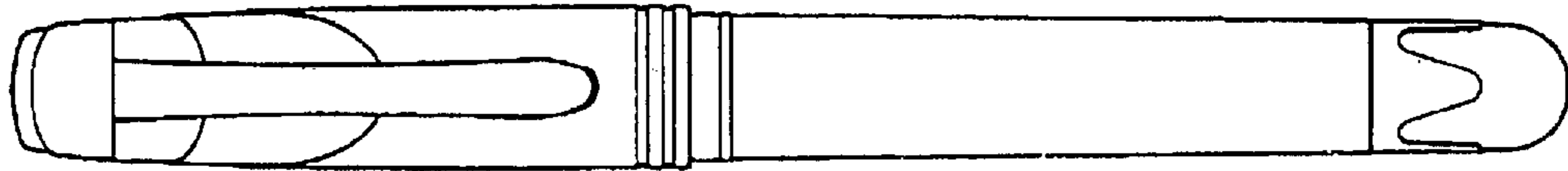

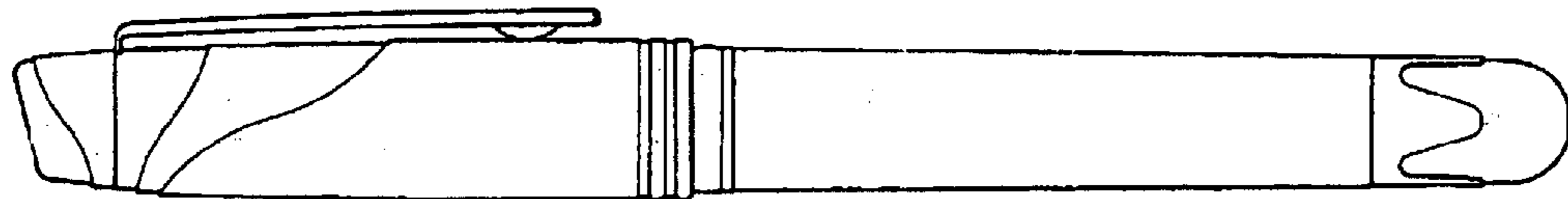

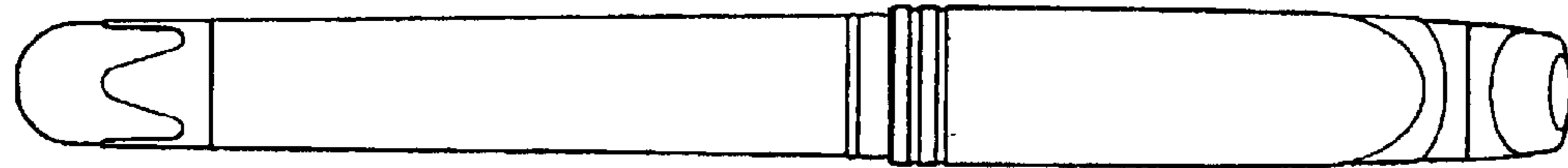

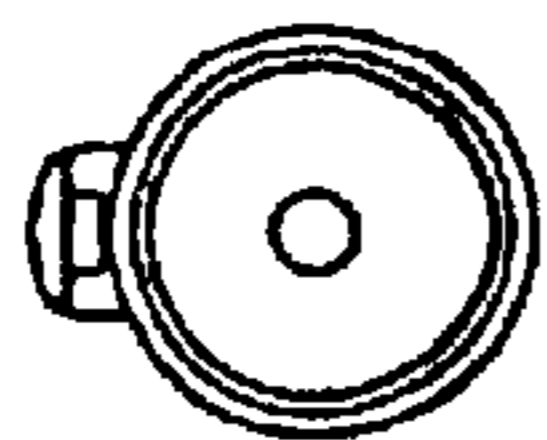

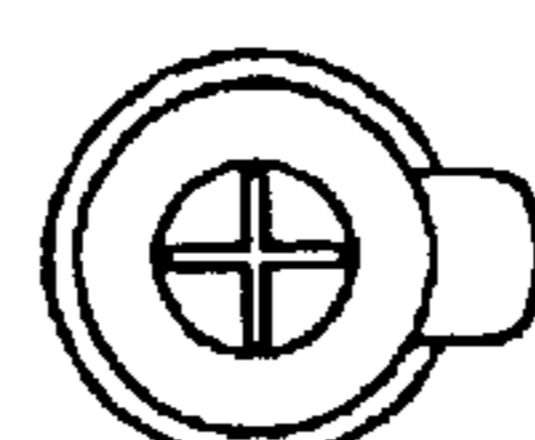
